# Inverse H arish - C handra transform and di erence operators

In the paper we calculate the im ages of the operators of $m$ ultiplication by Laurent polynom ials w ith respect to the $H$ arish $-C$ handra transform and its non-sym $m$ etric generalization due to $O$ pdam. It readily leads to a new sim ple proofofthe H arish-C handra inversion theorem in the zonalcase (see $\mathrm{HC}, \mathrm{Hel}$ ) and the corresponding theorem from [01]. W e assum e that $\mathrm{k}>0$ and restrict ourselves to com pactly supported functions, borrow ing the grow th estim ates from [01].

The $H$ arish- $C$ handra transform is the integration of sym $m$ etric functions on the $m$ axim al real split tonus $A$ of a sem i-sim ple Lie group $G$ m ultiplied by the spherical zonal function ( X ; ), where X 2 A ; 2 (LieA R C) : $T$ he $m$ easure is the restriction of the invariant $m$ easure on $G$ to the space of double cosets $K n G=K \quad A=W$ for the $m$ axim alcom pact subgroup $K \quad G$ and the restricted $W$ eyl group $W$. The function is a sym m etric ( $W$-invariant) eigenfunction of the radial parts of the $G$-invariant di erential operators on $\mathrm{G}=\mathrm{K}$; determ ines the set of eigenvalues. T he param eter k is given by the root $m$ ultiplicities ( $k=1$ in the group case). There is a generalization to arbitrary $k$ due to Calogero, Sutherland, $K$ oomw inder, M oser, O lshanetsky, P erelom ov, H eckm an, and O pdam. See $\mathbb{H O}$ 1,H1,O2] for a system atic theory. In the non-sym $m$ etric variant due to Opdam [01], the operators from [C 5] replace the radial parts of $G$-invariant operators and their $k$-generalizations. $T$ he problem is to de ne the inverse transform $s$ for various classes of functions.

In the papers [ $C 1-C 4$ ], a di erence countenpart of the $H$ arish $C$ handra transform was suggested, which is also a deform ation of the Fourier transform in the p-adic theory of spherical functions. Its kemel (a q-generalization of ) is de ned as an eigenfunction of the $q$-di erence \radial parts" ( $M$ acdonald's operators and their generalizations). There are applications in com binatorics (the $M$ acdonald polynom ials), the representation theory (say, quantum groups at roots of unity), and the $m$ athem aticalphysics (the K nizhnik-Zam olodchikov equations and $m$ ore). The di erence Fourier transform is self-dual, i.e. the

kemel is x \$ sym m etric for $\mathrm{X}=\mathrm{q}^{\mathrm{X}}$. This holds in the di erential theory only for the so-called rational degeneration $w$ ith the tangent space $T_{e}(G=K)$ instead of $G=K$ (see $\mathbb{H e l}, \mathrm{D}, \mathrm{J}]$ ) and for special $k=0 ; 1$. In the latter cases, the di erential and di erence transform $s$ coincide up to a norm alization.
$T$ he di erential case is recovered when $q$ goes to 1 . At the $m$ om ent the analytic $m$ ethods are not $m$ ature enough to $m$ anage the lim iting procedure in detail. So we develop the corresponding technique w thout any reference to the di erence Fourier transform, which is not introduced and discussed in the paper, sw itching from the double a ne Hecke algebra [C 9] to the degenerate one from [C 7]. The latter generalizes Lusztig's graded a ne H ecke algebra [u] (the $G L_{n}$-case is due to $D$ rinfeld). $M$ ainly we need the intertw iners and creation operators from [C 2] (see [C 9] and $\mathbb{K} S]$ for $G L_{n}$ ). It is w orth mentioning that the p-adic theory corresponds to the $\lim$ it q ! 0, which does not violate the standard di erence convergence condition jij< 1 and hardly creates any analytic problem s.

The key result is that the O pdam transform s of the operators of multiplication by the coordinates coincide w ith the operators from [C 6] (see (4.11) below ). R espectively, the $H$ arish $-C$ handra transform s of the $m$ ultiplications by W -invariant Laurent polynom ials are the di erence operators from (4.14). It is not very surprising that the transform s of these im portant operators haven't been found before. T he calculation, not di cult by itself, involves the follow ing ingredients new in the harm onic analysis on sym m etric spaces:
a) TheD unkl-type operators [C 5], their relation to degenerate (graded) a ne H ecke algebras [C 8], and the O pdam transform [01].
b) TheM acdonald operators, di erence counterparts ofD unkloperators, and double a ne H ecke algebras M 1, M 2, C 6,C 9].
W e begin the paper w ith som e basic facts about double a ne H ecke algebras and their polynom ial representations which are necessary to produce difference D unkl-type operators. Then we discuss the two degeneration procedures leading respectively to the operators from [C 5](di erential) and from [C 6] (di erence). B oth are govemed by the sam e degenerate double a ne $H$ ecke algebra (introduced in [C 7]). It eventually results in the inversion theorem.
$H$ opefillly this approach can be extended to any $k$ and, $m$ oreover, $m$ ay help to (re)establish the analytic properties of the direct and inverse transform s . I believe that this paper will stim ulate a system atic renew al of the H arishC handra theory and related representation theory on the basis of the di erenceoperator $m$ ethods.

Generally speaking, a direct veri cation of (2.8) w thout the $X$-intertw iners and the involution " is possible but $m$ uch m ore di cult.

The scalar factors on the left are necessary to preserve the norm alization $G(0 ;)=1$, so we can use the $m$ ain property of the intertw iners (2.8) and the uniqueness of $G\left(x ;\right.$ ) (Theorem 5.1). Expressing $s_{j}^{x}$ in term $s$ of $s_{j}$ (when applied to $G!$ ), we get (6.6) for $\hat{w}=S_{j}$. It is obvious for $\hat{w}=r$. U sing the com mutativity of $\hat{w}^{x}$ and $S_{\hat{u}}$ for $\hat{w}$; $\hat{u} 2 \mathrm{~W}^{\mathrm{b}}$, we establish this relation in the general case. For w 2 W it is due to O pdam.

Form ula (6.7) results directly from (6.6) because we already know that $\hat{w}^{x}$ are unitary for $f f ; f^{0} g$ and $S_{\hat{w}}$ are unitary w ith respect to $f g ; g^{0} g$ for the considered classes of functions. See Theorem s 42, 4.3 and (5.4), (6.4).

For instance, let us check (6.8) for $F$, which is a particular case of (6.7):

Thus the Opdam transform s of the $\backslash m$ ultiplications by the coordinates" $\mathrm{X}_{\mathrm{b}}$ are the operators $b$.

Since $D_{b}$ and ${ }_{b}$ are self-adjoint for the corresponding inner products (see Theorem 42), we get (6.9), which is in fact the de ning property of $F$ and G .

Corollary 6.3. The compositions $G F: C_{C}^{1}\left(R^{n}\right)!C_{C}^{1}\left(R^{n}\right)$, and FG:PW (C $\left.{ }^{n}\right)$ ! PW (C ${ }^{n}$ ) are multiplications by nonzero constants. The transform SF ;G establish isom onphism $s$ betw een the corresponding space identifying $f$; $g$ and $f$; $g$ up to proportionality.

Proof. The rst statem ent readily follow s from the $M$ ain $T$ heorem. The composition $G F$ sends $C_{c}^{1}\left(R^{n}\right)$ into itself, is continuous (due to Opdam), and com $m$ utes $w$ th the operators $X_{b}$ ( $m$ ultiplications by $X_{b}$ ). So it is the $m$ ultiplication by a function $u(x)$ of $C^{1}$ type. It $m$ ust also com $m$ ute $w$ th $D_{b}$. $H$ ence $G(x ;) u(x)$ is another solution of the eigenvalue problem (5.1) and $u(x)$ has to be a constant.

Let us check that F G , which is a continuous operator on P W (C ${ }^{n}$ ) (for any
 by an analytic function $v()$. Indeed, the $i m$ age of $F G w$ ith respect to the standard Fourier transform $(k=0)$ is a continuous operator on $C{ }_{c}^{1}\left(R^{n}\right)$ com muting w ith the derivatives $@=@ x_{i}$. So it is the convolution $w$ ith som efunction and its inverse Fourier transfom is the multiplication by a certain $v()$. Since $F G(g)=C$ onst $g$ for any $g()$ from $F\left(C_{C}^{1}\left(R^{n}\right)\right), v$ is constant.

The claim about the inner products is obvious because fF (f);gg = ff; $G(g) g$ for $f 2 C_{c}^{1}\left(R^{n}\right), g 2 P W\left(C{ }^{n}\right)$.

The corrolary is due to O pdam ([01],T heorem 9.13 (1)). H e uses P eetre's characterization of di erential operators (sim ilar to what Van D en B an and Schlichtkrull did in BS]). A nyw ay a certain nontrivial analytic argum ent is involved to check that GF is multiplication by a constant.
$T$ he sym $m$ etric case. The transform s can be readily reduced to the sym $m$ etric level. If $f$ is $W$-invariant then

for $F$ from (5 2). H ere w e applied the $W$-sym $m$ etrization to the integrand of the (5.3) and used that is $W$-invariant. So $F$ coincides $w$ ith the $k$-deform ation of the H arish -C handra transform on W -invariant functions up to a m inor technical detail. The $W$-invariance of $F$ in results in the $W$-invariance of $F$ ( $f$ ).

As to $G$, weW -sym $m$ etrize the integrand in the de nition $w$ ith respect to $x$ and , replacing $G$ by $F$ and by by its $W$-sym metrization. The latter is the genuine H arish-C handra \m easure"

up to a coe cient of proportionality.
F inally, given a $W$-invariant function $f 2 \mathrm{C}_{\mathrm{c}}^{1}\left(\mathrm{R}^{\mathrm{n}}\right)$;

A sim ilar form ula holds for $G$. See $\mathbb{H C}, \mathrm{He} \mathrm{e}]$ and $[\mathrm{GV}], \mathrm{Ch} .6$ for the classical theory.

A $s$ an application, we are able to calculate the Fourier transform $s$ of the operatons $\mathrm{p}(\mathrm{X}) 2 \mathrm{C}\left[\mathrm{X}_{\mathrm{b}}\right]^{\mathrm{W}} \quad$ (sym m etric Laurent polynom ials acting by mul tiplication) in the $H$ arish-C handra theory and its $k$-deform ation. They are exactly the operators $p$ from Section 4. In the $m$ inuscule case, we get form ulas (4.15). W e mention that in [01] and other papers the pairings serving the Fourier transform s are herm itian. C om plex con jugations can be added to ours.

W e hope that them ethod used in this paper can be generaized to negative $k$ and to other classes of functions (cf. BS,HO2]). Relations (6.6) considered as di erence equations for $G(x ;) w$ ith respect to $m$ ay help $w$ th the grow th estim ates via the theory of di erence equations and the equivalence with difference K nizhnik-Zam olodchikov equations. H ow ever I believe that the $m$ ain progress here $w$ ill be connected $w$ ith the di erence Fourier transform .
