GEOMETRY OF M IXED STATES AND DEGENERACY STRUCTURE OF GEOMETRIC PHASES FOR MULTI-LEVEL QUANTUM SYSTEMS. A UNITARY GROUP APPROACH

A bstract

We analyze the geom etric aspects of unitary evolution of general states for a multilevel quantum system by exploiting the structure of coadjoint orbits in the unitary group Lie algebra. Using the same methods in the case of SU (3) we study the e ect of degeneracies on geom etric phases for three-level system s. This is shown to lead to a highly nontrivial generalization of the result for two-level system s in which degeneracy results in a "monopole" structure in parameter space. The rich structures that arise are related to the geom etry of adjoint orbits in SU (3). The limiting case of a two-level degeneracy in a three-level system is shown to lead to the known monopole structure.

1 Introduction.

The original discovery and development of the geometric phase ideas were in the context of cyclic evolution within the A diabatic T heorem of Q uantum M echanics [7]. In this treatment the adiabatic time dependence of the H am iltonian operator was supposed to arise from its dependence on classical external parameters which in turn were taken to be slow ly varying functions of time. Thus the quantum geometric phase was associated with a closed circuit in the external parameter space rather than in the H ilbert or ray space of the quantum system.

Subsequent work has shown that the geometric phase can be viewed as belonging intrinsically to the ray space of the quantum system, and no reference need be made to the space of classical external parameters [25, 1]. The geometric phase idea has been applied also in the study of dissipative quantum m echanical and classical dynam ical system s [19]. How ever the original picture shows its usefulness in certain physical situations and should therefore be retained. In particular the parameter space is most appropriate for studying the e ects of degeneracies in the eigenvalue spectrum of the quantum Hamiltonian. In his original work [7], Berry studied the most in portant practical case of twolevel degeneracy. Near such a point in param eter space, with no essential loss of generality one can suppose that there are generically three independent real param eters in the Ham iltonian. In accordance with the von Neum ann-W igner theorem it requires the vanishing of all three parameters to produce a degeneracy of levels in the Ham iltonian. In this three-dimensional picture the point of degeneracy appears as a \m agnetic m onopole" (in param eter, not in physical space), and this singular point structure dom inates the geom etric phases for closed circuits in its vicinity.

The aim of this paper is to discuss som e general geom etric aspects of the unitary evolution of a quantum system with a nite number of levels, specializing later to a detailed study of the generic features of a three-level system, which would be the next level of complication in the quantum mechanical sense after two-level system s. For this problem , when degeneracies occur, the earlier \m agnetic monopole" in the geometric phase discussion gets replaced by a far richer singularity structure in an eight-dimensional parameter space, and essentially new geometric as well as algebraic features arise. The situation hardly looks like a \monopole" any more. The basic reason is that while the treatment of two-level degeneracy involves the group SU (2) and its (real three-dim ensional) adjoint representation, with three active levels one has to work with the group SU (3) and its (real eight-dimensional) adjoint representation. We make contact here with som e previous work on SU (3) [2, 3, 20], putting how everm ore emphasis on the geom etric aspects involved in the analysis. The more general fram ework in which we study the occurrence of geom etric phases and that is presented here can be of som e relevance to studies and experiments on quantum and/or optical system swith a nite num ber of degrees of freedom that can be described on nite-dimensional Hilbert spaces, such as those occurring in many-channel (and three-channel in particular) optical interferom etry [22, 24, 23], quantum

com puting [27, 28, 29, 12] or the study of entangled states [18, 28, 16, 21, 14, 6] of sim ple com posite system s.

The material of the paper is organized as follows. In Sect 2 we discuss some general features of a generic n-level quantum system as described, in the von Neum ann picture, in the space of mixed states (or density matrices) and analyze the structure of the orbits under the action of the appropriate unitary group, ie. U (n). In Sect. 3 we collect the basic features of a Herm itian 3-level H am iltonian, its eigenvalues and eigenvectors and the regions of double and triple degeneracy in parameter space. We make use of the de ning and adjoint representations of SU (3) and whenever possible bring in the SU (3) invariants of the problem. In Sect.4 we disscuss brie y the geometric properties of adjoint orbits in the Lie algebra of SU (3). Sect.5 deals with the three independent geom etric phase two-form s, relates them to the sym plectic structures on the orbits, and develops a "sum rule" for them. The next Sect.6 analyzes these two-forms from the point of view of their SU (3) transform ation behaviour and shows that there are three independent tensor contributions belonging respectively to the octet (8), decouplet (10) and antidecouplet (10^2) irreducible representations of SU (3). The details of recombining these three parts and reconstituting the complete two-form s are given. Sect.7 studies the lim iting case of a two-level degeneracy in a three-level system and traces in detail the emergence of the more familiar \m onopole" structure as a special case in the present form alism . Sect.8 contains som e concluding rem arks, and in the Appendices som e relevant m aterials related to SU (3) and its irreducible tensors, as needed here, are collected.

2 General A spects for n-level System s.

M any aspects of quantum dynamical systems are described on the space of mixed states (also called density matrices) where the evolution is ruled by the von N eum ann equation:

where describes the mixed state and H is the (time-independent) Ham iltonian of the system. The von Neumann equation may be obtained from the Schrodinger equation:

The dynam ical evolution given by integrating the von Neumann equation has the form :

i.e. it is a conjugation in the space of m ixed states.

In m any physical situations (e.g. in m any-channel interferom etry and quantum computing [28, 29, 12] we deal actually with nite-level quantum systems, in which case the H ilbert space of states is given by $H = C^n$ for some n, and the group of unitary transform ations is the unitary group U (n). The orbits of the group, acting on the space of m ixed states, will determ ine the carrier spaces of the dynam ical evolution according to the von N eum ann equation, i.e. each initial condition will select an orbit to which it belongs and the evolved state will rem ain on the same orbit. If instead a dissipative term is added on the rhs. of the von N eum ann equation, in general the evolution will not be unitary anym ore and the initial state will be carried from one orbit to another depending on the space of the orbits m ay become relevant when dissipation occurs.

Here we are not going however to deal with particular dynam ical systems but would rather like to concentrate our attention on the \carrier spaces", i.e. we are emphasizing the kinem atical rather than the dynam ical aspects. In particular we would like to consider the space of mixed states (convex com binations of pure states) and study how they are \partitioned" into orbits of U (n) under conjugation. Eventually, in paving the way to the com parison of the von N eumann and the Schrodinger equations we will consider the connection one-form that is usually associated with the \geom etric" or \Berry" phase.

The basic idea of our approach consists in embedding the space of mixed states in the space of all H emmitean matrices, i.e. instead of considering only convex combinations of pure states we will enlarge to combinations with arbitrary real coe cients. Hereafter we will multiply them by the imaginary unit is that they will de ne the Lie algebra u (n) of the unitary group. W ith this extension our analysis will reduce to the analysis of the adjoint (or coadjoint) orbits of U (n) on its Lie algebra.

The structures available on the space of matrices will allow us to consider bilinear products that are \inner" in u(n), and this will provide us with com – putational tools making the analysis of the orbits more manageable. In the next Sections more detailed computations will be carried out for a three-level quantum system, i.e. for U (3). In this particular context we will also exhibit the connection one-form or \Berry connection".

2.1 A lgebraic Structures on the Enlarged Space of M ixed States.

W hen H is not generic, i.e. there are degeneracies in its spectrum, not all powers are independent, and the independent ones are in a number equal to the degree of the minimal polynom ial associated with H. The commutant of H will be no more A belian and will have dimension greater than n.

iii) Two Herm itean matrices will be in the same orbit i they have the same characteristic polynom ial. We recall that the characteristic polynom ial P () is de ned as:

and it is clear that the kernel of ! coincides with the vector elds generated by the commutant of H. Going to the quotient we obtain the symplectic structures on the orbits. In the case of SU (3) an explicit expression in terms of the Euler angles is given in [11, 9, 8].

3 Structure of the H am iltonian, Spectrum and D egeneracies for Three-Level System s.

For a quantum system in which three (generically) distinct energy eigenvalues and eigenvectors play a dom inant role and the other states m ay be neglected, the generic H am iltonian is som e H emm itean three-dim ensional matrix. W ith no loss of generality and whenever needed, by subtracting an appropriate multiple of the identity, we m ay rem ove the trace of the matrix, so that at the point of triple degeneracy all three eigenvalues vanish. W e recall that the set of all H erm itian 3 3 m atrices de nes the Lie algebra u (3) of the unitary group U (3), while the traceless ones de ne the Lie algebra su (3) of SU (3).

A basis of generators for su (3) is given by the (Herm itean and traceless) G ell'M ann m atrices [15, 13] of A ppendix A.

A generic 3 3 H erm itean matrix can be uniquely represented in the basis of the G ell'M ann generators [15] as:

This implies that a study of the geometry of the generic orbits may turn out to be relevant for the study of the geometry of entangled states as well. As stated in Sect 2, the coadjoint orbits are sym plectic manifolds, the sym – plectic form being given by Eq.(19). $!_{\rm H}^3$ will be a volume-form and will de ne a di erentiable measure on the orbit. When pulled back to S⁷, and identifying for short $!_{\rm H}^3$ with its pull-back, $!_{\rm H}^3 \wedge d$ will be a volume-form on S⁷ and, sim ilarly, $!_{\rm H}^3 \wedge d$ $^{\rm A}$ dr=r will be a volume-form on R⁸ flog, the latter providing a (Bures [26, 10]) measure on the space of density matrices.

F inally, the orbits can also be equipped with a metric. Indeed, if fH_ig is a basis in the Lie algebra u(n) of U(n) (e.g. the one given in Eqs.(5 7) we can also de ne a left-invariant metric g on U(n) as:

4 Som e G eom etry of the A d pint O rbits of SU (3).

As already stated in Sect2, we will be interested in the orbits of SU (3) in the space of the traceless H erm itean matrices or in those of U (3) in the space of all H erm itean matrices.

To make contact with the previous Section, we recall that each orbit is characterized uniquely by the isotropy group of any one of its elements (the isotropy groups for di erent elements being conjugate subgroups of SU (3) or U (3) as the case m ay be), and that the latter is generated by the commutant in the way that has been discussed in Sect 2 and that will be rephrased here in the speci c context of SU (3) (or U (3)).

If H is generic, the isotropy group is generated by H ;H 2 and H 3 as:

For any group G and for any given H 2 \underline{G} , the Lie algebra of G, the orbit through H will be di eom orphic with the coset space $G = K_H$, with K_H the isotropy group of H. We can also identify the orbit by taking H in its rest frame. With H xed in this manner, we can write the sym plectic structure on this coset space as:

5 Geometric Phase Two-Forms and U(1) Connections over Coadjoint Orbits.

A fler this general discussion of the structure of the space of all (pure and m ixed) states, we turn to the geometric phase problem for three-level system s.

Following the Adiabatic Theorem of Quantum Mechanics we can imagine carrying any one of the three nondegenerate eigenvectors ja; i of the (generic) Hamiltonian H () along a closed path C \mathbb{R}^8 , avoiding the origin and the subsets $_{12}$ and $_{23}$, and we can then ask how much geometrical phase it has accumulated. From a physical point of view we would consider circuits \close" to the origin ~ = 0. Thus we are concerned with three di erent geometrical phases ^(a) (C); a = 1;2;3, each one associated with a given eigenvector. Notice that in the case of a two-level system, when the relevant group is SU (2), one has also two in principle di erent geometrical phases. However, as they di er by a constant (4) and by a sign, one is accustom ed to speak of a single \Berry phase" in that context. Here we will be forced to deal with three phases. We will discuss in what follows som e m ore general \sum rule" among them.

It is known that the above geom etric phases can be computed as integrals over any two-dimensional surface bounded by C in R 8 $\,$ ff0g [$_{12}$ [$_{23}$ g of corresponding two-form s V $^{(a)}$ (). Such form s are the curvature form s associated with the corresponding \Berry phase" connection one-form s. The general expression for these two-form s describing the \setminus ux" of the geom etric phase in parameter space is [7]:

6 SU (3) tensor analysis of the geom etric phase two-form s.

The transform ation law (98) shows that, for each levela, $V_{rs}^{(a)}$ (~) is a second rank tensor over the octet representation of SU (3). In Appendix A, we describe how such a tensor can be decomposed into SU (3)-irreducible components belonging to the decouplet (10), antidecouplet (10[?]) and octet (8) UIR's of SU (3), and then can be recovered by combinations of these components. Based on the matrix elements $V_{rs}^{(a)}$ (~⁽⁰⁾) given in (101), we must compute the nonvanishing irreducible tensor components in the rest frame, for each a, and then use eq. (96) to get the expression for general ~.

It is convenient to interchangeably use octet indices r; s = 1; :::; 8 and contravariant and covariant SU (3) tensor indices b; c; d; e; f = 1; 2; 3. We ind that, in the rest frame and for each level a = 1; 2; 3, the only nonvanishing components of the (10) and (10[?]) tensors W (a)bod, $\overline{W}_{bcd}^{(a)}$ are the 123 components; these are the only U (1) U (1) invariant ones. As for the octet parts, in all cases X r^(a) turns out to be diagonal (and traceless), so in the octet notation this means that only the r = 3 and r = 8 components remain. Again by (99,100) these are U (1) U (1) invariant.

However, as pointed out in Sect.3, there are particular directions in R⁸ along which either E₁₂ or E₂₃ vanishes, signalling a double degeneracy. These are the two separate four-parameter sets of directions comprising the regions $_{12}$, $_{23}$ de ned in eq.ns (47,48). As explained in Appendix A, these directions map out the two four-dimensional regions in S⁷ which correspond to the two singular orbits in the Lie algebra su (3) of SU (3), each realizing the coset space SU (3)=U (2). We can exhibit the structures of the two basic energy di erences E₁₂, E₂₃ in the vicinity of these regions, expressing them in terms of the two SU (3) invariants 22 and $\sim ~ \sim$. Starting with eq.ns (38) and (42) and expanding them near = =6 and = =2 respectively, we nd:

Now we analyze in more detail the situation near, say, the upper double degeneracy, when ~ lies close to $_{12}$. First we deal with the octet or X ^(a) contribution to $V_{rs}^{(a)}$ (~) in this limit, and later look at the <u>(10)</u> and <u>(10)</u> contributions. The aim is to trace how the two-levelm onopole structure is recovered from the present three-level form alism. It is adequate to work in the rest fram e ~ = ~⁽⁰⁾ and use eq. (103), since the transition to a general fram e via SU (3) cannot introduce any singular factors. Let us in the follow ing denote the sm all energy di erence E $_{12}$ by . The prefactor in eq. (103) introduces an explicit 1= factor in the expression for X ^(a):

This must be balanced by matching powers of from the remaining parts of eq. (103), since we know from the general formula (77) that nothing more singular than $1=^2$ can appear in the two-form V^(a). This is indeed borne out by detailed calculations. We nd, remembering that $E_{12} =$ is the small parameter, that

On the other hand, from (102) and (111) we nd that the leading nonvanishing (10) and (10[?]) contributions to $V_{rs}^{(a)}$ (~⁽⁰⁾), again apart from antisymmetry in r and s, are as follows:

Adding the two sets of contributions we see that for \sim near $_{12}$, in the rest frame, the surviving singular terms in the two-form s $V_{rs}^{(a)}$ ($\sim^{(0)}$) are very few:

We can see how the di erent irreducible SU (3) tensor components combine in just the right manner to reproduce the three-dimensional magnetic monopole type of singularity in the two-form s $V_{rs}^{(a)}$ ($^{(0)}$) when we are near the point of double-degeneracy. Limiting ourself to SU (2) transformations in the 12 subspace in SU (3), it is evident that the term s $V_{12}^{(1;2)}$ ($^{(0)}$) of eq. (121) give rise to the familiar three-dimensional monopole eld, expressed how ever in eight-dimensional space using the relations in (76). Thus they are singular not only at a single point but all over the region $_{12}$ R⁸ fOg.

8 Concluding rem arks.

We have presented a study of two aspects of multilevel quantum systems, unied by the geometrical features of coad pint orbits in the Lie algebra of the unitary groups U (n), SU (n). These are the properties of unitary von Neum ann evolution of general pure or m ixed states for such system s; and in the n = 3 case the detailed structures of the geom etric phases in the neighborhood of degeneracies. W e have exam ined the structures of the two-form s or covariant antisym m etric tensor elds in parameter space, whose uxes through any closed circuit give the corresponding quantum adiabatic geometric phases when one is in the vicinity of a point of three-level degeneracy. In comparison to the three-dimensional monopole singularity in the two-level case, here one has a much richer structure with many new features. To begin with, the parameter space is eightdim ensional. In the spirit of the von-Neum ann W igner theorem , double degeneracies occur along two four-param eter sets of singular rays, 12 and 23, in param eter space; while the triple degeneracy occurs just at a single point $\sim = 0$. Beyond this there is a rich SU (3) tensor structure in the relevant two-form s. W hereas for the two-level case the result was a simple radial \vector" eld, here we have three independent irreducible tensor contributions belonging to the tensor types (8), (10) and (10[?]). Overall reality makes the last two com plex conjugates of one another, but intrinsically they should be considered as independent of one another and of the $(\underline{8})$ contribution.

The complexity of the expressions we have obtained is unavoidable, and autom atically belongs to the next most interesting case from the point of view of general quantum mechanics after the two-level degeneracy. We have shown that they contain within them, embedded in intricate ways, the monopole of the double degeneracy problem when one is near one of the regions $_{12}$ and $_{23}$, in parameter space. However we emphasize that in the complete eightdimensional picture these are far from being point singularities. We can explain the complexity of the present expressions by saying that they have to contain the earlier monopole results in certain limiting situations, and then go beyond them to handle a triple degeneracy.

As long as this invariant is in the open interval (1;1), the stability group of n is conjugate to U (1) U (1) SU (3); hence the orbit of n under SU (3) action, D (A) n 8A, is six-dimensional and realizes the coset space SU (3)=U (1) U (1). The six dimensions of this orbit together with the variable parameter n n n account for the seven dimensions of S⁷ at generic points. At the endpoints of the interval in (133), the corresponding n 2 S⁷ have four-dimensional stability groups, conjugate to U (2) SU (3). Correspondingly we have two very special and singular four-dimensional orbits of such vectors in S⁷. In the notation of eqns (47,48), they are given by

Such a tensor has 28 independent real components. Now, the antisymmetric part of the direct product of two octet representations of SU (3) contains, upon reduction, the (complex) decouplet <u>10</u>, the (conjugate) anti-decouplet <u>10</u>² and the (real) octet <u>8</u>, once each. The counting agrees since reality of $T_{\rm rs}$ implies that the <u>10</u>² components are complex conjugates of the <u>10</u> components. We project out the <u>10</u>, <u>10</u>² and <u>8</u> components respectively, of $T_{\rm rs}$ in the following way:
