# Quantum universal variable-length source coding

We construct an optimal quantum universal variable—length code that achieves the admissible minimum rate, i.e., our code is used for any probability distribution of quantum states. Its probability of exceeding the admissible minimum rate exponentially goes to 0.0 ur code is optimal in the sense of its exponent. In addition, its average error asymptotically tends to 0.

### I. INTRODUCTION

As was proven by Schum acher [1], and Jozsa and Schum acher [2], we can compress the unknown source state into the length nH (p) with a su-ciently small error when the source state on n quantum systems obeys the n-i.i.d. distribution of the known probability p, where p = p() and H () is the von Neumann entropy. Tr p log. Jozsa and Schum acher's protocol depends on the mixture state p. Concerning the quantum source coding, there are two settings: blind coding, in which the input is the unknown quantum state, and visible coding, in which the input is classical information which determines the quantum state that we want to send, i.e., the encoder knows the input quantum state. In this paper, we treat only blind coding. In our setting, we allow mixed states as input states.

In blind coding, K oashi and Im oto [3] proved that even if we allow m ixed states as input states w ithout trivial redundancies, the m in im um adm issible length is nH  $\Gamma_p$ ). Depending only on the coding length nR, Jozsa et al. [4] constructed a code which is independent of the distribution which the input obeys. In their protocol, if and only if the m in im um adm issible length of the distribution p is less than nR, we can decode with a su ciently small error. This kind code is called a quantum universal xed-length source code.

In the classical system, depending on the input state, the encoder can determ ine the coding length. Such a code is called a variable-length code. Using this type code, we can compress any information without error. When we suitably choose a variable-length code for the probability distribution p of the input, the coding length is less than nH (p), except for a small enough probability. In particular, Lynch [5] and D avisson [6] proposed a variable-length code with no error, in which the coding length is less than nH (p) except for a small enough probability under the distribution p. Such a code is called a universal variable-length source code. Today, their code can be regarded as the following two-stage code: at the rst step, we send the empirical distribution (i.e., the type) which indicates a subset of data, and in the second step, we send information which indicates every sequence belonging to the subset [7].

This paper deals with quantum data compression in which the encoder determines the coding length, according to the input state. In order to make this decision, he must measure the input quantum system. A fiter this measurement, depending on the data, the encoder compresses the nal state of this measurement and sends its data and the compressed state. This type code is called a quantum variable-length source code. However, in general, the encoder knows only that the input state is written as a separable state  $x_1$   $x_2$   $x_n$ . Therefore, it is impossible to determine the coding length without destruction of the input state.

In particular, independently of the probability distribution p, we construct the code satisfying the following conditions: the average error concerning to B ures distance tends to 0. The probability that the coding length is greater than nH  $\Gamma_p$ ), tends to 0. Such a code is called a quantum universal variable-length source code. In our construction, similarly to K eyl and W error [8], an essential role is played by the representation theory of the special unitary group and the symmetric group on the tensored space.

In our code, the encoder performs a quantum measurement closely related to irreducible decomposition of the two groups, and its resulting data can be approximately regarded as a quantum analogue of type. Thus, our code can be regarded as a quantum analogue of Lynch-D avisson code [5],[6]. Of course, if we can estimate the entropy H  $\Gamma_p$ ), we can compress the coding rate to the admissible rate H  $\Gamma_p$ ) with a probability close to 1. However, when we perform a naive measurement for the estimation of H  $\Gamma_p$ ), the input state is destroyed. Therefore, in our code, it is the main problem to treat the trade-o between the estimation of H  $\Gamma_p$ ) and the non-demolition of the input state.

One m ight consider that the universal variable code can be easily realized as follows. First, use the n , where is small, states for the estimation of H  $T_p$ ). Second, apply Jozsa et. al. protocol [4] by setting R = H  $T_p$ ) + , and apply to n (1 ) states. If we consider individual error (24), this code successfully compress the source. However, in our paper, like Jozsa et. al. [4], we consider the total Bures distance (1) between the input state and the output state. In this criterion, haive estimate and compress' strategy destroys the input state a lot. The detail will be discussed in section 6. (Note also that our criterion (1) is different from K rattenthanler and Slater's criterion [9] and Schum acher and W estmoreland's criterion [10].)

In this paper, we discuss the universality for the probability fam ily P consisting of predicted probabilities on S (H ). For any probability fam ily P on S (H ), we de ne universality of a quantum variable—length source code and evaluate the exponent of the probability that the coding length is greater than the m inim um adm issible length, which is called the over ow probability. However, unfortunately, in our approach, it is discult to construct a quantum universal variable—length source code whose error exponentially tends to 0 in the blind setting. In the visible coding case, it is possible to construct such a code. This topic will be discussed in another paper.

We sum marize quantum xed-length source coding in section II. A fler this sum mary, we state our mathematical setting and the main results in section III. Our proofs and our construction of code are given in sections V and IV. Moreover, as is demonstrated in section VI, in the 2-dimensional case, a naive code destroys the state and is not used as a quantum universal variable-length source code.

# II. SUM M ARY OF QUANTUM FIXED-LENGTH SOURCE COD ING

Let H be a nite-dimensional Hilbert space that represents the physical system of interest and let S (H) be the set of density operators on H. Consider a source of quantum state which produces the state  $\sim_n := 1 \quad 2 \quad n$  with probability the i.i.d. distribution  $p^n$  of the probability p on S (H). In xed-length source coding, a sequence of states  $\sim_n$  is compressed to the state in a smaller Hilbert space H  $_n$  H  $_n^n$ , whose dimension is  $e^{nR}$ . Here, the encoder and the decoder is a trace-preserving completely positive (TP-CP) map E  $_n^n$  and D  $_n^n$ , respectively. The average of the total error is given by

where Bures distance is de ned as

Note that the support of p does not necessarily consist of pure states. In this setting, we focus the in  $\,$ m um of the rate with which the average error goes to zero. The in  $\,$ m um is called the  $\,$ m in im um admissible rate R  $_{\rm p}$  of p, and is de  $\,$ ned by

The number  $nR_p$  is called m in im um admissible length. When the source has no trivial redundancy in the sense following, it is calculated as

where  $_p = _{2\,S\,(H\,)}^P p($ ). The direct part was proven by Schum acher [1], and Jozsa and Schum acher [2], and the converse part was proven by Barnum et al. [14] in the pure state case. In the mixed case, K oashi and Im oto [3] discussed this problem as follows. Indeed, if the source has trivial redundancies, we can compress up to more than the rate H  $_p$ ). We consider the source to have trivial redundancy if

the support S (p) of p satis es the following. The Hilbert space H is decomposed as (2) satisfying the conditions (i) and (ii):

- (i) Any element 2 S (p) is commutative with  $P_1$ , where  $P_1$  denotes the projection to the subspace  $H_{J;1}$   $H_{K;1}$ .
- (ii) The state  $\frac{\mathrm{Tr}_{\mathrm{H}\ _{J,1}}\ \mathrm{P}_{1}\ \mathrm{P}_{1}}{\mathrm{Tr}_{\mathrm{P}_{1}}}$  is independent of 2 S (p).

Precisely, we should state that the conditions (i) and  $_{\rm f}$ (ii) hold almost everywhere for p. In this case, without loss of information, we can transform to  $_{1}{\rm Tr}_{{\rm H}_{\,{\rm K}\,,1}}\,{\rm P}_{1}\,{\rm P}_{1}$ . When the encoder sends the state  $_{1}{\rm Tr}_{{\rm H}_{\,{\rm K}\,,1}}\,{\rm P}_{1}\,{\rm P}_{1}$  instead of , the decoder can recover the state from the state  $_{1}{\rm Tr}_{{\rm H}_{\,{\rm K}\,,1}}\,{\rm P}_{1}\,{\rm P}_{1}$ . where the RHS of (3) is given by the nest decomposition satisfying (i) and (ii). Following their proof, we can understand that if  $\lim \sup \frac{1}{n} \log \dim H_n < R_p$ ,

which is called the weak converse. When the support of p consists of pure states, if  $\lim\sup \frac{1}{n}\log \dim H_n < R_p = H$  (p), we obtain

which is called the strong converse, and was proven by W inter [15] in the rst time. A more simple proof was given by Hayashi [16]. However, the strong converse in the mixed states case is an open problem. M oreover, in the pure states case, the optimal exponent of average error was treated by Hayashi [16].

### III. QUANTUM UN IVERSAL VARIABLE-LENGTH SOURCE COD ING

In the variable-length case, we need describe a quantum measurement with state evolution, by using an instrument consisting of a decomposition E  $^0=$  fE  $^0_!\,g_{!\,2}$ , by CP maps from S (H) to S (H) under the condition  $_{!\,2}$  TrE  $^0_!\,($ ) = 1; 8 2 S (H). When we perform the instrument E  $^0=$  fE  $^0_!\,g_{!\,2}$  for an initial state , we get the data! and the nal state  $_{\rm TrE\,^0_!\,()}^{\rm E\,^0_!\,()}$  with the probability TrE  $^0_!\,($ ). A quantum variable-length encoder E is given by a measurement process E  $^0$  and encoding process E  $^0_!\,$  depending the data!, which is a TP-CP map from S (H) to S (H  $_!\,$ ), where the H ilbert space H  $_!\,$  depends on the data!, as

The decoder is given by a set of TP-CP maps D = fD  $_{!}$  g $_{!2}$  , which presents the decoding process depending the data !. A pair of an encoder E = fE  $_{!}$  g $_{!2}$  and a decoder D = fD  $_{!}$  g $_{!2}$  is called a quantum variable-length source code on H . The coding length is described by log j j+ log dim H  $_{!}$ , which is a random variable obeying the probability P<sup>E</sup> (!)  $\rightleftharpoons$  TrE  $_{!}$  () when the input state is . Of course, any quantum variable-length source code can be regarded as a quantum xed-length source code whose length is the maximum of log j j+ log dim H  $_{!}$ .

When the state  $\sim_n$  on H  $^n$  obeys the i.i.d. distribution  $p^n$  of the probability p on S (H), the error of decoding for a variable-length code (E  $^n$ ; D  $^n$ ) on H  $^n$  is evaluated by Bures distance as

As guaranteed by Theorem 1, we can reduce the coding rate to the admissible rate H (p) with a su ciently small error and a probability in nitely close to 1, asymptotically, i.e. there exists a quantum universal variable-length source code f  $(E^n; D^n)$  g satisfying that

Therefore, the inequalities

hold. When the support of p consists of pure states, since the adm issible rate R  $_p$  equals H  $\Gamma_p$ ), the RHS of (10) equals H  $\Gamma_p$ ) i.e. our code is optimal. However, in the mixed states case, the adm issible rate R  $_p$  of a probability p is rarely less than H  $\Gamma_p$ ). (See equation (3).) In this rare case, our code cannot up to the adm issible rate R  $_p$ . When for any 2 S (H) there exists a probability q 2 P such that  $\Gamma_q$  and R  $_q$  = H  $\Gamma_q$ ), the RHS of (10) equals H  $\Gamma_p$ ), although the adm issible rate R  $_p$  is less than H  $\Gamma_p$ ). In this case, our code is optimal for any probability p 2 P .

Next, we discuss the exponent of the over ow probability:  $P_{p^n}^{E^n} = \frac{1}{n}$  (log j  $_n$  j+ log dim H  $_{!_n}$ ) R .

We construct a quantum variable-length source code satisfying (11) in section IV. Indeed, as is guaranteed by the following theorem, our code is optimal in the sense of the exponent of the decreasing rate of the over ow probability when  $\inf_{q^2 P \ H} \bigcap_{q} R \ m \ \inf_{q^2 P \ H} D \ \bigcap_q k^- p V$ ) =  $\inf_{q^2 P \ R_q > R} D \ \bigcap_q k^- p$ .

Of course, when the family consists of all probabilities on S (H), the RHS of (11) and the RHS of (12) coincide, i.e. our code is optimal in the sense of the exponent of the over ow probability.

# IV. CONSTRUCTION OF A QUANTUM VARIABLE-LENGTH SOURCE CODE

First, we construct a universal quantum variable—length source code that achieves the optim alrate (11) for the fam ily of all probabilities on S (H ). This fam ily is covariant for the actions of the d-dimensional special unitary group SU (d), and any n-i.i.d. distribution  $p^n$  is invariant for the action of the n-th symmetric group  $S_n$  on the tensored space H  $^n$ . Thus, our code should satisfy the invariance for these actions on H  $^n$ .

Now, we focus on the irreducible decomposition of the tensored space H  $^{\rm n}$  concerning the representations of  $S_{\rm n}$  and SU (d), and de  $^{\rm n}$  ne the Young index n as,

and denote the set of Young indices n by  $Y_n$ . Young index n uniquely corresponds to the irreducible unitary representation of  $S_n$  and the one of SU (d). Now, we denote the representation space of the irreducible unitary representation of  $S_n$  (SU (d)) corresponding to n by  $V_n$  ( $U_n$ ), respectively. In particular, regarding a unitary representation of SU (d), Young index n gives the highest weight of the corresponding representation. Then, the tensored space H  $^n$  is decomposed as follows; i.e. H  $^n$  is equivalent with the following direct sum space under the representation of  $S_n$  and SU (d).

For details, see W eyl [18], G oodm an and W allach [19], and Iwahori [20]. The e ciency of this representation m ethod was discussed from several viewpoints. Regarding xed-length source coding, it was discussed by Jozsa et. al. [4]. Regarding quantum relative entropy, it was by H ayashi[21]. Regarding quantum hypothesis testing, it was by H ayashi[22]. Regarding estimation of spectrum, it was by K eyl and W ener[8].

In the following, for an intuitive explanation of our construction, we naively construct a good variable-length code in the case  $H=C^2$ . For this construction, we ked a strictly increasing sequence  $a=fag_{i=1}^{l+1}$  of real numbers such that  $\frac{1}{2}=a_1< a_2<\dots< a_{l+1}=1$ . We de not the encoder  $E^{a_{jn}}$  whose data set f1;...; lg by

and de ne the decoder  $D_i^{\mathfrak{a},n}$  as the embedding from  $H_i^{\mathfrak{a},n}$  to  $H_i^{\mathfrak{a},n}$ , where we denote the projection to  $H_i^{\mathfrak{a},n}$  by  $P_i^{\mathfrak{a},n}$ . When the larger eigenvalue of the mixture  $p_i^{\mathfrak{a},n}$  belongs to the interval  $p_i^{\mathfrak{a},n}$ , as is guaranteed by Lemma 5 in Appendix A, if the larger eigenvalue of the mixture  $p_i^{\mathfrak{a},n}$  does not lie on the boundary on the interval  $p_i^{\mathfrak{a},n}$ , the probability  $p_i^{\mathfrak{a},n}$  tends to 1. Of course, if we choose  $p_i^{\mathfrak{a},n}$  a to be sulciently small, the coding length is close to the entropy  $p_i^{\mathfrak{a},n}$  with almost probability

Now, we assume that the interval  $a_{i+1}$   $a_i$  ( $i=2;\ldots;l$  1) is and that  $a_2$   $a_1;a_{l+1}$   $a_l$  < . Then, our code is uniquely de ned by the choice of  $\frac{1}{2}$ ;  $\frac{1}{2}$  + ). For the non-demolition of initial states, we construct a variable-length code, by choosing  $a_2$  2  $f_n \frac{k}{j_n} 2$   $(\frac{1}{2}; \frac{1}{2} + ); k$  2 Zg at random . In this protocol, we can expect that the average error tends to 0 for any probability p on S ( $C^2$ ). Note that the set  $f_n \frac{k}{j_n} \frac{k}{j_n} 2$   $(\frac{1}{2}; \frac{1}{2} + ); k$  2 Zg corresponds to the data set  $_n$ . In order to achieve the rate H  $(f_p)$ , we need to choose the set n so that  $\frac{1}{n} \log j_n j!$  0. It is essential for our code to restrict  $a_2$  to this lattice  $f_{\frac{k}{n}}^{\frac{k}{n}} \mathbf{j}_{k} 2 \mathbb{Z} \mathbf{g}$ .

Moreover, for a xed number n, when is large, the demolition of initial state seems small and the coding length seems long. Therefore, roughly speaking, in this code for a nite number n, by choosing, we can treat the trade o between the coding length and the non-dem olition of the input state.

Next, we generalize the above code to the d-dimensional case, and evaluate its average error. In order to satisfy the universality and the condition (11), we need choose depending on n, m ore carefully. For > 0 we de ne a subset Y;n of Zd as

#### V. OPTIM ALITY OF THE EXPONENT OF THE OVERFLOW PROBABILITY

Next, we prove Theorem 2. When the support of any element p of P consists of pure states, i.e. the pure states case, we can prove Theorem 2 by using the monotonicity of quantum relative entropy because the strong converse (5) holds in quantum xed-length pure state source coding, as is explained in section II. However, in the mixed states case, we cannot use this strategy, and we need the following lemma called the strong converse part of quantum Stein's lemma in quantum hypothesis testing proven by 0 gaw a and Nagaoka [23] as an alternative. Its another proof was given by Hayashi[22].

Since the monotonicity of quantum relative entropy corresponds to the weak converse part of quantum Stein's lem ma, the former strategy can be regarded as the combination of the strong converse part (5) of quantum xed-length pure state source coding and the weak converse part of quantum Stein's lem ma, and the latter proof can be regarded as the combination of the weak converse part (4) of quantum xed-length source coding and the strong converse part of quantum Stein's lem ma.

First, for the reader's convenience, we give the form er proof which is simpler than the latter but is applied only in the pure states case. After this proof, we give a more sound proof which can be used in the general case. Let p and q be an arbitrary elements of P, and R be arbitrary real number such that R is less than the minimum admissible rate of q, i.e.,  $R < R_q$ . In particular, we assume that the support of q consists of pure states. For a quantum variable-length source code f (E  $^n$ ; D  $^n$ ) g for a family P, deforming the code (E  $^n$ ; D  $^n$ ), we denote the xed-length code (E  $^n$ ; D  $^n$ ) as follows. Note that  $b(_R;)$  1 for any state  $_R$  of the maximum of this code is less than nR, we can regard it as a  $_R$  xed-length code whose length is nR.

From the construction of the xed-length code  $(E^{R;n};D^{R;n})$ , we can easily check that

# VI. DISCUSSION

In our code, the nonzero number is essential. One may expect that the quantum variable—length source code  $f(E^{0m};D^{0m})g$  is universal. However, this code destroys the input state by a quantum measurement as follows.

As is understood from our proof of Theorem 1, bound (11) cannot be achieved unless—tends to 0. It seems essential to approximate the nonzero number > 0 to 0.

If we discuss quantum universal coding under another error  ${}^0_{n,p}$  (E  ${}^n$ ;D  ${}^n$ ) instead of  ${}^n_{n,p}$  (E  ${}^n$ ;D  ${}^n$ ) (c.f. (6)):

we can use several strategies for quantum universal coding. For example, if we use no states only for the estimation of H  $( \Gamma_p )$ , we can reduce the error  $_{n\,p}^0$  to zero, asymptotically, by use of Jozsa et. al. protocol [4]. However, in this strategy, we cannot reduce the error  $_{n\,p}$  because the demolition of the rst no states is crucial for this criterion.

Next, we discuss how rapidly the average error  $_{n,p}$  tends to 0 in our code. Assume that d=2 and  $f\dot{p}_1\dot{i}$ ,  $\dot{p}_2\dot{i}$  is a CONS of  $C^2$ . Unless  $_n>0$  satis es  $\dot{j}_n\dot{j}<1$ , the coding length always equals 2n. Then, we can assume that  $\dot{j}_n\dot{j}<1$ .

Therefore, it seems impossible to construct a universal code whose average error  $_{n,p}$  exponentially tends to 0.

Thus, its dierence equals  $\sin^2($  (t) (t) (d( $t_1;1$  t<sub>0</sub>) d( $t_1;t_0$ )) > 0. This gap is closely related to the ambiguity of the large deviation-type bounds in quantum estimation [17]. It seems very hard to match the upper bound and the lower bound concerning the exponent of the over ow probability in the general case.

# VII. CONCLUSION

We construct a quantum variable—length code satisfying equation (11). This is optimal in the sense of Theorem 2 when the family P consists of probabilities on S (H) with no trivial redundancies. However, in our code the average error does not exponentially vanish. The construction of such a code seems to be dicult.
