CASIM IR ENERGY OF A DILUTE DISPERSIVE DIELECTRIC BALL: REALISTIC MICROSCOPIC MODEL

The C asim ir energy of a dilute hom ogeneous nonmagnetic dielectric ball at zero temperature is derived analytically within a microscopic realistic model of dielectrics for an arbitrary physically possible frequency dispersion of dielectric permittivity "(i!). Divergences are absent in calculations, a minimum interatomic distance is a physical cut-o. C asim ir surface force is proved to be attractive. A physical de nition of the C asim ir energy is discussed.

1. M icroscopic Approach

Consider a dielectric nonmagnetic ball of the radius a and permittivity "at zero temperature, surrounded by a vacuum. The ball is dilute, i.e. all nalexpressions are obtained under the assumption " 1 1 in the order ("(i!) 1°), the lowest order that yields the energy of interaction between atoms of the ball.

The C asim ir energy of a disjoint m acroscopic system (two dispersive dielectric parallel plates is a classic example by L ifshitz) depends only on the distance between m acroscopic bodies and dispersion of dielectrics 1 . On the other hand, it was not argued in Refs. 2 that for a dilute connected dielectric the C asim ir energy at zero temperature is equal to the energy of dipole-dipole pairw ise interactions of all atoms constituting the dielectric and thus should also depend on an average minimum distance between atoms of a dielectric. For a dilute dispersive dielectric ball with an arbitrary frequency dependent dielectric permittivity the C asim ir energy at zero temperature was not derived in Ref. 4 .

A dipole-dipole interaction of two neutral atoms with atomic polarizabilities $_1$ (i!) and $_2$ (i!) is described by a potential 5




Fig. 1. Energy calculation for the ball. Shaded areas I and II separated by a dashed line on the left picture denote areas of integration in the rst and second integrals in (2) respectively. A shaded area on the right picture represents the area of integration in the third integral in (2). A part of the sphere of radius r w hich is located inside the dielectric ball is denoted by a dotted line. Its area is equal to $2 \ r^2 \ (1 \ (p^2 + r^2 \ a^2) = (2pr))$.

where r is a distance between two atom s. The energy calculation for the ball is illustrated by Fig.1. Suppose that an atom with an atom ic polarizability (i!) is located at the point B . One has to integrate interaction of an atom at the point B via a potential (1) with the atom s separated by distances greater than interatom ic distances from the point B , integrate over all atom locations B inside the ball and multiply by a factor 1=2 to calculate the energy.

A ssum ing hom ogeneity of the ball (it results in $_1$ (i!) = $_2$ (i!) = (i!) and the condition that the number density of atoms doesn't depend on the point inside the ball), the C asim ir energy is equal to

Perform ing calculations, it is possible to derive an analytic result⁴:

where $E_1(x) = \frac{R_{+1}}{1}$ e ^{tx}=tdt.

Eq.(3) nally solves the problem of the Casim ir energy for a dilute dielectric ball at zero tem perature. This energy is nite and physical only when a nite m inim um separation between atoms is taken into account.

Some words need to be said about the change of a view point on the physical de nition of the C asim ir energy. When an interatom is distance—is taken into account, the C asim ir energy can be calculated without divergences by use of Eq.(2), and so calculated energy doesn't require further renormalization. No further renormalization is needed since it is obvious from the method of calculations that the C asim ir energy (3) coincides with a potential (binding) energy of the ball when is large enough, so that elects of short-range interatom is repulsive forces and other interactions can be neglected. In this case there is no classical part of the energy in the beginning of calculations, there exists only a set of atoms with specified interactions between them due to quantum—uctuations. The sum of all these interactions between atoms should give the C asim ir contribution to the binding energy of a dielectric ball { a macroscopic classical system.

The leading contribution from the last line in (3) is equal to

The term (4) can be called a contribution from large distances to the C asim ir energy of the ball. U sually all terms dierent from (4) were simply discarded or added up to macroscopic quantities of the ball (e.g., volume, surface energies) during the renormalization procedure, as it often happens in eld theory. So only the term (4) was usually considered as the Casim ir energy term. In fact, this was an erroneous de nition of the Casim ir energy since no physical quantities can be calculated by use of Eq.(4). All physical quantities that can be measurable at least in principle for a dilute ball (e.g., surface force or trajectories of the particles near the ball surface during the ball collapse in the adiabatic approximation) have to be calculated by use of a total potential energy of the ball (3). The term (4) has little in uence on physics. The reason is quite simple - the term (4) is much less in magnitude than the term s in the rst, second and third lines of (3). For exam ple, ratio of term s in the rst line of (3) to (4) is $(!_0a)(a=)^3$ 1, where $!_0$ is a characteristic atom ic absorption frequency. However, the term (4) was really important for development of the theory of Casim ir e ect in connected dielectrics since this term has been derived via m icroscopic 6 and m acroscopic 7 techniques — so the equivalence of large distance parts of the Casim ir energy for a dilute dielectric ball derived by m icroscopic and m acroscopic approaches was proved.

It is important to stress that so far macroscopic methods did not yield satisfactorily short distance contributions to the Casim ir energy of connected dielectrics⁸. The reason is simple: these methods were developed for disjoint, not connected dielectrics.

From (2) it follows that Casim ir surface force on a dilute dielectric ball is attractive. It is convenient to de ne N a=;p!. Then Eq.(3) can be rewritten

in a general form

From the condition of an atom ic conservation (6) it follows that during the ball collapse or expansion

It is convenient to use K ram ers{K ronig relations in the form

where the condition g(x) > 0 always holds. Using (5), (6), (7), (8), Casim ir force on a unit surface is equal to

F < 0 because all functions inside integrals are positive. Casim ir surface force is attractive for every model of atom ic polarizability consistent with general causal requirements.
