## Persistent currents due to point obstacles

We discuss properties of the two-dimensional Landau Ham iltonian perturbed by a family of identical potentials arranged equidistantly along a closed loop. It is demonstrated that for the loop size exceeding the elective size of the point obstacles and the cyclotronic radius such a system exhibits persistent currents at the bottom of the spectrum. We also show that the elect is sensitive to a small disorder.

## 1 Introduction

Persistent currents in rings threaded by a magnetic ux are one of the characteristic features of mesoscopic systems { see, e.g., [CGR,CWB] and numerous other theoretical and experimental papers where they were discussed. Recall that for a charged particle (an electron) connect to a loop C thee ect is contained in the dependence of the corresponding eigenvalues  $E_j$  on the ux threading the loop measured in the units of ux quanta,  $2 \sim \text{ciej}^1$ . Specifically the derivative  $@E_j = @$  equals  $\frac{1}{c}I_j$ , where  $I_j$  is the persistent current in the j{th state. In particular, if the particle motion on the loop is free, we have

where L is the loop circum ference, so the currents depend linearly on the applied eld.

The above exam ple represents an ideal case when the particle is strictly con ned to the loop. On the other hand, there are many situations when a particle in a magnetic eld can be transported being localized essentially in the vicinity of a barrier or an interface. A prominent example are the edge currents [Ha, MS]. They attracted a new wave of interest recently when in several papers [BP, FGW, FM, MMP] conditions were derived under which such a transport remained preserved in the presence of a disorder.

Even weaker interaction giving rise to a magnetic transport, this time without a classical analogue, was found in [EJK], where the Landau Hamiltonian was perturbed by a straight equidistant array of potentials. It was shown that such an operator has bands of absolutely continuous spectrum in the gaps between the Landau levels. An independent evidence for the transport in this situation was found in [Ue].

The question we are going to ask in this paper is the following. If we take a nite array of identical potentials in the plane making a loop, does the mentioned transport give rise to persistent currents? As we will see the answer is in general positive if the elective radii of the potentials (specified below { see (2.4)) and the cyclotronic radius corresponding to the eld intensity are much smaller than the loop size. We also discuss the election of disorder manifested by random ization of the coupling constants and show that the elect is sensitive to such perturbations: in an example with a ring of 12 obstacles a variation larger than 1% leads to a localization.

### 2 The model

### 2.1 2D magnetic systems with point obstacles

A swe said above, we are going to study a charged particle in the plane subject to a hom ogeneous magnetic eld perpendicular to the plane interacting with an equidistant array of point obstacles placed at points  $a_j$ ; j=1;:::;N, belonging to a closed loop. The simplest example is the situation when the latter is a circle,

For the sake of brevity we shall write a =  $(a_1; :::; a_N)$ . The obstacles will be modeled by potentials so formally the Hamiltonian of the system can be written as

where A is the appropriate vector potential which we choose here in the circular gauge,

To make things simple we have used rationalized units in (2.2) putting  $\sim = c = e = 2m = 1$ . On the other hand, the two-dimensional interaction is an involved object. To give it meaning and to specify the true coupling parameter which would replace the form al  $\sim_j$ 's, we use the denition based on self-adjoint extensions which is discussed thoroughly in [AGHH], see also [DO, GHS] for the situation with a magnetic eld. A interaction is determined by means of the boundary conditions

We now put = (  $_1$ ;:::;  $_N$  ) and denote by H  $_{,a}^B$  the H am iltonian of our model, which acts as free outside the interaction support,

for x 2 a, and its dom ain consists of all functions which belong to the Sobolev class W  $^{2;2}$  (R  $^2$  n a) and satisfy the boundary conditions (2.3).

The param eters  $_{\rm j}$  characterizing the \strength" of the interaction are not trivial [ES,CS]; this is clear from the fact that the free (Landau) H am iltonian, which we denote as H  $^{\rm B}$ , corresponds to  $_{\rm j}$  = 1;  $_{\rm j}$  = 1; ...; N . The di erence between  $_{\rm j}$  and the form alcoupling constants used in (2.2) re ects the nontrivial way in which the two-dimensional point interaction arises in the limit of scaled potentials. To understand the  $_{\rm j}$ 's it is more natural to

associate them with the scattering length: by [ES] the point interaction with the parameter reproduces the low-energy behaviour of the scattering upon an obstacle of the radius provided

# 2.2 Spectral properties of H B a

The spectrum of the free operator H  $^{\rm B}$  is the series of in nitely degenerate eigenvalues B (2n+1);  $n=0;1;\dots$  A nite number of point interactions leaves the essential spectrum intact so  $_{\rm ess}$  (H  $^{\rm B}_{,a}$ ) consists again of the Landau levels. M oreover, it follows from general principles [W e, Sec .8.3] that N point interactions can give rise to at most N eigenvalues in each gap of (H  $^{\rm B}$ ). It is this discrete spectrum which is the object of our interest.

To nd it we can make use of K rein's formula [AGHH, App.A] which expresses the resolvent kernel of H $_{\rm ga}^{\rm B}$  by m eans of that of the free operator, specially

where  $G_B$  ( $x;x^0;z$ ) is the resolvent kernel of H <sup>B</sup> and (B;z) its regularized value at the singularity,

which is independent of x. The sought discrete spectrum is given by the singularities of the second term at the r.h.s. of (2.5), or in other words, by solutions of the spectral condition

If  $z=z_0$  satis es this, it is an eigenvalue of the operator H  $_{,a}^{B}$  and the equation  $_{,a}^{B}(z_0)d=0$  has a nontrivial solution in C  $_{,a}^{N}$ ; the corresponding

as can be checked by a standard argum ent [AGHH].

To make use of the above form when we need the explicit form of the free G reen's function. It is known [DMM] to be

In this way we have derived the explicit form of the matrix  $^{\rm B}$ <sub>2</sub> (z) appearing in the condition (2.7).

## 3 The results




Figure 1: The energy spectra of a quantum particle on 2-dimensional plane with N p = 12 delta functions of strength parameter—placed equidistantly on a ring of radius R = 1 and subjected to perpendicular magnetic eld of constant strength B = 1. A ll quantities are in the unit  $\sim$  = c = e = 2m = 1.

In Fig. 1, we show the energy spectra of the system as a function of the common coupling strength  $_{\rm i}$  = . In this example, the N p = 12 of - interactions are placed equidistantly on the ring of circum ference L = 2 . We can make this assumption without loss of generality. It is true that scaling systems with 2D point interactions reveals peculiar properties [CS2], but in elect changing the size of the system is equivalent to the shift of on a constant proportional to logarithm of the scaling factor. One can see

from this gure that, for our choice of the system size, the coupling becomes strong as the parameter approaches the value = 1, in which case the eigenvalues split from the Landau levels of unperturbed system form a bunch of negative-energy states; recall that by (2.4) it corresponds to the scattering length  $= e^2$ .




Figure 2: The energy spectra of a quantum particle on 2-dim ensional plane with N p delta function of strength parameter = 1 placed equidistantly on a ring of radius R = 1 with perpendicular magnetic eld of constant strength B .




Figure 3: Pro le of probability current for N p = 12 delta-functions of strength parameter placed equidistantly on a ring of radius R=1 and subjected to perpendicular magnetic eld of constant strength B=0.5, B=1.0, B=1.5 and B=2.0.

The properties of these states are made clear by plotting their energies as the function of the magnetic eld B. We set the strength parameter to be = 1. In the top lines of Fig. 2, several lowest states are shown for for three cases Np = 6, Np = 12 and Np = 24. As the number of the -scatterers increases, one clearly sees the emergence of parabolic B dependence, which is the hallmark of the persistent current we have been looking for. The situation becomes clearer when we plot derivatives dE =dB and  $d^2E = dB^2$  as the function of B. A direct evidence of the existence of persistent current in our system is shown in Fig. 3, in which the probability ux current is depicted for Np = 12 case for the magnetic eld strengths B = 0.5, B = 1.0, B = 1.5 and B = 2.0.




Figure 4: The energy spectra of a quantum particle on 2-dimensional plane with N p delta function of uctuating strength parameter = 1 + p placed equidistantly on a ring of radius R = 1 + p with perpendicular magnetic eld of constant strength B.

As with the \usual!" persistent currents, one has to take into account the imperfection when thinking about the use of the elect in designing various devices. Thus the question of the robustness of the persistent current in our system is of interest. We test it by allowing random uctuation of the coupling strengths of the -scatterers. In Fig. 4, we plot the E, dE = dB and  $d^2E = dB^2$  as the function of B as before, but letting the coupling strength of each scatterer to vary random by by the amount uniform by around the central value = 1. The uctuations are taken to be = 0.01, = 0.02 and = 0.03 from the left to right. The number of -scatterers




Figure 5: Pro le of probability current for N p = 12 delta-functions of uctuating strength parameter = 1 + placed equidistantly on a ring of radius R = 1 and subjected to perpendicular magnetic eld of constant strength B = 0.5.

= 0.92 and = 0.93 from the left to right. The number of -scatterers is again set to be N p = 12. Some examples of probability current ow patterns at B = 0.5 for each case are shown in Fig. 5. While a more detailed analysis of such random perturbations is required, Figs. 4-5 suggest that the persistent current generated by the array of -scatterers is sensitive to small uctuations of the strength; one typically needs the accuracy of less the 1% to have the persistent current intact down to the ground state.

In conclusion, we have dem onstrated a purely quantum mechanism able to create persistent currents in systems with arrays of tiny obstacles in magnetic eld; it is the the wave nature of electrons which is responsible for this counterintuitive phenomenon. The result might eventually have a practical impact on the design of the quantum ring devices, however, the elect of localization by random perturbations deserves a deeper study.
