Quantum theory of heating of a single trapped ion

The heating of trapped ions due to the interaction with a quantized environment is studied without performing the Born-Markov approximation. A generalized master equation local in time is derived and a novel theoretical approach to solve it analytically is proposed. Our master equation is in the Lindblad form with time dependent coe cients, thus allowing the simulation of the dynamics by means of the Monte Carlo W ave Function (MCW F) method.

Single ions con ned in miniaturized radio frequency traps can be cooled down by means of laser cooling techniques very e ciently [1]. Experiments have shown that the center of m ass of a single cooled trapped ion undergoes a quantized harm onic oscillatory motion [2]. During the last decade a great deal of attention has been devoted to such systems since they turn out to be very weakly coupled to external environm ent, thus allowing the manipulation and observation of the coherent dynam ics of a single quantum system [3]. Indeed, by irradiating the ion with properly con gured laser beams, it is possible to manipulate the vibronic state of the ion. The easiness to engineer at will the interaction between the motional and internal degrees of freedom of the ion makes it possible to perform experim ental tests of fundam ental features of quantum mechanics. For example, many nonclassical states of the oscillatory motion of the ion have been prepared and measured [4]. By using multiple ions in a linear Paultrap, experiments on quantum non locality have been perform ed [5] and m any-particle entangled states have been realized [6]. Furtherm ore cold trapped ions have been recently proposed as a physical in plem entation for quantum computation [7].

Both for fundam ental studies and for technological applications it is of great interest to understand and study those factors limiting the delity of the operations perform ed to manipulate coherently the quantum state of the ion. Heating of the center of m ass oscillatory m otion of one or m ore trapped ions seems to be one of the major practical sources of decoherence [8]. The process of heating of a single trapped ion is due to the electrom agnetic coupling between noisy electric elds and the ion. Such elds give rise to uctuating forces acting on the ion which can cause an increase in its motional energy. The physical origin of the noisy electric elds in the center of the trap has not yet been unambiguously identied. In fact, measurem ents of the heating rate are very difcult to perform since they require high sensitivity and they may depend on parameters related to the specic trap geom etry used [8]. For this reason a general theory of heating would help in identifying and possibly reduce

the up to now unknown sources of noise.

Most of the theoretical studies on the heating of trapped ions deal with the interaction between a single harm onic oscillator and a reservoir which is either described as a classical stochastic eld [9, 10, 11, 12] or as an in nite chain of quantum harm onic oscillators. In the rst case an analytic solution for the dynamics of the system can be found without performing the Born-M arkov approximation [9, 11]. In other words, it is possible to study the short time evolution of the heating function when the eld noise spectrum is not at, as it is indeed in any real experimental situation. However the analytical treatments, in this case, cannot describe the therm alization process, i.e. the long time behavior, since the stochastic eld continuously feeds energy in the system, leading to an in nite growth of the heating function. On the other hand, m odelling a therm al reservoir as an in nite chain of harm onic oscillators at tem perature T allows, under certain approximations, to describe the dynamics of the system in term sofa master equation of the form [13]

where \hat{a}^y and \hat{a} are the creation and annihilation operators of vibrational quanta, is the heating constant and the environm ent is assumed to be at them alequilibrium, N being them ean number of reservoir excitations at tem – perature T. In Eq. (1) the term sproportional to (N + 1) account for spontaneous and stim ulated em ission, that is a transfer of energy from the system to the reservoir, while the term sproportional to N account for absorption, that is a transfer of energy from the reservoir to the system. The presence of the spontaneous emission term, arising from a quantized description of the reservoir, ensures the them alization process. Indeed, from equation (1), it is possible to derive the following expression describing the time evolution of the heating function:

with $n(!_0) = e^{-!_0} 1^{1}$, $= (KT)^1$ and $!_0$ frequency of the trap. In order to describe the dynam ics of the system by m eans of the master equation (1), how ever, it is necessary to assume the validity of the Born-M arkov approximation. As a consequence such a treatment is valid only for times t much bigger than the correlation time of the reservoir and thus does not give the correct short time behavior.

The aim of our paper is to study the heating of a single trapped ion interacting with a quantized reservoir without performing the Born-Markov approximation. One of the main results of the paper is the derivation of an analytical expression for the heating function describing both the non-Markovian short time behavior and the asymptotic thermalization process.

The Ham iltonian describing the interaction between the ion motion and a quantized reservoir modeled as an in nite chain of ham onic oscillators, can be written as follows $\hat{H} = \sim^{p_{-1}-1} c_j \hat{a} + \hat{a}^y \hat{b}_j + \hat{b}^y_j$, where \hat{b}_j is the annihilation operator of reservoir excitations and is the coupling strength. By using the time-convolution less projection operator technique [14] and perform ing the R otating W ave Approximation, we have derived the following master equation describing the non-M arkovian dynamics of the system in the interaction picture:

The functions (t) and (t) are de ned in terms of the two reservoir characteristic functions [15]: the correlation function () = ${}_{0}^{R_{1}}$! \dot{g} (!) ${}_{R_{1}}^{2}$ (2n(!)+1)cos(!)d!, and the susceptibility () = ${}_{0}$! \dot{g} (!) \dot{f} sin(!)d!, where n(!) = ${}_{0}^{-!}$ 1 1 . Moreover, assuming a Lorentzian spectral density \dot{g} (!) \dot{f} = ! ${}_{c}^{2}$ =[(!² + ! ${}_{c}^{2}$)] (O hm ic environment [16]) with ! c reservoir frequency cut, in the high temperature regime de ned by the condition (~) 1 ! c and in the weak coupling limit, the real functions (t) and (t) can be written in a simple analytic form :

where $r = !_c=!_0$. Remembering that in the high tem – perature regime $n(!_0)$ ' (~ !_0) ¹, it is easy to check that in the M arkovian limit, that is when t ______R with _______R = 1=!_c correlation time of the reservoir, equation (3) reduces to equation (1). The analytic expression of (t) and (t) for a generic tem perature T is, in general, more complicated. Nonetheless the tem perature dependence of these coe cients of the master equation brings to light interesting features in the dynamics of the system and, for this reason, it is carefully discussed in a follow up paper [17].

Our non-Markovian master equation (3) has the general form of the time-convolutionless master equations [18, 19]. How ever, it is worth noting that it is not only localin time but also, as long as the coe cients (t) + (t)and (t) (t) are positive, in the Lindblad form . We have veried that, for the value of parameters currently used in the experiments and for r > 1 the time dependent sum and di erence coe cients are positive at all times t. Note that the condition $r > 1 \sin p \ln p$ means that the spectral density of the reservoir overlaps with the frequency of oscillation of the ion, which is a reasonable and comm only done assumption. In other words, we dem onstrate for the st time that the non-Markovian dynam ics of the reduced density matrix of the system here considered, is described by a Lindblad-type master equation. Thus, it is possible to use the standard M CW F method to unravel Eq. (3) [20]. We note that up to now, only quantum state di usion unravelings have been known and used for simulating the tem poral behavior of a harm onic oscillator interacting with a non-M arkovian quantized environm ent [21]. We would like to emphasize that the advantage of working with a master equation of Lindblad type whose analytical solution m ay be successfully found, as in our case, is that the positivity of the density matrix is ensured. In the following we will use the quantum jum p M C W F m ethod to obtain the tem poralbehavior of the heating function and com pare it with the analytic solution.

We now brie y sketch the novel analytical treatment we have developed to solve the master equation (3) and derive a closed expression for the heating function describing both its short and its long time behavior. A detailed description of the method will be given elsewhere [17]. The rst step of our approach consists in expanding the density matrix of the system as follows [22]:

In Eq. (6), 2 C and $_{t}(;) =$ Tr exp d^{y} $d^{(t)}$ is the quantum characteristic function. Inserting Eq. (6) into Eq. (3) and by using some useful algebric properties of the cronologically ordered time evolution superoperators T_c(t) of the system, de ned by $(t) = T_{c}(t) (0)$, we obtain the following expression for the quantum characteristic function:

In this equation $_0$ is the quantum characteristic func-

tion at the initial time instant t = 0,

The functions (t) and (t) are de ned by eqs. (4) and (5). For example, assuming as initial state a vibrational

Fock state jki, Eq. (7) becom es

where L_k (y) is the Laguerre polynom ial of order k in y. Eq. (7) together with Eq. (6) gives the analytic expression of the density m atrix of the system in an operatorial form at any time instant t. From Eq. (7) it is easy to derive the following expression for the mean vibrational quantum number, i.e. for the heating function:

In Figs. 1 and 2 we show the short and long time behavior of the heating function of a trapped ion initially prepared in its vibrational ground state. W e com pare the analytical solution and the M CW F simulation perform ed starting from the master equation (3). The gures show a very good agreem ent between the analytical and the numerical approaches. We note that our quantum theory of heating predicts the initial quadratic behavior typical of non-Markovian dynamics. In Fig. 3 we compare the non-Markovian and Markovian time evolution for times t sm aller than the reservoir correlation time $_{\rm R} = 1 = !_{\rm C}$. A similar result was deduced by James and by Budini in the case of a classical environm ent described in terms of a stochastic noisy electric eld [9, 11]. O ur approach, how ever, allow s also to describe the asymptotic therm alization process as shown in Fig. 2. Indeed, for times _R and for a at reservoir spectrum r 1, the heatt ing function given by equation (11) reduces to the well. known M arkovian equation given by Eq. (2), as one can easily derive substituting the asymptotic expressions for (t! 1) and (t! 1) into equations (8), (9) and (11), in the lim it r 1.

In conclusion we have proposed a new approach for studying the heating of a single trapped ion due to the interaction with a quantized reservoir. Our approach does not rely on the Bom-M arkov approxim ation and thus allow sto describe the initial quadratic behavior of the heating function. M oreover, due to the quantum description of the environment, our solution describes correctly the therm alization process. Stated another way our quantum theory of heating bridges a gap existing in the literature. Until now, indeed, only non-M arkovian analytical solutions, in the case of interaction with a classical environment, or M arkovian analytical solutions, for interactions with a quantum environment, were known.

It is in portant to emphasize that m easurem ents of the initial quadratic behavior of the heating function are difcult to perform for two reasons. Firstly because this would mean to make many measurem ents in an interval of time of the order of $_{\rm R}$ ' 10 ⁸ s, for the value of param eters used in the paper. The second and more in portant reason is related to the di culty in revealing so sm all

variations in hî (t)i as the ones shown in Fig.1. Very recently, how ever, it has been experim entally dem onstrated the possibility of engineering both the type of reservoir interacting with a single trapped ion and the coupling between the system and the environm ent [23]. The analytical solution we have presented in this paper m akes it possible to look for ranges of the relevant param eters of both the system and the reservoir in correspondence of which the non-M arkovian quadratic behavior becom es experim entally observable.

The experimental ability in engineering reservoir suggests also another application. A swe have already mentioned in the paper, we have analyzed the dependence of the coe cients of our master equation (3) on reservoir parameters such as its temperature T and frequency cut $!_c$. We have found that by changing such parameters the master equation passes from Lindblad type to non-Lindblad type. Such a modi cation does related a deep change in the dynamics of the system. This result will be discussed in more detail in a follow up paper since we believe that the possibility of studying analytically such changes may give more insight in understanding the fundamental properties of the heating process of single trapped ions.
