A nom alous power law of quantum reversibility for classically regular dynamics

The Loschm idt E cho M (t) (de ned as the squared overlap of wave packets evolving with two slightly di erent H am iltonians) is a measure of quantum reversibility. We investigate its behavior for classically quasi-integrable systems. A dominant regime emerges where M (t) / t with = 3d=2 depending solely on the dimension d of the system. This power law decay is faster than the result / t d for the decay of classical phase space densities.

The search for quantum signatures of chaos has provided much insight into how classical dynam ics manifests itself in quantum mechanics [1,2]. The basic question is how to determ ine from a system's quantum properties whether the classical limit of its dynamics is chaotic or regular. One very successful approach has been to look at the spectral statistics, in particular the distribution of level spacings [3]. An altogether dierent approach, advocated by Schack and Caves [4], has been to investigate the sensitivity of the quantum dynamics to perturbations of the Hamiltonian. This approach goes back to the early work of Peres [5] and has attracted new interest recently in connection with the study of decoherence and quantum reversibility [6{12}].

The basic quantity in this approach is the so-called Loschm idt Echo, i.e. the delity

with which a narrow wavepacket $_0$ can be reconstructed by inverting the dynam ics after a timetwith a perturbed H am iltonian H = H $_0$ + V [5,6]. (We set h = 1.) The delity quanti es the sensitivity of the time-reversal operation to the uncertainty in the H am iltonian, and thus provides for a measure of quantum reversibility.

To date, most investigations of M (t) focused on classically chaotic Ham iltonians H and H $_0$ [6{10]. One notable exception it the original paper by Peres [5], who noted that the decay of M (t) is slower in a regular system | but did not quantify it further. We will show in this article that in a regular system a dominant regime emerges where M (t) has a power law decay / t $^{\rm 3d=2}$, with an exponent depending solely on the dimension d of the system . This power law decay establishes the higher degree of quantum reversibility of regular systems compared to chaotic ones, where M (t) decays exponentially.

This trend is as expected from classical reversibility (dened in term softhe decay of the overlap of classical phase space distributions [13]). However, we not that quantum mechanics plays a crucial role in regular systems by inducing a parametrically faster power law decay / t $^{\rm 3d=2}$ than the classical one / t $^{\rm d}$.

We consider the generic situation of a regular or quasi-integrable H $_{0}$ and a perturbation potential V that has no com m on integral of m otion with H $_{0}$. (By regular or quasi-integrable we mean systems with a phase space dominated by invariant tori.) This condition ensures that, classically, the perturbation has a component transverse to the invariant tori almost everywhere in phase space. Our investigation will moreover focus on a regime of su ciently strong perturbation (de ned below), where one expects a fast decay of the perturbation correlator. This regime is to be contrasted with the linear response regime considered in Ref. [11].

We follow the sem iclassical approach of Jalabert and Pastawski [6]. We start from a Gaussian wavepacket $_0$ (r_0^0) = (2) $^{d=4}$ exp[ip $_0$ (r r_0) \dot{r}_0^0 $r_0\dot{f}=2$ 2] and approximate its time evolution by

The sem iclassical propagator is expressed as a sum over classical trajectories (labelled s) connecting r and r_0^0 in the time t. For each s, the partial propagator contains the action integral $S_{\rm s}^{\rm H}$ (r; r_0^0 ;t) along s, a M aslov index $_{\rm s}$ (which will drop out), and the determ inant $C_{\rm s}$ of the monodrom y matrix. Since we consider a narrow initial wavepacket, we linearize the action in $r_0^0-r_0$ and perform the integration over r_0^0 . After a stationary phase approximation, the sem iclassical delity reads

with initial momentum $p_s = @S_s = @r_0$.

Eqs. (2(4) are equally valid for regular and chaotic H am iltonians, as long as sem iclassics applies. Squaring the am plitude in Eq. (4) leads to a double sum over classical paths s and s^0 and a double integration over coordinates r

and r^0 . A coordingly, M (t) = M $^{(d)}$ (t) + M $^{(nd)}$ (t) splits into diagonal (s = s 0) and nondiagonal (s \in s 0) contributions. The diagonal contribution sensitively depends on whether H $_0$ is regular or chaotic. Ref. [6] found that M $^{(d)}$ (t) / exp(t) for chaotic dynam ics, with the Lyapunov exponent. We will show that the decay turns into a power law M $^{(d)}$ (t) / t $^{3d-2}$ for regular dynam ics. The nondiagonal contribution, on the contrary, is insensitive to the nature of the classical dynam ics (set by H $_0$), provided the perturbation H am iltonian V has no common integral of motion with H $_0$. Ref. [7] found that M $^{(nd)}$ (t) / exp(t) for chaotic dynam ics, with given by the golden rule spreading width of an eigenstate of H $_0$ over the eigenbasis of H . (This golden rule decay requires that is larger than the level spacing , but smaller than the bandwidth.) We will see that the same exponential decay of M $^{(nd)}$ (t) holds when H $_0$ is regular, so that M $^{(d)}$ (t) always dominates in the long time limit. Consequently, the delity decays exponentially, / exp[min(;)t] for chaotic systems, while for regular systems the decay is algebraic, / t $^{3d-2}$, as it is then set by the diagonal contribution. The golden rule width still determines the regime of validity of the power law decay via the condition > .

Continuing from Eq. (4), and still following Ref. [6], we write M $\,$ (t) as

with $S_s(r;r_0;t) = S_s^H(r;r_0;t)$ $S_s^{H_0}(r;r_0;t)$. Considering rst the diagonal contribution M $^{(d)}(t)$, we set $s = s^0$ and expand the phase di erence as

The points q and q^0 lie on the classical path with q(t) = r, $q^0(t) = r^0$, and $q(0) = q^0(0) = r_0$. In a regular system, the distance between two initially close points increases linearly with time, $jq(t) = q^0(t)j'$ (t=t) $jr = r^0j$. Here we depart from the exponential divergence / exp[(t t)] assumed in Ref. [6] for chaotic dynamics.

The spatial integrations and the sum s over classical paths in Eq. (5) lead to the phase averaging

Since V and H $_0$ have no common integral of motion, we may expect a fast decay of the correlations,

One then gets

The Gaussian integration over $r-r^0$ ensures that $r-r^0$, and hence $r_+-(r+r^0)\!=\!2-r$. One C $_s$ is then absorbed by a change of variable from r_+ to p_s , and the Gaussian integral over r-gives a factor / $t^{d=2}$. Finally, setting C $_s-t^d$ as is the case in a regular system , we arrive at

which is the central result of this paper. The power law (10) holds once the perturbation is strong enough to induce a golden rule spreading of the eigenstates of H $_0$ over the eigenbasis of H $_0$ (which is the range of validity [6,7] of the above sem iclassical approach), and under the assumption that the perturbation potential varies rapidly along a classical trajectory of H $_0$. We used this assumption to average the complex exponential in Eq. (7).] The decay exponent 3d=2 is insensitive to the choice (8) of a -function force correlator. Even a power-law decaying correlator / f f f with

1) results in the same exponent as in Eq. (10).

The nondiagonal contribution (s \in s⁰) to Eq. (5) is the same as in Refs. [6,7]. The phase averaging can be performed separately for s and s⁰ and one gets

The point q (t) lies on path s w ith q (0) = r_0 and q (t) = r. If V and H $_0$ have no com m on integral of m otion, the correlator of V gives the golden rule decay / exp(t) regardless of whether H $_0$ is chaotic or regular [15]. We conclude that for regular system s, the delity is dominated by the algebraically decaying diagonal contribution.

In order to check num erically the analytical result (10), we have studied the kicked top H am iltonian [1]

which describes a vector spin of conserved m agnitude S, undergoing a free precession around the y-axis, which is periodically perturbed (period) by sudden rotations around the z-axis over an angle proportional to S_z . Because S is conserved, H $_0$ is a one-dimensional H am iltonian (d = 1), with a two-dimensional classical phase space consisting of the sphere of radius S = 1. The canonically conjugated variables are ('; cos), where and ' are spherical coordinates.

The classical \lim it of the kicked top is given by the map [1]

in the cartesian coordinates $x=\sin\cos'$, $y=\sin\sin'$, and $z=\cos$. Depending on the kicking strength K, the classical dynamics is regular, partially chaotic, or fully chaotic. We consider a kicking strength K = 1:1 for which the dynamics is regular for most of phase space. We checked that our results are not sensitive to the value of K, as long as the dynamics remains regular.

The quantum mechanical time evolution after n periods is given by the n-th power of the Floquet operator

W e perturb the reversed time evolution by a periodic rotation of constant angle around the x-axis, slightly delayed with respect to the kicks in H $_{\rm 0}$,

The corresponding F loquet operator is F = $\exp(i S_x)F_0$. We set = 1 for ease of notation, and varied S between 250 and 1000 (both H and H $_0$ conserve the spin m agnitude). We calculated the average decay \overline{M} of M (t = n) = $\frac{1}{2}h_0\frac{1}{2}(F^y)^nF_0^n\frac{1}{2}oif$ taken over 50 to 200 initial G aussian wavepackets $_0$ of m inimal spreading (coherent states).




FIG. 1. Decay of \overline{M} for S=1000, K=1:1, and $10^5=1:5$, 4:5, and 10 (thick solid lines from right to left). The crossover from exponential to power-law decay is illustrated by the dotted-dashed line / $\exp[2:56\ 10^{-5}\,t]$ and the dashed line / $t^{-3=2}$. The dotted line gives the classical decay / t^{-1} . Inset: Decay of \overline{M} for K=1:1, $=10^{-4}$, and S=250, 500, and 1000 (solid lines from right to left). The dashed and dotted-dashed lines indicate the power law / $t^{-3=2}$ and exponential/ $\exp[2\ 10^{-4}\,t]$ decay, respectively. These plots show that the $t^{-3=2}$ decay is reached either by increasing the perturbation strength at xed spin magnitude S, or by increasing S at xed .

In Fig. 1 we show the decay of M for S = 1000 and dierent perturbation strengths . For weak perturbations, the decay of \overline{M} is exponential, and not Gaussian as one would expect from rst order perturbation theory

[5]. The reason why the perturbation operator S_x gives no rst order correction is that for K = 1:1, eigenfunctions of F_0 are almost identical to eigenfunctions of S_{γ} , so that diagonal matrix elements of V vanish in this basis. For weak , the local spectral density of states () consists then of a delta function at zero energy plus an algebraically decaying tail [14]. Because of the absence of a rst-order correction, the decay of the delity is given by the Fourier transform of this tail [10]. We numerically obtained a decay () / $(^2+^2=4)^1$ with / $^{1:5}$. The resulting exponential decay / exp (t) of the delity differs from the golden rule decay / exp(t) with / 2 . As increases, the decay of M turns into the predicted power law / t $^{3=2}$, which prevails as soon as one enters the golden rule regime, i.e. for = $^{2}S^{3} > 1$ [7]. One therefore expects the power law decay to appear as S is increased at xed , which is indeed observed in the inset to Fig. 1.

We checked that these results are not sensitive to our choice of H am iltonian, by replacing $S_{\rm x}$ in Eq. (15) with $S_{\rm z}^2$ (this is the model used in Ref. [11]) and also by studying a kicked rotator as an alternative model to the kicked top. These numerical results all give clear conomnation of the power law decay (10).

It is instructive to contrast these results for the decay of the overlap of quantum wavefunctions with the decay of the overlap of classical phase space distributions, a \classical delity" problem that has recently been investigated [9,11,13]. We assume that the two phase space distributions $_{0}$ and are initially identical and evolve according to the Liouville equation of motion corresponding to the classical map (13) for two dierent Hamiltonians H $_{0}$ and H . We consider regular dynamics and ask for the decay of the normalized phase space overlap




FIG .2. Decay of the average overlap (16) of classical phase space distributions, for the kicked top with K = 1:1 and = 1:7 10 4 (solid line). The dotted and dashed lines give the classical and quantum power law decays / t 1 and / t $^{3\text{--}2}$, respectively.

We have found above that a factor / t $^{d=2}$ in the decay of the quantum delity M (t) / t $^{3d=2}$ originates from the action phase di erence and is thus of purely quantum origin. O ne therefore expects a slower classical decay M $_{\rm C}$ (t) / $\underline{C_{\rm S}}$ / t $^{\rm d}$. In Fig. 2 we show the decay of the averaged M $_{\rm C}$ taken over 10^4 initial points within a narrow volume of phase space $\underline{\sin}$ ', for K = 1:1 and = 1:7 10^4 . The decay is M $_{\rm C}$ / t 1 , and clearly di ers from the quantum decay / t $^{3=2}$.

The power law decay prevails for classically weak perturbations, for which the center of mass of and $_0$ stay close together. [This is required by the stationary phase condition leading to Eq. (4).] Keeping xed, and increasing the perturbation strength , the invariant tori of H $_0$ start to dier signicantly from those of H on the resolution scale , giving a threshold $_c$. Above $_c$, the distance between the center of mass of $_0$ and increases with time / t and one expects a much faster decay M $_c$ (t) / exp[const $_c$ 1] for classical G aussian

phase space distributions [13]. Quantum mechanically, = 1=S (the e ective P lanck constant) and the threshold translates into $_{\rm C}$ 1=S, coinciding with the upper boundary of the golden rule regime. As long as one stays in that regime, the perturbation will a ect the phase in Eq. (7), and result in the anomalous power law decay / t $^{\rm 3d=2}$.

In conclusion, our investigations of the Loschm idt E cho (1) in the generic regime of classically quasi-integrable dynamics show that its decay is dominated by the power law M (t) / t . While from purely classical considerations one expects an exponent $_{\rm C}$ = d, we sem iclassically obtain an anomalous exponent = 3d=2. This is corroborated by numerical simulations. The power law decay is to be contrasted with the exponential decay found for chaotic systems, thereby providing for a novel \quantum signature of chaos".

- [15] This conclusion, that the golden rule decay holds whether H $_0$ is regular or chaotic, can also be obtained via a fully quantum mechanical approach based on random -matrix theory assumptions for V . The invariance under unitary transformations of the distribution of V is succient to obtain the exponential decay M $^{(nd)}$ (t) / exp(t), irrespective of the distribution of H $_0$.
