# Experim ental preparation of $W$ erner state $v i a$ spontaneous param etric dow n -conversion

#### Abstract

W epresent an experim ent of preparing $W$ emer state $v i a$ spontaneous param etric dow $n$-conversion and controlled decoherence of photons in this paper. In this experim ent two independent BBO (beta-barium borate) crystals are used to produce dow $n$-conversion light beam $s$, which are $m$ ixed to prepare $W$ emer state.

## I. IN TRODUCTION

Entanglem ent is not only one of the $m$ ost striking features of quantum $m$ echanics, it also plays a crucial role in the eld of quantum inform ation $\left[\begin{array}{l}{[17,5] \text {. E ntangled states are im portant resources for } m \text { ost applications of quantum }}\end{array}\right.$
 correction [l] 1 ] etc. A lthough the best perform ance of such tasks requires $m$ axim ally entangled states (Bell states), the decoherence e ects due to the environm ent $m$ ake the pure entangled state into a statisticalm ixture and degrade quantum entanglem ent in the realw ord. For a practicalpurpose, a puri cation schem em ay be applied to the degraded entanglem ent $\left[\begin{array}{ll}\text { [19, } \\ 1,1 \\ -1\end{array}\right]$.

O ne of the m ost im portant degraded Bell states is $W$ emer state $[1010]$, $W$ emer state in 2 system takes the follow ing form [8]:

$w$ here $I_{n}$ denotes the $n \quad n$ identity $m$ atrix and $j \quad i$ is the singlet state of the four $B$ ell states

The $W$ emer state $w$ is characterized by a single realparam eter $F$ called delity. This quantity m easures the overlap of W emer state with a Bell state. In the case where F $61=2$, the state is separable, and thus has no entanglem ent to recover or $m$ aintain. And a $W$ emer state w th $F>2+3 \overline{2}=8 \quad 0: 78$ violates the $C$ lauser $H$ ome-Shim ony $H$ olt (C H SH ) inequality [11 [1]

There are $m$ any theoretical investigations on $W$ emer state [ $\left.{ }^{-}{ }^{-}{ }^{\prime}\right]$, and the $W$ emer state plays an im portant role in entanglem ent puri cation " of experim ental realization of $W$ emer state to date. At present, the most accessible and controllable source of entanglem ent is obtained from the process of spontaneous param etric dow n-conversion in a nonlinear crystal. In this paper, we present an experim entalpreparation ofbi-photon $W$ emer state via spontaneous param etric dow n-conversion and the prepared state is in the form

C. Zhang $\left[\overline{2}^{-1} 1\right]$ has proposed a theoretical protocolto produce an arbitrary tw o-bit m ixed state by using beam splitters $w$ ith variable polarization transm ission coe cients and single-m ode optical bers. H ow ever, in this paper, we propose a di erent way to prepare $W$ emer states conveniently in experim ent.

This paper is organized as follow s . In Sec. II, the experim ental set-up is described. T he experim ental results is given in Sec. III and the discussion and sum $m$ ary is given in Sec. IV .

## II. EXPERIMENTALSETHP

In our experim ent, the $W$ emer state is bi-photon's polarization state, which is obtained by m ixing a com plete m ixed state and an entangled state.
$T$ he experim ental set-up is depicted in $F$ ig. 1. The 1.7 mm -diam pum p beam at 351.1 nm (single line, 100 mW ) is produced by an argon ion laser (C oherent, Sabre, m odel D BW 25/7), and directed to the rst BBO (beta-barium borate) crystal (cut for type-I phase m atching, optic axis cut at $=35: 0,1 \mathrm{~mm}$ thick) after passing through a polarizing beam splitter (PBS) to give a pure horizontalpolarization state. Two entangled photon beam s (polarized in verticaldirection) produced by the BBO crystalpassing through a sequence of quartz plates, with an optic axis set in the diagonal direction. It is pointed out that the photon polarization state $w i l l$ decohere in such an environm ent [1]. The thickness of quartz plates is set in such a way that the photon's polarization decoheres com pletely (See Ref. $\left[27_{1}\right]$, the di erence betw een optical path of horizontal and vertical optical polarizations in the quartz plates is 1530 , and 0 is the central w ave length of the dow n-converted light.). The rem ained pum $p$ beam passes through the BBO crystal and is rotated to $P^{\frac{1}{2}}(\neq 1+j V i)$ by a halfw ave plate ( $H W P$ ) and is transm itted through the second BBO crystal which is the sam e as that proposed by $K$ w iat in Ref. [ such a state. The dow n-converted light beam s produced by the rst BBO were re ected by four re ectors and passed through the second BBO crystalto be m ixed w ith the dow n-converted beam sproduced in the second BBO.N ote the reason that the pum $p$ w as set in single line instead of single frequency is to decrease the coherent length (about 4 cm in our experim ent) of the pum $p$ light and avoid the interference betw een the dow $n$-converted light beam $s$ from the two BBO crystals.

At the end, the bi-photon polarization state is m easured tom graphically $[1]$ HW P and PBS.W e use 16 analyzer settings as listed in Table I. T he photons are detected by using silicon avalanche photodiodes ( $E G \& G, S P C M-A Q R$ ) operated in the geiger mode. Each detector is preceded by a sm all iris (the diam eter is 1.5 mm ) to de ne the spatialm ode, a narrowband interference ler ( $\mathbb{F}$ ) centered at 702 nm (A ndover, 050FC 46-25/7022 [23'], full width at half is equal to 4.62 nm ) to reduce background and de ne the bandw idth of the photons, and a collection lens. The detector outputs are recorded in coincidence with a tim e-to-am plitude converter and a single-channel analyzer, leading to an e ective coincidence window of 5 ns . The resulting rate of accidental coincidences is less than $1 s^{1}$, which can be neglected com pared w ith the typical rate of the true coincidences, which is about $300 \mathrm{~s}^{1}$.

We also test whether the states produced by this set-up violate the CHSH inequality. This inequality show s that IS j 2 for any local realistic theory, where

and $C(1 ; 2)$ is the coincidence rate of two detectors $w$ hen the polarization analyzer angels are set in 1 and 2 . In this experim ent, we selected the settings: ${ }_{1}=22: 5, \underset{i}{i}=67: 5,{ }_{1}^{0}=22: 5,{ }_{1}^{0}=112: 5,2=0, \stackrel{?}{2}=90$, ${ }_{2}^{0}=45,{ }_{2}^{0 ?}=135$.

W e can adjust the intensity proportion (it can be tuned by adjusting the position of the re ectors) betw een the dow n-converted light from tw O B BO crystals to obtain $W$ emer states $w$ th di erent coe cients $x$. Two output states have been produced in this experim ent, for one of them the CHSH inequality is violated while the other is not.
$T$ he tom ographic results are shown in Table I.

The tom ographic results of the second output are shown in the sixth colum $n$ of $T a b l e ~ I$. From these data we can obtain the density $m$ atrix of the second output state

where $x_{2}=0: 405$ 0:005 and the delity $F\left(2 ;{ }_{2}\right)$ is equalto 0:982. TheCHSH correlation value jS j=1:380 0:008< 2, which satis es the CHSH inequality. The theoretical value of $j$ jof state ${ }_{2}^{0}$ is equal to $1: 146$. W e should note that there is signi cant di erence in count rates betw een the tw o sets of results. In our experim ent, the intensity proportion of dow n-converted light beam sbetw een tw O BBO crystals is tuned by adjusting the position of the re ectors. So the length of dow n-converted photon's optical path betw een the source and the detector has been changed for preparing the second state. T herefore, the count rates have been decreased signi cantly.
$W$ e can use the \linear entropy" to quantify the degree ofm ixture of a quantum state and use the tangle to m easure the degree of entanglem ent of a tw o-bit quantum state [1] [25]. The linear entropy for a two-bit system is de ned by

The tangle is de ned as $T=C^{2}$, where $C$ is the concurrence in Ref. $\left.\underline{N} \overline{5}_{1}^{\prime}\right]$. In this experim ent, for the rst density $m$ atrix in Eq. (4), $P=0: 46 \quad 0: 03$ and $T=0: 35 \quad 0: 01$, and for the second density $m$ atrix in $E q$. (7), $P=0: 83 \quad 0: 03$ and $T=0: 01 \quad 0: 00$.
$W$ e have prepared tw o typicalW emer states in this experim ent and $m$ easured the density $m$ atrix tom ographically. T w o independent BBO crystals are used to produce param etric down-conversion light beam swhich can be m ixed to prepare a w ide range of tw $0-b i t$ quantum states. In our experim ent, the intensity proportion of dow n-converted light beam sbetw een tw o BBO crystals are tuned by adjusting the position of the re ectors. In fact, the proportion can be tuned with linear optical elem ents, which is shown in Fig. 2.

A though the output light beam s were produced by classically mixing (not quantum superposing) the downconverted light beam $s$, it is hard (but not in principle) to distinguish from which crystals the output photon is produced since the pump light is continuous. H ow ever, if we use the pulse pum $p$ we can distinguish which crystal the output photon from by $m$ easuring the photon's arrival tim $e$, that is, we can distill the classical inform ation of the $m$ ixed state and it can be regarded as a pure state.
$W$ e expect that this $m$ ethod can be $m$ odi ed to prepare arbitrary two-bit states conveniently and this source can be used in experim ental investigation of entanglem ent puri cation or other quantum inform ation tasks.

W here $n_{H}\left(n_{V}\right)$ is the refractive index of horizontal (vertical) polarization. It is necessary to note that although $n_{H}$ and $n_{V}$ are dependent on frequency !, the value of $n_{H} \quad n_{V}$ does not vary obviously w th frequency varying in $a$ sm all scale and we regard it as constant. The density operator of the polarization state can be obtained by tracing over frequency degrees of freedom from the com plete density operator

From Eq. (A -3) it can be seen that the evolution of the polarization's states depend on the character of the \environm ent" which is described by the fiunction A (!).

The spectrum of the photon's frequency is de ned by the narrowband interference $\mathbb{t e r}$ ( $\mathbb{F}$ ). In this experim ent, the spectrum of the photon's frequency is rectangular function. To obtain this environm ent, we use an interference
lter whose spectrum 's shape is approxim ate to rectangle and the fullwidth at halfmaxim um (FW HM) is $=4: 62$ nm . (A ndover, 050FC 46-25/7022 [23]). The theoretical value of $(x)$ is

The results are show $n$ in F ig. 4. The coherence of the photon's polarization degenerates as theoretical expected.. It is interesting that the coherence is recovered to som e extent after it degenerated com pletely, which is sim ilar to the Fraunhofer di raction at a rectangular aperture (or slit) '" rectangular, there are som e deviations at the tail of curve.
