## Quantum computation with unknown param eters

We show how it is possible to realize quantum computations on a system in which most of the parameters are practically unknown. We illustrate our results with a novel implementation of a quantum computer by means of bosonic atoms in an optical lattice. In particular we show how a universal set of gates can be carried out even if the number of atoms per site is uncertain.

Scalable quantum computation requires the implementation of quantum gates with a very high delity. This in plies that the param eters describing the physical system on which the gates are performed have to be controlled with a very high precision, something which it is very hard to achieve in practice. In fact, in several system s only very few param eters can be very well controlled, whereas other posses larger uncertainties. These uncertainties may prevent current experiments from reaching the threshold of fault tolerant quantum computation (i.e. gate delities of the order of 0:9999 [2]), that is, the possibility of building a scalable quantum com puter. For exam ple, in quantum com puters based on trapped ions or neutral atom s  $[\beta]$ , the relative phase of the lasers driving a Ram an transition can be controlled very precisely, whereas the corresponding R abi frequency

has a larger uncertainty . If we denote by T the time required to execute a gate (of the order of 1), then a high gate delity requires T 1 (equivalently, = 1), which may very hard to achieve, at least to reach the above m entioned threshold.

In this letter we show how to achieve a very high gate delity even when most of the param eters describing the system cannot be adjusted to precise values. O urm ethod is based on the technique of adiabatic passage, com bined with some of the ideas of quantum control theory. We will illustrate our method with a novel implementation of quantum computing using atoms con ned in optical lattices [7]. If the number of atom s in each of the potential well is uncertain, which is one of the problem s with this kind of experiments, most of the parameters will have an uncertainty of the order of the parameter itself(e.g. j j ), which under norm al circum stances will give rise to very poor delities and even in pede the perform ance of quantum gates. As we will show, using our method not only quantum computation is possible but even very high delities could be achieved.

The use of adiabatic passage techniques to implement quantum gates is, of course, not a new idea. In fact, severalmethods to perform certain quantum gates using Berry phases have been put forward recently [8, 9, 10]. Furthermore, adiabatic passage techniques have been proposed as a way of implementing a universal set of holonomies [10], i.e. quantum gates which are carried out by varying certain parameters and whose outcome only depends on geom etrical properties of the paths in param eter space [8]. In all these proposals, physical im – plem entations of standard quantum computation have been adapted so that the quantum gates are performed in an adiabatic way giving rise to holonomies. Despite its clear fundam ental interest, it is not clear yet if such a novel way of im plem enting the quantum gates may o er real bene ts with respect to the original proposals. In contrast, in our illustrative exam ple adiabatic passage is required to perform quantum gates and therefore it is an essential tool not only to achieve the desired precision but also to build a quantum computer at all.

The outline of the paper is as follows. First we will show how to produce a universal set of gates (H adam ard, phase, and CNOT) starting from two H am iltonians in which only one parameter is precisely controlled. Then we will show that this method eliminates an important obstacle in a particular physical scenario that has been proposed for quantum computation [7], namely a set of atom s in optical lattices interacting via cold collisions.

Let us consider a set of qubits that can be manipulated according to the single qubit H am iltonian

and the two{qubit Ham iltonian

A sm entioned above, we will assume that most of the param eters appearing in these Ham iltonians are basically unknown. On the other hand, we will not consider any random ness in these param eters (the corresponding errors could be corrected with standard error correction m ethods [5], as long as they are sm all). In particular we will assume that only ' can be precisely controlled. For the other parameters we will assume that: (1) they are given by an unknown (single valued) function of some experim entally controllable param eters; (2) they can be set to zero. For example, we may have = f(I), where I is a parameter that can be experimentally controlled, and we only know about f that f(0) = 0 and that we can reach som e value m f(Im) € 0 for som e Im [1]. Below we analyze a particular physical scenario which exactly corresponds to this situation. How ever, we want to stress




FIG.1: Schema of how the parameters of H am iltonian (1) have to be changed in order to perform a phase gate (a), and H adam and gate (b). In Fig. (c) we show a possible evolution of the parameters and for the H adam and gate.

that this situation can be naturally found in more general scenarios. For exam ple, for atom ic qubits the states Di and jlimay correspond to two degenerate atom ic (ground state) levels which are driven by two lasers of the same frequency and di erent polarization. The corresponding Hamiltonian is given by (1), where the param eters '; ; describe the relative phase of the lasers, the Rabi frequency and detuning of the two-photon Ram an transition, respectively. The Rabi frequency can be changed by adjusting the intensity of the lasers, and the detuning and the phase di erence by using appropriate modulators. In practice, () can be set to zero very precisely by switching o the lasers (modulators) and ' can be very precisely controlled to any number between 0 and 2. However, xing or to a precise value (for example, 23:098 kHz) may be much more challenging.

The idea of obtaining perfect gates with unknown param eters relies on the combination of adiabatic passage techniques [8] and ideas of quantum control [11]. Let us recall the basic idea of adiabatic passage. Suppose we have a H am iltonian that depends param etrically on a set of param eters, denoted by p, which are changed adiabatically with time along a given trajectory p(t). A fiber a time T, the unitary operator corresponding to the evolution is given by

$$U(T) = e^{i(+)} j [p(T)]ih [p(0)]j; (3)$$

Here, j (p)i are the eigenstates of the Ham iltonian for which the parameters take on the values p. The phase

is a dynam ical phase that explicitly depends on how the parameters p are changed with time, whereas the phase is a purely geom etrical phase ands depends on the trajectory described in the parameter space. Our basic idea to perform any given gate is rst to design the change of the parameters in the Ham iltonians (1)-(2) such that the eigenvectors evolve according to the desired gate, and then to repeat the procedure changing the param eters appropriately in order to cancel the geom etric and dynam ical phases.

Let us rst show how to perform the phase gate  $U = e^{i_z^2}$ . We set = 0 for all times. The parameters (;') have to be changed as follows [see Fig. 1(a)]:

Steps (i,ii) and (iv,v) are performed adiabatically and require a time T. The double arrow of step (iii) indicates a sudden change of parameters. Note that (0) =

(2T) = 0, (t) = (2T t) and '(t) = + '(2T t), which does not require the know ledge of the function f but in plies a precise control of the phase. A simple analysis shows that (i-v) achieve the desired transform ation  $\mathcal{D}i ! e^{i=2}\mathcal{D}i$ ,  $\mathcal{J}i ! e^{i=2}\mathcal{J}i$ . Note also that the dynam ical and geom etrical phases acquired in the adiabatic processes (i-v) cancel out.

The H adam and gate can be perform ed in a similar fashion. In the space of [;  $_x = \cos(')$ ], the protocol is

as shown in Fig.1 (b-c). In order to avoid the dynam ical phases, we have to make sure that steps (i-v) are run in half the time as (vi-vii). More precisely, if t < T, we must ensure that (t) = (T t),  $_x(t) = _x(T t)$ , (T + t) = (t=2) and  $_x(T + t) = _x(t=2)$ . W ith this requisite we get  $\frac{p_1}{2}$  (jDi + jLi) ! jDi,  $\frac{p_1}{2}$  (jDi - jLi) !

jli. A gain, the whole procedure does not require us to know or , but rather to control the evolution of the experim ental parameters which determ ine them .

The C-NOT gate requires the combination of two two-qubit processes using H<sub>2</sub> and one local gate. The rst process involves changing the parameters [~; ~<sub>x</sub> =  $-\cos(')$ ] of Eq. (2) according to

This procedure gives rise to the transform ation

where  $= \frac{R_T}{0}$  (t)dt is an unknown dynam ical phase. The second operation required is a NOT on the rst qubit  $U_2 = (j)ihlj + jlih0j$  II. Finally, if  $^{(1)}$  (t) denotes the evolution of  $\sim$  in Eq. (6), we need to follow a path such that  $^{(3)}$  (t)  $= ^{(1)}$  (t),  $^{(3)}$  (t) = 0. If the tim ing is correct, we achieve the transform ation




FIG. 2: Log-log plot of the gate error, E = 1 F, for di erent local and nonlocal gates. (a) Realization based on H am iltonians (1)-(2), with xed param eters and varying time. W e plot the error for the H adam ard (solid), phase (dashed) and CNOT gates (dotted). (b-d) Errors for our proposal with atom ic ensembles. W e x the the total time all param eters except the interaction constant U<sub>bb</sub>. In (b-c) we plot realizations for n = 1 (solid) and n = 3;5 (dashed) atom sper lattice site. In (d) we plot simulations with a di erence of atom s of jn m j= 0;1;2 between both wells (solid, dash and dotted lines). The vaues of the param eters are given in the text.

Everything combined gives us the CNOT up to a global unimportant phase  $U_{cnot} = j0ih0j$  II+ jlihlj  $i_y = e^{i} U_2 U_3 U_2 U_1$ .

In Fig. 2(a) we illustrate the performance of our method, as well as its sensitivity against non {adiabatic processes. As a gure of merit we have chosen the gate delity [5]  $F = j\Gamma rfU_{ideal}^{y}U_{real}gg^{2}=d^{2}$ , where d is the dimensionality of the space (2 for local gates, 4 for two-qubit gates),  $U_{ideal}$  is the gate that we wish to produce and  $U_{real}$  is the actual operation performed. As expected, for xed parameters  $f_{m} = m = \tilde{m} = \tilde{m} = 1 = 10$ ; m = = 4g, the adiabatic theorem applies when the processes are performed with a su ciently slow speed. Typically a time T  $300 = m;300 = \tilde{m}$  is required for the desired delity F = 1  $10^{4}$ .

Let us now consider a set of bosonic atom s con ned in a periodic optical lattice at su ciently low temperature (such that only the rst B loch band is occupied). The atom s have two relevant internal (ground) levels, jai and jbi, in which the qubit is stored. This set-up has been considered in R ef. [7] where it has been shown how single quantum gates can be realized using lasers and two {qubit gates by displacing the atom s that are in a particular internal state to the next neighbor location. The basic ingredients of such a proposal have been recently realized experimentally [12]. How ever, in this and all other schemes so far [13] it is assumed that there is a single atom per lattice site since otherwise even the concept of qubit is no longer valid. In present experiments, in which the optical lattice is loaded with a Bose-E instein condensate [4, 6], this is not the case (since zero temperature is required and the number of atom s must be identical to the number of lattice sites). We show now a novel implementation in which, with the help of the methods presented above, one overcom es this problem.

For us a qubit will be form ed by an aggregate of atom s at some lattice site. The number of atom s form ing each qubit is completely unknown. The only requirement is that there is at least one atom per site [14]. We will denote by  $n_k$  the number of atom s in the k {th well and identify the states of the corresponding qubit as

where  $a_k^y$  ( $b_k^y$ ) are the creation operators for one atom in levels jai and jbi, respectively. The quantum gates will be realized using lasers, switching the tunneling between neighboring sites, and using the atom {atom interaction.

In the absence of any external eld, the H am iltonian describing our system is

Here,  $U_{bb}$  and  $J_k^{(b)}$  describe the interactions between and the tunneling of atom s in state jbi. We will assume that  $J_k^{(b)}$  can be set to zero and increased by adjusting the intensities of the lasers which create the optical lattice. We have assumed that the atom s in state jai do not interact at all and do not hop, something which may be achieved by tuning the scattering lengths and the optical lattice. Both restrictions will be relaxed later on. The Ham iltonian (10) possesses a very in portant property when all  $J_k^{(b)} = 0$ , namely it has no e ect on the computational basis (i.e. H j i = 0 for all states j i in the H ilbert space generated by the qubits). O therw ise, it would produce a non {trivial evolution that would spoil the computation.

We show now how a single qubit gate on qubit k can be realized using lasers. First, during the whole operation we set  $J_k^{(b)} = 0$  in order to avoid hopping. The laser interaction is described by the H am iltonian

For  $U_{bb}$  j<sub>k</sub> j we can project the total H am iltonian acting on site k by an elective H am iltonian acting on the qubit which resembles (1), with = k and  $= k \frac{p}{n_k} \frac{1}{n_k}$ . Thus, using the methods exposed above we can achieve the H adam and and phase gates with a high precision, even though the coupling between the bosonic ensemble and light depends on the number of atom s.

For the realization of the two-qubit H am iltonian (2) we need to com bine several elem ents. First of all we need the R am an coupling of Eq. (11) to operate on the second well. Second, we need to tilt the lattice using a m agnetic eld [4] which couples to states jai and joi di erently, H tilt =  $_{\rm k}$  kg ( $a_{\rm k}^{\rm y}a_{\rm k}$   $b_{\rm k}^{\rm y}b_{\rm k}$ ). And nally we must allow virtual hopping of atom s of the type jbi (J <sup>(b)</sup> jJ <sub>bb</sub> g). A fler adiabatic elim ination we nd that the e ective H am iltonian depends on the number of particles in the second site, n<sub>2</sub>,

The identi cation with Eq. (2) is evident, and once m ore the use of adiabatic passage will produce gates which are independent of the num ber of particles.

W e have studied the di erent sources of error which may a ect our proposal: (i) U  $_{\rm bb}$  is nite and (ii) atom s in state jaim ay hop and interact. These last phenom ena are described by additional contributions to Eq. (10) which are of the form  $J_k^{(a)}(a_k^y a_{k+1} + a_{k+1}^y a_k), U_{aa}a_k^y a_k^y a_k a_k$ , and  $U_{ab}a_{k}^{y}b_{k}^{y}a_{k}b_{k}$ . The consequences of both imperfections are: (i) more than one atom per well can be excited, (ii) the occupation numbers may change due to hopping of atom s and (iii) by m eans of virtual transitions the e ective H am iltonian di ers from (1) and (2). The e ects (i)-(ii) are eliminated if  $(=U_{bb})^2$  1 and  $(U_k^{(a)}=U_{bb})^2$ 1. Once these conditions are met, we may analyze the remaining errors with a perturbative study of the Ham iltonians (11) and (10) plus the term s  $(J^{(a)}; U_{ab}; U_{aa})$  that we did not consider before. In Eq. (11), the virtual excitation of two atoms increments the parameter by an  $+ 2 ^{2}n_{k} = ( + U_{ab})$ unknown am ount, <sub>eff</sub> U<sub>bb</sub>).  $U_{bb}$  and  ${}^{2}n_{k}T = U_{bb}$  1, this shift may be ne-IfUab glected. In the two-qubit gates the energy shifts are instead due to virtual hopping of all types of atom s. They are of the order of m ax  $(J^{(b)}; J^{(a)})^2 = g^2$   $J^2 = U_{bb}$ , and for  $J^2 T = U_{bb}$ 1 they also may be neglected.

To quantitatively determ ine the in uence of these errors we have simulated the evolution of two atom ic ensembles with an elective H am iltonian which results of applying second order perturbation theory to Eq. (10), and which takes into account all important processes. The results are shown in Figs. 2 (c-d). For the two-qubit gate we have assumed  $U_{aa} = U_{ab}$ ,  $J^{(a)} = J^{(b)} = J$ ,  $J_m = 0.05U_{ab}$ ,  $_m = J_m^2 = 10$ ,  $g = U_{bb} + U_{ab} = 2$  and operation time, T = 200 = m, while changing the ratio  $U_{bb} = U_{ab}$  and the populations of the wells. For the local gates we have assumed  $_m = 1$ ,  $_m = U_{bb} = 10$  and di erent occupation numbers  $n_k$ , and we have also changed  $U_{bb} = m$ .

W e extract several conclusions. First, the stronger the interaction between atom s in state pi, the smaller the

energy shifts. Typically, a ratio  $U_{bb} = 10^4 U_{ab}$  is required to make F = 1 10<sup>4</sup>. Second, the larger the number of atom s per well, the poorer the delity of the local gates Figs. 2 (b-c)]. And nally, the delity of the twoqubit gate presents a sm all dependence on the population im balance between wells.

In this work we have shown that it is possible to perform quantum computation even when the constants in the governing Ham iltonians are unknown. We have developed a scheme based on perform ing adiabatic passage with one-qubit (1) and two-qubit (2) Ham iltonians. W ith selected paths and appropriate tim ing, it is possible to perform a universal set of gates (Hadam and gate, phase gate and a CNOT). These procedures cannot only be used for quantum computing but also for quantum sim ulation [15]. Finally, based on the preceding ideas, we have proposed a scheme for quantum computing with cold atom s in a tunable optical lattice. Our schem e works even when the num ber of atom s per lattice site is uncertain. Note that, these ideas also apply to some other setups like the m icrotraps recently realized in Ref. [16].

How ever in many realistic in plan entations this is not possible, since the measurements are destructive (lead to heating or the atom s escape the trap), and in di erent realizations the dependence is di erent.
