## Storage of energy in con ned quantum systems

U sing the non-perturbative m ethod of dressed states introduced in previous publications, we study the evolution of a con ned quantum m echanical system embedded in a ohmic environment. Our approach furnishes a theoretical m echanism to control inhibition of the decay of excited quantum systems in cavities, in both weak and strong coupling regimes. In recent publications [1,2] a method (dressed states) has been introduced that allows a non-perturbative approach to situations where a material body (an atom or a B rownian particle) is coupled to a eld, provided that the interaction between the parts of the system can be approximated by a linear coupling. From now on we use the term "particle" in a general sense, referring to an atom, a B rownian particle a molecule, etc.... Our dressed states can be viewed as a rigorous version of the sem iqualitative idea of dressed atom introduced originally in ref. [3], which can be constructed in reason of the linear character of our problem. M ore precisely, the method applies for all systems that can be described by an H am iltonian of the form,

where the subscript 0 refers to the "m aterial body" and k = 1;2;::N refer to the harm onic environment m odes. A Ham iltonian of this type, describing a linear coupling of a particle with an environment, has been used in [4] to study the quantum B rownian motion of a particle with the path-integral form alism. The lim it N ! 1 in Eq.(1) is understood. We investigate also the behaviour of the system as a function of the strenght of the coupling between the particle and the bath. In particular we give explicitly non-perturbative form ulas for the decay probability of the particle in the weak and strong coupling regim es.

We consider the problem of a particle  $q_0$  in the harmonic approximation having (bare) frequency  $!_0$  coupled to N other oscillators  $q_i$  of frequencies  $!_i$ ; i = 1;2;...N. In the limit N ! 1 we recover our situation of the coupling particle bath (eld) after rede nition of divergent quantities. The bilinear Hamiltonian (1) can be turned to principal axis by means of a point transformation,  $q = t^r Q_r$   $p = t^r P_r$ ; = (0;fkg); k = 1;2;...N; r = 0;...N; performed by an orthonormal matrix  $T = (t^r)$ . The subscript = 0 and = k referrespectively to the particle and the harmonic modes of the

bath and r refers to the norm alm odes. In term s of norm alm om enta and coordinates, the transform ed H am iltonian in principal axis reads,  $H = \frac{1}{2} \sum_{r=0}^{N} (P_r^2 + \sum_{r=1}^{2} Q_r^2);$ where the 'r's are the norm al frequencies corresponding to the possible collective stable oscillation m odes of the coupled system . The matrix elements t<sup>r</sup> are given by [1]

We take  $q_k = (!_k)^n$ . In this case the environment is classied according to n > 1, n = 1, or n < 1, respectively as suprachmic, ohmic or subchmic. For a subchmic environment the sum in Eq.(3) is convergent and the frequency  $!_0$  is well de ned. For ohmic and suprachmic environments the sum in the right hand side of Eq.(3) diverges what makes the equation meaningless as it stands, a renormalization procedure being needed. In this case, by a straightforward generalization of the method described in [1] we can de ne a renormalized frequency !, by means of a counterterm !<sup>2</sup>,

in term s of which Eq.(3) becomes,

with the notation E [n] standing for the smallest integer containing n. We see that in the lim it N ! 1 the above procedure is exactly the analogous of naive mass renormalization in Quantum Field Theory: the addition of a counterterm  $!^2q_0^2$  allows to compensate the in nuty of  $!_0^2$  in such a way as to leave a nite, physically meaninful renormalized frequency !. This simple renormalization scheme has been originally introduced in ref. [5].

To proceed, we take the constant as  $= \frac{P}{2g!}$ , ! being the interval between two neighbouring bath frequencies (supposed uniform) and where g is some constant [with dimension of (frequency)<sup>2</sup>]. For reasons that will become apparent later, we restrict ouselves to the physical situations in which the whole system is conned to a cavity of diameter L, and the environment frequencies  $!_{\,\rm k}$  can be writen in the form

Then using the form ula,

and restricting ourselves to an ohm ic environm ent, Eq.(5) can be written in closed form ,

The solutions of Eq.(8) with respect to give the spectrum of eigenfrequencies r corresponding to the collective norm alm odes.

The transform ation m atrix elements turning the m aterial body-bath system to principal axis is obtained in terms of the physically meaningful quantities r, !, after some rather long but straightforw ard manipulations analogous as it has been done in [1]. They read,

To study the time evolution of the particle, we start from the eigenstates of our system, represented by the norm alized eigenfunctions,

where H  $n_s$  stands for the  $n_s$ -th H erm ite polynom ial and  $_0$  is the normalized vacuum eigenfunction. We introduce dressed coordinates  $q_0^0$  and  $fq_i^0 g$  for, respectively the dressed atom and the dressed eld, de ned by [1],

valid for arbitrary L and where ! = f!;  $!_{i}g$ , and let us de ne for a xed instant the complete orthonorm alset of functions [1],

where  $q^0 = q_0^0; q_1^0, ! = f!; !_ig$ . Note that the ground state  $_0$  in the above equation is the same as in Eq.(10).

The invariance of the ground state is due to our de nition of dressed coordinates given by Eq. (11). Each function

 $_{0-1}$  ::: (q<sup>0</sup>) describes a state in which the dressed oscillator q<sup>0</sup> is in its the excited state. Using Eq.(11) the functions (12) can be expressed in terms of the normal coordinates Q<sub>r</sub>. But since (10) is a complete set of orthonormal functions, the functions (12) may be written as linear combinations of the eigenfunctions of the coupled system, and conversely.

Let us call  ${}^0_1 = {}_{100:::0()0:::}$  the con guration in which only the dressed oscillator  $q^0_0$  (the dressed particle) is in the rst excited level. Then it is shown in [1] the following expression for the time evolution of the rst-level excited dressed particle  $q^0_0$ ,

From Eq.(13) we see that the initially excited dressed particle naturally distributes its energy am ong itself and all other dressed oscillators (the environment) as time goes on, with probability am plitudes given by the quantities  $f_0$  (t) in Eq.(13). In Eq.(13) the coe cients  $f^0$  (t) have a simple interpretation:  $f^{00}$  (t) and  $f^{0i}$  (t) are respectively the probability am plitudes that at time t the dressed particle still be excited or have radiated a quantum of frequency h! i. W e see that this form alism allows a quite natural description of the radiation process as a simple exact time evolution of the system . In the case of a very large cavity (free space) ourm ethod reproduces for weak coupling the well-known perturbative results [1,2]. Nevertheless it should be remarked that due to our approximations to be done below for the con ned system, we can not recover free space results from our con ned system .

N ext we study the time evolution process of the conned dressed particle when it is prepared in such a way that initially it is in its rst excited state. We shall consider the situation of the particle con ned in a cavity of diameter L.

Let us now consider the ohm ic system in which the particle is placed in the center of a cavity of diam eter L, in the case of a small L, in: that satis es the condition of being much smaller than the coherence lenght, L << 2c=g. We note that from a physical point of view, L stands for either the diam eter of a spherical cavity or the spacing between in nite paralellm irrors. To obtain the eigenfrequencies spectrum, we remark that from a graphical analysis of Eq.(8) it can be seen that in the case of small values of L, its solutions are very near the frequency values corresponding to the asymptots of the curve  $\cot(\frac{L}{2c})$ , which correspond to the environm ent m odes  $!_i = i2$  c=L, except from the smallest eigenfrequency are nearer and nearer to the values corresponding to the

asymptots. For instance, for a value of L of the order of 2 10  $^{2}$ m and !  $10^{10}$ =s, only the lowest eigenfrequency  $_{0}$  is significantly different from the eld frequency corresponding to the rst asymptot, all the other eigenfrequencies  $_{k}$ ; k = 1;2;... being very close to the eld modes k2 c=L. For higher values of ! (and lower values of L) the differences between the eigenfrequencies and the eld modes frequencies are still smaller. Thus to solve Eq.(8) for the larger eigenfrequencies we expand the function  $\cot(\frac{L}{2c})$  around the values corresponding to the asymptots. We write,

with 0 < k < 1, satisfying the equation,

But since for a small value of L every  $_k$  is much smaller than 1, Eq.(15) can be linearized in  $_k$ , giving,

Eqs.(14) and (16) give approximate solutions to the eigenfrequencies  $_k$ ; k = 1;2:...

To solve Eq.(8) with respect to the lowest eigenfrequency  $_0$ , let us assume that it satis as the condition  $_0L=2c<<1$  (we will see below that this condition is compatible with the condition of a small L as dened above). Inserting the condition  $_0L=2c<<1$  in Eq.(8) and keeping up to quadratic terms in we obtain the solution for the lowest eigenfrequency  $_0$ ,

Let us consider the situations of weak coupling (g !) and of strong coupling (g !), and let us consider the situation where the dressed m aterial body is initially in its rst excited level. Then from Eq.(13) we obtain the probability that it will still be excited after a ellapsed time t,

## a) W eak coupling

In the case of weak coupling a physically interesting situation is when interactions of electrom agnetic type are involved. In this case, we take g = !, where is the ne structure constant, = 1=137. Then the factor f multiplying 2c=g in Eq.(18) is 0.07 and the condition L 2c=g is replaced by a more restrictive one, L 0.07(2c=g). For a typical infrared frequency, for instance ! 2;0  $10^{1}$ =s, our calculations are valid for a value of L, L 10 <sup>3</sup>m.

From Eqs.(9) and using the above expressions for the eigenfrequencies for sm all L, we obtain the matrix elements,

To obtain the above equations we have neglected the corrective term  $_k$ , from the expressions for the eigenfrequencies  $_k$ . Nevertheless, corrections in  $_k$  should be included in the expressions for the matrix elements  $t_k^k$ , in order to avoid spurious singularities due to our approximation.

Using Eqs.(20) in Eq.(19), we obtain

where we have introduced the dimensionless parameter

= Lg=2c, corresponding to a sm allvalue of L and we remem ber that the eigenfrequencies are given by Eqs.(14), (16) and (17). As time goes on, the probability that the material body be excited attains periodically a minimum value which has a lower bound given by,

For instance, for a frequency ! of the order !  $4:00 \ 10^{14}$ =s (in the red visible), and L  $1:0 \ 10^{6}$ m, rem em – bering our weak coupling anzatz g = !, we see from Eq.(22) that the probability that the material body be at any time excited will never fall below a value 0:97, or a decay probability that is never higher that a value

0.03. It is interesting to compare this result with experimental observations in [6], where stability is found for atom s em itting in the visible range placed between two parallelm innors a distance  $L = 1.1 \quad 10^{6}$ m apart from one another [6]. For cavities smallenough the probability that the material body remain excited as time goes on, oscillates with time between a maximum and a minimum values and never departs signi cantly from the situation of stability in the excited state.

Nevertheless, in the weak coupling regime for any xed value of the emission frequency, the probability that the particle rem ain excited can be considerably changed. This is a general phenom enon. We see from Eq. (22) that mathematically there are two values of the cavity size, corresponding to = 0 and = 15=14 which correspond to the probability one of the particle be excited at any time. A lso, we can see from Eq. (22) that them in im al value of M in  $(jt^{00}(t))$  is attained for = 15=28. The size of the cavity corresponding to this value of is exactly half the (non-zero) size of the cavity allowing from a mathematical point of view, permanent excitation of the particle. How ever we should not give physical meaning to the portion of the parabole (22) from = 15=28to in nity, it will correspond for values > 15=14 to probabilities larger than one and is physically meaningless. The physically meaningful part of the parabole (22) corresponds to 0 < < 15=28 . Our conclusion is that varying from 0 to = 15=28 we attain at the middle of the curve the point of maximum emission, where  $M in (f^{00}(t)^2)$ 0:55. In the weak coupling regime, this is the m in in alpossible probability to the particle rem ain excited inside the cavity for any emm ission frequency.

b) Strong coupling

In this case it can be seen from Eqs (16), (17) and (18) that  $_0$  ! and we obtain from Eq.(9),

U sing Eqs.(23) in Eq.(19), we obtain for the probability that the excited system be still at the rst energy level at time t, the expression,

We see from (24) that as the system evolves in time, the probability that the material body be excited, attains periodically a minimum value which has a lower bound given by,

The behaviour of the system in the strong coupling regime is completely dierent from weak coupling behaviour. The condition of positivity of (25) in poses for xed values of g and ! an upper bound for the quantity

,  $_{m ax}$ , which corresponds to an upper bound to the diam eter L of the cavity,  $L_{m ax}$  (remember = Lg=2c). Values of larger than  $_{m ax}$ , or equivalently, values of L larger than  $L_{m ax}$  are unphysical (correspond to negative probabilities) and should not be considered. These

upper bounds are obtained from the solution with respect to , of the inequality, M in ( ) 0. We have M in () > 0 or M in () = 0, for respectively < max or  $= \max_{m \text{ ax}} \cdot The solution of the equation M in () = 0 gives,$  $\frac{1}{2} + \frac{2+3^{5}}{5}$ max = 0:37:For = max, the minin al probability that the atom remain stable vanishes. W e see com paring with the results of the previous subsection, that the behaviour of the system for strong coupling is rather di erent from its behaviour in the weak coupling regime. For appropriate cavity dimensions, which are of the same order of those ensuring stability in the weak coupling regime, we ensure for strong coupling the com plete decay of the particle to the ground state in a sm all. ellapsed time.

We have presented in this note a non-perturbative treatm ent of a con ned ohm ic quantum system consisting of particle (in the larger sense of a "m aterial body", an atom or a B row nian particle) coupled to an environm ent m odeled by non-interacting oscillators. O ne possible conclusion is that by changing conveniently the physical and geom etric param eters (the em ission frequency, the strenghness of the coupling and the size of the conning cavity) our form alism theoretically allow sa control on the rate of em ission and of the energy storage capacity (perhaps inform ation?) in the cavity. D epending on the strenghness of the coupling, the em ission probability ranges from a com plete stability to a very rapid decay.
