ON INTERFEROMETRIC DUALITY IN MULTIBEAM EXPERIMENTS

A bstract

We critically analyze the problem of formulating duality between fringe visibility and which-way information, in multibeam interference experiments. We show that the traditional notion of visibility is incompatible with any intuitive idea of complementarity, but for the two-beam case. We derive a number of new inequalities, not present in the twobeam case, one of them coinciding with a recently proposed multibeam generalization of the inequality found by G reenberger and YaSin. We show, by an explicit procedure of optimization in a three-beam case, that suggested generalizations of Englert's inequality, do not convey, di erently from the two-beam case, the idea of complementarity, according to which an increase of visibility is at the cost of a loss in path information, and viceversa.

1 Introduction

Interferom etric duality, as complementarity between fringe visibility and which-way information is called today, has a long, perhaps a surprisingly long history (for a recent review, see [1]). It was the central issue of the fam ous debate between E instein and Bohr, on complementarity. Even if, already at that time, in defending complementarity against E instein's criticism, Bohr pointed out that not only the system under observation, but also the measuring apparatus should be regarded as a quantum object [2], the discussion was essentially sem iclassical in nature. As it was based essentially on the position-momentum Heisenberg uncertainty principle, it considered only the two extreme cases, of either a purely particle-like or a purely wave-like behavior of the system. It was only in 1979 that W ootters and Zurek, [3] gave the rst full quantum mechanical treatment of Young interference, in the presence of a which-way detector. They recognized that "in Einstein's version of the double-slit experiment, one can retain a surprisingly strong interference pattern by not insisting on a 100% reliable determination of the slit through which each photon passes".

By now, a consistent and simple form ulation of interferom etric duality has been achieved in the case of two interfering beams. In the absence of a which-way detector, G reenberger and YaSin [4], showed that it was possible to convert the basic quantum m echanical inequality Tr^2 1, into one connecting the fringe visibility to the predictability of the path, based on unequal beam populations. This is an experimentally testable inequality, as it involves physically m easurable quantities. For pure states, when the inequality is saturated, this statement becomes a formulation of interferom etric duality; any increase in predictability is at the cost of a decrease in visibility, and vice versa.

In the case of an interference experiment performed in the presence of a which-way detector, in order to gain information on the path, one needs to carry out a measurement on the detector, after the passage of each quanton. Since, in general, no measurement ensures an unambiguous path reconstruction, the determination of the best possible measurement is a matter of statistical decision theory, that requires an a priori choice of an evaluation criterion. In their pioneering work, W ootters and Zurek, [3], used Shannon's de nition of information entropy [5] in order to evaluate the which-way information gained after the measurement. Following this suggestion, Englert [6], by using a di erent criterion for evaluating the available information, was able to establish an inequality, stating that the sum of the square of the distinguishability, that gives a quantitative estimate of the way, and the visibility squared, is bound by one. Again, the inequality is saturated for pure states, turning into a statement of interferometric duality: any gain in distinguishability is paid by a loss in visibility and vice versa.

In the present paper we discuss the issue of form ulating interferom etric duality, in the case of multibeam experiments. As an example of the problem sarising, we may refer to an experiment [7] with four beams, in which the surprising result is found that scattering of a photon by one of the beams, may lead to an increase of visibility, rather than to an attenuation. (For a comment see [8]). To get a better understanding of this experiment, we build an analytical three-beam example, which shows that, di erently from the two-beam case, the traditional visibility may increase, after an interaction of the beams with another quantum system. This points towards the need for a di erent notion of visibility, and one possibility is o ered in [9], where the visibility is de ned as the properly normalized, rm s deviation of the fringes intensity from its mean value. We brie y review Durr's [9] derivation, for the multibeam case, of an inequality similar to the one of G reenberger and YaSin [4], that relates this new notion of visibility, to a corresponding new ly de ned predictability. Again, in the case of pure state the inequality is saturated and, then, in analogy with the two beam case, may be taken as a form al de nition of interferom etric duality. However, as we will discuss later, this is at the cost of

In Ref. [6] the distinguishability is expressed in term s of the optim um likelihood L_{opt} for "guessing the way right". This optim um likelihood is one m inus the optim um average Bayes cost C_{opt}

using a de nition of predictability that has some how lost contact with the ability of guessing the way right. Furtherm one we show how, in the multibeam case, it is possible to construct new inequalities, resulting, like the one of G reenberger and YaSin, from basic quantum mechanical properties of the density matrix. Each of them can be written in terms of quantities that, in principle, may be measured in interference experiments, such as higher momenta of fringes intensity. The new inequalities then provide, exactly as the original one, independent tests on the validity of quantum mechanics in multibeam interference experiments. They also are saturated for pure states, but, at least at rst sight, they do not seem to convey any simple relation with the principle of com plan entarity.

Then we turn to the more interesting problem of complementarity in the presence of a which-way detector. By introducing two alternative de nitions of distinguishability, Durr constructed a generalization of Englert's inequality to the multibeam case, proposing to look at it as a form alde nition of interferom etric duality. We show that, apart from the two beam case, the new inequality holds as an equality only for the extrem e cases where either the visibility or the distinguishability vanishes, even when the beam s and the detector are both prepared in pure states. Then, there may be cases in which the distinguishability and the visibility both increase or decrease at the sam e time. This is in sharp contrast with the idea of com plem entarity, according to which "...the more clearly we wish to observe the wave nature ... the more information we must give up about... particle properties" β . In a recent paper [10], an example in which this situation occurs was constructed. However, we considered there an extrem ely sim pli ed model for the detector, having a two-dimensional space of states. A realistic model requires an in nite Hilbert space of states, and we analyze it in this paper. This is a much harder problem, because the task of determ ining the path distinguishability in plies the solution of an optimization problem, that has to be performed now in an in nite dim ensional space. We report the full proof in this paper, not only for the sake of com pleteness, but also because it provides an example in quantum decision theory, which is a subject where few general results are known, and few cases can be actually treated. Surprisingly, in the case we exam ined, the distinguishability of the in nite-dimensional problem coincides with the one found in [10], for the simplied model. This shows that the conclusions drawn in [10] have full generality, showing that the notion of interferom etric duality in the multibeam case has not been yet properly form ulated.

The paper is organized as follows: in Sec. II we discuss interferom etric-duality schemes, not involving which way detectors. In Sec. III we derive a new set of inequalities, not present in the two-beam case, and we comment on them. In Sec.IV, which way detection schemes are treated, while in Sec.V, we discuss the optimization problem for a three-beam example. Sec. VI is devoted to our concluding remarks.

2 V isibility and P redictability.

We consider an n-beam interferom eter, in which a beam splitter splits rst a beam of quantum objects ("quantons", in brief) into n beam s, that afterwards converge on a second beam splitter, where they interfere, giving rise to n output beam s. We imagine that, at some instant of time, the (normalized) wave-functions $j_i > i = 1; ...;$ n for the individual beam s are fully localized in the region between the two beam -splitters, and are spatially well separated from each other, so that < $_{ijj} = _{ij}$. The state of the quanton, in front of the second beam -splitter, is then described by a density matrix of the form :

The diagonal elements $_{ii}$ represent the populations $_i$ of the beam s, and obviously they satisfy the condition:

The o-diagonal elements of , that we shall denote as I_{ij} , are instead related to the probability I of nding a quanton in one of the n output beam s, according to the following equation: 0 1

Here, i = j is the relative phase between beam s i and j. In this paper we consider experim ental settings, such that all these relative phases can be adjustable at will. However, this is not the case in a number of experimental settings, where the features of the apparatus may lead to relations among the relative phases of the beam s. When this happens, the output beam intensity Eq.(2.3) may be rewritten, by expressing the relative phases in terms of the independently adjustable ones. An analysis of complementarity tailored on specific experimental settings, involving denite relations among the phases, may turn out to be interesting and useful. However, the purpose of the present paper is to study the problem s arising when the full freedom allowed by an n-beam setting is taken into account.

Going back to Eq.(2.3), one notices that I does not depend at all on the populations $_{i}$. In the standard case of an interferom eter with two beam s of interfering quantons, a typical measure of the fringe contrast is the traditional visibility V, de ned as:

where I_{max} and I_{min} are, respectively, the maximum and minimum of I. It is easy to verify, using Eq.(2.3) with n = 2, that

A few years ago, G reenberger and YaSin [4] noticed that the general rules of Q uantum M echanics imply the existence of a simple relation connecting the visibility V, to the populations $_{i}$ of the beam s. They considered the so-called predictability

which can be interpreted as the a-priori probability for "guessing the way right", when one has unequal populations of the beam s. It is easy to verify that the general condition

tums into the follow ing inequality

W hen it is saturated, namely for pure states, one can recognize in Eq.(2.8) a statement of wave-particle duality, because then a large predictability of the way followed by the quantons, in plies a small visibility of the interference fringes, and viceversa.

Independently on any interpretation, the inequality (2.8) represents a testable relation between measurable quantities, that follows from the rst principles of Quantum Mechanics. Indeed, the experiments with asymmetric beams of neutrons made by Rauch et al.[11] are compatible with it. It is interesting to observe that Eq.(2.8) provides also an operative, quantitative way to determ ine how far the beam is from being pure.

One may ask whether an inequality analogous to Eq.(2.8) holds in the multibeam case. Here, one's rst attitude would be to keep the de nition of visibility, Eq.(2.5), unaltered. However, this choice has a severe fault, as we now explain. Suppose that the beam s are made interact with another system, that we call environment, and assume that the interaction does not alter the populations of the beam s. If the interaction is described as a scattering process, its e ect is to give rise to an entanglement of the beam s with the environment, such that:

Here, $j_0 > and j_i > are normalized environments' states (we have assumed for simplicity that the initial state <math>j_0 > of the environment is pure, but taking a mixture would not change the result). The entanglement with the environment alters the probability of noting a quanton in the chosen output beam. Indeed, the state ⁰ of the beam s, after the interaction with the environment, is obtained by tracing out the environment's degree of freedom from Eq.(2.9):$

By plugging 0 into Eq.(2.3), we obtain the new expression for the probability I 0 of nding a quanton in the selected output beam :

If we agree that the visibility V should be fully determ ined by the intensity of the output beam I^0 , we require that it should be de ned in such a way that, for any choice of the environments states $j_i > , V^0 = V$. It is easy to convince oneself that the standard visibility V fulls this requirement for two-beams, while it does not for a larger number of beams. Indeed, for two beams, $V^0 = V$ is a direct consequence of Eq.(2.5). Things are different already with three beams. Consider for example the three-beam state, described by the following density matrix

It can be checked that is positive de nite if 0 < 1. A direct computation of the visibility V, for > 0, gives the result:

Suppose now that the interaction with the environment is such that the environment's states in Eq.(2.9) satisfy the conditions: $j_1 >= j_2 >$ and $< _1 j_3 >= < _2 j_3 >= 0$. This condition is typically realized if the environment interacts only with the third beam, as it happens, for example, if one scatters light o the third beam only. This is precisely the type of situation that is realized, in a four beam context, in the experiment of Ref.[7]. With this choice for the states $j_i >$, the density matrix 0 in Eq.(2.10) becomes:

We see that, for 1=4 < < 1, $V^0 > V$. We believe that these considerations lead one to abandon V as a good measure of the visibility, in the multibeam case, and to search for a di erent de nition.

Thus we need multibeam generalizations of the above de nitions for the visibility and the predictability. Of course, this is a matter of choice, but it is clear that the choices for the de nitions of the two quantities are tied to each other, if they are eventually to satisfy an inequality like Eq.(2.8). Indeed a simple reasoning provides us with a possible answer. One observes that, for any number of beam s, it is still true that Tr^2 1. Upon expanding the trace, one can rewrite this condition as:

One observes now that the rst sum depends only on the populations $_{i}$ of the beam s, which should determ ine the predictability, while the second sum depends only on the non diagonal

elements of , which are the ones that appear in the expression of the intensity I of the output beam, Eq.(2.3), and thus determine the features of the interference pattern. Eq.(2.16) suggests that we dene the generalized visibility V as:

where C is a constant, chosen such that the range of values of V is the interval [0;1]. One nds C = n=(n 1), and so we get:

which is the choice m ade in [9]. It is clear that this de nition of V satis es the above requirem ent, that any interaction with the environm ent should m ake V decrease, because, according to Eq.(2.9), the m oduli $J_{ij} \hat{J}$ can never get larger, as a result of the interaction with the environm ent. M oreover, we see that for two beam s V = $2J_{12}j$ which coincides with Eq.(2.5), and so V = V. It is easy to check that V can be expressed also as a rm s average, over all possible values of the phases i, of the deviation of the intensity I of the output beam from its m ean value:

Here the, bracket $\langle \rangle$ denotes an average with respect to the phases $_{i}$ and $I = I \langle I \rangle$.

O ne proceeds in a sim ilar manner with the generalized predictability P . Eq.(2.16) suggests that we de ne P as: v

where the constants A and B should be chosen such that the range of values of P² coincides with the interval [0;1]. It is easy to convince oneself that this requirement uniquely xes $A = n = (n \quad 1), B = \quad 1 = n$, and so we obtain:

which is the choice of [9]. It is easy to check that this expression coincides with P, Eq.(2.6), when n = 2.0 nem ay observe that this de nition enjoys the following nice features:

i) P reaches its maximum value if and only if either one of the populations $_{i}$ is equal to one, and the others are zero, which corresponds to full predictability of the path;

ii) P reaches its m in im um if and only if all the populations are equal to each other, which m eans total absence of predictability;

ii) P and P² are strictly convex functions. This means that, for any choice of two sets of populations $^{0} = \begin{pmatrix} 0 \\ 1 \end{pmatrix}$, and $^{0} = \begin{pmatrix} 0 \\ 1 \end{pmatrix}$; ...; $^{0}_{n}$), and for any 2 [0;1] one has:

where the equality sign holds if and only if the vectors 0 and 0 coincide. A similar equation holds for P². This is an important property, because it means that the predictability (or its square) of any convex combination of states is never larger than the convex sum of the corresponding predictabilities (or their squares).

One can check now that P^2 and V^2 satisfy an inequality analogous to Eq.(2.8):

where the equal sign holds if and only if the state is pure. This result deserves a number of comments:

1) As in the two beams case, the above inequality provides a testable relation between measurable quantities, and it would be interesting to verify it.

2) On the level of interpretations, when saturated, Eq.(2.23) can be regarded as a statement of wave-particle duality, in analogy with the two-beam relation, Eq.(2.8). In fact, since the quantity P depends only on the populations $_i$, P m ay be interpreted as a particle like attribute of the quantons. On the other side, since the quantity V depends only on the numbers I_{ij} , that determ ine the interference term s in the expression of I, it is legitimate to regard V as a m easure of the wavelike attributes of the quanton.

3) However, the quantity P does not carry the same meaning as the quantity P used in the two-beam case, and the name "predictability" given to it in Ref.[9] is not the most appropriate. Indeed, from the point of view of statistical decision theory [12], the natural de nition of predictability would not be that in Eq.(2.21), bur rather the following. If one interprets the number $_{i}$ as the probability for a quanton to be in the beam i, and if one decides to bet every time on the most populated beam i, the sum $_{i \in i}^{P}$ is represents the probability of loosing the bet. Then, it is natural to de ne the predictability P_n as:

where the normalization is xed by the requirement that $P_n = 0$, if the beams are equally populated, and $P_n = 1$, if any of the populations is equal to one. For n = 2, this de nition reduces to that used by G reenberger and YaSin, in Eq.(2.6), and in fact it was proposed as a generalization of it in Ref.[13]. It is surely possible to write inequalities involving P_n and V, but, as far as we know, none of them is saturated by arbitrary pure states, di erently from Eq.(2.23). So, one is faced with a situation in which the less intuitive notion of "predictability", given by Eq.(2.21), enters in a sharp relation with the visibility, while the most intuitive one, given by Eq.(2.24), enters in a relation with the visibility, that is not saturated even for pure states.

3 Higher order inequalities.

In a multibeam interferom eter a new interesting feature is present, which is absent in the two-beam case, and puts Eq.(2.8) into a new perspective. In fact, Eq.(2.23), that relates the

populations of the beam s $_{i}$ to the features of the interference fringes, is only the rst of a collection of inequalities, that we now discuss. The new inequalities, exactly like Eq.(2.23), rest on the rst principles of Q uantum M echanics and can be derived along similar lines, by considering higher powers of the density matrix . Indeed, for n beam s, one has the following n 1 independent inequalities:

For example, with three beams, if we take m = 3 we obtain:

This inequality, like Eq.(2.23), may be translated in term s of physically measurable quantities, although in a more elaborate way. First, we notice that the combination of non-diagonal elements of the density matrix, that appears in the last term of the r.h.s. of the above E quation represents the third moment of the intensity I of the output beam :

On the other side, the quantities $J_{ij}\hat{j}$ that appear in the middle terms, are related, as in Eq.(2.5), to the visibilities V_{ij} of the three interference patterns, that are obtained by letting the beam si and j interfere with each other, after intercepting the remaining beam. Therefore, we may rewrite Eq.(3.2) as:

which shows clearly that the novel inequality is a testable relation, to be checked by experiment.

This example illustrates the general structure of the new higher order inequalities. As the number n of beams and the power of m in Eq.(3.1) increase, higher and higher moments of the intensity I will appear. Furtherm ore, data related to the interference patterns form ed by all possible subsets of beam s that can be sorted out of the n beam s, will appear.

A few comments are in order. On one side, the higher order inequalities are similar to Eq.(2.23), in that they are all testable in principle, and become equalities for beam s in a pure state. On the other side, di erently from Eq.(2.23), they do not exhibit a natural splitting of the particlelike quantities $_{i}$ from the wavelike quantities I_{ij} , into two separate, positive de nite term s.

The existence of this sequence of inequalities suggests that, from the point of view of complementarity, the two-beam and the multibeam case are dierent. For two-beams, the basic properties of the density matrix are completely expressed in terms of a single duality relation, like Eq.(2.8). In the multibeam case, a whole sequence of independent inequalities is needed, if one is to fully express the basic properties of the density matrix. Except for the rst

one, none of these inequalities seems to be related in any simple way to the intuitive concept of wave-particle duality. It seems than that the lowest-order inequality, Eq.(2.23), still carries an idea of wave-particle duality, but only at the cost of averaging out the elects related to higher order m om ents.

4 W hich-way detection.

The notion of predictability, introduced in Sec.II, does not express any real know ledge of the path followed by individual quantons, but at most our a-prioriability of predicting it. A more interesting situation arises if the experimenter actually tries to gain which way information on individual quantons, by letting them interact with a detector, placed in the region where the beam s are still spatially separated. The analysis proceeds assuming that the detector also can be treated as a quantum system, and that the particle-detector interaction is described by som e unitary process. A detector can be considered as a part of the environm ent, whose state and whose interaction with the beam s can, to some extent, be controlled by the experim enter. If we let $j_0 > be the initial state of the detector (which we assume to be pure, for simplicity),$ the interaction with the particle will give rise to an entangled density matrix $b_{\delta} e_{\ell}$ of the form considered earlier, in Eq.(2.9). This time, however, we interpret the states $j_i > as n$ norm alized (but not necessarily orthogonal!) states of the which way detectors. The existence of a correlation between the detector state j_i > and the beam j_i >, in Eq.(2.9), is at the basis of the detector's ability to store which-way inform ation. We observed earlier that the very interaction of the quantons with the detector, causes, as a rule, a decrease in the visibility. A coording to the intuitive idea of the wave-particle duality, one would like to explain this decrease of the visibility as a consequence of the fact that one is trying to gain which-way information on the quantons. In order to see if this is the case, we need read out the whichway information stored in the detector. We thus consider the naldetector state $_{\rm D}$, obtained by taking a trace of Eq.(2.9) over the particle's degrees of freedom :

A swe see, $_{\rm D}$ is a mixture of the n nal states j_i>, corresponding to the n possible paths, weighted by the fraction $_{\rm i}$ of quantons taking the respective path. Thus the problem of determining the trajectory of the particle reduces to the following one: after the passage of each particle, is there a way to decide in which of the n states j_i> the detector was left? If the states j_i> are orthogonal to each other, the answer is obviously yes. If, however, the states j_i> are not orthogonal to each other, there is no way to unambiguously infer the path: whichever detector observable W one picks, there will be at least one eigenvector of W, having a non-zero projection onto more than one state j_i>. Therefore, when the corresponding eigenvalue is obtained as the result of a measurement, no unique detector-state can be inferred, and only probabilistic judgments can be made. Under such circum stances, the best the experimenter can do is to select the observable that provides as much information

as possible, on the average, namely after m any repetitions of the experiment. Of course, this presupposes the choice of a de nite criterion to measure the average amount of which-way information delivered by a certain observable W.

Let us see in detail how this is done. Consider an observable W , and let the projector onto the subspace of the detector's H ilbert space H $_D$, associated with the eigenvalue w . The a-priori probability p of getting the result w is:

where Tr_D denotes a trace over the detector's Hilbert space H_D and $P_i = j < ij j_i > j$. The quantity $_iP_i$ coincides with the probability of getting the value w , when all the beam s, except the i-th one, are intercepted before reaching the detector, and indeed this provides us a way to measure the numbers $_iP_i$. When the interferom eter is operated with n-beam s, one may interpret the normalized probabilities Q_i :

as the a-posteriori relative probability, for a particle to be in the i-th beam , provided that the measurem ent of W gave the outcom e w.

On the other side, if W is measured after the passage of each quanton, one can sort the quantons in the output beam into distinct subensembles, according to the result w of the measurement. The subensembles of quantons are described by density matrices () of the form :

We see that the a posteriori probabilities Q_i coincide with the diagonal elements of the density matrices $()_{ij}$, and thus represent also the populations of the beam s, for the sorted subensembles of quantons.

Let us consider now the case of two beams. For each outcome w, one can consider the predictability P (W) and the visibility V (W), associated with the corresponding subensemble of quantons:

Notice that both quantities depend, of course, on the observable W. It is clear that an inequality like Eq.(2.6) holds for each subensemble, separately:

The equality sign holds if and only if the subensemble is a pure state, which is surely the case if the beam s and the detector are separately prepared in pure states, before they interact.

W hen the eigenvalue w is observed, it is natural to de ne the average am ount of which-way know ledge delivered by W as the predictability P (W) of the corresponding subensemble of quantons. In order to measure the overall ability of the observable W to discriminate the paths, one de ness a quantity K (W) ^Y, which is some average of the partial predictabilities P (W). The procedure implicitly adopted by Englert in [6], is to de ne K (W) as the weighted average of the numbers P (W), with weights provided by the a priori probabilities p:

which gives expression to the intuitive idea that any observable W, that we decide to measure, provides us with a better know ledge of the path, than that available on the basis of a mere a priori judgement. One has also the other inequality

For the proofs of these inequalities, we address the reader to Ref.([1]), where they are derived in a number of independent ways. In the so-called which-way sorting schemes, it is natural to select the observable W such as to maxim ize K (W), and one then denes the distinguishability D of the paths as the maximum value of K (W):

It is easy to see that Eqs.(4.11), (4.13) and (4.14) together imply the following inequality, analogous to Eq.(2.8), rst derived by Englert in Ref.[6]:

Thus, given the visibility V, there is an upper bound for the distinguishability, set by the above relation. But Englert in fact proves much more than this: he shows that Eq.(4.15) becomes an identity, when both the beam s and the detector are in a pure state. In our opinion, this fact is essential to justify the interpretation of Eq.(4.15) as a statement of the complementary

character of the wave and particle attributes of a quanton. In fact, this implies that, when the beam of quantons and the detector are as noiseless as they can possibly be in Quantum M echanics, namely when they are in pure states, an increase in any of the two terms is necessarily accompanied by an exactly quanti able corresponding decrease of the other.

A possible generalization of the above considerations, to the multibeam case, is as follows [9]. One sorts again the quantons, into subensembles, depending on the outcom e of the measurement of W. For each outcom e w, one uses the generalized predictability P in Eq.(2.21), and the generalized visibility V in Eq.(2.18), to de ne the "conditioned which-way knowledge" K (W):

and the "partial erasure visibility" V (W):

The quantities introduced above, are related by the follow ing chains of inequalities, the proofs of which can be found in [9]:

These inequalities show that K'(W) and V'(W) provide more cient measures for the average which-way information, and for the erasure visibility, respectively. However, the author of Ref.[9] observes that the quantities K (W) and V (W) are preferable to K'(W), and V'(W), respectively, because they are the ones that reduce, for n = 2, to the de nitions used in the two-beam case. We would like to point out that, since K (W) and V (W) are essentially variances of the diagonal and non-diagonal elements, respectively, of the density matrices for

the subensembles of quantons, it appears more natural, from a statistical point of view, to combine them in quadrature, as done in Eq.(4.20). This suggests that one should adopt the de nition with the quadrature also in the two-beam case.

By taking the suprem a of all the quantities de ned above, over all possible observables W, one can de ne a set of four quantities, that characterize the state of the beam s. For example, upon taking the maxim a of K (W) and K (W), we end up with two possible de nitions for the which-way distinguishability, D and D, respectively:

It is clear that this inequality is saturated, regardless of the observable W, when the state of the combined detector-beam system is pure. This is an immediate consequence of Eq.(4.18).

One of the central results of Ref.[9] is the following inequality, generalizing Eq.(4.15):

Thus we see that also in the multibeam case, the visibility V sets an upper limit for the amount of which-way information, irrespective of how one measures it, via D or D. In Ref.[9] it is suggested that the above two inequalities provide multibeam generalizations of the two-beam wave-particle duality relation Eq.(4.15).

Even if Eq.(4.26) and Eq.(4.25) represent correct inequalities, that can be tested in an experiment, in our opinion, their interpretation as an expression of wave-particle duality appears disputable. The root of the problem is that the above inequalities, di erently from the two beam case, cannot be saturated, in general, even if the beam s and the detector are prepared in pure states (in Appendix I, we actually prove that Eq.(4.26), for example, can be saturated only if D = P, which means that the detector does not provide any inform ation). Therefore,

one m ay conceive the possibility of designing two which-way detectors D_1 and D_2 , such that $V_1 > V_2$, while, at the same time, $D_1 > D_2$. This possibility, which conjects with the intuitive idea of complementarity, actually occurs, as we anticipated in Ref.[10], and as we report in the next Section.

5 A three-beam example.

The example discussed in Ref.[10], was based on a three beam interferom eter with equally populated beams, described by the pure state:

For the sake of simplicity, it was assumed there that the detector's H ilbert space was a twodimensional space H $_2$. Its rays were described via the B loch parametrization, such that:

where \hat{n} is a unit three-vector and $\sim = (x; y; z)$ is any representation of the Paulim atrices. We denoted by $\hat{n} > \langle \hat{n} \rangle$ the ray corresponding to the vector \hat{n} . We required that the directions \hat{n}_+ ; \hat{n}_- ; \hat{n}_0 , associated with the states $j_i \rangle$, were coplanar, and such that \hat{n}_+ and \hat{n}_- both formed an angle with \hat{n}_0 We imagined that could be varied at will, by acting on the detector, and in Ref.[10] we obtained the following expressions for the visibility V and the distinguishability D, as functions of :

The values of V and D are plotted in the gure. By looking at it, one realizes that som ething unexpected happens: while in the interval 0 < =2, V decreases and D increases, as expected from the wave-particle duality, we see that in the interval =2, V and D decrease and increase simultaneously! We see that if we pick two values $_1$ and $_2$ in this region, we obtain two which-way detectors, that precisely realize the situation described at the end of the previous Section.

The analysis of R ef.[10], that we have sum marized here, is not realistic though, because of the sim plifying assumption of a detector with a two-dimensional Hilbert space of states. Even assuming that the detector's nalstates j_i > span a two-dimensional subspace H₂, stillone has to take into account that the full H ibert space H_D of a realistic device is in nite-dimensional. Now, it is known from the theory of quantum detection [12, 17] that the optimum discrimination




Figure 1: Plots of the quantities D (solid line), V (dotted line), and $D^2 + V^2$ (dashed line), as functions of in a three beam situation.

am ong an assigned set of quantum states, is not always achieved by an observable that leaves invariant the subspace spanned by them . However, the value of D quoted above corresponds to m axim izing the which-way know ledge over the restricted set of detector's observables W, that leave invariant the subspace H_2 . Then, in order to complete the proof, we need to show that no observable in H_D can perform better than the one determ ined in Ref.[10], by considering only operators that live in H_2 . Filling this gap, is by no m eans an easy job, because it is a matter of solving an optim ization problem in an in nite-dimensional H ilbert space. There is no general strategy for solving this sort of problem s, and we can rely only on few known general results [12, 17, 18]. The interested reader can nd the lengthy procedure to compute D in Appendix II. Here, we content ourselves with sketching the method followed, and presenting the results.

For the sake of de niteness, let us agree to use K (W) as our measure of the which wayinformation. At the end of this Section, we shall discuss what changes if one instead uses K'(W). The determination of the optimal observable W_{opt} is facilitated by the observation that, even when H_D is in nite-dimensional, the problem can be formulated entirely in the subspace H₂, as we now explain. One observes that the probabilities P₁ that enter in the de nition of K (W) can be written also as:

where is the orthogonal projector onto H_2 , and A = is a positive (herm itian) operator on the subspace H_2 . Thus we see that the operators A contain all the information we need, about W, in order to compute the which-way know ledge. It is to be noticed that A are not projection operators, in general. However, they must provide a decomposition of the identity onto H_2 , since:

Such a collection of operators on H₂, provides an example of what is known in M athem at ics as a Positive O perator Valued M easure (POVM in short). Notice though that, while any hem it ian operator in H_D gives rise, by projection, to a POVM in H₂, the converse m ay not be true. ^x O ur strategy to determ ine W_{opt} is then to search inst for the optim al POVM A_{opt} in H₂ (the notion of which way know ledge is obviously de ned for an arbitrary POVM, as well), and to check at the end if A_{opt} can be realized by projecting onto H₂ an operator W in H_D, as in Eq.(5.6). If this is the case, W is guaranteed to be optiminal, and we can say that D = K (A_{opt}). The determ ination of A_{opt} is facilitated by a general theorem [18], that states that for any m easure of the which-way know ledge that is a weighted average of a convex function, the optiminal POVM consists of rank-one operators. This is the case for the which-way know ledge K, which is a weighted average of the predictability P, which indeed is a convex function. The A being rank-one operators, we are ensured that there exist non-negative numbers 2 and unit vectors m such that:

The interested reader m ay nd in Appendix II how the optimal POVM can be determined. Here we just report the result: for all values of A_{opt} turns out to have only two non vanishing elements, A , such that:

It is clear that the operators A coincide with the projectors found in Ref.[10], showing that it was indeed su cient to carry out the optimization procedure in H $_2$.

It should be appreciated that this coincidence is by no means trivial, and strictly depends on the choice of K (W) as a measure of which-way knowledge. For example, for = 2 = 3, it is known [12, 17], that, with either Shannon's entropy or Bayes' cost function as measures of information, the optimal POVM actually consists of three elements, and thus it is not associated with an operator in H₂.

^x In e ect, this problem arises only if H_D is nite dimensional. If H_D is in nite dimensional, all POVM 's are acceptable, because a general theorem due to Neumark [19] ensures that all POVM 's of any H ibert space, can be realized as projections of self-adjoint operators from a larger H ibert space.

Then, our observation that the inequality Eq.(2.23) fails to carry the physical picture associated with the idea of complementarity is now fully demonstrated. We have checked that a similar conclusion can be drawn if, rather than K, one uses the alternative de nition of distinguishability D' provided by Eq.(4.22). In fact, it turns out that the optimal POVM for K' coincides with the one found earlier, in the interval 0 < 2=3, and so D' = D. The proof of this can be found in Appendix II.

6 Conclusions

The intuitive concept of C om plem entarity has found, in the case of two-beam s interference experiments, a satisfactory, fully quantum mechanical formulation as interferom etric duality. In this paper, we critically analyzed the di culties encountered in the attempt of generalizing this concept to multibeam experiments, and discussed the shortcom ings that are present, in our opinion, in recent proposals. It seems to us fair to say that interferom etric duality has not yet found a proper formulation, in the multibeam case. To justify this conclusion, let us recall the di erent points we have elaborated in the paper.

In the two-beam case, general quantum mechanical requirements on the density matrix im ply the G reenberger-YaSin inequality, that, when saturated, expresses interferometric duality. This inequality has been generalized to the multibeam case [9], leading to a form ald enition of interferometric duality formore than two beams. The price payed is that the corresponding generalized concept of predictability has lost the intuitive connection with minimizing the error in guessing the way right. The traditional concept of predictability may enter, together with the generalized visibility, in an inequality that is not saturated, and then cannot convey the idea of complementarity, which requires that a better visibility is necessarily related to a loss in information.

We have shown that general requirements of quantum mechanics imply new inequalities, that are not present in the two beam case. These inequalities are again experimentally testable. They deserve further study but, at the present, they do not seem to exhibit a direct relation with the idea of complementarity.

Interferom etric duality m ay be fully analyzed only in the presence of which-way detectors. In the two beam case, Englert has shown that the visibility enters, with the distinguishability, into an inequality, that is saturated for pure states. As maximizing the distinguishability, minimizes the error in guessing the way right by performing a measurement, this relation fully expresses interferom etric duality. In deriving an analogous inequality for the multibeam case, D urr has introduced two alternative notions of distinguishability. However, we have shown that this inequality is never saturated, apart from trivial cases. Then, a pure inequality m ay be consistent with a situation in which an increase (decrease) in visibility goes together with an increase (decrease) in distinguishability, contrary to the intuitive idea of interferom etric duality. W e have given a full proof that this possibility actually occurs in a realistic example. The inequalities proposed by Durr, in terms of generalized visibility and distiguishability, are then correct quantum mechanical relations, testable in principle, but they fail to convey the idea of interferom etric duality.

It is seems then fair to conclude that interference duality in multibeam experiments has not yet been properly formulated. We have the problem open, but we notice it is by no means necessary that quantum mechanics should provide us with an exact formulation of this concept in the multibeam case. May be, one should content him (her)self with its formulation in the two beam case, where the sem iclassical intuitive idea of complementarity was rst introduced. May be, Quantum Mechanics provides us just with the values of observable quantities, and experimentally testable inequalities. The analysis we have performed may hint in this direction, but further investigation is required.

Now, for n > 2 and V > 0, Eq.(8.10) implies that the matrix elements $\langle w j_i \rangle$ are all di erent from zero. To see it, we separate the states $j_i >$ into two subsets, A and B. Since $p = j < w = j_i > j^2 = 1$ for all i, it is easy to verify that the above equations in ply:

Since all detector states di er by a phase, it obviously follows that the detector provides no information at all, and thus D = P.

9 Appendix II

In this Appendix, we determ ine the rank-one POVM that m axim izes the which-way know ledge, for the three beam interferom eter considered in Sec.V. The procedure is di erent, depending on whether we choose to measure the which-way know ledge by means of K or K . We consider rst K, because it is the simplest case. We can prove then that, for any num ber of beam swith equal populations $_{i}$, and any choice of the detector states $j_{i} > in H_{2}$, the POVM A that maxim izes K can be taken to have only two non vanishing elements, $A = fA_{1}; A_{2}g$. The proof is as follows. First, we notice that, for any rank-one POVM consisting of only two elements, the conditions for a POVM, Eq.(5.9), in ply:

Thus, all rank-one POVM with two elements are characterized by a pair of unit vectors \mathfrak{m} , that are opposite to each other. Such a POVM clearly coincides with the Projector Valued M easure (PVM) associated with the hermitian operator $\mathfrak{m}_1 \sim \mathfrak{in} H_2$. We let A the optim al PVM, that can be obtained by considering all possible directions for \mathfrak{m}_1 . We can show that such an A represents the optim al POVM. To see this, we prove that the which way-know ledge K (A) delivered by A is not less than that delivered by any other POVM C. By virtue of the theorem proved in Ref.[18], it is su cient to consider POVM 's C m ade of rank-one operators. In order to evaluate K (C), it is convenient to rewrite the quantities p K , for any element C = 2 ^(C) (1 + $\mathfrak{m}^{(C)}$ ~) of C, as

$$= \frac{(C)^{r}}{n 1} \frac{1}{n 1} \frac{1}{n} \left[1 + (m^{(C)})^{X} + (n^{(C)})^{2}\right] + \frac{1}{n} \frac{p^{2}}{i} \left[1 + (m^{(C)})^{2}\right] + 2m^{(C)} \frac{X}{i} + (n^{(C)})^{1-2}$$

$$= \frac{(C)^{r}}{n 1} \frac{1}{n 1}$$

We observe now that, for equally populated beam s, i = 1=n, the last sum in the above equation vanishes, and the expression for p K becomes invariant under the exchange of $\mathbb{M}^{(C)}$ with $\mathbb{M}^{(C)}$. Consider now the POVM B, such that:

O f course, $p^{(+)}K^{(+)} = p K = 2$, while the invariance of p K in plies $p^{(-)}K^{(-)} = p^{(+)}K^{(+)}$. It follows that the average information for B and C are equal to each other, K (B) = K (C). Now, for each value of , the pair of operators $B = {}^{(C)} = (1 \text{ m}^{(C)} \text{ ~})=2$ constitutes by itself a POVM, with two elements. Thus, the POVM C can be regarded as a collection of POVM 's with two elements, each taken with a non-negative weight ${}^{(C)}$. But then K (C), being equal to the average of the amounts of information provided by a number of POVM with two elements, cannot be larger than the amount of information K (A) delivered by the best POVM with two elements. Thus we have shown that K (C) = K (B) K (A), which shows that A is the optim al POVM.

It remains to nd A for the example considered in Sec.V, but this is easy. If we let and the polar angles that identify the vector \mathfrak{m}_1 , one nds for the square of the which-way information the following expression:

For all values of , the which-way inform ation is maximum if $\cos = 1$, i.e. if the vector \mathfrak{m}_1 lies in the same plane as the vectors \mathfrak{m}_1 . As for the optimal value of , it depends on . For 0 < 2 = 3, the best choice is = =2, and one gets the PVM in Eq.5.10), with gives the path distinguishability D given in Eq.(5.4). For larger values of , one has = 0 and then the optimal PVM is that of Eq.(5.11), with D given by Eq.(5.5).

We turn now to the case when the which-way inform ation is measured by means of K. Since the square of the predictability is a convex function, we are ensured by the general theorem proved in [18] that the optimal POVM is made of rank-one operators, of the form (5.8). We split the computation of the optimal POVM in two steps. First, we prove a lemma, which actually holds for any measure of the which-way inform ation F, which is a weighted average of a convex function of the a-posteriori probabilities Q_i .

Lemma: consider an interferom eter with n beams, and arbitrary populations $_{i}$. Let the detector states $j_{i} > be in H_{2}$, and have coplanar vectors \hat{n}_{i} . Then, the optimal POVM is necessarily such that all the vectors \hat{m} in Eq.(5.8) lie in the same plane containing the vectors \hat{n}_{i} .

The proof of the lem m a is as follows. Let B be an optim al POVM. Suppose that some of the vectors $\mathfrak{m}^{(B)}$ do not belong to the plane containing the vectors \mathfrak{n}_i , which we assume to be the xz plane. We show below how to construct a new POVM A providing not less information than B, and such that the vectors $\mathfrak{m}^{(A)}$ all belong to the xz plane. The rst step in the construction of A consists in symmetrizing B with respect to the xz plane. The symmetrization is done by replacing each element B of B, not lying in the xz plane, by the pair (B⁰; B⁰), where B⁰ = B =2, and B⁰ has the same weight as B⁰, while its vector $\mathfrak{m}^{(B)(0)}$ is the symmetric of $\mathfrak{m}^{(B)}$ with respect to the xz plane. It is easy to verify that the symmetrization preserves the conditions for a POVM [Eqs. (5.9)]. Since all the vectors \mathfrak{n}_i belong by assumption to the xz plane, the which way know ledge actually depends only on the projections of the vectors $\mathfrak{m}^{(B)}$ in the plane xz. This is plies, at is easy to check, that symmetrization with respect to the xz

plane does not change the am ount of which way know ledge. We assume therefore that B has been prelim inarily symmetrized in this way. Now we show that we can replace, one after the other, each pair of symmetric elements (B⁰; B⁰) by another pair of operators, whose vectors lie in the xz plane, without reducing the information provided by the POVM. Consider for example the pair (B⁰; B⁰). We construct the unique pair of unit vectors \hat{t} and \hat{v} , lying the xz plane, and such that:

$$\hat{u} + \hat{v} = 2 \, (m^{(B)x} \, \hat{i} + m^{(B)z} \, \hat{k}); \qquad (9.5)$$

where \hat{i} and \hat{j} are the directions of the x and z axis, respectively. Notice that $\hat{u} \in \diamond$. Consider now the collection of operators obtained by replacing the pair (B⁰; B⁰) with the pair (A⁰; A⁰) such that:

It is clear, in view of Eqs. (9.5), that the new collection of operators still form s a resolution of the identity, and thus represents a POVM. Equations (9.5) also im ply:

$$P_{i}^{(B)0} = P_{i}^{(B)0} = (1 + m^{(B)x}n_{i}^{x} + m^{(B)z}n_{i}^{z}) =$$

$$= \frac{1}{2} (1 + u^{x}n_{i}^{x} + u^{z}n_{i}^{z}) + \frac{1}{2} (1 + v^{x}n_{i}^{x} + v^{z}n_{i}^{z}) = \frac{1}{2} (P_{i}^{(A)0} + P_{i}^{(A)0}); \quad (9.7)$$

Now, de ne ${}^{0} = p^{(A)0} = (2p^{(B)})$, and ${}^{00} = p^{(A)0} = (2p^{(B)})$, where $p^{(B)} = p^{(B)0} = p^{(B)0}$. Since $p^{(A)0} + p^{(A)0} = 2p^{(B)}$, we have ${}^{0} + {}^{0} = 1$. It is easy to verify that:

But then, the convexity of F im plies:

It follows that the new POVM is no worse than B. By repeating this construction, we can obviously elim inate from B all the p pairs of elem ents not lying in the xz plane, until we get a POVM A, which provides not less inform ation than B, whose elem ents all lie in the xz plane. This concludes the proof of the lem m a.

Now we can proceed as follows: we consider the POVM 's consisting of two elements only, and having its vectors \mathfrak{m}_i parallel to the x axis. By direct evaluation one can check that K (A) equals the expression in Eq.(5.4). We can prove that, for 0 < 2 = 3, such an A provides not less information than any other POVM, C, consisting of more than two elements. By virtue of the lemma just proven, we loose no generality if we assume that the all the vectors $\mathfrak{m}^{(C)}$ of C lie in the xz plane. Our rst move is to symmetrize C with respect to z axis, by introducing a POVM B, consisting of pairs of elements (B⁰; B⁰⁰), having equal weights, and vectors \mathfrak{m}^{0} and \mathfrak{m}^{00} that are symmetric with respect to the z axis:

$$B^{0} = \frac{1}{2}C ; B^{0} = \frac{1}{2} (C) (1 m^{x} + m^{z});$$
 (9.10)

B provides as much inform ation as C. Indeed, in view of Eq. (??), we nd

$$P^{(C)} = 2P^{(B)0} = 2P^{(B)0}; \qquad (9.11)$$

The invariance of the predictability with respect to permutations of its arguments, then ensures that K (B) = K (C). Thus, we bose no information if we consider a POVM B, that is symmetric with respect to the z axis. Now we describe a procedure of reduction that, applied to a symmetric POVM like B, gives rise to another symmetric POVM B, which contains two elements less than B, but nevertheless gives no less information than B. The procedure works as follows: we pick at will two pairs of elements of B, say $(B_N^0; B_N^0)$ and $(B_N^0_{-1}; B_N^0_{-1})$ and consider the unique pair of symmetric unit vectors $\hat{\alpha} = u^x \hat{1} + u^z \hat{k}$ such that:

Consider the symmetric collection \hat{B} , obtained from B after replacing the four elements $(B_N^0; B_N^0; B_N^0_1; B_N^0_1)$ by the pair $(\hat{B}_N^0_1; \hat{B}_N^0_1)$ such that:

$$\hat{B}_{N}^{0} = \begin{pmatrix} B \\ N \end{pmatrix} + \begin{pmatrix} B \\ N \end{pmatrix} (1 + \hat{u}_{+} \sim); \quad \hat{B}_{N}^{00} = \begin{pmatrix} B \\ N \end{pmatrix} (1 + \hat{u} \sim): \quad (9.13)$$

 \hat{B} is still a POVM, as it is easy to verify. Moreover, \hat{B} provides not less information than B, as we now show. Indeed, after some algebra, one nds:

where the function g(x) has the expression:

In view of Eq. (9.12), the r.h.s. of Eq. (9.14) is of the form

where $= {\binom{B}{N}} = {\binom{B}{N}} + {\binom{B}{N}}_{N-1}$, while $x_1 = m_N^{\binom{B}{2}}$ and $x_2 = m_N^{\binom{B}{2}}_{N-1}$. It may be checked that, for all values of , such that 0 < 2 = 3, g(x) is concave, for x 2 [1;1], and so the rhs. of Eq. (9.16) is non-negative for any value of 2 [0;1]. This implies that the rhs. of Eq. (9.14) is non-negative as well, and so K (B) K (B). A fler enough iterations of this procedure, we end up with a symmetric POVM consisting of two pairs of elements (B $_1^0$;B $_1^0$) and (B $_2^0$;B $_2^0$). But then, the conditions for a POVM, Eqs. (5.9), in ply that the quantity between the brackets on the rhs. of Eq. (9.12) vanishes, and so Eq. (9.12) gives $u^z = 0$. This means that the last iteration gives rise precisely to the PVM A. By putting everything together, we have show n that K (C) = K (B) K (B) ::: K (A), and this is the required result.
