A diabatic Q uantum State G eneration and Statistical Zero K now ledge

A bstract

The design of new quantum algorithms has proven to be an extrem ely di cult task. This paper considers a di erent approach to the problem. We system atically study 'quantum state generation', nam ely, which superpositions can be e ciently generated. We rst show that all problems in Statistical Zero K now ledge (SZK), a class which contains m any languages that are natural candidates for BQP, can be reduced to an instance of quantum state generation. This was known before for graph isom orphism, but we give a general recipe for all problems in SZK. We demonstrate the reduction from the problem to its quantum state generation version for three exam ples: D iscrete log, quadratic residuosity and a gap version of closest vector in a lattice.

We then develop tools for quantum state generation. For this task, we de ne the fram ework of 'adiabatic quantum state generation' which uses the language of ground states, spectral gaps and H am iltonians instead of the standard unitary gate language. This language stems from the recently suggested adiabatic computation m odel [20] and seem s to be especially tailored for the task of quantum state generation. A fler de ning the paradigm, we provide two basic lemm as for adiabatic quantum state generation:

The Sparse Hamiltonian kemma, which gives a general technique for in plementing sparse Hamiltonians e ciently, and,

The jagged adiabatic path lem m a, which gives conditions for a sequence of H am iltonians to allow e cient adiabatic state generation.

We use our tools to prove that any quantum state which can be generated e ciently in the standard model can also be generated e ciently adiabatically, and vice versa. Finally we show how to apply our techniques to generate superpositions corresponding to limiting distributions of a large class of M arkov chains, including the uniform distribution over all perfect

m atchings in a bipartite graph and the set of all grid points inside high dim ensional convex bodies. These nalresults draw an interesting connection between quantum computation and rapidly mixing M arkov chains.

1 Introduction

Quantum computation carries the hope of solving in quantum polynom ialtim e classically intractable tasks. The most notable success so far is Shor's quantum algorithm for factoring integers and for noting the discrete log 41]. Following Shor's algorithm, several other algorithms were discovered, such as Hallgren's algorithm for solving Pell's equation [28], W atrous's algorithm s for the group black box m odel [45], and the Legendre symbol algorithm by Van Dam et al [14]. Except for [14], all of these algorithms fall into the fram ework of the H idden subgroup problem, and in fact use exactly the same quantum circuitry; The exception, [14], is a di erent algorithm but also heavily uses Fourier transforms and exploits the special algebraic structure of the problem. Recently, a beautiful new algorithm by Childs et. al.[10] was found, which gives an exponential speed up over classical algorithm s using an entirely different approach, nam ely quantum walks. The algorithm however, works in the black box m odel and solves a fairly contrived problem.

One cannot overstate the importance of developing qualitatively di erent quantum algorithm ic techniques and approaches for the development of the eld of quantum computation. In this paper we attempt to make a step in that direction by approaching the issue of quantum algorithms from a di erent point of view.

It has been folk bre know ledge for a few years already that the problem of graph isom orphism, which is considered classically hard [33] has an e cient quantum algorithm as long as a certain state, namely the superposition of all graphs isom orphic to a given graph, χ

can be generated e ciently by a quantum Turing machine (for simplicity, we ignore normalizing constants in the above state and in the rest of the paper). The reason that generating $j_G i$ su ces is very simple: For two isom orphic graphs, these states are identical, whereas for two non isom orphic graphs they are orthogonal. A simple circuit can distinguish between the case of orthogonal states and that of identical states, where the main idea is that if the states are orthogonal they will prevent the di erent states of a qubit attached to them to interfere. One is tempted to assume that such a state, $j_G i$, is easy to construct since the equivalent classical distribution, namely the uniform distribution over all graphs isomorphic to a certain graph, can be sampled from e ciently. Indeed, the state $j_G i = 2S_n j i j (G) i$ can be easily generated by this argument; However, it is a curious (and disturbing) fact of quantum m echanics that though $j_G i$ is an easy state to generate, so far no one know show to generate $j_G i = 2S_n j i$.

In this paper we system atically study the problem of quantum state generation. We will mostly be interested in a restricted version of state generation, namely generating states corresponding to classical probability distributions, which we loosely refer to as quantum sampling (or Q sampling) from a distribution. To be more specience, we consider the probability distribution of a circuit, D_c , which is the distribution over the outputs of the classical circuit C when its inputs are uniform by distributed. Denote $jC i \stackrel{def}{=} P p_{\overline{D_c(z)}} jzi$. We denote the problem of circuit quantum sampling:

De nition 1. Circuit Quantum Sampling (CQS):

Input: (;C) where C is a description of a classical circuit from n to m bits, and $0 \qquad \frac{1}{2}$.

Output: A description of a quantum circuit Q of size poly (j) such that j (j) , j ij .

We rst show that most of the quantum algorithm ic problem s considered so far can be reduced to quantum sampling. Most problem s that were considered good candidates for BQP, such as discrete log (DLOG), quadratic residuosity, approximating closest and shortest vectors in a lattice, graph isomorphism and more, belong to the complexity class statistical zero knowledge, or SZK (see section 2 for background.) We prove

Theorem 1. Any L 2 SZK (Statistical Zero Know ledge) can be reduced to a family of instances of CQS.

The proof relies on a reduction by Sahai and Vadhan [40] from SZK to a complete problem called statistical di erence. Theorem 1 shows that a general solution for quantum sampling would imply SZK $BQP \cdot W$ e note that there exists an oracle A relative to which SZK^A 6 BQP^{A} [1], and so such a proofmust be non relativizing.

Theorem 1 translates a zero know ledge proof into an instance of CQS. In general, the reduction can be quite involved, building on the reduction in [40]. Speci c exam – ples of special interest turn out to be sim pler, e.g., for the case of graph isom orphism described above, the reduction results in a circuit C_G that gets as an input a uniform ly random string and outputs a uniform ly random graph isom orphic to G. In section 2 we demonstrate the reduction for three interesting cases: a decision variant of D LOG (based on a zero know ledge proof of G oldwasser, M icali and R acko [24]) and approximating the closest vector problem in lattices (based on a zero know ledge proof of G oldwasser, M icali and that although quite often one can look at the zero know ledge proof and directly infer the required state generation, som etim es it is not obvious such a transition exists at all. Theorem 1, how ever, tells us such a reduction is always possible.

The problem of what states can be generated e ciently by a quantum computer is thus of critical importance to the understanding of the computational power of quantum computers. We therefore embark on the task of designing tools for quantum state generation, and studying which states can be generated e ciently. The recently suggested fram ework of adiabatic quantum computation [20] seems to be tailored exactly for this purpose, since it is stated in terms of quantum state generation; Let us rst explain this fram ework.

Recall that the time evolution of a quantum system 's state j (t) i is described by Schrodinger's equation:

 (t) $i = H$ (t) j (t) i : (2)

where H (t) is an operator called the H am iltonian of the system. We will consider systems of n qubits; H is then taken to be local, i.e. a sum of operators, each operating on a constant number of qubits. This captures the physical restriction that interactions in nature involve only a small number of particles, and means that the H am iltonian H (t) can actually be implemented in the lab. A diabatic evolution concerns the case in which H (t) varies very slow ly in time; The qualitative statement of the adiabatic theorem is that if the quantum system is initialized in the ground state (the eigenstate with lowest eigenvalue) of H (0), and if the modi cation of H in time is done slow ly enough, namely adiabatically, then the nal state will be the ground state of the nal H am iltonian H (T).

Recently, Farhi, Goldstone, Gutmann and Sipser [20] suggested to use adiabatic evolutions to solve NP hard languages. It was shown in [20, 15] that such adiabatic evolutions can be simulated e ciently on a quantum circuit, and so designing such a successful process would imply a quantum e cient algorithm for the problem. Farhi et. al.'s idea was to nd them inimum of a given function f as follows: H (0) is chosen to be some generic Ham iltonian. H (T) is chosen to be the problem Ham iltonian, namely a matrix which has the values of f on its diagonal and zero everywhere else. The system is then initialized in the ground state of H (0) and evolves adiabatically on the convex line H (t) = $(1 \quad \frac{t}{T})H_0 + \frac{t}{T}H_T$. By the adiabatic theorem if the evolution is slow enough, the nal state will be the ground state of H (T) which is exactly the sought after minimum of f.

The e ciency of these adiabatic algorithms is determined by how slow the adiabatic evolution needs to be for the adiabatic theorem to hold. It turns out that this depends mainly on the spectral gaps of the H am iltonians H (t). If these spectral gaps are not too small, the modication of the H am iltonians can be done 'fairly fast', and the adiabatic algorithm then becomes e cient. The main problem in analyzing the e ciency of adiabatic algorithm s is thus lower bounding the spectral gap; T his is a very di cult task in general, and hence not much is known analytically about adiabatic algorithm s. [17, 12, 18] analyze num erically the performance of adiabatic algorithm s of NP complete problem s. It was proven in [15, 39] that G rover's quadratic speed up [26] can be achieved adiabatically. Lower bounds for special cases were given in [15]. In [2] it was shown that adiabatic evolution with local H am iltonians is in fact equivalent in computational power to the standard quantum computation model.

In this paper, we propose to use the language of A diabatic evolutions, H am ilto-

nians, ground states and spectral gaps as a theoretical fram ework for quantum state generation. Our goal is not to replace the quantum circuit model, neither to im prove on it, but rather to develop a paradigm, or a language, in which quantum state generation can be studied conveniently. The advantage in using the H am iltonian language is that the task of quantum state generation becomes much more natural, since adiabatic evolution is cast in the language of state generation. Furthermore, as we will see, it seems that this language lends itself more easily than the standard circuit model to developing general tools.

In order to provide a fram ework for the study of state generation using the adiabatic language, we de ne adiabatic quantum state generation as general as we can. Thus, we replace the requirem ent that the Ham iltonians are on a straight line, with Ham iltonians on any general path. Second, we replace the requirement that the Ham iltonians are local, with the requirement that they are simulatable, i.e., that the unitary matrix e^{itH (s)} can be approximated by a quantum circuit to within any polynom ial accuracy for any polynom ially bounded time t. Thus, we still use the standard model of quantum circuits in our paradigm. However, our goal is to derive quantum circuits solving the state generation problem, from adiabatic state generation algorithm s. Indeed, any adiabatic state generator can be simulated e ciently by a quantum circuit. We give two proofs of this fact. The st proof follows from the adiabatic theorem. The second proof is self contained, and does not require know ledge of the adiabatic theorem . Instead it uses the simple Zeno e ect [8], thus providing an alternative point of view of adiabatic algorithms using measurements (Such a path was taken also in [11].) This in plies that adiabatic state generators can be used as a fram ework for designing algorithms for quantum state generation.

We next describe two basic and general tools for designing adiabatic state generators. The rst question that one encounters is naturally, what kind of H am iltonians can be used. In other words, when is it possible to simulate, or implement, a H am iltonian e ciently. To this end we prove the sparse H am iltonian lemma which gives a very general condition for a H am iltonian to be simulatable. A H am iltonian H on n qubits is row-sparse if the number of non-zero entries at each row is polynom ially bounded. H is said to be row-computable if there exists a (quantum or classical) ef-

cient algorithm that given i outputs a list $(j; H_{i;j})$ running over all non zero entries $H_{i;j}$. As a norm for H am iltonians we use the spectral norm, i.e. the operator norm induced by the l_2 norm on states.

Lem m a 1. (The sparse H am iltonian lem m a). If H is a row-sparse, rowcomputable H am iltonian on n qubits and jH jj poly(n), then H is simulatable.

We note that this general lemma is useful also in two other contexts: rst, in the context of simulating complicated physical systems on a quantum circuit. Second, for continuous quantum walks [13] which use Ham iltonians. For example, in [10] Ham iltonians are used to derive an exponential quantum speed up using quantum walks. Our lemma can be used directly to simplify the Ham iltonian implementation used in [10] and to remove the unnecessary constraints (namely coloring of the nodes) which were assumed for the sake of simulating the Ham iltonian.

The next question that one encounters in designing adiabatic quantum state generation algorithm s concerns bounding the spectral gap, which as we mentioned before is a di cult task. We would like to develop tools to nd paths in the Ham iltonian space such that the spectral gaps are guaranteed to be non negligible, i.e. larger than 1=poly (n). Our next lem m a provides a way to do this in certain cases. Denote (H) to be the ground state of H (if unique.)

Lem m a 2. (The Jagged A diabatic P ath lem m a). Let $fH_{j}g_{j=1}^{T=poly(n)}$ be a sequence of simulatable H am iltonians on n qubits, all with polynom ially bounded norm, non-negligible spectral gaps and with groundvalues 0, such that the inner product between the unique ground states (H_{j}) and (H_{j+1}) is non negligible for all j. Then there is an e cient quantum algorithm that takes (H_{0}) to within arbitrarily sm all distance from (H_{T}) .

To prove this kmm a, the naive idea is to use the sequence of H am iltonians as stepping stones for the adiabatic computation, connecting H_j to H_{j+1} by a straight line to create the path H (t). However this way the spectral gaps along the way m ight be small. Instead we use two simple ideas, which we can turn into two more useful tools form anipulating H am iltonians for adiabatic state generation. The rst idea is to replace each H am iltonian H_j by the H am iltonian $_{\rm H_j}$ which is the projection on the subspace orthogonal to the ground states of H_j. We show how to implement these projections using K itaev's phase estimation algorithm [32]. The second useful idea is to connect by straight lines projections on states with non negligible inner product. We show that the H am iltonians on such a line are guaranteed to have non negligible spectral gap. These ideas can be put together to show that the jagged adiabatic path connecting the projections $_{\rm H_j}$ is guaranteed to have su ciently large spectral gap.

W e use the above tools to show that

Theorem 2. Any quantum state that can be e ciently generated in the circuit model, can also be e ciently generated by an adiabatic state generation algorithm, and vice versa.

Thus the question of the complexity of quantum state generation is equivalent (up to polynom ial term s) in the circuit model and in the adiabatic state generation model.

In the nalpart of the paper we dem onstrate how ourm ethods for adiabatic quantum state generation work in a particularly interesting dom ain, namely Q sampling from the limiting distributions of M arkov chains. There is an interesting connection between rapidly mixing M arkov chains and adiabatic computation. A M arkov chain is rapidly mixing if and only if the second eigenvalue gap, namely the di erence between the largest and second largest eigenvalue of the M arkov m atrix M, is non negligible [4]. This clearly bears resemblance to the adiabatic condition of a non negligible spectral gap, and suggests to look at H am iltonians of the form

 H_M will be a Ham iltonian if M is symmetric; if M is not symmetric but is a reversible M arkov chain [35] we can still de ne the Ham iltonian corresponding to it (see section 8.) The sparse Ham iltonian lemma has as an immediate corollary that for a special type of M arkov chains, which we call strongly sam plable, the quantum analog of the M arkov chain can be implemented:

C orollary 1. If M is a strongly samplable M arkov chain, then H_M is simulatable.

In adiabatic computation one is interested in sequences of H am iltonians; W e thus consider sequences of strongly samplable M arkov chains. There is a particularly interesting paradigm in the study of M arkov chains where sequences of M arkov chains are repeatedly used: Approximate counting [30]. In approximate counting the idea is to start from a M arkov chain on a set that is easy to count, and which is contained in a large set the size of which we want to estimate; O ne then slow ly increases the set on which the M arkov chain operates so as to nally get to the desired set

. This paradigm and modi cations of it, in which the M arkov chains are modi ed slightly until the desired M arkov chain is attained, are a commonly used tool in m any algorithm s; A notable example is the recent algorithm for approximating the perm anent [29]. In the last part of the paper we show how to use our techniques to translate such approximate counting algorithm s in order to quantum sample from the limiting distributions of the nalM arkov chain. We show:

Theorem 3. (Loosely:) Let A be an e cient random ized algorithm to approxim ately count a set , possibly with weights; Suppose A uses slow ly varying M arkov chains starting from a simple M arkov chain. Then there is an e cient quantum algorithm Q that Q samples from the nallimiting distribution over .

W e stress that it is NOT the case that we are interested in a quantum speed up for sampling from various distributions but rather we are interested in the coherent Q sample of the classical distribution.

We exploit this paradigm to Q sample from the set of all perfect m atchings of a bipartite graph, using the recent algorithm by Jerrum, Sinclair and Vigoda [29]. U sing the same ideas we can also Q sample from all linear extensions of partial orders, using Bubley and D yer algorithm [9], from all lattice points in a convex body satisfying certain restrictions using Applegate-K annan technique [6] and from m any m ore states. We note that some of these states (perhaps all) can be generated using standard techniques which exploit the self reducibility of the problem (see [27]). We stress however that our techniques are qualitatively and signi cantly di erent from previous techniques for generating quantum states, and in particular do not require self reducibility. This can be important for extending this approach to other quantum states.

In this paper we have set the grounds for the general study of the problem of Q sam pling and adiabatic quantum state generation, where we have suggested to use the language of H am iltonians and ground states for quantum state generation. This direction points at very interesting and intriguing connections between quantum computation and many di erent areas: the complexity class SZK and its complete

problem statistical di erence 40], the notion of adiabatic evolution [31], the study of rapidly mixing M arkov chains using spectral gaps [35], quantum walks [10], and the study of ground states and spectral gaps of H am iltonians in Physics. Hopefully, these connections will point at various techniques from these areas which can be borrowed to give m ore tools for adiabatic quantum state generation; N otably, the study of spectral gaps of H am iltonians in physics is a lively area with various recently developed techniques (see [42] and references therein). It seems that a much deeper understanding of the adiabatic paradigm is required, in order to solve the most interesting open question, namely to design interesting new quantum algorithm s. An open question which m ight help in the task is to present known quantum algorithm s, eg. Shor's DLOG algorithm, or the quadratic residuosity algorithm, in the language of adiabatic com putation, in an insightful way.

The rest of the paper is organized as follows. We start with the results related to SZK; We then describe quantum adiabatic computation, de ne the adiabatic quantum state generation framework, and use the adiabatic theorem to prove that an adiabatic state generator in plies a state generation algorithm. Next we prove our two main tools: the sparse H am iltonian km m a, and the jagged adiabatic path km m a. We then use these tools to prove that adiabatic state generation is equivalent to standard quantum state generation. Finally we draw the connection to M arkov chains and demonstrate how to use our techniques to Q sample from approximately countable sets. In the appendix we give the second proof of transform ing adiabatic state generators to algorithm s using the Zeno e ect.

2 Q sam pling and SZK

W e start with som e background about Statistical Zero K now ledge. For an excellent source on this subject, see Vadhan's thesis [44] or Sahai and Vadhan [40].

2.1 SZK

A pair = $(_{Yes}; _{No})$ is a promise problem if $_{Yes}$ f0;1g, $_{No}$ f0;1g and $_{Yes} \setminus _{No} =$; We look at $_{Yes}$ as the set of all yes instances, $_{No}$ as the set of all no instances and we do not care about all other inputs. If every x 2 f0;1g is in $_{Yes}$ [$_{No}$ we call a language.

We say a promise problem has an interactive proof with soundness error $_{\rm s}$ and completeness error $_{\rm c}$ if there exists an interactive protocol between a prover P and a veri er V denoted by (P;V), where V is a probabilistic polynom ial time machine, and

If x 2 $_{\rm Yes}$ V accepts with probability at least 1 $_{\rm c}$.

If x 2 $_{\rm N\,o}$ then for every prover P $\,$, V accepts with probability at most $_{\rm s}.$

W hen an interactive proof system (;V) for a promise problem is run on an input x, it produces a distribution over "transcripts" that contain the conversation

between the prover and the verier. I.e., each possible transcript appears with some probability (depending on the random coin tosses of the prover and the verier).

An interactive proof system (;V) for a promise problem is said to be "honest veri er statistical zero know ledge", and in short HVSZK, if there exists a probabilistic polynom ial time simulator S that for every x 2 $_{\rm Yes}$ produces a distribution on transcripts that is close (in the '_1 distance de ned below) to the distribution on transcripts in the real proof. If the simulated distribution is exactly the correct distribution, we say the proof system is "honest veri er perfect zero know ledge, and in short HVPZK.

W e stress that the simulator's output is based on the input alone, and the simulator has no access to the prover. Also, note that we only require the simulator to produce a good distribution on inputs in $_{Yes}$, and we do not care about other inputs. This is because for "No" instances there is no correct proof anyway. We refer the interested reader to Vadhan's thesis [44] for rigorous de nitions and a discussion of their subtleties.

The de nition of HVSZK captures exactly the notion of \zero knowledge"; If the honest veri er can simulate the interaction with the prover by him self, in case the input is in , then he does not learn anything from the interaction (except for the knowledge that the input is in). We denote by HVSZK the class of all prom ise problems that have an interactive proof which satis es these restrictions. O ne can wonder whether cheating veri ers can get inform ation from an honest prover by deviating from the protocol. Indeed, in some interactive proofs this happens. However, a general result says that any HVSZK proof can be simulated by one which does not leak much inform ation even with dishonest veri ers [3]. We thus denote by SZK the class of all prom ise problem s which have interactive proof system s which are statistically zero knowledge against an honest (or equivalently a general) veri er.

It is known that $BPP SZK AM \setminus coAM$ and that SZK is closed under complement. It follows that SZK does not contain any NP {complete language unless the polynomial hierarchy collapses. For this, and other results known about this elegant class, we refer the reader, again, to Vadhan's thesis [44].

2.2 The complete problem

Recently, Sahaiand Vadhan found a natural complete problem for the class Statistical Zero K now ledge, denoted by SZK. One nice thing about the problem is that it does not mention interactive proofs in any explicit or implicit way. We need some facts about distances between distributions in order to de ne the problem. For two classical distributions fp(x)g; fq(x)g de ne their ' distance and their delity (this measure is known by many other names as well):

We also de ne the variation distance to be $jp qjj = \frac{1}{2}jp qj$ so that it is a value between 0 and 1. The following fact is very useful:

Fact 1. (See [37])

or equivalently

We can now de ne the complete problem for SZK:

De nition 2. Statistical Di erence (SD;)

Input : Two classical circuits C_0 ; C_1 with m Boolean outputs.

Promise: jj _{c0} D_{c1} jj or j _{c0} D_{c1} jj

Output: Which of the two possibilities occurs? (yes for the rst case and no for the second)

Sahai and Vadhan [40, 44] show that for any two constants 0 < 1 such that even 2 > ,SD ; is complete for SZK 1 . A well explained exposition can also be found in [44].

2.3 Reduction from SZK to Q sam pling.

We need a very simple building block.

C laim 1. Let $=\frac{p^{1}}{2}$ (\mathcal{D} ; vi+ j]; wi). If we apply a Hadam and gate on the rst qubit and measure it, we get the answer 0 with probability $\frac{1+R \operatorname{eal}(\operatorname{try} i)}{2}$ and 1 with probability $\frac{1-R \operatorname{eal}(\operatorname{try} i)}{2}$.

The proof is a direct calculation. We now proceed to prove Theorem 1.

Proof. Let $C_0; C_1$ be an input to SD, $C_0; C_1$ are circuits with moutputs. It is enough to show that SD_{1=4;3=4} 2 BQP, given that we can Q sample from the given circuits. Let us not assume that we can Q sample from both circuits with = 0 error. We can therefore generate the superposition $\frac{1}{2}$ (Di f_0 i + f_1 i f_1 i). We then apply a Hadam and gate on the not qubit and measure it. We use C laim 1 with v = f_0 i and w = f_1 i. In our case

We therefore get 0 with probability $\frac{1+F(D_{C_0};D_{C_0})}{2}$. Thus,

¹Sahai and Vadhan also show, ([44], Proposition 4.7.1) that any prom ise problem in HVPZK reduces to $SD_{1=2,0}$, where the line above the class denotes com plem ent, i.e., we swap between the yes and no instances.

Setting $=\frac{3}{4}$ and $=\frac{1}{4}$ we get that if $jD_{C_0} D_{C_1}jj$ we measure 0 with probability at most $\frac{1+p(1-2)}{2}$ 0:831, while if $jD_{C_0} D_{C_1}jj$ we measure 0 with probability at least 1 $\frac{1}{2}$ $\frac{7}{8} = 0.875$. Repeating the experiment 0 ($\log(\frac{1}{2})$) times, we can decide on the right answer with error probability smaller than . If the quantum sampling circuit has a small error (say $<\frac{1}{100}$) then the resulting states are close to the correct ones and the error introduced can be swallowed by the gap of the BQP algorithm.

The above theorem shows that in order to give an e-cient quantum algorithm for any problem in SZK, it is su cient to nd an e-cient quantum sampler from the corresponding circuits. One can use the theorem to start from a zero know ledge proof for a certain language, and translate it to a fam ily of circuits which we would like to Q sample from. Sometimes this reduction can be very easy, without the need to go through the complicated reduction of Sahai and Vadhan [40], but in general we do not know that the speci-cation of the states is easy to derive. For the sake of illustration, we give the exact descriptions of the states required to Q sample from for three examples, in which the reduction turns out to be much simpler than the general case. These cases are of particular interest for quantum algorithm s: discrete log, quadratic residuosity and a gap version of C losest vector in a lattice.

2.4 A promise problem equivalent to D iscrete Log

The problem :

Goldreich and Kushilevitz [21] de ne the promise problem DLP_c as:

Input: A prime p, a generator g of \mathbb{Z}_p and an input y 2 \mathbb{Z}_p . Prom ise: The prom ise is that $x = \log_p(y)$ is in $[1;qp] [\frac{p}{2} + 1;\frac{p}{2} + qp]$, Output: W hether x 2 [1;qp] or x 2 $\frac{p}{3} + 1;\frac{p}{2} + qp]$

[21] proves that D LOG is reducible to D LP_c for every 0 < c < 1=2. They also prove that D LP_c has a perfect zero know ledge proof if 0 < c 1=6. W e take c = 1=6 and show how to solve D LP₁₌₆ with CQS.

The reduction :

We assume we can solve the construction problem for the circuit $C_{y;k} = C_{n;g;y;k}$ that computes $C_{y;k}$ (i) = y ign odp) for i 2 f0;1g^k. The algorithm gets into the state $\frac{p!}{2}$ [jDi $C_{g^{p=2+1};blog(p)c-1}$ + jLi $C_{y;blog(p)c-3}$] and proceeds as in C laim 1.

Correctness :

2.5 Quadratic residuosity

The problem :

we denote xRn if $x = y^2 \pmod{n}$ for som ey, and xNn otherwise. The problem QR is to decide on input x; n whether xRn. An e cient algorithm is known for the case of n being a prime, and the problem is believed to be hard for n = pq where p; q are chosen at random among large primes p and q. A basic fact, that follows directly from the Chinese remainder theorem is

Fact 2.

If the prime factorization of n is $n = p_1^{e_1} p_2^{e_2} ::: p_k^{e_k}$, then for every x

If the prime factorization of n is $n = p_1 p_2 ::: p_k$ then every $z \ge z_n$ that has a square root, has the same number of square roots.

We show how to reduce the n = pq case to the CQS (adopting the zero know ledge proof of [24]).

The reduction : We use the circuit $C_a(r)$ that on input r 2 Z_n outputs $z = r^2 a \pmod{n}$. Suppose we know how to quantum sample C_a for every a. On input integers n;x, (n;x) = 1, the algorithm gets into the state $\frac{p^1}{2}$ [DijC_1i+ jlijC_xi] and proceeds as in C laim 1.

Correctness :

W e have

Suppose xN n. There are only p+q = 1 integers $r \ge Z_n$ that are not co-prime to n. For every r co-prime with p, $z = xr^2$ must be a non-residue (or else xR n as well). We conclude that $\sum_{z:zRn} p_z = \frac{p+q}{pq} = 0$ and so $hC_x jC_1 i = 0$.

We note that for a general n, dierent elements might have a dierent number of solutions (e.g., try n = 8) and the number of elements not co-prime to n might be large, so one has to be more careful.

2.6 Approximating CVP

We describe here the reduction to quantum sampling for a gap problem of CVP (closest vector in a lattice), which builds upon the statistical zero know ledge proof of G oldreich and G oldwasser [22]. A lattice of dimension n is represented by a basis, denoted B, which is an n non-singularmatrix over R. The lattice L (B) is the set of points L (B) = fB c jc 2 Zⁿg, i.e., all integer linear combinations of the columns of B. The distance d(v₁;v₂) between two points is the Euclidean distance '2. The distance between a point v and a set A is d(v;A) = m in_{a2A} d(v;a). We also denote j\$ jj the length of the largest vector of the set S. The closest vector problem, CVP, gets as input an n{dimensional lattice B and a target vector v 2 Rⁿ. The output should be the point b2 L (B) closest to v. The problem is NP hard. Furtherm ore, it is NP hard to approximate the distance to the closest vector in the lattice to within sm all factors, and it is easy to approximate it to within 2ⁿ factor, for every > 0. See [22] for a discussion. In [22] an (honest prover) perfect zero know ledge proof is period.

The problem :

Input: An n {dim ensional lattice B, a vector v 2 Rⁿ and designated distance d. W e set $g = g(n) = \frac{n}{c \log n}$, for som e c > 0.

Promise: Eitherd(v;L(B)) dord(v;L(B)) g d. Output: W hich possibility happens.

W e let H $_{\rm t}$ denote the sphere of all points in R $^{\rm n}$ of distance at most t from the origin.

The reduction : The circuit C_0 gets as input a random string, and outputs the vector r + , where r is a uniform ly random point in $H_{2^n jB} [fvgjj] \ L (B)$ and is a uniform ly random point $2 H_{\frac{q}{2}} d$ [22] explain how to sample such points with alm ost the right distribution, i.e. they give a description of an e cient such C_0 .

We remark that the points cannot be random ly chosen from the real (continuous) vector space, due to precision issues, but [22] show that taking a ne enough discrete approximation and a large enough cuto of the lattice results in an exponentially smallerror. >From now on we work in the continuous world, bearing in m ind that in fact everything is im plemented in a discrete approximation of it.

Now assume we can quantum sample from the circuit C_0 . We can then also quantum sample from the circuit C_v which we de ne to be the same circuit except that the outputs are shifted by the vector v and become r + + v. To solve the gap problem the algorithm gets into the state $\frac{1}{p_2}$ [Jif_0i + Jif_1i] and proceeds as in C laim 1.

Correctness :

If v is far away from the lattice L (B), then the calculation at [22] shows that the states jC_0i and jC_1i have no overlap and so $hC_0jC_1i = 0$.

On the other hand, suppose v is close to the lattice, d(v; L(B)) = d. Notice that the noise has magnitude about gd, and so the spheres around any lattice point r and around r+v have a large overlap. Indeed, the argument of [22] shows that if we express $f_0 i = \frac{1}{z} p_z j i$ and $f_1 i = \frac{1}{z} p_z^0 j$; it then $j = p^0 j = 1$ n^{2c}. We see that $hC_0 f_1 i = F(p; p^0) = n^{2c}$. Iterating the above poly (n) times we get an RQP algorithm, namely a polynomial quantum algorithm with one sided error.

3 Physics Background

This section gives background required for our de nition of adiabatic state generation. We start with some preliminaries regarding the operator norm and the Trotter form ula. We then describe the adiabatic theorem, and the model of adiabatic computation as de ned in 20].

3.1 SpectralNorm

The operator norm of a linear transform ation T, induced by the $\frac{1}{2}$ norm is called the spectral norm and is de ned by

De nition 3. We say a linear transformation T_2 {approximates a linear transformation T_1 if jT_1 $T_2 jj$, and if this happens we write $T_2 = T_1 + .$

3.2 Trotter Form u la

Say $H = {}^{P} H_{m}$ with each H_{m} Herm itian. Trotter's formula states that one can approximate e^{itH} by slowly interleaving executions of $e^{tH_{m}}$. We use the following variant of it:

Lem m a 3. [37] Let H_i be Herm itian, $H = {P \atop m=1} H_m$. Further assume H and H_i have bounded norm, jH j; jH ij . De ne

Notice that for every xed t; M and , the error term goes down to zero with . In applications, we will pick to be polynom ially sm all, in such a way that the above error term is polynom ially sm all.

3.3 Tim e D ependent Schrodinger E quation

A quantum state j i of a quantum system evolves in time according to Schrodinger's equation:

where H (t) is a Herm itian matrix which is called the Ham iltonian of the physical system. The evolution of the state from time 0 to time T can be described by integrating Schrodinger's equation over time. If H is constant and independent of time, one gets

Since H is Hermitian e^{iHT} is unitary, and so we get the familiar unitary evolution from quantum circuits. The time evolution is unitary regardless of whether H is time dependent or not.

The groundstate of a H am iltonian H is the eigenstate with the sm allest eigenvalue, and we denote it by (H). The spectral gap of a H am iltonian H is the di erence between the sm allest and second to sm allest eigenvalues, and we denote it by (H).

3.4 The adiabatic Theorem

In the study of adiabatic evolution one is interested in the long time behavior (at large times T) of a quantum system initialized in the ground state of H at time 0 when the H am iltonian of the system, H (t) changes very slow ly in time, namely adiabatically.

The qualitative statement of the adiabatic theorem is that if the quantum system is initialized in the ground state of H (0), the Hamiltonian at time 0, and if the modi cation of H along the path H (t) in the Hamiltonian space is done in nitely slowly, then the nalstate will be the ground state of the nalHamiltonian H (T).

To make this statement correct, we need to add various conditions and quanti – cations. Historically, the rst and simplest adiabatic theorem was found by Bom and Fock in 1928 [8]. In 1958 K ato [31] improved the statement to essentially the statement we use in this paper (which we state shortly), and which is usually referred to as the adiabatic theorem. A proof can be found in [36]. For more sophisticated adiabatic theorems see [7] and references therein.

To state the adiabatic theorem, it is convenient and traditional to work with a re-scaled time $s = \frac{t}{T}$ where T is the total time. The Schrödinger's equation restated in terms of the re-scaled times then reads

where $T = \frac{dt}{ds}$ can be referred to as the delay schedule, or the total time.

Theorem 4. (The adiabatic theorem, adapted from [36, 20]). Let H () be a function from [0;1] to the vector space of H am iltonians on n qubits. Assume H () is continuous, has a unique ground state, for every s 2 [0;1], and is di erentiable in all

but possibly nitely many points. Let > 0 and assume that the following adiabatic condition holds for all points s 2 (0;1) in which the derivative is dened:

Then, a quantum system that is initialized at time 0 with the ground state (H (0)) of H (0), and evolves according to the dynam ics of the H am iltonians H (), ends up at re-scaled time 1 at a state j (1) i that is within $^{\circ}$ distance from (H (1)) for some constant c > 0.

W e will refer to equation 14 as the adiabatic condition.

The proof of the adiabatic theorem is rather involved. One way to get intuition about it is by observing how the Schrödinger equation behaves when eigenstates are considered; If the eigenvalue is , the eigenstate evolves by a multiplicative factor $e^{i t}$, which rotates in time faster the larger the absolute value of the eigenvalue is, and so the ground state rotates the least. The fast rotations are essentially responsible to the cancellations of the contributions of the vectors with the higher eigenvalues, due to interference e ects.

4 A diabatic Q uantum State G eneration

In this section we de ne our paradigm for quantum state generation, based on the ideas of adiabatic quantum computation (and the adiabatic theorem). We would like to allow as much exibility as possible in the building blocks. We therefore allow any Ham iltonian which can be implemented e ciently by quantum circuits. We also allow using general Ham iltonian paths and not necessarily straight lines. We de ne:

De nition 4. (Sim ulatable H am iltonians). We say a Ham iltonian H on n qubits is sim ulatable if for every t > 0 and every accuracy 0 < < 1 the unitary transformation

can be approximated to within accuracy by a quantum circuit of size poly (n;t;1=).

If H is simulatable, then by de nition so is cH for any 0 c poly (n). It therefore follows by Trotter's equation (3) that any convex combination of two simulatable, bounded norm H am iltonians is simulatable. Also, If H is simulatable and U is a unitary matrix that can be e ciently applied by a quantum circuit, then UHU^Y is also simulatable, because e $itUHU^Y = Ue^{itH}U^Y$.

W e note that these rules cannot be applied unboundedly m any times in a recursive way, because the simulation will then blow up. The interested reader is referred to [37, 10] for a m ore complete set of rules for simulating H am iltonians.

W e now describe an adiabatic path, which is an allow able path in the H am iltonian space:

De nition 5. (A diabatic path). A function H from s 2 [0;1] to the vector space of H am iltonians on n qubits, is an adiabatic path if

H (s) is continuous,

H (s) is di erentiable except for nitely many points,

8s H (s) has a unique groundstate, and

8s, H (s) is simulatable given s.

The adiabatic theorem tells us that the time evolution of a system evolving along the adiabatic path willend with the nalground state, if done slow ly enough, namely when the adiabatic condition holds. A diabatic quantum state generation is basically the process of implementing the Schrödinger's evolution along an adiabatic path, where we require that the adiabatic condition holds.

De nition 6. (A diabatic Q uantum State G eneration). An adiabatic Q uantum State G enerator (H_x (s);T;) has for every x 2 f0;1gⁿ an adiabatic path H_x (s), such that for the given T; the adiabatic condition is satis ed for all s 2 [0;1] where it is de ned. W e also require that the generator is explicit, i.e., that there exists a polynom ialtim e quantum machine that

On input x 2 f0;1ⁿ outputs (H $_x$ (0)), the groundstate of H $_x$ (0), and, On input x 2 f0;1ⁿ, s 2 [0;1] and > 0 outputs a circuit C $_x$ (s) approximating e $^{i H_x (s)}$.

We then say the generator adiabatically generates $(H_x(1))$.

Remark: We note that in previous papers on adiabatic computation, eg. in [15], a delay schedule (s) which is a function of s was used. We chose to work with one single delay parameter, T, instead, which m ight seem restrictive; However, working with a single parameter does not restrict the model since more complicated delay schedules can be encoded into the dependence on s.

We will show that every adiabatic quantum state Generator can be e ciently simulated by a quantum circuit, in Claim 2. We later on prove the other direction of Claim 2, which implies Theorem 2, which shows the equivalence in computational power of quantum state generation in the standard and in the adiabatic fram eworks. Thus, designing state generation algorithms in the adiabatic paradigm indeed makes sense since it can be simulated e ciently on a quantum circuit, and we do not lose in computational power by moving to the adiabatic fram ework and working only with ground states. The advantage in working in the adiabatic model is that the language of this paradigm seems more adequate for developing general tools. A fler the statement and proof of Claim 2, we proceed to prove several such basic tools. Once we develop these tools, we will be able to prove the other direction of the equivalence theorem and apply the tools for generating interesting states.

4.1 Circuit simulation of adiabatic state generation

An adiabatic state generator can be simulated e ciently by a quantum circuit:

C laim 2. (C incuit simulation of adiabatic state generation). Let $(H_x(s);T;)$ be an Adiabatic Quantum State Generator. Assume T poly (n). Then, there exists a quantum circuit that on input x generates the state $(H_x(1))$ to within accuracy, with size poly (T;1=;n).

Proof. (B ased on A diabatic Theorem) The circuit is built by discretizing time to su ciently small intervals of length , and then applying the unitary matrices e^{iH (j)}. Intuitively this should work, as the adiabatic theorem tells us that a physical system evolving for time T according to Schrodinger's equation with the given adiabatic path will end up in a state close to (H_x(1)). The form al error analysis can be done by exactly the same techniques that were used in [15]. We do not give the details of the proof based on the adiabatic theorem here, since the proof of the adiabatic theorem itself is hard to follow.

We give a second proof of C laim 2. The proof does not require know ledge of the adiabatic theorem . Instead, it relies on the Zeno e ect [8], and due to its simplicity, we can give it in full details. We include it in order to give a self contained proof of C laim 2, and also because we believe it gives a di erent, illum inating perspective on the adiabatic evolution from the measurement point of view . We note that another approach toward the connection between adiabatic computation and measurements was taken in [11]. The full Zeno based proof appears in Appendix A . Here we give a sketch.

Proof. (B ased on the Zeno e ect) As before, we begin at the state (H (0)), and the circuit is built by discretizing time to su ciently small intervals of length . At each time step j, j = 1; :::; R, instead of simulating the H am iltonian as before we apply a measurement determined by H (s_j). Speci cally, we measure the state in a basis which includes the groundstate (H (s_j)). If R is su ciently large, the subsequent H am iltonians are very close in the spectral norm, and the adiabatic condition guarantees that their groundstates are very close in the Euclidean norm. G iven that at time step j the state is the groundstate (H (s_j)), the next measurement results with very high probability in a projection on the new groundstate (H (s_{j+1})). The Zeno e ect guarantees that the error probability behaves like $1=R^2$, i.e. quadratically in R (and not linearly), and so the accumulated error after R steps is still small, which in plies that the probability that the nal state is the groundstate of H (1) is very high, if R is taken to be large enough.

5 The Sparse H am iltonian Lem m a

Our rst concern is which H am iltonians can be simulated e ciently. We restate the sparse H am iltonian lemma:

Lem m a 1 The sparse H am iltonian lem m a If H is a row-sparse, row-computable H am iltonian on n qubits and jH jj poly (n) then H is simulatable.

The main idea of the proof is to explicitly write H as a sum of polynom ially many bounded norm H am iltonians H_m which are all block diagonal (in a combinatorial sense) and such that the size of the blocks in each matrix is at most 2 2. We then show that each H am iltonian H_m is simulatable and use Trotter's formula to simulate H.

5.1 The reduction to 2 2 combinatorially block diagonal matrices.

Let us de ne:

De nition 7. (Combinatorialblock.) Let A be a matrix with rows ROW S(A) and columns COLS(A). We say (R;C) ROW S(A) COLS(A) is a combinatorial block if $\Re j = jC j$ for every c2 C, r & R, A (c;r) = 0, and for every c& C, r 2 R, A (c;r) = 0.

A is block diagonal in the combinatorial sense i there is some renaming of the nodes under which it becomes block diagonal in the usual sense. Equivalently, A is block diagonal in_S the combinatorial sense i there is a decomposition of its rows into ROW S (A) = $\begin{bmatrix} B \\ b=1 \end{bmatrix}$ R_b, and of its columns COLS (A) = $\begin{bmatrix} B \\ b=1 \end{bmatrix}$ C_b such that for every b, (R_b;C_b) is a combinatorial block. We say A is 2 2 combinatorially block diagonal, if each combinatorial block (R_b;C_b) is at most 2 2, i.e., for every b either $\Re_b j = \Im_b j = 1$ or $\Re_b j = \Im_b j = 2$.

C laim 3. (D ecom position lem m a). Let H be a row-sparse, row-com putable H am iltonian over n qubits, with at most D non-zero elements in each row. Then there is a way to decom pose H into $H = \int_{m=1}^{D+1/2} n^6 H_m$ where:

Each H_m is a row-sparse, row-computable H am iltonian over n qubits, and,

Each H_m is 2 2 combinatorially block diagonal.

Proof. (Of C laim 3) We color all the entries of H with $(D + 1)^2 n^6$ colors. For (i; j) 2 [N] and i < j (i.e., (i; j) is an upper-diagonal entry) we de ne:

where

If i = j we set k = 1, otherwise we let k be the set integer in the range [2:n] such that $i \notin j \pmod{k}$, and we know there must be such a k.

If $H_{i;j} = 0$ we set rindex_H (i; j) = 0, otherwise we let rindex_H (i; j) be the index of $H_{i;j}$ in the list of all non-zero elements in the i'th row of H. cindex_H (i; j) is similar, but with regard to the columns of H.

For lower-diagonal entries, i > j, we de ne $\infty_{\mathbb{H}}$ (i; j) = $\infty_{\mathbb{H}}$ (j; i). A ltogether, we use $(n^2)^3$ (D + 1³) colors.

For a colorm, we de ne H_m [i; j] = H [i; j] cl_{H} (i; j) m, i.e., H_m is H on the entries colored by m and zero everywhere else. Clearly, $H = mH_m$ and each H_m is H erm itian. Also as H is row-sparse and row-computable, there is a simple poly (n)-time classical algorithm computing the coloring col_H (i; j), and so each H_m is also row-computable. It is left to show that it is 2 2 combinatorially block-diagonal.

Indeed, x a colorm. Let us order all the upper-triangular, non-zero elements of H_m in a list N ON ZERO_m = f(i;j) jH_m (i;j) \notin 0 and i jg. Say the elements of N ON ZERO_m are f(i;j);:::;(i_b;j_b)g. For every element (i_b;j_b) 2 N ON ZERO_m we introduce a block. If $i_b = j_b$ then we set $R_b = C_b = fi_bg$ while if $i_b \notin j_b$ then we set $R_b = C_b = fi_bg$ while if $i_b \notin j_b$ then we set $R_b = C_b = fi_bg$.




Figure 1: In the upper diagonal side of the matrix H_m : the row and column of $(i_b; j_b)$ are empty because the color m contains the row-index and column index of (i; j), and the j_b 'th row and i_b 'th column are empty because m contains k; im od k; jm od k and im od k \in jm od k. The lower diagonal side of H_m is just a relation of the upper diagonal side. It follows that $fi_b; j_bg$ is a 2 2 com binatorial block.

Say $i_b \notin j_b$ (the $i_b = j_b$ case is similar and simpler). As the colorm contains the row-index and colum n-index of $(i_b; j_b)$, it must be the case that $(i_b; j_b)$ is the only element in NONZERO_m from that row (or column). Furthermore, as $i_b \mod k \notin j_b \mod k$, and both k; im od k and jm od k are included in the colorm, it must be the case that there are no elements in NONZERO_m that belong to the j_b row or i_b column (see Figure 1). It follows that $(R_b; C_b)$ is a block. We therefore see that H_m is 2 combinatorially block-diagonal as desired.

Claim 4. For every m, jH m jj jH jj.

Proof. Fix an m . H $_m$ is combinatorially block diagonal and therefore its norm $jH_m jj$ is achieved as the norm of one of its blocks. Now, H $_m$ blocks are either

- 1 1, and then the block is $(H_{i;i})$ for some i, and it has norm $H_{i;i}$ j or,
- 2 2, and then the block is $\begin{pmatrix} 0 & A_k; \\ A_k; \\ 0 & \end{pmatrix}$ for some k; ', and has norm $A_k; j$.

It follows that $\max_{m} j H_{m} j m ax_{k}; H_{k}; j$. On the other hand $j H j m ax_{k}; H_{k}; j$. The proof follows.

5.2 2 combinatorially block diagonal matrices are simulatable.

C laim 5. Every 2 2 combinatorially block diagonal, row-computable H am iltonian A is simulatable to within arbitrary polynom ial approximation.

Proof. Let t > 0 and > 0 an accuracy parameter.

The circuit :

A is 2 2 combinatorially block diagonal. It therefore follows that A's action on a given input ki is captured by a 2 2 unitary transform ation U_k . Form ally, given k, say ki belongs to a 2 2 block fk; 'g in A. We set $b_k = 2$ (for a 2 2 block) and m in_k = m in (k; '), m ax_k = m ax (k; ') (for the subspace to which k belongs). We then set A_k to be the part of A relevant to this subspace

$$T_1: k;0i! b_k; m in_k; m ax_k; A_k; \Phi_k; k$$

where \bar{A}_k is our approximation to the entries of A_k and $\bar{\Phi}_k$ is our approximation to e ${}^{it\bar{A}_k}$, and where both matrices are expressed by their four (or one) entries. We use ${}^{\circ (1)}$ accuracy.

Having $\hat{\Phi}_k$; m in_k; m ax_k; k w ritten down, we can simulate the action of $\hat{\Phi}_k$. We can therefore have an e cient unitary transform ation T_2 :

for jvi2 Spanfm in_k ; m ax_kg .

Our algorithm is applying T_1 followed by T_2 and then T_1^{-1} for cleanup.

Correctness: Let us denote D $\mathbb{F}F = e^{itA}$ $T_1^{-1}T_2T_1$. Our goal is to show that jDi jj. We notice that D i is also 2 2 block diagonal, and therefore its norm can be achieved by a vector belonging to one of its dimension one or two subspaces, say to Spanfmin_k; max_kg. Let U_k j i = jmin_ki + jmax_ki and f_k j i = e jmin_ki + ^e jmax_ki. We see that:

where the set equation holds since it holds for jn in i, jn ax_k i and by linearity it holds for the whole subspace spanned by them . We conclude that \mathcal{D} i j i j= $j(U_k \quad \mathbf{f}_k)$ j i j and so j \mathcal{D} i j = m ax_k j $\mathcal{U}_k \quad \mathbf{f}_k$ jj. However, by our construction, j $\mathbf{f}_k \quad A_k$ jj \circ ⁽¹⁾ and so j $\mathbf{f}_k \quad U_k$ jj as desired.

We proved the claim for matrices with 2 $2 \mod b$ inatorial blocks. We remark that the same approach works for matrices with m m combinatorial blocks, as long as m is polynomial in n.

5.3 Proving the sparse H am iltonian lem m a

W e now prove the sparse H am iltonian Lem m a:

Proof. (Of Lemma 1.) Let H be row-sparse with D poly (n) non-zero elements in each row, and jH jj = poly(n). Let t > 0. Our goal is to e ciently simulate e^{itH} to within acquiracy.

We express $H = \prod_{m=1}^{p} H_m$ as in C laim 3, M $(D + 1)^2 n^6$ poly (n). We choose such that 0 (M t ${}^{3-2}$) $\frac{1}{2}$. Note that $\frac{1}{2}$ poly (t; n) for some large enough polynom ial. By C laim 5 we can simulate in polynom ial time each e ${}^{i H_m}$ to within $\frac{1}{2M t_{\pm}}$ accuracy. We then compute $U^{\frac{t}{2}}$, using our approximations to e ${}^{i H_m}$, as in Corollary 3. Corollary 3 assures us that our computation is close to e itH , as desired (suing the fact that for every m, $jH_m jj = jH jj=$ poly (n)). The size of the computation is $\frac{t}{2}$ 2M poly (; M; n;) = poly (n; t;) as required.

6 The Jagged A diabatic Path Lemma

Next we consider the question of which paths in the Ham iltonian space guarantee non negligible spectral gaps. We restate the jagged adiabatic path lemma.

Lem m a 2: Let $fH_{j}g_{j=1}^{T=poly(n)}$ be a sequence of bounded norm, simulatable H am iltonians on n qubits, with non-negligible spectral gaps and with groundvalues 0 such that the inner product between the unique ground states (H_{j}) ; (H_{j+1}) is non negligible for all j. Then there is an e cient quantum algorithm that takes (H_{0}) to within arbitrarily small distance from (H_{T}) .

Proof. (of lem m a 2) W e replace the sequence fH jg with the sequence of H am iltonians H is a projection on the space orthogonal to the groundstate of H j, and we connect two neighboring projections by a line. W e prove in claim 6, using K itaev's phase estimation algorithm, that the fact that H j is simulatable implies that so is H i. A lso, as projections, H have bounded norms, jj H jj 1. It follows




Figure 2: In the left side of the drawing we see two H am iltonians H_1 and H_2 connected by a straight line, and the spectral gaps along that line. In the right side of the drawing we see the same two H am iltonians H_1 and H_2 connected through a jagged line that goes through a third connecting H am iltonian H_3 in the middle, and the spectral gaps along that jagged path. Note that on the left the spectral gap becomes zero in the middle, while on the right it is always larger than one.

then, by the results mentioned in Section 3, that all the Ham iltonians on the path connecting these projections are simulatable, as convex combinations of simulatable Ham iltonians.

We now have to show the H am iltonians on the path have non negligible spectral gap. By de nition $_{H_j}$ has a spectral gap equal to 1. It remains to show, however, that the H am iltonians on the line connecting $_{H_j}$ and $_{H_{j+1}}$ have large spectral gaps, which we prove in the simple C laim 7.

We can now apply the adiabatic theorem and get Lemma 2. Indeed, a linear time parameterization su ces to show that this algorithm satis es the adiabatic condition. $\hfill \square$

C laim 6. (H am iltonian-to-projection lemma). Let H be a Ham iltonian on n qubits such that e^{iH} can be approximated to within arbitrary polynomial accuracy by a polynomial quantum circuit, and let kH k m = poly(n). Let (H) be non negligible, and larger than $1=n^{\circ}$, and further assume that the groundvalue of H is 0. Then the projection $_{H}$, is simulatable.

P roof. W e observe that K itaev's phase estimation algorithm [32, 37] can be applied here to give a good enough approximation of the eigenvalue, and as the spectral gap is non-negligible we can decide with exponentially good condence whether an eigenstate has the lowest eigenvalue or a larger eigenvalue. We therefore can apply the following algorithm:

Apply K itaev's phase estimation algorithm to write down one bit of information on an extra qubit: whether an input eigenstate of H is the ground state or orthogonal to it. Apply a phase shift of value e^{it} to this extra qubit, conditioned that it is in the state jli (if it is jli we do nothing). This conditional phase shift corresponds to applying for time t a Ham iltonian with two eigenspaces, the ground state and the subspace orthogonal to it, with respective eigenvalues 0 and 1, which is exactly the desired projection.

F inally, to erase the extra qubit written down, we reverse the state and uncalculate the inform ation written on that qubit using K itaev's phase estimation algorithm again.

W e will also use the following basic but useful claim regarding the convex com bination of two projections. For a vector j i, the H am iltonian H = I j ih j is the projection onto the subspace orthogonal to . We prove:

Claim 7. Let ji; jibe two vectors in some subspace, H = I jih jand H = I jih j. For any convex combination H = (1)(I jih j)+ (I jih j; 2 [0;1], of the two Ham iltonians H; H, (H) jh jij.

Proof. To prove this, we observe that the problem is two dimensional, write $j i = aj i + bj^2 i$, and write the matrix H in a basis which contains j i and $j^2 i$. The eigenvalues of this matrix are all 1 except for a two dimensional subspace, where the matrix is exactly

$$\dot{a}\dot{f} + (1) ab$$

 $ab \dot{b}\dot{f}$: (17)

D is gonalizing this matrix we nd that the spectral gap is exactly $1 4(1) \frac{1}{2}$ which is minimized for = 1=2 where it is exactly jaj.

W e use the tools we have developed to prove the equivalence of standard and adiabatic state generation complexity, and for generating interesting M arkov chain states. W e start with the equivalence result.

7 Equivalence of Standard and A diabatic State G eneration

Theorem 2 asserts that any quantum state that can be e ciently generated in the quantum circuit model, can also be e ciently generated by an adiabatic state generation algorithm, and vice versa. We already saw the direction from adiabatic state generation to quantum circuits. To complete the proof of Theorem 2 we now show the other direction.

C laim 8. Let j i be the nalstate of a quantum circuit C with M gates, then there is a quantum adiabatic state generator which outputs this state, of com p lexity poly (n; M).

Proof. W log. the circuit starts in the state jli. We rst modify the circuit so that the state does not change too much between subsequent time steps. The reason we need this will become apparent shortly. To make this modication, let us assume for concreteness that the quantum circuit C uses only Hadam and gates, To oligates and N ot gates. This set of gates was recently shown to be universal by Shi [43], and a simpli ed proof can be found in 3 (Our proof works with any universal set with obvious modications.) We replace each gate g in the circuit by two^P \overline{g} gates. For $\overline{P} \overline{g}$ we can choose any of the possible square roots arbitrarily, but for concreteness we notice that Hadam and, N ot and To oligates have 1 eigenvalues, and we choose $\overline{1} = 1$ and $\overline{1} = i$. We call the modi ed circuit C⁰. Obviously C and C⁰ compute the same function.

The path. We let M^{0} be the number of gates in C^{0} . For integer 0 j M^{0} , we set

$$H_{x}\left(\frac{j}{M_{0}}\right) = I \quad j_{x}(j)ih_{x}(j)j$$

where $j_x(j)i$ is the state of the system after applying the rst j gates of C^0 on the input x. For $s = \frac{j+}{M^0}$, 2 [D;1), de ne $H_x(s) = (1)H_x(j) + H_x(j+1)$.

The spectral gaps are large. C learly all the H am iltonians $H_x(j)$ for integer 0 j M⁰, have non-negligible spectral gaps, since they are projections. We claim that for any state and any gate $p \overline{g}$, $p \overline{g}j i j \frac{p_1}{p_1}$. Indeed, represent as $a_1v_1 + a_2v_2$ where v_1 belongs to the 1-eigenspace of $p^2\overline{g}$ and v_2 belongs to the i-eigenspace of $p \overline{g}$. We see that $p \overline{g}j j j = j\overline{a}_1 f + j\overline{a}_2 f j$. As $j\overline{a}_1 f + j\overline{a}_2 f = 1$, a little algebra shows that this quantity is at least $p \overline{b}$. In particular, setting = x(j) we see that $p x(j)j x(j+1)ij p \overline{b}$. It therefore follows by claim 7 that all the H am iltonians on the line between $H_x(j)$ and $H_x(j+1)$ have spectral gaps larger than $p \overline{b}_2$.

The H am iltonians are simulatable. Given a state jyi we can

Apply the inverse of the st j gates of C, If we are in state jx;0i apply a phase shift e^{i} , and Apply the st j gates of C

which clearly implements $e^{i H_x(j)}$.

A diabatic C ondition is Satis ed. We have $\frac{dH}{ds}(s_0) = \lim_{j \to 0} \frac{H(s_0+) H(s_0)}{M(s_0)}$. We ignore the nitely many points $s = \frac{j}{M^0}$ where j is an integer in [0;M⁰]. For all other points s, when goes to 0 both H(s_0 +) and H(s_0) belong to the same interval. Say they belong to the j'th interval, $s_0 = \frac{j+}{M^0}$, 0 < < 1. Then,

$$H (s_0) = (1)H_x(j) + H_x(j+1)$$

$$H (s_0 +) = H (\frac{j + M^0}{M^0}) = (1 M^0)H_x(j) + (+ M^0)H_x(j+1)$$

It follows that H (s₀ +) H (s₀) = M⁰ H_x(j + 1) M⁰ H_x(j) and $\frac{dH}{ds}$ (s₀) = M⁰ $H_x(j+1)$ H_x(j)]. We conclude that $jj\frac{dH}{ds}jj$ 2M⁰ and to satisfy E quation (14) we just need to pick T = O ($\frac{M^0}{2}$).

8 Quantum State Generation and Markov Chains

F inally, we show how to use our techniques to generate interesting quantum states related to M arkov chains.

8.1 Markov chain Background

We will consider M arkov chains with states indexed by n bit strings. If M is an ergodic (i.e. connected, aperiodic) M arkov chain, characterized with the m atrix M operating on probability distributions over the state space, and p is an initial probability distribution, then $\lim_{t_{1}} m^{t} = w$ here is called the limiting distribution and is unique and independent of p.

A Markov chain M has eigenvalues between 1 and 1. A Markov chain is said to be rapidly mixing if starting from any initial distribution, the distribution after polynom ially many time steps is within total variation distance from the limiting distribution . [5] shows that a Markov chain is rapidly mixing if and only if its second eigenvalue gap is non negligible, namely bounded from below by 1=poly(n).

A M arkov chain is reversible if for the limiting distribution it holds that M [i; j] $_{i} = M$ [j; i] $_{j}$. We note that a symmetric M arkov chain M is in particular reversible. A lso, for an ergodic, reversible M arkov chain M $_{i} > 0$ for all i.

In approximate counting algorithms one is interested in sequences of rapidly mixing Markov chains, where subsequent Markov chains have quite similar limiting distributions. For more background regarding Markov chains, see [35] and references therein; For more background regarding approximate counting algorithms see [30].

8.2 Reversible M arkov chains and H am iltonians

For a reversible M we de ne

$$H_{M} = I \quad D \text{ iag} \begin{pmatrix} p \\ i \end{pmatrix} \qquad M \quad D \text{ iag} \begin{pmatrix} 1 \\ -i \end{pmatrix}$$
(18)

A direct calculation shows that M is reversible i H_M is symmetric. In such a case we call H_M the Ham iltonian corresponding to M. The properties of H_M and M are very much related:

C laim 9. If M is a reversible M arkov chain, we have:

 H_M is a Ham iltonian with $jH_M jj 1$.

The spectral gap of H_M equals the second eigenvalue gap of M .

If is the limiting distribution of M , then the ground state of H_M is (H $_{\rm M}$) = $j \stackrel{\rm def}{=} {}^{\rm P} \stackrel{\rm p}{=} \frac{p}{i}$ (i) ji.

Proof. If M is reversible, H_{M} is Herm it ian and hence has an eigenvector basis. In particular I $H_{M} = M^{-1}$ and so I H_{M} and M have the same spectrum. It follows that if the eigenvalues of H_{M} are $f_{r}g$ then the eigenvalues of M are f1 $_{r}g$. As a reversible M arkov chain, M has norm bounded by 1.

Also, if v_r is an eigenvector of H_M with eigenvalue r, then D iag $\binom{p}{}v_r$ is the corresponding left eigenvectors of M with eigenvalue 1 In particular, D iag $\binom{p}{}(H_M) = (M)$. It therefore follows that $(H_M)_i = \frac{p}{i}$, or in short $(H_M) = j$ i.

This gives a direct connection between H am iltonians, spectral gaps and groundstates on one hand, and rapidly m ixing reversible M arkov chains and lim iting distribution on the other hand.

8.3 Simulating H_M

Not every Ham iltonian corresponding to a reversible Markov chain can be easily simulated. We will shortly see that the Ham iltonian corresponding to a symmetric Markov chain is simulatable. For general reversible Markov chains we need some more restrictions. We de ne:

De nition 8. A reversible Markov chain is strongly sam plable if it is:

row computable, and,

Given i; j2 , there is an e cient way to approxim ate $\frac{1}{4}$.

Row computability holds in most interesting cases but the second requirement is quite restrictive. Still, we note that it holds in many interesting cases such as all M etropolis algorithms (see [25]). It also trivially holds for symmetric M, where the limiting distribution is uniform.

lim it ing distribution is uniform. As H_M [i;j] = $\xrightarrow{i}_{j}M$ [i;j] we see that if M is strongly samplable then H_M is row-computable. As H_M has bounded norm, the sparse Ham iltonian lemma implies:

C orollary 1: If a M arkov chain M is a strongly samplable then H_M is simulatable.

8.4 From Markov chains to Quantum Sampling

We are interested in strongly sam plable rapidly mixing M arkov chains, so that the H am iltonians are simulatable and have non negligible spectral gaps by claim 9. To adapt this setting to adiabatic algorithm s, and to the setting of the jagged adiabatic path lemma in particular, we now consider sequences of M arkov chains, and de ne:

De nition 9. (Slow ly Varying M arkov Chains). Let $fM_tg_{t=1}^T$ be a sequence of Markov chains on , j j= N = 2°. Let t be the limiting distribution of M_t. We say the sequence is slow ly varying if for all c > 0, for all large enough n, for all 1 t T j_t t+1 j 1 1=n^c.

W e prove that we can move from sequences of slow ly varying M arkov chains to Q uantum sampling. W e can now state Theorem 3 precisely.

Theorem 3: Let $fM_{tg_{t=1}}^{T}$ be a slow ly varying sequence of strongly sam plable M arkov chains which are all rapidly mixing, and let t be their corresponding limiting distributions. Then if there is an e cient Q sam pler for $j_{0}i$, then there is an e cient Q sam pler for $j_{T}i$.

Proof. We already saw the H am iltonians H_{M_t} are simulatable and have bounded norm. A lso, as the M arkov chains in the sequence are rapidly m ixing, they have large spectral gaps, and therefore so do the H am iltonians H_{M_t} . To complete the proof we show that the inner product between the groundstates of subsequent H am iltonians is non negligible, and then the theorem pfollows from the jagged path lemma. Indeed, h $(H_{M_t})j(H_{M_{t+1}})i = h_t j_{t+1}i = \int_i f_t(i) f_{t+1}(i) f_t f_{t+1}j_{t+1}j_{t+1}j_{t+1}i = f_t(i) f_t(i) f_{t+1}(i) f_t f_{t+1}j_{t+1}$

E sentially all M arkov chains that are used in approxim ate counting that we are aware of m eet the criteria of the theorem. The following is a partial list of states we can Q sample from using Theorem 1, where the citations refer to the approxim ate algorithms that we use as the basis for the quantum sampling algorithm :

- 1. Uniform superposition over all perfect matchings of a given bipartite graph [29].
- 2. All spanning trees of a given graph [9].
- 3. All lattice points contained in a high dimensional convex body satisfying the conditions of [6].
- 4. Various G ibbs distribution over rapidly m ixing M arkov chains using the M etropolis lter \$5].
- 5. Log-concave distributions [6].

W e note that m ost if not all of these states can be generated using other simpler techniques. However our techniques do not rely on self reducibility, and are thus qualitatively di erent and perhaps extendible in other ways. We illustrate our technique with the example of how to Q sample from all perfect m atchings in a given bipartite graph. We also note that if we could relax the second requirement in D e nition 8 the techniques in this section could have been used to give a quantum algorithm for graph isom orphism.

8.5 Q sam pling from Perfect M atchings

In this subsection we heavily rely on the work of Sinclair, Jerrum and Vigoda [29] who recently showed how to e ciently approximate a permanent of any matrix with non negative entries, using a sequence of Markov chains on the set of Matchings of a bipartite graph. The details of this work are far too involved to explain here fully, and we refer the interested reader to [29] for further details.

In a nutshell, the idea in [29] is to apply a M etropolis random walk on the set of perfect and near perfect m atchings (i.e. perfect m atchings m inus one edge) of the complete bipartite graph. Since [29] is interested in a given input bipartite graph, which is a subgraph of the complete graph, they assign weights to the edges such that edges that do not participate in the input graph are slow ly decreasing until the probability they appear in the nal distribution practically vanishes. The weights of the edges are updated using data that is collected from running the M arkov chain with the previous set of weights, in an adaptive way. The nalM arkov chain with the nal param eters converges to a probability distribution which is essentially concentrated on the perfect m atchings of the input graph, where the probability of the perfect m atchings is 1=n times that of the near perfect m atching.

It is easy to check that the M arkov chains being used in [29] are all strongly samplable, since they are M etropolis chains. M oreover, the sequence of M arkov chains is slow ly varying. It remains to see that can quantum sample from the limiting distribution of the initial chain that is used in [29]. This limiting distribution is a distribution over all perfect and near perfect m atchings in the complete bipartite graph, with each near perfect m atching having weight n times that of a perfect m atching, where n is the number of nodes of the given graph. Indeed, to generate this super-position we do the follow ing:

We generate $2S_n$ in i, where m in the matching on the bipartite graph induced by $2S_n$. We can eligentiate this state because we can generate a super-position over all permutations in S_n , and there is an easy computation from a permutation to a perfect matching in a complete bipartite graph and vice versa.

We generate the state $\text{Di} + \frac{p_n P_n}{n}$ jii norm alized, on a log(n) dimensional register. This can be done e ciently because of the low-dimension.

We apply a transformation that maps in ; ii to j; m i when i = 0, and to j; m feigi for i > 0, where m feig is the matching m minus the i⁰th edge in the matching. There is an easy computation from m feig to m; i and vice versa, and so this transformation can be done e ciently. We are now at the desired state.

Thus we can apply Theorem 1 to Q sample from the limiting distribution of the nalM arkov chain. We then measure to see whether the matching is perfect or not, and with non negligible probability we project the state onto the uniform distribution over all perfect matchings of the given graph.

A Zeno e ect approach to simulating adiabatic Generators

Proof. (Of C laim 2) We concentrate on a time interval $[s_0;s_1]$, $s_0 < s_1$, where H () is continuous on $[s;s_1]$ and di erentiable on $(s_0;s_1)$. We denote $m_{ax} =$

 $\max_{s^2(s_0;s_1)} \frac{dH}{ds}(s)$ is and $\min_{m \text{ in }} = \min_{s^2(s_0;s_1)}$ (H (s)). We choose R $(\frac{2}{\max_{m \text{ in }}})$. Notice that R is polynomially related to the schedule time T in the adiabatic condition.

We divide the interval [0;1] to R time steps. At time step j, j = 1;:::;R, we measure the state with a projective, orthogonal measurement that has the ground state of H $(\frac{j}{R})$ as one of its answers. We begin at the state (H (0)).

We need to show our procedure can be implemented e ciently, i.e., that if H is simulatable and has a non negligible spectral gap, then such a measurement can be implemented e ciently. We also need to show our procedure is accurate, i.e., that under the condition of the adiabatic theorem, for the R we have chosen, with very high probability the nal state is indeed (H (1)).

A ccuracy :

Our next step is to claim that two Ham iltonians that are close to each other have close groundstates. This is captured in the following claim, that we prove later.

Having that, we see that since kH $(\frac{j+1}{R})$ H $(\frac{j}{R})k$ $\frac{max}{R}$, C laim 10 asserts that the probability for successful projection at the j⁰th m easurement, i.e. the probability that the outcome is indeed the groundstate, is 1 O $(\frac{2}{R^2}\frac{ax}{2})$. The probability we err at any of the R steps is therefore at most O $(\frac{2}{R^2}\frac{ax}{2})$ which is

atmost by our choice of R.

E ciency :

We use K itaev's phase estimation algorithm [32, 37] to give, with polynom ially good condence, a polynom ially good approximation of the eigenvalue, and we then measure the eigenvalue. As the spectral gap is non-negligible, this in elect does an orthonorm alm easurement with the eigenstate subspace as one possible answer, as desired. The procedure is polynom ial because H is simulatable and we can electron ciently approximate electron for every polynom ialt.

We nish with the proof of C laim 10.

Proof. (Of Claim 10) W log we can assume H and J are positive, otherwise just add C I to both matrices, for large enough constant C. This does not e ect the spectral norm of the di erence, the spectral gaps or the inner product between the groundstates.
