# Linear optics substituting schem e for $m$ ulti-m ode operations

#### Abstract

W e propose a schem e allow ing a conditional im plem entation of suitably truncated general singleor m ulti-m ode operators acting on states of traveling optical signalm odes. T he schem e solely relies on single-photon and coherent states and applies beam splitters and zero-and single-photon detections. The signal ow of the setup resembles that of a m ulti-m ode quantum teleportation schem e thus allow ing the individual signalm odes to be spatially separated from each other. Som e exam ples such as the realization of crossK err nonlinearities, $m$ ulti-m ode $m$ irrors, and the preparation of multi-photon entangled states are considered.

## I. INTRODUCTION

A general problem in quantum optics is the imple$m$ entation of a de ned single-orm ulti-m ode operator by som e physical schem e since $m$ any $e$ orts am ount to the realization of a desired quantum state transform ation of an unknow $n$ or control of a known signal quantum state [1, 2, 3, 4, 5, 6, 7, 8, 6, 10, 11, 12, 13, 14, 15, 16]. Here, we lim it attention to a physical system consisting of a num ber of traveling light pulses described by nonm onochrom atic signalm odes. W e assum $e$ that the spatial pulse length is large com pared to the wavelength of the radiation, so that we dealw ith quasi-m onochrom atic pulses corresponding to quasi-orthogonalm odes.

A di culty is that at present, only a lim ited set of basic operations can be im plem ented directly. C om posite operations therefore have to be constructed from elem entary ones which are sim ple enough to allow their direct realization. Exam ples of such basic operations are the preparation of coherent (i.e., G lauber) states by singlem ode lasers, or single-photon states by para$m$ etric dow $n$ converters, furthem ore param etric interactions as realized by beam splitters, threewave m ixers, and $K$ err-nonlinearities, and the discrim ination betw een presence and absence of photons by $m$ eans ofbinary 0-1photodetectors such as A valanche photodiodes. A sim ple com bination of these techniques allow $s$ further $m$ anipulations such as param etric am pli cation, coherent displace$m$ ent, or the preparation and detection of photon num ber (i.e., Fock) states [17].

To give an exam ple, the signal pulse $m$ ay be sent through a medium applied in the param etric approxim ation, i.e., the m edium realizes a weak coupling betw een the signalm odes and a num ber of auxiliary m odes prepared in strong coherent states. Since within classical optics, nth-order interactions are described as a $n$ th-order deviation from linearity of the polarization in-

duced in a medium by an electric eld, the interaction strength is expected to decline rapidly $w$ th increasing order. Strong elds are therefore required for their observation. In contrast, setups discussed within quantum optics and quantum inform ation processing often operate w ith supenpositions of low-excited Fock states while the coherent am plitudes in the auxiliary modes cannot be increased unlim ited to achieve a desired interaction strength of the reduced signal operation. This greatly lim its the order of the nonlinearity applicable and with it the variety of unitary transform ations that can be realized by a given $m$ edium. D esirable are therefore substituting schem es for such nonlinear interactions [18, 19]. In particular, one $m$ ay apply the nonlinearity hidden in the quantum $m$ easurem ent process and to use m erely passive optical elem ents such as beam splitters [20] and photodetectors while relying on sim ple auxiliary preparations such as coherent and single-photon states [21]. A local $m$ easurem ent perform ed on a spatially extended quantum system a ects the reduced state at the other locations. By repeated $m$ easurem ents and postselection of desired detection events, this back-action caused by a m easurem ent can then be used to perform well-de ned $m$ anipulations, inchding state preparations 22, 23, 24, 25, 26, 27, 28, 29], quantum logic operations [30, 31, 32, 33, 34, 35], state puri cations 36], quantum error corrections [37], and state detections [38, 39]. $T$ he sim plest basic operations one $m$ ay think of are the application of the $m$ ode operators $A$ and $a^{y}$, i.e., photon subtraction and addition [40, 41]. W ith regard to com positions, it is necessary to lim it operation to a suitably chosen nite-dim ensional subspace of the system 's H ilbert space, cf., e.g., [37], since only a nite num ber of param eters can be controlled.

Theaim ofthis paper is to investigate a theoreticalpossibility of im plem enting a desired single- or m ulti-m ode operation $\hat{Y}$ on the quantum state $\%$ of a traveling optical signal. T he schem e solely relies on beam splitters as well as zero- and single-photon detections. In this way, nonlinear and active optical elem ents can be avoided. It requires the preparation of coherent states and single-
photon states，how ever．T he idea is to start w ith a single photon，which is then $m$ anipulated to construct an en－ tangled $k-m$ ode state．A fter that，the latter is shared by local setups perform ing the transform ation in the signal m odes． T he m easurem ent－assisted and hence conditional transform ation leads to an output state

is the probability of the respective $m$ easurem ent result， i．e．the success probability＇．In particular，if the oper－ ator $\hat{Y}$ is proportional to a unitary one，$\hat{Y}=\hat{U}$ ，where $\hat{U}^{y}=\hat{U} \quad 1$ ，then the success probability is independent of the input state，$p=j \hat{j}$ ．

W ithin the scope of explaining the principle，we lim it attention to idealized opticaldevices，as the e ect of im－ perfections depends on the desired transform ation and the signal state itself．In a given practical setup，the im perfections and the resulting coupling of the system to its environm ent $m$ ust be considered since loss of only one photon $m$ ay change the phase in a supenposition of tw o states and yield wrong results．A part from this，the $m$ ode $m$ atching becom es an im portant issue especially in the case of com posite devices such as opticalm ultiports． A generalization of Eq．（1）allow ing the inclusion of loss w ould be the transform ation $\frac{20}{0}=p^{1} l_{1} \hat{Y}_{1}{ }^{\circ} \hat{Y}_{1}^{y}$ w th given coe cients 10.

T he article is organized as follow s．Section $\square$ describes the local devices which $m$ ix the signal pulses and an en－ tangled state in order to perform the desired transform a－ tion of the signal，whereas section III is dedicated to the preparation of the entangled state itself．T he operation of the com plete setup is considered in section IV，and sec－ tion $V$ explains how generaloperators can be approached w ith it．To give som e exam ples，a few operators ofspecial interest are considered in section V I，such as functions of the single－m ode photon num ber operator in section VIA， tw o－m ode cross K err interactions in section V IB，U（N ）－ transform ations in section V IC，and the preparation of m ulti－photon entangled states in section VID．Finally，a sum $m$ ary and som e concluding rem arks are given in sec－ tion V II．A n appendix is added to outline three possibili－ ties of im plem enting single－photon cloning as required to prepare the entangled state and som e ordering relations for the photon num ber operator．

## II．LOCALOPERATIONS

The schem e consists ofk localdevioes，each im plem ent－ ing a conditional singlem ode photon subtraction or ad－ dition，depending on the case in which it is applied．T he setup of such a localdevice is show $n$ in $F$ ig ． 1 and consists of beam splitters $\hat{U}_{01}\left(\mathrm{~T}_{1} ; \mathrm{R}_{1}\right)$ and $\hat{U}_{21}\left(\mathrm{~T}_{2} ; \mathrm{R}_{2}\right)$ as well as
photodetectors $D_{1}$ and $D_{2}$ ．W e describe the $m$ ixing of som emode $j w$ th som $e$ other $m$ ode $k$ by a beam split－ ter in the usual way by a unitary operator $\hat{U}_{j k}(T ; R ; P)$ de ned via the relation
by its com plex transm ittance $T$ ，re ectance $R$ ，and phase $P$ obeying 打予 $+R \mathcal{R}=-p \rho=1$ ．If not stated otherw ise， we will assum e that $P=1$ within the work．

The setup show $n$ in $F$ ig． 1 realizes a transform ation of the signal state \％in m ode 0 according to Eq．（1），where the single－m ode operator $\hat{Y}=\hat{Y}_{0}$（s）depends on the pho－ ton number $s=0 ; 1$ of the Fock state jsi in which one of the rem aining input $m$ odes are prepared．$W$ e distinguish betw een two di erent cases of operation．First consider

W e see that（apart from the operator $\mathrm{T}_{1}^{\hat{\mathrm{r}}_{0}}$ which is alw ays present）in case（0）we realize a photon subtraction and in case（1）a photon addition，controlled by the photon num ber $s=0 ; 1$ of the control input state ji．

## III. PREPARATION OF THEENTANGLED

 STATEThe combined operation of $k$ local setups show $n$ in Fig. 1 requires an entangled $k$-m ode state
shared by all the stations. Here, z is a given com plex num ber, and the jsi are photon num ber states $w$ ith $s=$ $0 ; 1$. In this section, we discuss the preparation of the state Eq. (6). We start with preparing a m ode 0 in a single-photon state jli and $m$ ix it $w$ ith som e other m ode $j$ prepared in the vacuum state j0iusing a balanced beam splitter $\hat{U}_{0 j}(T=R=1 \stackrel{P}{=} \overline{2})$, which leaves the photon in a state

## IV. OVERALLOPERATION

Let us now assume that a state $j_{1 ;::: ; k}$ given by Eq. (6) is prepared. E ach $m$ ode $l=1 ;::: ; k$ is fed into the control input of a device Fig. 1 (the input port fed with the variable photon num ber state jsi in $F$ ig. (1), assum ing case ( $\mathrm{s}_{1}$ ), respectively. A schem atic view of an exam ple of the overall setup is depicted in Fig. 2. Denoting the

and $\hat{a}^{(s)}$ stands for $\hat{a}$ if $s=0$ and for $a^{y}$ if $s=1 . W$ e see that for given beam splitter param eters $T_{k}$ and $R_{k}$, can be chosen as desired by varying $z$. N ote that the signal $m$ odes $j_{1} ;::: ; j_{k}$ don't have to be distinct, cf . the exam ples in section V IA and section V IB. N ote also that those $m$ odes which are distinct $m$ ay be spatially separated from each other. The signal ow of the schem e F ig. 2 then resem bles that of a m ulti-m ode quantum teleportation setup.

W e now consider $N$ successive applications of $q$. (14). If $z$ is varied from step to step, the resulting overall operator becom es the product of the individual operators Eq. (14) according to

is an arbitrary polynom ial of order $N$ in $\hat{A}$ determ ined by its roots $n^{1} n$. The product sym bol has been used to indicate that the index of the factors increases from right to left.

A ssum e now that we want to im plem ent an anbitrary expandable function $F(\hat{A})$. In general, $\hat{A}$ can only be approxim ated by a polynom ial $F_{N}(\hat{A})$ of order $N$ in $\hat{A}$ w ith su ciently large N . T here are how ever tw o cases in which $F(\hat{A})$ can be replaced exactly w ith som e polynomial.

## A. Existence of an eigen space of $\hat{A}$

In the rst case, a set of $N^{0}+1$ eigenstates $\jmath^{1}$ i of $\hat{A}$ can be found,
where $N^{0}(N)$ is chosen such that a renum bering of the eigenvalues $A_{1^{0}}^{0}$ gives a set $f A_{0} ;::: ; A_{N} g$ of exactly $N+1$ distinct $A_{1}$. W e now choose Eq. (18) to be the polynom ial
of order $N$ in $\hat{A}$, so that we obtain $F_{N}(\hat{A}) \jmath_{1} i=$ F ( $\hat{A}$ ) J ${ }_{1}{ }^{0}$ i. In Eq. (16) we then have

W e see that a signal state o satisfying the condition
is transform ed according to Eq. (1), where $\hat{Y} \hat{T}^{N} F(\hat{A})$, cf. Eq. 21). In this sense, a desired function $F(\hat{A})$ can be im plem ented. In order to com pensate the operator $\hat{\mathrm{T}}$, the transm ittance $T_{1} m$ ay be chosen su ciently close to unity, i.e., $\mathrm{R}_{1} j$ 1. A precise com pensation is possible by an additionalim plem entation of the operator $\hat{T}{ }^{\mathrm{N}}$ allowed in the photon-num ber truncated case as discussed below, in section VIA. We then have $\hat{Y} \quad \mathrm{~F} \hat{\mathrm{~A}}$ ). N ote that the replacem ent of the function $F(\hat{A})$ by a polynom ial $F_{N}(\hat{A})$ of order $N$ in $\hat{A}$ is unique. If there was another polynom ial $G_{N}(\hat{A})$ of order $N$ in $\hat{A}$ for which also $G_{N}\left(\hat{A^{\prime}}\right) \jmath^{\prime} 1^{0} i=F(\hat{A}) \jmath^{0} i$ with $1^{0}=0 ;::: ; N^{0}$, we could consider the polynom ial $F_{N}(x) \quad G_{N}(x)$ of order $N$ in $x$. It has how ever the $(\mathbb{N}+1)$ distinct roots $x_{1}=A_{1}$, so that $F_{N}(x) \quad G_{N}(x) \quad 0$. Of particular interest is the case in which in each of the $m$ odes $j_{1} ;::: ; j_{k}$, the num ber of annihilation operators occuring in $\hat{A}$ equals the num ber of creation operators, so that the eigenstates $\jmath_{1}{ }^{0} i=$ $j_{j_{1}}^{\left(1^{0}\right)} ;::: ; \mathrm{n}_{\mathrm{j}_{\mathrm{k}}}^{\left(1^{0}\right)}$ i are $\mathrm{N}^{0}+1$ photon num ber states (they m ay be, e.g., the low est states occuring in a Fock space expansion).

## B. Photon-num ber truncated signal states

In the other case, there exists a m ode $j_{1}$ in which the num ber of annihilation operators occuring in $\hat{A}$ exceeds
the num ber of creation operators and the signal state ${ }^{\circ}$ is photon-num ber truncated in this $m$ ode,

W e choose Eq. (18) to be the sum of the rst $N+1$ ele$m$ ents of the power series expansion of $(\hat{A})$, so that the signal state ${ }^{\circ}$ is again transform ed according to Eq. (1), where $\hat{Y} \quad \hat{T}^{N} F(\hat{A})$, cf. Eq. (21).

## V. APPROACHING GENERALOPERATOR

## FUNCTIONS

A ssum e that we want to im plem ent an arbitrary function $\hat{F}$ of the creation and annihilation operators of a num ber of signalm odes, $\hat{Y} \hat{F}$ in Eq. (1). We further assum $e$ that the expansion of $\ln \hat{F}$ can according to

## VI. EXAMPLESOFAPPLICATION

W e have seen that wem ay im plem ent a given binom ial in any $m$ om ent of the creation and annihilation operators of a num ber of traveling opticalm odes. A repeated application then allow s - in principle - the approxim ation of a desired function of the respective $m$ ode operators. In a concrete exam ple, the general schem e can be sim pli ed considerably. Let us illustrate this in som e cases of special interest such as single- and tw om ode operators, since the application of single-photon cloners $m$ ay be avoided in this case.

## A. Functions of the single-m ode photon num ber operator

U ntil now we have placed em phasis on the realization ofgeneraloperators. In a given case how ever, the respective schem em ay be sim pli ed considerably. For exam ple, let us assum e that $\hat{A}=\hat{\mathrm{n}}_{0}$. This exam ple is of particular im portance since it allow s the com pensation of the operators $\hat{\mathrm{T}}$ in Eq. (16) and Eq. (28) for photon-num ber truncated states as we will see below. In Eq. (14), we then have $k=2, j_{1}=j_{2}=0$ and $s_{1}=0, s_{2}=1$. Instead of applying the setup Fig. 1 in the signalm ode 0 rst in case ( 0 ) and then in case (1), it is su cient to prepare its input ports 1 and 2 in a state $j i_{12}$ as de ned in Eq. 7). $T$ he resulting com plete setup is shown in $F$ ig. ${ }^{3}(a)$. If the photodetectors $D_{1}$ and $D_{2}$ detect 0 and 1 photons, respectively, the signal state $\frac{2}{\circ}$ is transform ed in $m$ ode 0 according to Eq. (1), where

To the setup acting on $m$ ode 1 consisting of beam splitters $\hat{U}_{15}\left(T_{1} ; R_{1}\right)$ and $\hat{U}_{35}\left(T_{2} ; R_{2}\right)$ as well as photodetectors $D_{3}$ and $D_{5}$, a second, identicalsetup acting on m ode 0 is added consisting of beam splitters $\hat{U}_{04}\left(T_{1} ; R_{1}\right)$ and $\hat{U}_{24}\left(T_{2} ; R_{2}\right)$ as well as photodetectors $D_{2}$ and $D_{4}$. The m odes are labeled as show $n$ in $F$ ig. 3 (b). The input $m$ odes are prepared in a

We see that for $\mathrm{k}=1$ we obtain a coherent phase state (in particular, for $\bar{k} j=1$ a London phase state). For $\mathrm{k}=2$ we obtain a tw ofm ode squeezed state (in particular, for $\dot{\chi} j=1$ an EPR-like state). In the lim it k! 1 , the states Eq. (52) $m$ ay be used as a representation of an EPR-like state betw een a num ber n of quantum elds (instead of two modes of a eld). To see this, the elds are indexed according to dje $1+[(j$

1) $m$ od $n$ ], i.e., $m$ ode $j$ is ascribed to eld dje.

## VII. CONCLUSION

In sum $m$ ary it can be said that, starting from a single photon, cf. Eq. 7), we can with a given probability approach arbitrary operators of spatially separated traveling optical m odes. The problem is that the success probability, which depends on the desired transform ation and the signal state in general, is expected to decline exponentially $w$ th an increasing num ber of steps $N$, so that the practical applicability of the schem e is lim ited to sm all N , su cient to engineer, e.g., states in the vicinity of the vacuum. On the other hand, the application of giant nonlinearities to elds containing only few photons represents just the case discussed in potentialquantum inform ation processing devioes. To give an estim ation, consider a passively m ode-locked laser whose resonator has an opticalround trip length ofl= 3 cm , so that the repetition frequency of the em itted pulse train is $=1{ }^{1} \mathrm{C}=10 \mathrm{GHz}$. If this pulse train is used to prepare the entangled state needed to run the schem e, then its repetition frequency determ ines that of the overall device. A $n$ assum ed total success probability of $p=$ $10{ }^{10}$ would then reduce the $m$ ean repetition frequency of the properly transform ed output pulses to ${ }^{0}=1 \mathrm{~Hz}$, which $m$ ay still be useful for basic research experim ents
but unacceptable for technical applications. A part from this, there $m$ ay be the situation where only a single unknow $n$ signal pulse is available that $m$ ust not be spoiled by a w rong detection since no copies can be produced of it. T his constitutes the m ain draw back of all conditional m easurem ent schem es.

It $m$ ay be worth $m$ entioning that the whole schem e $m$ ay also run tim e-reversed', i.e., all pulses are sent in opposite directions through the devioe, while the locations of state preparations and (assum ed) detections are interchanged, so that the resulting adjoint' schem e im plem ents the adjint operator $\hat{Y}{ }^{y}$.

In what follow S , we give a num ber of possibilities to im plem ent a single-photon cloner Eq. (8).

## 1. C ross-K err non linearity

To im plem ent single-photon cloning, we m ay apply a $M$ ach-Zehnder-interferom eterequipped w ith a cross-K err nonlinearity as can be seen as follow s . $W$ e prepare input m ode 2 of a balanced beam splitter $\hat{U}_{21}(\mathrm{~T}=\mathrm{R}=1=\overline{2})$ in a single-photon state 1 lli and the other input $m$ ode in the vacuum state j0i. A fter output m ode 2 has passed a cross $K$ err coupler

## 3. Linear optics

A disadvantage of the previous two proposals is their dependency on large nonlinear coe cients which are hardly achievable in practice. Therefore, we now give a possibility of im plem enting Eq. (8) solely based on beam splitters and zero-and single-photon detections. A ssum e that a state
w th som e arbitrary 0 is prepared. M ode 3 is mixed w ith an auxiliary m ode 5 prepared in f coherent state $j$ i using a beam splitter $\hat{U}_{53}\left(\mathrm{~T}=\mathrm{R}=\frac{1}{\mathrm{P}}=\overline{2}\right)$ and m ode 4 passes a beam splitter $\hat{U}_{04}\left(T=R=1={ }^{\mathrm{P}} \overline{2}\right)$. If eventually 0 photons are detected in m odes 3 and 4 but 1 photon in each of the $m$ odes 0 and 5, respectively, the device realizes an operator

The parsm eters ofallother beam splitters are given by $T=R=1=\overline{2}$. $T$ he setup represents an array
