# Two exactly-solvable problems in one-dimensional quantum mechanics on circle

#### Abstract

In this note we establish a relation between two exactly-solvable problems on circle, namely singular Coulomb and singular oscillator systems.


1. In a recent paper [1] have constructed a series of complex mappings $S_{2 C} \rightarrow S_{2}$, $S_{4 C} \rightarrow S_{3}$ and $S_{8 C} \rightarrow S_{5}$, which extend to spherical geometry the Levi-Civita, KustaanheimoStiefel and Hurwitz transformations, well known for Euclidean space. We have shown that these transformations establish a correspondence between Coulomb and oscillator problems in classical and quantum mechanics for dimensions $(2,2),(3,4)$ and $(5,8)$ on the spheres. A detailed analysis of the real mapping on the curved space has been done in [2]. It was remarked that in the stereographic projection the relation between Coulomb and oscillator problems functionally coincide with the flat space Levi-Civita and Kustaanheimo-Stiefel transformations. The relation between the quasiradial Schrödinger equations for Coulomb and oscillator problems on the $n$-dimensional spheres and one- and two-sheeted hyperboloids for $n \geq 2$ was found in the article [3].

The present note are devoted to two one-dimensional exactly-solvable potentials on circle $S_{1}: s_{0}^{2}+s_{1}^{2}=R^{2}$

\begin{equation*}
V^{s o}(\vec{s})=\frac{\omega^{2} R^{2}}{2} \frac{s_{1}^{2}}{s_{0}^{2}}+\frac{1}{2} \frac{k_{1}^{2}-\frac{1}{4}}{s_{1}^{2}}, \quad V^{c}(\vec{s})=-\frac{\mu}{R} \frac{s_{0}}{\left|s_{1}\right|}+\frac{1}{2} \frac{p^{2}-\frac{1}{4}}{s_{1}^{2}}, \tag{1}
\end{equation*}
$$

where $s_{0}, s_{1}$ are Cartesian coordinates in ambient Euclidean space $E_{2}$.
2. The Schrödinger equation describing the nonrelativistic quantum motion on the circle $S_{1}$ in polar coordinate $\varphi \in[-\pi, \pi]$

$$
s_{0}=R \cos \varphi, \quad s_{1}=R \sin \varphi
$$

has the following form $(\hbar=m=1)$

$$
\begin{equation*}
\frac{d^{2} \Psi}{d \varphi^{2}}+2 R^{2}[E-V(\varphi)] \Psi=0 \tag{2}
\end{equation*}
$$

Substituting the singular oscillator potential $V^{s o}(\varphi)$ in eq. (2), we obtain Pöschl-Teller-type equation

$$
\begin{equation*}
\frac{d^{2} \Psi}{d \varphi^{2}}+\left[\epsilon-\frac{k_{0}^{2}-\frac{1}{4}}{\cos ^{2} \varphi}-\frac{k_{1}^{2}-\frac{1}{4}}{\sin ^{2} \varphi}\right] \Psi=0 \tag{3}
\end{equation*}
$$

where $\epsilon=2 R^{2} E+\omega^{2} R^{4}$ and $k_{0}^{2}=\omega^{2} R^{4}+\frac{1}{4}$. The regular (at points $\varphi=0$ and $\pi / 2$ ) solution of above equation maybe chosen in following form [5]

$$
\begin{align*}
& \Psi_{n}(\varphi)=\sqrt{\frac{2\left(2 n+k_{0} \pm k_{1}+1\right) \Gamma\left(n+k_{0}+k_{1}+1\right) \Gamma\left(n \pm k_{1}+1\right)}{R\left[\Gamma\left(1 \pm k_{1}\right)\right]^{2} \Gamma\left(n+k_{0}+1\right)(n)!}} \\
& (\sin \varphi)^{\frac{1}{2} \pm k_{1}}(\cos \varphi)^{\frac{1}{2}+k_{0}}{ }_{2} F_{1}\left(-n, n+k_{0} \pm k_{1}+1 ; 1 \pm k_{1} ; \sin ^{2} \varphi\right), \tag{4}
\end{align*}
$$

with

$$
\begin{equation*}
\epsilon=\left(2 n \pm k_{1}+k_{0}+1\right)^{2}, \quad n=0,1,2 \ldots \ldots \tag{5}
\end{equation*}
$$

Then the energy spectrum of the one-dimensional singular oscillator is given by

$$
\begin{equation*}
E_{n}(R)=\frac{1}{2 R^{2}}\left[\left(2 n \pm k_{1}+\frac{1}{2}\right)^{2}+\left(2 k_{0}+1\right)\left(2 n \pm k_{1}+1\right)\right] . \tag{6}
\end{equation*}
$$

Let us remark that the wave-functions have been normalized in the domain $[0, \pi / 2]$. The positive sign at the $k_{1}$ has to taken whenever $k_{1}>\frac{1}{2}$, i.e. the additional term to oscillator potential is repulsive at the origin and the motion take place only in domain $\varphi \in[0, \pi / 2]$. If $0<\left|k_{1}\right| \leq \frac{1}{2}$, i.e. the additional term is attractive at the origin, both the positive and negative sign must be taken into account in the solution. The motion in this case take place in $\varphi \in[-\pi / 2, \pi / 2]$. This is indicated by the notion $\pm k_{1}$, in the formulas.
3. Let us to write the Schrödinger equation (21) for singular Coulomb potential $V^{c}(\vec{s})$

\begin{equation*}
\frac{d^{2} \Psi}{d \varphi^{2}}+\left(2 R^{2} E+2 \mu R \cot |\varphi|+\frac{p^{2}-\frac{1}{4}}{\sin ^{2} \varphi}\right) \Psi=0 \tag{7}
\end{equation*}
$$

First we will consider the region $\varphi \in[0, \pi]$. We make now a transformation to the new variable $\theta \in\left[0, \frac{\pi}{2}\right]$

$$
\begin{equation*}
e^{i \varphi}=\cos \theta \tag{8}
\end{equation*}
$$

which is possible if we continue the variable $\varphi$ in the complex domain: $\operatorname{Re} \varphi=0,0 \leq \operatorname{Im}$ $\varphi<\infty$ (see Fig. 1). We complexify also the coupling constant $\mu$ by putting $k=i \mu$ such that

$$
\begin{equation*}
\mu \cot \varphi=k\left(1-2 \sin ^{-2} \theta\right) . \tag{9}
\end{equation*}
$$

As result we obtain the equation

$$
\begin{equation*}
\frac{d^{2} W}{d \theta^{2}}+\left[\epsilon-\frac{k_{0}^{2}-\frac{1}{4}}{\cos ^{2} \theta}-\frac{k_{1}^{2}-\frac{1}{4}}{\sin ^{2} \theta}\right] W=0 \tag{10}
\end{equation*}
$$

where $W(\theta)=(\cot \theta)^{\frac{1}{2}} Z(\theta)$ and

$$
\begin{equation*}
\epsilon=2 R^{2} E+2 k R, \quad k_{0}^{2}=2 R^{2} E-2 k R, \quad k_{1}^{2}=2-4 p^{2} . \tag{11}
\end{equation*}
$$

From the above equation we see that, up to the substitution (11) the equation (10) for one-dimensional singular Coulomb problem (with restriction $0<p^{2} \leq \frac{1}{2}$ ) coincides to the one-dimensional singular oscillator equation (3).


Figure 1: Domain $\mathbf{G}=\{0 \leq \operatorname{Re} \varphi \leq \pi ; 0 \leq \operatorname{Im} \varphi<\infty\}$ on the complex plane of $\varphi$.

The regular, for $\theta \in[0, \pi / 2]$ and $k_{0} \geq 1 / 4$, solution of this equation according to (4) is

$$
\begin{equation*}
\Psi(\theta)=\frac{W(\theta)}{\sqrt{\cot \theta}}=C_{n}(\sin \theta)^{1 \pm k_{1}}(\cos \theta)^{k_{0}}{ }_{2} F_{1}\left(-n, n+k_{0} \pm k_{1}+1 ; 1 \pm k_{1} ; \sin ^{2} \theta\right) \tag{12}
\end{equation*}
$$

where $C_{n}$ is the normalization constant. To compute the constant $C_{n}$ we require that the wave function (12) satisfy the condition

$$
\begin{equation*}
R \int_{0}^{\pi} \Psi_{n} \Psi_{n}^{\diamond} d \varphi=\frac{1}{2} \tag{13}
\end{equation*}
$$

where the symbol " $\diamond$ " means the complex conjugate together with the inversion $\varphi \rightarrow-\varphi$, i.e. $\Psi^{\diamond}(\varphi)=\Psi^{*}(-\varphi)$. [We choose the scalar product as $\Psi^{\diamond}$ because for $\varphi \in \mathbf{G}$ and real $\mu$, and $\epsilon$ the function $\Psi^{\diamond}(\varphi)$ also belongs to the solution space of (7)]. By analogy to the work
[1, 3], we consider the integral over contour $G$ in the complex plane of variable $\varphi$ (see Fig.1)

$$
\begin{align*}
\oint \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi & =\int_{0}^{\pi} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi+\int_{\pi}^{\pi+i \infty} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi \\
& +\int_{\pi+i \infty}^{i \infty} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi+\int_{i \infty}^{0} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi \tag{14}
\end{align*}
$$

Using the facts that the integrand vanishes as $e^{2 i k_{0} \varphi}$ and that $\Psi_{n}(\varphi)$ is regular in the domain G (see Fig.1), then according to the Cauchy theorem we have

$$
\begin{equation*}
\int_{0}^{\pi} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi=\left(1-e^{2 i \pi k_{0}}\right) \int_{0}^{i \infty} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi \tag{15}
\end{equation*}
$$

Making the substitution (8) in the right integral of eq. (15), we find

$$
\begin{equation*}
\int_{0}^{\pi} \Psi_{n}(\varphi) \Psi_{n}^{\diamond}(\varphi) d \varphi=i\left(1-e^{2 i \pi k_{0}}\right) \int_{0}^{\frac{\pi}{2}}\left[\Psi_{n}\right] \tan \theta d \theta \tag{16}
\end{equation*}
$$

and after integration over the angle $\theta$ we finally get [6]

$$
\begin{equation*}
C_{n}=\sqrt{\frac{\left(-i k_{0}\right)\left(2 n+k_{0} \pm k_{1}+1\right) \Gamma\left(n+1 \pm k_{1}\right) \Gamma\left(n+k_{0} \pm k_{1}+1\right)}{R\left[1-e^{2 i \pi k_{0}}\right]\left(2 n \pm k_{1}+1\right) n!\left[\Gamma\left(1 \pm k_{1}\right)\right]^{2} \Gamma\left(n+k_{0}+1\right)}} . \tag{17}
\end{equation*}
$$

Let us now consider two most interesting cases.
(i). The case when $p^{2}=\frac{1}{4}$. Then the duality transformation (8) establish the connection between pure Coulomb problem and singular oscillator with $k_{1}^{2}=1$. Comparing the eqs. (5) with (11) and putting $k=i \mu$, we get

$$
\begin{equation*}
k_{0}=-(n+1)+i \sigma, \quad \sigma=\frac{\mu R}{n+1} \tag{18}
\end{equation*}
$$

and for energy spectrum

$$
\begin{equation*}
E_{n}(R)=\frac{(n+1)^{2}}{2 R^{2}}-\frac{\mu^{2}}{2(n+1)^{2}}, \quad n=0,1,2, \ldots \tag{19}
\end{equation*}
$$

Returning to the variable $\varphi$, we obtain that wave function at $0 \leq \phi \leq \pi$ has the form

$$
\begin{equation*}
\Psi_{n \sigma}(\varphi)=C_{n}(\sigma) \sin \varphi e^{-i \varphi(n-i \sigma)}{ }_{2} F_{1}\left(-n, 1+i \sigma ; 2 ; 1-e^{2 i \varphi}\right), \tag{20}
\end{equation*}
$$

where the normalization constant $C_{n}(\sigma)$ is

$$
\begin{equation*}
C_{n}(\sigma)=e^{\frac{\sigma \pi}{2}}|\Gamma(1+i \sigma)| \sqrt{\frac{(n+1)^{2}+\sigma^{2}}{\pi R}} \tag{21}
\end{equation*}
$$

The wave function in the region $-\pi \leq \varphi<0\left(s_{1}<0\right)$ maybe determined from the eq. (20) by the reflection $\varphi \rightarrow-\varphi$. Therefore the general solution of the Schrödinger equation for $\varphi \in[-\pi, \pi]$ can be presented in form of even and odd function

$$
\begin{aligned}
& \Psi_{n \sigma}^{(+)}(\varphi)=C_{n}(\sigma) \sin |\varphi| e^{-i(n-i \sigma)|\varphi|} F\left(-n, 1+i \sigma ; 2 ; 1-e^{2 i|\varphi|}\right), \\
& \Psi_{n \sigma}^{(-)}(\varphi)=C_{n}(\sigma) \sin \varphi e^{-i(n-i \sigma)|\varphi|} F\left(-n, 1+i \sigma ; 2 ; 1-e^{2 i|\varphi|}\right)
\end{aligned}
$$

Thus by using the relation between Coulomb and singular oscillator systems we have constructed the wave functions and energy spectrum for a Coulomb system on the one-dimensional sphere.
(ii). Choosing now $k_{1}^{2}=\frac{1}{4}$ or the same $p^{2}-\frac{1}{4}=\frac{3}{16}$. In this case the centrifugal potential term is repulsive at the origin for singular Coulomb systems and the motion take place only in one of the domains $\varphi>0$ or $\varphi<0$. For oscillator system this term equal zero and therefore the duality transformation (8) connect singular Coulomb and pure oscillator systems.

Let us introduce the quantity $\nu$ which takes two values $\nu=\frac{1}{4}$ and $\nu=\frac{3}{4}$. Making all calculations by analogy to previous case, it is easy to obtain the energy spectrum

$$
\begin{equation*}
E_{n}^{\nu}(R)=\frac{(n+\nu)^{2}}{2 R^{2}}-\frac{\mu^{2}}{2(n+\nu)^{2}}, \quad n=0,1,2, \ldots \tag{22}
\end{equation*}
$$

and wave functions

$$
\begin{aligned}
\Psi_{n \sigma}^{\nu}(\varphi) & =e^{\frac{\sigma \pi}{2}} 2^{\nu} \frac{|\Gamma(\nu+i \sigma)|}{\Gamma(2 \nu)} \sqrt{\frac{\left[(n+\nu)^{2}+\sigma^{2}\right] \Gamma(n+2 \nu)}{4 \pi R(n+\nu) n!}} \\
& \times(\sin \varphi)^{\nu} e^{-i \varphi(n-i \sigma)}{ }_{2} F_{1}\left(-n, \nu+i \sigma ; 2 \nu ; 1-e^{2 i \varphi}\right)
\end{aligned}
$$

where $\sigma=\mu R /(n+\nu)$.
In the contraction limit $R \rightarrow \infty, \varphi \rightarrow 0$ and $R \varphi \sim x$ - fixed, we see that

$$
\begin{equation*}
\epsilon_{n}=\lim _{R \rightarrow \infty} E_{n}^{\nu}(R)=-\frac{\mu^{2}}{2(n+\nu)^{2}}, \quad n=0,1, \ldots \tag{23}
\end{equation*}
$$

and

$$
\begin{equation*}
\Phi_{n}^{\nu}(y)=\lim _{\substack{R \rightarrow \infty \\ \varphi \rightarrow 0}} \Psi_{n \sigma}^{\nu}(\varphi)=\frac{\sqrt{\mu}}{\Gamma(2 \nu)} \frac{1}{(n+\nu)} \sqrt{\frac{\Gamma(n+2 \nu)}{2 n!}} y^{\nu} e^{-\frac{|y|}{2}}{ }_{1} F_{1}(-n ; 2 \nu ; y) \tag{24}
\end{equation*}
$$

where $y=2 \mu x /(n+\nu)$. Formulas (23) and (24) coincides with the formulas for energy levels $\epsilon_{n}$ and up to the factor $\sqrt{2}$ for wave functions $\Phi_{n}^{\nu}(y)$ for two type one-dimensional Coulomb anyons with $\nu=\frac{1}{4}$ and $\nu=\frac{3}{4}$ respectively [4].
