Quantum Search of Spatial Regions

A bstract

Can G rover's algorithm speed up search of a physical region | for example a 2-D grid of size $p_{\overline{n}}$ $p_{\overline{n}}$? The problem is that $p_{\overline{n}}$ time seems to be needed for each query, just to move amplitude across the grid. Here we show that this problem can be sum ounted, refitting a claim to the contrary by Benio . In particular, we show how to search a d-dimensional hypercube in time $O(\overline{n})$ for d 3, or $O(\overline{n} \log^{5-2} n)$ for d = 2. More generally, we introduce a model of quantum query complexity on graphs, motivated by fundamental physical limits on information storage, particularly the holographic principle from black hole therm odynamics. Our results in this model include almost-tight upper and low er bounds form any search tasks; a generalized algorithm that works for any graph with good expansion properties, not just hypercubes; and relationships am ong several notions of 'locality' for unitary matrices acting on graphs. A s an application of our results, we give an $O(\overline{n})$ -qubit communication protocol for the disjointness problem, which in proves an upper bound of H yer and de W olf and matches a low er bound of R azborov.

1 Introduction

The goal of G rover's quantum search algorithm [17, 18] is to search an 'unsorted database' of size n in a number of queries proportional to $\frac{1}{n}$. C lassically, of course, order n queries are needed. It is sometimes asserted that, although the speedup of G rover's algorithm is only quadratic, this speedup is provable, in contrast to the exponential speedup of Shor's factoring algorithm [29]. But is that really true? G rover's algorithm is typically in agined as speeding up combinatorial search and we do not know whether every problem in NP can be classically solved quadratically faster than the \obvious" way, any m ore than we know whether factoring is in BPP.

But could G rover's algorithm speed up search of a physical region? Here the basic problem, it seems to us, is the time needed for signals to travel across the region. For if we are interested in the fundamental lim its imposed by physics, then we should acknow ledge that the speed of light is nite, and that a bounded region of space can store only a nite am ount of information, according to the holographic principle [9]. We discuss the latter constraint in detail in Section 2; for now, we say only that it suggests a model in which a quantum robot' occupies a superposition over nitely many locations, and moving the robot from one location to an adjacent one takes unit time. In such a model, the time needed to search a region could depend critically on its spatial layout. For example, if the n entries are arranged on a line, then even to m ove the robot from one end to the other takes n 1 steps. But what if the entries are arranged on, say, a 2-dimensional square grid (Figure 1)?

1.1 Sum mary of Results

This paper gives the rst system atic treatment of quantum search of spatial regions, with 'regions' modeled as connected graphs. Our main result is positive: we show that a quantum robot can search a d-dimensional

hypercube with n vertices for a unique marked vertex in time 0 $p = n \log^{3-2} n$ when d = 2, or 0 p = n when d = 2, or

Section 5 presents the main results; Section 5.4 shows further that, when there are k or more marked vertices, the search time becomes 0 $p = \frac{1}{n} \log^{5-2} n$ when d = 2, or $p = \frac{1}{n} e^{1-2} e^{1-d}$ when d = 3. Also, Section 6 generalizes our algorithm to arbitrary graphs that have hypercube-like' expansion properties. Here the best bounds we can achieve are $p = \frac{1}{n} 2^{\circ} \left(\frac{1}{\log n}\right)$ when d = 2, or 0 $p = \frac{1}{n} \log^{1-2} e^{1-d}$ when d > 2 (note that d need not be an integer). Table 1.1 sum marizes the results.

Section 7 shows, as an unexpected application of our search algorithm, that the quantum communication complexity of the well-known disjointness problem is 0(n). This improves an 0^{n} n c n upper bound of H yer and de W olf [20], and matches the $\binom{n}{n}$ by er bound of Razborov [23].

The rest of the paper is about the form alm odel that underlies our results. Section 2 sets the stage for this model, by exploring the ultimate limits on information storage in posed by properties of space and time. This discussion serves only to motivate our results; thus, it can be safely skipped by readers unconcerned with the physical universe. In Section 3 we de ne quantum query algorithms on graphs, a model similar to quantum query algorithms as de ned by Beals et al. [4], but with the added requirement that unitary operations be 'local' with respect to some graph. In Section 3.1 we address the di cult question, which also arises in work on quantum random walks [1] and quantum cellular autom ata [31], of what 'local' means. Section 4 proves general facts about our model, including an upper bound of 0 n for the time needed to search any graph with diameter , and a proof (using the hybrid argument of Bennett et al. [7]) that this upper bound is tight for certain graphs. We conclude in Section 8 with some open problem s.

1.2 Related W ork

In a paper on Space searches with a quantum robot,'Benio [6] asked whether G rover's algorithm can speed up search of a physical region, as opposed to a combinatorial search space. H is answer was discouraging: for a 2-D grid of size $\frac{p}{n}$, G rover's algorithm is no faster than classical search. The reason is that, during each of the $\binom{p}{n}$ G rover iterations, the algorithm must use order $\frac{p}{n}$ steps just to travel across the grid and return to its starting point for the di usion step. On the other hand, Benio noted, G rover's algorithm does yield some speedup for grids of dimension 3 or higher, since those grids have diam eter less than $\frac{p}{n}$.

Our results show that Benio 's claim is mistaken: by using G rover's algorithm m ore carefully, one can search a 2-D grid for a single marked vertex in O $pn \log^{3=2} n$ time. To us this illustrates why one should not assume an algorithm is optimal on heuristic grounds. Painful experience for example, the \obviously optimal" O n^3 matrix multiplication algorithm [30] is what taught computer scientists to see the proving of lower bounds as more than a form ality.

O ur setting is related to that of quantum random walks on graphs [1, 13, 14, 28]. In an earlier version of this paper, we asked whether quantum walks might yield an alternative spatial search algorithm, possibly even one that outperforms our divide-and-conquer algorithm. Motivated by this question, Childs and Goldstone [16] managed to show that in the continuous-time setting, a quantum walk can search a d-dimensional hypercube for a single marked vertex in time O (\overline{n} logn) when d = 4, or O (\overline{n}) when d 5. Our algorithm was still faster in 3 or fewer dimensions (see Table 12). Subsequently, however, Ambainis, K empe, and R ivosh β] gave an algorithm based on a discrete-time quantum walk, which was as fast as ours in 3 or more dimensions, and faster in 2 dimensions. In particular, when d = 2 their algorithm used only O (\overline{n} logn) time to nd a unique marked vertex. Childs and Goldstone [15] then gave a continuous-time quantum walk algorithm with the same performance, and related this algorithm to properties of the D irac equation. It is still open whether O (\overline{n}) time is achievable in 2 dimensions.

Currently, the main drawback of the quantum walk approach is that all analyses have relied heavily on symmetries in the underlying graph. If even minor 'defects' are introduced, it is no longer known how to upper-bound the running time. By contrast, the analysis of our divide-and-conquer algorithm is elementary, and does not depend on eigenvalue bounds. We can therefore show that the algorithm works for any graphs with su ciently good expansion properties.

Childs and Goldstone [16] argued that the quantum walk approach has the advantage of requiring fewer auxiliary qubits than the divide-and-conquer approach. However, the need form any qubits was an artifact of how we im plemented the algorithm in a previous version of the paper. The current version uses only one qubit.

2 The Physics of D atabases

Theoretical computer science generally deals with the limit as some resource (such as time or memory) increases to in nity. What is not always appreciated is that, as the resource bound increases, physical constraints may come into play that were negligible at 'sub-asymptotic' scales. We believe theoretical computer scientists ought to know something about such constraints, and to account for them when possible.

For if the constraints are ignored on the ground that they \never m atter in practice," then the obvious question arises: why use asymptotic analysis in the st place, rather than restricting attention to those instance sizes that occur in practice?

A constraint of particular interest for us is the holographic principle [9], which arose from black-hole therm odynam ics. The principle states that the inform ation content of any spatial region is upper-bounded by its surface area (not volume), at a rate of one bit per Planck area, or about 1.4 10^{69} bits per square m eter. Intuitively, if one tried to build a spherical hard disk with m ass density , one could not keep expanding it forever. For as soon as the radius reached the Schwarzschild bound of $r = \frac{3}{3} = (8)$ (in Planck units, c = G = - k = 1), the hard disk would collapse to form a black hole, and thus its contents would be irretrievable.

A ctually the situation is worse than that: even a planar hard disk of constant m ass density would collapse to form a black hole once its radius became su ciently large, r = (1 =). (We assume here that the hard disk is disc-shaped. A linear or 1-D hard disk could expand inde nitely without collapse.) It is possible, though, that a hard disk's information content could asymptotically exceed its mass. For example, a black hole's mass is proportional to the radius of its event horizon, but the entropy is proportional to the square of the radius (that is, to the surface area). A dm ittedly, inherent di culties with storage and retrievalm ake a black hole horizon less than ideal as a hard disk. However, even a weakly-gravitating system could store information at a rate asymptotically exceeding its mass-energy. For instance, Bousso [9] shows that an enclosed ball of radiation with radius r can store $n = r^{3-2}$ bits, even though its energy grows only as r. Our results in Section 6.1 will imply that a quantum robot could (in principle!) search such a 'radiation disk' for a marked item in time 0 $r^{5-4} = 0$ n^{5-6} . This is some improvement over the trivial (n) upper bound for a 1-D hard disk, though it falls short of the desired 0 $\binom{n}{n}$.

In general, if $n = r^c$ bits are scattered throughout a 3-D ball of radius r (where c 3 and the bits' locations are known), we will show in Theorem 30 that the time needed to search for a 1' bit grows as $n^{1-c+1=6} = r^{1+c=6}$ (om itting logarithm ic factors). In particular, if $n = r^2$ (saturating the holographic bound), then the time grows as n^{2-3} or r^{4-3} . To achieve a search time of 0 (n polylogn), the bits would need to be concentrated on a 2-D surface.

Because of the holographic principle, we see that it is not only quantum mechanics that yields a $\binom{p}{n}$ lower bound on the number of steps needed for unordered search. If the item s to be searched are laid out spatially, then general relativity in 3 + 1 dimensions independently yields the same bound, $\binom{p}{n}$, up to a constant factor.¹ Interestingly, in d + 1 dimensions the relativity bound would be $n^{1-(d-1)}$, which for d > 3 is weaker than the quantum mechanics bound. Given that our two fundamental theories yield the same bound, it is natural to ask whether that bound is tight. The answer seem s to be that it is not tight, since (i) the entropy on a black hole horizon is not e ciently accessible², and (ii) weakly-gravitating system s are subject to the Bekenstein bound [5], an even stronger entropy constraint than the holographic bound.

Yet it is still of basic interest to know whether n bits in a radius-r ball can be searched in time $p \ln (n \ln n r \ln n)$ that is, whether it is possible to do anything better than either brute-force quantum search (with the drawback pointed out by Benio [6]), or classical search. Our results show that it is possible.

From a physical point of view, several questions naturally arise: (1) whether our complexity measure is realistic; (2) how to account for time dilation; and (3) whether given the number of bits we are in agining, cosm ological bounds are also relevant. Let us address these questions in turn.

(1) O ne could argue that to maintain a 'quantum database' of size n requires n computing elements ([32], though see also [24]). So why not just exploit those elements to search the database in parallel? Then it becomes trivial to show that the search time is limited only by the radius of the database, so

the algorithm s of this paper are unnecessary. Our response is that, while there m ight be n 'passive' computing elements (capable of storing data), there m ight be m any fewer 'active' elements, which we consequently wish to place in a superposition over locations. This assumption seems physically unobjectionable. For a particle (and indeed any object) really does have an indeterm inate location, not merely an indeterm inate internal state (such as spin) at some location. We leave as an open problem, how ever, whether our assumption is valid for speci c quantum computer architectures such as ion traps.

- (2) So long as we invoke general relativity, should we not also consider the e ects of tim e dilation? Those e ects are indeed pronounced near a black hole horizon. Again, though, for our upper bounds we will have in m ind systems far from the Schwarzschild lim it, for which any time dilation is by at m ost a constant factor independent of n.
- (3) How do cosm obgical considerations a ect our analysis? Bousso [8] argues that, in a spacetim e with positive cosm obgical constant > 0, the total number of bits accessible to any one experiment is at most 3 = (ln 2), or roughly 10¹²² given current experimental bounds [26] on .³ Intuitively, even if the universe is spatially in nite, most of it recedes too quickly from any one observer to be harnessed as computer memory.

O ne response to this result is to assume an idealization in which vanishes, although P lanck's constant ~ does not vanish. As justi cation, one could argue that without the idealization = 0, all asymptotic bounds in computer science are basically ctions. But perhaps a better response is to accept the $3 = (\ln 2)$ bound, and then ask how close one can come to saturating it in di erent scenarios. C lassically, the maximum number of bits that can be searched is, in a crude model⁴, actually proportional to $1 = p_1 0^{61}$ rather than 1 =. The reason is that if a region had much more than 1 = bits, then after 1 = P lanck times that is, about 10^{10} years, or roughly the current age of the universe most of the region would have receded beyond one's cosm obgical horizon. W hat our results suggest is that, using a quantum robot, one could come closer to saturating the cosm ological bound is since, for example, a 2-D region of size 1 = can be searched in time $0 = \frac{p_1}{2}$ polylog $\frac{p_1}{p_1}$. How anyone could prepare a database of size much greater than $1 = p_1$ remains unclear, but if such a database existed, it could be searched!

3 The M odel

M uch of what is known about the power of quantum computing comes from the black-box or query m odel [2,4,7,17,29], in which one counts only the num ber of queries to an oracle, not the num ber of computational steps. We will take this model as the starting point for a form alde nition of quantum robots. Doing so will focus attention on our main concern: how much harder is it to evaluate a function when its inputs are spatially separated? As it turns out, all of our algorithms will be e cient as measured by the num ber of gates and auxiliary qubits needed to implement them.

For simplicity, we assume that a robot's goal is to evaluate a Boolean function $f:f0;1g^n ! f0;1g, which could be partial or total. A 'region of space' is a connected undirected graph <math>G = (V;E)$ with vertices $V = fv_1; :::;v_ng$. Let $X = x_1 :::x_n \ 2 \ f0;1g^n$ be an input to f; then each bit x_i is available only at vertex v_i . We assume the robot knows G and the vertex labels in advance, and so is ignorant only of the x_i bits. We thus sidestep a major di culty for quantum walks [1], which is how to ensure that a process on an unknown graph is unitary.

Here $v_i 2 V$ is a vertex, representing the robot's location; and z is a bit string (which can be arbitrarily long), representing the robot's internal con guration. The state evolves via an alternating sequence of T algorithm steps and T oracle steps:

An oracle step 0 ^(t) m aps each basis state $\dot{y}_i;zi$ to $\dot{y}_i;z = x_ii$, where x_i is exclusive-OR'ed into the rst bit of z. An algorithm step U ^(t) can be any unitary matrix that (1) does not depend on X, and (2) acts 'locally' on G. How to make the second condition precise is the subject of Section 3.1.

The initial state of the algorithm is $j_{i;1}$;0i. Let $i_{i;z}^{(t)}$ (X) be the amplitude of $j_{i;z}$ immediately after the tth oracle step; then the algorithm succeeds with probability 1 " if

for all inputs X , where $z_{O U T}$ is a bit of z representing the output.

3.1 Locality Criteria

C lassically, it is easy to decide whether a stochastic matrix acts locally with respect to a graph G: it does if it moves probability only along the edges of G. In the quantum case, however, interference makes the question much more subtle. In this section we propose three criteria for whether a unitary matrix U is local. O ur algorithm s will then be implemented using the most restrictive of these criteria.

The rst criterion we call Z-bcality (for zero): U is Z-bcal if, given any pair of non-neighboring vertices $v_1; v_2$ in G, U \sends no am plitude" from v_1 to v_2 ; that is, the corresponding entries in U are all 0. The second criterion, C-bcality (for composability), says that this is not enough: not only must U send am plitude only between neighboring vertices, but it must be composed of a product of commuting unitaries, each of which acts on a single edge. The third criterion is perhaps the most natural one to a physicist: U is H-bcal (for H am iltonian) if it can be obtained by applying a locally-acting, low -energy H am iltonian for some xed am ount of time. M ore form ally, let $U_{i;z!}$ i ;z be the entry in the j_{v_i} ;zi column and j_{v_i} ;zi row of U.

De nition 1 U is Z-local if U _{i;z! i ;z} = 0 whenever i f i and (v_i;v_i) is not an edge of G .

D e nition 2 U is C-local if the basis states can be partitioned into subsets P_1 ;:::; P_q such that

(i) $U_{i;z!} = 0$ whenever $y_i;zi$ and $y_i;z$ ibelong to distinct $P_j's$, and

(ii) for each j, all basis states in P_{i} are either from the same vertex or from two adjacent vertices.

De nition 3 U is H-local if U = e^{iH} for some Herm itian H with eigenvalues of absolute value at most , such that $H_{i_{j_z}! i_{j_z}} = 0$ whenever if i and $(v_i; v_i)$ is not an edge in E.

If a unitary matrix is C-local, then it is also Z-local and H-local. For the latter implication, note that any unitary U can be written as e^{iH} for some H with eigenvalues of absolute value at most . So we can write the unitary U_j acting on each P_j as e^{iH_j} ; then since the U_j's commute,

$$U_{j} = e^{i H_{j}}.$$

Beyond that, though, how are the locality criteria related? A re they approximately equivalent? If not, then does a problem 's complexity in our model ever depend on which criterion is chosen? Let us emphasize

that these questions are not answered by, for example, the Solovay-K itaev theorem (see [22]), that an n n unitary matrix can be approximated using a number of gates polynomial in n. For recall that the de nition of C-locality requires the edgew ise operations to commute indeed, without that requirement, one could produce any unitary matrix at all. So the relevant question, which we leave open, is whether any Z-local or H-local unitary can be approximated by a product of, say, O (logn) C-local unitaries. (A product of O (n) such unitaries trivially su ces, but that is far too many.)

4 GeneralBounds

G iven a Boolean function $f:f0;1g^n ! f0;1g$, the quantum query complexity Q (f), de ned by Beals et al. [4], is the minimum T for which there exists a T-query quantum algorithm that evaluates f with probability at least 2=3 on all inputs. (W e will always be interested in the two-sided, bounded-error complexity, sometimes denoted Q_2 (f).) Similarly, given a graph G with n vertices labeled 1;:::;n, we let Q (f;G) be the minimum T for which there exists a T-query quantum robot on G that evaluates f with probability 2=3. Here we require the algorithm steps to be C-local. One might also consider the corresponding measures Q^2 (f;G) and Q^H (f;G) with Z-local and H-local steps respectively. Clearly Q (f;G) Q^Z (f;G) and Q (f;G) Q^H (f;G); we conjecture that all three measures are asymptotically equivalent but were unable to prove this.

Let $_{\rm G}$ be the diam eter of G, and call f nondegenerate if it depends on all n input bits.

Proposition 4 For all f;G,

- (i) Q (f;G) 2n 3.
- (ii) Q (f;G) $(2_G + 1)Q$ (f).
- (iii) Q (f;G) Q (f).
- (iv) Q (f;G) $_{G} = 2$ if f is nondegenerate.

Proof.

- (i) Starting from the root, a spanning tree for G can be traversed in 2 (n 1) 1 steps (there is no need to return to the root).
- (ii) We can simulate a query in 2 $_{G}$ steps, by fanning out from the start vertex v_{1} and then returning. Applying a unitary at v_{1} takes 1 step.
- (iii) Obvious.
- (iv) There exists a vertex v_i whose distance to v_1 is at least $_G = 2$, and f could depend on x_i .

We now show that the model is robust.

P roposition 5 For nondegenerate f, the following change Q (f;G) by at most a constant factor.

- (i) Replacing the initial state jv_1 ;0i by an arbitrary (known) j i.
- (ii) Requiring the nalstate to be localized at some vertex v_i with probability at least 1 ", for a constant " > 0.
- (iii) A llowing multiple algorithm steps between each oracle step (and measuring the complexity by the num ber of algorithm steps).

Proof.

- (i) We can transform jy_1 ;0i to j i (and hence j i to jy_1 ;0i) in $_G = O(Q(f;G))$ steps, by fanning out from v_1 along the edges of a m inim um height spanning tree.
- (ii) A ssum e without loss of generality that z_{OUT} is accessed only once, to write the output. Then after z_{OUT} is accessed, uncompute (that is, run the algorithm backwards) to localize the nal state at v_1 . The state can then be localized at any v_1 in $_G = O(Q(f;G))$ steps. We can succeed with any constant probability by repeating this procedure a constant num ber of times.
- (iii) The oracle step 0 is its own inverse, so we can implement a sequence U₁;U₂;:::of algorithm steps as follows (where I is the identity):

$$U_1 ! O ! I ! O ! U_2 !$$

A function of particular interest is $f = OR(x_1; :::; x_n)$, which outputs 1 if and only if $x_i = 1$ for some i. We rst give a general upper bound on Q (OR;G) in terms of the diameter of G. (Throughout the paper, we sometimes om it oor and ceiling signs if they clearly have no elect on the asymptotics.)

Proposition 6

Proof. Let be a minimum-height spanning tree for G, rooted at v_1 . A depth-rst search on uses 2n 2 steps. Let S_1 be the set of vertices visited by depth-rst search in steps 1 to $_G$, S_2 be those visited in steps $_G$ + 1 to 2 $_G$, and so on. Then

Furtherm ore, for each S_j there is a classical algorithm A_j , using at most 3_G steps, that starts at v_1 , ends at v_1 , and outputs 1' if and only if $x_i = 1$ for some $v_i \ 2 \ S_j$. Then we simply perform G rover search at v_1 over all A_j ; since each iteration takes 0 ($_G$) steps and there are 0 $p = \frac{p}{2n = G}$ iterations, the number of steps is 0 $p = \frac{1}{n_G}$.

The bound of Proposition 6 is tight:

For by unitarity, the Euclidean distance between $^{(t)}(X_{q-1})$ and $^{(t)}(X_{q})$ can only increase as a result of queries T qc + 1 through T (q 1) c. But no amplitude from outside L_j can reach v_i during that interval, since the distance is =2 and there are only c < =2 time steps. Therefore, switching from X_{q-1} to X_q can only a ect amplitude that is in L_j immediately after query T qc :

Here the rst inequality uses the triangle inequality, and the third uses the C auchy-Schwarz inequality. Now assuming the algorithm is correct we need D (0;w) = (1), which implies that $T = \frac{p_{min}}{n}$.

It is immediate that Theorem 7 applies to Z-local unitaries as well as C-local ones: that is, Q^Z (OR;G) = p - n. We believe the theorem can be extended to H-local unitaries as well, but a full discussion of this issue would take us too far a eld.

5 Search on Grids

Let L_d (n) be a d-dimensional grid graph of size $n^{1=d}$ ^{1=d}. That is, each vertex is specified by d coordinates i_1 ;:::; i_d 2 1;:::; $n^{1=d}$, and is connected to the at most 2d vertices obtainable by adding or subtracting 1 from a single coordinate (boundary vertices have few er than 2d neighbors). We write simply L_d when n is clear from context. In this section we present ourmain positive results: that Q (OR; L_d) = $\binom{p}{n}$ for d 3, and Q (OR; L_2) = 0 $\binom{p}{n}$ polylogn) for d = 2.

Before proving these claims, let us develop some intuition by showing weaker bounds, taking the case d = 2 for illustration. Clearly Q (OR;L₂) = 0 $n^{3=4}$: we simply partition L₂ (n) into p subsquares, each a copy of L₂ (n). In 5 n steps, the robot can travel from the start vertex to any subsquare C, search C classically for a marked vertex, and then return to the start vertex. Thus, by searching all p n of the C's in superposition and applying Grover's algorithm, the robot can search the grid in time 0 $n^{1=4}$ 5 p n = 0 $n^{3=4}$.

Once we know that, we might as well partition L_2 (n) into n^{1-3} subsquares, each a copy of L_2 n^{2-3} . Searching any one of these subsquares by the previous algorithm takes time 0 n^{2-3} $n^{3-4} = 0$ $\binom{p}{n}$, an am ount of time that also success travel to the subsquare and back from the start vertex. So using G rover's algorithm, the robot can search L_2 (n) in time 0 n^{1-3} $\frac{p}{n} = 0$ n^{2-3} . We can continue recursively in this manner to make the running time approach 0 $\binom{p}{n}$. The trouble is that, with each additional layer of recursion, the robot needs to repeat the search more often to upper-bound the error probability. Using this approach, the best bounds we could obtain are roughly 0 $\binom{p}{n}$ polylogn) for 3, or $n^2 n^{2-3}$ for d = 2. In what follows, we use the amplitude amplication approach of G rover [19] and B rassard et al. [11] to improve these bounds, in the case of a single marked vertex, to 0 $\binom{p}{n}$ for d 3 (Section 5.2) and 0 $n^2 n \log^{3-2} n$ for d = 2 (Section 5.3). Section 5.4 generalizes these results to the case of multiple marked vertices.

Intuitively, the reason the case d = 2 is special is that there, the diam eter of the grid is $\binom{p}{n}$, which m atches exactly the time needed for G rover search. For d 3, by contrast, the robot can travel across the grid in much less time than is needed to search it.

5.1 Amplitude Ampli cation

We start by describing am plitude am pli cation [11, 19], a generalization of G rover search. Let U be a quantum algorithm that, with probability , outputs a correct answer together with a witness that proves the answer correct. (For example, in the case of search, the algorithm outputs a vertex label i such that $x_i = 1$.) Am pli cation generates a new algorithm that calls U order 1 = 1 times, and that produces both a correct answer and a witness with probability (1). In particular, assume U starts in basis state jsi, and let m be a positive integer. Then the am pli cation procedure works as follows:

- (1) Set j₀i= U jsi.
- (2) For i = 1 to m set $j_{i+1}i = USU^{-1}W j_ii$, where

W ips the phase of basis state jui if and only if jui contains a description of a correct witness, and

S ips the phase of basis state jui if and only if jui = jsi.

We can decompose j_0i as sin $j_{succ}i + cos j_{fail}i$, where $j_{succ}i$ is a superposition over basis states containing a correct witness and $j_{fail}i$ is a superposition over all other basis states. Brassard et al. [11] showed the following:

Lem m a 8 ([11]) j_ii = sin [(2i+1)]j succi + $\cos [(2i+1)]j_{fail}i$.

If m easyring j_0 i gives a correct witness with probability, then jain $j^2 = and j j$ 1 = -. So taking m = 0 (1 = -) yields sin [(2m + 1)] 1. For our algorithm s, though, the multiplicative constant under the big-0 also matters. To upper-bound this constant, we prove the following lemma.

Lem m a 9 Suppose a quantum algorithm U outputs a correct answer and witness with probability exactly . Then by using 2m + 1 calls to U or U 1 , where

Proof. We perform m steps of am plitude am pli cation, which requires 2m + 1 calls to U or U¹. By Lem ma 8, this yields the nalstate

Here the rst line uses the monotonicity of $\sin^2 x$ in the interval [0; =2], and the second line uses the fact that $\sin x + x^3 = 6$ for all x = 0 by Taylor series expansion.

Note that there is no need to uncompute any garbage left by U, beyond the uncomputation that happens \autom atically" within the amplication procedure.

5.2 Dimension At Least 3

Our goal is the follow ing:

Theorem 10 If d 3, then Q (OR; L_d) = $\binom{p_n}{n}$.

In this section, we prove Theorem 10 for the special case of a unique marked vertex; then, in Sections 5.4 and 5.5, we will generalize to multiple marked vertices. Let $OR^{(k)}$ be the problem of deciding whether there are no marked vertices or exactly k of them, given that one of these is true. Then:

Theorem 11 If d 3, then Q
$$OR^{(1)}; L_d = (\stackrel{P}{n}).$$

Choose constants 2 (2=3;1) and 2 (1=3;1=2) such that > 1=3 (for example, = 4=5 and m = 5=11 will work). Let $'_0$ be a large positive integer; then for all positive integers R, let $'_R = '_{R-1} \cdot \binom{1}{R-1}^{1}$. Also let $n_R = \binom{'d}{R}$. A ssume for simplicity that $n = n_R$ for som e R; in other words, that the hypercube L_d (n_R) to be searched has sides of length $'_R$. Later we will remove this assumption.

Consider the following recursive algorithm A. If $n = n_0$, then search L_d (n_0) classically, returning 1 if a marked vertex is found and 0 otherwise. Otherwise partition L_d (n_R) into $n_R = n_{R-1}$ subcubes, each one a

copy of L_d (n_{R 1}). Take the algorithm that consists of picking a subcube C uniform ly at random, and then running A recursively on C. Amplify this algorithm (n_R =n_{R 1}) times.

The intuition behind the exponents is that $n_{R-1} = n_{R}$, so searching $L_d (n_{R-1})$ should take about $n_{R}^{=2}$ steps, which dominates the $n_{R}^{1=d}$ steps needed to travel across the hypercube when d 3. A loo, at level R we want to am plify a num ber of times that is less than $(n_{R} = n_{R-1})^{1=2}$ by some polynomial amount, since full am pli cation would be inecient. The reason for the constraint > 1=3 will appear in the analysis.

We now provide a more explicit description of A, which shows that it can be implemented using C-local puttaries and only a single bit of workspace. At any time, the quantum robot's state will have the form $_{i,z}$ $_{i,z}$ $j_{y_i};z_i$, where v_i is a vertex of L_d (n_R) and z is a single bit that records whether or not a marked vertex has been found. G iven a subcube C, let v (C) be the \comer" vertex of C; that is, the vertex that is m inim al in all d coordinates. Then the initial state when searching C will be j_r (C); 0i. Beware, how ever, that \initial state" in this context just means the state jsi from Section 5.1. Because of the way am plitude amplication works, A will offen be invoked on C with other initial states, and even run in reverse.

For convenience, we will implement A using a two-stage recursion: given any subcube, the task of A will be to amplify the result of another procedure called U, which in turn runs A recursively on smaller subcubes. We will also use the conditional phase ips W and S from Section 5.1. For convenience, we write A_R ; U_R ; W_R ; S_R to denote the level of recursion that is currently active. Thus, A_R calls U_R , which calls A_{R-1} , which calls U_{R-1} , and so on down to A_0 .

A lgorithm 12 (A_R) Searches a subcube C of size n_R for the marked vertex, and ampli es the result to have larger probability. Default initial state: \dot{y} (C);0i.

If R = 0 then:

- (1) U se classical C-local operations to visit all n_0 vertices of C in any order. At each $v_i \ge C$, use a query transform ation to map the state jv_i ; zi to jv_i ; z x_i i.
- (2) Return to v (C).
- If R 1 then:
- (1) Let m_R be the smallest integer such that $2m_R + 1$ ($n_R = n_{R-1}$).
- (2) $Call U_R$.
- (3) For i = 1 to m_R , call W_R , then U_R^{-1} , then S_R , then U_R .

Suppose A_R is run on the initial state jv (C);0i, and let C_1 ;:::; $C_{n_R=n_0}$ be the minimal subcubes in $C \mid m$ earning those of size n_0 . Then the nal state after A_R term inates should be

if C does not contain the marked vertex. O there ise the nalstate should have non-negligible overlap with $jv(C_i);1i$, where C_i is the minimal subcube in C that contains the marked vertex. In particular, if R = 0, then the nalstate should be jv(C);1i if C contains the marked vertex, and jv(C);0i otherwise.

The two phase- ip subroutines, W_R and S_R, are both trivial to implement. To apply W_R, map each basis state j_{i_i} ; zi to $(1)^z j_{i_i}$; zi. To apply S_R, map each j_{i_i} ; zi to j_{i_i} ; zi if z = 0 and $v_i = v$ (C) for some subcube C of size n_R , and to j_{i_i} ; zi otherwise. Below we give pseudocode for U_R .

A lgorithm 13 (U_R) Searches a subcube C of size n_R for the marked vertex. D efault initial state: jv (C);0i.

(1) Partition C into $n_R = n_{R-1}$ smaller subcubes C_1 ;:::; $C_{n_R} = n_{R-1}$, each of size n_{R-1} .

(2) For all j 2 f1;:::;dg, let V_j be the set of corner vertices v (C_i) that di er from v (C) only in the rst j coordinates. Thus V₀ = fv (C)g, and in general jV_jj = ('_R = '_{R 1})^j. For j = 1 to d, let jV_ji be the state

Apply a sequence of transform ations $Z_1, Z_2, ::; Z_d$ where Z_j is a unitary that maps y_{j-1} ito y_j i by applying C-local unitaries that move amplitude only along the jth coordinate.

(3) $CallA_{R-1}$ recursively. (Note that this searches C_1 ;:::; $C_{n_R=n_{R-1}}$ in superposition. Also, the required amplication is performed for each of these subcubes automatically by step (3) of A_{R-1} .)

If U_R is run on the initial state jv (C); 0i, then the nal state should be

$$p = \frac{1}{n_R = n_{R-1}} \sum_{i=1}^{n_X = n_0} j_i i;$$

where j_i is the correct nal state when A_{R-1} is run on subcube C_i with initial state jv (C_i) ;0i. A key point is that there is no need for U_R to call A_{R-1} twice, once to compute and once to uncompute | for the uncomputation is already built into A_R . This is what will enable us to prove an upper bound of O(n) instead of O(n) = O(n) polylogn).

W e now analyze the running time of A $_{\rm R}$.

Lem m a 14 A $_{\rm R}$ uses 0 (n $_{\rm R}$) steps.

P roof. Let T_A (R) and T_U (R) be the total numbers of steps used by A_R and U_R respectively in searching L_d (n_R). Then we have T_A (0) = 0 (1), and

Here the second line follows because $2m_R + 1$ $(n_R = n_{R-1}) + 2$, the fourth because the $(n_R = n_{R-1})$ terms increase doubly exponentially, so adding 2 to each will not a ect the asymptotics; the seventh because $n_i = n_{i+1}$, the eighth because $n_{R-1} - n_R$; and the last because > 1=3 1=d, hence $n_1^{1=d} < 1$.

Next we need to low er-bound the success probability. Say that A_R or U_R \succeeds" if a m easurement in the standard basis yields the result jv (C_i); 1i, where C_i is the minimal subcube that contains the marked vertex. Of course, the marked vertex itself can then be found in $n_0 = 0$ (1) steps.

Lem m a 15 A sum ing there is a unique marked vertex, A_R succeeds with probability $1=n_R^{1/2}$

Proof. Let P_A (R) and P_U (R) be the success probabilities of A_R and U_R respectively when searching L_d (n_R). Then clearly P_A (0) = 1, and P_U (R) = (n_R 1= n_R) P_A (R 1) for all R 1. So by Lemma 9,

Here the third line follows because $2m_R + 1$ ($n_{R-1} = n_R$) and the function $x - \frac{1}{3}x^2$ is nondecreasing in the interval [0;1]; the fourth because P_A (R 1) 1; the sixth because $n_{R-1} - n_R$; and the last because < 1 and < 1=2, the n_R 's increase doubly exponentially, and n_0 is su ciently large.

Finally, take A_R itself and amplify it to success probability (1) by running it $O(n_R^{1=2})$ times. This yields an algorithm for searching $L_d(n_R)$ with overall running time $O(n_R^{1=2})$, which implies that $Q OR^{(1)}; L_d(n_R) = O(n_R^{1=2})$.

All that remains is to handle values of n that do not equal n_R for any R. The solution is simple: rst nd the largest R such that $n_R < n$. Then set $n^0 = n_R$ $n^{1=d} = r_R^d$, and embed L_d (n) into the larger hypercube L_d (n⁰). Clearly Q OR⁽¹⁾; L_d (n) Q OR⁽¹⁾; L_d (n⁰). Also notice that $n^0 = 0$ (n) and that $n^0 = 0$ $n_R^{1=} = 0$ $n_R^{3=2}$. Next partition L_d (n⁰) into $n^0 = n_R$ subcubes, each a copy of L_d (n_R). The algorithm will now have one additional level of recursion, which chooses a subcube of L_d (n⁰) uniform by at random, runs A_R on that subcube, and then amplies the resulting procedure r_R^{0} into $n^0 = n_R$ times. The total time is now r_R^{-1} is now r_R^{-1} .

5.3 Dimension 2

In the d = 2 case, the best we can achieve is the following:

Theorem 16 Q (OR; L_2) = 0 $p = \frac{1}{n} \log^{5-2} n$.

A gain, we start with the single marked vertex case and postpone the general case to Sections 5.4 and 5.5.

Theorem 17 Q OR $^{(1)}$; L $_2$ = 0 $^{p} \, \overline{n} \, \log^{3=2} n$.

For d 3, we perform ed am pli cation on large (greater than 0 $1=n^{1/2}$) probabilities only once, at the end. For d = 2, on the other hand, any algorithm that we construct with any nonzero success probability will have running time $\binom{p}{n}$, simply because that is the diam eter of the grid. If we want to keep the running time 0 $\binom{p}{n}$, then we can only perform 0 (1) am pli cation steps at the end. Therefore we need to keep the success probability relatively high throughout the recursion, meaning that we su er an increase in the running time, since am pli cation to high probabilities is less e cient.

The procedures A_R , U_R , W_R , and S_R are identical to those in Section 5.2; all that changes are the parameter settings. For all integers R 0, we now let $n_R = \frac{2R}{0}$, for some odd integer '0 3 to be set later. Thus, A_R and U_R search the square grid L_2 (n_R) of size $\binom{N}{0}$. A lso, let $m = \binom{1}{0}$ 1)=2; then A_R applies m steps of am plitude amplication to U_R .

We now prove the counterparts of Lemm as 14 and 15 for the two-dimensional case.

Lemma 18 A_R uses 0 R_0^{R+1} steps.

This is because (R) iterations of the m ap $x_R = x_{R-1} - \frac{1}{3}x_{R-1}^2$ are needed to drop from (say) 2=R to 1=R, and $x_0 = P_A$ (0) = 1 is greater than 2=R.

We can amplify A_R to success probability (1) by repeating it 0 p \overline{R} times. This yields an algorithm for searching L_2 (n_R) that uses 0 $R^{3=2} {}^{R+1}_{0} = 0 {}^{p} \overline{n_R} R^{3=2} {}^{o}_{0}$ steps in total. We can minimize this expression subject to ${}^{2R}_{0} = n_R$ by taking ${}^{o}_{0}$ to be constant and R to be (logn $_R$), which yields Q OR ${}^{(1)}; L_2$ (n_R) = 0 ${}^{p} \overline{n_R} \log n_R^{3=2}$. If n is not of the form ${}^{2R}_{0}$, then we simply nd the smallest integer R such that n < ${}^{2R}_{0}$, and embed L_2 (n) in the larger grid L_2 ${}^{2R}_{0}$. Since ${}^{o}_{0}$ is a constant, this increases the running time by at most a constant factor. We have now proved Theorem 17.

5.4 Multiple Marked Items

W hat about the case in which there are multiple is with $x_i = 1$? If there are k marked items (where k need not be known in advance), then G rover's algorithm can nd a marked item with high probability in 0 $\frac{p}{n=k}$ queries, as shown by Boyer et al. [10]. In our setting, however, this is too much to hope for since even if there are many marked vertices, they might all be in a faraway part of the hypercube. Then $n^{1=d}$ steps are needed, even if $\frac{1}{n=k} < n^{1=d}$. Indeed, we can show a stronger lower bound. Recall that OR ^(k) is the problem of deciding whether there are no marked vertices or exactly k of them.

Here, for sim plicity, we ignore constant factors depending on d.

Proof. For simplicity, we assume that both $k^{1=d}$ and $n=3^dk^{1=d}$ are integers. (In the general case, we can just replace k by $k^{1=d}$ and n by the largest integer of the form $(3m)^d k$ which is less than n. This only changes the lower bound by a constant factor depending on d.)

We use a hybrid argument almost identical to that of Theorem 7. Divide L_d into n=k subcubes, each having k vertices and side length $k^{1=d}$. Let S be a regularly-spaced set of $M = n = 3^d k$ of these subcubes, so that any two subcubes in S have distance at least $2k^{1=d}$ from one another. Then choose a subcube $C_j 2 S$ uniform ly at random and mark all k vertices in C_j . This enables us to consider each $C_j 2 S$ itself as a single vertex (out of M in total), having distance at least $2k^{1=d}$ to every other vertex.

M ore form ally, given a subcube $C_j 2 S$, let \mathfrak{E}_j be the set of vertices consisting of C_j and the $3^d 1$ subcubes surrounding it. (Thus, \mathfrak{E}_j is a subcube of side length $3k^{1-d}$.) Then the query magnitude of \mathfrak{E}_j after the tth query is

Notice that if k = n, then the bound of Theorem 20 becomes $n^{1=d}$ which is just the diameter of L_d . A lso, if d = 2, then 1=2 1=d=0 and the bound is simply $\binom{k}{n}$ independent of k. The bound of Theorem 20 can be achieved (up to a constant factor that depends on d) for d = 3, and nearly achieved for d = 2. We rst construct an algorithm for the case when k is known.

5.5 Unknown Number of Marked Item s

We now show how to deal with an unknown k. Let $OR^{(k)}$ be the problem of deciding whether there are no marked vertices or at least k of them, given that one of these is true.

Proof. We use the straightforward doubling' approach of Boyer et al. [10]:

(2) Query a random vertex v, and output 1 if v is a m arked vertex and 0 otherwise.

Let k k be the number of marked vertices. If k n=3, then there exists a j $\log_2 (n=k)$ such that j=3 k $2 \ j=3$. So Lem m a 22 in plies that the jth iteration of step (1) nds a marked vertex with probability at least 2=9. On the other hand, if k n=3, then step (2) nds a marked vertex with probability at least 1=3. For d 3, the time used in step (1) is at most

Taking k = 1 gives a loorithm s for unconstrained OR with running times 0 (n) for 3 and 0 (n) log⁵⁼² n) for d = 2, thereby establishing Theorem s 10 and 16.

6 Search on Irregular G raphs

In Section 1.2, we claim ed that our divide-and-conquer approach has the advantage of being robust: it works not only for highly sym m etric graphs such as hypercubes, but for any graphs having com parable expansion properties. Let us now substantiate this claim.

Say a fam ily of connected graphs fG $_n = (V_n; E_n)g$ is d-dimensional if there exists a > 0 such that for all n; `and v 2 V_n ,

where B (v; ') is the set of vertices having distance at most 'from v in G_n . Intuitively, G_n is d-dimensional (for d 2 an integer) if its expansion properties are at least as good as those of the hypercube $L_d(n)$.⁵ It is immediate that the diameter of G_n is at most $(n=)^{1-d}$. Note, though, that G_n might not be an expander graph in the usual sense, since we have not required that every su ciently small set of vertices has many neighbors.

Our goal is to show the following.

Theorem 24 If G is d-dimensional, then

In proving part (i), the intuition is simple: we want to decompose G recursively into subgraphs (called clusters), which will serve the same role as subcubes did in the hypercube case. The procedure is as follows. For some constant $n_1 > 1$, rst choose $dn=n_1e$ vertices uniform ly at random to be designated as 1-pegs. Then form 1-clusters by assigning each vertex in G to its closest 1-peg, as in a Voronoidiagram. (T ies are broken random ly.) Let v (C) be the peg of cluster C. Next, split up any 1-cluster C with m ore than n_1 vertices into djC j= n_1e arbitrarily-chosen 1-clusters, each with size at m ost n_1 and with v (C) as its 1-peg. O bserve that

where $n = r_1 j$. Therefore, the splitting-up step can at most double the num ber of clusters.

In the next iteration, set $n_2 = n_1^{1=}$, for some constant 2 (2=d;1). Choose 2 dn= n_2 e vertices uniform ly at random as 2-pegs. Then form 2-clusters by assigning each 1-cluster C to the 2-peg that is closest to the 1-peg v (C). G iven a 2-cluster C⁰, let j_c^{0} be the number of 1-clusters in C⁰. Then as before, split up any C⁰ with j_c^{0} $j_c > n_2=n_1$ into dj_c^{0} $j_c = (n_2=n_1)e$ arbitrarily-chosen 2-clusters, each with size at most $n_2=n_1$ and with v (C⁰) as its 2-peg. C ontinue recursively in this manner, setting $n_R = n_{R-1}^{1=}$ and choosing 2^{R-1} dn= $n_R e$ vertices as R-pegs for each R. Stop at the maximum R such that n_R n. For technical convenience, set $n_0 = 1$, and consider each vertex v to be the 0-peg of the 0-cluster fvg.

For R 1, de ne the radius of an R-cluster C to be the maximum, over all (R 1)-clusters C⁰ in C, of the distance from v (C) to v (C⁰). Also, call an R-cluster good if it has radius at most r_{R}^{n} , where $r_{R}^{n} = \frac{2}{2} n_{R} \ln n^{1-d}$.

Lem m a 25 W ith probability 1 o (1) over the choice of clusters, all clusters are good.

⁵ In general, it makes sense to consider non-integer d as well.

Proof. Let v be the $(R \ 1)$ -peg of an $(R \ 1)$ -cluster. Then β (v; ')j ^{vd}, where B (v; ') is the ball of radius 'about v. So the probability that v has distance greater than '_R to the nearest R-peg is at most

Furtherm ore, the total number of pegs is easily seen to be 0 (n). It follows by the union bound that every (R 1)-peg for every R has distance at most '_R to the nearest R-peg, with probability 1 0 (1=n) = 1 o (1) over the choice of clusters. \blacksquare

At the end we have a tree of clusters, which can be searched recursively just as in the hypercube case. Lem m a 25 gives us a guarantee on the time needed to move a level down (from a peg of an R -cluster to a peg of an R 1-cluster contained in it) or a level up. A lso, let K 0 (C) be the num ber of (R 1)-clusters in R - cluster C; then K 0 (C) K (R) where K (R) = 2 dn_R =n_R 1e. If K 0 (C) < K (R), then place K (R) K 0 (C) \dumma y" (R 1)-clusters in C, each of which has (R 1)-peg v (C). Now, every R -cluster contains an equal num ber of R 1 clusters.

Our algorithm is similar to Section 5.2 but the basis states now have the form jy;z;Ci, where v is a vertex, z is an answer bit, and C is the label of the cluster currently being searched. (Unfortunately, because multiple R-clusters can have the same peg, a single auxiliary qubit no longer su ces.)

The algorithm A_R from Section 5.2 now does the following, when invoked on the initial state jr (C);0;C i, where C is an R-cluster. If R = 0, then A_R uses a query transformation to prepare the state jr (C);1;C i if v (C) is the marked vertex and jr (C);0;C i otherwise. If R 1 and C is not a dum my cluster, then A_R perform s m_R steps of am plitude amplitude and U_R , where m_R is the largest integer such that $2m_R + 1$

 $n_R = n_{R-1}$.⁶ If C is a dum m y cluster, then A_R does nothing for an appropriate num ber of steps, and then returns that no marked item was found.

We now describe the subroutine U_R , for R 1. When invoked with jv (C);0;C i as its initial state, U_R rst prepares a uniform superposition

It does this by rst constructing a spanning tree T for C, rooted at v (C) and having m inim aldepth, and then moving am plitude along the edges of T so as to prepare j_C i. A fter j_C i has been prepared, U_R then calls A_{R-1} recursively, to search C_1 ;:::; $C_{K-(R)}$ in superposition and am plify the results. Note that, because of the cluster labels, there is no reason why am plitude being routed through C should not pass through som e other cluster C ⁰ along the way | but there is also no advantage in our analysis for allowing this.

W e now analyze the running time and success probability of A $_{\rm R}$.

Lem m a 26 A $_R$ uses 0 $p \frac{1}{n_R} \log^{1-d} n$ steps, assuming that all clusters are good.

Finally, we repeat A_R itself0 (polylog n_R) times, to achieve success probability (1) using 0 $p_{\overline{n_R}}$ polylog n_R steps in total. Again, if n is not equal to n_R for any R, then we simply nd the largest R such that $n_R < n$, and then add one m ore level of recursion that searches a random R-cluster and am pli es the result $p_{\overline{n_R}}$ times. The resulting algorithm uses 0 (n_R polylog n) steps, thereby establishing part (i) of Theorem 24 for the case of a unique marked vertex.

As in Theorem 23, we give an algorithm B consisting of $\log_2(n=k) + 1$ iterations. In iteration j = 0, choose dn=ke vertices $w_1; :::; w_{dn=ke}$ uniform by at random. Then run the algorithm for the unique marked vertex case, but instead of taking all vertices in G as 0-pegs, take on by $w_1; :::; w_{dn=ke}$. On the other hand, still choose the 1-pegs, 2-pegs, and so on uniform by at random from am ong all vertices in G. For all R, the number of R-pegs should be $d(n=k)=n_R e$. In general, in iteration j of B, choose $n=2^{j}k$ vertices $w_1; :::; w_{dn=(2^jk)e}$ uniform by at random, and then run the algorithm for a unique marked vertex as if $w_1; :::; w_{dn=(2^jk)e}$ were the only vertices in the graph.

It is easy to see that, assuming there are k orm ore marked vertices, with probability (1) there exists an iteration j such that exactly one of w_1 ;:::; $w_{dn=(2^{j}k)e}$ is marked. Hence B succeeds with probability (1). It remains only to upper-bound B's running time.

In iteration j, notice that Lemma 25 goes through if we use $r_R^{(j)} := \frac{2}{2} 2^j k n_R \ln \frac{n}{k} \ln \frac{n}{k}$ instead of r_R . That is, with probability 1 0 (k=n) = 1 o (1) over the choice of clusters, every R-cluster has radius at most $r_R^{(j)}$. So letting T_A (R) be the running time of A_R on an R-cluster, the recurrence in Lemma 26 becomes

$$T_A (R) = \frac{p_{R}}{n_R = n_{R-1}} (p_{R}^{(j)} + T_A (R-1)) = 0 \frac{p_{R}}{n_R} 2^j k \log (n=k)^{1=d};$$

which is

$$0 \quad \frac{p_{n} \log^{1=d} \frac{n}{k}}{(2^{j}k)^{1=2}}!$$

if $n_R = n = 2^j k$. As usual, the case where there is no R such that $n_R = n = 2^j k$ is trivially handled by adding one more level of recursion. If we factor in the O (1=polylogn_R) repetitions of A_R needed to boost the success probability to (1), then the total running time of iteration j is

$$0 \quad \frac{p - poly \log \frac{n}{k}}{(2^{j}k)^{1-2}} :$$

Therefore B's running time is

$$0 = \frac{1}{\sum_{j=0}^{\log_X(n=k)} \frac{p}{n} \frac{p}{n} \frac{p}{p} \frac{1}{p} \frac{p}{p} \frac{p}{p}$$

For the d = 2 case, the best upper bound we can show is $pn2^{\circ} (\frac{p}{\log n})$. This is obtained by simply modifying A_R to have a deeper recursion tree. Instead of taking $n_R = n_{R-1}^{1=}$ for some , we take $n_R = 2^{p} \frac{\log n}{\log n} n_{R-1} = 2^{R^{p} \frac{\log n}{\log n}}$, so that the total number of levels is $p \frac{\log n}{\log n}$. Lem ma 25 goes through without modi cation, while the recurrence for the running time becomes

$$T_{A} (R) = p \frac{p}{n_{R} = n_{R-1}} (Y_{R} + T_{A} (R - 1))$$

$$p \frac{p}{n_{R} = n_{R-1}} (Y_{R} + p \frac{p}{n_{R} = n_{R-2}} (Y_{R-1} + p \frac{p}{n_{R} = n_{0}})$$

$$= 0 2^{p} \frac{p}{\log n} (R = 2)^{p} \frac{p}{\ln n} + p \frac{p}{\log n} (R = 2)^{p} \frac{p}{\ln n}$$

$$= p \frac{p}{n2^{0}} (p \frac{p}{\log n})$$

A lso, since the success probability decreases by at most a constant factor at each level, we have that $P_A(R) = 2 \circ \binom{D_{DGR}}{D_{GR}}$, and hence $2^{\circ} \binom{D_{DGR}}{D_{GR}}$ amplication steps success to boost the success probability to (1). Handling multiple marked item s adds an additional factor of logn, which is absorbed into $2^{\circ} \binom{D_{DGR}}{D_{GR}}$. This completes Theorem 24.

6.1 Bits Scattered on a Graph

n

In Section 2, we discussed several ways to pack a given amount of entropy into a spatial region of given dimensions. However, we said nothing about how the entropy is distributed within the region. It might be uniform, or concentrated on the boundary, or distributed in some other way. So we need to answer the following: suppose that in some graph, hout of the n vertices might be marked, and we know which h those

are. Then how much time is needed to determ ine whether any of the h is marked? If the graph is the hypercube L_d for d 2 or is d-dimensional for d > 2, then the results of the previous sections imply that 0 (n polylogn) steps su ce. However, we wish to use fewer steps, taking advantage of the fact that h m ight be much smaller than n. Form ally, suppose we are given a graph G with n vertices, of which h are potentially marked. Let $0 R^{(h; k)}$ be the problem of deciding whether G has no marked vertices or at least k of them, given that one of these is the case.

P roposition 29 For all integer constants d 2, there exists a d-dimensional graph G such that

$$Q \quad OR^{(h; k)}; G = n^{1-d} \frac{h}{k} :$$

P roof. Let G be the d-dimensional hypercube L_d (n). C reate h=k subcubes of potentially marked vertices, each having k vertices and side length $k^{1=d}$. Space these subcubes out in L_d (n) so that the distance between any pair of them is $(nk=h)^{1=d}$. Then choose a subcube C uniform ly at random and mark all k

vertices in C. This enables us to consider each subcube as a single vertex, having distance $(nk=h)^{1=d}$ to every other vertex. The lower bound now follows by a hybrid argument essentially identical to that of Theorem 20.

In particular, if d = 2 then $\binom{p}{n}$ time is always needed, since the potentially marked vertices m ight all be far from the start vertex. The lower bound of Proposition 29 can be achieved up to a polylogarithm ic factor.

P roposition 30 If G is d-dimensional for a constant d > 2, then

Q OR^(h; k); G = O
$$n^{1=d} \frac{h}{k}$$
 polylog $\frac{h}{k}$:

P roof. A ssum e without loss of generality that k = o(h), since otherwise a marked item is trivially found. Use algorithm B from Corollary 28, with the following simple change. In iteration j, choose $h = 2^{j}k$ potentially marked vertices $w_1; :::; w_{dh=(2^{j}k)e}$ uniform by at random, and then run the algorithm for a unique marked vertex as if $w_1; :::; w_{dh=(2^{j}k)e}$ were the only vertices in the graph. That is, take $w_1; :::; w_{dh=(2^{j}k)e}$ as 0-pegs; then for all R 1, choose $h = 2^{j}kn_R$ vertices of G uniform by at random as R-pegs. Lem ma 25 goes through if we use $\frac{b^{(j)}}{R} := \frac{2}{h}2^{j}kn_R \ln \frac{h}{k}^{1-d}$ instead of '_R. So following Corollary 28, the running time of iteration j is now

$$0 \quad \frac{p_{n_{R}}}{n_{R}} \quad \frac{n}{h} 2^{j} k \quad \frac{1=d}{polylog} \frac{h}{k} = 0 \quad n^{1=d} \quad \frac{h}{2^{j} k} \quad \frac{1=2}{polylog} \frac{h}{k}$$

if $n_R = h = 2^j k$. Therefore the total running time is

Intuitively, P roposition 30 says that the worst case for search occurs when the h potential marked vertices are scattered evenly throughout the graph.

7 Application to D isjointness

In this section we show how our results can be used to strengthen a seem ingly unrelated result in quantum computing. Suppose A lice has a string $X = x_1 :::x_n \ 2 \ f0;1g^n$, and B ob has a string $Y = y_1 :::y_n \ 2 \ f0;1g^n$. In the disjointness problem, A lice and B ob m ust decide with high probability whether there exists an i such that $x_i = y_i = 1$, using as few bits of communication as possible. Buhman, C leve, and W igderson [12] observed that in the quantum setting, A lice and B ob can solve this problem using only 0 (\overline{n} logn) qubits of communication. This was subsequently in proved by H yer and de W olf [20] to 0 $\frac{P}{nc}\log^{n}$, where c is a constant and log n is the iterated logarithm function. Using the search algorithm of Theorem 10, we can im prove this to 0 (\overline{n}), which m atches the celebrated ($\frac{P}{n}$) lower bound of Razborov [23].

Theorem 31 The quantum communication complexity of the disjointness problem is 0 (n).

P roof. The protocol is as follows. A lice and Bob both store their inputs in a 3-D cube L₃ (n) (Figure 3); that is, they let $x_{jkl} = x_i$ and $y_{jkl} = y_i$, where $i = n^{2-3}j + n^{1-3}k + l + 1$ and $j;k;l2 \quad 0; \ldots; n^{1-3} \quad 1$. To decide whether there exists a (j;k;l) with $x_{jkl} = y_{jkl} = 1$, A lice simply runs our search algorithm for an unknown number of marked items. If the search algorithm is in the state

then the joint state of A lice and B ob will be

$$_{j;k;l;z;c} \dot{y}_{jkl} i \dot{z} i \dot{z} i \dot{y}_{jkl} i;$$
 (1)

where A lice holds the rst y_{jkl} i and j_{2i} , Bob holds the second y_{jkl} , and j_{2i} is the communication channel. Thus, whenever A lice is at location (j_{jk} ; l) of her cube, Bob is at location (j_{jk} ; l) of his cube.

- (1) To simulate a query, A lice sends jzi and an auxiliary qubit holding x_{jk1} to Bob. Bob performs jzi! jz y_{jk1}i, conditional on x_{jk1} = 1. He then returns both bits to A lice, and nally A lice returns the auxiliary qubit to the jDi state by exclusive OR 'ing it with x_{jk1}.
- (2) To simulate a non-query transform ation that does not change $jv_{jkl}i$, A lice just perform s it herself.
- (3) By exam ining A lgorithm s 12 and 13, we see that there are two transform ations that change jv_{jk1}i. We dealwith them separately.

First, step 1 of A kgorithm 12 uses a classical C-local transform ation $\dot{y}_{j;k;l}i ! \dot{y}_{j^{0};k^{0};l^{0}}i$. This transform ation can be simulated by A lice and B ob each separately applying $\dot{y}_{j;k;l}i ! \dot{y}_{j^{0};k^{0};l^{0}}i$.

Second, step 2 of A kgorithm 13 applies transform ations Z_1, Z_2 , and Z_3 . For brevity, we restrict ourselves to discussing Z_1 . This transform ation m aps an initial state $\mathbf{j}_{j;k;1}$;0i to a uniform superposition over \mathbf{j}_{j_0} ; $_{k;1}$;0i for all $(\mathbf{j}^0;k;1)$ lying in the same C_i as $(\mathbf{j};k;1)$. We can decompose this into a sequence of transform ations mapping \mathbf{j}_{j_0} ; $_{k;1}$ ito \mathbf{j}_{j_0} ; $_{k;1}$ if for some , . This can be implemented

in three steps, using an auxiliary qubit. The auxiliary qubit is initialized to Di and is initially held by A lice. At the end, the auxiliary qubit is returned to Di. The sequence of transform ations is

The rst transform ation is perform ed by A lice who then sends the auxiliary qubit to B ob. The second transform ation is perform ed by B ob, who then sends the auxiliary qubit back to A lice, who perform s the third transform ation.

Since the algorithm uses $0 \left(\begin{array}{c} n \\ n \end{array} \right)$ steps, and each step is simulated using a constant amount of communication, the number of qubits communicated in the disjointness protocol is therefore also $0 \left(\begin{array}{c} n \\ n \end{array} \right)$.

8 Open Problem s

A s discussed in Section 3.1, a salient open problem raised by this work is to prove relationships am ong Z-local, C-local, and H-local unitary matrices. In particular, can any Z-local or H-local unitary be approximated by a product of a small number of C-local unitaries? A lso, is it true that Q (f;G) = Q^{Z} (f;G) =

Q^H (f;G) forallf;G?

Finally, what is the complexity of nding a unique marked vertex on a 2-D square grid? As mentioned in Section 1.2, Ambainis, Kempe, and Rivosh [3] showed that $Q \cap R^{(1)}; L_2 = O \begin{pmatrix} p \\ n \end{pmatrix} \log n$. Can the remaining factor of logn be removed?
