BBGKY Hierarchy Underlying Many Particle Quantum Mechanics

Recently, the one particle quantum mechanics has been obtained in the framework of an entirely classical subquantum kinetics. In the present paper we argue that, within the same scheme and without any additional assumption, it is possible to obtain also the n-particle non relativistic quantum mechanics. The main goal of the present e ort is to show that the classical BBGKY hierarchical equation, for the n-particle reduced distribution function, is the ancestor of the n-particle Schrodinger equation. On the other hand we show that within the scenario of the subquantum structure of quantum particle, the Fisher information measure emerges naturally in quantum mechanics.

In ref. [1], it is shown that quantum mechanics can be obtained in a self-consistent scheme of an entirely classicalm any body physics. W ithin this fram ework the mean features of quantum mechanics (i.e. the probabilistic nature of the quantum description, the quantum potential, the Schrodinger equation, the quantum operators, the Heisenberg uncertainty principle) were obtained starting from a classical subquantum kinetics in the phase space and without invoking any additional principle. Furtherm ore the fundam ental constant h em erges naturally as an integration constant and represents a free parameter for the theory. Within this theory, the astonishing scenario of a subquantum structure for the quantum particle em erges spontaneously. The quantum particle turns out to have an internal structure and a spatial dispersion and appears to be composed by N identical point like and interacting subquantum objects, the monads, obeying to the law s of New tonian physics. The theory can be viewed as describing a mechanism which permits to construct the quantum particle starting from its constituents and then quantum mechanics appears to describe a physical reality.

The statistical ensemble of these N monads is described in the phase space through the distribution function f = f(t;x;v) whose time evolution is governed by the kinetic equation L f = C(f), being L the Liouville operator and C(f) the collision integral that takes into account the intermonad interactions. We don't make any assumption about the structure of the collision integral and the nature of the interaction between the monads except that, during the point-like collisions the monad number, momentum and energy are conserved. The projection of the above phase space kinetics into the physical space produces a hydrodynamics which naturally leads to the one particle spinless quantum mechanics when the external force eld is conservative.

Recently in ref. [2], it is shown that the above kinetic

approach can be easily adopted to treat the quantum particle with spin in an external electromagnetic eld. Of course in this way the spinning quantum mechanics can be obtained.

The energy conservation during the collisions considered in the present scheme plays a very important role and could be also taken into account in the stochastic models of quantum mechanics as it has been recently observed in ref. [3].

A question which naturally arises at this point is if it is possible to extend the kinetic formalism of ref. [1] in order to treat non relativistic many particle quantum system s. This point is neglected in the literature where almost the totality of works devoted to the derivation and interpretation of quantum mechanics concern the single particle.

The main goal of the present paper is to show that it is possible to obtain, within the theory developed in ref. [1] and without any additional assumption, also the n-particle quantum mechanics starting from the classical kinetics governed in the phase space by the BBGKY hierarchy.

BBGKY Hierarchy: Let us consider a statistical ensemble constituted by N identical and indistinguished point-like particles (monads) obeying the laws of classical physics. It is well known that the n-particle reduced distribution function $f_n = f_n(t; x_1; v_1; x_2; v_2; ...; x_n; v_n)$ obeys the following BBGKY hierarchical evolution equation [4]

 $C_i(f_{n+1})$ are the collision integrals which can be expressed in term of the function f_{n+1} . The assumption that during the point-like collisions the monad number,

Let us consider the 6n-dimensional phase space (x,v) being $x=(x_1;x_2;:::;x_n)$ and $v=(v_1;v_2;:::;v_n)$. We introduce the two gradient operators $\theta=\theta x=(\theta=\theta x_1;\theta=\theta x_2;:::;\theta=\theta x_n)$ and $\theta=\theta v=(\theta=\theta v_1;\theta=\theta v_2;:::;\theta=\theta v_n)$. Then we do not the 3n-dimensional force $F=(F_1;F_2;:::;F_n)$ which can be derived from a potential

The BBGKY hierarchical equation (1), governing the evolution of the n-particle reduced distribution function $f_n = f_n(t;x;v)$, can be written in the following compact form

as one can verify im mediately starting from Eq. (3).

Hydrodynam ics: We consider now the projection of the kinetics from the 6n-dimensional phase space into the 3n-dimensional space of the coordinates x, where the system is described through the distribution function $_n$ (t;x) = f_n (t;x;v) d^{3n} v. A fler recalling that the total value of a given physical quantity with density A = A (t;x;v)

can be calculated as $A f_n d^{3n} v d^{3n} x$ we de ne the mean value of A in the point x through

This mean value represents the density of A in the space of the coordinates and perm its to write the total value of A as $_{\rm n}$ < A > $_{\rm v}$ d³ⁿx. We do not the densities in the space of the coordinates for some quantities used in following. The densities of current, of stress tensor and of heat ux vector are do ned, respectively, by

U sing the standard procedure consisting in multiplying Eq. (5) by the three collision invariants g_k (v) and integrating with respect to v, the three following hydrodynamic equations can be obtained [5, 6]:

and $s_i = E u_i + i_j u_j + h_i$ is the energy ux density vector. Eqs (14)-(16) de ne the most general hydrodynam ics of the particle system which behaves in the physical space as a uid. In particular Eq. (16) in poses the conservation of the total energy H of the system

A fler recalling that the external force F is conservative, from Eq. (15) it follows in m ediately that the irrotationality of u in plies the conservativity of F and viceversa, namely

Quantum potential: From the two expressions of the force F given by Eq.s (17) and (20) it follows in mediately

with = \ln_n . Note that Eq. (22) descends from the requirement that the force F is conservative and can be

viewed as a condition constraining the forms of W and $_{jk}$ which result to be two functionals of the eld . The solutions of the latter equation are couples of W and $_{jk}$ and in principle there can exist more than one solution. Even though it can appear that Eq. (22) contains considerable degrees of freedom , in the following we will show that the particular structure of this equation restricts strongly the number of its solutions.

We suppose now that just as the left hand side, both the rst and the second term in the right hand side in Eq. (22) are curl free and will take the form $\mbox{0}$ (:::)= $\mbox{0}x_j$. This requirement for the rst term can be satis ed in two dierent ways. The rst and most natural way is related to the choice $j_k = j_k$. A Iternatively we can pose $j_k = \mbox{0}a_k = \mbox{0}$

C learly the two terms in the right hand side of Eq. (25) must be curl free. These requirements in pose the two following conditions

From this last equation we can obtain the expression of W while Eq. (23) gives the expression of $_{ij}$. Finally, we can write the most general solution of Eq. (22) under the form

The above expressions of $_{jk}$ and W de ne a family of solutions of Eq. (22) and represent the hydrodynamic constitutive equations for the system . Remark that these equations have been enforced exclusively from the fact that the internal stress forces are conservative.

In the above constitutive equations the terms containing U describe the standard classical Eulerian u.id. For instance the nonlinear potential U ($_{\rm n}$) = a $_{\rm n}$ appearing in the so called cubic non-linear Schrodinger equation is originated from the stress tensor $_{\rm jk}=\frac{1}{2}\,a_{\rm n}$ $_{\rm jk}$. A nalogously the logarithm is non-linearity U ($_{\rm n}$) = bln $_{\rm n}$ in the Schrodinger equation is originated from a constant stress tensor $_{\rm jk}$ = b $_{\rm jk}$.

In the following, we pose U=0 and focalize our attention to the term of Eqs (29) and (30), proportional to the arbitrary constant c, which is absent in classical kinetics. From the dentition of the total internal energy, it results that $H=d^{3n}x_n$ " > 0. Starting from Eq. (29) and performing an integration by parts, we obtain H=c $d^{3n}x$ (0 $_n=0x$) $_n^2=1$. Then we pose c=2=4 in order to put H>0. The real positive constant remains a free parameter of the theory.

We introduce the normalized n-particle reduced distribution function $%_n = {}_n = N$ being $N = {}_n d^{3n}x$, so that $%_n d^{3n}x = 1$. Then we dene the mass m = N the internal potential W = N W and set h = N. From (30) follows the expression of W

W e recall that the potential W given by Eq. (31) is the quantum potential (M adelug 1926) [7,8] and it is rem arkable that here it has been obtained in the fram ework of an entirely classical subquantum kinetics. Note that the subquantum m onad structure of the system generates the stress forces and then the potential W . C learly when this structure is suppressed the quantum potential vanishes. Furtherm ore the presence of the collision integrals C_i in the BBGKY kinetic Eq. (1) which take into account the monad interactions are necessary for the consistency of the theory.

M any particle Schrodinger equation: We do not the external potential V = NV, and set S = NS. Now the quantum—uid is described completely by the two scalar elds $\$_n$ and S whose evolution equations are (32) and (33), respectively.

The total energy H given by Eq. (18) results to be the sum of two term s: $H = H^{(cl)} + H$. The rst term

corresponds to the energy of n interacting classical particles while the second term $H = \prod_n d^{3n} x$ is originated by the internal structure of the n bodies and is given by

Eq. (37) hints on the existence of a tight link between quantum mechanics and Fisher information theory. It is remarkable that H results to be proportional to the Fisher information measure I (Fisher 1922) which describes an important feature of quantum mechanics [9, 10, 11, 12]. Once again, within the scenario of the subquantum structure of quantum particle, another basic physical concept, namely I, emerges naturally. In the present context I has a very transparent meaning being simply a measure of the internal energy of quantum system. The fact that H is originated from the internal structure of the n-bodies becomes more transparent if we observe that H can be written also as

O fcourse starting from $H = H^{(cl)} + H$ and taking into account Eq.s (35) and (36) one obtains in mediately the well known expression of the Hamiltonian of the n-particle quantum mechanics

In the present picture the mass of the n-body quantum system is M=nm. A filer recalling that m=N follows im mediately that the system is composed by N=nN monads

Conclusions: The approach used here to obtain the Schrodinger equation for a system of n quantum particles starting from the BBGKY hierarchy describing a statistical system of N = nN subquantum monads, suggests that quantum mechanics can be viewed as a hidden variables theory. This approach can be used easily also to construct the non linear quantum mechanics [it is enough to consider U $\stackrel{\leftarrow}{\bullet}$ 0 in Eqs (29), (30)] and then for study the non lineare ects originated for instance from the particle bosonic or ferm ionic nature [13, 14].
