# B B G K Y H ierarchy U nderly ing M any Particle Q uantum M echanics

#### Abstract

Recently, the one particle quantum mechanics has been obtained in the fram ew ork of an entirely classical subquantum kinetics. In the present paper we argue that, w th in the sam e schem e and w ithout any additional assum ption, it is possible to obtain also the $n$-particle non relativistic quantum $m$ echanics. The $m$ ain goal of the present e ort is to show that the classicalBBGKY hierarchical equation, for the n-particle reduced distribution function, is the ancestor of the n-particle Schrodinger equation. On the other hand we show that within the scenario of the subquantum structure of quantum particle, the $F$ isher inform ation $m$ easure em erges naturally in quantum $m e-$ chanics.

In ref. $\overline{[1]}]$, it is show $n$ that quantum $m$ echanics can be obtained in a self consistent schem e of an entirely classicalm any body physics. W th in this fram ew ork the m ean features of quantum $m$ echanics (i.e. the probabilistic nature of the quantum description, the quantum potential, the Schrodinger equation, the quantum operators, the H eisenberg uncertainty principle) were obtained starting from a classical subquantum kinetics in the phase space and w thout invoking any additional principle. Further$m$ ore the fundam ental constant $h$ em erges naturally as an integration constant and represents a free param eter for the theory. W thin this theory, the astonishing soenario of a subquantum structure for the quantum particle em erges spontaneously. The quantum particle tums out to have an intemalstructure and a spatialdispersion and appears to be com posed by N identical point like and interacting subquantum ob jects, the m onads, obeying to the law s of $N$ ew tonian physics. The theory can be view ed as describing a m echanism which perm its to construct the quantum particle starting from its constituents and then quantum $m$ echanics appears to describe a physical reality.
$T$ he statistical ensemble of these $N \mathrm{~m}$ onads is described in the phase space through the distribution function $f=f(t ; x ; v)$ whose time evolution is govemed by the kinetic equation $L f=C(f)$, being $L$ the Liouville operator and $C$ ( $f$ ) the collision integral that takes into account the interm onad interactions. $W$ e don't $m$ ake any assum ption about the structure of the collision integral and the nature of the interaction betw een the $m$ onads except that, during the point-like collisions the $m$ onad num ber, $m$ om entum and energy are conserved. T he projection of the above phase space kinetics into the physical space produces a hydrodynam ics which naturally leads to the one particle spinless quantum $m$ echanics $w$ hen the extemal force eld is conservative.

Recently in ref. [2], it is show $n$ that the above kinetic

[^0]approach can be easily adopted to treat the quantum particle with spin in an extemal electrom agnetic eld. $O$ f course in this way the spinning quantum mechanics can be obtained.

The energy conservation during the collisions considered in the present schem e plays a very im portant role and could be also taken into account in the stochastic m odels of quantum m echanics as it has been recently observed in ref. $\left.\bar{\beta}_{1}^{\prime}\right]$.

A question which naturally arises at this point is if it is possible to extend the kinetic form alism of ref. [1] [1] in order to treat non relativistic $m$ any particle quantum system S . This point is neglected in the literature where alm ost the totality of w orks devoted to the derivation and interpretation of quantum $m$ echanics concem the single particle.

The $m$ ain goal of the present paper is to show that it is possible to obtain, w ithin the theory developed in ref. []$\left._{1}^{1}\right]$ and w thout any additional assum ption, also the $n$-particle quantum $m$ echanics starting from the classical kinetics govemed in the phase space by the BBGKY hierarchy.

BBGKY H ierarchy: Let us consider a statistical ensemble constituted by N identical and indistinguished point-like particles ( $m$ onads) obeying the law s of classical physics. It is well known that the n-particle reduced distribution function $\mathrm{f}_{\mathrm{n}}=\mathrm{f}_{\mathrm{n}}\left(\mathrm{t} ; \mathrm{x}_{1} ; \mathrm{V}_{1} ; \mathrm{x}_{2} ; \mathrm{V}_{2} ;:: ; ; \mathrm{X}_{\mathrm{n}} ; \mathrm{V}_{\mathrm{n}}\right)$ obeys the follow ing BBGKY hierarchicalevolution equation [4]

H ydrodynam ics: W e consider now the pro jection of the kinetics from the $6 n$-dim ensionalphase space into the $3 n-$ dim ensional space of the coordinates $x$, where the system is described through the distribution function ${ }_{n}(t ; x)=$
$f_{n}(t ; x ; v) d^{3 n} v$. A fter recalling that the total value of a given physical quantity $w$ ith density $A=A(t ; x ; v)$ can be calculated as $A f_{n} d^{3 n} v d^{3 n} x$ we de ne the $m$ ean value of $A$ in the point $x$ through

viewed as a condition constraining the form $S$ of $W$ and $j k$ which result to be two functionals of the eld. The solutions of the latter equation are couples of W and jk and in principle there can exist $m$ ore than one solution. Even though it can appear that Eq. (22́ㅡ) contains considerable degrees of freedom, in the follow ing we w ill show that the particular structure of this equation restricts strongly the num ber of its solutions.

W e suppose now that just as the left hand side, both the rst and the second term in the right hand side in Eq. (22근) are curl free and will take the form @ (:: $)=@ x_{j}$. $T$ his requirem ent for the rst term can be satis ed in two di erent ways. The above expressions of $j k$ and $W$ de ne a fam ily of solutions of Eq. (22') and represent the hydrodynam ic constitutive equations for the system. Rem ark that these equations have been enforced exclusively from the fact that the intemal stress forces are conservative.

In the above constitutive equations the term s containing $U$ describe the standard classical Eulerian uid. For instance the nonlinear potential $U\left({ }_{n}\right)=a_{n}$ appearing in the so called cubic non-linear Schrodinger equation is originated from the stress tensor $j k=\frac{1}{2} a_{n}{ }_{j k}$. Analogously the logarithm ic non-linearity $U\left({ }_{n}\right)=b l_{n}$ in the Schrodinger equation is originated from a constant stress tensor ${ }_{j k}=\mathrm{b} \mathrm{jk}^{\mathrm{k}}$.

In the follow ing, we pose $\mathrm{U}_{-}=0$ and_focalize our attention to the term of Eqs $\left(2 \overline{2}_{1}^{\prime}\right)$ and $\left(\overline{3}^{3} \bar{O}_{1}\right)$, proportional to the arbitrary constant c , which is absent in classical kinetics. From the de $\mathrm{n}_{\mathrm{R}}$ tion of the total intemal energy, it results that $H=d^{3 n} x_{n} ">0$. Starting from Eq. (2 $\underline{2}_{1}^{\prime}$ ) and ${ }_{\mathrm{R}}$ perform ing an integration by parts, we obtain $H=c \quad d^{3 n} x\left(@_{n}=@ x\right)^{2}={ }_{n}$. W e recall that the potentialW given by Eq. ( $\left.\bar{\beta}_{\mathbf{1}}^{\mathbf{1}}\right)$ is the quantum potential ( $M$ adelug 1926) "[7, ', ', '1] and it is rem ankable that here it has been obtained in the fram ew ork of an entirely classical subquantum kinetics. $N$ ote that the subquantum $m$ onad structure of the system generates the stress forces and then the potentialW. C learly when this structure is suppressed the quantum potential vanishes. Furthem ore the presence of the collision integrals $C_{i}$ in the BBGKY kinetic Eq. (11) which take into account the $m$ onad interactions are necessary for the consistency of the theory.

M any particle Schrodinger equation: W e de ne the extemal potential $\mathrm{V}=\mathrm{NV}$, and set $\mathrm{S}=\mathrm{N} S$. N ow the quantum uid is described com pletely by the two scalar elds $\%_{n}$ and $S$ whose evolution equations are (32) and (33), , respectively.

Eq. [ $\overline{3} \overline{7} \overline{1})$ hints on the existence of a tight link between quantum $m$ echanics and $F$ isher inform ation theory. It is rem arkable that $H$ results to be proportional to the $F$ isher in form ation $m$ easure I ( $F$ isher 1922) which describes an important feature of quantum $m$ echanics
 subquantum structure of quantum particle, another basic physical concept, nam ely I, em erges naturally. In the present context I has a very transparent $m$ eaning being sim ply a $m$ easure of the intemal energy of quantum system. The fact that $H$ is originated from the intemal structure of the $n$-bodies becom esm ore transparent ifwe observe that $H$ can be w ritten also as

In the present picture the $m$ ass of the $n$-body quantum system is $M=n m$. A fter recalling that $m=N$ follow $s$ im m ediately that the system is com posed by $N=n N$ m onads.

Conclusions: The approach used here to obtain the Schrodinger equation for a system of $n$ quantum particles starting from the BBGKY hierarchy describing a statisticalsystem of $N=n N$ subquantum monads, suggests that quantum $m$ echanics can be view ed as a hidden variables theory. This approach can be used easily also to construct the non linear quantum $m$ echanics [it is enough to consider $U \in 0$ in E qs $\left.(2 \underline{d}),\left(30_{1} 0_{1}\right)\right]$ and then for study the non lineare ects originated for instance from the particle bosonic or ferm ionic nature $\left[13^{1}, 1\right]$
