Orthopositronium: Annihilation of Positron in Gaseous Neon'

A bstract

On the basis of phenom enological model of the orthopositronium annihilation isotope anomaly in gaseous neon (lifetime spectra, positrons source 22 Na) the realistic estimation of an additinal mode (0.2%) of the orthopositronium annihilation is received.

received for halfa century of making of these measurements, the experimental situation for gaseous neon proved to be unique [1, 2].

In a method of delayed $_n-_a$ -coincidences (lifetime method) the appearance of positron in substance is registered by nuclear $_n$ -quantum (start)

The counter, developing signal stop', registers not only $_a$ -quantum (with energy 0.5 MeV) but also $_n$ -quantum (1.27 MeV) with recording e ciency

respectively, and the relation of random (R) and true (C) coincidences looks like [2]

where Q (s 1) is the power of the positron source, is the resolving time of the coincidence circuit, $"_1$ the recording e ciency for quanta entering the counter, and m_2 is the mean solid viewing angle of counter in conditions of bad' geometry.

The annihilation $_{\rm a}$ -quanta are registered in conditions of bad' geometry, as the annihilation acts occurs in all volume of gas, unlike nuclear $_{\rm n}$ -quanta outgoing from the centre of volume, where the source of positrons is lokated.

As the rate of occurrence of the marking 'start' $_{\rm n}$ -quantum (1/) is more than the order higher than the rate of the fastes processes of positrons annihilation in substance, the correctness and accuracy of the lifetime method are not to be doubted.

Nevertheless once this common rule was broken in our article [2] (its title is repeated in the title of this paper). In this article the results of a number of measurements executed in the USA, England, Canada and in Russia (Institute of Chemical Physics, Russian A cademy of Sciences, Moscow) are generalized, and for the rst time the attention is paid to speci c features of the positron annihilation lifetime spectra in the area of the so called 'shoulder' in gaseous neon as compared with other inert gases. Collectivization of nuclear excitation ²² Ne (2⁺) was assumed by us in conditions of experiment in the m acroscopic group of identical nuclei (22Ne) | like the nuclear gamma-resonance (NGR) as in the natural mixture of the neon isotopes $(^{20}Ne^{21}Ne^{22}Ne)$ contains about 9% ²²Ne and then in such collective of nuclei it is impossible to specify a location of a nucleus, which em its n-quantum registered by the counter ('start'). On this basis the explanation of the phenom enon of smoothing the shoulder in neon was o ered, which according to this version is caused by uncontrollable grows of a background of random coincidance because of realization in neon of a condition of bad' geom etry also for nuclear n-quantum. The paradox of this assumption, so long as the manifestation of NGR is supposed to occur in gas (similar scattering of -quanta, without recoil of the radiating and absorbing nuclei, is possible only in a solid state the Mossbauer e ect), was attributed to peculiarity of a nal state of +-decay of nucleus 22 N a as far back as on the initial stage of a study of the phenom enon of smoothing of a shoulder in neon [3]. We would like to notice that a year ago, on the occasion of the flieth anniversary of the hypothesis of W Pauli about neutrino, B. Pontecorvo has marked: :::huge grows of neutrino physics, which became a quantitative science, healthy and powerful and nevertheless perm it a quantitative unexpectedness' [4]. Development of this thesis in works [5, 6], in view of the newest experimental data and the other technique of 'start' registration, based on the initial site of track of positron from +-decay ²²Na or ⁶⁸Ga, allowed us to attribute form ation of macroscopic collective /resonance/ nuclear state (MCN/R/S) to the specic quality of +-decay of nuclei of this type $J = 1^+$ (with a change of a spin on 1 and conversation of parity), which should be considered as topological quantum transition [5,7] in limited volume' of space-time.

Earlier, as a result of taking into account all manifestations of positron annihilation species features in gaseous neon, it became clear, that the shoulder in neon can be in uenced also by annihilation of orthopositronium (spin S= 1, triplet state 3 (e⁺ e)₁, symbol T Ps, $_T$ ' 140 ns) [8], while short living parapositronium (spin S= 0, singlet state 1 (e⁺ e)₀, symbol S Ps, $_S$ ' 125 ps) can not exert such in uence, as it is registered by the device with resolving time 0:1 Ins near interval of time t 0 (peak

of instant coincidence). On this basis was constructed phenom enological model of this phenom enon and parametrization of lifetime spectra of positron (orthopositronium) annihilation in gaseous neon was received [3].

This point of view received additional stimuli in the results of precise measurements of the orthopositronium annihilation rate ($_{\rm T}$ = 1= $_{\rm T}$), executed by a group of Michigan University (Ann Arbor, USA | A.Rich, D.W. Gidley, and co-workers) [9], which were con rmed and specied in the second half of 1980s with use of two dierent techniques of Start' registration [10, 11, 12]. In these works the excess of experimental meaning of the self-annihilation (3 $_{\rm a}$ -annihilation) $^{\rm T}$ Ps rate $_{\rm T}$ (obs.) over the meaning calculated in quantum electrodynamics (QED)

Coming back to features of lifetime spectra in neon, we shall notice that the estimations ranges of the quantity 10^4 n 10^6 of nuclei collective $^{22}{\rm N\,e}$, sustaining nuclear excitation $^{22}{\rm N\,e}$ (2⁺) in a nal state of $^+$ -decay $^{22}{\rm N\,a}$, is made in [3] on the basis of a hypothesis about NGR of $_{\rm n}$ -quantum within MCN/R/S with taking into account insigni cance of internal conversion factor and within insigni cance of pair conversion factor for transition $^{22}{\rm N\,e}$ (2⁺)! $^{22}{\rm N\,e}$ (0⁺). This estimation is supported and speci ed in paper [5] on the basis of other reasons

 $(\bar{n}=5.2780)$ 140 is the complete number of nuclei MCNS, and is the share of isotope 22 Ne in natural neon), developing an idea of $^+$ -decay of nuclei like 22 Na as topological quantum transition:

about connection of the orthopositronium with in irror Universe' [13], in which from the point of view of the common observer the antipode symmetry' of energy and action is realized [14], and

about complete degeneration of ortho- and parasuperpositronium in N=2 supersymmetric QED (N=2 SQED) [15].

Experim ental supervision of dependence of characteristic sites of lifetime spectra on gaseus neon isotope composition [16] ('isotope anomaly' [5]) has con rmed all preconditions of the phenomenology [3]. Let's consider 'shift' (as a result of double supertransformation | from fermion to boson and back to fermion¹ | a particle is transferred in other point of space [17]) in quality of a 'lattice constant' of cellular, crystal like structure of limited volume non-trivial space topology in a nal state of '-decay, and we identify it to the orthopositron ium oscillation between our Universe and

In irror Universe', which explains ' $_{\rm T}$ -anomaly' by 2+1-splitting 3 $_{\rm a}$ -annihilation of the orthopositronium $^{\rm T}$ P s! $_{\rm a}$ =2 $^{\rm 0}$ into a single observable $_{\rm a}$ -quantum (1:022 M eV) and two not observable mirror quanta (with total energy 3:6 $^{\rm 10}$ eV [5]). O ver last years the qualitative substantiation of 2+1-splitting 3 $_{\rm a}$ -annihilation of the orthopositronium with participation of the mirror Universe' has been received by the method of chronometric invariants (physical observable values) in generalized 4-dimensional space-time, the special case of which is the space-time of the General Theory of Relativity [18].

The structure of MCN/R/S includes an insigni cant share of nuclei of atom s $\bar{n}=5.2780$ 10 from their complete number 5 10 in volume of gas $V_g=\frac{4}{3}$ R $_g^3$ cm 3 (R $_g$ ' 2 cm is a radius of the measuring chamber) at pressure 50 75 atm. We receive an experimental estimation of the MCNRS lattice constant'

This estimation is comparable with virtual fundamental length ('shift')

caused by exchange interaction, the so-called 'annihilation interaction' bringing to energy increase of the ortopositronium ground state on size $\frac{3}{7}$ W ' 3:6 10^4 eV ('hew force of the annihilation' [19], W is the hyper ne splitting of the ortho- and parapositronium). In terms of physics it means, that the attraction between electron and positron in 'Ps is weakened, because for a time $\frac{h}{\frac{3}{7}}$ W' 2 ps they stay in the form of one virtual photon. This fact can be interpreted as in possibility to locate 'Ps within the limits of volume, smaller than '3. Therefore radius MCNS r_c we shall determine from equality

The form ation of MCN/R/S, having m acroscopic radius r_c ' 128 cm, occurs as the consequence of long-range action for baryon charge: the nontrivial topology of limited volume of space-time in a nal state of $^+$ -decay means occurrence in a lattice units the baryon charge B (its carrier is a proton | p; the nuclei of substance atoms interact with it by exchange), compensated by hole B (P) with negative mass in the mirror Universe (antipode symmetry [14]), with which substance does not interact.

For nding out coordination of the concept MCN/R/S we consider initial phenomenological model [3] in approximation of repeatedly resonant scattering of $_{\rm n}-$ quantum with resonant cross section

where $f_M = \exp\left[-4^{-2} \frac{\sqrt{x^2}}{2}\right]$ is the M ossbauer factor (x^2 is a root-m ean-square displacement of a nucleus ^{22}Ne in a direction of $_n$ -quantum), = 2 hc/E $_n$ is length of a wave of $_n$ -quantum, I_0 and I_1 are the spins of ground and exited states of ^{22}Ne . As

in M C N/R/S the root-m ean-square displacem ent of a nucleus has the radius of nuclear forces action (2{3}) 10^{3} cm ('isotope anomaly' [5]), and 10^{-10} cm, then the M ossbauer factor gets the maximum value $f_{\rm M}=1.$ W e should remind here, that from middle 1980s up to middle 1990s a hypothesis about stationary long-range action for baryon charge (so-called 'fith force') was studied and is not con rmed by experiment, but this does not a ect non-stationary aspect of similar non-electrom agnetic long-range action in a nal state of '-decay.

Thus, resonant cross section $_{\rm r}$ ' 7.5 $_{\rm 10^{21}~cm^2}$. It is easy to receive an estimation of Yength of resonant run' of $_{\rm n}$ -quantum between two consecutive acts of resonant scattering on nuclei $^{22}{\rm Ne}$ in MCNRS, as $f_{\rm M}=1$ (the exact resonance) means, that length of run can be estimated as for gas of elastic spheres

where is a concentration of an isotope $^{22}{\rm Ne}$ in natural neon at pressure p 50 atm . The received estimation seems to exclude consecutive realization of the concept MCNRS, because with dense cell packing in structure of MCNRS the parameter of packing 1=12 ' 0.083 is close to a share of an isotope $^{22}{\rm Ne}$ in natural neon (' 0.09), i.e.: distance between two nuclei $^{22}{\rm Ne}$ on the way of $_{\rm n}$ -quantum equal to 2 ' 0.11 cm , and on the order less than $l_{\rm n}$. But it is necessary to take into account the speci c feature of kinetics of elementary processes in MCNRS, instant participation in resonant scattering of $_{\rm n}$ -quantum n = $\bar{\rm n}$ ' 0.5 10 nuclei $^{22}{\rm Ne}$, like in parallel chemical reactions, i.e.: m acroscopic resonant cross section grows n-multiple: $_{\rm n}$ = n $_{\rm r}$.

For the majority of the researchers, both theoretists and experimenters, the problem of orthopositronium arose only in the second half of 1980s, after numerous conmations and specification [10, 11, 12] of the first observation by Michigan group of a discrepancy between theory and experiment [9]. The next decade passed in intensive search of the solution of the problem, but it was not found. From middle 1990s, when it seemed that all experimental and theoretical ideas were exhaused in these researches there came a pause. In the last years the interest in this problem has revived again [20, 21]. But a suggestion about single-quantum annihilation of TPs [22] with participation of the mirror Universe' [5, 23] has not been investigated in experiment.

The above analysis of 'isotope anomaly' in neon allows to proceed to estimation of an additional mode of single-quantum annihilation ^TPs. Let's consider the result of work [24], in which the probability of the ^TPs annihilation on one a-quantum and neutral supersymmetric gauge boson U with spin 1 is calculated:

where $x = (m_U = m_e)$! 0. An explanation of `_T = anomaly' (0.2%) lacks 4{5 orders. But it is already clear, that in MCNS due to single-quantum virtual annihilation take place the oscillations TPs TPs 0 between our Universe and the in irror Universe' (there and back', with shift [5, see footnote (1)], i.e. occurs incoherent interaction TPs 0 with \bar{n} units' of space-like structures MCNS, and hence multiple sum mation

sim ilar in all others attitudes to mode (6). Here mass M in (7) has a secondary origin: it is formed in gas on \bar{n} units of MCNS, having an a nity to baryon charge of atom ic nuclei.

Nevertheless there are some more disculties: rst, earlier in experiment was received the estimation of the top limit of the probable contribution of the $^{\rm T}$ Ps single-photon annihilation 4 10% [25]; secondly, from the point of view of phenomenological model based on results of supersymmetric consideration of the orthopositronium problem [5, 15, 24], a single-photon mode of orthopositronium annihilation (three photon mixed $_{\rm a}$ =2 $^{\rm O}$) does not agree with symmetry, because photon propagates in a certain direction as the atwave, i.e. the central symmetry of space is broken.

The way out of this critical situation was prepared before discovery of supersym — metry by de nition of notoph [26]: contrary to mass-bearing particles, helicity (projection of full angular momentum on a direction of movement) is relativistic invariant for zero-mass particles. Under discussion in a massless particle with zero helicity com — plementary to photon according to its properties (helicity is equal to 1) and therefore referred to as hotoph'. In interactions notoph similar to photon bears spin 1. Notoph is described by antisymmetric tensor potential, while the eld strength is a 4-vector (instead of vector potential and tensor of electromagnetic eld strength):::when discussing new particles and their interactions we should take notoph into account:::'.

Helicity of notoph is equal to zero, i.e. it propagates as a spherical wave. Thus, experimental task of search of single-photon annihilation ${}^{T}Ps={}^{T}Ps^{0}$! ${}_{a}=2$ 0 is transformed to search of single-notoph annihilation ${}^{T}Ps={}^{T}Ps^{0}$! ${}_{a}=2$ 0 , and it changes the technique of experiment. In measurements [1, 9, 10, 11, 12, 16, 25] were xed not only time and power correlations of -quanta, but also spatial arrangement of detectors, which breaks angular isotropy of measurements. For an establishment of the contribution of supersymmetric single-notoph mode of ${}^{T}Ps={}^{T}Ps^{0}$ annihilation the technique ensuring 4 -geometry of detecting notoph is needed. In work [21] it is suggested that the technique which was used in work [27] should be improved to achieve higher sensitivity. A coording to the authors of work [21] for realization of reliable measurements of the contribution of a mode ${}^{T}Ps!$ ${}^{T}Ps^{0}$ in conditions of vacuum the increase of 4 -calorimeters sensitivity is necessary.

In our suggestion which takes into account also 'isotope anom aly' of orthopositronium, it is necessary to allocate expected e ect at E $_{\rm a}$ ' $2{\rm m\,_e}c^2$ on a background of peak of complete annihilation energy 1:022 M eV, instead of at E $_{\rm a}$ ' 0, as in work [27] and as it is o ered in [21].

The o ered here way of the ortopositronium problem decision summarizes supervision, phenomenology and experimental results submitted in our publication for 25 years, and is in essence complete substantiation of decisive experiment for search single-notoph annihilation ${}^{T}Ps={}^{T}Ps^{0}!$ ${}_{a}=2$ 0 . It is based on the ideas which have arisen on brossing of of nuclear-physical directions and techniques of researches of a chemical kinet-

ics and a structure of substance | the 'positronics' and gam ma-resonance spectroscopy, | created in the beginning 60s in Institute of Chem ical Physics by V. I. Goldanskii with co-workers. The author is grateful to memory of the Academician Vitalii Iosifovich Goldanskii for support of these publications, which stimulated statement of critical experiment, for organizational support of experimental work [16] and for the shown interest to coming-to-be of this direction of the orthopositronium dynamics researches.
