C onditional generation of arbitrary multimode entangled states of light with linear optics

W e propose a universal scheme for the probabilistic generation of an arbitrary multim ode entangled state of light with nite expansion in Fock basis. The suggested setup involves passive linear optics, single photon sources, strong coherent laser beam s, and photodetectors with single-photon resolution. The e ciency of this setup m ay be greatly enhanced if, in addition, a quantum m em ory is available.

I. IN TRODUCTION

The generation of nonclassical states of light is one of the prim ary research areas in quantum optics. In particular, the preparation of entangled states of light has attracted a considerable am ount of attention recently, since these states have been identi ed as a key resource for quantum information processing [1]. O ther interesting applications of the entangled states include, for instance, ultra-high precision measurements [2, 3, 4, 5] and quantum optical lithography [6, 7, 8].

The range of interactions between light elds that are experimentally accessible and feasible is rather limited, which restricts the class of quantum states of the optical eld that can be generated in the lab. However, this class can be signi cantly extended if one considers probabilistic generation schemes, whose success is conditioned on the detection of a particular outcome of a measurement performed on some ancilla system. Schemes for probabilistic preparation of Fock states [9], arbitrary superpositions of Fock states of single-mode eld [10, 11], and superpositions of classically distinguishable states (Schrodinger-cat-like states) [12, 13], have been found. Several setups for the generation of twomode N -photon path-entangled states have been suggested [14, 15, 16, 17, 18]. Recently, the experimental conditional preparation of a single-photon Fock state with negative W igner function has been reported [19].

However, all the above mentioned schemes are still quite restrictive since they are capable to prepare only single-mode states or only a particular class of two-mode states (such as the N-photon states). In this paper, we design a truly universal scheme that can be used to probabilistically generate an arbitrary multimode entangled state of light, provided that each mode does not contain more than N photons, where N is an arbitrary but nite integer. The resources required for the present scheme comprise the passive linear optical elements (beam splitters and phase shifters), single photon sources, strong coherent laser beam s, and photodetectors. It was shown recently that these resources are su cient for perform ing universal quantum computing [20, 21, 22, 23, 24, 25]. O urproposal provides another illustration of the surprising versatility and power of such an approach, relying only on linear optics and single photons. In this context it is worth mentioning that, very recently, C lausen et al. suggested a scheme for approximate conditional implementation of general single- or multiment of operators acting on states of traveling optical eld [26]. The scheme described in [26] is also based on linear optics and may be in principle used for (approximate) quantum state preparation. We emphasize that the approach proposed in the present paper conceptually diers from that of Ref. [26]. We are primarily interested in exact state preparation and our setup is speci cally tailored for that purpose.

We will rst explain all the essential features of the state-preparation procedure on the sim plest yet nontrivial example of two-mode entangled state that is form ed by a superposition of two product states,

where N is a norm alization factor. Then we will generalize the preparation procedure and design a scheme for the generation of arbitrary multim ode entangled states of light. We note in passing that even the simple entangled states (1) may not applications in the investigations of the foundations of quantum mechanics. For instance, it was shown recently that the states of the form (1) yield a strong violation of Bell-CHSH inequalities when A lice and B ob perform balanced hom odyne measurements followed by an appropriate binning [27].

The paper is structured as follows. In Section II, we propose a method to probabilistically generate the twomode entangled state (1) with the help of passive linear optics, single photon sources, strong coherent laser elds and photodetectors. In section III we shall extend our scheme to allow form ore than two modes and more than two terms in the superposition. We will thus design a universal device that enables one to conditionally prepare an arbitrary multimode state of light. Finally, the conclusions are drawn in Section IV.

II. CONDITIONALGENERATION OF TW O M ODE ENTANGLED STATES

Let us rst note that, in order to simplify the notation, we shall om it the norm alization factors in front of the quantum states in what follows.

Since the state j i_{AB} is rather complicated, we divide its preparation into several steps. The main simpli cation stems from the observation that the entangled state (1) can be prepared by m eans of entanglem ent sw apping [28, 29, 30] if we possess the two three-m ode states




FIG.1: Schem atic of the setup for the generation of the entangled state (1) via entanglem ent swapping. The two modes emerging from the QND measurement devices are combined on a balanced beam splitter and the swapping succeeds when each photodetector PD detects exactly one photon. The boxes denoted A lice and B ob correspond to the setup depicted in Fig. 2 and W P denotes a waveplate.

where j V i and j H i denote the state of a single photon in spatialm ode A_2 (or B_2) that is polarized vertically or horizontally, respectively. As shown in Fig. 1, we easily obtain the state (1) from the state j $i_A j \,^0 i_B$ if we project the single photons in spatialm odes A_2 and B_2 onto the m axim ally entangled B ell state

The generation of state (1) thus boils down to the preparation of the entangled state (2). [State (3) can be prepared sim ilarly]. This latter task will be accomplished with the help of a quantum non-dem olition (QND) measurem ent of a single photon, which creates entanglem ent.

A. QND measurement




FIG.2: The setup for the conditional generation of the entangled state (2). The polarizing beam splitter PBS₁ transm its vertically polarized photons and re ects horizontally polarized ones. The box labeled as QND performs the quantum non-demolition measurement of the photon number in the spatial mode while preserving the polarization state of the photon, see Fig. 3. The polarizing beam splitter PBS₂ partially re ects and partially transm its both vertically and horizontally polarized photons. BS₁ is a usual beam splitter and PD denotes photodetector with single-photon sensitivity.

The proposed setup is depicted in Fig. 2. The input polarization modes 1V and 1H are prepared in the pure single-mode states jfi and jgi that contain no more than N + 1 photons,

where jii denotes the n-photon Fock state. The states ${}_{P}^{(5)}$ are, of course, closely related to the states jfi = ${}_{n=0}^{P} f_{n}$ jni and jgi = ${}_{n=0}^{P} g_{n}$ jni appearing in Eq. (2).

The exact relationship between them will be specied later. Note that it was shown by Dakna et al. [11] that the single-mode states (5) can be probabilistically generated with the help of passive linear optics, single photon sources, strong coherent laser pulses and photodetectors with single photon sensitivity.

As shown in Fig. 2, the input beam containing the states jfi and jgi in the V and H polarization modes impinges on a beam splitter BS_1 with transmittance t_1 and re ectance r_1 . The purpose of this beam splitter is to separate a single photon from one of the input states and thus create entanglem ent. O f course, BS_1 m ay split m ore than one photon or no photon at all. Therefore we must verify that there is exactly a single photon present in the output spatialm ode 2, without disturbing its polarization state. Such QND measurements of a single photon have been recently thoroughly discussed in Ref. [31] where several schemes have been proposed and analyzed.

O ne possible m ethod relies on teleportation [32, 33]. W ith the help of the conditional C-NOT gate for photonic qubits [20] we have to rst prepare the singlet state $jVH i_{34}$ $jHV i_{34}$ in the auxiliary m odes 34. Then we teleport the polarization state of a photon in m ode 2 onto the photon in m ode 4 by perform ing a B ellm easurem ent on m odes 2 and 3. This m easurem ent should be carried out with two detectors that are capable to resolve the num ber of photons. If exactly two photons are detected in coincidence at the two detectors, then we know that there w as a single photon in m ode 2 and its polarization state has been coherently transferred onto the state of a single photon in m ode 4.




FIG.3: Interferom etric scheme for a QND measurement of a single photon [31]. BS are balanced beam splitters. PBS denotes polarizing beam splitters that transmit horizontally polarized photons and reject vertically polarized photons. R $_{90}$ is a waveplate that rotates polarization state by 90 degrees.

Kok et al. also proposed QND measurement schemes that do not require a-priori entanglem ent [31]. For our purposes it su ces to employ the simple interferom etric scheme depicted in Fig. 3 which performs a partial QND photon number measurement. The coincident detection of a single photon in detectors PD_1 and PD_2 indicates that there was at least one photon in the input mode. Moreover, if there was exactly a single photon at the input, then its polarization state is unperturbed by the m easurem ent. The probability of successfulQND m easurem ent of a single photon provided that there is a single photon in the spatial mode 2 is equal to 1=8. In the preparation scheme shown in Fig. 1 the two QND m easurem ents are followed by the entanglem ent swapping that succeeds only if each photodetector in Fig. 1 detects exactly one photon. In this way we select the events when there is exactly a single photon in each m ode A_2 and B_2 .

The state after the QND $\,$ m easurem ent can be written in the form

where the non-unitary operators B_0 and B_1 describe removal of none or a single photon at BS_1 , respectively,

B. Quantum erasure

The QND m easurem ent has thus created the entanglem ent. Still, B j fi and B j gi are states of two di erent polarization m odes while fi and jgi in Eq. (2) are states of a single m ode. We achieve this by erasing the information about the polarization. This is done with the help of a polarizing beam splitter PBS₂, see Fig. 2. The beam splitter is rotated such that it combines the V and H polarizations. If we associate the annihilation operators a_{1V} and a_{1H} with the modes 1V and 1H, then the transform ation carried out by PBS₂ is given by

where the polarization modes 1X and 1Y are spatially separated at the output of PBS₂ as indicated in Fig. 2. The erasing succeeds if and only if the detector PD placed on the 1Y mode does not detect any photon, which ensures that all photons have been transmitted to the linearly polarized output mode 1X.

Since the input states do not contain m ore than $N\,\,+\,\,1$ photons each and since a single photon was subtracted on B S_1 , the state after erasure of the polarization information reads

where the output complex amplitudes f_n and g_n are given by the following form ula,

It follows that we can x the values of output coe cients f_n by properly choosing the complex amplitudes of the input states. We have the recurrence equations

and a similar formula holds for g_{n+1} . The amplitudes f_{n+1} and g_{n+1} are calculated as follows. First, some nonzero values for f_0 and g_0 are chosen. Then one uses repeatedly Eq. (11) to calculate f_{n+1} and g_{n+1} from f_k and g_k , 0 k n, and the iterations stop at n = N.

We have thus almost obtained the state (2). However, while the elective states jfi and jgi in (9) have the correct structure in the subspace spanned by the rst N + 1 Fock states Di; jli; :::;N i, they also contain an unwanted tail in the subspace spanned by the Fock states N + 1i; :::; JN + 1i.




FIG.4:Quantum scissors.

C. Quantum state truncation

The last step in our scheme is to get rid of that tail. We do so with the help of the quantum scissors [34, 35, 36, 37, 38] that will project the state in the mode 1 onto the subspace spanned by the rst N + 1 Fock states. This action is form ally described by the projector $_{QS} =$

 $\bar{n}_{n=0}^{N}$ juilm j. A fler this truncation, we nally obtain the target entangled state (2) in the output modes 1 and 2 of our device.

The quantum scissors have been discussed in detail in several recent papers [34, 35, 36, 37, 38]. The schemes proposed there can be implemented with the use of linear optics, single photon sources, and photodetectors. The setup that we shall consider in the present paper is depicted in Fig. 4. The modes 2 and 3 are prepared in a pure N -photon two-mode entangled state

It was shown recently that these states may be conditionally generated with the help of linear optics, single photon sources and photodetectors [14, 15, 16, 17]. We then combine the modes 1 and 2 on a balanced beam splitter and measure the number of photons in output m odes 1 and 2 by m eans of two photodetectors P D $_1$ and PD₂ with single-photon resolution. The truncation is a conditional operation that succeeds when certain particular m easurem ent outcom e has been detected, say, no photons at P D $_1$ and N photons at P D $_2$, which we denote as (0;N). Note, that one could also consider other detection events, but the total num ber of photons detected by the photodetectors should be equal to N . The quantum scissors is essentially a quantum state teleportation in the subspace of the rst N + 1 Fock states, where the state (12) serves as the quantum channel, and the Belltype m easurem ent is carried out with the use of the beam splitter in Fig. 4 that couples the modes 1 and 2.

For our particular choice of the detection event (0; N), and assuming a balanced beam splitter, we nd that

should hold, where

is the probability of the successful quantum -state truncation that projects onto the subspace spanned by Di;jli;...;N i.

III. GENERAL SCHEME

So far we have considered the generation of a twom ode state that consists of a superposition of two product states. In this section we shall generalize our scheme in several ways.

A . M $\neg\!\!m$ ode entangled state

First, we will discuss the preparation of a M -m ode entangled state which has a form limited to the superposition of two product states, namely

To prepare this state, we st generate M states

as before, and then project the M $\,$ single photons onto the maxim ally entangled state

This projection can be performed with the Greenberger-Home-Zeilinger (GHZ) state analyzer described by Pan and Zeilinger [39]. This analyzer consists of polarizing beam splitters and half-wave plates and allows one to distinguish two GHZ states of M qubits.

B. A rbitrary two-m ode entangled states

O ur second generalization extends the preparation procedure to two-m ode states that are superpositions of d product states,

O by iously, a natural strategy is to prepare this state via d-dim ensional entanglem ent sw apping from two states of the form




FIG. 5: Scheme for conditional generation of the entangled state (19). The erasing of the spatial information is achieved conditionally on no photon being detected at the d 1 pho-todetectors PD.

where jli; denotes a state of a single photon in the jth auxiliary spatial mode. To prepare the states (19), we proceed essentially as in Sec. II. The extended scheme is depicted in Fig. 5. Initially, d spatial modes are prepared in states jfi. The array of d beam splitters BSi extracts, with a certain probability, a single photon. We must verify the presence of exactly one single photon in total in the modes 1°; ...; d⁰ while preserving the coherence am ong these m odes by perform ing a QND m easurement. This can be accomplished by d-dimensional teleportation similarly as discussed in Section II. However, this time we need to teleport a qudit encoded as a state of a single photon in d spatial modes. Fortunately, it was shown recently that the probabilistic gates for quantum computing with linear optics [20, 21, 22, 23, 24], that were introduced for qubits, can be easily extended to qudits [40]. This means that all the necessary manipulations, such as the generation of maxim ally entangled state of two qudits and the Bell measurement, can be probabilistically carried out with the resources that we assum e here.

A fler the QND m easurem ent, we must erase the spatial inform ation contained in the resulting state

where B_j are given by Eq. (7). This is done by the second array of d 1 beam splitters indicated by the shaded zone in Fig. 5. The preparation is nished by the application of the quantum scissors, that truncate the Fock state expansion of the output state at N photons.

Suppose that the output mode after erasing is a bal-

anced linear superposition of all d m odes

The complex amplitudes of the states $jf_j i = \int_n f_{jn} jn i$ can then be expressed in term softhe complex amplitudes of the input states f_{jn} as follows

where the prime indicates summation over all $n = (n_1; :::; n_d)$ satisfying the constraint $\int_{k=1}^{d} n_k = n$. Note that the form ula (22) may be easily inverted and we can determ ine the complex amplitudes $f_{j;k}$ of the input states for any given prescribed output states j_{fji} .

C. Universal schem e

Finally, we point out that those two generalizations can be combined and we can thus generate an arbitrary multimode entangled state of light where each mode contains no more than N photons. Any M -m ode state of this kind can be written as a superposition of no more than $d = (N + 1)^{M}$ product states,

Note that the norm of each product state in the superposition (23) may be arbitrary. We can conditionally generate the state (23) if we rst prepare M entangled states (k = 1; :::; M)

where jl_{ijk} denotes a single photon state of the (j;k)th auxiliary spatialm ode. As discussed above, the states (24) can be prepared with the help of the scheme depicted in Fig. 5. Then, we carry out a joint measurement on all auxiliary photons. The state j is obtained if we project the auxiliary modes onto an M-photon GHZ entangled state:

W ith the help of the techniques developed in the fram ework of the quantum computation with linear optics, the entangled M -photon G H Z state (25) can be mapped onto a product state of M photons which can then be detected by observing an appropriate M -photon coincidence. The factorization consists of a sequence of the C-SH FT gates for two qudits. The C-SH FT gate is de ned as follows,

where j^0 j should be calculated modulo d. As shown in Ref. [40] this transform ation can be (probabilistically) perform ed with the use of single photon sources, passive linear optics and photodetectors with single photon sensitivity. If we apply the C-SH IFT gate to the qudits 1 and k, where k = 2;:::;M, then the GHZ state (25) is m apped onto product state of M photons

D. State preparation with quantum memory

The above described procedure for the preparation of the generic M -m ode entangled state clearly shows that our approach is indeed general since it allows us, in principle, to generate an arbitrary state. But the success probability of the scheme will be exponentially sm all in general. The preparation procedure will therefore have to be repeated exponentially m any times to produce the desired state. In the rest of this section we shall argue that the number of operations required to produce the desired state can be signicantly decreased if a quantum m em ory is available. The situation is similar to that analyzed in Ref. [18] where the operations required to produce \cat states" was drastically decreased by using a recursive procedure that uses a quantum m em ory.

The advantage of the quantum mem ory is that it allows one to wait until successive steps in the state generation protocol have succeeded before proceeding with the next steps. For instance in the scheme described in Fig. 5, one can rst produce the states jf_ji and store them in a mem ory before proceeding with the production of the entangled state (19). Suppose that the state jfi_j can be prepared with the probability P_j . W ithout quantum mem ory the probability of simultaneous preparation of the d states jfi_j is $P = \int_{j=1}^{d} P_j$ and the number of required operations thus scales as N 0 / 1=P. If, after a successful preparation, we store each state jfi in a mem ory, we reduce the number of required operations to N 0 / $\int_{j=1}^{d} 1=P_j$.

A more elaborate use of a quantum memory is to build the state using a recursive procedure based on the Schm idt decomposition. Them ethod is best explained on an explicit example. Suppose we would like to prepare a four-mode state j i_{ABCD} . The Schm idt decomposition of this four-mode state with respect to a bi-partite splitting into the AB and CD modes can be written as

follow s,

where $j_{j}i_{AB}$ and $j_{j}i_{CD}$ form orthogonal bases in some subspaces of the H ilbert space of m odes AB and CD, respectively. The number of the terms in the Schmidt decomposition (29) is bounded by d $(N + 1)^2$ while, in general, $(N + 1)^4$ terms were necessary in the general procedure of Section IIIC. The decomposition (29) suggests that we could obtain the state j i_{ABCD} via entanglement swapping if we rst prepare two entangled states

Now the entangled states ji_{ABX} and $j^{0}i_{CDY}$ can be prepared using the general procedure of Sec. IIIC . How ever, for states of the specic form (30), a simpler procedure can be devised. One st generates d states j_{iAB} where the tilde indicates that j_{ij} is related to j_{ij} via relations sim ilar to those described by Eqs. (11). The state jiABX is then prepared with the help of the device shown in Fig. 5 where the mode B of $j_{\gamma_j} i_{AB}$ is sent to the jth input port of the interferom eter. The only modi cation is that we must also erase the spatial information carried by the A modes of the states j_{AB} and perform the quantum state truncation after the erasing. Brie y, all d m odes A_{i} are combined on an array of d1 beam splitters and the detectors monitor the rst d - 1 output ports. If these detectors do not register any photon, then the erasing procedure succeeded and we apply the quantum scissors to the state in the dth output port.

C learly, this recursive procedure can be extended to any number of modes. The resulting scheme resembles a tree structure involving repeated applications of the entangling scheme shown in Fig. 5 and the entanglement swapping that produces an 2m - m ode state from two m - m ode states entangled with auxiliary single photons. This scheme relying on quantum memory may possibly lead to a substantial in provement of the generation probability, similarly to the case of the two-mode N -photon cat states [18].

IV. CONCLUSIONS

In sum m ary, the scheme proposed in the present paper is universal in that arbitrary multimode entangled states of light can be probabilistically generated. The resources required are passive linear optics, single photon sources, strong coherent states, and detectors with single-photon resolution. This result clearly illustrates the versatility and power of the approach relying only on linear optics and single photons.

It is fair to say, though, that the suggested setup is rather com plicated and involves several nontrivial operations such as the quantum non-dem olition m easurem ent of a single photon, quantum scissors, and transform ations of photonic qudits encoded as a state of a single photon in d spatial modes. We have shown that all these operations can be (probabilistically) in plem ented with the resources that we consider here. The resulting procedure m ay becom e very com plex for general states. How ever, it should be emphasized that building a state like (23) must necessarily be complicated because of the large number of parameters $[(N + 1)^{M}]$ 1 com plex num bers] that characterize this state and that must be xed by the preparation scheme. We have also argued that the use of a quantum memory can decrease the number of operations required to produce the desired state.

W e hope that this paper will stimulate the e orts to-

wards experimental demonstrations of the basic building blocks of our scheme, such as the conditional generation of single-mode nite superpositions of Fock states and the preparation of two-mode entangled N -photon states required for the quantum state truncation.
