## Polarization squeezing with cold atom s

We study the interaction of a nearly resonant linearly polarized laser beam with a cloud of cold cesium atoms in a high nesse optical cavity. We show theoretically and experimentally that the cross-Kerre ect due to the saturation of the optical transition produces quadrature squeezing on both the mean eld and the orthogonally polarized vacuum mode. An interpretation of this vacuum squeezing as polarization squeezing is given and a method form easuring quantum Stokes parameters for weak beam s via a local oscillator is developed.

A great deal of attention has been recently given to the quantum features of the polarization states of the light, essentially because of their connections with quantum information technology. Several theoretical schemes to produce polarization squeezing using Kerr-like media have been proposed [1] and realized using optical bers [2]. O ther experim ental realizations achieve polarization squeezing by mixing squeezed vacuum (generated by an OPO) with a strong coherent beam on a polarizing beam splitter [3] or mixing two independent quadrature squeezed beams (generated by an OPA) on a polarizing beam splitter [4]. Very recently it has been proposed to propagate a linearly polarized light beam through an atom ic medium exhibiting self rotation to generate squeezed vacuum in the orthogonal polarization [5], which is equivalent to achieving polarization squeezing. In previous works [6] the interaction between a cloud of cold cesium atoms placed in a high nesse optical cavity and a circularly polarized laser beam nearly resonant with an atom ic transition has been studied. Because of optical pumping, the atom ic medium is conveniently modelled by an ensemble of two-level atom s. The saturation of the optical transition gives rise to an intensity-dependent refraction index. It is well known that the interaction of the light with a Kerr-like medium produces bistable behavior of the light transmitted by the cavity and that, at the turning point of the bistability curve, the quantum uctuations of the light can be strongly modi ed and generate quadrature squeezing [7]. A noise reduction of 40% has thus been observed in our group [6].

In this paper we focus on the theoretical and experimental investigation of polarization squeezing via the interaction of a linearly polarized laser beam with cold cesium atoms. In this con guration, the two-level atom model is no longer applicable and the situation much more complicated. We describe the interaction between light and the atom ic medium by means of an X-like four-level quantum model based on the linear input-output method. Our theoretical analysis shows clearly that competitive optical pumping may result in polarization switching, and polarization squeezing is predicted by the model [8]. In agreem ent with the model we observe quadrature squeezing in the probe laser mode and in the orthogonal vacuum mode. Experimentally, we obtain a polarization squeezing of 13% and we show for the rst time that the quantum Stokes parameters for very weak beams can be measured together with their phases using a local oscillator (LO). In our case squeezing is due to cross-K err e ect induced by the mean eld rather than to the polarization self-rotation responsible for polarization switching.




FIG.1: Experim ental set-up: PBS: polarizing beam splitter; BS: 10/90 beam splitter; =2: half-wave plate; PZT: piezoelectric ceram ic.

The con guration used in the experiment is described in detail in [6]. In Fig. 1 we present the main features of the set-up. The cesium atoms are cooled in a standard magneto-optical trap which operates with three orthogonal circularly polarized trapping beam generated by a T is apphire laser and an inhom ogeneous magnetic eld. The trapping T is apphire laser is detuned by 3 times the linewidth of the upper state on the low frequency side of the  $6S_{1=2}$ , F = 4 to  $6P_{3=2}$ , F = 5 transition. To prevent atoms from being optically pumped to the  $6S_{1=2}$ , F = 3

state, we superimpose a diode laser tuned to the  $6S_{1=2}$ , F=3 to  $6P_{3=2}$ , F=4 transition to the trapping beam s. We use a 25 cm long linear cavity built around the cell. The cavity is close to the hem ifocal con guration with a waist of 260 m. The coupling mirror has a transmission coe cient T of 10%, the rear m irror is highly re ecting. Hence, the cavity is close to the bad cavity lim it for which the cavity linew idth (= 5 M H z) is larger than the atom ic linew idth ( = 2:6 MHz). We probe the atom s with a linearly polarized laser beam detuned by about 50 M H z in the red of the  $6S_{1=2}$ , F = 4 to  $6P_{3=2}$ , F = 5 transition. The optical power of the probe beam ranges from 5 to 15 W. Under these conditions, the num ber of atom s interacting with the light beam is about  $10^6-10^7$ . The polarization of the light transmitted by the cavity is analyzed with a quarter-wave plate and a polarizing beam splitter (PBS1), so that Vs1 and Vs2 give the amount of respectively left-handed (I+) and right-handed (I) circular light.




FIG. 2: A nalysis of the circular polarization content of the light transmitted by the cavity and detected by the photodiodes shown in Fig. 1. Polarization switching occurs at point A. The power of the incident light is 7  $\,$  W  $\,$ .

A typical recording of the transmitted intensities I as a function of the cavity length is shown in Fig. 2: starting from the left up to point A, the polarization remains linear (nearly equal am ount of circular polarized light on both photodiodes), then it becomes circular. This polarization switching was known to occur in Fabry-Perot cavities containing atom ic vapors with degenerate sublevels in the ground state [9, 10]. In the experiment the probe beam is nearly resonant with the  $6S_{1=2}$ , F=4 to  $6P_{3=2}$ , F=5 transition: in principle, all the 20 Zeem an sub-levels are involved in the interaction. In order to get a qualitative physical insight into this problem, avoiding too heavy calculations, we model the atom ic medium as an X -like four-level system [see Fig. 3].

The competitive optical pumping between the circular component of light makes the linear polarization unstable inside the cavity above some intensity threshold. The optical pumping is responsible for polarization switching and the general shape of the cavity resonance curve [see Fig. 2] is well understood within this theoretical frame [8, 9, 10]. A Iternatively, the polarization

switching threshold m ay be interpreted as a laser oscillation threshold for the m ode orthogonal to the m ain polarization m ode [8]. H ere, we are interested in the quantum

uctuations of the light, which can be strongly modi ed via the interaction with the atom s. W hen the polarization of the light is circular, the situation is analogous to the previous experimental scheme when the incom ing

eld was circularly polarized §]. W e will therefore focus in the following on the case for which the polarization remains linear along the x-axis. The saturation of the

components of light causes the medium to behave as a Kerr-like medium for the mean  $eklA_x$ . In addition, the vacuum orthogonal  $A_y$  mode experiences a non linear dephasing via cross-Kerre ect 2, 8]. This system is then expected to generate quadrature squeezing for both modes; in the large detuning limit [], the equation for the vacuum mode uctuations reads §]




FIG. 4: Normalized quadrature noise for the vacuum eld mode at 3 MHz (a) and for the mean eld mode at 6 MHz (b). The best squeezing is 13% for the vacuum mode and 5% for the mean eld mode.

with  $_{\rm c}$  the cavity detuning,  $_{\rm 0}$  = 2N g<sup>2</sup> = T the linear atom ic dephasing,  $s_x = 2g^2 \hbar \hat{A}_x i f^2 = 2$  the saturation parameter and  $\hat{A}_{u}^{in}$  the incident eld uctuations. The cross-Kerr induced term has two contributions: a dephasing (/  $j\hat{A}_x i^2 \hat{A}_y$ ) and the term in  $h\hat{A}_x i^2 \hat{A}_y^2$ , responsible for the squeezing of this mode. A similar equation can be derived for the mean  $eldA_x$ , for which the squeezing is then generated via the usual K err term  $(/hA_x i^2 A_y^{\gamma})$ . These equations are valid when the large excess noise due to optical pumping can be neglected, that is for times smaller than the optical pumping time, in contrast with [5]. Squeezing is then predicted for noise frequencies higher than the inverse optical pum ping time. Using the experimental set-up described in Fig. 1, we have m easured the quadrature noise of both m odes. The signal recorded at the output of the cavity (see Fig. 2) is used to lock the cavity length on the regim e where the polarization remains linear. After interacting with the atoms, both elds are mainly re ected by BS and then mixed on PBS2 with a 10 mW localoscillatorbeam (LO). U sing the half-wave plate =2a, we are able to send either

the mean eld mode or the orthogonal vacuum mode to PBS3 and perform the usual homodyne detection. By varying the relative phase of the LO with respect to the probe beam we can detect the noise features of all the quadratures of the eld. In agreement with the theoretical predictions, we observe quadrature squeezing on both the main mode and the orthogonalmode. The results are 5% (7% after correction for optical losses, mainly due to BS) of noise reduction for the main polarization mode at 6 M Hz and 13% (18% after correction) for the squeezed vacuum state at 3 M Hz, as shown in Fig. 4. This system is then able to produce simultaneously two squeezed modes, for which the relatives phases are intrinsically

xed. Let us note that these two squeezed modes can be used to generate a pair of entangled beam s, which will be presented in a forthcoming publication [11].

In the following we focus on the study of the noise of the mode with orthogonal polarization with respect to the main mode, commonly referred to as polarization noise. The characterization of the quantum features of the polarization state relies on the measurement of the quantum Stokes parameters [12]. They are de ned from their classical counterparts

These operators obey the commutation relations  $[\hat{S}_0; \hat{S}_i] = 0$  and  $[\hat{S}_i; \hat{S}_j] = {}_{ijk} 2i\hat{S}_k$  (i = 1;2;3). Their spectral noise densities satisfy uncertainty relations  $V_{\hat{S}_i}$  (!)  $V_{\hat{S}_i}$  (!)  $j_{ijk}h\hat{S}_k i\hat{f}$ . In our case the light is linearly polarized along the x-axis, then  $h\hat{S}_0 i = h\hat{S}_1 i = \frac{2}{x}$ and  $h\hat{S}_2 i = h\hat{S}_3 i = 0$ , where  $h\hat{A}_x i = \frac{1}{x}$  is chosen real. Then the only non trivial Heisenberg inequality is  $V_{\hat{S}_2}$  (!)  $V_{\hat{S}_3}$  (!)  $\frac{4}{x}$ . Polarization squeezing is then achieved if  $V_{\hat{S}_2}$  or  $V_{\hat{S}_3}$  is below the coherent state value  $\frac{2}{x}$ . The uctuations of  $\hat{S}_2$  and  $\hat{S}_3$  are related to the uctuations of the quadratures of the vacuum orthogonal mode

The physical meaning of the Stokes parameters uctuations is the following: the  $\hat{S}_2$  uctuations lead to a geometric jitter of the polarization axis, whereas the  $\hat{S}_3$ 

uctuations are linked to ellipticity uctuations. It can be seen from Eq. (2) that these uctuations are related to the amplitude and phase uctuations of  $\hat{A_y}$ . Therefore polarization squeezing is equivalent to vacuum squeezing on the orthogonalm ode.

The m easurem ent of the Stokes param eters can be carried out directly by m eans of two balanced photodiodes and suitable com binations of half wave and quarter wave plates [12]. In our set-up, however, the power of the probe beam interacting with the atoms ( 10 W) is not su cient, so that we need a LO for the detection. The uctuations of the vacuum mode  $\hat{A}_y$  are m easured using the hom odyne detection described above. Following Eq. (2) the photocurrent can be expressed in terms of the uctuations of  $\hat{S}_2$  and  $\hat{S}_3$ :

where  $_{hd}$  is the relative phase between the LO and the mean eld. As hd is varied in time, we correspondingly detect the uctuations of the Stokes parameters  $\hat{S}_{hd}$ . For instance, hd = 0 (respectively =2) corresponds to the detection of the uctuations of  $\hat{S}_2$  (respectively of  $\hat{S}_3$ ). Hence, in the experim ent we can get the Stokes param eters simply by simultaneously measuring the relative phase hd and the quadrature noise of the vacuum mode. This measurement is readily performed by setting the half-wave plate before PBS2 in such a way that the  $\hat{A_v}$ mode is sent to the hom odyne detection; the mean eld  $\hat{A_x}$  goes through the other port of the beam splitter and is detected together with a portion of the LO by a photodiode (see Fig. 1). The phase is determined via the interference signal between LO and  $\hat{A_x}$  (i / cos  $_{hd}).$ The two signals i and ind are sent to the XY channel of the oscilloscope, giving the characteristic curves reported below .




FIG. 5: Normalized quadrature noise at 3 MHz for the vacuum mode  $\hat{A}_y$  vs the normalized interference signal:  $\cos_{hd}$ . The general case is shown in curve (a): polarization squeezing is achieved when  $_{hd} = _{sq} = 30$ : a linear combination of  $\hat{S}_2$  and  $\hat{S}_3$  is squeezed. In curve (b),  $\hat{S}_3$  is squeezed ( $_{sq} = -2$ ).

In Fig. 5 the normalized quadrature noise of  $\hat{A}_y$ , obtained at a noise frequency of 3 MHz, is plotted as a function of the relative phase between the mean eld and the LO. In agreement with Eq.  $\beta$ ), it can be seen that the noise of  $\hat{S}_2$  is given by the extreme

points  $_{hd} = 0$ ; on the diagram and that of  $\hat{S}_3$  by the center point  $_{hd} = =2$ . In general, for an arbitrary squeezed quadrature, a linear combination of  $\hat{S}_2$  and  $\hat{S}_3$  is squeezed (Fig. 5a). We not that the polarization squeezing strongly depends on the operating point and on the noise frequency. For instance, in Fig. 5b, we see that  $\hat{S}_3$  is squeezed.

To conclude, we have demonstrated that the nearly resonant interaction of a linearly polarized laser beam with a cloud of cold atoms in an optical cavity can produce quadrature squeezing on the mean eld mode and on the orthogonally polarized vacuum mode. We have shown that these results can be interpreted as polarization squeezing and developed a method to measure the quantum Stokesparameters for weak beams, using a local oscillator and a standard hom odyne detection.
