Special functions, raising and lowering operators

A bstract. The Schrodinger equations which are exactly solvable in terms of associated special functions are directly related to some self-adjoint operators defined in the theory of hypergeometric type equations. The fundamental formulae occurring in a supersymmetric approach to these Hamiltonians are consequences of some formulae concerning the general theory of associated special functions. We use this connection in order to obtain a general theory of Schrodinger equations exactly solvable in terms of associated special functions, and to extend certain results known in the case of some particular potentials.

1. Introduction

It is well-known [2, 4] that, in the case of certain potentials, the Schrodinger equation is exactly solvable and its solutions can be expressed in terms of the so-called associated special functions. Our purpose is to present a general theory of these quantum systems. Our systematic study recovers a number of earlier results in a natural united way and also leads to new indings.

The number of articles concerning exactly solvable quantum systems and related subjects is very large (see [2, 4, 5] and references therein). Our approach is based on the raising/low ering operators presented in general form (for the rst time to our know ledge) by Jafarizadeh and Fakhri [5]. We reobtain these operators in a much simpler way, and use them in a rather dierent way. More details can be found in [3].

2. Orthogonal polynomials and associated special functions

M any problems in quantum mechanics and mathematical physics lead to equations of hypergeometric type

where (s) and (s) are polynomials of at most second and rst degree, respectively, and is a constant. This equation can be reduced to the self-adjoint form

and if (s) > 0, %(s) > 0 for all s 2 (a;b), then the polynom ials $_{1}$ are orthogonal with weight function %(s) in the interval (a;b). In this case $_{1}$ are known as classical orthogonal polynom ials [7].

Let (s) = (s). By differentiating the equation (3) m times and multiplying it by m (s), we get for each m 2 f0;1;2;::; lg the associated differential equation which can be written as H $_m$ $_{lm}$ = $_{lm}$, where

For each m 2 N, let H_m be the linear span of $f_{m,m}$; $f_{m+1,m}$; $f_{m+2,m}$; $f_{m+2,m}$; $f_{m+2,m}$; $f_{m+2,m}$; we shall restrict us to the case when f_{m} is dense in f_{m} for all f_{m} 2 N. For this it is su cient the interval (a;b) to be nite, but not necessary.

3. Raising and lowering operators. Factorizations for H $_{\rm m}$

Lorente has shown recently [6] that a factorization of H $_0$ can be obtained by using the well-known three term recurrence relation satis ed by $_1$ and a consequence of R odrigues form ula. Following Lorente's idea we obtain a factorization of H $_m$ by using the dennition $_{l,m}$ (s) = $_{l,m}$ (s) and a three term recurrence relation.




Figure 1. The functions $_{l,m}$ satisfy the relation H $_{m}$ $_{l,m}$ = $_{l}$ $_{l,m}$, and are related (up to som e multiplicative constants) through the operators A_m , A_m^+ , a_m , a_m^+ , U_m and $U_{m}^{1} = U_{m}^{+}$.

5. A pplication to Schrodinger type operators

The problem of factorization of operators H_m is a very important one since it is directly related to the factorization of some Schrodinger type operators [2, 4]. If we use a change of variable s=s(x) such that ds=dx=(s(x)) or ds=dx=(s(x)) and denote the new functions $l_{zm}(x)=(s(x))$ s(x) $l_{zm}(s(x))$ then the relation H_m $l_{zm}=l_{zm}$ becomes an equation of Schrodinger type

For example, by starting from the equation of Jacobi polynomials with = 1=2, = 1=2, and using the change of variable s(x) = cos x we obtain the Schrödinger equation corresponding to the Poschl-Teller potential [1]

From the relations satis ed by ${\rm A}_{\rm m}$ and ${\rm A}_{\rm m}^+$ we get the formulae

If we choose the change of variable s=s(x) such that ds=dx=(s(x)) then the formulae are very sim ilar (only som e signs are changed). In the case of Poschl-Teller potential (14) we get
