C oherent population trapping is shown to occur in a driven sym metric double-well potential in the strong-eld regime. The system parameters have been chosen to reproduce the 0 \$ 3<sup>+</sup> transition of the inversion mode of the ammonia molecule. For a molecule initially prepared in its lower doublet we methat, under certain circum stances, the 3<sup>+</sup> level remains unpopulated, and this occurs in spite of the fact that the laser eld is resonant with the 0 \$ 3<sup>+</sup> transition and intense enough so as to strongly mix the 0<sup>+</sup> and 0 ground states. This counterintuitive result constitutes a coherent population trapping phenom enon of nonperturbative origin which cannot be accounted for with the usual models. We propose an analytic nonperturbative model which accounts correctly for the observed phenom enon.

Q uantum dynam ics in symmetric double-well potentials is important to understand numerous physical and chem ical processes. A typical example is the tunneling dynam ics of the hydrogen atom s in the inversion mode of the ammonia molecule, which is responsible for the splitting of the vibrational levels [1]. O ther examples include electron tunneling in quantum sem iconductor structures [2] or interm olecular proton transfer processes [3].

In recent years there has been increasing interest in quantum coherence phenom ena displayed by atom ic and molecular systems irradiated with strong laser elds [4]. Coherent external elds induce quantum interference effects such as coherent population trapping [5], electrom agnetically induced transparency [6] or lasing without inversion [7]. In particular, in connection with the time evolution of a quantum system in a symmetric doublewell potential it has been shown that under certain circum stances an intense laser eld can induce coherent tunneling suppression [8]. In this Letter we show that such a system can also exhibit coherent population trapping. This population trapping phenom enon is nonperturbative in nature and cannot be accounted for with the usual models. We propose an analytically solvable nonperturbative model which accounts correctly for the essential features of the observed phenom enon.

Speci cally, we consider a symmetric quartic doublewellpotential strongly driven by a linearly polarized laser eld. A fier appropriate scaling the corresponding dimensionless H am iltonian reads

where the coupling constant is proportional to the laser eld am plitude  $E_0$  and  $= !_L t w ith !_L$  being the laser frequency. The dimensionless parameter , which gives approximately the number of doublets below the barrier top, has been chosen to be 1:735: This value reproduces, to a good approximation, the elective potential involved in the inversion mode of the ammonia molecule. The laser frequency has been tuned to the 0 \$ 3<sup>+</sup> vibrational transition and its intensity satisfies h0<sup>+</sup> K j0 i = E<sub>0 12</sub> = 0:35 !\_L where 12 is the dipole matrix element between the ground states j0<sup>+</sup> i and j0 i, and all quantities are assumed to be dimensionless.

Transitions  $0^+$  \$ 0 and 0 \$  $3^+$  are dipole allowed whereas the  $0^+$  \$  $3^+$  transition is forbidden. Therefore, in the weak-eld regime (E  $_0$   $_{12}=!_L$ ;  $_0=!_L$ 1 with 0 being the energy splitting of the lower doublet) and for a laser eld tuned to the  $0 \ \$ \ 3^+$  transition, one expects the upper level to be populated or not depending on whether the molecule is initially prepared in the 10 i or  $\mathcal{D}^+$  i state, respectively. The laser intensity considered above, however, corresponds to the strong-eld regime  $!_{\rm L}$ ). Under these circum stances the two lower (E<sub>0 12</sub> levels become strongly mixed and the 10 i state becomes highly populated. One then would expect the upper level to be populated irrespective of the fact that the molecule be initially prepared in the  $\mathcal{D}$  i or  $\mathcal{D}^+$  i state.




FIG.1. Populations vs. =  $!_{L}t$  for an ammonia molecule initially prepared in: (a) the  $j^{+}$  istate; and (b) the  $j^{0}$  istate. Curves (1) give the total population of the lower doublet; curve (2) gives the population of the  $j^{0}$  i state; and curves (3) give the population of the upper level  $j^{+}$  i.

Fig. 1a shows the evolution of the populations for an ammonia molecule initially prepared in its ground state  $D^+$  i. These results have been obtained num erically by direct integration of the Schrodinger equation. We have included the 20 low est-lying levels, which guarantees convergence. As is apparent from the gure, the upper level  $\beta^+$  i rem ainsalwaysunpopulated [curve (3)], and this occurs despite the fact that the j) i state becom es highly populated [curve (2)] and the laser eld directly connects this latter state with the upper level. This gure also shows that the total population in the lower doublet remains always close to unity [curve (1)]. Thus, under the action of the driving eld the initial population oscillates rapidly between  $10^+$  i and  $10^-$  i while it remains trapped in the lower doublet. This counterintuitive result represents a coherent population trapping phenom enon of nonperturbative nature which cannot be accounted for with the usualm odels.

The case of an ammonia molecule prepared initially in j i is considered in Fig. 1b. This gure shows the time evolution of both the population of the upper level  $\beta^+$  i [curve (3)] and the total population of the lower doublet [curve (1)]. As before the initial population oscillates very rapidly between  $\mathcal{D}$  i and  $\mathcal{D}^+$  i (not shown for clarity). Now, how ever, a periodic population transfer between the low erdoublet and the upper level takes place on a di erent tim escale. In fact, apart from the rapid oscillations of the upper level population (which originates from population transfers to levels adjacent to  $\mathcal{B}^+$  i, as a detailed num erical analysis reveals) the behavior of the system in this nonperturbative regime resembles that of the corresponding weak-eld regime.

The above results pose two intriguing questions: i) W hy does the population become trapped when the molecule is initially prepared in its ground state? and ii) W hy does the system behave essentially in a similar way both in the nonperturbative strong-eld regime and in the weak-eld regime? In what follows, we propose an analytic nonperturbative three-levelm odel which can give an answer to these questions.

The most directly involved states,  $j^+$  i,  $j^-$  i and  $\beta^+$  i, will be denoted jli,  $j^+$  i and  $j^-$  i, respectively. The energy splitting of the lower doublet is  $_0$ , and  $!_3$  denotes the energy of the upper level. The system H am iltonian is

where ~ 1;  $_{ij}$  jihj; and  $_{ij}$  E<sub>0</sub>  $_{ij}$  with  $_{ij}$  being the dipole matrix elements between jii and jji.

Them ost rapidly oscillating terms can be absorbed by performing the unitary transformation

with () =  $(_{12}=!_{L}) \sin ()$ . Next, we expand the time dependent coe cients of H<sup>0</sup> in Fourier series, which allows us to separate the Ham iltonian into a dom inant constant contribution  $H_0^0$  and a time-dependent part H  $^{0}$  ( ). Then, substitution of H  $^{0}$  into the evolution operator of the system shows that when the driving eld is quasiresonant with the 21\$ Bi transition and both the energy dierence <sub>0</sub> and the Rabi frequency <sub>23</sub> are small in comparison with the laser frequency, H  $^{0}$ ( ) becom es a sm all, rapidly oscillating perturbation which can be safely neglected. M ore generally, it can be shown that in the strong-eld regime (  $_{12}$ =!  $_{\rm L}$  & 1) and for a quasiresonant laser eld,  $H_p^0$  () becom es negligible whenever  $_0=!_L$ ;  $_{23}=!_L$  $_{12}=!_{L}$ . (In our case,  $_{0}=!_{L} = 328$  10<sup>4</sup>;  $_{23}=!_{L} = 023$ , and  $_{12}=!_{L} =$ 1:10.) Under these circum stances, the dynam ical evolution of the system is governed by the Ham iltonian

where the renormalized energy dierence  ${}^{R}_{0}$  and Rabi frequency  ${}^{R}_{23}$  are eld-dependent quantities de ned as  ${}^{R}_{0} = {}_{0}J_{0} (2 {}_{12}=!_{L})$  and  ${}^{R}_{23} = 2!_{L} ({}_{23}={}_{12})J_{1} ({}_{12}=!_{L})$ , with J<sub>n</sub> being the n<sup>th</sup>-order Bessel function. The Schrodinger equation associated with the above H am iltonian can be readily solved analytically, and after transform ing back one obtains the follow ing nonperturbative general solution

where  $^{R} = !_{3}$  q  $\frac{\binom{R}{0}=2}{\binom{R}{23}^{2}+\binom{R}{2}}$  is the renormalized detuning and  $^{R} = \frac{\binom{R}{23}^{2}+\binom{R}{2}}{\frac{R}{23}^{2}+\binom{R}{2}}$  is the renormalized generalized Rabi-frequency. The physical content of the above solution becomes more transparent by considering the extended H ilbert space of -periodic state vectors [9]. In fact, the basis fj<sup>0</sup>() ig with j<sup>0</sup>() i U<sup>t</sup>() jii turns out to be the natural basis to express j()i

As this expression re ects, the dynamical evolution of the probability am plitudes corresponding to the renormalized fji<sup>0</sup>() ig states is governed by the Ham iltonian  $H^{0}$  of Eq. (5). Such Ham iltonian has the same form as the original Hamiltonian (2) in the limit  $_{12}$  ! 0 (in the rotating wave approximation and in the fram e rotating with the laser frequency). Therefore, the theory is renorm alizable in the sense that when analyzed in term s of the fji<sup>0</sup> () ig states, the nonperturbative e ects of the radiation eld on the dynam ical evolution of the system can be absorbed into the renorm alized splitting  $\begin{bmatrix} R\\0 \end{bmatrix}$  and Rabifrequency  $\frac{R}{23}$ , in such a way that the system evolves obeying the sam e H am iltonian as that of the weak-eld regime in the rotating wave approximation. In fact, the general solution (9) is valid both in the (perturbative) weak-eld regime ( $_{12}=!_{L}; _{0}=!_{L}$ 1) and in the (nonperturbative) strong-eld regime ( $_{12}=!_{L} \& 1$ ).

As Eq. (8a) shows, under the action of the coherent external eld, the  $jl^0()$  is state decouples and all the population that is initially in state jli becomes trapped in  $jl^0()$  i. For a system prepared initially in its ground state this implies, in particular, that the upper level  $\beta i$ remains always unpopulated. This occurs in spite of the fact that the initial population oscillates very rapidly between the jli and  $\beta i$  levels, and the latter is directly coupled to  $\beta i$  via a laser eld tuned to the 2 \$ 3 transition. This is a coherent population trapping phenom enon of nonperturbative origin.




FIG.2. Theoretical predictions for the sam e situations considered in Fig. 1. For comparison purposes, along with the analytical results (solid lines) the corresponding exact num erical results have been plotted again (dotted lines).

On the other hand, when the molecule is prepared in = 0 in the state 1/2 i, the population di erence between the upper level and the lower doublet oscillates in time as

Fig. 2 shows the theoretical predictions of our model for the same situations considered in Fig. 1. Fig. 2a corresponds to an ammonia molecule prepared initially in its ground state. In this case, the populations  $_{\rm ii}$  () of the molecular states fjig are predicted to be

and  $_{11}() = 1$   $_{22}()$ . Thus, the population of the low erdoublet, which under these circum stances coincides with that of the renorm alized state  $jl^0()$ , remains always equal to one [curve (1)] and the upper level remains unpopulated [curve (3)], in good agreem ent with the numerical results (dotted lines). Fig. 2a also compares the analytical result for the population of level jl [curve (2)] with the corresponding exact numerical result.

On the other hand, F ig. 2b shows the evolution of the populations for a molecule prepared at = 0 in state 12i. In this case the population of the lower doublet coincides with that of the renorm alized state  $2^{0}()$  i and, according to our model, oscillates in time as [curve (1)]

while the population of the upper level behaves as  $_{33}() = 1$ <sub>11</sub>()  $_{22}$  () [curve (3)]. These results are in good qualitative agreem ent with the corresponding num erical results. The main discrepancy between Figs. 2b and 1b com es from the rapid oscillatory behavior of the upper level population. A salready m entioned, it can be shown that this discrepancy, which decreases as the laser intensity does, originates from population transfers to levels ad jacent to the  $3^+$  level, which now have a more signi cant contribution. In fact, if the num erical problem is restricted to the three levelsm ost directly involved then num erical and analytical results become indistinguishable on the scale of the gures. Our three-level model already captures the essential features of the system and enables us to understand the dom inant behavior of the populations in terms of a nonperturbative coherent population trapping phenom enon. The upper level rem ains unpopulated when the molecule is initially prepared in its ground state because such con guration corresponds to an initial preparation in the trapping state  $J^0()$  i.

Next, we will analyze the in uence of dissipation on the coherent population trapping phenom enon previously found. Spontaneous em ission e ects can be conveniently incorporated by assuming that the upper level decays radiatively into state 2i with an e ective spontaneous em ission rate. The dynamics of the system is now described in terms of the density operator (t) which obeys the usual master equation (in which we have retained nonsecular terms). By performing the unitary transform ation (3) one obtains a transform ed master equation for the density operator  $^{0}(t) = U(t) (t)U^{+}(t)$ , which, within the range of validity of our model, leads to the following equations of motion governing the time evolution of populations and coherences:

A sEq. (13a) re ects, whenever the R abi frequency  $_{12}$  coupling the two low er-lying states is nonzero, the upper state  $\beta$ i rem ains unpopulated in the steady state regardless of the initial preparation. As a consequence, in the steady state the molecular population becomes trapped in the low er doublet and the uorescence from level  $\beta$ i vanishes. This behavior, which is in sharp contrast with the well-known behavior of the system in the  $_{12} = 0$  limit, is typical of system s exhibiting coherent population trapping and has its origin in quantum interferences involving the two low er-lying levels [5].

It is not hard to see from the above equations that, for arbitrary external elds (such that  $^{R}_{23} \in 0$ ), the steady-state population of  $2^{0}$  (t) i also vanishes so that all of the population becomes trapped in the steady state in  $1^{0}$  (t) i irrespective of the initial preparation.

In conclusion, we have shown that coherent population trapping can occur in the nonperturbative regime and have proposed an analytically solvable nonperturbative three-levelm odel which enables us to understand the observed phenom enon. A lthough we have presented results for only one eld intensity, essentially the same behavior, in good agreem ent with our analytic model, occurs in the parameter range 0:1 .  $12^{-1}L$  . 0:5 . A detailed account of the model will be given elsew here.
