# Decoherence free algebra

#### Abstract

We consider the decoherence free subalgebra which satisfies the minimal condition introduced by Alicki [1]. We show the manifest form of it and relate the subalgebra with the Kraus representation. The arguments also provides a new proof for generalized Lüders theorem [5].


## 1 Introduction

Decoherence is a non-unitary dynamics that is a consequence of system- environment coupling. As a way to protect a quantum system against decoherence, a subalgebra whose dynamics is implementable by unitary operator has attracted considerable interests; that is, the decoherence free subalgebra.

Let $M_{n}$ be a $C^{*}$-algebra of all $n \times n$ matrices and $\phi$ a unital trace preserving completely positive map from $M_{n}$ into itself. It is known that $\phi$ satisfies the Kadison inequality:

$$
\begin{equation*}
\phi\left(x^{*} x\right) \geq \phi(x)^{*} \phi(x) \quad \text { for all } x \in M_{n} \tag{1}
\end{equation*}
$$

The equality holds for all $x \in M_{n}$ if and only if $\phi$ is given by a unitary operator $U$ as $\phi(x)=U^{*} x U$. So $\phi\left(x^{*} x\right)-\phi(x)^{*} \phi(x)$ can be interpreted as a dissipation function. Under these considerations, Alicki introduced the decoherence free subalgebra $N_{\phi}$ of $\phi$ as [1]

$$
N_{\phi}=\left\{x_{1}+i x_{2} \in M_{n} ; x_{i}=x_{i}^{*}, \phi\left(x_{i}^{2}\right)=\phi\left(x_{i}\right)^{2}, i=1,2\right\} .
$$

It is a $C^{*}$-subalgebra of $M_{n}$. Suppose that $\phi$ can be joined to the identity map id, in the sense that there exists a continuous map from interval $[0,1]$ to completely positive map $t \rightarrow \phi_{t}$ which satisfies $\phi_{0}=\mathrm{id}$, and $\phi_{1}=\phi$. Then there exists a unitary operator $U_{\phi}$ in $M_{n}$ such that

$$
\phi(x)=U_{\phi}^{*} x U_{\phi} \quad \text { for all } x \in N_{\phi} .
$$

Hence it seems suitable to call $N_{\phi}$ decoherence free algebra. However, how can we find the manifest form of this subalgebra? In particular, how is it related to the Kraus representation $\phi(x)=\sum_{i=1}^{k} A_{i}^{*} x A_{i}$ ? In this paper, we consider this problem and show the following proposition:

Proposition 1.1 The decoherence free subalgebra $N_{\phi}$ is equal to the commutant of the algebra generated by $A_{i} A_{j}^{*}$;

$$
N_{\phi}=\left\{A_{i} A_{j}^{*}, \text { for all } 1 \leq i, j \leq k\right\}^{\prime},
$$

which is independent of the choice of the Kraus representation.
Here and hereafter, we denote the commutant of $\mathcal{C}$ by $\mathcal{C}^{\prime} \equiv\left\{x \in M_{n} ; x y=\right.$ $y x$ for all $y \in \mathcal{C}\}$. The arguments also provides a new proof for generalized Lüders theorem [5].

## 2 The decoherence free algebra

Let us first confirm the notations. We denote by $B(\mathcal{H})$ the set of all bounded operators on Hilbert space $\mathcal{H}$. A subset $S$ of Hilbert space $\mathcal{H}$ is said to be total if it spans $\mathcal{H}$. We denote by $\mathfrak{h}_{m}$ the $m$-dimensional Hilbert space, and denote the orthonormal basis of it as $\left\{\mathrm{e}_{i} ; 1 \leq i \leq m\right\}$. A linear map $\phi$ from $B\left(\mathcal{H}_{2}\right)$ to $B\left(\mathcal{H}_{1}\right)$ is called a unital completely positive map if it satisfies $(\mathrm{i}) \phi(1)=1$ and (ii)for every $n=1,2, \cdots$ the correspondence $\left(X_{i j}\right) \rightarrow\left(\phi\left(X_{i j}\right)\right) 1 \leq i, j \leq n$ from $B\left(\mathcal{H}_{2} \otimes \mathbb{C}^{n}\right)$ to $B\left(\mathcal{H}_{1} \otimes \mathbb{C}^{n}\right)$ preserves positivity.

Before going into the proof, we introduce two famous Theorems. The first one is the Theorem of Choi [2];

Theorem 2.1 Suppose that $\phi$ is a unital completely positive map from $B\left(\mathcal{H}_{2}\right)$ to $B\left(\mathcal{H}_{1}\right)$. If $\phi\left(a^{*} a\right)=\phi(a)^{*} \phi(a)$ and $\phi\left(a a^{*}\right)=\phi(a) \phi(a)^{*}$ for some $a \in B\left(\mathcal{H}_{2}\right)$, then for all $b \in B\left(\mathcal{H}_{2}\right)$, we have $\phi(b a)=\phi(b) \phi(a), \phi(a b)=\phi(a) \phi(b)$.

The second one is the Theorem of Steinspring [3];
Theorem 2.2 Let $\mathcal{H}_{1}$ and $\mathcal{H}_{2}$ be finite dimensional Hilbert spaces and let $\phi$ be a unital completely positive map from a $B\left(\mathcal{H}_{2}\right)$ to $B\left(\mathcal{H}_{1}\right)$. Then there exists a Hilbert space $\mathcal{K}$ and isometry $V$ from $\mathcal{H}_{1}$ to $\mathcal{H}_{2} \otimes \mathcal{K}$ such that the following holds:
(a) $\phi(x)=V^{*}(x \otimes 1) V \quad$ for all $x \in B\left(\mathcal{H}_{2}\right)$
(b) $\left\{(x \otimes 1) V u \mid x \in B\left(\mathcal{H}_{2}\right), u \in \mathcal{H}_{1}\right\}$ is total in $\mathcal{H}_{2} \otimes \mathcal{K}$.
(c) If $\mathcal{K}^{\prime}$ is another Hilbert space and $V^{\prime}$ is an isometry from $\mathcal{H}_{1}$ to $\mathcal{H}_{2} \otimes \mathcal{K}^{\prime}$ such that (a) and (b) hold, then there exists a unitary $W$ from $\mathcal{H}_{2} \otimes \mathcal{K}$ to $\mathcal{H}_{2} \otimes \mathcal{K}^{\prime}$ such that $W\left(x \otimes 1_{\mathcal{K}}\right) V=\left(x \otimes 1_{\mathcal{K}^{\prime}}\right) V^{\prime}$.

What we consider is a unital completely positive map from $B(\mathcal{H})$ to $B(\mathcal{H})$, where $\mathcal{H}$ is $n$-dimensional Hilbert space and $B(\mathcal{H})$ is equal to $M_{n}$. Now let us proceed to the proof of the proposition.

Proof of Proposition 1.1 Let $A_{i} \in B(\mathcal{H}), 1 \leq i \leq m$ be Kraus operators which give the Kraus representation of $\phi$ as

$$
\phi(a)=\sum_{1=1}^{m} A_{i}^{*} a A_{i}
$$

Define a linear map $V$ from $\mathcal{H}$ to $\mathcal{H} \otimes \mathfrak{h}_{m}$ by

$$
V u=\sum_{i=1}^{m} A_{i} u \otimes \mathrm{e}_{i} .
$$

The adjoint of $V$ satisfies

$$
V^{*}\left(\sum_{i=1}^{m} \psi_{i} \otimes \mathrm{e}_{i}\right)=\sum_{i=1}^{m} A_{i}^{*} \psi_{i}
$$

and

$$
V^{*}(a \otimes 1) V=\sum_{1=1}^{m} A_{i}^{*} a A_{i}=\phi(a)
$$

Therefore, the condition (a) of the Steinspring's Theorem holds for the pair $\left(K \equiv \mathfrak{h}_{m}, V\right)$.

First we consider the case that the condition (b) is also satisfied. Note that by the definition of $N_{\phi}$, and the Choi's Theorem, any element $a$ of $N_{\phi}$ satisfies $\phi\left(a^{*} a\right)=\phi(a)^{*} \phi(a)$. Then again by Choi's Theorem, we have

$$
\begin{equation*}
\phi(b a)=\phi(b) \phi(a), \phi(a b)=\phi(a) \phi(b) \tag{2}
\end{equation*}
$$

for all $a \in N_{\phi}$ and all $b \in B(\mathcal{H})$. The relation (2) is represented in the Steinspring representation as

$$
V V^{*}\left(a \otimes 1_{K}\right) V V^{*}\left(b \otimes 1_{K}\right) V u=V V^{*}\left(a \otimes 1_{K}\right)\left(b \otimes 1_{K}\right) V u
$$

for all $u \in \mathcal{H}, a \in N_{\phi}$ and $b \in B(\mathcal{H})$. As $\left\{\left(b \otimes 1_{K}\right) V u \mid b \in B(\mathcal{H}), u \in \mathcal{H}\right\}$ is total in $\mathcal{H} \otimes K$ by condition (b), this implies

$$
V V^{*}\left(a \otimes 1_{K}\right) V V^{*}=V V^{*}\left(a \otimes 1_{K}\right)
$$

on $\mathcal{H} \otimes K$. The decoherence free algebra $N_{\phi}$ is involutive. So we also have

$$
V V^{*}\left(a^{*} \otimes 1_{K}\right) V V^{*}=V V^{*}\left(a^{*} \otimes 1_{K}\right)
$$

for all $a \in N_{\phi}$. Taking the adjoint of this, we have

$$
V V^{*}\left(a \otimes 1_{K}\right) V V^{*}=\left(a \otimes 1_{K}\right) V V^{*}
$$

Combining these, we get

$$
\left(a \otimes 1_{K}\right) V V^{*}=V V^{*}\left(a \otimes 1_{K}\right)
$$

for all $a \in N_{\phi}$. As

$$
V V^{*}=\sum_{i, j=1}^{m} A_{i} A_{j}^{*} \otimes\left|\mathrm{e}_{i}\right\rangle\left\langle\mathrm{e}_{j}\right|
$$

we obtain

$$
\begin{equation*}
a A_{i} A_{j}^{*}=A_{i} A_{j}^{*} a \quad 1 \leq i, j \leq m \tag{3}
\end{equation*}
$$

for all $a$ in $N_{\phi}$. Conversely, suppose that a self-adjoint element $a$ in $B(\mathcal{H})$ satisfies (3). Then it follows that

$$
\begin{aligned}
\phi(a)^{2}=\sum_{i, j=1}^{m} A_{i}^{*} a A_{i} A_{j}^{*} a A_{j} & =\sum_{i, j=1}^{m} A_{i}^{*} A_{i} A_{j}^{*} a^{2} A_{j} \\
& =\phi(1) \phi\left(a^{2}\right)=\phi\left(a^{2}\right)
\end{aligned}
$$

Here we used the fact that $\phi$ is unital. Hence $N_{\phi}$ is equal to the commutant

$$
N_{\phi}=\left\{A_{i} A_{j}^{*} \quad 1 \leq i, j \leq k\right\}^{\prime}
$$

Second we consider the case that condition (b) of the Steinspring's Theorem fails. Let $\tilde{P}$ be a projection operator in $\mathcal{H} \otimes \mathfrak{h}_{m}$ onto the subspace spanned by $\{(x \otimes 1) V u \mid x \in B(\mathcal{H}), u \in \mathcal{H}\}$. Note that $\tilde{P}$ satisfies

$$
\tilde{P}(x \otimes 1)(y \otimes 1) V u=(x \otimes 1)(y \otimes 1) V u=(x \otimes 1) \tilde{P}(y \otimes 1) V u
$$

This implies

$$
\tilde{P}(x \otimes 1) \tilde{P}=(x \otimes 1) \tilde{P}, \quad \tilde{P}\left(x^{*} \otimes 1\right) \tilde{P}=\left(x^{*} \otimes 1\right) \tilde{P}, \quad x \in B(\mathcal{H}) .
$$

Taking the adjoint of the second equation, we obtain

$$
(x \otimes 1) \tilde{P}=\tilde{P}(x \otimes 1), \quad x \in B(\mathcal{H}) .
$$

By Theorem of 5.9 of [4], all the bounded operator which commutes with $B(\mathcal{H}) \otimes$ 1 belongs to $1 \otimes M_{m}$. So $\tilde{P}$ is of the form $\tilde{P}=1 \otimes P$, where $P$ is a projection in $\mathfrak{h}_{m}$. If $(\mathrm{b})$ is not satisfied, $P \neq 1$. In this case, we define a new orthogonal basis $f_{j}$ of $\mathfrak{h}_{j}$ so that there exists $1 \leq l<m$, such that

$$
\begin{align*}
& P f_{j}=f_{j} \quad \text { for } \quad 1 \leq j \leq l \\
& P f_{j}=0 \quad \text { for } \quad l+1 \leq j \leq m \tag{4}
\end{align*}
$$

The orthonormal basis $\left\{e_{i}\right\}$ and $\left\{f_{j}\right\}$ are connected by a unitary transformation, as

$$
e_{i}=\sum_{j=1}^{m} v_{i, j} f_{j}
$$

Define bounded operators $B_{j} 1 \leq j \leq m$ as

$$
B_{j}=\sum_{i=1}^{m} v_{i, j} A_{i}
$$

Using these relations, we obtain

$$
V u=\sum_{i=1}^{m} A_{i} u \otimes e_{i}=\sum_{j=1}^{m} B_{j} u \otimes f_{j} .
$$

From $(1 \otimes(1-P)) V u=0$ and (4), we have $B_{j}=0$ for $l+1 \leq j \leq m$. We then see that condition (b) is satisfied if and only if $A_{i}$ are linear independent. Now as $\{(x \otimes 1) V u \mid x \in B(\mathcal{H}), u \in \mathcal{H}\}$ is total in $\mathcal{H} \otimes P \mathfrak{h}_{m}=\mathcal{H} \otimes \mathfrak{h}_{l}$, the pair $\left(\mathfrak{h}_{l}, V\right)$ satisfies conditions (a),(b) of the Stinespring's Theorem. So by the preceding arguments, we have

$$
N_{\phi}=\left\{B_{i} B_{j}^{*} \quad 1 \leq i, j \leq l\right\}^{\prime}
$$

On the other hands, as $v_{i, j}$ satisfies

$$
\sum_{j=1}^{m} \overline{v_{i, j}} v_{k, j}=\delta_{i, k},
$$

we have

$$
\sum_{j=1}^{m} \overline{v_{i, j}} B_{j}=\sum_{k, j=1}^{m} \overline{v_{i, j}} v_{k, j} A_{k}=A_{i} .
$$

Hence we have

$$
\left\{B_{i} B_{j}^{*} 1 \leq i, j \leq l\right\}^{\prime} \supset\left\{A_{i} A_{j}^{*} 1 \leq i, j \leq m\right\}^{\prime}
$$

and

$$
\left\{B_{i} B_{j}^{*} 1 \leq i, j \leq l\right\}^{\prime} \subset\left\{A_{i} A_{j}^{*} 1 \leq i, j \leq m\right\}^{\prime}
$$

Therefore, we obtain

$$
N_{\phi}=\left\{B_{i} B_{j}^{*} 1 \leq i, j \leq l\right\}^{\prime}=\left\{A_{i} A_{j}^{*} 1 \leq i, j \leq m\right\}^{\prime},
$$

which completes the proof.

Let us consider the relation between decoherence free algebra $N_{\phi}$ and the fixed points $M_{\phi}$ of $\phi$ defined by

$$
M_{\phi}=\left\{x \in M_{n} \mid \phi(x)=x\right\} .
$$

We have the following Lemma:

Lemma 2.1 Let $\phi$ be a unital trace preserving completely positive map from $M_{n}$ into itself. Then $N_{\phi}$ includes $M_{\phi}$.

Proof
Any $x \in M_{\phi}$ is decomposed into $x=x_{1}+i x_{2}$, where $x_{1}, x_{2}$ are self adjoint elements of $M_{\phi}$. So it suffices to show that any self-adjoint element $x$ of $M_{\phi}$ satisfies $\phi\left(x^{2}\right)=\phi(x)^{2}$. By the inequality (1), we have

$$
\phi\left(x^{2}\right)-x^{2} \geq 0
$$

On the other hands, we have

$$
\operatorname{Tr}\left(\phi\left(x^{2}\right)-x^{2}\right)=0
$$

because $\phi$ is trace preserving. As trace is faithful, we have

$$
\phi\left(x^{2}\right)=x^{2}=\phi(x)^{2},
$$

which completes the proof.
Let $\mathcal{A}$ be a $C^{*}$-algebra generated by $A_{i}$, and $\mathcal{B}$, a $C^{*}$-algebra generated by $A_{i} A_{j}^{*}$. Clearly, $\mathcal{B} \subset \mathcal{A}$ and the following inclusion relation holds:

$$
\mathcal{A}^{\prime} \subset M_{\phi} \subset N_{\phi}=\mathcal{B}^{\prime}
$$

If $A_{i}$ are positive, then $A_{i}=\sqrt{A_{i} A_{i}^{*}} \in \mathcal{B}$, i.e., all the generators of $\mathcal{A}$ is included in $\mathcal{B}$. So we have $\mathcal{A}=\mathcal{B}$, which implies $\mathcal{A}^{\prime}=\mathcal{B}^{\prime}$. In this case, we have

$$
\mathcal{A}^{\prime}=M_{\phi}=N_{\phi}=\mathcal{B}^{\prime}
$$

That is, all the decoherence free elements are fixed points if $A_{i}$ are positive. This is a new proof of a generalized Lüders theorem [5], 6].
