A bstract. Physical constraints such as positivity endow the set of quantum states with a rich geometry if the system dimension is greater than two. To shed some light on the complicated structure of the set of quantum states, we consider a stratication with strata given by unitary orbit manifolds, which can be identieed with agmanifolds. The results are applied to study the geometry of the coherence vector for n-level quantum systems. It is shown that the unitary orbits can be naturally identieed with spheres in R^{n²} 1 only for n = 2. In higher dimensions the coherence vector only de nes a non-surjective embedding into a closed ball. A detailed analysis of the three-level case is presented. Finally, a re ned stratication in terms of symplectic orbits is considered.

1. Introduction

The Bloch vector [1] provides a representation of the quantum states of a two-level system in terms of real observables, and allows the identic cation of quantum states with points in a closed ball in 3D Euclidean space, the Bloch ball, which has proven to be extremely useful. In quantum information theory, for instance, the states of a single qubit can be identied with points on the surface of the Bloch ball (if the state is pure) or points inside the ball (if the state is mixed). Unitary operations can be interpreted as rotations of this ball, and dissipative processes as linear or a ne contractions of the Bloch ball [1, 2].

Naturally, many e orts have been made to generalize the B bch ball to higher dimensions by de ning a generalized coherence vector similar to the B bch vector for two-level system s. However, while it is easy to de ne a B bch 3 or general coherence vector [4, 5] for N -level system s, it has become clear that the geometry of quantum states in higher dimensions is farm ore complex than in the two-level case. Some e orts have been made at determining the set of B bch vectors corresponding to physical states for higher dimensional system s using the higher trace invariants or C asim ir invariants, for instance by K in ura [6], who also demonstrated the complicated and asymmetric structure of the set of B bch vectors in higher dimensions. Byrd and K haneja [7] independently provided a similar characterization of the positivity of the density matrix in terms of the coherence vector representation.

In this paper we pursue a di erent approach to study the structure of quantum states for higher dimensional systems, and the origin of the di erence between the two-level case and higher dimensions. In section II we de ne a natural stratication of the set of density matrices in terms of unitary orbits. We show that the unitary orbits can be identied with a gmanifolds and determine their dimensions. For two-level systems this straticed set can be identied with a smooth realmanifold with boundary, the 3D B loch ball, with strata given by concentric spheres.

In section III we brie y review the de nition of the B bch vector and de ne a general coherence vector, which can be naturally embedded into a closed ball in R^{n^2} ¹. This embedding is surjective for two-level systems, hence allowing the identication of physical states with points in this closed ball. We show that for higher dimensional systems, however, the embedding is never surjective due to positivity constraints, and the dimensions of the orbit manifolds vary depending on the multiplicities of the eigenvalues of the states in each stratum. Furthermore, for two-level systems there exists a total ordering of the strata given by the length of the B bch vector, or the distance of the unitary orbit from the center of the B bch ball { the B bch vector of pure states has length one, and the shorter the B bch vector, the more mixed the state is. For higher dimensional systems we show that the length of the coherence or generalized B bch vector is no longer a su cient measure for the disorder of the system. A detailed analysis of the three-level case concludes section III.

Finally, in section IV we brie y consider a re ned strati cation of the set of density matrices de ned by the action of the sym plectic group. The sym plectic group is of interest because it occurs naturally for quantum system s with certain dynam ical sym metries (such as atom ic system s with degenerate energy levels) and it is the only proper subgroup of the unitary group that acts transitively on certain unitary orbits [10]. We show that the sym plectic orbits of pseudo-pure states agree with the unitary orbits and provide bounds on the dimensions of other sym plectic orbits, showing that the sym plectic orbits generally have much low er dimension. From a control point of

view this means that a 2n-dimensional H am iltonian control system with dynamical Lie group Sp (n) is pure-state controllable but we cannot control generic ensembles.

2. D ensity m atrices and unitary orbits

Throughout this paper we restrict our attention to quantum systems whose H ilbert space is a nite-dimensional complex vector space C^n , where n is an integer greater than one, and for simplicity we will often use V to denote C^n with the standard H emittian inner product h ; i. Any physical state of this system can be represented by a density operator, i.e., a positive semi-de nite (self-adjoint) linear operator with trace one. The subset of rank-one density operators corresponds to pure states of the system , all other density operators to mixed states.

In the following we denote the set of all positive semi-de nite operators on V by P (V), the subset of all density matrices by D (V), and the subset of pure states by D₁(V). We also de ne the class of pseudo-pure states or pure-state-like ensembles as the set of density operators D₁(V) whose spectrum consists of exactly two distinct eigenvalues with multiplicities one and n 1, respectively. It is well known that D (V) form s a convex subset of the set of H erm itian matrices since given two density matrices $_1; _2 2 D$ (V), the straight line path de ned by (t) = (1 t)₁ + t₂ for t2 [D;1] is contained in D (V). To see this, note that (t) is H erm itian, Tr((t)) = 1 and h (t)x jxi = (1 t)h_1x jxi + th_2x jxi 0 for all x 2 Cⁿ and t2 [D;1].

We de ne the orbit of a quantum state under the action of the dynam ical Lie group G to be the set $G := fg \quad {}^1gjg 2$ Gg. The orbits endow the set of quantum states with the structure of a strati ed set. In principle, any Lie group G acting on the set of density operators de nes a strati cation of D (V). However, the orbits under the action of G = U (n) are of particular interest since they determ ine the most general evolution of the quantum states in a closed system. From a control point of view, the unitary orbit of a state represents the maxim alset of states that are reachable from the given state via (open-loop) coherent control, or in the language of quantum computing, by applying a unitary gate to the state.

Before we attempt to classify the orbits, we recall the following standard result from linear algebra:

Proposition 1 Let $_1$ and $_2$ be two density matrices. The following are equivalent:

- (i) 1 and 2 are unitarily equivalent, i.e., $2 = U_1 U^y$ for some unitary matrix U.
- (ii) $_{\rm 1}$ and $_{\rm 2}$ have the same spectrum, i.e., the same eigenvalues including multiplicity.
- (iii) $Tr(\frac{r}{1}) = Tr(\frac{r}{2})$ for all r = 1;2;...;n.

This result shows immediately that the orbit of a density matrix under U (n) is uniquely determined by its spectrum, i.e., two density matrices belong to the same unitary orbit if and only if they have the same eigenvalues $_i$ with the same multiplicities n_i . Each orbit can therefore be represented by a canonical diagonal density matrix of the form

where the eigenvalues shall be ordered such that $_{i} > _{j}$ for i < j to ensure a unique representation. Since the $_{i}$ can be arbitrary real numbers in [0;1] provided they satisfy $_{i=1}^{r} n_{i}$ $_{i} = 1$, we see immediately that there are in nitely many distinct

orbits corresponding to the (uncountably) in nitely many possible choices for the $_i$. Thus, we can say that the unitary group U (n) partitions the set of density matrices D (V) into an uncountably in nite family of (distinct) orbits or strata.

We can de nea (partial) ordering on this strati cation via majorization. Let $_1$, $_2$ be two density operators with eigenvalues $a_m^{(i)}$, i = 1; 2, counted with multiplicity and ordered in a nonincreasing sequence. $_1$ $_2$ if

For instance, $1 = \frac{1}{5}$ diag(1;1;3) $2 = \frac{1}{5}$ diag(2;2;1) since 1 2, 1 + 1 2 + 2 and 1 + 1 + 3 = 2 + 2 + 1. M a prization has been shown to be a useful way to compare the degree of disorder of physical system s [8] and naturally de nes a partial ordering on the unitary orbits (strata) via 1 2 if i = [i] and 1 2. However, note that only some orbits can be compared that way. Consider $1 = \frac{1}{8}$ diag(5;2;1) and $2 = \frac{1}{8}$ diag(4;4;0). We have 5 > 4 but 5 + 2 < 4 + 4. Hence, neither orbit m a prizes the other.

To determ ine the nature of the strata given by the orbits, we de ne the isotropy subgroup or stabilizer at as the subgroup G of elements in G that leave invariant, i.e., for which we have g d = 0. We shall show that the orbit of an element

2 D (V) under the unitary group U (n) can be identified with a certain type of manifold called a agmanifold. For the purpose of proving this result we observe that U (n) is a compact Lie group and hence a compact topological groupz and the space of density matrices is a Hausdor spacex, and we have the following result (see P], for instance):

z A topological group is a topological space X endowed with a group structure that allows us to \multiply" elements of the space and compute inverses such that both operations are continuous with respect to the topology. The unitary group, for instance, is a multiplicative group since multiplication of two unitary matrices gives a unitary matrix, every unitary matrix has an inverse given by the Hermitian conjugate, and the identity provides a neutral element. Furthermore, as a subset of the complex matrices the unitary group is naturally endowed with a topology that allows us to separate two unitary matrices by open sets, and matrix multiplication and Hermitian conjugation are continuous with respect to this topology.

x A Hausdor space basically is a space endowed with a topology that allows us to separate points by disjoint open sets.

C orollary 1 If $2 D_{1^{\circ}}(V)$ (pseudo-pure state) then the orbit of is hom eom orphic to U (n)=[U (1) U (n 1)], which is hom eom orphic to the complex projective space CP^{n-1} .

To illustrate the result, we explicitly compute the orbits under the action of U (n) for n = 2 and n = 3.

Example 1: Let be a 2 2 density matrix. is unitarily equivalent to diag(r;1 r) with 0 r 1. If r = 1 r then $= \frac{1}{2}I_2$ and the orbit of is hom eom orphic to U (2)=U (2), i.e., a single point. O therw ise, its orbit is hom eom orphic to U (2)=[U (1) U (1)]' CP¹.

Since CP^1 is di com orphic to the sphere S^2 , this shows that any U (2) orbit of a two-level system is hom com orphic to S^2 , except the trivial orbit of the com pletely random ensemble $\frac{1}{2}I_2$ which consists of a single point.

Furtherm ore, note that the requirem ent of positivity of reduces to 0 r 1 and hence r^2 r, or equivalently, $Tr(^2) = r^2 + (1 r)^2 = 1 2r + 2r^2 1 2r + 2r = 1$. We shall see that this implies that the set of all 2 2 density matrices (the union of all orbits) is hom eom orphic to a closed ball in \mathbb{R}^3 .

Thus, we have a neat m athem atical justication for the Bloch ball description of a two-level system, which will be discussed in detail later.

Example 2: Let be a 3 3 density matrix. If has only one eigenvalue with multiplicity 3 then $=\frac{1}{3}I_3$ and its orbit is how eom orphic to U (3)=U (3), which is a single point as before.

If has two distinct eigenvalues then it is a pseudo-pure state unitarily equivalent to = diag(1 2a;a;a) where 0 a 1 and a $\notin \frac{1}{3}$. Its isotropy subgroup is therefore U (1) U (2), and its orbit is hom eom orphic to U (3)=[U (1) U (2)] and has dimension 9 1 4 = 4.

If is a generic ensemble with three distinct eigenvalues a_ib_ic then its canonical form is = diag(a_ib_ic) and its isotropy subgroup is U (1) U (1) U (1). Hence, its orbit is hom eom orphic to U (3)=[U (1) U (1) U (1)] and has reald in ension 9 3 = 6.

The results of the previous example are summarized in the Table 1. The table also provides a complete classic cation of the orbits for n = 4.

The previous two examples clearly show the di erence between two-level systems s and higher dimensional systems (n > 2). While all orbit manifolds (except the trivial orbit of the completely random ensemble) for two-level systems are homemorphic to a sphere, no such homeomorphism is possible in the latter case, i.e., the orbit manifolds for higher dimensional systems can never be identied with spheres in a higher dimensional Euclidean space. That is, although we can always embed the quantum states of the system in a compact subset (closed ball) of a real vector space of su ciently high dimension, there is no one-to-one correspondence between spheres in this ball and orbits of quantum states, except for n = 2, which explains the di culties one encounters when trying to generalize intuitive reasoning valid for the B loch ball for n = 2 to B loch vectors in higher dimensions.

3. C oherence vector and em beddings of quantum states

3.1. De nition of B loch or coherence vector

For a two-level system any density operator can be expanded as

where I_2 is the 2D identity matrix, and x = jlih2j jlih1j, y = i(jlih2j + jlih1j) and z = i(jlih1j + jlih2j) are the usual (unnorm alized) 2D Paulim atrices. The coordinates x, y and z are real since the Paulim atrices are Hermitian and = Tr() for $= x_i y_i z_i$. Hence, the state of any two-level system can be characterized completely by the real vector $s = (x_i y_i z)$, called the B boch vector.

For an n-level system we can proceed in a similar fashion. Let

where $\mathbf{s}_k = \text{Tr}(\gamma_k)$ for $k = 1; \dots; n^2$ 1. The resulting real vector $\mathbf{s} = (\mathbf{s}_k)_{k=1}^{n^2-1}$ is the Bloch vector of the n-dimensional system.

A lthough the B loch vector de ned above is useful, it is generally more elegant, and often more convenient, to work with an orthonormal basis. To this end, we de ne the normalized Paulimatrices f $_{k}g_{k=1}^{n^{2}-1} = f_{\frac{p_{1}}{2}} \sim_{k} g_{k=1}^{n^{2}-1}$, which satisfy the orthonormality condition

Furtherm ore, $f_k jk = 1; :::; n^2$ 1g together with $_0 = \frac{1}{p_n} I_n$ form s an orthonorm all basis for all H erm itian n n m atrices, and we can expand any density m atrix in term s of this 0 N basis

where $s_k = Tr(k)$ for $k = 0; ...; n^2$ 1. Since $1 = Tr(k) = \frac{p_k}{n} s_0$, we have $s_0 = \frac{1}{n}$ for all density matrices. Hence, is completely determined by the real n^2 1 vector $s = (s_1; ...; s_{n^2-1})$. This vector is often called the general coherence vector. Equations (5) and (7) are equivalent, and we easily see that s = 2s, i.e., the standard B loch vector di ers from the coherence vector only by a factor of 2.

It is easy to verify that the mapping that takes to the real coherence vector s, or equivalently the B boch vector s = 2s, de nes an embedding of the density matrices into a closed ball in R^{n^2-1} for all n > 1. However, the two-level case is special in that the embedding de ned is surjective. We shall now discuss the nature of the resulting di erences between the n = 2 and n > 2 case, and provide a detailed analysis of the three-level case.

3.2. Bloch ball picture for n = 2

For two-level systems the embedding de ned above is not only one-to-one but also surjective, and hence provides a hom eom orphism between orbits of density matrices under U (n) and the closed ballof radius one (B loch vector as de ned above) or radius $\frac{1}{2}$ (coherence vector as de ned above) in R³. Unitary transform ations of a density matrix can be interpreted as real rotations of the this ball. Example 1 shows that the action of the unitary group on the set of quantum states partitions it into an uncountably in nite num ber of distinct orbit manifolds, hom eom orphic to concentric, two-dimensional spheres in the B loch ball, with the exception of the trivial orbit of the completely random ensemble, which is mapped to the single point at the center of the ball.

It is also easy to see that the distance of an orbit from the center of the ball is determined by $Tr(^2)$ via $r = 2Tr(^2) - 1$ (B both vector) or $r = Tr(^2) - \frac{1}{2}$ (coherence vector). Pure states ($Tr(^2) = 1$) have maximal distance from the center of the ball and hence form its boundary. Furthermore, the disorder of an orbit is completely determined by its distance r() from the center, i.e., 1 = 2 if $r(_1) < r(_2)$.

From the point of view of controllability of quantum systems, it is also worth noting that all orbits (with the exception of the completely random ensemble) have the same dimension and geometry. Hence, any group that acts transitively on the class of pure states, for instance, will also act transitively on all classes of mixed states and vice versa. Of course, the only such groups are U (2) or SU (2). Hence, pure-state and mixed-state controllability are equivalent notions for two-level system s.

3.3. B bch ball picture for n > 2

For n > 2 the situation is quite di erent due to the fact that the embedding into a closed ball in R^{n^2} de ned by γ s is not surjective. It is easy to see that the distance of each unitary orbit from the center in R^{n^2} remains completely determined O rbits of quantum states and geom etry of B bch vectors for N -level system s

by Tr(2):

However, a glance at the dimensions of the orbits in Table 1 shows immediately that each orbit is only a submanifold of a sphere of a xed distance from the origin. For instance, as we have shown in the previous section, the orbit of pure states for n = 3corresponds to a four-dimensional submanifold of the seven-dimensional boundary sphere with radius $1 \frac{1}{3}$ in R⁸. Since there is only a single orbit of pure states, the remainder of the points on the boundary sphere do not correspond to physical states.

For mixed states the situation is more complicated since each sphere of xed radius r from the origin now generally contains an uncountably in nite number of distinct orbits, all satisfying Tr(m) = 1 and $Tr(\frac{2}{m}) = r^2$ but di ering in higher trace invariants, e.g., $Tr(\frac{k}{m}) \in Tr(\frac{k}{m}_0)$ for som $e^2 < k$ n. The dimensions of the orbits contained within each sphere vary depending on the type of ensem ble but each sphere (except for the boundary) generally contains a set of positive m easure of orbits corresponding to physical states, and often a positive measure set of points that do not belong to physical orbits. Moreover, the degree of disorder of an orbit can no longer be properly characterized by its distance from the center of the ball. Orbits contained in the same sphere can often not be compared with respect to our partial ordering and may have di erent von-N eum ann entropy. Furtherm ore, orbits at di erent distances from the origin may have the same von-N eum ann entropy.

3.4. Analysis of n = 3 case

To illustrate the general statem ents above, let us consider the n = 3 case and the set of orbits determ ined by the fam ily of states = diag(a;b;c) with b;c given by

Note that we have Tr() = a + b + c = 1 and Tr(²) = c_2 for all a. However, for

to represent a physical state a;b;c m ust be real and have values in [0;1]. These constraints in ply that the argument of K m ust be non-negative and K 1 a, or equivalently K^2 (1 a)². This yields the inequalities

which must be simultaneously satis ed. To ensure that there is a one-to-one correspondence between parameter values $(a;c_2)$ and orbits, we further require a b c. 


Figure 1. Diagram indicating parameter values corresponding to physical orbits

Fig. 1 illustrates the situation. The solid curve corresponds to $3a^2 2a + 1 = 2c_2$, the dash-dot line to $6a^2 4a + 1 = c_2$ and the dashed line to $2a^2 2a + 1 = c_2$. The points $(a;c_2)$ on the solid line correspond to orbits of pseudo-pure states = diag $(a;\frac{1}{2}(1 a);\frac{1}{2}(1 a))$, and the points on dash-dot line correspond to orbits of pseudo-pure states of the form = diag(a;a;1 2a). The points below the solid curve correspond to non-Hem itian matrices. The points $(a;c_2)$ above the dashed line correspond to non-positive Hem itian matrices. The points between these two curves represent physical states. However, only points in the shaded region between the curves satisfy all inequalities and represent unique orbits.

The gure also shows that for any $q \ 2 \ (\frac{1}{3};1)$, there exists a positive-measure set (interval) of a-values that correspond to distinct physical orbits, embedded in a sphere of xed radius $r = c_2 \ \frac{1}{3}$ from the origin. This shows that the number of $q \ -$ distinct orbits contained within each sphere of radius $0 < r < \ \frac{2}{3}$ is uncountably in nite. A unique orbit of xed distance from the center of the ball exists only for the special cases $c_2 = \frac{1}{3}$ and $c_2 = 1$, the form er corresponding to the trivial (i.e., zero-dimensional) orbit of the completely random ensemble $a = b = c = \frac{1}{3}$ that form s the center of the ball, and the latter to the four-dimensional orbit of pure states contained within the boundary sphere of the ball. Most of these orbits are generic and hence have dimension six. How ever, each sphere also contains at least one (two if




Figure 2.a + b = (1 + a + K) = 2 as a function of a for various values of c_2


Furtherm one, for $c_2 = \frac{1}{2}$ all values of $(a;c_2)$ that correspond to H erm itian m atrices actually correspond to positive H erm itian operators, i.e., physical states. Hence, the union of all orbits with $c_2 = \frac{1}{2}$ lls a ball of radius $\frac{1}{r_6}$. For $c_2 = \frac{1}{2}$, however, the positivity constraint kicks in and elim inates m ore and m ore a-values as c_2 approaches one. This means that the physical orbits inside the ball get sparser as c_2 increases. However, for each $c_2 < 1$ the orbits always occupy a positive measure set of the sphere S^7 they are embedded in since for each $c_2 < 1$ there is a 1D set of positive measure of a values representing disjoint physical orbits of dimension six. Hence, the union of these orbits (not counting the one or two pseudo-pure orbits) occupies a set of positive measure inside each seven-dimensional sphere S^7 . For $c_2 = 1$ the positivity constraint elim inates all a-values but a = 1 and hence the boundary sphere contains only the single four-dimensional orbit of proper pure states.

As regards the ordering of orbits, we have $[a;c_2]$ $[a;c_2^0]$ if $c_2 < c_2^0$ since K $(a;c_2) < K (a;c_2^0)$ for $c_2 < c_2^0$ and a xed. In general, however, we cannot compare orbits that have the same distance from the origin since $a + b = \frac{1}{2}(1 + a + K)$ is m onotonically decreasing over the valid range of a for $c_2 > \frac{1}{2}$, and non-m onotonic for $c - \frac{1}{2}$, i.e., $a < a^0$ typically implies $a + b > a^0 + b^0$. See Fig. 2 for a plot of $a + b = \frac{1}{2}(1 + a + K)$ as a function of a for various values of c_2 . Fig. 3, for comparison, shows a plot of the von-N eum ann entropy of the orbits S []= [a log(a) + b log(b) + c log(c)] as a function of a. A lso note that for su ciently large values of S, there are m any orbits of varying distance from the center with the same von-N eum ann entropy S although for xed a the orbits with the largest distance from the center have the smallest entropy, which is in accord with our partial ordering of the orbits.

4. A ctions of the sym plectic group

In the previous sections we have shown that the action of the unitary group on the set of quantum states endows it with the structure of a strati ed set and studied the properties of the strata de ned by the unitary orbit manifolds. This strati cation of

the set of density matrices was justimed on physical grounds since the dynamics of a (closed) quantum system is usually determined by the action of the unitary group.

Some physical systems, how ever, exhibit symmetries that restrict the dynamics to a proper subgroup of the unitary group. For instance, the dynamics of an atom ic system comprising twon-fold degenerate energy levels subject to coherent control elds of various polarizations is governed by the symplectic group Sp(n) due to dynamical symmetries [10]. Physical systems that exhibit symplectic symmetry are also of special interest in quantum control since they are pure-state controllable but lack mixed-state controllability [10]. This means, for instance, that we can steer the system from any pure initial state to any other pure state; how ever, if the system is initially in a mixed state, then it may not be possible to steer it to another mixed state even if this state is unitarily equivalent to the initial state, since the set of unitary operations at our disposal is limited and there may not be a sympletic unitary transform ation that achieves the desired aim [11].

The action of the sym plectic group also induces a strati cation of the set of density m atrices. Since the sym pletic group Sp (n) is a subgroup of the unitary group U (2n), it naturally follows that the sym pletic orbits are smaller than the unitary orbits. Hence, there will be more sym pletic orbits. We can also think of the action of the sym plectic group as partitioning the unitary orbits into sym plectic suborbits. The strati cation induced by the sym plectic group is therefore a remement of the strati cation induced by U (2n). The remainder of this section is devoted to exploring the relation between the sym plectic and unitary orbits / strati cation.

M athem atically, the symplectic group Sp(n) is the subgroup of unitary transform ations A 2 U (2n) that satisfy $A^T J A = J$ for

where I_n is the identity matrix in dimension n. Note that, technically, any group G that satis es $fS^T JS = J j8S 2$ G g for a matrix J unitarily equivalent to the J in (14) is a representation of Sp (n) but we shall assume the standard representation with J as in (14) here. The condition $S^T JS = J$ then in plies that any 2n 2n complex

matrix S 2 Sp(n) must be of the form

$$S = \begin{pmatrix} A & B \\ B & A \end{pmatrix}$$

where A and B are n n complex matrices and A denotes the complex conjugate of the A .

We now show that Sp(n) acts transitively on the unitary orbits of some states, but for the majority of states the symplectic orbits have lower dimension than the unitary orbits. The following results are an extension of earlier results showing that Sp(n) acts transitively only on pure-state-like and completely random ensembles [11].

P roposition 3 If is the completely random ensemble $\frac{1}{2n} I_{2n}$ or a pseudo-pure state then its orbit under Sp(n) is the same as the orbit under U (2n), i.e., Sp(n) acts transitively on this orbit.

Proof: The orbit of any pseudo-pure state 2 D_{1°} (V) under U (2n) is hom eom orphic to CP^{2n 1} by corollary 1. The assertion that Sp(n) acts transitively on the unitary orbits of pseudo-pure states hence follows directly from the well-known fact that Sp(n) acts transitively on CP^{2n 1} via the isom orphism : Hⁿ $\bar{!}$ C²ⁿ discussed in Appendix A. Since the orbit of $= \frac{1}{2n} I_{2n}$ under U (2n) consists of a single point, the assertion that Sp(n) acts transitively on this orbit is trivial. ■

P roposition 4 Let = diag($_{1}$; P_{2n}^{2n}) where 0 $_{i}$ 1 are the eigenvalues of counted with multiplicity, satisfying $P_{i=1}^{2n}$ $_{i}$ = 1. Then the orbit of is a hom ogeneous manifold of real dimension at most $2n^{2}$.

Proof: Since is diagonal the isotropy subgroup G contains the maximal torus T^n of Sp(n), namely all matrices of the form diag(z_1 ; $_n$; z_1 ; $_n$) with $z_1 \ge U(1)$ / S¹. Since G is a closed subgroup of the Lie group Sp(n), Proposition 2 im plies that the orbit is a hom ogeneous manifold of real dimension no more than dim_R (Sp(n)=Tⁿ) = n(2n + 1) $n = 2n^2$.

For certain special cases we can improve this bound on the orbit dimensions.

Proposition 5 If = diag($_n$; $_n$) where $_n$ is a diagonal n n density matrix but not a multiple of I_n then the sympletic orbit of is a hom ogeneous manifold of real dimension at most $2n^2$ 1. If = diag(aI_n ; bI_n) with 0 a; b 1 and a ϵ b then the orbit of under Sp(n) is a hom ogeneous manifold of real dimension $n^2 + n$.

Proof: In the form er case, observe that the isotropy subgroup at contains not only the maximal torus T^n , but all matrices of the form fzJ jz 2 S¹g. Since the matrix J is not symplectic-equivalent to any element of the maximal torus T^n , the rst statement follows immediately from the previous proposition.

In the second case, note that any elem ent Q that belongs to the isotropy subgroup at must satisfy Q Q^Y = . Since Q must also be in Sp(n), it must be of the form (15) for som e A; B 2 endo_c (Cⁿ). This im plies the matrices A and B must satisfy the relations: $aAA^{Y} + bBB^{Y} = aI_n$ and $aBB^{Y} + bAA^{Y} = bI_n$ and hence $ab(a^2 b^2)BB^{Y} = 0$. As 0 < a;b; < 1 and $a \notin b$ by assumption, we must have B = 0 and A 2 U (n). Thus, the isotropy subgroup at is A = 00 = A with A 2 U (n). By Theorem 1, the orbit of is a hom ogeneous manifold of real dimension n (2n + 1) $n^2 = n^2 + n$.

P roposition 6 If = diag(D_{2n}_{2} ; I_{2}), where D_{2n}_{2} is a diagonal (2n 2') (2n 2') complex matrix, I_{2} is the identity 2' 2' complex matrix, and 2 [0;1], then the orbit of is a hom ogeneous manifold of real dimension at most n (2n + 1) '(2'+ 1). P roof: We note the isotropy subgroup at contains the group I_{2n}_{2} , 0_{22} , jQ 2 Sp(')g, which is isom orphic to the subgroup Sp('). Hence, the orbit of is a hom ogeneous manifold of real dimension at most n (2n + 1) '(2'+ 1).

as desired.

In table 2 we compare the dimensions of the orbits of various types of ensembles under U (2n) with those of the orbits under Sp(n) for n = 2 and n = 3. The classi cation of the orbits is based on the spectrum of . Note that the spectrum of uniquely determ ines the unitary orbit (or equivalence class) belongs to. How ever, two density matrices with the same spectrum may belong to di erent symplectic orbits. For instance, $_0 = \text{diag}(a;b;a;b)$ and $_1 = \text{diag}(a;a;b;b)$ are unitarily equivalent but belong to di erent orbits under the symplectic group as de ned above. See example 1 in [11].

5. Conclusion

We have shown that the action of a Lie group on the set of quantum states endows it with the structure of a strati ed set with strata given by the orbit manifolds. In particular, we studied the strati cation of the set of states induced by the action of the unitary group, which is especially useful since the unitary orbits are of interest in quantum control and computing, where they determ ine the maxim all set of quantum states that are reachable from a given set via a coherent control or by applying a unitary gate. Furtherm ore, there are many properties of quantum states such as von-Neum ann or Renyi entropy that depend only on the unitary orbit the state belongs to. It therefore makes sense to de ne these functions on the unitary strati cation. We have shown that the unitary orbits can be identied with ag manifolds whose type and dimension depend only on the multiplicity of the eigenvalues of the states belonging to the orbit. We have also determ ined the dimensions of the orbit manifolds and shown that we can de ne a partial ordering related to the degree of disorder in the system on this strati cation via majorization.

To better understand the geom etry and structure of the set of quantum states, we studied the embedding of the quantum states and their associated orbit manifolds of an n-level system into realEuclidean space provided by the coherence vector. We showed that the coherence vector we de ned always maps the quantum states into a closed ball in \mathbb{R}^{n^2-1} in such a manner that the orbit manifolds are mapped to submanifolds of spheres of xed radius from the center. For n = 2 this embedding is surjective, hence justifying the identication of the set of quantum states with the closed ball in R³, and the identic cation of the orbits with concentric spheres inside this ball. By comparing the dimensions of the orbits we also showed that this embedding is no longer surjective for n > 2 and the orbit m anifolds in this case are proper submanifolds of spheres in \mathbb{R}^{n^2-1} of lower dimension. The manifold of pure states is always a submanifold of the boundary sphere, which contains no other orbits, while all other spheres of xed distance from the center generally contain in nitely many dispint orbits of varying dimensions, and depending on the distance of the sphere from the center, a positive m easure set of points which do not correspond to quantum states at all. A detailed analysis for the three-level case was provided.

Finally, we studied system s whose natural evolution is restricted to a subgroup of the unitary group such as the symplectic group due to dynamical symmetries. We showed that we can de neare ned stratic cation based on the smaller orbits of this subgroup. In case of the symplectic group we have shown that the orbits of all pseudo-pure states agree with the unitary orbits, while the symplectic orbits of all other (mixed) states have lower dimension than the unitary orbits. From the point of view of control this means that we can control pure and pseudo pure states for such system s but not generic ensembles.

Appendix A. The sym plectic group

The sym plectic group Sp(n) is usually de ned as the Lie group of autom orphism s on Hⁿ, where H is the skew – eld of quaternions, that preserve the canonical sym plectic inner product

$$hq jq^0 i = \sum_{i=1}^{X^n} q_i q_i^0;$$

where q and q^0 are n-vectors whose entries q_i are quaternions and conjugation q is over ${\tt H}$.

The (skew - eld) of quaternions H can be regarded as a vector space over R with the standard basis f1; e_1 ; e_2 ; e_3 g subject to the multiplicative relations: $e_i^2 = 1$ for 1 i 3 and $e_ie_j = e_je_i = e_k$ for any even permutation (i; j;k) of the set (1;2;3). Since the eld of complex numbers C is isomorphic to R 1 R₁ end every quaternion q can be written as

$$q = q_0 + q_1e_1 + q_2e_2 + q_3e_3 = (q_0 + q_1e_1) + e_2(q_2 - q_3e_1);$$

we may also regard H as a vector space over C with basis f1;e₂g. We therefore obtain an isomorphism $: H^n ! C^{2n}$ of complex vector spaces via $(q_1; n) \neq (z_1; 2n; z where q_i = z_i + z_{n+1}e_2 . Consequently,$

Since A preserves the canonical H erm itian inner product on C^{2n} , A 2 U (2n). Since A leaves invariant the canonical skew -sym m etric bilinear form S (;), it is equivalent to having $A^T J A = J$.
