## M easuring Polynom ial Invariants of Multi-Party Quantum States

W e present networks for directly estimating the polynom ial invariants of multiparty quantum states under local transform ations. The structure of these networks is closely related to the structure of the invariants them selves and this lends a physical interpretation to these otherwise abstract m athem atical quantities. Speci cally, our networks estimate the invariants under local unitary (LU) transform ations and under stochastic local operations and classical communication (SLOCC).Our networks can estimate the LU invariants formultiparty states, where each party can have a Hilbert space of arbitrary dimension and the SLOCC invariants formulti-qubit states. W e analyze the statistical e ciency of our networks com pared to m ethods based on estimating the state coe cients and calculating the invariants.

# I. IN TRODUCTION

Entanglement is a key resource in quantum information and computation since it can be used to perform tasks such as teleportation, super-dense coding and key distribution. Therefore, it is important to nd ways of classifying and quantifying the entanglement properties of quantum states. Central to this is the idea that locally invariant quantities can be used to characterize entanglement. Invariants under Local Unitary (LU) and more general transformations, such as Stochastic Local Operations and Classical Communication (SLOCC), have been extensively studied in this context [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12].

However, invariants are rather abstract m athem atical objects and it is natural to ask whether any physical m eaning can be given to them. One way of doing this is to investigate how these quantities m ight be m easured given a number of copies of an unknown state. This could be done by simply m easuring the coe cients of the state and then calculating the invariants. How ever, nding procedures to m easure the invariants directly m ay be m ore e cient and also lends the invariants a physical interpretation as \collective observables" of the state.

For bipartite pure states, the Schm idt coe cients are a complete set of LU invariants and optim al protocols for measuring them were given in [13]. A lso, in [14] a m ethod was given for estimating the polynom ial SLOCC invariants of a general two-qubit state.

In this paper we present networks for estimating two classes of polynom ial invariants for multi-party states: the LU invariants for multi-party states with arbitrary localH ilbert space dimension and the SLOCC invariants for multi-qubit states. In both cases, the protocol works for both pure and mixed states. In particular, the structure of the networks re ects the structure of the invariants in a very simple way.

In xII, we review the construction of local invariants under LU transform ations and in xIII, the networks for m easuring these invariants are presented. We then turn to invariants under SLOCC transform ations, reviewing their construction in xIV and presenting networks to measure them in xV. In order to construct the networks for SLOCC invariants we make use of the Structural Physical Approxim ation (SPA) to non-physical maps introduced in [15]. The relevant details of this are presented in xV I. Finally, in xV II we evaluate estim ation protocols based on our networks by comparing them to simple techniques based on estim ating the state coe cients.

# II. POLYNOM IAL INVARIANTS UNDER LU TRANSFORMATIONS

A. Pure states

Two n-party pure states j i; j <sup>0</sup>i 2  $\sum_{j=1}^{N} C^{d_j}$  are equivalent under LU transform ations if

where U<sub>j</sub> 2 U (d<sub>j</sub>) is a unitary operation acting on the H ilbert space of the jth party. States on the same orbit under this action have the same entanglement properties. G iven a particular state, we might be interested in determining which orbit it belongs to. This can be done by establishing a canonical point on each orbit, such as the Schmidt form for bipartite states. However, canonical forms rapidly become more complicated as the number of parties is increased. A lternatively, we can construct polynom ial functions of the state coe cients that are invariant on each orbit. Theorems from invariant theory guarantee that a nite set of such polynom ials is enough to distinguish the generic orbits under this action. We now review the construction of such a set.




FIG.1: D iagram m atic representation of the quartic two-qubit LU invariant J, given in eq.(4). The rst index of each term is represented by a circle and the second by a square. A line joins indices that are contracted with a  $\cdot$ .

# 1. One party

Consider the state  $j = \sum_{i=1}^{P} \sum_{j=1}^{d} i j j i$  in a single party H ilbert space C<sup>d</sup>, where fjig is an orthonormal basis. The only independent invariant under unitary transformations of this state is the norm h j i. This may be written as

$$h j i = \begin{bmatrix} X & X & & \\ i & i & \\ & i & & \\ & & i & \\ & & & i & j \end{bmatrix}$$

where i = j is the K ronecker delta. i = j is the U (d) invariant tensor and invariants for larger numbers of parties are formed by similar contractions of the state coe cients with their complex conjugates.

#### 2. Two qubits

As an example, consider a two-qubit state  $j i = P_{\substack{1 \\ i,j=0}}^{1} j j j i$ . There is only one independent quadratic invariant, which is simply the norm of the state. How - ever, at quartic order we nd the following invariant, which is functionally independent of the norm

For two qubits, we know that this is the only other independent invariant because every state has a canonical Schmidt form  $j i = {p \over p} j 0 i + {p \over 1} p j 1 i$ , with 1=2 p 1 and J = 2 (p<sup>2</sup> p) + 1 determ inesp uniquely.

A nother useful way of representing the invariant is to de netwo permutations ; on the set f1;2g where is the identity permutation and (1) = 2; (2) = 1. Then

This also suggests a diagram m atic way of representing the invariant (see g. 1).

## 3. General case

A multipartite pure state can be written in terms of an orthonorm albasis as follows

A general polynom ial function of the state coe cients and their com plex conjugates can be written as

If the polynom ial (6) has equal numbers of 's and 's and all the indices of the 's are contracted using the invariant tensor with those of the 's, each index being contracted with an index corresponding to the sam e party then the polynom ial is manifestly invariant under LU transform ations.

Such polynom ials can be written in terms of permutations on the indices. Let r be the degree of the polynom ial in (and hence also the degree in ). Let ; ; ::: be permutations acting on the set f1;2;:::;rg and let ~ = (; ; ;:::). Then the invariants can be written as:

In fact, can always be chosen to be the identity permutation by permuting the terms in this expression. Additionally, each  $J_{-}$  can be associated with a diagram constructed in the same way as g.1.

The invariants  $J_{\sim}$  are enough to completely distinguish the generic orbits under LU transformations. In fact, invariant theory guarantees that only a nite collection of them are needed to do this. However, except in a few simple cases, it is unknown which  $J_{\sim}$  invariants form m inim al complete sets.

#### B. M ixed states

Twomixed states ;  $^{0}$  are equivalent under LU transform ations if

The LU invariants for m ixed states can be derived by rew riting the pure state invariants (7) in terms of the density m atrix = j ih j and noting that the resulting expressions are still invariant under LU transform ations for general density m atrices. This can be done by noting that terms such as  $i_1 j_1 \cdots i_{j_2 j_2} \cdots$  are elements of the density m atrix. A general density m atrix m ay be written in terms of an orthonorm albasis as




FIG.2: General construction of network to measure polynomialLU invariants.

and the corresponding expression for an LU invariant is

## III. MEASURING INVARIANTS UNDER LU TRANSFORMATIONS

## A. Network construction

The general construction of the network used to measure the LU invariants is shown in g.2. It generalizes networks for estimating functionals of bipartite states given in [14, 16, 17]. To measure an LU invariant of degree r in (and also degree r in ) we take r copies of the unknown state . In addition, we take a single qubit in the state Di and apply a Hadam and rotation H to transform the state to  $\frac{1}{2}$  (Di + Ji). In the next step, we apply a unitary operation U on the r copies of controlled by the Hadam and rotated qubit. Finally we perform a measurement on the single qubit in the fDi; Jig basis. The expectation value of this measurement will be

W hen = j ih j is a pure state then this is equivalent to

In order to determ ine networks for measuring the LU invariants, it only remains to show that there is a U such that the invariants can be expressed in the form (11).

To do this for pure states, we have to express polynomials of the form (7) in the form of (12). Firstly, we note that  $^{ijk}$ ::: = hijk ::: j i,  $_{ijk}$ ::: = h jijk ::: i and to each permutation in (7) we associate a permutation matrix




FIG.3: Network form easuring the 2-qubit quartic invariant.

where P acts on the H ibert space of the same party for each of the r copies of the state j i. Then to each ~ we associate the permutation matrix

where P ; P ; P ;::: act on the H ilbert space of the same party as ; ; ;::: in (7) on each of the r copies of the state. Then (7) can be written as

Since  $P_{\sim}$  is unitary these invariants can be estimated with the network in g.2 by setting  $U = P_{\sim}$  to obtain the real part and  $U = iP_{\sim}$  to obtain the imaginary part. For the speci c example of the 2-qubit invariant (3) we have

Note also that the physical construction of  $P_{\sim}$  is closely related to the diagram associated with  $J_{\sim}$  (compare gs. 1 and 3 for example).

Finally, note that if is a mixed state then applying the same procedure without modi cation will give the invariants of eq. (10).

It has previously been noted [6] that all hom ogeneous polynom ialLU invariants are determ ined by the expectation values of two observables on r copies of a state. Here, we have given an explicit network for measuring these observables. A lso, sim ilar constructions can be made to estim ate other polynom ial functionals of quantum states [17] and these can be modiled to enable the estimation to proceed by LOCC [18], i.e. with no collective operations over the n-parties. A similar modil cation would enable the LU invariants to be estimated by LOCC, but this would a ect the eligible construction discussed in xV IIB.

# IV. POLYNOM TAL INVARIANTSUNDER SLOCC

W hen attempting to classify entanglement, it is often useful to consider invariants under local transformations that are more general than unitary transform ations. For this purpose, invariants under SLOCC have been introduced [19]. In xV we construct a network to measure the modulus squared of these invariants for the case where each party has a single qubit (i.e. the H ilbert space is ( $\mathbb{C}^2$ )<sup>n</sup>).

## A. Pure states

Two n-party pure states j i and j <sup>0</sup>i are equivalent under SLOCC if it is possible to obtain j <sup>0</sup>i with nonzero probability via a sequence of LocalO perations and ClassicalCommunication (LOCC) starting from a single copy of j i and vice-versa. In [20], this criterion was shown to be equivalent to

where M  $_{\rm j}$  2 GL  $(d_{\rm j})$  is an invertible linear transform ation acting on the  $d_{\rm j}\text{-}dim$  ensional H ibert space of the jth party.

In what follows, we nd polynom ial invariants for the special case where M  $_j$  2 SL (2), i.e. the transform ation has unit determ inant and each party has a single qubit. Networks to determ ine the m odulus squared of these invariants will be given in xV. Note that it is not possible to measure the SL (2)<sup>n</sup> invariants directly because they are not invariant under global phase transform ations j i! e<sup>i</sup> j i, which have no physical signi cance. It is for this reason that we instead measure the modulus squared, which is invariant under these phase transform mations.

Under general GL (2)<sup>n</sup> transform ations, the polynomial SL (2)<sup>n</sup> invariants are still invariant up to a multiplicative factor, which is just some power of the determinant of M<sub>1</sub> M<sub>2</sub> ::: M<sub>n</sub>. Thus, ratios of appropriate powers of these polynomials will be invariants under GL (2)<sup>n</sup>.

#### 1. Two qubits

In order to illustrate the polynom ial invariants under  $SL(2)_{P'}^{n}$ , rst consider the case where n = 2. Two states  $j i = {2 \atop j;k=1}^{jk} jki$  and  $j^{0}i = {2 \atop j;k=1}^{0jk} jki$  satisfy (17) if

This means that det() = det( $^{0}$ ) is an SL(2) SL(2) invariant, since det( $M_{1}$ ) = det( $M_{2}$ ) = 1. This may be written as

where the totally antisymmetric tensor  $_{ij}$  is the SL (2) invariant tensor. For two qubit pure states, this is the only independent SL (2) SL (2) invariant.

# 2. General case

The SL  $(2)^n$  invariants can be constructed in a similar way to the LU invariants except the invariant tensor is now <sub>ij</sub>, and we contract 's with 's instead of 's. Thus, polynom ials of the form

are manifestly invariant. Note that it is straightforward to generalize this construction to the case where each party has a d-dimensional H ilbert space by contracting with the SL (d)<sup>n</sup> invariant tensor  $_{i_1 i_2 ::: i_d}$  instead of  $_{ij}$ . However, it is not yet clear how to measure these invariants because the e ect of the higher rank tensors cannot be physically implemented by linear transform ations on states.

### B. M ixed states

In general, two m ixed states ; <sup>0</sup> are equivalent under SLOCC if there exists two completely positive m aps  $E_1;E_2$  which are implementable via LOCC with non-zero probability of success such that <sup>0</sup> =  $E_1$  () and =  $E_2$  (<sup>0</sup>). In order derive invariants using the expressions from the previous section, we will restrict to the case where and <sup>0</sup> are related by

with M  $_{\rm j}$  2 SL (2). The resulting expressions m ay not be invariant under m ore general SLOCC transform ations, but are related to important quantities in entanglem ent theory as described in xIV C

Unlike the LU invariants, it is not clear that (20) can be written simply in terms of the coe cients of the density matrix = j ih j. However,  $\chi_{\sim}^2$  can be written as follows

and these will also be  $SL(2)^n$  invariants form ixed states.

#### C. Exam ples of SL (2)<sup>n</sup> invariants

The K  $_{\sim}$  invariants are especially interesting in entanglem ent theory because many important entanglem ent measures can be easily calculated from them. For example, in the case of two-qubits, the concurrence [21] is de ned as a simple function of the eigenvalues of ~, where




FIG. 4: Diagram m atic representation of the 3-tangle. The rst index of each term is represented by a circle, the second by a square and the third by a triangle. A line joins indices that are contracted with an .

and <sup>T</sup> stands for transpose in the computational basis. These eigenvalues can be calculated from Tr(( ~)<sup>m</sup>) for m = 1;2;3;4, which are simply the moduli squared of K ~ invariants. In [14], networks were constructed to estimate these invariants for two qubits and we will generalize this construction to K ~ invariants for larger num bers of parties.

A nother interesting example is the 3-tangle [22, 23], which is de ned for pure states as the modulus of the following 3-qubit K  $_{\sim}$  invariant.

The 3-tangle gives inform ation about the genuine 3-party entanglem ent between the qubits.

F inally, note that the K  $\sim$  invariants can be given sim – ilar diagram m atic representations to the J $_{\sim}$  invariants. This is illustrated for the 3-tangle in g.4.

The modulus squared of the SLOCC invariants can be measured using a network similar to g. 2 except that the unknown states must be preprocessed prior to the controlled-U operation. If K<sub>~</sub> is of degree r in then we will need r copies of . The preprocessing stage will consist of collective unitary operations and completely positive maps that act on the entire H ilbert space of the r copies of . The resulting state <sup>0</sup>, will yield the expectation value

for the measurement at the end of the network. In this section, we describe the preprocessing operations and unitary operations U that enable the modulus squared of the SLOCC invariants to be written in this form.

First, we apply the inverse of the permutation matrix associated with ~ to the roopies of to obtain  $P_{2}^{y}$   ${}^{r}P_{\sim}$ .

The second, and nal, part of the preprocessing stage is to apply a completely positive map to the state. To describe we rst de ne the multi-party analogue of eq. (23).

Next, we de neam ap that acts on a product of r states by applying the tilde operation to the even numbered states as follows

where each <sub>i</sub> is an n-party state.

Unfortunately, cannot be physically implemented, since it is not a completely positive map. This can be dealt with by using the Structural Physical Approxim ation (SPA) to , which we will call . is the \closest" physicalmap to . This is discussed in xVI, but for now we construct the network as if could be implemented perfectly.

The nalpre-processed state <sup>0</sup> will be

where j ji is an n-party state ful ls this condition.

## VI. THE STRUCTURAL PHYSICAL APPROX IM AT ION

The operation encountered in the previous section is an example of a positive, but not completely positive m ap. These cannot be implemented exactly, but instead we can apply an approximation.

where I is the identity operator and ; are real positive constants chosen such that is completely positive. If we x and such that is trace-preserving and is maxim ized, then the results of [15] im ply that

where n is the number of qubits in each copy of the state and r is the degree of the K  $_{\sim}$  for which we are estimating the modulus squared.

On replacing with in our network the expectation value of the Z m easurem ent still allows the m odulus squared of the K  $_{\sim}$  invariant to be determined via

However, the SPA does a ect the accuracy to which the invariant is determ ined. This is discussed further in the next section. Additionally, in [18], it is shown that this sort of SPA can be implemented by LOCC. Thus, the SLOCC invariants could also be estimated by LOCC, but the e ciency discussed in xVIIB would be a ected.

Them ain aim of the protocols presented in xIII and xV is to provide a physical interpretation for the polynom ial invariants. How ever, we have not yet addressed the question of how e cient these m easurem ent protocols are. In this section, we compare the e ciency of our protocols to protocols based on simply m easuring the state coefcients and calculating the invariants. We use unbiased estimators based on counting [24, 25, 26]. A lso, we perform the analysis in the limit where a large number of copies of the state have been m easured, so that the variances of the estimates are small and can be treated to rst order in all subsequent calculations. We note that more sophisticated estimation procedures are also possible [27], but our purpose here is to compare the networks to methods that are easily accessible experimentally.

M easuring the state coe cients would clearly be a more straightforward procedure to perform experimentally than using our network. A lthough more parameters have to be determined, this does not necessarily mean that it is a less e cient method for estimating the invariants than using our networks. There are several quite general reasons why this might be the case.

Firstly, suppose that we are interested in measuring a complete set of polynomial LU invariants for some unknown state of n parties, where each party has a ddim ensional Hilbert space. In general, we do not know how many we would need to measure, but parameter counting arguments [1, 2, 3] show that the number of local degrees of freedom is linear in n whereas the total num ber of degrees of freedom is exponential in n. Thus, for large n alm ost all the degrees of freedom are nonlocal. Even for moderately sized n, there are nearly as m any invariants as there are state coe cients. In addition, the invariants are typically highly non-linear functions of the state coe cients. For these reasons, we expect that m easuring a com plete set of invariants directly will generally not be more e cient than measuring the state coe cients for large n. Sim ilar considerations also apply to the SLOCC invariants.

D espite these considerations, it may be the case that our networks are more e cient if we are only interested in measuring a small incom plete subset of the invariants. A lso, they may be more e cient for estimating com plete sets when n is small. For this reason, and for sim plicity, we concentrate on estimating two qubit invariants in this section.

There are also other reasons why our protocols may not be e cient. For example, our protocols only em – ploy a two-outcom e m easurem ent for each r copies of the state whereas estimating the state coe cients uses a two-outcom e m easurem ent on each copy. A lso, for the K $_{\sim}$  invariants, we will see that using the SPA introduces a lot of noise into the m easurem ent. N onetheless, there are still some cases where using our networks is more e cient than estimating the state coe cients.

### A. Statistical analysis of the network

For a particular setup in our network we make repeated m easurements of an observable Z , with expectation value  $F = Tr (U^{-0})$ . Z is a random variable[31] with distribution

$$p(Z = +1) = \frac{1}{2}(1 + F)$$

If we de ne the event Z = +1 as a success and set p = P (Z = +1) then repeating the network N times is equivalent to perform ing N Bernoullitrials. The num – ber of successes N<sub>s</sub> is a random variable with a binom ial distribution and its expectation value is  $hN_si = Np = \frac{N}{2} (1 + F)$ . In an actual experiment, the observed num – ber of successes  $\hat{N}_s$  can be used to compute an unbiased estim ator for F, given by

$$\dot{\mathbf{F}} = 2\frac{\dot{N_s}}{N} \qquad 1 \tag{34}$$

with variance

var 
$$\hat{F} = \frac{1}{N} 1 F^2$$
 (35)

We are interested in determining how many trials are needed in order for the estimate  $\hat{F}$  to be reasonably accurate. Speci cally, we would like to quantify how many trials are needed to make the variance of var( $\hat{F}$ )

for some > 0. In an experimental situation, we would not be able to calculate var $(\mathbf{F})$  from our data, so we would have to estimate it using the sample variance, var $(\mathbf{F})$ . However, in the limit N ! 1 we can use the fact that var $(\mathbf{F}) = 0$  (N <sup>1</sup>) and var $(var(\mathbf{F})) = 0$  (N <sup>4</sup>), i.e. var $(\mathbf{F})$  converges to the true variance much faster than  $\mathbf{F}$  converges to F so var $(\mathbf{F})$  var $(\mathbf{F})$ . Thus, in this limit we have that

Recall that for the LU invariants, the real and in aginary parts of the invariant are estim ated independently and that each use of the network requires r copies of the state, where r is the degree of the invariant in . If we use the same number of sam ples for estim ating both the real and in aginary parts then the total number of copies required is

In some cases, we know a priori that the invariant is always realor always in aginary. If this is the case, then we can achieve the same accuracy with

For the SLOCC invariants, each use of the network requires r copies of the state, where r is the degree of the

invariant in . A loo the estim ate of the invariant m ust take into account the use of the SPA via (32). In this case, the total num ber of copies required is

$$M \cdot \frac{r}{2} = 2^{\frac{3}{2}nr} + 1 + 1 + \frac{r}{3} + 2^{nr} + 2^{nr}$$
(39)

Notice that the  $2^{3nr}$  term will dominate the term in the square bracket for large n and r. This is due to the noise introduced into the measurem ent by the SPA.

# ${\ensuremath{\mathsf{B}}}$ . C om parison to ${\ensuremath{\mathsf{m}}}$ etc. based on state estim ation

In order to evaluate our protocols, we compare them to methods based on estimating the density matrix of the state and then calculating the invariants. We do this by estimating each state coe cient using observations on single copies of the state. This is known as hom odyne tomography (see [27] for an overview and also [24, 25, 26]). This is not the optimal way of reconstructing the state in general[28], but it will greatly simplify the analysis.

## 1. Example: Two-qubit LU invariants

A general two-qubit density matrix can be written as

The two-qubit LU invariant (3) can be written in terms of these coe cients as

Each  $b_j$  can be determined by simply performing a  $_j$  m easurement on N  $_j$  copies of B ob's half of the state. The probability distributions of the associated random variables are given by

$$p(_{j} = +1) = \frac{1}{2} (1 + b_{j})$$
  

$$p(_{j} = -1) = \frac{1}{2} (1 - b_{j})$$
(42)

Thus, each  $b_j$  can be estimated in the same way as F in (34) and we have that

$$\operatorname{var}(\hat{b}_{j}) = \frac{1 \quad b_{j}^{2}}{N_{j}}$$
(43)

W e can then construct an estim ator for J given by

$$\hat{J} = \frac{1}{2} \stackrel{0}{=} 1 + \frac{X}{j} \hat{b_j}^2 A \qquad (44)$$

to rst order in  $var(b_j)$ .

If we make the additional restriction that each observable \_j is sampled the same number of times (i.e. N  $_j = \frac{N}{3}$ ) then we must take

$$N' - \frac{3}{b_j^2} \frac{X}{1 b_j^2}$$
(46)

for our estim ate to have variance / .

O ne way to compare this to the result for our network is to take an average over all pure states. If we assume that all pure states are equally likely, i.e. integrate (V IIB) and (46) using H aar measure (for details see [29]), then we nd that on average we will need 3=2 times as many copies of the state if we use the coe cient estimation method. This is half of what one might expect from parameters counting alone, since three times as many parameters are estimated in the state coe cient method. The factor of two is explained by the fact that each use of our network uses two copies of the state.

However, it is possible to nd parameter ranges in which the state coe cient method performs better than our networks. One such range is given by setting  $b_1 = b_2 = 0$ ;  $\frac{3}{5} < b_3 < \frac{3}{5}$ . This illustrates the fact that parameter counting does not always relatively of a given protocol. Any partial information we have available about the type of states being measured might change our judgement of which protocol is more e cient.

## 2. Example: Two-qubit SLOCC invariants

For the two-qubit SLOCC invariants we take the quadratic invariant (19) as an example. In terms of the decom position (40) this can be written as

If we estim ate this by m easuring all 15 of the state coe cients an equal num ber of tim es then by a sim ilar analysis to the LU case we nd that we need at least

copies of the state to get a variance /  $\$  .

Taking averages, one nds that few ercopies are needed in the state coe cient protocolby a factor  $5 ext{ 10}^3$  despite the fact that m any m ore parameters have to be estim ated in this protocol than when using our network. This is largely due to the factor  $2^{12}$  that appears in (39), which arises from the noise introduced by the SPA. This suggests that other estimation and detection protocols based on the SPA [14, 16] may be less e cient than parameter counting arguments would im ply. In fact, there are no states for which our network perform s better than the coe cient estimation method. Even in the best possible case for our network, the state coe cient method requires fewer states by about 3 orders of magnitude.

#### VIII. CONCLUSIONS

W e have presented networks form easuring the polynomial invariants of quantum states under LU and SLOCC transform ations. The structure of these networks is closely related to the structure of the invariants them selves and thus gives the invariants a physical interpretation. C om parison of these networks with m ethods based on estimating the state coe cients indicate that the networks are of limited practical use for estimating com plete sets of invariants. Indeed, our results suggest that any estimation procedure that em ploys the SPA is statistically ine cient even when the num ber of parties is small.

We know that no procedure for estimating invariants directly can outperform protocols based on estimating the state coe cients as the num ber of parties is increased. For small num bers of parties it seems that there can be some increase in e ciency, but the optimal protocol is not known in general.
