#### G eneralized H ypergeom etric C oherent States

We introduce a large class of holom orphic quantum states by choosing their norm alization functions to be given by generalized hypergeom etric functions. We call them generalized hypergeom etric states in general, and generalized hypergeom etric coherent states in particular, if they allow a resolution of unity. Depending on the domain of convergence of the generalized hypergeom etric functions, we distinguish generalized hypergeom etric states on the plane, the open unit disk, and the unit circle. All states are eigenstates of suitably dened lowering operators. We then study their photon number statistics and phase properties as revealed by the Husimi and Pegg-Barnett phase distributions. On the basis of the generalized hypergeom etric coherent states we introduce generalized hypergeom etric Husimi distributions and corresponding phase distributions as well as new analytic representations of arbitrary quantum states in Bargmann and Hardy spaces.

#### 1. INTRODUCTION

C oherent states, their variants and generalizations have been extensively studied over the last four decades. A comprehensive review of this development can be found in Refs. [1, 2, 3]. Recently, K lauder et al. [4] have exposed a rather generalmethod for constructing holomorphic coherent states of the form

where z is a complex variable, (n) a set of strictly positive parameters and the states jni form an orthonormal basis (usually the Fock basis). The normalization function is given by the series

for  $= \frac{1}{2}$ ; its radius of convergence determ ines the dom ain of de nition of the states in Eq. (1.1).

In this paper we consider a particular, but nevertheless very large class of holom or phic coherent states of the form (1.1), for which the normalization functions (1.2) are given by generalized hypergeom etric functions

We call them generalized hypergeom etric states in general, and generalized hypergeom etric coherent states if in addition they allow a resolution of unity with a positive weight function. They comprise many well known quantum states as particular or limiting cases as well as some of the examples constructed in Ref. [4].

The plan of the paper is as follows. In Section 2 we introduce the generalized hypergeom etric states, which naturally fall into three classes: generalized hypergeom etric states on the plane, the open unit disk, and the unit circle. In Section 3 we discuss the generalized hypergeom etric coherent states and use them to represent an arbitrary state by analytic functions either on the plane or the unit disk. We then show in Section 4 that all states are eigenstates of suitably de ned lowering operators. In Section 5 we consider the photon number statistics of the generalized hypergeom etric states and in Section 6 their phase properties as given by the Husim i and Pegg-Barnett phase distributions. Generalizations of the Husim idistribution on the basis of the generalized hypergeom etric coherent states and corresponding phase distributions are introduced and discussed in Section 7. We conclude in Section 8 with a sum mary of our main results.

### 2. GENERALIZED HYPERGEOM ETRIC STATES

In this section we introduce the generalized hypergeometric states, classify them according to de nite criteria of convergence, and indicate the constraints on the param eters on which the states depend.

We de ne generalized hypergeom etric states (GHS) by

where  $(a)_n = (a + n) = (a)$  is the Pochhammer symbol. The normalization function is then given by the generalized hypergeometric function

evaluated at  $= \frac{1}{2}$ . The GHS depend on the complex variable z and on the two sets of num erator  $(a_1; ...; a_p)$ and denominator (b1;:::;ba) parameters. The nonnegative integers p and q assum e the value p = 0 (q = 0) if there are no num erator (denom inator) param eters; this will be indicated by a dot, e.g.  $j_1;0;z_1=j_2; ;z_{i+1,0}$ . Since the parameter functions  $_{p}$   $_{q}$  (n) are the de ning quantities, som e of their particular properties becom e \global" and hold true for the GHS and all quantities derived on their basis. This will by exemplied repeatedly in the following. As a rst property we mention the symm etric dependence on the num erator and, separately, the denom inator param eters. A second property is related with the factorized structure of p q (n): if 1 num erator and 1 denom inator param eters coalesce  $(a_i = b_i)$ , they cancel and the state p;q;zi reduces to the lower-order state p l;q l;zi of the rem aining param eters. Thus, the conventional coherent states (CS) result for p = q = 0or, m ore generally, for  $p = q \in 0$  and all parameters coalescing.

The normalization function also determines the scalar product of two  $G\ H\ S\ w$  ith identical parameter sets

It follows that the GHS are normalized, but not orthogonal. The scalar product is well dened if the generalized hypergeometric functions involved converge. The function  $_pF_q$  (a<sub>1</sub>;:::;a<sub>p</sub>;b<sub>1</sub>;:::;b<sub>q</sub>; ) converges in the following cases for:

where  $Re(\frac{p}{j=1}a_j)$   $\frac{p}{j=1}b_j$ ; in all other cases it diverges [5]. A coording to the three cases of unconditional convergence, Eqs. (2.5a) to (2.5c), we obtain generalized hypergeom etric states on the plane, the open unit disk, and the unit circle, respectively. These states depend analytically on the complex variable z (disregarding the normalization function) and thus belong to the very large class of holomorphic quantum states. Besides these normalized states we shall consider also unnormalizable states on the unit circle violating the condition < 0.

W e conclude this section by review ing the constraints on the param eters  $a_1; \ldots; a_p$  and  $b_1; \ldots; b_q$ . First of all, we exclude zero or negative integer values for  $a_1; \ldots; a_p$ 

(leading to unde ned parameter functions p q) and for  $b_1; \ldots; b_q$  (leading to unde ned normalization functions  $p F_q$ ). Next we require the parameter functions p q n to be real and strictly positive, leading to the conditions

which follow from the obvious recurrence relation

with seed value p q(0) = 1. The conditions (2.6) are satised for all n, if: (i) all parameters are real and positive, (ii) an even number of parameters is real and negative with pairwise the same negative integer parts, (iii) an even number of numerator parameters and/or of denominator parameters are pairwise complex conjugate to each other. If cases (ii) and/or (iii) occur, the remaining parameters are supposed to be real and positive.

## 3. GENERALIZED HYPERGEOMETRIC COHERENT STATES

In this section we introduce generalized hypergeom etric coherent states (GHCS) as a set of generalized hypergeom etric states (GHS) which is (over)complete and allows a resolution of unity with a non-negative weight function. The resolution of unity is then used on the one hand to determ ine the corresponding weight functions and on the other hand to introduce new analytic representations for arbitrary quantum states.

We consider stathe GHCS on the plane and on the unit disk related, respectively, with the convergence criteria (2.5a) and (2.5b). In these cases the resolution of unity  $(\hat{1})$  takes the form

with a positive weight function  $pw_q(x)$  depending on  $x = jz \hat{j}$ ; the integration is over the complex plane or unit disk, as appropriate. Introducing the states (2.1) into Eq. (3.1) and performing the angular integration, the following conditions result:

where  $pw_q(x) = pW_q(x) = pN_q(x)$  and the upper limit of the integral is R = 1 (R = 1) for the GHCS on the plane (disk). Correspondingly, the unknown distribution  $pw_q(x)$  is given by the solution of a Stieltjes (Hausdor) moment problem with the moments given in Eq. (2.2). As shown by K lauder et al. [4], the solution can be obtained by using Mellin transform techniques. Thus, replacing in Eq. (3.2) the discrete variable n by the complex

variable (s 1), the distribution  $_p w_q$  (x) and the parameter function  $_p \ _q$  (s 1) become a M ellin transform related pair. There are well known references where such pairs are tabulated [5, 6, 7]. Thus, using Ref. [5, p. 303, formula (37)] or Ref. [6, p. 728, formula (8.4.51.9)], we not in term s of the M eiger G-function

are satis ed. It follows that  $_pw_q(x)$  exists for all GHS on the plane, but only for those with > 1 on the disk. The solution found, however, need not be positive. The positivity of  $_pw_q(x)$  must be checked in each particular case and may result in additional constraints on the param eters. As was the case for the states, if I numerator param eters coalesce with I denom inator param eters, the weight function  $_pw_q(x)$  reduces to the lower-order weight function  $_p1w_{q1}(x)$  of the remaining param eters, due to a well known property of the  $_pF_q$  and G functions. On the other hand, this can be seen also as a consequence of the de ning condition (3.2).

The resolution of unity, Eq. (3.1), can be used to introduce a new representation by sandwiching it between two arbitrary state vectors, h jand ji, and writing the resulting scalar product in the form

We call this the GHCS representation of the state j i. The series appearing in Eq. (3.7) de nes an entire analytic function of = z, which may be regarded as

another representation. We call it the generalized hypergeom etric analytic representation of ji:

Note that the analytic representations and the measures depend explicitly also on the parameter sets  $(a_1; :::; a_p)$  and  $(b_1; :::; b_q)$ . For a given state j i we then obtain in nitely many analytic representations on the plane and unit disk beeing, respectively, elements of B argmann and Hardy spaces with measure (3.10). The usual B argmann representation based on the coherent states is recovered for p=q=0. The simplest Hardy space representation is based on the coherent phase states given in Eq. (3.20) below [8].

Next we consider the GHS on the unit circle and write  $z=e^{i'}$ . We distinguish two types of states, denoted by  $p;q;e^{i'}$  i and p;q;' i depending on whether the convergence criterion (2.5c) is satis ed or not. The normalized states ( < 0) are de ned by

The normalization function in Eq. (3.11) is a constant given by the generalized hypergeometric function of unit argument. These states do not yield a resolution of unity, as the resulting Hausdor moment problem

for the sought for function  $pw_q(')$  has no solution: Eq. (3.13) in plies the vanishing of all Fourier components of the function  $pw_q(')$  for  $n \in m$ , thus reducing it to a constant which cannot m atch the values on the rhs. for all n = m. These states, corresponding to  $_1$   $_0$  (a; ;n) $_a$ j  $_1$ = 1 for all n, are the only ones yielding a resolution of unity with  $_1$ w $_0$  = 1=(2) according to Eq. (3.13).

W e conclude this section by giving exam ples of GHCS for particular values of p and q. W e quote for each state the parameter, the normalization and the weight functions. The complex variable z is denoted by , j j < 1, for the GHCS on the plane (p < q+ 1) and by , j j < 1, for the GHCS on the unit disk (p = q+ 1).

- (a) The conventional coherent states j i = 50;0;i correspond to p = q = 0, in which case 0,0(n) = n!,  $0F_0() = e$  and  $0W_0();\frac{2}{3}) = 1$ .

The states  $j_a$ ; ;  $(j_{i,1})$  for a=2k and B argm ann index  $k=\frac{1}{2}$ ; 1;  $\frac{3}{2}$ ; ...: yield the Perelom ov coherent states of the discrete series of the SU (1,1) representations, and for arbitrary non-negative k those of its universal covering group [11, 12]. Of particular interest are the states for  $k=\frac{1}{2}$ , also known as coherent phase states [13]

Their weight function (3.19) vanishes and the resolution of unity is applicable only as a limiting equation [14].

(e) For the states  $p;1; i = p_1;a_2;b; i_{(2;1)}$  with  $p_2 = p_1;a_2;b;n = p_1!(b)_n = [(a_1)_n (a_2)_n]$ , the constraints (2.6) allow not only positive parameter values, but also pairs of negative-valued parameters with equal negative integer parts as well as a complex-valued pair  $p_2 = p_3$ . The normalization function is given by the Gaussian hypergeometric function  $p_2F_1(a_1;a_2;b;n)$  and the weight function by ([7, p. 198, formula (5.50)])

with  $a_1+a_2$  b> 1 due to Eq. (3.5b). It is not clear if this condition together with the constraints (2.6) are sufcient to guarantee the positivity of  $_2w_1$  in all cases. For coalescing param eters ( $a_1=b$  or  $a_2=b$ ) we recover the results of the previous example (d) for the states j;0; i.

#### 4. GENERALIZED HYPERGEOM ETRIC STATES AS EIGENSTATES OF LOW ERING OPERATORS

In this section we introduce ladder operators of raising and lowering type, the latter having as eigenstates the generalized hypergeom etric states introduced in Section 2. These operators generalize the creation and annihilation operators of the harmonic oscillator in the case of the GH (C)S on the plane, and the Susskind-G logower exponential phase operators in the case of the GH (C)S on the unit disk and circle.

We do no generalized hypergeometric lowering and raising operators by

with  $_0f_0$  (n) =  $\frac{p}{n+1}$  and all products in the num erator (denom inator) replaced by 1 if q = 0 (p = 0). It is very satisfactory that these coe cients are real and positive due to the same constraints (2.6) already observed. The ladder operators depend explicitly on the two parameter sets, e.g.  $_p\hat{U}_q = _p\hat{U}_q$  (a1;:::;ap;b1;:::;bq). Due to the product structure of  $_pf_q$  (n), if 1 num erator parameters coalesce with 1 denom inator parameters, the operator  $_p\hat{U}_q$  reduces to the lower-order operator  $_p1\hat{U}_{q1}$  of the remaining parameters. The ladder operators obey the noncanonical commutation relation

justifying their name as lowering and raising operators, respectively. It is then easy to show that the GH (C)S are eigenstates of the lowering operator

Seen from this perspective the generalized hypergeom etric (coherent) states are also instancies of the very large class of so-called nonlinear coherent (or f-coherent) states [3, 15, 16]. These are eigenstates of low ering operators of the type (4.1a) with  $_p f_q (n)$  replaced by  $n+1 \ f (n)$ , where the f-param eters f (n) are quite arbitrary  $\frac{1}{n}$  our case f (n) is given by Eq. (4.2) without the factor  $\frac{1}{n+1}$ .

For p < q + 1 we denote  $_{p}\hat{A_{q}} = _{p}\hat{U_{q}}$  and  $_{p}\hat{A_{q}}^{y} = _{p}\hat{U_{q}}^{y}$ , which m ay be considered as a generalization of the usual annihilation (a) and creation (a) operators of the harm onic oscillator. In particular, we have

It is then natural to call  $_p\hat{A_q}$  ( $_p\hat{A_q}^y$ ) the generalized hypergeom etric annihilation (creation) operators. The eigenstates of  $_p\hat{A_q}$  are the G H (C )S on the plane,  $p;q;\,i,\,w$  ith

com plex eigenvalue , j j< 1 . They m ay be considered as generalizations of the conventional coherent states j i, which are eigenstates of  $\hat{a}$ .

For p=q+1 we write  $_p\hat{E_q}=_p\hat{U_q}$  and  $_p\hat{E_q}=_p\hat{U_q}^v$ . The eigenstates of  $_p\hat{E_q}$  are: (a) the GH (C)S on the unit disk,  $\dot{p};q;$  i, with complex eigenvalue ,  $\dot{j}$  j< 1; (b) the GHS on the unit circle with eigenvalue  $e^{i'}$  for both, the normalized states  $\dot{p};q;e^{i'}$  i, Eq. (3.11), and the unnormalizable states  $\dot{p};q;e^{i'}$  i, Eq. (3.12). This is similar to the Susskind-Glogower [17] exponential phase operator  $\hat{E}$ , having as eigenstates the coherent phase states (3.20) on the unit disk and the phase states (3.14) on the unit circle. Now the operator  $\hat{E}$  is a limiting case of the operator  $_1\hat{E_0}$  (a) for a! 1:

This correlates with the limit for the corresponding eigenstates in Eqs. (3.20) and (3.14). It is then justified to consider the operators  $_{p}\hat{E_{q}}$  and their eigenstates, the GHS on the unit disk and unit circle, as generalizations of the Susskind-G logower exponential phase operator  $\hat{E}$  and its eigenstates, the coherent phase states and the phase states, respectively. For this reason we call  $_{p}\hat{E_{q}}$  and  $_{p}\hat{E_{q}}^{\gamma}$  the generalized hypergeom etric exponential phase operators.

G iven the nonherm itian ladder operators we may glene herm itian combinations by  $_p\hat{Q}_q=(_p\hat{A}_q^{\gamma}+_p\hat{A}_q)=\bar{2}$  and  $_p\hat{P}_q=i(_p\hat{A}_q^{\gamma}-_p\hat{A}_q)=\bar{2}$ , and similarly by  $_p\hat{C}_q=(_p\hat{E}_q^{\gamma}+_p\hat{E}_q)=2$  and  $_p\hat{S}_q=i(_p\hat{E}_q^{\gamma}-_p\hat{E}_q)=2$ . Our notation suggests to \interpret"  $_p\hat{Q}_q$  ( $_p\hat{P}_q$ ) as generalized hypergeom etric coordinate (momentum) operators, and  $_p\hat{C}_q$  ( $_p\hat{S}_q$ ) as generalized hypergeom etric cosine (sine) operators (a la Susskind-G logower). However, these operators do not satisfy the usual commutation relations and we have not verified that they have the right spectrum. Their study is beyond the scope of this paper.

#### 5. PHOTON NUMBER STATISTICS

The generalized hypergeom etric (coherent) states lead to classicals well as nonclassical behaviour in the photon number statistics. The considerations in this section do not depend on the existence of a weight function and apply, therefore, to both GHS and GHCS.

The GH (C)S de ned in Eq. (2.1) have the Fock representation  ${\bf Eq.}$

Positive, vanishing, or negative values of the M andel param eter correspond to super-Poissonian, Poissonian, or sub-Poissonian statistics, respectively. The latter is a signature of nonclassical behaviour. If in the above expressions we let la-param eters coalesce with 1b-param eters, we obtain the corresponding expressions for the lower-order states jp l;q l;zi.

We now consider the photon number statistics of some particular GHCS. For each state we quote the photon number distribution, the mean photon number, and the Mandel parameter. We also show and discuss graphical representations for selected values of the parameters and compare them with those for the coherent states.

- (a) We start with the coherent states j i. Their photon number distribution is the Poisson distribution  $P_{ji}(n) = (j j^2 = n!) e^{j j^2}$ , yielding  $_0 n_0 = j j^2$  and  $_0 Q_0 = 0$ .
  - (b) For the G H C S  $\mathcal{D}$ ; 1; i = j;  $i_{0;1}$ , we have:




FIG. 1: Photon number distributions of the GHCS  $\mathcal{D}$ ; i = j;b; i<sub>(0:1)</sub> and the CS j i for j j= 3.




FIG. 2: Mean photon numbers of the GHCS  $\hat{J}0;1; i = j;b; i_{(0;1)}$  and the CS ji as a function of jj.

The photon number distributions of the states 0;1; in Fig. 1 peak at low values of the photon number n, their mean photon numbers in Fig. 2 increase for large




FIG. 3: Mandel parameters of the GHCS  $\mathfrak{P};1; i = j;b; i_{(0;1)}$  and the CS ji as a function of jj.




FIG. 4: Photon number distributions of the GHCS  $jl;1; i = ja;b; i_{(1;1)}$  and the CS ji for jj = 3.

enough j jm uch slower than for the coherent state, and the negative values of their M andel param eters in Fig. 3 indicate nonclassical behaviour for all j j.

(c) For the GHCS j;1;  $i = ja;b; i_{(1;1)}$  we nd




FIG. 5: Mean photon numbers of the GHCS  $jl;1; i = ja;b; i_{(1;1)}$  and the CS ji as a function of jj.




FIG. 6: Mandel parameters of the GHCS  $ji;1;i=ja;b;i_{(1;1)}$  and the CS ji as a function of ji.

These relations reduce for a=b to those of the coherent states. This rem ark is very helpful in understanding the behaviour of the photon number distributions in Fig. 4, the mean photon numbers in Fig. 5, and the M andel parameters in Fig. 6. All curves coincide for a=b with the CS-curves and depart from them as soon as a becomes dierent from b. The deviations are on either side with respect to the CS-curves, depending on wether a < b or a > b. As an example, the M andel parameters in Fig. 6 are positive (negative) for a < b (a > b).

(d) For the GHCS  $j1;0; i= ja; ;_{(\hat{1};0)}$  we have




FIG. 7: Photon number distributions of the GHCS j1;0; i = ja; ;  $i_{(1,0)}$  and the CS j i for  $j = \frac{3}{4} = j$  j.

states for this reason [14]. The photon number distributions are shown in Fig. 7 and compared with the Poisson distribution for the same value of the variable (j j=  $\frac{3}{4}$  = j ). The mean photon number and the Mandel parameter have the same simple dependence on j j. The Mandel parameter is independent of the parameter a and always positive (classical behaviour).

For  $b=a_2$  (or  $b=a_1$ ) we recover the results of the previous example (d). We refrain from graphical representations as there are too many parameters.

## 6. HUSIM IAND HUSIM IPHASE DISTRIBUTIONS

In this section we consider the Husim i distributions (Q functions) and the corresponding phase distributions for the generalized hypergeom etric (coherent) states. We also comment on the Pegg-Barnett phase distributions.

The Husimi distribution for the GH(C)S p;q;zi is given by the modulus squared of its wave function in the coherent state basis ji

It is positive, normalized to 1 with measure  $d^2$  and provides a two-dimensional probability distribution over the complex -plane. Writing = j je  $^i$  and integrating over the radial part j j the Husim iphase distribution is obtained in the form [20, 21]




FIG. 8: Husim iphase distributions P  $_{\rm j0;1;\ i}^{\rm (Q)}$  () of the G H C S  $_{\rm j0;1;\ i}$  i = j;b; i  $_{\rm (0;1)}$  and P  $_{\rm j\,i}^{\rm (Q)}$  () of the C S j i for j j=  $_{\rm 4}^{\rm 3}$ .

It has the same form as Eq. (6.3), with  $G^{(Q)}$  (n;n°) replaced by  $G^{(PB)}$  (n;n°) = 1. Since the same result is obtained for the (dierently motivated) Pegg-Barnett phase distribution [22], we have used the upper index (PB) in Eq. (6.5). Note that the dependence of the phase distributions on the phases is through the phase dierence ( ') only, where' is the phase of the complex variable (z =  $\frac{1}{2} e^{i}$ ) de ning the GH (C)S.




FIG. 9: Husim iphase distributions  $P_{jl;l;i}^{(Q)}$  () of the GHCS  $jl;l;i=ja;b;i_{(l;l)}$  and  $P_{ji}^{(Q)}$  () of the CS ji for  $jj=\frac{3}{4}$ .




FIG. 10: Husim iphase distributions  $P_{ji,0;i}^{(Q)}$  () of the GHCS  $ji;0;i=ja;;i_{(1;0)}$  and  $P_{ji}^{(Q)}$  () of the CS ji for  $jj=\frac{3}{4}=ji$ .

We display in Figures 8{10 the Husim iphase distributions of the GHCS j;q;zi for (p;q)=(0;1);(1;1), and (1;0), respectively, and for dierent values of the corresponding parameters. All distributions peak at = '. The heights of the peaks increase: with decreasing b in Fig. 8, with decreasing b and increasing a in Fig. 9, and with increasing a in Fig. 10. In Fig. 9 the phase distributions  $P_{j;i}^{(Q)}$  () for a = b and  $P_{j}^{(Q)}$  () would be identical; for a > b (a < b) the heights of the peaks then move above (below) the CS peak. This is similar to the behaviour observed in the photon number distributions of the states  $jl;1;\,i$ .

The Pegg-Barnett phase distributions look qualitatively sim ilar, so we do not display them explicitly. The peaks at = ' are always higher (due to  $G^{(PB)}$ ) (n;n0)  $G^{(Q)}$ ) (n;n0)) and consequently the distributions are narrower in order to preserve the normalization.

# 7. GENERALIZED HYPERGEOMETRIC HUSIMIAND GENERALIZED HYPERGEOMETRICHUSIMIPHASE DISTRIBUTIONS

By analogy with the conventional H usim i distribution we de ne in this section the generalized hypergeom etric H usim i distribution of a norm alized state j i by the modulus squared of its wave function in the GHCS basis, Eq. (3.7):

It provides a two-dim ensional true probability distribution over the complex z-plane for p < q+1 and over the unit z-disk for p=q+1. The corresponding normalization condition

is a consequence of the resolution of unity, Eq. (3.1). It is thereforem and atory for the state p;q;zi in the denition (7.1) to be a GHCS; the state j i can be any normalized state, in particular a GHS or GHCS. For later reference, we call the states j i and p;q;zi the signal and analyzing states, respectively. In dening generalized hypergeom etric Husimi distributions we have formally replaced the analyzing CS in the usual Husimi distribution by an analyzing GHCS and have included the weight function into the distribution rather than into the integration measure. The conventional Husimi distribution is then recovered for p = q = 0, i.e.  $Q_{j-i}() = Q_{j-i}^{(0;0)}()$ .

The generalized hypergeom etric H usim i distributions can be used to de ne corresponding phase distributions by integrating over the m odulus of the complex variable  $z=\dot{y}\cdot\dot{y}^2$  ( $x=\dot{y}\cdot\dot{y}^2$ ):

where the integration is over the 2 -interval chosen for the phase , usually [ ; ] or [0;2].

The phase distributions (7.4) and (6.3) have the same form all structure, only the coe cients are different. Those appearing in Eq. (7.4) are given by

in terms of the moments p-q (n) from Eq. (2.2). They are symmetric in n and  $n^0$  and normalized to 1 for  $n=n^0$ , thus insuring the normalization condition (7.5). These coe cients encode the information on the analyzing state p;q;zi. The information on the signal state j i is contained solely in the product  $n-n^0$ , where  $n=\ln j$  i. If the system is described by a density operator n, this product should be replaced by the density matrix elements

in the Fock basis,  $n_{;n^0} = \text{Im}\,j^n_j \, ^0 i$ ; correspondingly,  $^\circ$  should appear instead of j in j in Eq. (7.1). If the dependence on the parameters is needed, we shall write  $P_{ji}^{(p;q)}(a_1; \ldots; a_p; b_1; \ldots; b_q; )$  for the phase distributions and  $G^{(p;q)}(a_1; \ldots; a_p; b_1; \ldots; b_q; n; n^0)$  for the coe cients. The latter can be written also in factorized form

Comparing the product structures of p = q(n) and  $G^{(p;q)}(n;n^0)$ , Eqs. (2.2) and (7.7), it follows that each Pochhammer symbol (a) $_n$  contributes a coe cient  $G^{(a)}(n;n^0)$ ; the factor  $G^{(Q)}(n;n^0) = G^{(1)}(n;n^0)$  comes from  $(n+1)=(1)_n$  according to the same rule. If in Eq. (7.7) p or q or both are zero, the corresponding product(s) should be replaced by 1. Thus  $G^{(0;0)}(n;n^0) = G^{(Q)}(n;n^0)$ , so that the conventional Husin i phase distribution is given by  $P_{ji}^{(Q)}(1) = P_{ji}^{(0;0)}(1)$ . Similarly, the Pegg-Barnett phase distribution is given by  $P_{ji}^{(PB)}(1) = P_{ji}^{(1;0)}(1)$ , since  $G^{(1;0)}(1)$  are  $G^{(Q)}(1)$  and  $G^{(Q)}(1)$  are generally, the generalized hypergeometric Husin i and corresponding phase distributions of order (p 1;q 1) result from those of order (p;q) by letting 1 numerator parameters coalesce with 1 denominator parameters.

We now consider some generalized hypergeometric H usim i phase distributions for the Fock and coherent states. For any Fock state N i we have  $_n = _{n,N}$  and the phase distributions (7.4) become uniform with value 1=(2), as expected.




FIG.11: Generalized hypergeom etric H usim i phase distributions  $P_{ji}^{(0;1)}$  (;b; ) and H usim i phase distribution  $P_{ji}^{(Q)}$  () of the CS ji for j j=  $\frac{3}{4}$ .




FIG. 12: Generalized hypergeom etric H usim iphase distributions P $_{j\,i}^{\,(1\,;1)}$  (a;b; ) and H usim iphase distribution P $_{j\,i}^{\,(Q\,)}$  () of the CS ji for j j=  $\frac{3}{4}$ .




FIG.13: Generalized hypergeom etric H usim i phase distributions  $P_{ji}^{(1;0)}$  (a; ; ) and H usim i phase distribution  $P_{ji}^{(Q)}$  ( ) of the CS ji for jj=  $\frac{3}{4}$ .

For the coherent states jiwith = jje  $^{i'}$  and  $_n$  = e  $^{j}$   $^{j^2=2}$  jj  $^n$   $e^{in'}$  =  $^n$ !, the resulting phase distributions (7.4) depend only on the phase di erence ( We display in Figures 11 (13 the generalized hypergeom etric H usim i phase distributions of a coherent state for (p;q) = (0;1); (1;1), and (1;0), respectively. All distributions peak at the coherent phase = '. The heights of the peaks decrease: with decreasing b in Fig. 11, with decreasing b and increasing a in Fig. 12, and with increasing a in Fig. 13. In Fig. 12 the phase distribution  $P_{i,i}^{(1;1)}$  (a;b; ) for a = b and the H usim iphase distribution  $P_{i,i}^{(Q)}$  ( ) would yield the same results; for a < b (a > b) the heights of the peaks then move above (below) the peak of  $P_{i,i}^{(Q)}$  (). This behaviour is similar to the one observed in the conventional Husim i phase distributions of the states 1;1; i as well as in their photon number distributions.

The phase distributions shown in Figures 11{13 are \dual" to those in Figures 8{10 in the sense that the signal and analysing states have been interchanged. The

signal (analyzing) state is a GHCS (CS) in Figures 8{10, and a CS (GHCS) in Figures 11{13. In the rst case we deal with the usual Husim i phase distribution  $P_{jrq;zi}^{(0;0)}$  of the GHCS jr;q;zi, in the second case with the generalized hypergeom etric Husim i phase distribution  $P_{ji}^{(p;q)}$  of the conventional CS ji. The two sets of gures show an opposite behaviour in the sense that for the same variation of the param eters the heights of the peaks increase in one set and decrease in the other set.

The phase distributions showing this dual behaviour originate from generalized hypergeometric Husimi distributions of the type  $Q_{\dot{p};q;z\dot{z}}^{(p;q)}(z)$ , where both the signal  $(\dot{p};q;z\dot{z})$  and the analysing  $(\dot{p};q;z\dot{z})$  states are GHCS and therefore interchangeable. We call

the generalized hypergeometric Husimi distribution  $Q_{p;q;z_1}^{(p;q)}(a_1;:::;a_p;b_1;:::;b_q;z)$  and the one with interchanged states,  $Q_{p;q;z_1}^{(p;q)}(a_1;:::;a_p;b_1;:::;b_q;z)$ , dual to each other and extend this denition to the corresponding phase distributions,  $P_{p;q;z_1}^{(p;q)}(\cdot)$  and  $P_{p;q;z_1}^{(p;q)}(\cdot)$ . Dual distributions are nontrivial due to the nonorthogonality of the GHCS and this is true even if for p=p and q=q the two sets of tilded and untilded parameters are identical. In this case the self-dual distributions  $Q_{p;q;z_1}^{(p;q)}(z)$  are determined by the scalar product in Eq. (2.4), i.e.

$$Q_{p,q;z_{1}}^{(p,q)}(z) = \frac{1}{p} \frac{pW_{q}(\dot{z}_{1}^{2}) \dot{p}N_{q}(z_{2}^{2}) \dot{f}}{pN_{q}(\dot{z}_{1}^{2}) pN_{q}(\dot{z}_{2}^{2})} : (7.9)$$

Self-dual distributions actually provide a m easure of the nonorthogonality of the GHCS with identical parameter sets. The simplest self-dual distribution is the usual Husimi distribution for a conventional coherent state, given by the well known overlap of the two coherent states: Q  $_{j-i}$  ( ) =  $\frac{1}{2}$  jh  $_{j}$ - $_{ij}$ <sup>2</sup> = Q  $_{j}$  i (~). The corresponding self-dual phase distribution is P  $_{j}^{(Q)}$  ( ), also shown in Figures 8{13 for comparison.

In this paper we have introduced a large class of holom orphic quantum states ja;:::;ap;b1;:::;bq;zi,depending on a complex variable z and two sets of parameters,  $(a_1; ::: ; a_p)$  and  $(b_1; ::: ; b_q)$ . We called them generalized hypergeom etric states (GHS) as their norm alization function is given by the generalized hypergeom etric function  $_{p}F_{q}(a_{1};...;a_{p};b_{1};...;b_{q};\dot{z}_{1})$ . Depending on the domain of convergence of the latter, the GHS are de ned on the whole z-plane (jzj < 1), the open unit disk  $(\dot{z}\dot{j} < 1)$ , or the unit circle  $(\dot{z}\dot{j} = 1)$ . A coordingly, these states may be considered as generalizations of the usual coherent states, the coherent phase states, and the phase states. Those GHS yielding a resolution of unity with a positive weight function de ne the subclass of generalized hypergeom etric coherent states (GHCS). We have determined the corresponding weight functions by Mellin transform techniques, but their positivity must be checked separately. The GHS on the plane (unit disk and circle) are eigenstates with eigenvalue z of suitably de ned low ering operators  ${}_{p}\hat{A_{q}}$  ( ${}_{p}\hat{E_{q}}$ ); the latter m ay be considered as generalizations of a (E), the usual annihilation operator of the harm onic oscillator (the Susskind-G logower exponential phase operator).

To reveal the physical content of the GH (C)S we have studied their photon number statistics (photon number distribution, mean photon number, Meandel parameter) and phase properties (Husimi and Pegg-Barnett phase distributions). Numerical results were displayed for particular states and parameter values.

The GHCS on the plane (unit disk) can be used to dene new analytic representations of arbitrary quantum states, which are elements of corresponding Bargmann (Hardy) spaces. They can be used also to de ne generalized hypergeometric Husimi functions over the complex plane (unit disk) and corresponding phase distributions. Of particular interest are the generalized hypergeometric Husimi functions when considered for another GHCS, as then the two GHCS can be interchanged (dual distributions). The corresponding phase distributions show a correlated behaviour. Self-dual distributions are nontrivial and provide a measure of the nonorthogonality of the GHCS.
