On the Distribution of the Wave Function for Systems in Thermal Equilibrium

A bstract

For a quantum system, a density matrix that is not pure can arise, via averaging, from a distribution of its wave function, a norm alized vector belonging to its Hilbert space H . While itself does not determ ine a unique , additional facts, such as that the system has come to therm al equilibrium, might. It is thus not unreasonable to ask, which , if any, corresponds to a given therm odynamic ensemble? To answer this question we construct, for any given density matrix , a natural measure on the unit sphere in H , denoted GAP (). We do this using a suitable projection of the Gaussian measure on H with covariance W e establish som e nice properties of GAP () and show that this m easure arises naturally when considering macroscopic systems. In particular, we argue that it is the most appropriate choice for system s in therm al equilibrium, described by the canonical ensemble density matrix = (1=Z)exp(H).GAP() may also be relevant to quantum chaos and to the stochastic evolution of open quantum system s, where distributions on H are often used.

Key words: canonical ensemble in quantum theory; probability measures on Hilbert space; Gaussian measures; density matrices.

1 Introduction

In classical mechanics, ensembles, such as the microcanonical and canonical ensembles, are represented by probability distributions on the phase space. In quantum mechanics, ensembles are usually represented by density matrices. It is natural to regard these density matrices as arising from probability distributions on the (norm alized) wave functions associated with the therm odynam ical ensembles, so that members of the ensemble are represented by a random state vector. There are, how ever, as is well known, many probability distributions which give rise to the same density matrix, and thus to the sam e predictions for experim ental outcom es [25, sec. IV 3].¹ M oreover, as em phasized by Landau and Lifshitz [13, sec. 1.5], the energy levels for macroscopic systems are so closely spaced (exponentially small in the number of particles in the system) that \the concept of stationary states [energy eigenfunctions] becomes in a certain sense unrealistic" because of the di culty of preparing a system with such a sharp energy and keeping it isolated. Landau and Lifshitz are therefore wary of, and warn against, regarding the density matrix for such a system as arising solely from our lack of know ledge about the wave function of the system . We shall argue, however, that despite these caveats such distributions can be both useful and physically meaningful. In particular we describe here a novel probability distribution, to be associated with any therm allensem ble such as the canonical ensemble.

W hile probability distributions on wave functions are natural objects of study in many contexts, from quantum chaos [3, 12, 23] to open quantum systems [4], our main m otivation for considering them is to exploit the analogy between classical and quantum statistical mechanics [20, 21, 26, 14, 15, 16]. This analogy suggests that some relevant classical reasonings can be transferred to quantum mechanics by form ally replacing the classical phase space by the unit sphere S (H) of the quantum system's Hilbert space H. In particular, with a natural measure (d) on S (H) one can utilize the notion of typicality, i.e., consider properties of a system common to \almost all" members of an ensemble. This is a notion frequently used in equilibrium statistical mechanics, as in, e.g., Boltzm ann's recognition that typical phase points on the energy surface of a macroscopic system are such that the empirical distribution of velocities is approximately M axwellian. Once one has such a measure for quantum system s, one could attempt an analysis of the second law of therm odynam ics in quantum mechanics along the lines of

¹This empirical equivalence should not too hastily be regarded as in plying physical equivalence. Consider, for example, the two Schrödinger's cat states = (alive dead) = 2. The measure that gives equal weight to these two states corresponds to the same density matrix as the one giving equal weight to alive and dead. However the physical situation corresponding to the former measure, a mixture of two grotesque superpositions, seem s dram atically diement from the one corresponding to the latter, a routine mixture. It is thus not easy to regard these two measures as physically equivalent.

Boltzm ann's analysis of the second law in classical mechanics, involving an argument to the e ect that the behavior described in the second law (such as entropy increase) occurs for typical states of an isolated macroscopic system, i.e. for the overwhelming majority of points on S (H) with respect to (d).

Probability distributions on wave functions of a composite system, with Hilbert space H , have in fact been used to establish the typical properties of the reduced density matrix of a subsystem arising from the wave function of the composite. For example, Page [19] considers the uniform distribution on S (H) for a nite-dimensional Hilbert space H , in terms of which he shows that the von Neumann entropy of the reduced density matrix is typically nearly maxim alunder appropriate conditions on the dimensions of the relevant Hilbert spaces.

G iven a probability distribution on the unit sphere S (H) of the H ilbert space H there is always an associated density matrix [25]: it is the density matrix of the mixture, or the statistical ensemble of systems, de ned by the distribution , given by

For any projection operator P, tr (P) is the probability of obtaining in an experiment a result corresponding to P for a system with a -distributed wave function. It is evident from (1) that is the second moment, or covariance matrix, of, provided has mean 0 (which may, and will, be assumed without loss of generality since and are equivalent physically).

W hile a probability measure on S (H) determines a unique density matrix on H via (1), the converse is not true: the association 7 given by (1) is many-toone.² There is furthermore no unique \physically correct" choice of for a given since for any corresponding to one could, in principle, prepare an ensemble of system s with wave functions distributed according to this . How ever, while itself need not determ ine a unique probability measure, additional facts about a system, such as that it has come to therm all equilibrium, might. It is thus not unreasonable to ask: which measure on S (H) corresponds to a given therm odynamic ensemble?

Let us start with the m icrocanonical ensemble, corresponding to the energy interval [E;E +], where is small on the m acroscopic scale but large enough for the interval

²For example, in a k-dimensional H ibert space the uniform probability distribution $u = u_{S_{(H_i)}}$ over the unit sphere has density matrix $u = \frac{1}{k}I$ with I the identity operator on H ; at the same time, for every orthonormal basis of H the uniform distribution over the basis (which is a measure concentrated on just k points) has the same density matrix, $= \frac{1}{k}I$. to contain many eigenvalues. To this there is associated the spectral subspace H $_{\rm E}$;, the span of the eigenstates jni of the Ham iltonian H corresponding to eigenvalues E $_{\rm n}$ between E and E + . Since H $_{\rm E}$; is nite dimensional, one can form the m icrocanonical density matrix

with $P_{H_{E_{i}}} = 1_{E_{i},E_{i}+1}(H)$ the projection to $H_{E_{i}}$. This density matrix is diagonal in the energy representation and gives equal weight to all energy eigenstates in the interval $[E_{i};E_{i}+1]$.

But what is the corresponding m icrocanonical measure? The most plausible answer, given long ago by Schrodinger [20, 21] and Bloch [26], is the (normalized) uniform measure u_E ; = $u_S (H_E,)$ on the unit sphere in this subspace. $_E$; is associated with u_E ; via (1).

Note that a wave function chosen at random from this distribution is almost certainly a nontrivial superposition of the eigenstates jni with random coe cients hnji that are identically distributed, but not independent. The measure u_E ; is clearly stationary, i.e., invariant under the unitary time evolution generated by H, and it is as spread out as it could be over the set S (H $_E$;) of allowed wave functions. This measure provides us with a notion of a \typical wave function" from H $_E$; which is very di erent from the one arising from the measure $_E$; that, when H is nondegenerate, gives equal probability (dim H $_E$;)¹ to every eigenstate jni with eigenvalue E $_n$ 2 [E; E +]. The measure $_E$; which is concentrated on these eigenstates, is, however, less robust to sm all perturbations in H than is the sm oother measure u_E ;.

Our proposal for the canonical ensemble is in the spirit of the uniform microcanonical m easure u_{E} ; and reduces to it in the appropriate cases. It is based on a m athem atically natural fam ily of probability measures on S (H). For every density matrix on H, there is a unique member of this family, satisfying (1) for , namely the = Gaussian adjusted projected measure GAP (), constructed roughly as follows: Eq. (1) (i.e., the fact that is the covariance of) suggests that we start by considering the Gaussian measure G () with covariance (and mean 0), which could, in nitely many dimensions, be expressed by G ()(d) / exp(hj^1ji)d (where d is the obvious Lebesgue measure on H).³ This is not adequate, however, since the measure that we seek must live on the sphere S (H) whereas G () is spread out over all of H . We thus adjust and then project G () to S (H), in the manner described in Section 2, in order to obtain the measure GAP (), having the prescribed covariance $\$ as well as

 $^{^{3}}$ Berry [3] has conjectured, and for some cases proven, that such measures describe interesting universal properties of chaotic energy eigenfunctions in the sem iclassical regime, see also [12, 23]. It is perhaps worth considering the possibility that the GAP measures described here provide som ewhat better candidates for this purpose.

other desirable properties.

It is our contention that a quantum system in therm al equilibrium at inverse tem – perature should be described by a random state vector whose distribution is given by the measure GAP () associated with the density matrix for the canonical ensemble,

In order to convey the signi cance of GAP () as well as the plausibility of our proposal that GAP () describes them alequilibrium, we recall that a system described by a canonical ensemble is usually regarded as a subsystem of a larger system. It is therefore in portant to consider the notion of the distribution of the wave function of a subsystem. Consider a composite system in a pure state $2 H_1 H_2$, and ask what might be meant by the wave function of the subsystem with H ilbert space H_1 . For this we propose the following. Let figging be a (generalized) orthonormal basis of H_2 (playing the role, say, of the eigenbasis of the position representation). For each choice of join the (partial) scalar product ho_2 j i, taken in H_2 , is a vector belonging to H_1 . Regarding join as random, we are led to consider the random vector $12 H_1$ given by

where N = N (;Q₂) = hQ₂ji¹ is the normalizing factor and jQ₂i is a random element of the basis figure, chosen with the quantum distribution

We refer to $_1$ as the conditional wave function [6] of system 1. Note that $_1$ becomes doubly random when we start with a random wave function in H $_1$ H $_2$ instead of a xed one.

The distribution of $_1$ corresponding to (4) and (5) is given by the probability measure on S (H $_1$),

where ()d denotes the \delta" measure concentrated at . While the density matrix $_{1}$ associated with $_{1}$ always equals the reduced density matrix $_{1}^{\text{red}}$ of system 1, given by

the measure $_1$ itself usually depends on the choice of the basis figures. It turns out, nevertheless, as we point out in Section 5.1, that $_1$ (d $_1$) is a universal function of $_1^{\text{red}}$

in the special case that system 2 is large and is typical (with respect to the uniform distribution on all wave functions with the same reduced density matrix), namely GAP ($\frac{red}{1}$). Thus GAP () has a distinguished, universal status among all probability measures on S (H) with density matrix.

To further support our claim that GAP () is the right measure for , we shall regard, as is usually done, the system described by as coupled to a (very large) heat bath. The interaction between the heat bath and the system is assumed to be (in some suitable sense) negligible. We will argue that if the wave function of the combined \system plus bath" has microcanonical distribution u_E ; then the distribution of the conditional wave function of the (sm all) system is approximately GAP (); see Section 4.

Indeed, a stronger statement is true. As we argue in Section 5.2, even for a typical xed m icrocanonical wave function of the composite, i.e., one typical for u_E ; , the conditional wave function of the system, de ned in (4), is then approximately GAP ()-distributed, for a typical basis fighing. This is related to the fact that for a typical m icrocanonical wave function of the composite the reduced density matrix for the system is approximately [7, 21]. Note that the analogous statement in classical m echanics would be wrong: for a xed phase point of the composite, be it typical or atypical, the phase point of the system could never be random, but rather would merely be the part of belonging to the system.

The remainder of this paper is organized as follows. In Section 2 we denote the measure GAP () and obtain several ways of writing it. In Section 3 we describe some natural mathematical properties of these measures, and suggest that these properties uniquely characterize the measures. In Section 4 we argue that GAP () represents the canonical ensemble. In Section 5 we outline the proof that GAP () is the distribution of the conditional wave function for most wave functions in H₁ H₂ with reduced density matrix if system 2 is large, and show that GAP () is the typical distribution of the conditional wave function arising from a xed microcanonical wave function of a system in contact with a heat bath. In Section 6 we discuss other measures that have been or might be considered as the therm all equilibrium distribution of the core cients of a GAP () -distributed state vector in the simplest possible example, the two-level system.

2 De nition of GAP ()

In this section, we de ne, for any given density matrix on a (separable) Hilbert space H ; the Gaussian adjusted projected measure GAP () on S (H). This de nition makes use of two auxiliary m easures, G () and GA (), de ned as follows.

G () is the Gaussian measure on H with covariance matrix (and mean 0). More explicitly, let finig be an orthonormal basis of eigenvectors of and p_h the corresponding eigenvalues,

Such a basis exists because has nite trace. Let Z_n be a sequence of independent complex-valued random variables having a (rotationally symmetric) G aussian distribution in C with mean 0 and variance

Note that ^G is not normalized, i.e., it does not lie in S (H). In order that ^G lie in H at all, we need that the sequence Z_n be square-summable, $_n \not Z_n \not f < 1$. That this is almost surely the case follows from the fact that $E_n \not Z_n f$ is nite. In fact,

It also follows that G alm ost surely lies in the positive spectral subspace of , the closed subspace spanned by those jni with $p_n \notin 0$, or, equivalently, the orthogonal complement of the kernel of ; we shall call this subspace support (). Note further that, since G () is the Gaussian measure with covariance , it does not depend (in the case of degenerate) on the choice of the basis fjnig among the eigenbases of , but only on

Since we want a measure on S (H) while G () is not concentrated on S (H) but rather is spread out, it would be natural to project G () to S (H). However, since projecting to S (H) changes the covariance of a measure, as we will point out in detail in Section 3.1, we introduce an adjustment factor that exactly compensates for the

change of covariance due to projection. We thus de ne the adjusted G aussian measure GA () on H $\,$ by

where P denotes the action of P on m easures.

M ore generally, one can de ne for any measure on H the \adjust-and-project" procedure: let A () be the adjusted measure A () (d) = k k² (d); then the adjusted-and-projected measure is P_{R} A () = A () P^{1} , thus de ning a mapping P A from the measures on H with (d) k k² = 1 to the probability measures on S (H). We then have that GAP () = P A (G ()).

We remark that GAP , too, lies in support() almost surely, and that P (G) does not have distribution GAP () nor covariance (see Sect.3.1).

We can be more explicit in the case that has nite rank $k = \dim \text{ support}(), e.g.$ for nite-dimensional H : then there exists a Lebesgue volume measure on support() = C^{k} , and we can specify the densities of G() and GA(),

where $_{E}$ is the m icrocanonical density m atrix given in (2) and u_{E} is the m icrocanonical m easure.

3 Properties of GAP()

In this section we prove the following properties of GAP ():

P roperty 1 The density matrix associated with GAP () in the sense of (1) is , i.e., $_{\rm GAP()} =$.

P roperty 2 The association 7 GAP () is covariant: For any unitary operator U on H ,

where $U = U^{1}$ is the adjoint of U and U is the action of U on m easures, $U = U^{1}$. In particular, GAP () is stationary under any unitary evolution that preserves .

Property 3 If $2 H_1 H_2$ has distribution GAP $\begin{pmatrix} 1 & 2 \end{pmatrix}$ then, for any basis figzing of H₂, the conditional wave function $_1$ has distribution GAP $\begin{pmatrix} 1 \end{pmatrix}$. (\GAP of a product density matrix has GAP marginal.")

W e will refer to the property expressed in Property 3 by saying that the fam ily of GAP m easures is hereditary. We note that when $2 \text{ H}_1 \text{ H}_2$ has distribution GAP () and is not a tensor product, the distribution of $_1$ need not be GAP ($_1^{\text{red}}$) (as we will show after the proof of Property 3).

Before establishing these properties let us form ulate what they say about our candidate GAP () for the canonical distribution. As a consequence of Property 1, the density matrix arising from = GAP () in the sense of (1) is the density matrix . As a consequence of Property 2, GAP () is stationary, i.e., invariant under the unitary time evolution generated by H. As a consequence of Property 3, if $2 H = H_1 H_2$ has distribution GAP ($_{H_1H_2}$) and system s 1 and 2 are decoupled, $H = H_1 I_2 + I_1 H_2$, where I_i is the identity on H_i , then the conditional wave function $_1$ of system 1 has a distribution (in H_1) of the same kind with the same inverse temperature , namely GAP ($_{H_1,H_1}$;). This ts well with our claim that GAP () is the therm al equilibrium distribution since one would expect that if a system is in therm al equilibrium at inverse temperature then so are its subsystem s.

We conjecture that the family of GAP measures is the only family of measures satisfying Properties 1{3. This conjecture is formulated in detail, and established for suitably continuous families of measures, in Section 6.2.

The follow ing lem m a, proven in Section 3.3, is convenient for show ing that a random wave function is GAP-distributed:

3.1 The Density M atrix

In this subsection we establish Property 1. We then add a remark on the covariance matrix.

R em ark on the covariance m atrix. The equation GAP() = can be understood as expressing that GAP() and G() have the sam e covariance. For a probability m easure on H with m ean 0 that need not be concentrated on S (H), the covariance m atrix C is given by Z

Suppose we want to obtain from a probability measure on S (H) having the same covariance. The projection P of to S (H), de ned by P (B) = (R^+B) for B S (H), is not what we want, as it has covariance

However, P = A() does the job: it has the same covariance. As a consequence, a naturally distinguished measure on S = (H) with given covariance is the G aussian adjusted projected measure, the G A P measure, with the given covariance.

3.2 GAP() is Covariant

W e establish P roperty 2 and then discuss in m ore general term s under which conditions a measure on S (H) is stationary.

P roof of P roperty 2. Under a unitary transform ation U, a G aussian m easure with covariance m atrix C transforms into one with covariance m atrix UCU. Since kU $k^2 = k k^2$, GA (C) transforms into GA (UCU); that is, U $_{C}^{GA}$ and $_{UCU}^{GA}$ are equal in distribution, and since kU $_{C}^{GA}k = k _{C}^{GA}k$, we have that U $_{C}^{GAP}$ and $_{UCU}^{GAP}$ are equal in distribution. In other words, GAP (C) transforms into GAP (UCU), which is what we claim ed in (20).

3.2.1 Stationarity

In this subsection we discuss a criterion for stationarity under the evolution generated by $H = {}_{n} E_{n} j_{n} j_{n} j_{n}$ Consider the following property of a sequence of complex random variables Z_{n} :

(The phase $Z_n = J_n j$ exists when $Z_n \notin 0$.) Condition (22) in plies that the distribution of the random vector = $\sum_{n} Z_n j_n i$ is stationary, since $Z_n (t) = \exp(iE_n t = 2) Z_n (0)$. Note also that (22) in plies that the distribution has mean 0.

We show that the $Z_n = mj^{GAP}$ i have property (22). To begin with, the $Z_n = mj^G$ i obviously have this property since they are independent G aussian variables. Since the density of GA () relative to G () is a function of the moduli alone, also the $Z_n = mj^{GA}$ i satisfy (22). Finally, since the jmj^{GAP} i jare functions of the jmj^{GA} ij while the phases of the mj^{GAP} i equal the phases of the mj^{GA} i, also the $Z_n = mj^{GAP}$ i satisfy (22). W e would like to add that (22) is not merely a su cient, but also almost a necessary condition (and morally a necessary condition) for stationarity. Independent uniform phases correspond to the uniform measure on ${}^{Q}_{n}$ S¹. is the only stationary measure if the motion on ${}^{Q}_{n}$ S¹ is uniquely ergodic, and this is the case whenever the spectrum fE_ng of H is linearly independent over the rationals Q, i.e., when every nite linear combination ${}^{P}_{n}$ r_nE_n of eigenvalues with rational coe cients r_n, not all of which vanish, is nonzero, see [2, 24].

This is true of generic H am iltonians, so that is generically the unique stationary distribution on the torus. But even when the spectrum of H is linearly dependent, e.g. when there are degenerate eigenvalues, and thus further stationary measures on the torus exist, these further measures should not be relevant to therm al equilibrium measures, because of their instability against perturbations of H [11, 1].

The stationary measure on $\bigvee_{n} S^{1}$ corresponds, for given moduli $\not Z_{n} j or$, equivalently, by setting $\not Z_{n} j = p (\not E_{n})^{1=2}$ for a given probability measure p on the spectrum of H, to a stationary measure $_{p}$ on S (H) that is concentrated on the embedded torus (23). The measures $_{p}$ are (for generic H) the extrem all stationary measures, i.e., the extrem allelements of the convex set of stationary measures, of which all other stationary measures are mixtures.

3.3 GAP M easures and G aussian M easures

Lemma 1 is more or less immediate from the denition of GAP (). A more detailed proof looks like this:

Proof of Lemma 1. By assumption the distribution 1 of with respect to is G (). Thus for the distribution of with respect to ${}^{0}(d!) = k (!)k^{2} (d!)$, we have 0 ${}^{1}(d) = k k^{2}$ ${}^{1}(d) = k k^{2} G()(d) = GA()(d)$. Thus, P ((!)) has distribution P GA() = GAP().

3.4 Generalized Bases

W e have already remarked in the introduction that the orthonorm albasis fj_2 ig of H $_2$, used in the de nition of the conditional wave function, could be a generalized basis, such

as a \continuous" basis, for which it is appropriate to write

W e wish to elucidate this further. A generalized orthonorm alloasis figli: $q_2 2 Q_2 g$ indexed by the set Q_2 is mathematically de ned by a unitary isomorphism H₂! $L^2 (Q_2; dq_2)$, where dq_2 denotes a measure on Q_2 . We can think of Q_2 as the conguration space of system 2; as a typical example, system 2 may consist of N₂ particles in a box

R³, so that its con guration space is $Q_2 = N_2$ with dq₂ the Lebesgue measure (which can be regarded as obtained by combining N₂ copies of the volum e measure on R³).⁴ The form alket jq₂ i then means the delta function centered at q₂; it is to be treated as (though strictly speaking it is not) an element of H₂.

The de nition of the conditional wave function $_1$ then reads as follows: The vector 2 H $_1$ H $_2$ can be regarded, using the isom orphism H $_2$! L² (Q $_2$;dq $_2$), as a function :Q $_2$! H $_1$. Eq. (4) is to be understood as meaning

which is how (5) is to be understood in this setting. As is defined only up to changes on a null set in Q_2 , $_1$ may not be defined for a particular Q_2 . Its distribution in H $_1$, however, is defined unambiguously by (24). In the most familiar setting with H $_1 = L^2(Q_1; dq_1)$, we have that $(Q_2)(q_1) = (q_1; Q_2)$.

In the follow ing, we will allow generalized bases and use continuous instead of discrete notation, and set $M_2 j i = (Q_2)$.

⁴ In fact, in the original de nition of the conditional wave function in [6], q_2 was supposed to be the conguration, corresponding to the positions of the particles belonging to system 2. For our purposes here, how ever, the physical meaning of the q_2 is irrelevant, so that any generalized orthonorm albasis of H $_2$ can be used.

3.5 Distribution of the W ave Function of a Subsystem

Proof of Property 3. The proof is divided into four steps.

Thus $f(q_2)$ hog j i is G (1)-distributed, which completes step 2.

To verify the statem ent after P roperty 3, consider the density matrix = j ih j for a pure state of the form = $\Pr_n p_{\overline{p_n} n}$, where f ng and f ng are respectively orthonorm all bases for H₁ and H₂ and the p_n are nonnegative with $\Pr_n p_n = 1$. Then a GAP ()-distributed random vector coincides with up to a random phase, and so $\frac{red}{1} = \Pr_n p_n j_n$ ih nj. Choosing for fjp ig the basis f ng, the distribution of 1 is not GAP ($\frac{red}{1}$) but rather is concentrated on the eigenvectors of $\frac{red}{1}$. When the p_n are pairw ise-distinct this measure is the measure E IG ($\frac{red}{1}$) we denote in Section 6.1.1.

4 M icrocanonical D istribution for a Large System Implies the D istribution GAP () for a Subsystem

In this section we use P roperty 3, i.e., the fact that G A P m easures are hereditary, to show that G A P () is the distribution of the conditional wave function of a system coupled to a heat bath when the wave function of the composite is distributed m icrocanonically, i.e., according to $u_{\rm E}$;

Consider a system with H ilbert space H₁ coupled to a heat bath with H ilbert space H₂. Suppose the composite system has a random wave function $2 H = H_1 H_2$ whose distribution is microcanonical, u_E ; . A ssume further that the coupling is negligibly small, so that we can write for the H am iltonian

and that the heat bath is large (so that the energy levels of H $_2$ are very close).

It is a well known fact that form acroscopic systems di erent equilibrium ensembles, for example the microcanonical and the canonical, give approximately the same answer for appropriate quantities. By this equivalence of ensembles [17], we should have that $_{\rm E}$; for suitable = (E). Then, since GAP () depends continuously on , we have that $u_{\rm E}$; = GAP ($_{\rm E}$;) GAP (). Thus we should have that the distribution of the conditional wave function $_1$ of the system is approximately the same as would be obtained when is GAP ()-distributed. But since, by (27), the canonical density matrix is then of the form

we have by Property 3 that $_1$ is approximately GAP ($_{H_1;H_1}$;)-distributed, which is what we wanted to show .

5 Typicality of GAP M easures

The previous section concerns the distribution of the conditional wave function $_1$ arising from the microcanonical distribution of the wave function of the composite. It concerns, in other words, a random wave function of the composite. The result there is the analogue, on the level of measures on H ilbert space, of the well known result that if a microcanonical density matrix (2) is assumed for the composite, the reduced density matrix $_1^{\text{red}}$ of the system, de ned as the partial trace tr_{2 E;}, is canonical if the heat bath is large [13].

As indicated in the introduction, a stronger statem ent about the canonical density matrix is in fact true, namely that for a xed (nonrandom) wave function of the composite which is typical with respect to u_{E} ; ${}_{1}^{red} = {}_{H_1,H_1}$; when the heat bath is large (see [7, 21]; for a rigorous study of special cases of a similar question, see [22]).⁵ This stronger statem ent will be used in Section 5.2 to show that a similar statem ent holds for the distribution of ${}_{1}$ as well, namely that it is approximately GAP (${}_{H_1,H_1}$;)-distributed for a typical xed 2 H ${}_{E}$; and basis figzing of H ${}_{2}$. But we must rst consider the distribution of ${}_{1}$ for a typical 2 H .

5.1 Typicality of GAP M easures for a Subsystem of a Large System

In this section we argue that for a typical wave function of a big system the conditional wave function of a small subsystem is approximately GAP-distributed, rst giving a precise formulation of this result and then sketching its proof. We give the detailed proof in [8].

⁵ It is a consequence of the results in [19] that when dim H₂ ! 1, the reduced density matrix becom esproportional to the identity on H₁ for typical wave functions relative to the uniform distribution on S (H) (corresponding to u_E ; for E = 0 and H = 0).

5.1.1 Statem ent of the Result

Let $H = H_1$ H_2 , where H_1 and H_2 have respective dimensions k and m, with k < m < 1. For any given density matrix 1 on H_1 , consider the set

where $\frac{red}{1}$ () = tr₂j ih j is the reduced density matrix for the wave function . There is a natural notion of (norm alized) uniform measure u₁ on R (₁); we give its precise de nition in Section 5.1.3.

We claim that for xed k and large m, the distribution $_1$ of the conditional wave function $_1$ of system 1, de ned by (4) and (5) for a basis figzing of H $_2$, is close to GAP ($_1$) for the overwhelm ing majority, relative to u $_1$, of vectors 2 H with reduced density matrix $_1$. M ore precisely:

5.1.2 Measure on H Versus Density Matrix

It is important to resist the temptation to translate u_1 into a density matrix in H . As mentioned in the introduction, to every probability measure on S (H) there corresponds a density matrix in H, given by (1), which contains all the empirically accessible information about an ensemble with distribution . It may therefore seem a natural step to consider, instead of the measure u_1 , directly its density matrix $= \frac{1}{m} - 1$ I₂, where I₂ is the identity on H₂. But since our result concerns properties of most wave functions relative to , it cannot be form ulated in term softhe density matrix . In particular, the corresponding statement relative to another measure = 0.66 on S (H) with the same density matrix = -0.66 on soft are product vectors, we could be false. Noting that has a basis of eigenstates that are product vectors, we could, for example, take = 0.66 to be a measure concentrated on these eigenstates. For any such state u_1 is a delta-measure.

5.1.3 Outline of Proof

The result follows, by (5), Lemma 1, and the continuity of P A, from the corresponding statement about the Gaussian measure G ($_1$) on H $_1$ with covariance $_1$:

As the reduced density matrix is given, $\frac{red}{1} = \frac{1}{1}$, the orthonormal basis f_ig and the coecients c_i are determined (when 1 is nondegenerate) as the eigenvectors and the square-roots of the eigenvalues of 1, and, R (1) is in a natural one-to-one correspondence with the set ONS (H₂;k) of all orthonormal systems f_ig in H₂ of cardinality k. (If some of the eigenvalues of 1 vanish, the one-to-one correspondence is with ONS (H₂;k⁰) where k⁰ = dim support(1).) The Haar measure on the unitary group of H₂ de nes the uniform distribution on the set of orthonormal bases of H₂, of which the uniform distribution on ONS (H₂;k) is a marginal, and thus de nes the uniform distribution u₁ on R (1). (When 1 is degenerate, u₁ does not depend upon how the eigenvectors i of 1 are chosen.)

The key idea for establishing (32) from the Schmidt decomposition (33) is this: 1 is the average of m delta measures with equal weights, $1 = m^{-1} p_{q_2 - 1}(q_2)$, located at the points

Now regard as random with distribution u_1 ; then the $_1(q_2)$ are m random vectors, and $_1$ is their empirical distribution. If the m k coe cients hq_2j_i were independent Gaussian (complex) random variables with (mean zero and) variance m⁻¹, then the $_1(q_2)$ would be m independent drawings of a G ($_1$)-distributed random vector; by the weak law of large numbers, their empirical distribution would usually be close to G ($_1$); in fact, the probability that $_1(f) = G(_1)(f) < "$ would converge to 1, as m ! 1.

However, when f $_{i}g$ is a random orthonormal system with uniform distribution as described above, the expansion coe cients $hq_{2}j_{i}i$ in the decomposition of the $_{i}s$

This completes the proof.

5.1.4 Reform ulation

W hile this result suggests that GAP () is the distribution of the conditional wave function of a system coupled to a heat bath when the wave function of the composite is a typical xed m icrocanonical wave function, belonging to H $_{\rm E}$; , it does not quite im ply it. The reason for this is that H $_{\rm E}$; has measure 0 w ith respect to the uniform distribution on H ; even when the latter is nite-dimensional. Nonetheless, there is a simple corollary, or reform ulation, of the result that will allow us to cope with m icrocanonical wave functions.

We have indicated that for our result the choice of basis fig.ig of H $_2$ does not matter. In fact, while $_1$, the distribution of the conditional wave function $_1$ of system 1, depends upon both 2 H and the choice of basis fig.ig of H $_2$, the distribution of $_1$ itself, when is u $_1$ -distributed, does not depend upon the choice of basis. This follows from the fact that for any unitary U on H $_2$

(and the invariance of the H aar m easure of the unitary group of H $_2$ under left multiplication). It similarly follows from (38) that for xed 2 H , the distribution of $_1$

arising from the uniform distribution of the basis figing, in the set ONB (H $_2$) of all orthonormal bases of H $_2$, is the same as the distribution of $_1$ arising from the uniform distribution u $_1$ of with a xed basis (and the fact that the H aarm easure is invariant under U ? U 1). We thus have the following corollary:

Let 2 H and let $_1 = tr_2 j$ ih j be the corresponding reduced density matrix for system 1. Then for a typical basis fig_ig of H $_2$, the conditional wave function $_1$ of system 1 is approximately GAP ($_1$)-distributed when m is large: For every " > 0 and every bounded continuous function f :S (H $_1$)! 5.2 Typicality of GAP () for a Subsystem of a Large System in the M icrocanonical Ensemble

It is an immediate consequence of the result of Section 5.1.4 that for any xed microcanonical wave function for a system coupled to a (large) heat bath, the conditional wave function $_1$ of the system will be approximately GAP-distributed. When this is combined with the \canonical typicality" described near the beginning of Section 5, we obtain the following result:

Consider a system with nite-dimensional H ibert space H₁ coupled to a heat bath with nite-dimensional H ibert space H₂. Suppose that the coupling is weak, so that we can write H = H₁ I₂+ I₁ H₂ on H = H₁ H₂, and that the heat bath is large, so that the eigenvalues of H₂ are close. Then for any wave function that is typical relative to the m icrocanonical measure u_{E} ; the distribution $_1$ of the conditional wave function $_1$, de ned by (4) and (5) for a typical basis figzing of the heat bath, is close to GAP () for suitable = (E), where $=_{H_1;H_1;}$. In other words, in the therm odynam ic limit, in which the volume V of the heat bath and dim (H₂) go to in nity and E = V = e is constant, we have that for all "; > 0, and for all bounded continuous functions f : S (H₁) ! R,

We note that if $f p_2$ is were an energy eigenbasis rather than a typical basis, the result would be false.

6 Remarks

6.1 O ther C and idates for the C anonical D istribution

We review in this section other distributions that have been, or may be, considered as possible candidates for the distribution of the wave function of a system from a canonical ensemble.

6.1.1 A D istribution on the E igenvectors

O ne possibility, which goes back to von N eum ann [25, p. 329], is to consider (d) as concentrated on the eigenvectors of ; we denote this distribution E IG () after the rst letters of \eigenvector"; it is de ned as follows. Suppose rst that is nondegenerate. To select an E IG ()-distributed vector, pick a unit eigenvector jni, so that $jni = p_i jni$, with probability p_n and random ize its phase. This de nition can be extended in a natural way to degenerate :

where H $_{\rm p}$ denotes the eigenspace of associated with eigenvalue p. Them easure E IG () is concentrated on the set ${}^{\rm S}_{\rm p}$ H $_{\rm p}$ of eigenvectors of , which for the canonical = H $_{\rm H}$; coincides with the set of eigenvectors of H; it is a mixture of the microcanonical distributions u_{S (H $_{\rm p}$) on the eigenspaces of H in the same way as in classical mechanics the canonical distribution on phase space is a mixture of the microcanonical distributions.}

Note that E IG ($_{E}$;) = u_{E} ; , and that in particular E IG ($_{E}$;) is not, when H is nondegenerate, the uniform distribution $_{E}$; on the energy eigenstates with energies in [E;E +], against which we have argued in the introduction.

The distribution E IG () has the same properties as those of GAP () described in Properties 1{3, except when is degenerate:

The measures E IG () are such that (a) they have the right density matrix: $_{E IG()} =$; (b) they are covariant: U E IG () = E IG (U U); (c) they are hereditary at nondegenerate : when H = H₁ H₂ and is nondegenerate and uncorrelated, = $_{1}$ 2, then E IG () has marginal (i.e., distribution of the conditional wave function) E IG ($_{1}$).

Proof. (a) and (b) are obvious. For (c) let, for i = 1;2, $j_{1i}i$ be a basis consisting of eigenvectors of i with eigenvalues $p_{n_1}^{(i)}$. Note that the tensor products $j_{11}i$ $j_{12}i$ are eigenvectors of with eigenvalues $p_{n_1}^{(1)}p_{n_2}^{(2)}$, and by nondegeneracy all eigenvectors of are of this form up to a phase factor. Since an E IG ()-distributed random vector is almost surely an eigenvector of , we have $= e^i N_1 i N_2 i$ with random N_1, N_2 , and .

The conditional wave function $_1$ is, up to the phase, the eigenvector N_1 i of $_1$ occurring as the rst factor in . The probability of obtaining N $_1 = n_1$ is $p_{n_1}^{(1)} p_{n_2}^{(2)} = p_{n_1}^{(1)} \cdot \frac{6}{2}$

In contrast, for a degenerate = $_1$ $_2$ the conditional wave function need not be E IG ($_1$)-distributed, as the following example shows. Suppose $_1$ and $_2$ are nondegenerate but $p_{n_1}^{(1)}p_{n_2}^{(2)} = p_{m_1}^{(1)}p_{m_2}^{(2)}$ for some $n_1 \notin m_1$; then an E IG ()-distributed , whenever it happens to be an eigenvector associated with eigenvalue $p_{n_1}^{(1)}p_{n_2}^{(2)}$, is of the form $cj_{n_1}ij_{n_2}i + c^0j_{m_1}ij_{m_2}i$, alm ost surely with nonvanishing coe cients c and c⁰; as a consequence, the conditional wave function is a multiple of $cj_{n_1}ihQ_2j_{n_2}i + c^0j_{m_1}ihQ_2j_{n_2}i$, which is, for typical Q_2 and unless $j_{n_2}i$ and $j_{m_2}i$ have disjoint supports, a nontrivial superposition of eigenvectors $j_{n_1}i$, $j_{m_1}i$ with di erent eigenvalues and thus cannot arise from the E IG ($_1$) distribution.⁷

Note also that E IG () is discontinuous as a function of at every degenerate ; in other words, E IG ($_{H}$; $_{H}$;) is, like $_{E}$; unstable against small perturbations of the H am iltonian. (And, as with $_{E}$; this fact, quite independently of the considerations on behalf of G A P -m easures in Sections 4 and 5, suggests against using E IG () as a therm alequilibrium distribution.) Moreover, E IG () is highly concentrated, generically on a one-dimensional subset of S (H), and in the case of a nite-dimensional H ilbert space H fails to be absolutely continuous relative to the uniform distribution u_{S} (H) on the unit sphere.

For further discussion of fam ilies () of m easures satisfying the analogues of P roperties $1{3, see Section 62.}$

6.1.2 An Extrem al D istribution

Here is another distribution on H associated with the density matrix . Let the random vector be X

the $_{p}$ being independent random vectors with distributions $u_{S_{(H_{p})}}$. In case all eigenvalues are nondegenerate, this means the coe cients Z_{n} of $_{p}$ = $_{n}Z_{n}$ jni, have independent uniform phases but xed moduli $Z_{n} j = \frac{p}{p_{n}} |$ in sharp contrast with the moduli when is GAP ()-distributed. And in contrast to the measure E IG () considered in the previous subsection, the weights p_{n} in the density matrix now come from the

⁶The relevant condition for (c) follows from nondegeneracy but is weaker: it is that the eigenvalues of 1 and 2 are multiplicatively independent, in the sense that $p_{n_1}^{(1)}p_{n_2}^{(2)} = p_{m_1}^{(1)}p_{m_2}^{(2)}$ can occur only trivially, i.e., when $p_{n_1}^{(1)} = p_{m_1}^{(1)}$ and $p_{n_2}^{(2)} = p_{m_2}^{(2)}$. In particular, the nondegeneracy of 1 and 2 is irrelevant.

xed size of the coe cients of when it is decomposed into the eigenvectors of , rather than from the probability with which these eigenvectors are chosen. This measure, too, is stationary under any unitary evolution that leaves invariant. In particular, it is stationary in the thermal case = $_{H_{i},H_{i}}$, and for generic H it is an extremal stationary measure as characterized in Section 3.2.1; in fact it is, in the notation of the last paragraph of Section 3.2.1, $_{p}$ with $p(E_{n}) = (1=Z) \exp(E_{n})$.

This measure, too, is highly concentrated: For a Hilbert space H of nite dimension k, it is supported by a submanifold of real dimension 2k m where m is the number of distinct eigenvalues of H, hence generically it is supported by a submanifold of just half the dimension of H.

6.1.3 The Distribution of Guerra and Lo redo

In [10], Guerra and Lo redo consider the canonical density matrix for the onedimensional harmonic oscillator and want to associate with it a disconprocess on the real line, using stochastic mechanics [18, 9]. Since stochastic mechanics associates a process with every wave function, they achieve this by nding a measure on S ($L^2(\mathbb{R})$) whose density matrix is .

They propose the following measure $\$, supported by coherent states. W ith every point (q;p) in the classical phase space R 2 of the harm on ic oscillator there is associated a coherent state

with $^2 = -2m!$, thus de ning a mapping C : R²! S (L²(R)), C (q;p) = $_{q;p}$. Let H (q;p) = $p^2=2m + \frac{1}{2}m!^2q^2$ be the classical Ham iltonian function, and consider the classical canonical distribution at inverse temperature 0 ,

Let ${}^{0} = \frac{e^{-!} 1}{-!}$: Then = C ${}^{class}_{0}$ is the distribution on coherent states arising from ${}^{class}_{0}$. The density matrix of is [10].

This measure is concentrated on a 2-dimensional submanifold of S ($L^2(R)$), namely on the set of coherent states (the image of C). Note also that not every density matrix on $L^2(R)$ can arise as the density matrix of a distribution on the set of coherent states; for example, a pure state = j in j can arise in this way if and only if is a coherent state.

6.1.4 The D istribution M axim izing an Entropy Functional

In a similar spirit, one may consider, on a nite-dimensional Hilbert space H , the distribution $(d) = f()u_{S(H)}(d)$ that maximizes the G ibbs entropy functional

A standard calculation using Lagrange multipliers leads to

with L a self-adjoint matrix determined by (46b) and (46d); comparison with (18b) shows that is not a GAP measure. (We remark, however, that another G ibbs entropy functional, $G^{0}[f] = \binom{R}{H}$ (d) f() log f(), based on the Lebesgue measure on H instead of $u_{S(H)}$, is maximized, under the constraints that the mean be 0 and the covariance be , by the Gaussian measure, f() (d) = G()(d).) There is no apparent reason why the family of measures should be hereditary.

The situation is di erent for the microcanonical ensemble: here, the distribution u_{E} ; = GAP ($_{E}$;) that we propose is in fact the maximizer of the appropriate G ibbs entropy functional G⁽⁰⁾. W hich functional is that? Since any measure (d) on S (H) whose covariancematrix is the projection $_{E}$; = const: $1_{E,E+-1}$ (H) must be concentrated on the subspace H $_{E}$; and thus cannot be absolutely continuous (possess a density) relative to $u_{S-(H-)}$, we consider instead its density relative to $u_{S-(H-)} = u_{E}$; that is, we consider (d) = f() u_{E} ; (d) and set

$$G^{00}[f] = u_{E}; (d) f() \log f():$$
(48)

Under the constraints that the probability measure have mean 0 and covariance $_{E;}$, $G^{(0)}[f]$ is maximized by f 1, or = $u_{E;}$; in fact even without the constraints on , $G^{(0)}[f]$ is maximized by f 1.

6.1.5 The Distribution of Brody and Hughston

B rody and H ughston [5] have proposed the following distribution to describe them al equilibrium. They observe that the projective space arising from a nite-dimensional H ilbert space, endowed with the dynamics arising from the unitary dynamics on H ilbert space, can be regarded as a classical H am iltonian system with H am iltonian function H (C) = h H j i=h j i (and symplectic form arising from the H ilbert space structure). They then de ne to be the classical canonical distribution of this H am iltonian system , i.e., to have density proportional to exp(H (C)) relative to the uniform volume m easure on the projective space (which can be obtained from the symplectic form or, alternatively, from $u_{S (H)}$ by projection from the sphere to the projective space). However, this distribution leads to a density matrix, di erent from the usual one given by (3), that does not describe the canonical ensemble.

6.2 A Uniqueness Result for GAP ()

A sE IG () is a fam ily of measures satisfying Properties 1{3 form ost density matrices , the question arises whether there is any fam ily of measures, besides GAP (), satisfying these properties for all density matrices. We expect that the answer is no, and form ulate the follow ing uniqueness conjecture: G iven, for every H ibert space H and every density matrix on H , a probability measure () on S (H) such that Properties 1{3 remain true when GAP () is replaced by (), then () = GAP (). In other words, we conjecture that = GAP () is the only hereditary covariant inverse of (1).

This is in fact true when we assume in addition that the mapping : 7 () is suitably continuous. Here is the argument: W hen is a multiple of a projection, = $(\dim H^{-0})^{-1}P_{H^{-0}}$ for a subspace H⁻⁰ H, then () must be, by covariance U () = $(U \ U)$, the uniform distribution on S (H⁻⁰), and thus () = GAP () in this case. Consider now a composite of a system (system 1) and a large heat bath (system 2) with H ilbert space H = H₁ H₂ and H am iltonian H = H₁ I₂ + I₁ H₂, and consider the m icrocanonical density matrix $_{E}$; for this system . By equivalence of ensembles, we have for suitable > 0 that $_{E}$; $_{H^{-}H^{+}}$; $= (1)^{-(2)}$ where $(1)^{-(1)} = _{H^{-1}H^{-1}}$. By the continuity of and GAP,

Now consider, for a wave function with distribution (1) (2) respectively GAP ((1) (2)), the distribution of the conditional wave function $_1$: by heredity, this is ((1)) respectively GAP ((1)). Since the distribution of $_1$ is a continuous function of the distribution of , we thus have that ((1)) GAP ((1)). Since we can make the degree of approximation arbitrarily good by making the heat bath su ciently large, we must have that ((1)) = GAP ((1)). For any density matrix on H 1 that does not have zero am ong its eigenvalues, there is an H 1 such that $= (1) = Z^{-1} \exp (-H_1)$ for = 1, and thus we have that (-) = GAP (-) for such a ; since these are dense, we have that (-) = GAP (-) for all density matrices on H 1. Since H 1 is arbitrary we are done.

6.3 Dynam ics of the Conditional W ave Function

M arkov processes in H ilbert space have long been considered (see [4] for an overview), particularly di usion processes and piecew ise determ inistic (jump) processes. This is often done for the purpose of num erical simulation of a master equation for the density matrix, or as a model of continuous measurement or of spontaneous wave function collapse. Such processes could arise as follows.

Since the conditional wave function $_1$ arises from the wave function hgpj i by inserting a random coordinate Q_2 for the second variable (and normalizing), any dynam ics (i.e., tim e evolution) for Q_2 , described by a curve t $\P Q_2$ (t) and preserving the quantum probability distribution of Q_2 , for example, as given by Bohm ian mechanics [6], gives rise to a dynam ics for the conditional wave function, t $\P _1$ (t) = N (t) h Q_2 (t) j (t) i, where (t) evolves according to Schrödinger's equation and N (t) = kh Q_2 (t) j (t) ik 1 is the normalizing factor. In this way one obtains a stochastic process (a random path) in S (H $_1$). In the case considered in Section 4, in which H $_2$ corresponds to a large heat bath, this process must have GAP ($_{H_1,H_1}$;) as an invariant measure. It would be interesting to know whether this process is approximately a simple process in S (H $_1$), perhaps a di usion process, perhaps one of the M arkov processes on H ilbert space considered already in the literature.

7 The Two-Level System as a Simple Example

In this last section, we consider a two-level system, with $H = C^2$ and

$$H = E_1 j lihl j + E_2 j lihl j$$

and calculate the joint distribution of the energy coe cients $Z_1 = h1ji$ and $Z_2 = h2ji$ for a GAP ()-distributed as explicitly as possible. We begin with a general nitedimensional system, $H = C^k$, and specialize to k = 2 later. One way of describing the distribution of is to give its density relative to the hypersurface area measure u on S (C^{k}); this we did in (18). Another way of describing the joint distribution of the Z_{n} is to describe the joint distribution of their moduli $Z_{n}j$, or of $Z_{n}\hat{J}$, as the phases of the Z_{n} are independent (of each other and of the moduli) and uniform by distributed, see (22).

Before we determ ine the distribution of $\mathcal{I}_n \mathcal{J}$, we repeat that its expectation can be computed easily. In fact, for any 2 H we have

$$E h ji^{2} = GAP()(d) h ji^{2} = \frac{1}{2} h j ji^{(3)} \frac{1}{Z()} h je^{H} ji:$$

Thus, for j i= jii, we obtain E $\mathbf{Z}_n \mathbf{j} = e^{E_n} = tr e^H$.

For greater clarity, from now on we write Z_n^{GAP} instead of Z_n . A relation similar to that between GAP (), GA (), and G () holds between the joint distributions of the $\mathcal{Z}_n^{GAP} \hat{\mathcal{I}}$, of the $\mathcal{Z}_n^{GA} \hat{\mathcal{I}}$, and of the $\mathcal{Z}_n^G \hat{\mathcal{I}}$. The joint distribution of the $\mathcal{Z}_n^G \hat{\mathcal{I}}$ is very sim – ple: they are independent and exponentially distributed with means $p_n = e^{-E_n} = \mathbb{Z}$ (). Since the density of GA relative to G, dGA=dG = $\begin{bmatrix} p \\ n \end{bmatrix} \hat{\mathcal{I}}_n \hat{\mathcal{I}}$, is a function of the moduli alone, and since, according to (22), GA = GA_{phases} GA_{moduli} , we have that

We now specialize to the two-level system, k = 2. Since $\mathcal{I}_{1}^{GAP} \hat{f} + \mathcal{I}_{2}^{GAP} \hat{f} = 1$, it su cess to determ ine the distribution of $\mathcal{I}_{1}^{GAP} \hat{f}$, for which we give an explicit form ula in (52c) below. We want to obtain the marginal distribution of (51) from the joint distribution of the $\mathcal{I}_{n}^{GA} \hat{f}$ in (0;1)², the rst quadrant of the plane, as given by (50). To this end, we introduce new coordinates in the rst quadrant:




Figure 1: P lot of the distribution density function f (s) of $\mathcal{I}_1 \mathcal{I}_1$, de ned in (52c), for various values of the parameter = exp($(E_2 E_1)$): (a) = 1=3, (b) = 1=2, (c) = 1, (d) = 2, (e) = 3.

with $_1 = (^1 (^1 + 1)=2)^{1=3}$ and $_2 = ((+1)=2)^{1=3}$ for $= \exp((E_2 E_1))$. The density f of the distribution (52c) of $\mathcal{I}_1^{GAP} f$ is depicted in Figure 1 for various values of . For = 1, f is identically 1. For > 1, we have $_2 = _1 > _1$, so that $_1s + _2(1 s)$ is decreasing monotonically from $_2$ at s = 0 to $_1$ at s = 1; hence, f is increasing monotonically from $_2^3$ to $_1^3$. For < 1, we have $_2 < _1$, and hence f is decreasing monotonically from $_2^3$ to $_1^3$. In all cases f is convex since $f^{00} = 0$.
