# Least paradoxical states of the Schrodinger cat

#### Abstract

M odeling the Schrodinger cat by a two state system and assum ing that the cat is coupled to the environm ent we look for the least paradoxical states of the Schrodinger cat in the follow ing way. We require the reduced density $m$ atrix of the cat for one of the tw o states in the superposition to be the sam e as the one for the total state while distinct from the reduced density $m$ atrix of the cat for the other state in the supenposition. W e then look for the reduced density $m$ atrices for $w$ hich the cat is as alive as possible for the rst state (and as dead as possible for the second state). T he resulting states are those in which the probability for the cat to be alive (or dead) is $1=2+\quad 2=4 \quad 0: 854$.

In the thought experim ent introduced by Schrodinger [1] a supenposition ofm icroscopically distinct orthogonal states leads to a supenposition ofm acroscopically distinct orthogonal states of the type

where $j_{1} i$ describes the Universe in which the cat is alive, while $j_{2}$ i describes the Universe in which the cat is dead. R ather then discussing possible resolutions of the paradox (see, e.g. [2]) we w ould like to consider for what states the paradoxicalnature of superposition (1) is least pronounced. Let us denote the reduced density matrices of the cat for states $j i, j 1 i$, and $j_{2} i b y, ~ r e s p e c t i v e l y, ~$, 1 , and 2 . The paradox would not exit if 1 and 2 corresponded, respectively, to pure states for alive and dead cat, and was identical to either 1 or 2 . C learly, this is not possible. H ow ever, since the cat can be entangled w ith the environm ent, we can relax the requirem ent that 1 and 2 correspond to pure states while keeping the requirem ent that is the same as either 1 or 2 . This would im ply that the cat has som e probability of being dead for state 1 and som e probability ofbeing alive for state 2 . Then we can look for the density matriges 1 and 2 for which the cat is, respectively, as alive and as dead as possible. O ur analysis show that the resulting states of the cat are those for which its probability to be alive (or dead) is $1=2+\quad \overline{2}=4 \quad 0: 854$.

T o form ulate the problem m ore precisely wem odel the cat by a two state system w ith states ᄀli and Riwhich correspond, respectively, to alive and dead states of the cat. W e im pose no restrictions on the form of the environm ent. Since the cat is m odeled by the two state system one can visualize the problem by using the B loch vector form alism [3]. Since we require that is equal to, say, 1 , the B loch vectors associated w ith and 1 have to be the sam e. W e also would like the reduced density $m$ atrices 1 and 2 to correspond to distinct states of the cat. H ow ever, once 1 is given, there is no unique way to choose a distinct 2 . O ne possible choige is based on the fact that in the Bloch picture two orthogonal pure
states correspond to two vectors of unit length pointing in the opposite directions. Generalizing this to the density $m$ atrices $w e w$ ill require the vector for 2 to be of the sam e length as for 1 but pointing in the opposite direction. Let the $B$ loch vector for state $71 i$ to lie in the positive $z$ direction. Then our problem is to nd vectors for , 1 , and 2 which , in addition to the requirem ents im posed above, have the largest absolute value of the $z$ com ponent. It is clear from this picture that one necessary condition is that all three vectors are parallel to the $z$ axis. To nd the $m$ axim um possible length of the vectors and the corresponding probabilities it is convenient
 Schm idt decom positions, i. e.,

H ere 2 is the probability that the cat is alive in state $j{ }_{1} i$ and that it is dead in state j $2 i$. Since Eqs. (2) are the Schm idt decom positions, functions j 1 i and j $2 i$ are orthonorm alas are functions $j_{1} i$ and $j_{2} i$. Our analysis now reduces to the search for states $j_{1} i, j{ }_{2} i, j{ }_{1} i$, and $j j_{2} i w h i c h$ lead to the largest value for ${ }^{2}$ and ensure that all the requirem ents im posed above are satis ed.

Since we require states $j_{1} i$ and $j_{2} i$ to be orthogonal to each other we m ust have

Substituting Eqs. (2) into Eq. (1) we obtain for $j$ i

As we want the reduced density $m$ atrix obtained from state $j i$ to be the same as the one obtained from state $j{ }_{1} i$, state $j i$ should have the Schm idt decom position

C om paring Eq. (4) and Eq. (5) we obtain for $j_{1} i$ and $j_{2} i$

For Eq. (5) to be the required Schm idt decom position functions $j_{1} i$ and $j_{2} i$ have to be orthonom al. It is sufcient to require that $j_{1} i$ and $j_{2} i$ are orthogonal and that one of them is norm alized since conditions (3) will ensure that the other state is also nom alized. Requiring that state $j_{1} i$ is norm alized leads to the follow ing equation for

$w h e r e A=h_{1} j_{1} i+h_{1} j_{1} i$. The requirem ent of orthogonality of $j_{1} i$ and $j_{2} i$ leads to

Solving Eq. 77) for and keeping only the positive solution (since the Schm idt decom positions allow only for positive expansion coe cients) we obtain

States $j_{1} i$ and $j_{1} i$ are nom alized, as a result A can take valuesbetween 2 and 2. Them axim um value of , $m$ is reached for $A=2 . T$ he corresponding probability m

m is given by

For $A$ to be equal to 2 we must have $j_{1 i}=j_{1} i$. C ondition (3) then requires that $j_{2} i=j j_{2} i$. The last tw o equalities ensure that condition (8) is also satis ed.

Thus, states $j i, j_{1} i$, and $j_{2} i w i t h$ the sought after properties w ill have the form
where j $1 i$ and j $2 i$ are tw o arbitrary orthonorm alstates ofthe environm ent and $m$ is obtained from (10). To sum up, the reduced density $m$ atrioes of the cat for states $j i$ and $j_{1} i$ are identical and diagonal in the basis of states $j 1 i$ and $2 i$, the probability for the cat to be alive is about 0.854 . The reduced density $m$ atrix of the cat for state $j_{2} i$ is also diagonal in the same basis, the probability for the cat to be dead is about 0.854 .

It is easy to see that the lim it $m$ appears already on the level of an isolated two state system. C onsider the follow ing orthonorm al states for tw o state system
and their superposition
$N$ ote that states $\overline{\mu i} i, j I I$, and $j I I I$ i have the sam e probabilities for the cat to be alive as, respectively, states $j_{1} i_{1} j_{2} i$, and $j i$. If we use the B loch vector form alism and chose the vector for state $j$ li to lie along the positive $z$ axis, then state $\overline{j i}$ corresponds to vector $P_{I}$ at 45 degrees to the $z$ axis. $T$ he $B$ loch vector $P$ II for state $j I I i$ is of the sam e length as $P_{I}$ but pointing in the opposite direction, while vector $P_{\text {III }}$ for state jIIIi is at 45 degrees to the z axis and perpendicular to both $\mathrm{P}_{I}$ and $\mathrm{P}_{\text {II }}$. It is clear from this picture thaf vectors $P_{\text {I }}$ and $P_{\text {II }} w$ ill have $z$ com ponents equal to $\overline{2}=2 \mathrm{w}$ th the corresponding probability for the cat to be alive given ${ }^{2}$ by ${ }_{\mathrm{m}}^{2}$ while the $z$ com ponent for vector $P_{\text {III }} w$ ill be $\overline{2}=2$. By us ing this geom etricalpicture one can convince oneself that this arrangem ent of vectors insures the largest absolute value of the $z$ com ponent for the three vectors. A ll three vectors, how ever, will have non zero and di erent $x$ and $y$ com ponents. Thus, coupling the cat to the environ$m$ ent in states (11) cannot increase the absolute value of the $z$ com ponents and the corresponding probabilities. H ow ever, 辻 allow s to rem ove the $x$ and $y$ com ponents of the $B$ loch vectors for all three states $m$ aking the reduced density $m$ atrioes obtained from states $j i$ and $j_{1} i$ identical. It can be argued that in the resulting states (11) the fate of the cat is less dram atic than in the original form ulation of the paradox.
