Phase shift analysis in N im tz experiments on tunneling and transmission

A bstract For the wave representing particle traveling through any layer system we calculate appropriate phase shifts comparing two methods. One bases on the standard scattering theory and is well known another uses unim odular but not unitary M -m onodrom y matrix. Both methods are not equivalent due to dierent boundary condition - in the one barrier case there exist analytical expressions showing dierence. A uthors generalize results to many barrier (layer) system. Instead of speaking about superlum inarity we introduce into the quantum mechanics so called by us "hurdling problem": can a quantum hurdler in one dimension be faster then a sprinter (without obstacles) at the same distance. Relations between wavefunction arguments and delay or advance are shown for N im tz system s.

1 The tunneling times de nitions with reference to S (scattering) and M (monodrom y transfer) matrix theories

1.1 Sm ith's method as S-m atrix method

Before 1960 duration of a collision was a rather ill-de ned concept, depending on a more or less arbitrary choice of a collision distance r. Such a point of view was represented by F.T. Sm ith (1960) [1] in his paper "Lifetim e M atrix in Collision Theory". In that work the author tried to generalize delay-time t = h (@ = @E) resulting from analysing the scattering of the wave packet into a concept of the generalS m atrix theory according to papers written by Bohm (1951) [2] and W igner (1955) [3]. If collision time is de ned as a limit for r ! 1, then the di erence between the time:

 a) in which the interacting particle stays within distance r, and the tim e:

b) it would have spent there in the absence of the interaction emerges as a well-de ned quantity which is nite if the interaction vanishes rapidly enough at large distances $r \mid 1$.

"In quantum mechanics, using steady-state wave functions, average time of residence in the scattering region is the integrated (excess) density divided by the total in-or out (ward) ux, and lifetime (more precisely, time delay) is de ned as the di erence between these residence times with and without interaction."




FIGURE 1. Inward, outward, tunneling etc. waves in scattering. During scattering only one wave (here) outward or inward ism odi ed. There is no cross term s between inward and outward uxes.

 $_{tun}$ is not incorporated in outw nor in inw . It is not clear if the rejected wave $_{refl}(: j_5 j = 1)$ is equal to outw . In shadow region the complete wave function must vanish [16] (= 0), there is no place for $_{tun}$ in .

If the wave functions are normalized to inward or outward unit ux through a sphere with radius r ! 1, than on the basis of complete wave functions (cf. g 1) we build the lifetime matrix Q, using the time operator (there are no consistent theory till now concerning the time operator) t = ih@=@E

where S is the scattering matrix. A coording to Sm ith's paper, Q and S contain complementary information and after diagonalization of Q its eigenvalues are the lifetimes of metastable states, while the corresponding eigenfunctions are the proper functions describing these metastable states. That's why Q is called the lifetime matrix according to the formula derived by Sm ith as below:

where the average value is taken to eliminate oscillating terms at large r. Q is introduced corollary using identity Q = hQ = QE.

In his method A, , are real functions, $\ell = \ell !$ gives time delay of incoming time packet due to reshaping before and during collision while $\ell () = \ell !$ due to reshaping only during collision (f² is the dimensional cross section). The above idea has been applied by O khovsky-Racam i [4] in investigations of relection and tunneling times. All these methods analyze variations of the complex wave arguments during scattering, directly (by O hm ura) indirectly in terms of uxes in ref.[4]. Below we try to nd analogue of phase functions 0 = 0! (distributions) as function of projectile wave-number for transmission through systems as in N in tz superlum inar experiments [12].

Depending on the problem under consideration the scattered phase shifts can be de ned in reference to other known shifts (as C oulom b phase shifts or just kr the argument of undistorted

Now having the scatterer we replace it by potential (repulsive or attractive) and matching wave functions and their derivatives outside potential range (as solutions of corresponding wave equation w ith initial condition that the <u>wave function</u> is equal to zero at origin as well with assumption that both uxes inward and outward are orthogonal [1], cf. gl) we calculate scattering am plitudes. The scattering device together with incom ing ux is located at cm. and elastic channel is one usually created by the nonresonant "re ected" wave function with the same k vector. The scattering theory doesn't make di erence between elastic re ected and transmitted waves. There is only one averaged elastic channel wave function. Such situation is typical for all S -m atrix problem s in area of nuclear reaction, the phase shifts de ne scattering am plitudes and these quantities de ne cross sections to be considered. The phase shifts are not m onotonic functions of energy [5] and such dependence were not investigate due to not unique de nition of potential. There were attempts to solve the inverse scattering problem (from phase shifts to restore potential) but without success.

The incoming ux when scattered by the target (barrier) is converted into the outgoing parts i.e. rejected and transmitted. On the projectile side in one dimension thought experiment there is rejected particle interfering with incident beam while on the other transmitted. But in reality it is not easy to say which particle is rejected or not. In the stationary theory we take into account only an averaged outgoing ux (mixture of rejected and transmitted particle; cf. g1,2.). From S-matrix point of view we have in one dimension two subchannels (R,T) or as in case of the separable radial part of the Schrödinger equation we must remove 1 wave degeneration. The 1-wave splits into two subfunctions corresponding to the rejected and transmitted 1 wave functions. In case of the radial coordinate (one dimension in three dimensional space) we are unable to de ne the left – right sides even experimentally to distinguish the rejected wave from the transmitted one (the exception is the shadow region in g. 1). This degeneracy cannot be describe with traditional S₁ elements. The scattering on the set of many barriers treated as one "black box" should be described by S-matrix. But such system should be characterized by one phase shift or 1 what cannot be true. We have two functions in output each with its own phase shift. To describe such system we must introduce unim odular M-matrix. The M-matrix

conserves the mutual exclusion relation between am plitudes R and T.From the transferm atrix point of view each wave function should receive proper phase shift (' $_{\rm R}$;' $_{\rm T}$) after scattering. Then we can nd S-matrix am plitudes if M-called transferm atrix is known. There is one more problem S₁ phase shifts are found from one matching while in case of transferm atrix, it is built from multimatching conditions as consequence of many borders between media (inside nuclear structure). The scattering system is no more the "black box" type. The internal structure causes multiscattering as sequence of subsequent rejudices and refractions what requires description in terms of not unitary M -matrix. The question is if both descriptions in terms of (S if exist and M) are equivalent. There is no papers where S-matrix R,T am plitudes could be calculated independent of M. (S is deducted from M not vice versa).

T ill now the transm ission (tunneling) was taken into account indirectly through reaction channels. Such treatment put tunneling outside the scattering theory. The consequences are :

-N on unique solutions at the origin (from two solutions we take only regular one into consideration, analysis below shows that in tunneling case the wave function is dimensional from zero at system origin or at least unde ned-not used)¹.

- In nuclear physics there are problem s with hard or soft core potentials which were not tested or compared with tunneling.

- Validity of time reversal invariance or detailed balance theorem which says that the time reversed incoming state (under the operator \hat{K}) is equal to an outgoing state with the same energy. The reversed in-state goes into the asymptotic free time reversed state $_{i^0}$ when t! + 1 i.e. $\hat{K} \stackrel{(+)}{_{i}} = \stackrel{()}{_{i^0}}$ and $\hat{K} \stackrel{()}{_{f}} = \stackrel{(+)}{_{f^0}}$. These relations induce $S_{i^0f^0} = S_{fi}$ called detailed balancing or m icroreversibility. In other words the transition probability for the inverse process with time-reversed parameters is the same as that of the direct process.

But tunneling is irreversible process and we suspect-cannot be described by function regular at origin.

In general case of the reaction a + A ! b + B (in the subbarrier collision) tunneling in out-state (b + B) is dimension that in in-state (a + A) and tunneling disturbs scattering states. C learly nonunitary condition breaking m icroreversibility relation, tunneling how ever can be introduced as additional indeterm inance in scattering theory.

1.2 Weak Wigner causality and Wigner time

The W igner time is the simplest one. According to [3] and formulated there the principle of causality, the scattered wave cannot have the scatterer (of diam eter r) before the incident wave has reach it i.e. @ = @k > r. This expression in case of positive derivatives gives retardation while negative values advanced in time solution, for the outgoing wave as de ned in [3] we can write $t_{out} = \frac{r}{2} + \frac{2@}{@k}$. Experimentally it is not easy to not from the excitation functions (cross sections) (k).(cf.eq. 1.10). In reality in macro world the scatterer (C oulom b or gravity eld) has in nite radius what forces $t_{out} ! 1$. Let d = 2r and $t_{in} = \frac{r}{2}$ then

If we know (k) the W igner time (the group one) can be easy derived for nite systems.


1.3 M onodrom y

To introduce M matrix we need two ingoing in () and two outgoing out() particle wave functions, (cfFig2).

The transmission or relection through any periodic or aperiodical set of square barriers rew ritten as the transformation from ($_{in}$; $_{R}$) to ($_{T}$) (undergoing the monodrom y matrix), can be described in terms of the [2 2]transfer ("monodrom y") cells given by superposition of [p_i] matrices with [H_i]. [p_i] represent free wave propagation between barriers which can be interpreted as phase translation to given position (the middle and/or edge of barriers) or phase translation about relative distance if [$p_{(i)}$] are used. In ref. [7] authors use simply the name translation operator. [H_i] describe particle motion under any barrier and are responsible for interactive wave propagation. Superposition of both matrices [H_i][p_i] represents propagation in two opposite directions inside or outside media. In case of the square barriers unim odular [H_i]

matrices have form $\begin{bmatrix} a & b \\ b & w \text{ here } a; b; c \text{ are real.} \end{bmatrix}$

M onodrom y (or the transfer matrix or translation operator unimodular not unitary (as well not equivalent to unitary) transform s the initial wave function amplitudes $A_0; B_0$ or (1;R) onto outgoing one $A_n; B_n$ or (T;0).

The monodromy form of M depends on the basic wave functions to be chosen. M shifts the solution of the Schrödinger equation from x to x + d i.e. from beginning of the barrier system to its end. In the time depended approach the wave function underlies unitary evolution :

 $(t = +1) = U(+1; 1)_{in} (1)$. The initial and nalwave functions are separated in time in S-matrix treatment while in M matrix approach as well in space: far left, far right. For inward, outward [(com plex exponential functions, H ankel functions etc.) or real basic solution like (cos; sin, regular and irregular C oulom b or Bessel functions etc.), here both representation M and M⁰ are connected by the unitary transform ation] we get:

M onodrom y M represents propagation of the wave functions through system of multiple cells as sequence of relections and transmission (at each cell edge the wave is splitted into relected and refracted (tunneled)) or M can be interpreted as superposition of cells characterized by two waves inward and outward. The four M -matrix elements can be expressed as function of complex variables T and R, above relations de ne only M $_{21}$ = R=T, M $_{22}$ = 1=T elements. The remaining M $_{12}$, M $_{11}$ elements, connected by det M] = 1 relation, we deduce from matching conditions. The monodrom y is unim odular not unitary. M $^{-1} \in M$ Y and hermitian conjugation

does not describe inverse motion. Multiple relections and transmissions are strictly correlated with multiple matching. If system is asymmetric (there exist at least one left and right matching which do not coincide), equivalent S-matrix can exist if we introduce additional phase shift ' between R and T waves. Monodromy can be periodic but not necessary. W ithout dissipation (energy loss) system consist of multiple superposition of unim odular matrices.

Now we consider transmission through certain device created by superposition of many barriers. Such systems can be equivalent any arbitrary shape potential U (x) de ned on the intervals $a_i \quad i \quad x \quad a_i + \quad i \text{ with help of square barriers (e.g. barriers on the Cantor set etc.). There are barriers as in the g.3:$




FIGURE 3. Set of barriers as used in tunneling and transmission or relection.

The superposition of all "phase translations" describe the full transfer operator M as transformation from the initial (spinor) amplitude state to nalone by means of matching conditions. By appropriate unitary transformation we can choose convenient amplitude representation. The choice depends on physics to be considered.

The n-th barriers system can be described by barrier center coordinates (a_j) or interbarrier distances (j) and barrier widths and heights (2j; j). Then the system width is given as

1.4 Phase properties of M matrix-one barrier case or the barrier set equivalent to one

Let in the equation (1.17,18) = const, $_i = \text{ and } H$ is the same for all $i H_i = H$. Then we call $M_i = M_i$; single cell "power" (or periodic) m onodrom y operator. Internal structure of M_i] representing certain device causing rejection and refraction de nest transmission or tunnelling through the barriers as well as general (aperiodic) m onodrom y. We maintain that m onodrom y as applied to two channel elastic scattering is group property.

In g. 4,5 we have shown transmission, $\arg T = \prime_2(k)$ and $\prime_2(k) = 2 + kd$ in single barrier case. The $\prime_2(k)$ in allowed k-band is increasing function of k and the quantum hurdler is slower then particle without obstacle; the (k) function has not such properties.

Using $'_{M \text{ on odrom } y}$ Et = 0, from position of the packet center we nd the transmission time in the N im tz experiments.

The heuristic time calculation fulls typical limits :

For typical $'_2$ expressions we get the same lim it. That expressions are not here in portant. We presume wide systems are composed from thin elementary segments.





FIGURE 5. Transm ission through one N in tz barrier 6m m w ide. ⁽⁰⁾ is barrier height in k units (here m m⁻¹). As in g.4 (kd) represents maximal negative phase slope according to weak W igner causality. The wave length at ⁽⁰⁾ is bigger than the barrier width so phase characteristic is dominated by '₁. The slopes of '₁ (k) and arg T phase curves are positive and give retardation. How ever '₂ kd = 2 suggests sm all speed advance.



In Fig.4 we have shown the phase characteristics in tunneling through one (or two barriers see g.6). Due to weak W igner causality applied to the sum of both phases $(@=@k)('_2) > d$. From monodrom y arg T = arg R = $'_2 + '_1$ kd = $'_2$. The phase $'_2$ kd alone is typical 2_0 as in Q M .-textbooks (see [5,9]). Sometimes for one or few barriers -when is comparable with the barrier width, the height of the barriers can be easy deduced from the phase characteristics. It is not a rule cf. g 5, 7 and others.




FIGURE 6. Transm ission through two equal barriers each one length unit [m m] wide. The cavity diameter is one millimeter wide too. ⁽⁰⁾ is barrier height in k units [1/m m] the same as for one barrier tunneling (cf. g.4).

For each cell we can de ne two internal phases $'_{1;i}$, $'_{2;i}$ "B both phases" (in analogy to in [10]) and another one k i as external typical for the interbarrier movement. Such method can be compared to the scattering as in [10]. Stability in classical mechanic is expressed by inequality TrM 2, here in quantum mechanics TrM describes mutual ratio of rejection and transmission (tunnelling) – expressed respectively by i or 'i behavior. High above the barriers ' $_{1;i}$! =2 so i! ' $_{2;i}$! kd_i. We see that much more appropriate phases to be named "B both phases" are ' $_{1;i}$; ' $_{2;i}$ which describe internal device structure however here we deal with the aperiodical or quasiperiodical system (periodic + boundary).

Let assume there exist average transfer operator \underline{M} equivalent to superposition of equal or di erent elementary monodrom y cells (assuming symmetric case $a_n + a_n = a_1 + a_1$). We say there exist an equivalent "black box" barrier operator \underline{M} which preserves the single cell form

(cf. eq. (1.15,17,18)).

The phases $\underline{'_1};\underline{'_2}$ are functions of device internal structure. We assume such phases exist and can be computed while M is folded from square barriers, $Te^{ikd} = f^{-1}(d;) = sin(\underline{'_1})e^{i(\underline{'_1}+\underline{'_2})}$ where represents all internal variables needed to compute $\underline{'_1};\underline{'_2}$. In most cases the product of the single cell expressions (1.18) can be computed only numerically. The total phase shift change is given approximately by \underline{M} transform sinput (1;R) onto (T;0) output):

In equations (1.25), for periodic case (i.e. $M_i = M_{*}$) where Cayley Ham ilton theorem can be applied, $O_n^{(U)}$ just cancel exponential term on the diagonal of M_i matrix. The total transfer periodic matrix is if $\cos() = \frac{1}{2}$ TrM *; :

it is obvious that similarity of M_"; trace with M trace (as in [10]) is accidentally. The trace properties are useful when we want to write any power of M^N_"; in term s of M_"; and the unit m atrix (see ref [13]). There exists however an additional matrix factor $O^{(U)}$ which changes the naltrace completely. From physical point of view we are interested only in transform ations which put $O^{(U)}$ into diagonal form m eaning that between interaction areas we have two free waves running in opposite directions. In general case for the i-cell we can de ne two scattering or B loch phases '_{2;i};'_{1;i} (B loch phases suggest periodicity what is not here the case) and phase displacement k_i so each cell has di erent trace properties. During out of resonance tunneling, particle seems to be insensible to_i distances_i h_i i

particle seems to be insensible to i distances. It is impossible to make diagonal both $0^{(U)}$ and $H_{*}^{(U)}$. Matching conditions induce the h i describing particle movement under the barrier as in [6]. The total transfer matrix is composed of many matrices. We must know its nal form explicitly to nd mutual ratio of rejection and transmission.

In aperiodical symmetric system (like barriers on the Cantor set) the averaged term $\frac{\prime_1}{2} + \frac{\prime_2}{2}$ is dimension the expression valid for the single barrier (1.21,22). The case symmetric is important, it is easy to calculate the phases \prime_1 ; \prime_2 : in the monodrom y matrix (1.16) W = 0 and as written already V is real so from (1.24) V = $\cot(\underline{\prime_1}) = R = T$. From X; Y we extract the second phase. For asymmetry we get $\cot(\underline{\prime_1}) = \frac{V^2 + W^2}{V^2 + W^2} = R = T$ and $\tan(\underline{\prime_1}) = \frac{W}{V} \cdot \underline{\prime_2}(k)$ is phase dimension. Resume:

Translation operators suggest "translation in time" too. S-m atrix is time independent operator (U (t ! 1 ;+1)) and treats the quantum wire translation device as "black box" which structure should be nd out in "phase shifts" experiments. Unitarity of S-m atrix suggests full symmetry of "black box". It is not clear if S-m atrix phase shifts $_1$ can be used to calculate time delay for particle traveling through the investigated object cf.[1]. Only the transmitted (tunneling) waves "feel" the object size (i.e. its depth). Tunneling introduces asymmetry into experiment as well into theory. May be motion emerges in the quantum mechanics as consequence of rejection - transmission interference (which takes place only under / over the barrier or the potential well). So there exist equivalent S-matrix (S_M) related with M-monodromy translation operator if M is symmetric. A symmetry causes problems and microreversibility is exact up to tunneling. M-matrix can be periodic but generally it is not. To describe properly tunneling and rejection we need mixture of inward and outward solutions (or at each point of the space the true solution is mixture of regular and irregular one coupled by tunneling e ect at origin where integration of the wave equation starts).

In tunneling, due to equivalence between the complex Schrodinger and two dimensional Maxwell (Helm holtz) equations, we consider as well photons as massive particles.

1.5 M onodrom y time

Two phase shifts suggest that W igner causality should be applied separately to re ected and transmitted waves. But if re ection has nothing common with transmission their coupling through the $\Re f + j\Gamma f = 1$ relation would result in completely di erent phases of both functions. The above analysis shows that in principle for symmetric systems both waves have common phase $'_2 = '_1 + '_2$ kd [8] and such sum should be used in causality relation. The phase $'_2$ alone corresponds to (1) if k (0) where (0) is the barrier height i.e. $2m V = h^2$. We can generalize the W igner time and write

Tangent to $'_{M \text{ onodrom } y} = '_{2}(k) + dk$ cannot be negative: the scattered wave cannot leave the barrier of width d before the incom ing wave has entered it - in consequence $t_{M \text{ onodrom } y} > 0$. There is additional phase $'_{1}$ which modi as weak causality relation (eq. 1.11). Both phases result from M -m atrix.

In case of asymmetric barrier systems we can introduce times separately for relection and transmission:

2 N im tz experim ents in view of the m onodrom y m atrix

The barriers in N in tz experiment [12] consist of two photonic lattices which are separated by an air gap. Each lattice consists between one and four equidistant Perspex layers separated by an air. The refractive index of Perspex is n= 1.61 in the measured frequency region. In order to build a photonic barrier for the m icrow ave signals, the thickness of the Perspex b= 6.0 (or 5.0) mm and the air layers a= 12.0, (8.5) mm present a quarter of the m icrow ave carrier's wavelength in barrier $_n = c=(nf_c) = 22:1; (20:4)mm$ and in air $_0 = c=f_c = 35:5; (32:8)mm$ respectively. The air space $d_{cav} = 130; (189)mm$ between the two lattices forms a cavity and extends the total length of the barrier. The resonance frequencies of the cavity can be calculated on the base of m onodrom y m atrix and are in case of two setups 1097 M hz (or 764 M H z); according to N im tz $f_{res} = c= (2d)$ is (1153) or (794M H z).




FIGURE 7. Two barriers (9.15G Hz) experiment: thickness of barrier is 5.0mm, $d_{cav} = 189mm$. The superluminal speed changes gradually from 6.9c at k = 0.12 to 3.4c near f_c , cf. g8. Total width of the system is 199mm.




FIGURE 8. Eight barriers (9.15GHz) experiment at 9.15GHz: thickness of barrier is 5.0mm, of air layers is 8.5mm, while $d_{cav} = 189\text{mm}$. The superlum in lapeed in region I is 23c while in region II 14c. Total width of the system is 280mm.

The calculated transm ission and wave function phases (according to monodrom y for symmetric photonic lattices the rejection phase equals the transm ission phase) are displayed in Fig (7,8). In Fig 8 we marked three areas with anom alous dispersion.

N in tz assumes that the frequency spectrum of the microwave signal lies completely in the nonresonant "forbidden" frequency region between $11f_{res}$ and $12f_{res}$. Using the monodromy calculation method and if ⁽⁰⁾ is correct, f_c should be shifted in comparison to N in tz data (see

gs 7,8) i.e. k from the value 0.1769 up to 0.19 equivalent, f_{c^0} ' 9G H z . The superlum inal k-regions weakly depend on small ⁽⁰⁾ changes. However ⁽⁰⁾ should be determ ine from the

internal Perspex structure. Sometimes for one barrier there is the sharp change in both $'_1$; $'_2$ phases behaviour at $k = {}^{(0)}$ if barrier width is comparable or bigger then particle wave length. for

Two barriers Nimtz experiment (9.15GHz)

It is not easy, from the phase curves to say where $^{(0)}$ is placed. $^{(0)}$ should be found by any independent m ethod.

At the end we present phase shift analysis in case of the K iang m odel with 10 -barriers [10,11]. In allowed bands the "quantum hurdler" is retarded. But it is not so simple in case of forbidden bands. If the particle is rejected, negative slope can be related with penetration depth and for the transmitted wave with advance speed.




FIGURE 9. The K iang model with ten barriers is a good example of ("superlum inal") time advance e ect in the successive k-forbidden regions. As in [10], we used for that model = 5, where is barrier penetrability and is the interbarrier distance. The slope of the phase line characterizes the superlum inal speed i.e. for the deepest band we have 19c for the next bands this speed decreases and is adequately: 10c, 5.5c, 4c and 2.5c in the latest band. In allowed regions the slopes are positive and give retardations. The group time delay is much bigger at resonances then between them - the phase curve oscillates strongly.

2.1 Final rem arks

 $^{(0)} = d = (c)$ is the "classical" time needed to travel We assume that d is system width and through barriers. For sym m etric device both waves relected and transm itted received the sam e phase shift '2 (m odulo =2). The m onodrom y phase shift analysis of relection and transm ission am plitudes rejects rejects rejection from the front and treats both processes as occurring after the time $tun = {}^{(0)} + {}^{(2)} where {}^{(2)} results from {}^{\prime}_{2}$. From the M -m atrix point of view rejection and transmission delay if de ned as $tun = (d + Q'_2 = Qk) = 2d_{pen} = is positive and allow us to$ interprete dpen as penetration depth in case of re ection. But we are unable to say from which position particle is transmitted. In that case interpretation is not easy. M ay be the tunneling wave function is strongly repelled from forbidden bands resulting in negative phase derivative. It seem s that the tunneling particle needs m uch shorter tim e to travel through barrier than in free space. Numerical calculations (with M-matrix) show that always $d_{pen} > 0$ according to weak W igner causality. If $2d_{pen}$ is actual distance seeing by the tunneling particle then $2d_{pen} = t_{un}$ is typical speed () in the matter, but d= $_{tun}$ gives the advance speed. W e stress once more the transfer matrix enable us to nd k-dependence of phases. The phase shift \prime_2 alone is not m onotonic and corresponds to phase shifts from Sm atrix. A nalysis of am plitudes from equivalent S matrix cause problem s. W e must de ne the arrival tim e for re ected particle and "departure" time for transmitted one. The probabilistic interpretation of R and T suggests that re ection occurs at barrier front [14] and then anom alous dispersion brakes weak W igner causality, time must be separately de ned for the rejected and transmitted waves, in consequence there is no interference between these waves. When we calculate \prime_2 (k) in allowed bands in simple

-barrier systems we recognize that it is monotonic function of k with nontypical resonance structure of another origin. The quantum hurdler is retarded as it can be seen from arg T in the K iang model (g. 9) but forbidden bands push out the particle. This structure emerges from interference e ects between both (re ected and transmitted or incoming and re ected) elastic channels in "continuum" including tunneling. Possible superlum inal area are seen in Fig.(5-9). i.e. anom abus dispersion $\frac{0'2}{0k} < 0$ but it is questionable if $'_1 = \text{const}$ or is negligible $-'_1$ is oscillating function of wave number k. We analyze anom abus dispersion (without absorption or dissipation) only from two channel interaction point of view. In usual propagation of light in refractive media we reject in uence of re ected wave.

Brillouin has written in his book [15] "it is in possible to think of refractive medium without

dispersion" (and energy loss) so the questions -w hat velocity coincides with elastic tunneling as well what the nature of anom abus dispersion is -remain open.
