# Construction of Som e Im portant C lasses of Generalized C oherent States: the N onlinear C oherent States M ethod

A bstract. Considering some important classes of generalized coherent states known in literature, we demonstrated that all of them can be created via conventional fashion, i.e. the "lowering operator eigen-state" and the "displacement operator" techniques using the "nonlinear coherent states" approach. As a result we obtained a "uni ed method" to construct a large class of coherent states which already have been introduced by di erent prescriptions.

#### 1. Introduction

C oherent states (C Ss) are venerable objects in physics with many applications in most of the elds of physics and mathematical physics K lauder(1985) and A li(2000)] from solid states physics to cosmology and occurred in the core of quantum optics. A long generalization of coherent states recently J-P G areau and JR K lauder proposed new coherent states (G K) for systems with discrete or continuous spectra, which parameterized by two real and continuous parameters J 0 and 1 < < 1, denoted by jJ; i [G areau (1999)]. They involve the representation of the discrete series su (1;1) Lie algebra, C oulom b-like spectrum, P oschl-T eller and the in nite square well potentials [A ntoine (2001)].

M one recently J R K lauder, K A Penson and J-M Sixdeniers introduced another in portant classes of generalized CSs through solutions of Stieltjes and Hausdor m om ent problem [K lauder(2001)]. The constructed CSs in their paper which we will denote them by  $j_{2i_{K,PS}}$  have these properties: i) normalization ii) continuity in the label and iii) they form an overcom plete set which allows a resolution of unity with a positive weight function. Then they have studied the statistical properties of these states by calculating M andel parameter and also the geometry of these states by a metric factor, both analytically and numerically. At last, they used some estimations, to not the proper H am iltonian for some sets of their CSs.

The generalized CSs mentioned above, neither de ned as eigestates of an annihilation operator, known as Barut-Girardelb(BG) CSs [Barut(1971)], nor resulted from the action of a displacement operator on a reference state, say vacuum state, known frequently as G im ore-Perelom ov (GP) CSs [G im ore(1972)] and Perelom ov (1972)]. In other words the algebraic and symmetry considerations of the above two sets of states have not been clear, there. The same situation holds for the generalized CSs proposed by K A Penson and A I Solom on we denote them by  $j_{z};qi_{PS}$  [Penson(1999)]. Due to these, our aim is to establish these subjects, and also to nd a simpler way to relate the constructed CSs to an exact expression of the H am iltonian, out of any estimation. In a sense our present paper m ay be considered along the completion of the works of G azeau et al [G azeau (1999)], K lauder et al [K lauder(2001)] and Penson et al [Penson (1999)].

Our procedure is based on the conjecture that these states may be studied in the so-called nonlinear(NL) coherent states orf-deformed coherent states category [M anko(1997)]. This is the main feature of our work. Nonlinear CSs attracted much attention in recent years, mostly because they exhibit nonclassical properties. As we know, up to now many quantum optical states such as q-deformed CS [M anko(1997)], negative binom ial state [W ang(1999) and W angFu(1999)], photon added (and subtracted) CS [Sivakum ar(2000), Sivakum ar(1999) and N aderi(2004)], the center ofm ass motion of a trapped ion [M atos(1996)], som e nonlinear phenom ena such as a hypothetical "frequency blue shift" in high intensity photon beam s [M anko(1995)] and recently after proposing f-bounded CS [R e'cam ier(2003)], the binom ial state (or displaced exited CS) [R oknizadeh(2004)] have been considered as som e sorts of nonlinear CSs.

W e attempt now to demonstrate that all sets of KPS coherent states including PS coherent state and the discrete series representations of the group SU (1;1) (BG and GP coherent states) and su (1;1)-Banut-G irandello CSs for Landau-level(LL) [Fakhri(2004)] can be classified in the nonlinear CSs with some special types of nonlinearity function f (n), by which we may obtain the "deformed annihilation and creation operators", "generalized displacement operator" and the "dynamical H am iltonian" of the system. Based on these results it will be possible to reproduce all of the above CSs through the conventional fashion, i.e. by annihilation and displacement operator de nition. In a general view the form alism presented in this paper provides a uni ed approach to construct all the employed CSs already introduced in di erent ways. In another direction as a matter of fact introducing the ladder operators related to the above CSs may be regarded as a rst step in the process of generation of these states in some experimental realization schemes in quantum optics, when one intended to perform the interaction H am iltonian describes form ally the interaction between atoms and electrom agnetic eld.

In addition to these, three interesting and new remarkable points, which seem ingly that have not been pointed out so far, en erges from our studies. The rst is that we can construct a new family of CSs (named the dual set), other than the KPS and PS coherent states [A li(2004) and Roy (2000)]. The second is that the Ham iltonian proposed in M anko (1997)] and others who cited him [see e.g.: Sivakum ar (2000)] m ust be reformed, in view of the action identity requirement imposed on the generalized CSs of K lauder [K lauder (1998)]. W e should quote here that recently som e authors (for instance see A H E 1K inaniand M D aoud [E K inani(2003)]) have used norm alordering form (factorization) for their H am iltonians. But they sometimes m ade this suggestion for drastic simplication, without any deep physical bases [Speliotopoulos(2000)]. Indeed they used the supersymmetric quantum mechanics (SUSQM) techniques as a "m athem atical tool" to nd the ladder operators for their H am iltonians. Interestingly our form alism for solvable H am iltonians gives an easier and clearer m ethod to obtain these operators whenever necessary. We will pay more attention to this result in the conclusion. Thirdly, our results give us the opportunity to observe that for some sets of the KPS coherent states, the nonlinearity phenomena will be visible in "low intensities of light", the fact that have been hidden, until we discovered the nonlinearity nature of them explicitly. This would be in portant experim entally, since as M an 'ko et al experienced, the nonlinear phenom ena in q-oscillators can be detected only in high intensity photon beam s M anko (1995)]. Therefore if anyone can generate these particular sets of KPS coherent states by interaction of a eld and atom s, it will be more easier to detect this phenom ena.

The plan of this paper is as follows: for the sake of com pleteness we will bring a brief review on the nonlinear CSs, as M an'ko et al introduced in section 2, following with a review on KPS and GK coherent states in section 3. Then the relation between KPS, PS and BG coherent states of su (1;1) with nonlinear CSs will be obvious in section 4, and so the generators of the deform ed oscillator algebra, displacem ent type operator, and the proper H am iltonian in each set of the above coherent states will be nd in sections 5 and 6. Based on our results we will introduce a vast class of new generalized CSs (dual fam ily of KPS and PS coherent states). Then we discuss about the extension of the procedure to the GK coherent states in section 7, and nally we present our conclusions.

# 2. N on linear coherent states

N onlinear C Ss were rst introduced explicitly in [M atos(1996) and M anko(1997)] but before them it is implicitly de ned by Shanta et al [Shanta(1994)] in a compact form. This notion attracted much attention in physical literature in recent decade, especially because of their nonclassical properties in quantum optics. M an'ko et al 's approach

is based on the two following postulates.

The rst is that the standard annihilation and creation operators deform ed with an intensity dependent function f(n) (which is an operator valued function), according to the relations:

with commutators between A and  $A^{y}$  as

where a,  $a^y$  and  $\hat{n} = a^y a$  are bosonic annihilation, creation and number operators, respectively. O rdinarily the phase of f is irrelevant and one m ay choose f to be real and nonnegative, i.e.  $f^y(\hat{n}) = f(\hat{n})$ . But to keep general consideration, we take into account the phase dependence of  $f(\hat{n})$  in general form alism given in this section.

The second postulate is that the H am iltonian of the deform ed oscillator in analog to the harm onic oscillator is found to be

where by index M  $\,$  we want to denote the H am iltonian as introduced by M an 'ko et al . The single m ode nonlinear C Ss obtained as eigen-state of the annihilation operator is as follow s:

where the coe cients C  $_n$  are given by

and the norm alization constant is determ ined as

In order to have states belonging to the Fock space, it is required that  $0 < N_{f} (jzf) < 1$ , which implies that  $jzj = \lim_{n \neq 1} n[f(n)]^{2}$ . No further restrictions are then put on f(n). Now with the help of Eqs. (6) and (7) the function f(n) corresponding to any nonlinear CS is found to be

which plays the key rule in our present work. To recognize the nonlinearity of any CS we can use this simple and useful relation; by this we mean that if  $C_n$ 's for any CS are known, then f (n) can be found from Eq. (9); when f (n) = 1 or at most be only a constant phase, we recover the original oscillator algebra, otherwise it is nonlinear.

#### 3. K P S and G K generalized coherent states

A long generalization of CSs J R K lauder et al [K lauder (2001)] introduced the states

where (n) satisfies (0) = 1 and the norm alization constant is determined as

C om paring Eqs. (6) with (10) we obtain: C (n) =  $[(n)]^{1=2}$  which describes the relation between KPS and nonlinear CSs. Indeed when  $C_n = 1 = n!$  we obtain CCS, otherwise (for instance in general when  $C_n = 1 = (n)$ ) as in (10), we are led to nonlinear CSs, this is what we want to show. We will demonstrate the equivalence between all sets of KPS coherent states and the nonlinear CSs in section 6 in detail. These states possess three conditions (i)-(iii) stated in the introduction, by appropriately selected functions (n). The third condition, which is the most di cult and at the same time the strongest requirements of any sets of CSs, were proved appreciatively by them, through Stieltjes and Hausdor powermom ent problem. Explicitly for each set of CSs jzi<sub>KPS</sub>, they found the positive weight function W (jz j) such that

where  $d^2 z = j z j l j z j l$ . Strictly speaking, evaluating the integral over in the LHS of Eq. (12), setting  $j z j^2$  x and simplify it, we arrive nally at:  $Z_p$

where the positive weight functions  $W(x) = \frac{W(x)}{N(x)}$  must be determined. Extending the values of n 2 N in (13) to s 2 C, it can be rewritten as: Z<sub>1</sub>

for R < 1, which is known as Hausdor moment problem, with H (R = x) as the Heaviside function. The positive weight functions W'(x) can be obtained, through M ellin and inverse M ellin transform techniques, when (n) is choosed. This autom atically guarantees the condition of resolution of the identity for the KPS states according to (12), (for a brief and nice discussion see: K lauder(2001) and references therein, e.g.: M arichev (1983) and P rudinkov (1998)).

A dopting certain physical criteria rather than imposing selected mathematical requirements, K lauder and G azeau by reparametrizing the generalized CSs jzi in terms of a two independent parameters J and , introduced the generalized CSs jJ; i,

known ordinarily as Gazeau-K lauder (GK) coherent states in the physical literature [K lauder (1998) and Gazeau (1999)]. These are explicitly de ned by the expansion

and (n) is a positive weight factor with (0) 1 by convention and the domains of J and are such that J 0 and 1 < < 1. These states required to satisfy the following properties: i) continuity of labeling: if (J; ) ! (J<sup>0</sup>; <sup>0</sup>) then, kjJ; i  $jJ^0$ ; <sup>0</sup>ik ! 0, ii) resolution of the identity:  $\hat{I} = jJ$ ; ihJ; jd (J; ) as usual and two extra properties: iii) tem poral stability: exp( iff t) jJ; i = jJ; + !ti and iv) the action identity: H = hJ;  $\hat{H}jJ$ ; i = !J, where H and  $\hat{H}$  are classical and quantum m echanical H am iltonians of the system, respectively. It must be understood that the forth condition forced the generalized CSs to have the essential property: "the most classical quantum states", but now in the sense of energy of the dynam ical system, in the same way that the canonical coherent state(CCS) is a quantum state which its position and m om entum expectation values obey the classical orbits of harm onic oscillator in phase space.

In Eq. (16) the kets jni are the eigen-vectors of the H am iltonian  $\hat{H}$ , with the eigen-energies E  $_{n}$

The action identity uniquely specified (n) in terms of the eigen-values of the H am iltonian  $\hat{H}$  with a discrete spectrum  $0 = e_0 < e_1 < e_2 < :::$

As an example, for the shifted H am iltonian of harm onic oscillator we have the CCS denoted by jJ;  $i_{CCS}$ :

Eq. (19) obviously states that (n) is directly related to the spectrum of the dynam ical system. So every H am iltonian uniquely determ ined the associated CS, although the inverse is not true. This is because of the existence of the isospectral H am iltonians in the context of quantum mechanics [Fern'andez (1994) and R oknizadeh (2004)].

4. The relation between some classes of generalized coherent states and the nonlinear coherent states

To start with we demonstrate the relation between the KPS and NL coherent states. As we have mentioned already by comparing Eqs. (6) and (10), the coe cients C  $_n$  can be determined. Then inserting C $_n$  and C $_n$   $_1$  into (9) yields:

which provides simply a bridge between KPS and NL coherent states. As a special case when (n) = n!, i.e. the canonical CS, we obtain f(n) = 1. We will demonstrate the equivalence between all sets of KPS coherent states and the nonlinear CSs in section 6. From Eq. (19)  $e_n$  can easily be found as a function of (n):

Remembering that  $e_n s$  are the eigen-values of the Ham iltonian, it will be obvious that neither every (n) of KPS coherent states nor every f (n) of nonlinear CSs are physically acceptable, when the dynam ics of the system (Ham itonian) is specified. Using Eqs. (21) and (22) we get

Now by using (21) we are able to nd f ( $\hat{n}$ ) for all sets of KPS coherent states and then the deform ed annihilation and creation operators  $A = af(\hat{n})$  and  $A^y = f^y(\hat{n})a^y$  m ay easily be obtained. Returning to the above descriptions, the operators A and  $A^y$  satisfy the following relations:

A lso note that  $A^{y}A_{j}hi = e_{n}jhi$ , not equal to njhi in general. W ith these results in m ind it would be obvious that Eq. (23) is not consistent with the relations (4) and (5) for the H am iltonian. A closer look at Eq. (23) which is a consequence of imposing the action identity on the H am iltonian of the system leads us to obtain a new form of the H am iltonian for the nonlinear C Ss as

A fler all this form of the H am iltonian m ay be considered as "norm al-ordered" of the M an 'ko et al H am iltonian  $H_M$ , introduced in Eq. (4),

C om paring Eqs. (4) and (5) with the Eqs. (23), (27) and (28) implies that if we require that the KPS and nonlinear CSs to possess the action identity property, the associated H am iltonian when expressed in term s of ladder operators must be reform ed in norm al-ordered form.

In sum mary our considerations enable one to obtain f-deform ed annihilation and creation operators as well as the Ham iltonian for all sets of  $j_{zi_{K,P,S}}$  discussed in [K lauder(2001)], after demonstrating that for each of them there exist a special nonlinearity function f (f1). Before closing this section, we bring two illustrative examples to show the ability of our method.

Example 4:1 Penson-Solom on generalized CSs:

As an example we can simply deduce the nonlinearity function for the generalized CSs introduced by Penson and Solom on (PS) [Penson (1999)]:

where N  $(q; j; j)^{1=2}$  is a normalization function and "(q; 0) = 1; 0 q 1. This de nition is based on an entirely analytical prescription, in which the authors proposed the generalized exponential function obtained from the following dimension:

So they have not used the ladder (or displacem ent) operator de nition for their states [Penson (1999)]. The nonlinearity function, the annihilation and creation operators evolve in these states can be easily obtained by our form alism as

Therefore our method enables one to reproduce them through solving the eigenvalue equation: A  $\dot{z}; qi_{p_s} = aq^{1-\hat{n}} \dot{z}; qi_{p_s} = z\dot{z}; qi_{p_s}$ , in addition to introducing a  $\hat{n}$  dependent H am iltonian describing the dynamics of the system :

Example 42 Barut-Girardello CSs for su (1;1) Lie algebra:

As second example we refer to the Barut-G irardello (BG) CSs, de ned for the discrete series representations of the group SU (1;1) [Barut(1971)]. Our form alism provides an easier tool to relate the SU (1;1) CSs of BG to both the Poschl-Teller (PT) and in nite square well potentials. The BG states decomposed over the num ber-state bases as:

Therefore we have established that the dynamical group associated with these two potentials is the SU (1;1) group. W e conclude that the generators of su (1;1) algebra L  $;L_+;L_{12}$  can be expressed in term softhe deform ed annihilation and creation operators including their com m utators such that

We note that our approach not only recover the results of Antoine(2001)] in a simpler and clearer manner, but also it gives the explicit form of the operators L ;L<sub>+</sub>;L<sub>12</sub> as some "intensity dependent" operators in consistence with the Holstein-Prim ako single mode realization of the su(1;1) Lie algebra [Gerry (1983)].

#### Example 4:3 su (1;1)-Barut-Girardelb CSs for Landau levels:

As an example closer to physics, it is well-known that the Landau levels(LL) is directly related to quantum mechanical study of the motion of a charged and spinless particle on a at plane in a constant magnetic eld [Landau (1977) and G azeau (2002)]. Recently it is realized two distinct sym metries corresponding to these states, namely su (2) and su (1;1) [Fakhri(2004)]. The author showed that the quantum states of the Landau problem corresponding to the motion of a spinless charged particle on a at surface in a constant magnetic eld =2 along z axis may be obtained as:

where  $I_{+m}$  (2 jz) is the modi ed Bessel function of the rst kind [M atson (1995)]. The states in (42) derived with the help of the low ering generator of the su (1;1) Lie algebra, the action of which is de ned by the relation:

A deep inspection to the states in (42) in comparison to the states in (34) shows a little di erence, in view of the lower limit of summation sign in the former equation. But this situation is similar to the states known as photon-added CSs [A garwal(1991)] in the sense that both of them are combinations of Fock space, with a cut-o in the summation from below. This common feature leads us to go on with the same procedure that has been done already to yield the nonlinearity function of the photonadded CSs (PACSs) in [W ang (1999) and Sizakum ar(1999)]. We denote the deformed annihilation operator and the nonlinearity function similar to PACSs as

where we have used the states (6) (replacing jiby j;m i) as the eigen-states of the new annihilation operator de ned in (44). Upon these considerations we can calculate the nonlinearity function for the su (1;1)-BGCSs related to LL as follows:

Hence again the ladder operators corresponding to this system m ay be obtained easily. Besides this, we will observe in the next section that one can also nd displacement operators associated with the above three examples, as well as KPS and GK coherent states.

#### 5. Introducing the generalized displacem ent operators

A fler we recast the KPS, PS and su (1;1) coherent states as nonlinear CSs and found a nonlinearity function for each set of them, it is now possible to construct all of them through a displacement type operator form alism. We will do this in two distinct ways.

I) B Roy and P Roy gave a proposition and de ned two new operators as follows [Roy (2000)]:

Before we proceed ahead to further clarify the problem, an interesting result may be given here. Choosing a special composition of the operators A in (1) and B<sup>y</sup> in (46), we may observe that B<sup>y</sup>Ajni = njni = A<sup>y</sup>Bjni. Also due to the following commutation relations:

the generators fA; B<sup>y</sup>; B<sup>y</sup>A; Ig constitute the commutation relations of the Lie algebra  $h_4$ . The corresponding Lie group is the well-known W eylH eisenberg (W -H) group denoted by H<sub>4</sub>. The same situation holds for the set of generators fB; A<sup>y</sup>; A<sup>y</sup>B; Ig, using A<sup>y</sup> in (1) and B in (46).

C om ing back again to the R oy and R oy form alism , the relations in (46) allow one to de ne two generalized displacem ent operators

Noting that  $D^{0}(z) = D(z)^{y} = D(z)^{1} J^{y}$ , it may be realized that the dual pairs obtained generally from the actions of (48) and (49) on the vacuum state are the orbits of a projective nonunitary representations of the W H group [A li(2004)], so we named displacement type or generalized displacement operator. Therefore it is possible to construct two sets of CSs, the rst is the old one introduced in [K lauder(2001)]:

O by iously the states  $\dot{z} \dot{z}_{k_{PS}}^{dual}$  in (51) are new ones, other than  $\dot{z} \dot{z}_{k_{PS}}$ . By the same procedures we have done in the previous sections it may be seen that the new states,  $\dot{z} \dot{z}_{k_{PS}}^{dual}$  can also be considered as NL coherent state with the nonlinearity function

which is exactly the inverse of  $f_{KPS}$  (A), as one may expect. A loo the Ham iltonian for the dual oscillator is found to be

II) M ore recently a generalm athem atical physics form alism for constructing the dual states has been proposed by S T A li and us [A li (2004)]. Following the latter form alism one can de ne the operator

The  $\hat{T}$  operator we introduced in Eq. (55) is well-de ned and the inverse of it can be easily obtained as

by which we may construct the new family of dual states:  $\hat{T}^{-1} \dot{z} \dot{i}_{ccs} \dot{z} \dot{i}^{dual}_{kPS}$ . It is readily found that these states are just the states we have obtained in (51). Before applying the form alism to the KPS coherent states we give some examples.

It must be mentioned that investigating the resolution of the identity and discussing the nonclassical properties, such as squeezing of the quadratures, sub (supper)-Poissonian statistics, amplitude squared squeezing, bunching (or antibunching) and the metric factor of these new states in (51) employing the same (n)'s proposed in [K lauder(2001)] remain for future works.

# Example 5:1 Generalized displacement operator for PS coherent states:

Upon using the results we derived in example 4.1 the dual of the PS states can be easily obtained using Roy and Roy approach [Roy (2000)]:

which is exactly the dual states we obtained in Eq. (58).

Example 5:2 Generalized displacement operators for BG and GP coherent states of su(1;1) Lie algebra:

As a well-known example we express the dual of BG coherent states in example 42. The duality of these states with the so-called G ilm ore-Perelom ov (GP) CSs have already been dem onstrated in [A li(2004)]. The latter states were de ned as:

where  $B = af_{GP}(h)$  and  $B^{y} = f_{GP}(h)a^{y}$  are the deform ed annihilation and creation operators for the dual system (GP states), respectively. It is immediately observed that  $[A; B^{y}] = I; [B; A^{y}] = I$ , where obviously  $A = af_{BG}(h)$  and  $A^{y}$  is its Herm ition conjugate. So it is possible to obtain the displacement type operators for the BG and GP nonlinear CSs discussed in this paper, using relations (48) and (49). As a result the displacement operators obtained by our method are such that:

To the best of our know ledge these form s of displacem ent type operators for discrete series representation of SU (1;1) group, related to BG and GP coherent states have not appeared in literature up to now.

W e close this section with implying that to apply the procedure to the su (1;1)-BG coherent states for LL we expressed as an example (E xample 4:3), one must re-de ned the auxiliary operators B and B<sup>Y</sup>, in place of the ones introduced in (46) as follows:

The other calculations are the same as the general su (1;1) coherent states in this example, so let us leave it over here.

6. C onstructing K P S coherent states through annihilation and displacem ent operators and introducing proper H am iltonians for them

Now we list, the nonlinearity function f (f) and the associated H am iltonian  $\hat{H}$  (f), for all of the KPS coherent states according to our proposed m ethod. The operators A,  $A^{y}$  can easily be obtained using Eqs. (1), (2) and the displacem ent operators in like m anner m ay be obtained using Eqs. (46), (48) and (49). So we ignore introducing them explicitly. A similar argument can also be m ade for the dual fam ily of CSs (see (53) and (54) and the discussion before it for  $f_{KPS}^{dual}(\hat{f})$  and  $\hat{H}_{KPS}^{dual}(\hat{f})$ ). Therefore introducing f (f) and  $\hat{H}_{(f)}$ , seem s to be enough for our purpose. The set of CSs de ned on the whole plane are as follow s.

One can see from  $\hat{H}$  that it is simply a shift in the energy eigen-states of the harm onic oscillator, as expected from (n), which is only a shift in n!. In all of the following cases we use the de nitions (7) for f (n)!, whenever necessary.

b) (n) =  $\frac{(n+)}{()}$ , where in this case and what follows is the gam m a function. The CSs constructed by this (n) are known as the M ittag-Le er (M L) CSs [Sixdeniers(1999)]. As a special case for = 1 and arbitrary we obtain:

where we have used the recurrence relation (z + 1) = z (z). As a result we observe that the M L coherent states are also nonlinear CSs.

The dual of this state occurs for (n) = (n + 1)!, which is a special case of the item (a) when p = 1. So there is no problem with the resolution of the identity for them.

This kind of deform ation has already been employed by V Buzek [Buzek (1989)] who imposed on the single-mode eld operators a and  $a^y$ , and showed that in the Jaynes-Cummings model with the intensity dependent coupling (when still the notion of nonlinear CS has not been used up to that time), interacting with the Holstein-Primako SU (1;1) CSs, the revivals of the radiation squeezing are strictly periodical for any value of initial squeezing. A lso the dual of these states with f (ft) = 1= ft has already been discovered and named harm onious states [Sudarshan (1993)].

All the Ham iltonians we derived above are such that  $\lim_{n \le 1} E_n = 1$ . Upon more investigation in the above f-functions, an interesting physical point which may be explored is that the f(n) functions in (68), (69), (70) and (71) will be equal to 1 (canonical C S) in the limit n ! 1, i.e. for high intensities. So to observe the nonlinearity phenom ena and its features in these special cases we do not need high intensities of light. On the contrary, if anyone can generate these special states through some physical processes, for instance the eld-atom interaction in a cavity, the nonlinearity e ects can be detected in bw intensities.

In addition to the above sets of C Ss, K lauder et al introduced a large class of C Ss which have been de ned on a unit disk. For these states also it is possible to continue in the same way we did for the states on the whole of the com plex plane:

The common property of these states is that the  $\lim its of f(n)$  and H as n goes to in nity are 0 and 1, respectively.

O ne can easily check that using the above f-functions (de ned on the whole plane or restricted to the open unit disk) and solving the eigen-value equation A jzi = z jzi, or acting the displacement operator D (z), obtained from Eq. (50) on the vacuum state ji by the well-known procedures, correctly lead to the  $jzi_{KPS}$ . The same argument may be followed for the dual family  $jzi_{KPS}^{dual}$ .

7. A discussion on constructing GK coherent states by annihilation and displacem ent operators techniques

J R K lauder asked a question, "what is the physics involved in choosing the annihilation operator eigen-states"? Therefore he and J-P G azeau re-de ned the generalized CSs with the four requirements (i)-(iv) mentioned before in section 3 [K lauder(1998 and 2001) and G azeau (1999)], now adays known as GK coherent states (equation (16)). To nd out the nonlinearity nature of the GK coherent states one may apply the method we proposed, on these states. As a result we arrive at the following expression for  $f_{\rm ex}$  (;  $\hat{n}$ ):

where we have choosed the notation  $e_n = \frac{(n)}{(n-1)}$  for simplicity. We demonstrated in the previous sections that this is the starting point to de ne the GK coherent states of any physical system as the (deform ed) annihilation operator eigen-states and associate with them a displacement (type) operator. In addition to deducing the above results in detail, we applied the procedure on the known examples in the literature such as C oulom b-like spectrum [G azeau (1999)], the P oschl-T eller and the in nite square well potentials [A ntoine (2001)], form ally.

But, although we have introduced an expression for the nonlinearity function for the GK coherent states in equation (82), by which we can form ally proceed further and get the explicit form of the requested results, upon a closer look at this relationship one can see that  $f_{GK}$  (;fi), is not a well-de ned operator valued function, in view of high careful m athem atical considerations. It should be understood, that clearly this result is not due to illegality of the proposed approach. In fact the di culty in this special case m ight be expected naturally, because of the relaxing of the holom orphicity [D dzijew icz (1998)] requirement in the de nition of the GK coherent states [G azeau (1999)].

Nevertheless one may still use the presented form alism to nd some special dual family associated with GK coherent states, the explicit form of which will not introduce here, until we nd a well-de ned form of them in future. Therefore the di culties that already mentioned in [A li(2004)] with the dual family of GK coherent states remain unsolved. We shall pay more attention to this matter in a forthcoming paper.

## 8. Concluding rem arks

In sum m ary we can classsify the obtained results as follows.

- I) We connected some important classes of CSs: KPS, PS and GK coherent states and the discrete series representation of su (1;1) Lie algebra using NL coherent states m ethod successfully. Nonlinear CSs encompasses all these states as special cases which are distinguishable from each other via the nonlinearity function f (n). So we have obtained a "uni ed m ethod" to construct all of these CSs which already have been introduced by di erent prescriptions. Therefore this work m ay be considered in parallel to the previous e orts [Shanta (1994) and A li(2004)] for uni cation of a large class of generalized CSs. Our re-construction of these states by the standard de nitions, i.e. annihilation operator eigen-states and displacement operator techniques, with the preceding results enriches each set of the above classes of CSs in quantum optics, in the context of each other. So we enlarged the classi cation of nonlinear CSs with states having the m ain property of the generalized CSs (the resolution of the identity), considerably.
- II) We did not discussed about the dual states in detail, indeed we wanted only to show that our method can active the Roy and Roy approach [Roy(2000)] to produce the dual of any generalized CSs that can be classified in the nonlinear CSs. So introducing the dual family of generalized CSs coherent states has been done brie y, since it was out of the scope of our present work.
- III) The result we obtained in equation (27) is in fact the factorization im plied in the literature, while authors deal with solvable potentials and try to nd ladder operators (see for instance D aoud (2002) and E kinani (2003)). A coording to the latter approach the one-dimensional supersymmetric quantum mechanics (SUSQM) provides an algebraic tool to de ne ladder operators for som e exactly solvable potentials. Therefore it may be understood that our method can be considered as an alternative form alism parallel to the well-known SUSQM techniques to reach this purpose more easily. Precisely speaking, for Ham iltonians having the properties mentioned in (18) i.e. for som e special solvable system s, one can factorize the Hamiltonian as we did in (27). This is interesting that these two distinct approaches term inate to a common point. To clarify more we add here that the equations (8)-(11) in [D aoud (2002)], which describe the action of creation, annihilation and their commutators on the related Fock space (where the author did not introduce the explicit form of the related operators), also can be derived with the help of our method, at least form ally (see the discussion at section 7). But since we are looking for not only their actions but also the explicit form of the related operators, in terms of standard ladder operators and number operator, we did not bring them in this contents due to the ill-de nition of the nonlinearity function (equation 82).
- IV) A sapostscript we mention another point. B ased on the latter potentiality of such a naive approach we proposed to nd the creation and annihilation operators, it may be realized as a comment that our formalism provides a straightforward fram ework for producing the photon-added [A garwal(1991)] or more precisely exited C Ss corresponding to exactly solvable potentials, such as Poschl-Teller and M orse potentials [Popov (2003) and D aoud (2002)]. The procedure is really manifest. Once the eigen-values of the H am iltonian were known, the G azeau-K lauder C Ss can be constructed using Eq. (16). The next step is to nd the nonlinearity function through which one can perform ladder operators with the help of our procedure. Finally the iterative action of the creation operator on the

GK coherent states readily gives the excited CSs. In this way this procedure can be applied in general to all sets of CSs discussed in the present work to create excited CSs of KPS, PS and su (1;1) types, as well as the GK coherent states in a simple manner.
