# C onstruction of Som e Im portant C lasses of G eneralized C oherent States: the N on linear C oherent States M ethod

A bstract. Considering som e im portant classes of generalized coherent states known in literature, we dem onstrated that all of them can be created via conventional fashion, i.e. the "lowering operator eigen-state" and the "displacem ent operator" techniques using the "nonlinear coherent states" approach. A s a result we obtained a "uni ed m ethod" to construct a large class of coherent states which already have been introduced by di erent prescriptions.

## 1. Introduction

C oherent states ( $C$ Ss) are venerable ob jects in physics $w$ ith $m$ any applications in $m$ ost of the elds of physics and $m$ athem atical physics $\mathbb{K}$ lauder(1985) and A li(2000)] from solid states physics to cosm ology and occurred in the core of quantum optics. A long generalization of coherent states recently JP G azeau and J R K lauder proposed new coherent states (G K) for system S w th discrete or continuous spectra, which param eterized by two real and continuous param eters $J \quad 0$ and $1 \ll 1$, denoted by jJ; i [G azeau (1999)]. T hey involve the representation ofthe discrete series su $(1 ; 1)$ Lie algebra, C oulom b-like spectrum , P osch 1 -T eller and the in nite square well potentials A ntoine (2001)].

M ore recently J R K lauder, K A P enson and J-M Sixdeniers introduced another im portant classes of generalized CSs through solutions of Stieltjes and Hausdor m om ent problem $\mathbb{K}$ lauder (2001)]. T he constructed C Ss in their paper which we w ill denote them by $\mathrm{K}_{\mathrm{K} p \mathrm{~s}}$ have these properties: i) nom alization ii) continuity in the label and iii) they form an overcom plete set which allow s a resolution of unity w ith a positive weight function.T hen they have studied the statistical properties of these states by calculating $M$ andel param eter and also the geom etry of these states by a $m$ etric factor, both analytically and num erically. At last, they used som e estim ations, to nd the proper H am iltonian for som e sets of their C Ss.

The generalized CSs mentioned above, neither de ned as eigestates of an annihilation operator, known as Banut-G irardello (BG) CSs Barut(1971)], nor resulted from the action of a displacem ent operator on a reference state, say vacuum state, known frequently as G im ore-P erelom ov (G P ) C Ss [G ilm ore (1972) and P erelom ov (1972)]. In other words the algebraic and sym $m$ etry considerations of the above two sets of states have not been clear, there. The sam e situation holds for the generalized CSs proposed by K A Penson and A I Solom on we denote them by j; qip s $\mathbb{P}$ enson (1999)]. D ue to these, our aim is to establish these sub jects, and also to nd a simpler way to relate the constructed CSs to an exact expression of the H am iltonian, out of any estim ation. In a sense our present paper $m$ ay be considered along the com pletion of the works of G azeau et al [G azeau (1999)], K lauder et al $\mathbb{K}$ lauder (2001)] and $P$ enson et al $\mathbb{P}$ enson (1999)].

O ur procedure is based on the conjecture that these states $m$ ay be studied in the so-called nonlinear $(\mathbb{N} L)$ coherent states orf-deform ed coherent states category $M$ anko (1997)]. $T$ his is the $m$ ain feature of our work. $N$ onlinear C Ss attracted much attention in recent years, $m$ ostly because they exhibit nonclassical properties. As we know, up to now many quantum optical states such as q-deform ed CS M anko (1997)], negative binom ial state [W ang (1999) and W angFu (1999)], photon added (and subtracted) C S [Sivakum ar(2000), Sìvakum ar(1999) and N aderi(2004)], the center ofm ass m otion of a trapped ion $M$ atos (1996) ], som e nonlinear phenom ena such as a hypothetical "frequency blue shift" in high intensity photon beam s M anko (1995)] and recently after proposing f-bounded CS $\mathbb{R} e^{\prime} c a m$ ier (2003)], the binom ial state (or displaced exited CS) $\mathbb{R}$ oknizadeh (2004)] have been considered as som e sorts of nonlinear C Ss.

We attem pt now to dem onstrate that all sets of KPS coherent states including PS coherent state and the discrete series representations of the group $S U(1 ; 1)$ (BG and GP coherent states) and su (1;1)Barut-G irardello CSs for Landau-level(LL) Fakhri(2004)] can be classi ed in the nonlinear CSs w ith some special types of nonlinearity function $f(n)$, by which we $m$ ay obtain the "deform ed annihilation
and creation operators", "generalized displacem ent operator" and the "dynam ical H am iltonian" of the system. B ased on these results it w ill be possible to reproduce all of the above CSs through the conventional fashion, i.e. by annihilation and displacem ent operator de nition. In a general view the form alism presented in this paper providesa uni ed approach to construct allthe em ployed C Ss already introduced in di erent ways. In another direction as a matter of fact introducing the ladder operators related to the above CSs may be regarded as a rst step in the process of generation of these states in som e experim ental realization schem es in quantum optics, when one intended to perform the interaction $H$ am iltonian describes form ally the interaction betw een atom $s$ and electrom agnetic eld.

In addition to these, three interesting and new rem arkable points, which seem ingly that have not been pointed out so far, em erges from our studies. The rst is that we can construct a new fam ily of CSs (nam ed the dual set), other than the KPS and PS coherent states $\mathbb{A}$ li(2004) and R oy (2000)]. The second is that the $H$ am iltonian proposed in M anko (1997)] and others who cited him [see e.g.: Sivakum ar(2000)]m ust be reform ed, in view of the action identity requirem ent im posed on the generalized C Ss ofK lauder $\mathbb{K}$ lauder(1998)]. W e should quote here that recently som e authors (for instance see A H E IK inaniand M D aoud $\mathbb{E} \mathbb{K}$ inani(2003)] have used nom alordering form (factorization) for their $H$ am iltonians. But they som etim es $m$ ade this suggestion for drastic sim pli cation, w thout any deep physical bases [Speliotopoulos(2000)]. Indeed they used the supersym $m$ etric quantum $m$ echanics (SU SQM) techniques as a " $m$ athem atical tool" to nd the ladder operators for their H am iltonians. Interestingly our form alism for solvable H am iltonians gives an easier and clearer $m$ ethod to obtain these operators whenever necessary. We will pay more attention to this result in the conclusion. Thirdly, our results give us the opportunity to observe that for some sets of the KPS coherent states, the nonlinearity phenom ena $w$ ill be visible in "low intensities of light", the fact that have been hidden, until we discovered the nonlinearity nature of them explicitly. This would be im portant experim entally, since as $M$ an'ko et al experienced, the nonlinear phenom ena in $q$-oscillators can be detected only in high intensity photon beam s $M$ anko (1995)]. T herefore if anyone can generate these particular sets of K P S coherent states by interaction of a eld and atom $s$, it will be $m$ ore easier to detect this phenom ena.

The plan of this paper is as follow s : for the sake of com pleteness we w ill bring a brief review on the nonlinear CSs, as M an'ko et al introduced in section 2, follow ing w ith a review on KPS and G K coherent states in section 3. T hen the relation betw een KPS, PS and BG coherent states of su $(1 ; 1)$ w ith nonlinear C Ss w ill be obvious in section 4, and so the generators of the deform ed oscillator algebra, displacem ent type operator, and the proper $H$ am iltonian in each set of the above coherent states $w$ illbe nd in sections 5 and 6. B ased on our results we will introduce a vast class of new generalized CSs (dual fam ily of K P S and P S coherent states). Then we discuss about the extension of the procedure to the G K coherent states in section 7, and nally we present our conclusions.

## 2. $N$ on linear coherent states

N onlinear C Ss were rst introduced explicitly in M atos(1996) and M anko (1997)] but before them it is im plicitly de ned by Shanta et al [Shanta (1994)] in a com pact form . $T$ his notion attracted m uch attention in physical literature in recent decade, especially because of their nonclassical properties in quantum optics. M an'ko et al's approach
is based on the tw o follow ing postulates.
The rst is that the standard annihilation and creation operators deform ed w ith an intensity dependent function $f(\hat{A})$ (which is an operator valued function), according to the relations:

where $a, a^{y}$ and $\hat{\mathrm{n}}=\mathrm{a}^{\mathrm{y}}$ a are bosonic annihilation, creation and num ber operators, respectively. O rdinarily the phase of $f$ is irrelevant and one $m$ ay choose $f$ to be real and nonnegative, i.e. $f^{y}(\hat{n})=f(\hat{n})$. But to keep general consideration, we take into account the phase dependence of $f(\mathrm{~A})$ in general form alism given in this section.
$T$ he second postulate is that the $H$ am iltonian of the deform ed oscillator in analog to the harm onic oscillator is found to be

where by index $M$ we want to denote the H am iltonian as introduced by M an'ko et al . T he single $m$ ode nonlinear C Ss obtained as eigen-state of the annihilation operator is as follow s:
where the coe cients $C_{n}$ are given by

and the norm alization constant is determ ined as

In order to have states belonging to the Fock space, it is required that $0<\mathrm{N}_{\mathrm{f}}$ (立予) $<$ 1 , which implies that $\dot{\xi} j \quad \lim _{n y} n[f(n)]^{2}$. No further restrictions are then put on $f(n)$. N ow w th the help of Eqs. (6) and (7) the function $f(n)$ corresponding to any nonlinear $C S$ is found to be

which plays the key rule in our present work. To recognize the nonlinearity of any CS we can use this sim ple and useful relation; by this $w e m$ ean that if $C_{n}$ 's for any CS are known, then $f(n)$ can be found from Eq. (9) ; when $f(n)=1$ or at $m$ ost be only a constant phase, we recover the original oscillator algebra, otherw ise it is nonlinear.

3．KPS and G K generalized coherent states
A long generalization of C Ss J R K lauder et al $\mathbb{K}$ lauder（2001）］introduced the states
where $(n)$ satis es $(0)=1$ and the nom alization constant is determ ined as

Comparing Eqs．（6）with（10）we obtain：$C(n)=[(n)]^{1=2}$ which describes the relation betw een KPS and nonlinear CSs．Indeed whep $C_{n}=1=\bar{n}$ ！we obtain CCS，otherw ise（for instance in general when $C_{n}=1=\frac{(n)}{}$ ）as in（10），we are led to nonlinear CSs，this is what we want to show．We will dem onstrate the equivalence betw een all sets ofK P S coherent states and the nonlinear C Ss in section 6 in detail．These states possess three conditions（i）－（iii）stated in the introduction，by appropriately selected fiunctions（ $n$ ）．The third condition，which is the $m$ ost di cult and at the same time the strongest requirem ents of any sets of CSs，were proved appreciatively by them，through Stieltjes and H ausdor power－m om ent problem．

for $R<1$ ，which is known as $H$ ausdor $m$ om ent problem，with $H(\mathbb{R})$ as the Heaviside function．The positive weight functions $W^{\top}(x)$ can be obtained， through $M$ ellin and inverse $M$ ellin transform techniques，when $(n)$ is choosed．This autom atically guarantees the condition of resolution of the identity for the K P S states according to（12），（for a brief and nice discussion see：K lauder（2001）and references therein，e．g．：M arichev（1983）and P rudinkov（1998））．

A dopting certain physical criteria rather than im posing selected $m$ athem atical requirem ents，$K$ lauder and $G$ azeau by reparam etrizing the generalized CSs ki in term sofa tw o independent param eters $J$ and ，introduced the generalized C Ss jं；i，
known ordinarily as G azeau - K lauder (G K ) coherent states in the physical literature $\mathbb{K}$ lauder (1998) and G azeau (1999)]. These are explicitly de ned by the expansion

It $m$ ust be understood that the forth condition forced the generalized CSs to have the essential property: "the m ost classical quantum states", but now in the sense of energy of the dynam ical system, in the sam e way that the canonical coherent state (CCS) is a quantum state which its position and $m$ om entum expectation values obey the classical onbits of harm onic oscillator in phase space.

In Eq. (16) the kets jni are the eigen-vectors of the H am ittonian $\hat{H}$, w ith the eigen-energies $\mathrm{E}_{\mathrm{n}}$

The action identity uniquely speci ed ( $n$ ) in term $s$ of the eigen-values of the $H$ am iltonian $\hat{H}$ w ith a discrete spectrum $0=e_{0}<e_{1}<e_{2}<:::$

Eq. (19) obviously states that ( n ) is directly related to the spectrum of the dynam ical system. So every H am iltonian uniquely determ ined the associated CS, although the inverse is not true. This is because of the existence of the isospectral H am iltonians in the context of quantum $m$ echanics $\mathbb{F e m}{ }^{\prime}$ andez (1994) and R oknizadeh (2004)].
4. The relation betw een som e classes of generalized coherent states and the nonlinear coherent states

To start w ith we dem onstrate the relation betw een the KPS and NL coherent states. A s we have $m$ entioned already by com paring Eqs. (6) and (10), the coe cients $C \mathrm{n}$ can be determ ined. $T$ hen inserting $C_{n}$ and $C_{n} 1$ into (9) yields:

which provides sim ply a bridge betw een K P S and N L coherent states. A s a specialcase when $(n)=n$ !, i.e. the canonicalCS, we obtain $f(n)=1$. W e w ill dem onstrate the equivalence betw een all sets of K P S coherent states and the nonlinear C Ss in section 6. From Eq. (19) $e_{n}$ can easily be found as a function of ( $n$ ):

Rem em bering that $e_{n} s$ are the eigen-values of the $H$ am iltonian, it $w i l l$ be obvious that neither every ( $n$ ) of KPS coherent states nor every $f(n)$ of nonlinear C Ss are physically acceptable, when the dynam ics of the system (Ham itonian) is speci ed. U sing Eqs. (21) and (22) we get

Now by using (21) we are able to nd $f(\mathrm{n})$ for all sets of KPS coherent states and then the deform ed annihilation and creation operators $A=a f(\hat{n})$ and $A^{y}=f^{y}(\hat{n}) a^{y}$ $m$ ay easily be obtained. Retuming to the above descriptions, the operators $A$ and $A{ }^{Y}$ satisfy the follow ing relations:

A lso note that $A{ }^{Y} A$ jin $=e_{n} j$ in, not equal to $n j i \operatorname{in}$ general. $W$ th these results in $m$ ind it would be obvious that Eq. (23) is not consistent $w$ ith the relations (4) and (5) for the $H$ am iltonian. A closer look at E $q$. (23) which is a consequence of im posing the action identity on the H am iltonian of the system leads us to obtain a new form of the $H$ am iltonian for the nonlinear C Ss as

Comparing Eqs. (4) and (5) w ith the Eqs. (23), (27) and (28) implies that if we require that the KPS and nonlinear CSs to possess the action identity property, the associated $H$ am iltonian when expressed in term sof ladder operatorsm ust be reform ed in norm al-ordered form .

In sum $m$ ary our considerations enable one to obtain $f$-deform ed annihilation and creation operators as well as the H am ittonian for all sets of $\dot{k} i_{\text {ks }}$ discussed in $\mathbb{K}$ lauder(2001)], after dem onstrating that for each of them there exist a special nonlinearity function $f(\mathrm{f})$. Before closing this section, we bring two illustrative exam ples to show the ability of ourm ethod.

E xam ple 4:1 Penson-Solom on generalized C Ss:

A s an exam ple we can sim ply deduce the nonlinearity function for the generalized C Ss introduced by Penson and Solom on (P S) $\mathbb{P}$ enson (1999)]:

This de nition isbased on an entirely analyticalprescription, in which the authors proposed the generalized exponential function obtained from the follow ing di erentialequation:

So they have not used the ladder (or displacem ent) operator de nition for their states $\mathbb{P}$ enson (1999)]. The nonlinearity function, the annihilation and creation operators evolve in these states can be easily obtained by our form alism as

Therefore our $m$ ethod enables one to reproduce them through solving the eigen-

A deep inspection to the states in (42) in com parison to the states in (34) show sa little di erence, in view of the low er lim it of sum $m$ ation sign in the form er equation. But this situation is sim ilar to the states known as photon-added C Ss A garwal(1991)] in the sense that both of them are combinations of Fock space, w ith a cut-o in the sum $m$ ation from below. This com $m$ on feature leads us to go on $w$ th the sam $e$ procedure that has been done already to yield the nonlinearity function of the photonadded CSs(PACSS) in [W ang (1999) and Sivakum ar(1999)]. W e de ne the deform ed anninilation operator and the nonlinearity function sim ilar to PACSs as

A fter we recast the K P S, P S and su $(1 ; 1)$ coherent states as nonlinear C Ss and found a nonlinearity function for each set of them, it is now possible to construct all of them through a displacem ent type operator form alism. W ew ill do this in tw o distinct ways.

6. C onstructing KPS coherent states through annihilation and displacem ent operators and introducing proper $H$ am iltonians for them
$N$ ow we list, the nonlinearity function $f(\hat{r})$ and the associated $H$ am iltonian $\hat{H}$ ( A ), for all of the KPS coherent states according to our proposed m ethod. The operators $A$, $A^{y}$ can easily be obtained using Eqs. (1), (2) and the displacem ent operators in like $m$ anner $m$ ay be obtained using Eqs. (46), (48) and (49). So we ignore introducing them explicitly. A sim ilar argum ent can also be made for the dual fam ily of CSs (see (53) and (54) and the discussion before it for $f_{\mathrm{KPS}}^{\text {dual }}(\hat{n})$ and $\hat{H}_{\mathrm{KP} \mathrm{S}}^{\text {dual }}(\hat{\mathrm{n}})$ ). Therefore introducing $f(\hat{n})$ and $\hat{H}(\hat{n})$, seem $s$ to be enough for our purpose. The set of C Ss de ned on the whole plane are as follows.

This kind of deform ation has already been em ployed by V Buzek Buzek (1989)] who im posed on the single-m ode eld operators a and $a^{y}$, and showed that in the Jaynes-C um m ings model w ith the intensity dependent coupling (w hen still the notion of nonlinear CS has not been used up to that tim e), interacting w ith the $H$ olstein $P$ rim ako $S U(1 ; 1) C S s$, the revivals of the radiation squeezing are strictly periodical for any value of initial squeezing. A lso the dual of these states w ith $\mathrm{f}(\hat{\mathrm{n}})=1=\overline{\mathrm{n}}$ has already been discovered and nam ed harm onious states [Sudarshan (1993)].

Upon $m$ ore investigation in the above $f$-fiunctions, an interesting physical point which $m$ ay be explored is that the $f(n)$ functions in (68), (69), (70) and (71) will be equal to 1 (canonical CS) in the lim it n ! 1 , i.e. for high intensities. So to observe the nonlinearity phenom ena and its features in these special cases we do not need high intensities of light. On the contrary, if anyone can generate these special states through som e physical processes, for instance the eld-atom interaction in a cavity, the nonlinearity e ects can be detected in low intensities.

In addition to the above sets of C Ss, K lauder et al introduced a large class of C S which have been de ned on a unit disk. For these states also it is possible to continue in the sam e way we did for the states on the whole of the com plex plane:

The com $m$ on property of these states is that the lim its of $f(n)$ and $H$ as $n$ goes to in nity are 0 and 1, respectively.

O ne can easily check that using the above f-fiunctions (de ned on the whole plane or restricted to the open unit disk) and solving the eigen-vahue equation $A \dot{k} i=z \dot{z} i$, or acting the displacem ent operatorD (z), obtained from Eq. (50) on the vacuum state jDi by the well-known procedures, correctly lead to the $\bar{\xi} i_{k p s}$. The same argum ent $m$ ay be followed for the dual fam ily $\mathrm{Ki}_{\mathrm{K} P \mathrm{~s}}^{\mathrm{dual}}$.
7. A discussion on constructing $G K$ coherent states by annihilation and displacem ent operators techniques

J R K lauder asked a question, "what is the physics involved in choosing the annihilation operator eigen-states"? Therefore he and JP G azeau re-de ned the generalized CSs w ith the four requirem ents (i)-(iv) mentioned before in section 3【K lauder (1998 and 2001) and G azeau (1999) ], now adays know n as G K coherent states (equation (16)). To nd out the nonlinearity nature of the G K coherent states one $m$ ay apply the $m$ ethod we proposed, on these states. As a result we arrive at the follow ing expression for $f_{G K}(; \hat{\wedge})$ :

$w$ here we have choosed the notation $\hat{\theta}_{\mathrm{n}} \quad \frac{(\mathrm{A})}{(\mathrm{n} 1)}$ for sim plicity. W e dem onstrated in the previous sections that this is the starting point to de ne the G K coherent states of any physicalsystem as the (deform ed) annihilation operator eigen-states and associate w ith them a displacem ent (type) operator. In addition to deducing the above results in detail, we applied the procedure on the know n exam ples in the literature such as C oulom b-like spectrum [G azeau (1999)], the P oschl-Teller and the in nite square well potentials A ntoine (2001)], form ally.

But, although we have introduced an expression for the nonlinearity function for the $G \mathrm{~K}$ coherent states in equation (82), by w hich we can form ally proceed further and get the explicit form of the requested results, upon a closer look at this relationship one can see that $f_{G K}(; \hat{n})$, is not a well-de ned operator valued function, in view of high careful $m$ athem atical considerations. It should be understood, that clearly this result is not due to illegality of the proposed approach. In fact the di culty in this special case $m$ ight be expected naturally, because of the relaxing of the holom onphicity [O dzijew icz (1998)] requirem ent in the de nition of the GK coherent states [G azeau (1999)].
$N$ evertheless one $m$ ay still use the presented form alism to nd som e special dual fam ily associated w ith G K coherent states, the explicit form of which will not introduce here, untilwe nd a well-de ned form ofthem in future. Therefore the di culties that already $m$ entioned in $[A$ li(2004)] w ith the dual fam ily of $G K$ coherent states re$m$ ain unsolved. W e shall pay $m$ ore attention to this $m$ atter in a forthcom ing paper.

## 8. C oncluding rem arks

In sum $m$ ary we can classsify the obtained results as follow s.
I) W e connected som e im portant classes of C Ss: KPS,PS and G K coherent states and the discrete series representation of $\operatorname{su}(1 ; 1)$ Lie algebra using $N L$ coherent states $m$ ethod successfully. N onlinear C Ss encom passes all these states as special cases which are distinguishable from each other via the nonlinearity function $f(n)$. So we have obtained a "uni ed m ethod" to construct all of these C Ss which already have been introduced by di erent prescriptions. Therefore this w ork m ay be considered in parallel to the previous e orts [Shanta (1994) and A li(2004)] for uni cation of a large class of generalized CSs. O ur re-construction of these states by the standard de nitions, i.e. annihilation operator eigen-states and displacem ent operator techniques, w the preceding results enriches each set of the above classes of CSs in quantum optics, in the context of each other. So we en larged the classi cation of nonlinear CSs with states having the $m$ ain property of the generalized CSs (the resolution of the identity), considerably.
II) W e did not discussed about the dual states in detail, indeed we wanted only to show that our method can active the R oy and R oy approach $\mathbb{R}$ oy (2000)] to produce the dual of any generalized C Ss that can be classi ed in the nonlinear C Ss. So introducing the dual fam ily of generalized C Ss coherent states has been done brie $y$, since it was out of the scope of our present work.
III) The result we obtained in equation (27) is in fact the factorization im plied in the literature, while authors dealw ith solvable potentials and try to nd ladder operators (see for instance D aoud (2002) and E $\mathbb{k}$ inani (2003)). A ccording to the latter approach the one-dim ensional supersym $m$ etric quantum $m$ echanics (SU SQ M ) provides an algebraic tool to de ne ladder operators for som e exactly solvable potentials. Therefore it $m$ ay be understood that our $m$ ethod can be considered as an altemative form alism parallel to the well-known SU SQM techniques to reach this purpose $m$ ore easily. P recisely speaking, for H am iltonians having the properties $m$ entioned in (18) i.e. for som e special solvable system $s$, one can factorize the H am iltonian as we did in (27). This is interesting that these two distinct approaches term inate to a com $m$ on point. To clarify $m$ ore we add here that the equations (8)-(11) in $\mathbb{D}$ aoud (2002)], which describe the action of creation, annihilation and their com $m$ utators on the related Fock space (w here the author did not introduce the explicit form of the related operators), also can be derived w ith the help of our $m$ ethod, at least form ally (see the discussion at section 7). But since we are looking for not only their actions but also the explicit form of the related operators, in term $s$ of standard ladder operators and num ber operator, we did not bring them in this contents due to the ill-de nition of the nonlinearity function (equation 82).

IV ) A s a postscript wem ention another point. B ased on the latter potentiality ofsuch a naive approach we proposed to nd the creation and annihilation operators, it $m$ ay be realized as a com $m$ ent that our form alism provides a straightforw ard fram ew ork for producing the photon-added [A garwal(1991)] or m ore precisely exited CSs corresponding to exactly solvable potentials, such as Poschl-Teller and $M$ orse potentials $\mathbb{P}$ opov (2003) and D aoud (2002)]. T he procedure is really $m$ anifest. O nce the eigen-values of the $H$ am iltonian were know $n$, the $G$ azeau$K$ lauder CSs can be constructed using Eq. (16). The next step is to nd the nonlinearity function through which one can perform ladder operators $w$ ith the help of our procedure. Finally the iterative action of the creation operator on the

G K coherent states readily gives the excited C S. In this w ay this procedure can be applied in general to all sets of CSs discussed in the present work to create excited C Ss of KPS, PS and su (1;1) types, as well as the G K coherent states in a simple m anner.
