E ective three-body interactions in triangular optical lattices

We demonstrate that a triangular optical lattice of two atom ic species, bosonic or ferm ionic, can be employed to generate a variety of novel spin-1=2 H am iltonians. These include e ective threespin interactions resulting from the possibility of atom s tunneling along two di erent paths. Such interactions can be employed to simulate particular one or two dimensional physical system s with ground states that possess a rich structure and undergo a variety of quantum phase transitions. In addition, tunneling can be activated by employing R am an transitions, thus creating an e ective H am iltonian that does not preserve the number of atom s of each species. In the presence of external electrom agnetic elds, resulting in complex tunneling couplings, we obtain e ective H am iltonians that break chiral symmetry. The ground states of these H am iltonians can be used for the physical implementation of geometrical or topological objects.

I. IN TRODUCTION

W ith the development of optical lattice technology [1, 2, 3], considerable attention has been focused on the experim entalsim ulation of a variety of many-particle system s, such as spin chains [4, 5, 6, 7]. This provides the possibility to probe and realise com plex quantum models with unique properties in the laboratory. Such examples, that are of interest in various areas of physics, are the system s that include m any-body interactions. The latter have been hard to study in the past due to the di culty in controlling them externally and isolating them from the environm ent [8]. To overcom e these problem s, techniques have been developed in quantum optics [9, 10, 11] which m inim ise imperfections and impurities in the implementation of the desired structures, thus paving the way for the consideration of such \higher order" phenom ena of multi-particle interactions. Their applications could be of much interest to cold atom technology as well as to condensed matter physics and quantum information.

In this paper we obtain the interaction term sofbosonic or ferm ionic lattices of two species of atom s, denoted here by " and # (see [4, 5, 7]). These can be two di erent hyper ne ground states of the same atom coupled via an excited state by a Ram an transition. The system is brought initially into the M ott insulator phase where the num ber of atom s at each site of the lattice is well de ned. By restricting to the case of only one atom per site it is possible to characterise the system by pseudospin basis states provided by internal ground states of the atom. Interactions between atom s in di erent sites are facilitated by virtual transitions. These are dictated by the tunneling coupling J from one site to its neighbours and by collisional couplings U that take place when two or m ore atom s are within the same site.

In the following we consider the case of weak tunneling couplings, J U, assuring that we are always in the M ott insulator regin e. O ur aim is to construct a perturbative study of the e ective interactions with respect to the smallparam eter J=U. Up to the third order this expansion willprovide H am iltonians that include three-spin interactions. These multiparticle interactions can be, in principle, realised with the near future technology. The m ain physical requirement is large collisional couplings, U, which can be obtained experimentally by Feshbach resonances [15, 16, 17]. First theoretical [19] and experimental [20] advances are already promising. Hence, the time interval needed for those higher order terms to have a signi cante ect can be well within the coherence times of the system.

Several applications spring out from our studies. The system atic description of the low energy Ham iltonian provides the m eans for the advanced control of the threespin interactions simulated in the lattice. Hence, di erent physicalm odels can be realised, with ground states that present a rich structure such as multiple degeneracies and a variety of quantum phase transitions [12, 13, 14]. Some of these multi-spin interactions have been theoretically studied in the past in the context of the hard rod boson [21, 22, 23, 24], using self-duality symmetries [25, 26]. Phase transitions between the corresponding ground states have been analysed [27, 28]. Subsequently, these phases may also be viewed as possible phases of the initial system, that is in the M ott insulator, where the behaviour of its ground state can be controlled at will [29].

The paper is organised as follows. In Section II, we present the physical system and the conditions required to obtain three-body interactions. The e ective three-spin H am iltonians for the case of bosonic or ferm ionic species of atom s in a system of three sites on a lattice are given in Sec. III. In Sec. IV we study the e ect R a-m an transitions can have on the tunneling process and generalised e ective H am iltonians are presented that do

not preserve the number of atom s of each species. These are of particular interest for the construction of certain geom etrical evolutions. In Sec. V com plex tunnelings are considered and the generation of chiral ground states is presented. In Sec. V I our results are extended tow and the construction of one dimensional models and several applications are discussed. In Sec. V II we present an outlook and the conclusions. Finally, in the Appendix, two alternative m ethods are presented for the perturbation theory that results in the three-spin interactions.

II. THE PHYSICAL MODEL




FIG.1: The basic building block for the triangular lattice con guration. Three-spin interaction terms appear between sites 1, 2 and 3. For example, tunneling between 1 and 3 can happen through two di erent paths, directly and through site 2. The latter results in an exchange interaction between 1 and 3 that is in uenced by the state of site 2.

Let us consider a cloud of ultra cold neutral atom s superimposed with several optical lattices [4, 5, 6, 7, 32]. For su ciently strong intensities of the laser eld this system can be placed in the M ott insulator phase where the expectation value of only one particle per lattice site is energetically allowed [3]. We are interested in the particular setup of lattices that form an equilateral triangular con guration, as shown in Fig. 1. This allows for the simultaneous superposition of the positional wave functions of the atom s belonging to the three sites. As we shall see in the follow ing this results in the generation of three-spin interaction.

The main contributions to the dynamics of the atom s in the lattice sites are given by the collisions of the atom s within the same site and the tunneling transitions of the atom sbetween neighbouring sites. In particular, the coupling of the collisional interaction for atom s in the same site are taken to be very large in magnitude, while they are supposed to vanish when they are in di erent sites. D ue to the low temperature of the system, this term is completely characterised by the s-wave scattering length. Furtherm ore, the overlap of the W annier wave functions between adjacent sites determ ines the tunneling am plitude, J, of the atom s from one site to its neighbours. Here, the relative rate between the tunneling and the collisional interaction term is supposed to be very small, i.e. J U, so that the state of the system is mainly dominated by the collisional interaction.

The H am iltonian describing the three lattice sites with three atoms of species = f'';#g subject to the above interactions is given by

where a_j denotes the annihilation operator of atom s of species at site j. The annihilation operator can describe ferm ions or bosons satisfying commutation or anticommutation relations respectively given by

where the sign denotes the anticom mutator or the commutator. The operator n_j is the corresponding number operator and : ::: : denotes norm all ordering of the product of the creation and annihilation operators. The H am iltonian H⁽⁰⁾ is the lowest order in the expansion with respect to the tunneling interaction.

D ue to the large collisional couplings activated when two orm ore atoms are present within the same site, the weak tunneling transitions do not change the average number of atoms per site. This is achieved by adiabatic elim ination of higher population states along the evolution leading eventually to an elective H am iltonian (see Appendix). The latter allows virtual transitions between these levels providing eventually non-trivial evolutions. A swe shall see in the Appendix it is possible to describe the low energy evolution of the bosonic or ferm ionic system up to the third order in the tunneling interaction by the elective H am iltonian

The indices , refer to states with one atom per site while , refer to states with two orm ore atom ic populations per site, E are the eigenvalues of the collisional part, H $^{(0)}$, while we neglected fast rotating term s e ective for long time intervals.

It is instructive to estim ate the energy scales involved in such a physical system . We would like to have a signi cant e ect of the three-spin interaction within the decoherence times of the experimental system, which we can take here to be of the order of several 10 m s. It is possible to vary the tunneling interactions from zero to some maximum value which we can take here to be of the order of J=~ 1 kHz 2]. In order to have a significant e ect from the term $J^3=U^2$ produced within the decoherence tim e one should choose U =~ 10 kHz. This can be achieved experim entally by moving close to a Feshbach resonance [15, 16, 17, 18], where U can take signi cantly large values as long as trap losses, attributed to three body collisions or production of molecules, remain negligible. With respect to these parameters we 10², which is within the M ott insulator have (J=U)² regime, while the next order in perturbation theory is an order of m agnitude sm aller than the one considered here and hence negligible. Note how ever, that new interaction terms arise only in 5th order in perturbation due to the triangular geom etry of the optical lattice. This places the requirem ents of our proposal for detecting the e ect of three-spin interactions within the range of the possible experim ental values of the near future technology.

W ithin the regime of single atom occupancy per site it is possible to switch to the pseudo-spin basis of states of the site j given by j"i $j_{n_{j''}} = 1; n_{j\#} = 0$ i and $\dot{n}_{j''} = 0; n_{j\#} = 1i$. Hence, the elective Ham ilj#i tonian can be given in terms of Pauli matrices acting on states expressed in the pseudo-spin basis. The symmetries of the initial Hamiltonian H restrict to a large degree the form of the low energy expansion. For exam ple, the conservation of the atom number of each species corresponds, in the spin basis, to the conservation of the total z-spin. Hence, any rotation on the xy-spin plane leaves the Ham iltonian invariant. This fact lim its the possible spin operators that can contribute to the e ective low energy interactions. Possible terms of the effective H am iltonian are given by f $_{j}^{z}$ g for the one-body interaction, f $\stackrel{z}{j} \stackrel{z}{j+1}$; $\stackrel{x}{j} \stackrel{x}{j+1}$ + $\stackrel{y}{j} \stackrel{y}{j+1}$ g for the two body interaction or f $\stackrel{z}{j} \stackrel{z}{j+1}$; $\stackrel{x}{j+2}$; ($\stackrel{x}{j} \stackrel{x}{j+1}$ + $\stackrel{y}{j} \stackrel{y}{j+1}$) $\stackrel{z}{j+2}$ g for the three-body interactions where 4 = 1, (see Fig. 1). As we can easily verify, the three-spin operators break parity symmetry, which is explicitly given by the transform ation "\$ #. This indicates that their coupling coe cient should also be asymmetric with respect to this transform ation, as the original atom ic system possesses this symmetry. Indeed, in the next section we shall see how these terms are generated in the optical lattice setup.

A nother in portant insight for the ground states of the presented H am iltonians comes from the geometry of the lattice. In the case considered here, the triangular pattern allows for the generation of exotic ground states due to frustration, that is ground states that are not m inim ising the energy of the individual H am iltonians of each link of the triangle. This e ectively allows for the presence of multiple degeneracy in the ground state of the system as we shall see in particular examples.

III. THE EFFECTIVE THREE-SPIN IN TERACTIONS

A. The bosonic model

Consider the low energy evolution of the triangular system given in Fig. 1 of three atoms in three sites of the lattice without the application of any external eld. D i erent rates in the tunneling parameter can then be achieved by tuning the intensities of the laser eld corresponding to the di erent directions of the triangle. By applying the perturbative expansion (2.3) up to the third order we obtain that the system can electively be described by




FIG. 2: The e ective couplings (a) ⁽¹⁾, (b) ⁽²⁾, (c) ⁽³⁾ and (d) ⁽⁴⁾ as functions of the tunneling couplings $J^{"}=U$ and $J^{\#}=U$, where we have set the tunneling couplings to be $J_1 = J_2 = J_3$ and the collisional couplings to be $U_{""} = U_{"\#} = U_{\#\#} = U$. All the parameters are normalised with respect to U.

where j is the Paulimatrix with the usual commutation properties $[j;_k] = 2i$ $!_{jk} \frac{1}{j}$. The three-spin interactions presented in the last line can be viewed as the two spin interactions of the second line controlled by the third spin (being spin up or down) through an additional ^z operator. The couplings, A, B, and ⁽ⁱ⁾, are given as expansions in J = U \circ by

where the symbol ("\$ #) denotes the repeating of the same term as on its left, but with the " and # indices interchanged. The A term contributes to an overall phase factor in the time evolution of the system and can be ignored. The B term can easily be $\operatorname{elim}_{pinated}$ and an arbitrary magnetic eld term of the form $_{j}B' \sim \operatorname{can}$ be added by applying a R am an transition with the appropriate laser elds. The behaviour of the ective couplings

as functions of the tunneling and collisional couplings is given in Fig. 2.




FIG. 3: The elective couplings ⁽¹⁾ and ⁽³⁾ are plotted against J["]=U and J[#]=U for U_{""} = U_{##} = 2:12U and U_{"#} = U. The coupling ⁽¹⁾ appears almost constant and zero as the unequal collisional terms can create a plateau area for a sm all range of the tunneling couplings, while ⁽³⁾ can be varied freely to positive or negative values.

O ne can isolate di erent parts of H am iltonian (3.1), each one including a three-spin interaction term, by varying the tunneling and/or the collisional couplings appropriately so that particular terms in (3.1) vanish, while others are freely varied. An example of this can be seen in Fig. 3 where the couplings ⁽¹⁾ and ⁽³⁾ are depicted. There, for the special choice of the collisional terms, $U_{""} = U_{\#\#} = 2.12U_{"\#}$, the ⁽¹⁾ coupling is kept to zero for a wide range of the tunneling couplings, while the threespin coupling, ⁽³⁾, can take any arbitrary value. O ne can also suppress the exchange interactions by keeping one of the two tunneling couplings zero w ithout a ecting the freedom in obtaining arbitrary positive or negative values for ⁽³⁾ as seen in Fig. 3.

Hence, the one dimensional Ham iltonian of the form

can be simulated in the optical lattice where all of its couplings can be arbitrarily and independently varied. The three-spin interaction term of this H am iltonian possesses fourfold degeneracy in its ground state, spanned by the states fj"""i;j"##i;j##"ig. The criticality behaviour of this m odel has been extensively studied in the past [21, 28], where it is shown to present rst and second order phase transitions. In particular, for $B_z = 0$

its self dual character can be demonstrated [25, 26]. To explicitly show that let us de ne the dual operators

that also satisfy the usual Pauli spin algebra. We can re-express the Ham iltonian H (B_x ;0) with respect to the dual operators obtaining nally

This equation of self duality indicates that if there is one critical point then it should be at $\beta_x j = 1$ as has also been veri ed num erically. Furtherm ore, the two spin interactions $\int_{j}^{z} \int_{j+1}^{z} has a degeneracy with a Z_2 symmetry while <math>\int_{j}^{z} \int_{j+1}^{z} \int_{j+2}^{z} has a three fold degeneracy leading to a Z_3 symmetry. By varying the corresponding couplings of the electric H am iltonian it is possible to induce transitions to and from the Z_2 and Z_3 ordered phases in a similar fashion as has been theoretically demonstrated in [13].$

B. The ferm ionic m odel

A lternatively, one can consider the case of ferm ionic atom s and derive the e ective interactions they induce up to the third order. Compared to the couplings in the bosonic case we now have $U_{*\#} = U$ being the only one that is present. The Pauli exclusion principle can be signalled by having $U_{**}; U_{\#\#}$! 1 that eventually forbids two ferm ionic atom s of the same species from occupying the same site. Keeping term s up to the third order in $J_i = U$ and employing the anticom mutation relations (2.2)

where the e ective couplings are a function of the initial variables of the H am iltonian (2.1) and




FIG. 4: The e ective couplings (a) $^{(1)}$, (b) $^{(2)}$, (c) $^{(3)}$ and (d) $^{(4)}$ as functions of the tunneling couplings J"=U and J[#]=U, where we have set the tunneling couplings to be $J_1 = J_2 = J_3$.

The dependence of the coupling term s on the param eters of the initial H am iltonian is simpler than in the bosonic case. Nevertheless, they can express a similar behaviour as can been seen in Fig. 4.

If the tunneling constants do not depend on the pseudospin orientation then any three spin interaction vanishes. N evertheless, when the tunneling am plitudes depend on the spin and by having just one of the orientation with non-zero tunneling, then just the diagonal two- and three-spin interactions remain.

IV. RAMAN ACTIVATED TUNNELINGS

A number of variations of the previous Ham iltonians are possible by employing techniques available from quantum optics [4, 7]. An interesting example involves the application of R am an transitions during the tunneling process. These transitions involve the direct coupling of the two atom ic states " and #. Consequently they are not atom -num ber preserving for each of the species.

A. The general case

Let us rst consider the case where the atom s are strongly trapped by an optical lattice as in the previous sections. If the lasers producing the R am an transition are form ing standing waves it is possible to activate tunneling transitions of atom s that simultaneously experience a change in their internal state. A s we shall see in the following the resulting H am iltonian is given by an SU (2) rotation applied to each P aulim atrix of the H am iltonian (3.1).

In particular, we shall consider the case of activating the tunneling with the application of two individual Ram an transitions. These transitions consist of four paired laser beam s L_1 , L_2 and L_1^0 , L_2^0 , each pair having a blue detuning and ⁰, di erent for the two di erent transitions. The phases and am plitudes of the laser beam s can be properly tuned so that the rst Ram an transition allow s the tunneling of the state

with tunneling rate J_+ between two neighbouring sites, while the second one activates the tunneling of the state

by an additional phase di erence of between the lasers L_1^0, L_2^0 , with an elective tunneling rate J . In the above equations denotes the phase di erence between the L_i laser eld, while tan = $j_{2} = _1 j$ where $_i$ are their corresponding R abi frequencies. Hence, the elective tunneling term is given by

Hence, the resulting tunneling H am iltonian can be obtained from the initial one via an SU (2) rotation $V_{\rm c}$ =

 $gV g^y$, where the corresponding tunneling couplings are form ally identied, i.e. $J^+ = J^{"}$ and $J^- = J^{\#}$. Note that the collisional Ham iltonian is not a ected by the Ram an transitions, and hence it is not transform ed under g rotations.

It is easy to derive the elective H am iltonian for this transform ation using the perturbative expansion. Indeed, from expressions (A 3) and (A 4) of the Appendix we straightforwardly obtain the second and third order terms of the H am iltonian H_{e}^{e} that appear after the application of the R am an transition. They are given by an SU (2) rotation that acts on the Paulim atrices of the initial elective H am iltonian. A ctually this statem ent holds in all orders of the perturbation theory and reads in its generality

where n is the order of the perturbation. Note that this useful result holds not only for the rotations, but also for the rotations which, in general, do not commute with the collisional H am iltonian H $^{(0)}$.

B. Rotated anisotropic X Y model

We now show that the above presented R am an transitions can be employed to obtain, for example, the anisotropic XY model. The direction of anisotropy is determined by the phase di erence of the laser elds em – ployed for the R am an transition. In particular consider, as in the previous, three sites of the optical lattice in a equilateral triangular con guration. For simplicity we assume $J_+ = J_- = J_-$ and $U_{**} = U_{**} = U_{**} = U_-$ Then the elective H am iltonian to the third order becomes the rotation

These elective couplings agree with the ones presented in (32). Moreover, by controlling the amplitude of the initial standing waves that trap the atom s in their equilibrium positions it is possible to reactivate the tunnelings

J["] and $J^{\#}$. This has the e ect that the overall H am iltonian is the sum of the two H am iltonians, the rotated one (4.1) and the initial one (3.1).

One can now check that the Ham iltonian (3.1) is invariant under g() rotations. On the other hand, when we add the H am iltonians H_0 and the one from (3.1) we obtain the generalised version of the anisotropic X Y m odel where additional third order terms are present. Hence, by turning on the $J^{"}$ and $J^{\#}$ tunnelings we can obtain the rotated version of the anisotropic X Y model, where the rotation is performed with respect to the z-spin axis by an angle . This approach provides a variety of control parameters (e.g. the angle and the ratio of the couplings of the two added H am iltonians) and, in addition, one can have these variables independent for each of the three directions of the two dimensional optical lattice. Particular settings of these structures have been proved to generate topological phenom ena [7], that support exotic anyonic excitations, useful for the construction of topologicalmemories [35]. In addition, the possibility of varying arbitrarily the control param eters of the above Ham iltonians and, consequently, of their ground states gives us the natural setup to study such phenom ena as geom etrical phases in lattice system s. Exam ples will be presented elsewhere [33].

V. COMPLEX TUNNELING AND TOPOLOGICAL EFFECTS

C onsider the case where we employ complex tunneling couplings [34] in the transitions described above. This can be performed by employing additional characteristics of the atoms like a charge e, an electric moment \sim_{e} or a magnetic moment \sim_{m} , and external electrom agnetic elds. A sthe external elds can break time reversalsymmetry, new term softhe form f $_{j}^{x}$ $_{j+1}^{y}$ $_{j+2}^{z}$ $_{j}^{y}$ $_{j+1}^{z}$ $_{j+2}^{y}$ appear in the elds with the external eld can be given in general by substituting its momentum by

where \mathbf{E} is the electric eld and \mathbf{A} is the vector potential. All of these terms satisfy the G auss gauge if we dem and that $\tilde{r} = 0$ and $\mathbf{E}(\mathbf{r}) / \mathbf{r} = \mathbf{r}^3$, hence they can generate a possible phase factor for the tunneling couplings.

The rst term results in the well known A haronov-Bohm e ect [36], while the second one is the origin of the A haronov-C asher e ect [37]. The rst one requires that the atom s involved are charged, which is not possible to achieve in the optical lattice setup. On the other hand it is plausible to consider the electric or m agnetic m om ents of the atom s. Nevertheless the A haronov-C asher e ect requires that the m agnetic m om ent of the atom m oves in the eld of a straight hom ogeneously charged line, the latter being technologically di cult to im plem ent. Though, resent experim ents have been perform ed that generalise the Aharonov-Casher e ect partly overcom ing the technological obstacles [38]. The third case involves the cyclic m ove of an electric m om ent through a gradient of a m agnetic eld nally contributing the phase

to the initial state, where S is the surface enclosed by the cyclic path of the electric m on ent. For example, if $\sim_{\rm e}$ is perpendicular to the surface S, taken to lie on the x-y plane then a non-zero phase, , is produced if there is a non-vanishing gradient of the magnetic eld along the z direction. A lternatively, if $\sim_{\rm e}$ is along the surface plane, then a non-zero phase is produced if the z com ponent of the magnetic eld has a non-vanishing gradient along the direction of $\sim_{\rm e}$. Hence, it is possible to generate a phase factor contribution to the tunneling couplings $J=e^i\ jJj$ with

Here x_i and x_{i+1} denote the positions of the lattice sites connected by the tunneling coupling J.

In order to isolate the new terms that appear in the case of complex tunneling couplings we should restrict to purely imaginary ones, i.e. $J_j = ijI_j j$. Then the elective Hamiltonian (2.3) becomes

By taking $U_{*\#}$! 1, $U_{**} = U_{\#\#} = U, J' = J$ and $J^{\#} = J$, one can set, in the bosonic case, with the aid of Feshbach resonances and compensating Zeem an terms, all the couplings to be zero apart from ⁽⁴⁾. Hence, the e ective H am iltonian reduces to

Remarkably, with this physical proposal, the interaction term (5.2) can be isolated, especially from the Zeem an terms that are predom inant in equivalent solid state in plementations. This interaction term is also known in the literature as the chirality operator [30]. It breaks time reversal sym – metry of the system, a consequence of the externally applied eld, by e ectively splitting the degeneracy of the ground state into two orthogonal sectors, nam ely \+ " and \ ", related by time reversal, T. These sectors are uniquely described by the eigenstates of H_e at the sites of one triangle. The low est energy sector with eigenenergy E₊ = $2\frac{3}{3}$ ⁽⁴⁾ is given by

The excited sector, j $_{1=2}i$, represents counter propagation with eigenvalue $E = 2 \frac{p}{3}^{(4)}$ and it is obtained from (5.3) by complex conjugation [30, 39, 40]. We would like to point out that, to the best of our know ledge, this is the rst physical proposal where this interaction term can be isolated, especially from the Zeem an term s that are predom inant in equivalent solid state in plem entations. A lternative models employing cold atom technology for the generation of topologically non-trivial ground states are given in [7, 41].

VI. ONE-AND TW O-DIMENSIONAL MODELS

It is also possible to employ the three-spin interactions that we studied extensively in the previous sections for the construction of extended one and two dimensional systems. The two dimensional generalisation is rather straightforward as the triangular system we considered is already de ned on the plane. Hence, all the interactions considered so far can be generalised for the case of a two dimensional lattice where the summation runs through all the lattice sites with each site having six neighbours.




FIG. 5: The one dimensional chain constructed out of equilateral triangles. Each triangle experiences the three-spin interactions presented in the previous.

The construction of the one dimensional model is more involving. In particular, we now consider a whole chain of triangles in a zig-zag one dimensional pattern as shown in Fig. 5. In principle this con guration can extend our model from the triangle to a chain. Nevertheless, a careful consideration of the two spin interactions shows that terms of the form $\begin{bmatrix} z \\ i \end{bmatrix}_{i+2}^{z}$ appear in the elective H am iltonian, due to the triangular setting (see Fig. 5). Such

H am iltonian term s involving nearest and next-to-nearest neighbour interactions are of interest in their own right [12, 13] but will not be address here. It is also possible to introduce a longitudinal optical lattice with half of the initial wavelength, and an appropriate am plitude such that it cancels exactly those interactions generating, nally, chains with only neighbouring couplings.

In a similar fashion it is possible to avoid generation of terms of the form $\begin{array}{c} x & x \\ i & i+2 \end{array} + \begin{array}{c} y & y \\ i & i+2 \end{array}$ by deactivating the longitudinal tunneling coupling in one of the modes, e.g. the "mode, which deactivates the corresponding exchange interaction.

As we are particularly interested in three-spin inperactions we would like to isolate the chain term $\frac{1}{i} \begin{pmatrix} x & z & x \\ i & i+1 & i+2 \end{pmatrix} + \begin{pmatrix} y & z & y \\ i & i+1 & i+2 \end{pmatrix}$ from the ⁽⁴⁾ term of Ham iltonian (3.1). This term includes, in addition, all the possible triangular permutations. To achieve that we could deactivate the non-longitudinal tunneling for one of the two m odes, e.g. the one that traps the " atoms. The interaction $\begin{bmatrix} z & z & z \\ i & i+1 & i+2 \end{bmatrix}$ is hom ogeneous, hence it does not pose such problem when it is extended to the one dimensional ladder. W ith the above procedures we can nally obtain a chain Ham iltonian as in (3.1) where the sum m ation runs up to the total number N of the sites.

VII. CONCLUSIONS

In this paper we presented a variety of di erent spin interactions that can be generated by a system of ultracold atom s superposed by optical lattices and initiated in the M ott insulator phase. In particular, we have been interested in the simulation and study of various threespin interactions conveniently obtained in a lattice with equilateral triangular structure. They appear by a perturbation expansion to the third order with respect to the tunneling transitions of the atom s when the dom inant interaction is the collisions of atom s within the same site. Am ong the m odels presented here we speci cally considered the $\begin{bmatrix} z & z \\ i+1 & z \end{bmatrix}$ interaction, a third order generalisation of the rotated inhom ogeneous X Y m odel, as well as interactions that explicitly break chiral sym m etry. These m odels can exhibit degeneracy in their ground states and undergo a variety of quantum phase transitions that can also be viewed as phases of the initial M ott insulator.

It is possible to employ quantum simulation techniques [31], in a similar fashion as for two spin Hamiltonians, to generate e ective three-spin interactions that are not possible to obtain straightforwardly from the optical lattice system. Hence, a variety of additional Hamiltonians can be obtained by considering manipulations of the above three-spin interactions with the application of appropriate instantaneous one or two spin transform ations. The possibility to externally control most of the param eters of the e ective H am iltonians at will reenters our model as a unique laboratory to study the relationship am ong exotic system s such as chiral spin system s, fractional quantum Hall system s or system s that exhibit high-T_c superconductivity [29, 30]. In addition, suitable applications have been presented within the realm of quantum computation [32] where three-qubit gates can be straightforwardly generated from the three-spin interactions. Furtherm ore, unique properties related with the criticality behaviour of the chain with three-spin interactions has been analysed in [14] where the two-point correlations, used traditionally to describe the criticality of a chain, seem to fail to identify long quantum correlations, suitably expressed by particular entanglem ent m easures [42].

In conclusion, we have presented a physicalm odel that can e ciently simulate a variety of three-spin interactions. The employed optical lattice techniques give the possibility to externally manipulate and control the couplings of the interactions. The e ect of these terms will eventually be signi cant with the improvement of the experimental techniques. Importantly, the three-spin interactions can be isolated from two-spin ones or from possible Zeem an terms that are always present in the corresponding spin systems. This makes the further study of their properties an important task for future work.

APPENDIX A: PERTURBATION THEORY

Consider the case of two species of atoms trapped in optical potentials forming a triangular conguration subject to the H am iltonian given by (2.1). For simplicity dene the diagonal free H am iltonian to be given by H $_{ii}^{(0)} = E_{i \ ij}$, where E_i is either zero or proportional to U_{aa} , U_{bb} or U_{ab} . As we have already mentioned we consider the case where tunneling couplings are much smaller than the collisional ones J U. Then the evolution of the system is dom inated by the term H ⁽⁰⁾. In fact, when we start from a conguration of one atom per lattice site, denoted by the subspace M of congurations, and activate small tunneling couplings, the change of atom number per site would be energetically unfavourable and is hence adiabatically eliminated.

To see this analytically we employ the interaction picture with respect to the H am iltonian H $^{(0)}$ obtaining

H igher orders are negligible as long as times t are considered for which Jt remains su ciently small, while Ut is large enough to avoid the accumulation of population outside the subspace M. W ith the form ulae (A 3) and (A 4) one can perform the perturbation up to the third order and nd the desired three-spin interactions (2.3). In practise the evaluation of the terms that contribute to the three-spin H am iltonian is quite simple. The states corresponding to and include sites with two or three atoms of the same or of di erent species. The tunneling couplings J are determ ined by each of these transitions and an appropriate coe cient is obtained in the case of the bosonic generation or annihilation of two

As an alternative procedure it is possible to eliminate the fast oscillating term without performing the perturbative expansion. This elimination is related with the adiabatic elimination of the states with two or more atom sper lattice site that are separated from the states with one atom per lattice site (con gurations in M) by a large energy gap proportional to U $_{\circ}$. It is easy to verify that the elements of H with indexes $(i_k j_k)$ corresponding to states that do not belong to M include fast rotating phases and, hence, they are zero, i.e. for those states $c_{j_k}^{i_k} = 0$. This provides a set of linear equations of the form $P_{i_k^0, j_k^0} H_{i_k \hat{j}_k \hat{j}_k}^{i_k, j_k} c_{j_k^0}^{i_k^0} = 0$ that can be solved, in principle, explicitly. In our case, Eqn. (B1) has overall 56 equations

resulting from the Schrodinger equation with 48 reduced to a linear system of coupled algebraic equations. This set can be solved by a computer and then expanded in term s of sm all couplings J U obtaining an alternative veri cation of the previous perturbative expansion.
