## G eneralized P seudopotentials for H igher Partial W ave Scattering

W e derive a generalized zero-range pseudopotential applicable to all partial wave solutions to the Schrodinger equation based on a delta-shell potential in the lim it that the shell radius approaches zero. This properly models all higher order multipole moments not accounted for with a monopolar delta function at the origin, as used in the familiar Ferm i pseudopotential for s-wave scattering. By making the strength of the potential energy dependent, we derive self-consistent solutions for the entire energy spectrum of the realistic potential. We apply this to study two particles in an isotropic harm onic trap, interacting through a central potential, and derive analytic expressions for the energy eigenstates and eigenvalues.

The rst step in studying the complex physics of a many-body system is modeling the fundamental twobody interactions. At low energies and for central potentials, a partial wave expansion reduces the complexity. Near zero temperature, s-wave scattering typically dom inates and the true interaction potential can be modeled by a contact interaction via the Ferm i pseudopotential, parameterized by the s-wave scattering length [1]. Such a description provides a highly accurate model of the behavior of quantum degenerate gases [2]. For energies outside the W igner-threshold regime, the Ferm i pseudopotential can be generalized to include an energy-dependent scattering length so that the mean-eld and trap energylevel shifts can be calculated in a self-consistent manner [3].

Further generalizations are necessary when higher order partial waves contribute to the interaction. In this Letter we derive an energy-dependent pseudopotential applicable to 1 > 0 scattering that captures the critical features of both the free and bound-state spectrum of the realistic interaction potential. We apply this to exactly solve the Schrodinger equation for two particles trapped in a harm onic well, interacting through a central potential, som ething typically done only in perturbation theory. An example in which higher partial wave scattering of trapped particles plays an important role is in the physics of degenerate gases of identical ferm ions where the s-wave scattering cross section vanishes [4]. Moreover, even for bosons, these higher 1 waves can be resonantly coupled to the dom inant l = 0 scattering due to noncentral forces [5] such as the dipolar spin-spin interaction [6], second order spin-orbit interaction [7], and/or the forces of an anisotropic trapping potential [8, 9]. An example of the latter is the interaction between two atom s, each trapped in a separate harm onic well, leading to an axially symmetric potential for the relative coordinate. In previous work, we discovered a new \trap induced shape resonance" whereby molecular bound states are shifted into resonance with trap vibrational levels due

to the trap's potential energy [10]. Such a resonance can have an 1-wave symmetry, and can be modeled by our generalized pseudopotential.

The rst attempt to derive a generalized pseudopotential was made by K.Huang and C.N.Yang [11, 12]. G iven a central force, the true asymptotic wave function for each 1 wave was supposed to follow from a contact potential,

where  $a_1$  is the elective scattering length generalized to higher partial waves. Recently Roth and Feldm eier [13] uncovered di culties with this pseudopotential noting that the mean-eld energy shift of interacting fermions in a trap is incorrect by a factor of (l+1)=(2l+1). They proposed that a distinct elective contact interaction is needed to calculate energy level shifts in perturbation theory and that the H uang and Y ang pseudopotential is sim ply not a propere ective interaction to use in a mean-

eld description of dilute quantum gases [13]. We show here that this distinction is unnecessary. Rather, the disagreem ent is due to a fundam ental problem in Huang's original derivation of the pseudopotential [12]. Huang and Yang incorrectly map the higher order multipoles associated with 1> 0 onto a monopolar function at the origin. We correct this by employing a -shellpotential in the lim it as the shell radius approaches zero. In this lim it our pseudopotential approaches H uang's original pseudopotential, but with the correct prefactors thereby giving both the correct matrix elements and eigenfunctions. O ur approach also corrects a di erent form ulation of the contact interaction which is used offen in the description of Rydberg atom collisions [14].

In the contact potential construction, one takes the asymptotic radial wave function associated with a given partial wave  $R_1(r) = A_1 [j_1(kr) \tan_1(k)n_1(kr)]$ , valid only outside the range of the true potential, and extends it to all r. The boundary condition at the origin is set

by the zero-range potential, param eterized by the 1-wave asymptotic phase shift  $_1(k)$ . Here we assume that the realistic potential has a nite range, valid when it falls o like  $1=r^3$  or faster. The scattering phase shift can be calculated directly via numerical or analytic solution to the Schrodinger equation or may be obtained through spectroscopic data. In order to treat the multipole singularity of the potential at the origin correctly, we write the pseudopotential as the limit of a shell with its radius approaching zero,

where the operator  $\hat{O}$  (r) contains the correct prefactors and regularization. To derive the correct form of  $\hat{O}$  (r) we solve the radial Schrodinger equation. The fam iliar inside and outside solutions expressed in sphericalBessel and Neum ann functions are

where we have used the asymptotic forms of the Bessel functions in the limit ks 1. Integrating the radial equation over the function gives us a second boundary condition. Again taking s 1=k, and using Eq.(5),

 $\mathbbm W$  ith the reduced  $\mathbbm ass$  and  $\sim$  scaled to one, the pseudopotential is then

C om paring this to the original H uang and Y ang pseudopotential we see that they di erby a factor (l+1)=(2l+1). This occurs because the original derivation ignores the inside wave function contribution of weight + 1 in Eq.(7). The -shell potential approach circum vents the singularity at the origin, allowing one to correctly capture higher multipoles. Furtherm ore, the -shell potential also enforces the correct ordering of limits, taking

s ! 0 as the nalstep. W ith this correction, we reproduce the perturbative mean-eld energy level shift found by R oth and Feldmeier [13] with a mathematically rigorous contact potential that also yields the correct asymptotic eigenfunctions.

In the above form, the -shell potential is not Herm mitian as the derivative acts solely to the right. The regularization we choose is necessary in order to extend the dom ain of the corresponding H am iltonian to irregular functions that diverge as  $1=r^{l+1}$  when r ! 0. A lthough this does not cause a problem in most applications, in general one must be cautious. In order to make the potential H erm itian on the whole dom ain, including both regular and irregular functions, an additional regularization operator  $r^{l}=(2l+1)!$  ( $(2^{l+1}=(2r^{l+1}r^{l+1}))$  can be added that acts to the left as projector onto the regular function subspace. Such dual regularization is cum – bersom e and so we generally choose to work with only a single regularization operator.

Our form of the -shell potential depends on the energy-dependent phase shift  $_1(k)$  which can usually be approximated in the W igner-threshold regime by a constant scattering length. We not it more useful here, how - ever, to de ne a fully energy-dependent 1-wave scattering length that captures not only corrections due to the effective range, but all higher order terms,

As in previously studied s-wave case [3], the general 1wave -shell potential in our derivation exactly reproduces the correct energy-dependent scattering phase shift  $_1(k)$  that arises from the true potential and therefore exactly reproduces the correct asymptotic wave functions for all partial waves at all energies. In fact, using an energy-dependent scattering length for higher partial wave scattering has added bene ts since the W ignerthreshold law may not hold for all 1, leading to strong energy dependence of the scattering length Eq.(10) near zero energy. For example, for power law potentials of the form  $C_n = r^n$  with 1 > n = 2, the phase shift is not proportional to  $k^{2l+1}$  but instead behaves as  $k^n$  [15]. A lthough the generalized scattering length at low energies is not constant, the full energy-dependent solution will hold. A generalbreakdown of the pseudopotential approximation only occurs in cases where the realistic potential does not have a nite range and an outside wave function cannot be de ned as in Eq.(3).

For two interacting particles in a trap, one solves for the discrete eigenvalues of the energy-dependent H am iltonian derived from an energy-dependent pseudopotential using a self-consistent procedure [3]. To this end, the eigenspectrum of the system is rst calculated as a function of a constant scattering length, giving E (a). Then the e ective scattering length is calculated as a function of kinetic energy  $E_K$  for untrapped scattering states of the interaction potential, yielding a (E). Simultaneous solutions are then found numerically. This two step procedure allows one to accurately determ ine the exact shift to the energy levels in the trap due to atom ic interactions when the interaction range and width of the trap wave functions are orders of magnitude di erent, as is typically the case.

For negative energies, k = i is purely in aginary and one m ust analytically continue the scattering length,

Similar to the s-wave case [10], this analytic continuation allows us to calculate both the shift in the energy spectrum of the trap eigenstates (positive energies) and the bound states of the interaction potential (negative energies). Consider the radial wave function for negative energies,

expressed in terms of the spherical Hankel functions of the rst and second kind  $h_1^{(1;2)}$ . Strictly speaking this solution is only allowed for a norm alizable wave functions; the true bound states of the -shell potential. These occur when  $tanh [i_1(i_1)] = 1$  since then the coe cient of the exponentially increasing  $h_1^{(2)}$  vanishes. At these energies,  $a_1 = 1 = .$  The -function bound states are thus located at E =  $(\sim)^2 = (2) = \sim^2 = (2 a_1^2)$ , just as in the s-wave case. The condition for a -function bound state,  $tanh [i_1(i_1)] = 1$ , is fullled only when the phase shift has a pole on the imaginary axis,  $_1(i) =$ i1 . This occurs at each of the negative energies at which the S-m atrix of the true interaction potential has a pole, i.e., at the energies of each of its bound states. The generalized 1-w ave pseudopotential with an energy-dependent scattering length thus provides an accurate description of the entire energy spectrum of the true interaction potential, bound and scattering, even for 1-w ave scattering lengths with strong energy dependence, i.e. outside the W igner-threshold law regime.

Our -shellapproach o ers a direct m ethod for obtaining analytic solutions to a scattering problem by simply m atching boundary conditions across the shell as we now demonstrate by employing the energy-dependent shell to nd all partial wave solutions to the Schrödinger equation for two particles in an isotropic harm onic trap interacting through a central potential. This is of particular interest for application to degenerate quantum gases, e.g. two interacting identical ferm ions. In the following, all distances are scaled to characteristic harm onic oscillator length  $z_0 = \sum_{\alpha=0}^{\infty} (1)^{\alpha}$ . A fter separating out the center of m ass motion, we make the Ansatz  $R_1(r) = r^{1}exp(r^2=2)w_1(r)$  for the relative coordinate radial wave function inside and and outside the shell. The radial equation including the scaled trapping potential  $r^2=2$  then reduces to the K ummer di erential equation, [16]  $zw^{(0)}(z) + (b z)w^{(0)}(z)$  aw (z) = 0, in the regions where the interaction potential is zero. Independent solutions of this equation are the con uent hypergeom etric functions, U (a;b;z) and M (a;b;z), where  $z = r^2$ , a =

and b= l+ 3=2. The inside solution m ust be proportional to  $r^{l}exp(\hat{r}^{2}=2)M(\hat{r}^{1}+3=2;\hat{r}^{2})$  which behaves regularly as  $r^{l}$  around the origin, whereas the outside solution m ust be proportional to  $r^{l}exp(\hat{r}^{2}=2)U(\hat{r}^{1}+3=2;\hat{r}^{2})$  which falls of exponentially for large r. The inside and outside solutions are then

W e again require continuity of the wave function at r = s. In the lim it ks 1,

where  $C_1$  (1) (1+ 3=2) (1 1=2)= and  $A_1^2 = A_1=C_1$ . Integrating the radial equation over the function gives us again a second boundary condition. Taking s 1=k and using Eq.(15), the derivatives of the outside and inside radial solutions are

Applying the operator  $\hat{O}$  (r) (8) to (14) for sm all s

and inserting Eq.(16) and (17) into (6) we arrive at the implicit eigenvalue equation,

This is the general eigenvalue equation for the 1-partial wave interaction that must be solved self-consistently for the energy-dependent  $a_1$  as described above. For l = 0 this reduces to the known swave eigenvalue equation [17]. The corresponding wave functions are the inside and outside wave functions noted above, where the ratio  $B_1=A_1^0$  is xed by Eq.(15). For nite shell radius these wave functions are in principle num erically normalizable unlike solutions obtained with a potential at the origin where the unnormalizable solutions diverge as r<sup>(l+1)</sup> for r! 0.

In order to verify the accuracy of the higher partial wave energy spectrum we choose a spherically symmetric step potential well with range d and depth  $V_0$  as a




FIG.1: (a) Step-well test interaction potential with range  $d = 0.4z_0$  and depth  $V_0 = 34.95$ ~! in a harm onic trap, l = 1 eigenstates (dotted lines) and corresponding reduced wave function (solid line). The -shell solution in the limit of the shell radius s ! 0 (dashed line) coincides with the actual eigenstates outside the range d. (b)-(d) C om parison between exact eigenvalues (solid lines) of the step-well interaction plus harm onic trap and pseudopotential eigenvalues (crosses) as a function of the range of the well potential and for l = 0;1;2 states. The unshifted interaction bound states ( xed at E  $_{\rm b} =$

test [see Fig. 1 (a)]. Figures 1 (b)-1 (d) show a comparison of the exact eigenspectra and the -shell approximation for wells with dierent nite range d. In particular, we chose a well with an 1-wave bound state close to dissociation to emphasize the accuracy of the approximation even in the regime of strongly energy-dependent scattering lengths al where the W igner-threshold law does not hold. We nd good agreem ent for relatively large ranges d of the well test potential as shown in Fig.1. The breakdown of the pseudopotential approximation at larger ranges is due to the modi cation of the interaction potential over its nite range by the harm onic trap. One can estimate the di erence between the energy shift with and without this modi cation for the interaction bound states in storder perturbation theory,  $E = h_{\text{shell}} \dot{\mathbf{y}}^2 = 2j_{\text{shell}} \dot{\mathbf{h}}_{\text{well}} \dot{\mathbf{y}}^2 = 2j_{\text{well}} \dot{\mathbf{h}}.$  Here well is the exact bound state associated with the step-well potential bound state and shell is the bound state wave function of the -function bound state. For l = 1 and 1= 2 these two wave functions di er more substantially than for s-waves, resulting in a bigger deviation of the pseudopotential approximation as the range d becomes large [Figs. 1(b)-(d)]. In the case of ultracold collisions the energy-dependent pseudopotential will therefore be a good approxim ation as long as the characteristic interaction length scale of the van der W aals interaction is much

sm aller that the characteristic length scale of the trap  $z_0$  [3].

In sum m ary, we have derived a generalized zero-range pseudopotential for higher partial wave interactions that captures both the scattering solutions and bound-state spectrum self-consistently. By employing a limiting procedure on a nite radius -shell potential, we provided a rigorous correction to the long standing error in Huang's and Yang's pseudopotential. The pseudopotential o ers a direct method to analytically solve the Schrodinger equation, as demonstrated for the case of interacting trapped atom s, where we derived the higher partial wave energy spectrum and obtained normalizable eigenfunctions. This is of special interest for degenerate gases of identical ferm ions where l = 1 scattering is the primary contribution to the interaction and also for Bose system s where noncentral forces play an important role. Our accurate modeling of the interaction and the analytical calculation of the eigenenergies should provide new avenues for studying degenerate gases of interacting ultracold atoms in tightly con ning traps [2], such as in optical lattices [18]. Beyond its application to manybody problem s the -shell pseudopotential is also useful for modeling controlled collisions, which could play an in portant role in quantum information processing.

A fler com pleting this paper, we learned of recent theoretical work by K an jilal and B lum e [9] in which the l = 1special case of Eq.(18) has been derived and applied to 1D and 3D con ned ferm ions, and of work by Peach et al. [19] in which Eq.(18) has been derived using a quantum – defect theory approach.
