M odulational instability of two-component Bose-E instein condensates in an optical lattice

We study modulational instability of two-component Bose-Einstein condensates in an optical lattice, which is modelled as a coupled discrete nonlinear Schrödinger equation. The excitation spectrum and the modulational instability condition of the total system are presented analytically. In the long-wavelength limit, our results agree with the hom ogeneous two-component Bose-Einstein condensates case. The discreteness e ects result in the appearance of the modulational instability for the condensates in miscible region. The numerical calculations con mour analytical results and show that the interspecies coupling can transfer the instability from one component to another. PACS numbers: 05.45.-a, 03.75 Lm

I. IN TRODUCTION

The modulational instability (M I) is a general phenomenon in nonlinear wave equations and can occur in various physical systems, such as uid dynamics, plasma physics, and nonlinear optics. Due to the interplay between nonlinearity and the dispersive e ects, a weak perturbation on a plane wave may induce an exponential growth, and result in the carrier wave break up into a train of localized waves [1]. Recently, the M I of Bose-E instein condensates (BEC) has attracted much interest, especially for the single-component BEC in an optical lattice [2,3]. In the super uid regime, the BEC in an optical lattice can be modeled by a discrete nonlinear Schrodinger equation [4,5]. Following Ref. [6], the M I of a BEC in a deep optical lattice has been studied both theoretically [7{10} and experimentally [11,12].

C om pared with the single-com ponent BEC system, binary mixtures of BEC s have much richer structures [13]. In fact, the excitation spectrum of a homogenous two-component BEC s has been studied in Refs. [14{16]. It was shown that the MI depends strongly on the sign of ${}^2_{12}$ 1 2, where 12 is the interspecies interaction strength, 1 and 2 are the intraspecies scattering strengthes, respectively. In Ref. [17], the MI of the two-component BEC s in a deep optical lattice was studied with a Josephson-like coupling term. How ever, their works were limited on a xed perturbation wave num ber (i.e., q =). In addition, they did not compare their results with that of the hom ogenous two-component BEC s case [14{16].

In this paper, we study the M I of two-com ponent BECs in an optical lattice. The explicit expression of the excitation spectrum is presented analytically. In order to outline the e ects of the discreteness, we com pare the M I condition of the m odulated plane waves with that of the hom ogenous two-com ponent BECs case, in which the M I can occur only for $\frac{2}{12} > 1 + 2$, i.e., the BECs in phase separation region [14{16]. Our results show that, the M I of the two com ponent BECs in an optical lattice depends not only on the sign of $\frac{2}{12} = 1 + 2$, but also on the wave

num ber k of the carrier waves. For $\frac{2}{12} < \frac{1}{2}$, the M I of the m iscible condensates can also take place when the condensates have relatively large wave num ber k > =2. The e ect of the interspecies coupling is investigated by num erical calculations. Our results show that the coupling between the two condensates can transfer the instability from one component to another.

II. THEORETICAL MODEL

We consider a cloud of BEC atom s which have two internal states labeled by jli and j2i in an optical lattice. When the heights of the interwell barriers are much higher than the chemical potentials, the condensate wave functions can be expressed as a sum of wave functions localized in each well of the periodic potential $(r;t) = N_{j}$; (t) (r_{j}) , where N is the total number of condensate atom s, and (r_{j}) is the spatial wave function localized in the jth site. W ith the help of the tight-binding approximation [4], the probability am plitudes j; obey a set of coupled DNLS equations (h = 1):

where K and \circ with = 1;2 describe the nearestneighbor hopping term and the on-site atom ic collisions, respectively. The stationary solutions of the DNLS equations (1) are plane waves $_{j;} = {}^{(0)}e^{i(kj)}t^{(j)}$ with the chem ical potentials of the two-component condensed atom s

Here, the chemical potentials P_{j} are to be determined by the normalization condition j_{j} ; j_{j} ; $j_{j} = 1$. The terms 2K cos(k) in Eq. (2) are the kinetic energies aroused from tunnelling. It should be noted that, we study the BECs system in the super uid regime with (N = M)K; (M) is the lattice number), and thus the dynamics can be well described by the DNLS equations.

The excitation spectrum can be obtained by the stability analysis of the plane waves. We introduce small perturbations to the carrier wave as: $_{j;}$ =

phonon m odes are taken in the traditional form $_{j;} = u e^{i(qj \ ! t)} + v e^{i(qj \ ! t)}$, with the constants u and v to be determ ined. Then we obtain the excitation spectra as

In the above derivations, we have assumed ⁽⁰⁾ to be real, and taken $K_1 = K_2 = K$, then $q_{i1} = q_{i2} =$ 4K $\cos(k) \sin^2(q=2)$ [18]. In the absence of the interspecies interactions ($_{12} = 0$), $= 2 \frac{1}{1} (\frac{_{(0)}}{_1})^2$ or $2_{2} \left(\frac{2}{2} \right)^{2}$. The two-component BECs are fully decoupled, and the spectra are the sam e with single-com ponent case [9,18]. According to Refs. [6,8], the plane waves of the condensates are modulationally unstable when the eigenfrequencies becomes in aginary, i.e., q(q+) < 0. In this case, the system undergoes exponential growth with the growth rate determ ined by the imaginary part of $!_{q;}^{()}$. From Eq. (4), we know that: (i) if $\frac{2}{12} < \frac{1}{2}$, i.e., the case of the two components being miscible, both $_1$ and $_2$ are positive; (ii) if $\frac{2}{12} > \frac{1}{2}$, then $_1 < 0$ and $_2 > 0$. W ithin the second scenario, the condensates tend to separate spatially, namely the phenomena of phase separation [19,20]. The sign of ($\frac{2}{12}$ 1 2) is of crucial in portant in discussing the stability of the eigenm odes.

III. M O D U LAT IO N A L IN STABILITY

In this section, we study the modulational instability by using Eq. (3). To understand the elect of the discreteness clearly, we rst study Eq. (3) in the long-wavelength lim \pm [6]. Eq. (3) in the long-wavelength lim \pm , i.e., k ! 0 and q ! 0, is reduced to:

which agrees with the usual expression obtained from continuous NLS equations [14{16] by replacing K q^2 with $q^2=2m$. It was shown that only imm iscible BECs (with ${}^2_{12} > {}_1_2$) exhibit the MI [21].

A. The M I condition for the m iscible BECs

The M I condition for the two-component BECs are determined by the condition: $_q(_q +) < 0$. For the miscible BECs with $_{12}^2 < _1 _2$, the M I occurs for

 $\cos(k) < 0$ and $_{q} + > 0$. For simplicity, we take $\binom{0}{1} = \binom{0}{2} = _{0}$, then $= \binom{2}{0}$, where




FIG.1. Region of the M I in the (q, k) plane for (a) m iscible BEC $_{12} = 0.993$ and $_2 = 1.00298$, (b) im m iscible BEC $_{12} = 0.9709$ and $_2 = 0.9417$. O ther parameters are taken as K = 1, $_1 = = 100$, and $_2^2 = 1 = (2M + 1) < _{0,cr}^2$.

Therefore, the m iscible BECs may exhibits the MI when =2 < k < 3 = 2 and ${}_0^2 > {}_q=$. More specially, both of the two-component with relative large wave number (k > =2) will be unstable for arbitrary q provided that ${}_0^2 > {}_{0;cr}^2 = 4K = {}_1$. Below the critical amplitude, the MI region depends on the perturbation's wave number q. In Fig. 1 (a), we consider the case ${}_0^2 < {}_{0;cr}^2$, where the atom ic collisions are taken as a₁: a₁₂: a₂::1:007:1:1:1:01 [22]. We take ${}_1 = {}$, then ${}_{12} = 0:993$ and ${}_2 = 1:00298$, which satisfy the m iscible criterion. Our results show that there exist three di erent regions in the (q, k) plane. The dotted line in Fig. 1 (a) separates the unstable regime into a fully unstable and a partially unstable, in which one component is stable and the second one is unstable.

B.The M I condition for the BECs in phase separation region

To study the M I of the imm iscible BECs, we take the atom is collisions are taken as $a_1 : a_{12} : a_2 :: 1:03 : 1:0:97$ [23]. Thus we have $a_{12} = 0:9709$ and $a_2 = 0:9417$, which meet the condition $a_{12}^2 > a_{1-2}^2$. Unlike the previous m iscible case, the M I condition considered here depends on the wave number k. We is not that for cosk > 0 (i.e., k < =2 or k > 3 =2), the M I condition is $a_0^2 > a_{q}=j_{1}j$. However, for =2 < k < 3 =2, it becomes $a_0^2 > a_{q}=2$. Since $j_{1}j_{2}^2$, the imm iscible BECs will be unstable in the whole (q, k) plane provided that $a_0^2 > a_{0,cr}^2 = 4K = j_{1}j$. Below the critical am plitude, the M I region in the (q, k) plane is shown in Fig. 1 (b). The M I can take place for any wave number k.

IV . N U M E R IC A L A N A LY S IS

The linear-stability analysis can determ ine the onset of M I, how ever it does not yield any dynam ical inform ation beyond the instability point. Therefore, we perform num erical simulations of the DNLS equations. The initial conditions are two m odulated plane waves

in accordance with our previous discussions. The modulation amplitudes are assumed smallcom pared with the background amplitudes = $0.05A \cdot W = \text{consider the optical lattice with the total number of the sites M = 400.$ From the periodic boundary condition, the wave numbers take the form of k = 2 I=M and q = 2 s=M, where we choose the unit lattice constant.

We rst consider the <u>m iscible BEC</u> case. We take the amplitude as A = 1 = 2M + 1 to insure the normalization condition. The wave numbers are chosen as (l = 50, s = 100), (l = 150, s = 100), and (l = 150, s = 50), which correspond to the points labeled by 1, 2, 3 in Fig. 1(a). The rst two points are stable, and the last one is in an unstable regime with the growth rate being 0:1863. Density of the rst component $j_{j;1}(t) f$ is plotted in Fig. 2. As expected from the analytical prediction, for the rst point (k = -4, q = -2), them odulated wave is stable. However, for the second point (k = 3 = 4, q = -2) as shown in Fig. 2(b), the density increase sharply at the nal stage. It is not predicted by the linear stability analysis. The reason for this phenom enon is the com – plex interactions between three fundam ental eigenm odes of wave numbers k, k q, and k + q contained in the initial state, and additional components of other wave numbers [6]. Fig. 2 (c) shows the case that $!_{q;1}$ is real and $!_{q;2}$ is in aginary, which m eans that the component 1 is stable and the component 2 is unstable. How ever, the instability is transferred from one component to another due to the e ects interspecies coupling, which in turn leads to the M I of total system. The appearance of spatially localized m odes with large am plitude indicates the m odulational instability of the m iscible BEC s.




FIG.2. Density of component 1 for the miscible case ($_{12}^2 < _{1 2}$). Component 2 is similar with component 1. (a) k = =4, q = =2, (b) k = 3 =4, q = =2, and (c) k = 3 =4, q = =4. Other parameters are the same as Fig. 1(a).

In Ref. [17], Rapti et al. calculated the spatiotem poral dynam ics of the two-com ponent BECs with purely nonlinear coupling, where the wave number k is taken as =2. A coording to the linear-stability analysis, how ever, within this case both $!_{q;1}$ and $!_{q;2}$ are real and equal to 2K sin (q), which means that there is no the M I. The appearance of the large-am plitude excitations in their numerical simulation may originate from the complex interactions between the eigenmodes involved.




FIG.3. Density of component 1 for the imm iscible case $\begin{pmatrix} 2\\12 \end{pmatrix} > \begin{pmatrix} 1\\2 \end{pmatrix}$. Component 2 is similar with component 1. (a) k = 3 = 4, q = = 40, (b) k = 3 = 4, q = = 20. Other parameters are the same as Fig. 1(b).

W e further study the M I of the two-component BECs for the imm iscible case. As an example we calculate two points: (l = 150, s = 5) and (l = 150, s = 10) in the unstable regime. Both points have real $!_{q,1}$ and im aginary $!_{q,2}$. The M I grow th rates are 0.0458 and 0.0902, respectively. The instability grow th time for the second point is twice to that of the second one. Our numerical results shown in Fig. 3 con rm the

analytical prediction. O ther simulations in the unstable regime show that the increase of q in the monotonic regime ($0 < q < \)$ can enhance the growth rate, i.e., the instability growth time becomes more and more shorter with the increase of q.

V.CONCLUSIONS

We have studied the modulational instability of twocomponent BEC in the super uid regime. The explicit expression of the excitation spectrum is presented analytically. In the long-wavelength limit, our results can recover previous results of two-species BECs in hom ogeneous case. From the Bogoliubov dispersion relation we studied the M I condition of the modulated plane waves. The discreteness e ect leads to the appearance of the M I for the two-component BECs not only in the miscible region but also in the phase separation region.

For the m iscible condensates, the M I can occur for relatively large wave number of the condensates k > =2. For the smaller $\frac{2}{0}$ compared with the critical density $\frac{2}{0;cr}$, the M I condition depends also on the perturbation wave number q. The M I conditions in the two-component BECs with the phase separation can take place for any k. However, unlike to the m iscible case, only one of the species can be modulationally unstable for any given q and k. To con m the analytical results, we also performed numerical calculations. We not that the interspecies coupling can transfer the instabilities from one component to the other, which lead to the M I of the whole system. In summary, with the help of linear-stability analysis, we have studied the stability of the modulated plane waves, which is essential to predict the existence of nonlinear localized modes, such as dark solitons, in the discrete nonlinear Schrödinger equation [24,25].
