# M odulational instability of tw o-com ponent Bose E in stein condensates in an optical lattice

#### Abstract

W e study modulational instability of two-com ponent Bose E instein condensates in an optical lattice, which is m odelled as a coupled discrete nonlinear Schrodinger equation. The excitation spectrum and the $m$ odulational instability condition of the total system are presented analytically. In the long-w avelength lim it, our results agree with the hom ogeneous tw o-com ponent B ose E instein condensates case. The discreteness e ects result in the appearance of the $m$ odulational instability for the condensates in $m$ iscible region. The num erical calculations con $m$ our analytical results and show that the interspecies coupling can transfer the instability from one com ponent to another. PACS num bers: 05.45.-a, 03.75 Lm


## I. IN TRODUCTION

The m odulational instability (M I) is a general phenom enon in nonlinear wave equations and can occur in various physical system $s$, such as uid dynam ics, plasm a physics, and nonlinear optics. D ue to the interplay betw een nonlinearity and the dispersive e ects, a weak perturbation on a plane wave may induce an exponential grow th, and result in the carrier wave break up into a train of localized w aves [1]. R ecently, the M I of B oseE instein condensates (BEC) has attracted much interest, especially for the single-com ponent BEC in an optical lattioe [2,3]. In the super uid regim e, the BEC in an optical lattice can be $m$ odeled by a discrete nonlinear Schrodinger equation [4,5]. Follow ing Ref. [6], the M I of a BEC in a deep optical lattioe has been studied both theoretically $[710]$ and experim entally [11,12].

C om pared w ith the single-com ponent BEC system, binary $m$ ixtures of BEC s have $m$ uch richer structures [13]. In fact, the excitation spectrum of a hom ogenous twocom ponent BECs has been studied in Refs. [14\{16]. It was shown that the M I depends strongly on the sign of ${ }_{12}^{2} \quad 1 \quad 2$, where 12 is the interspecies interaction strength, 1 and 2 are the intraspecies scattering strengthes, respectively. In Ref. [17], the M I of the tw o-com ponent B E C s in a deep optical lattice w as studied w ith a Josephson-like coupling term. H ow ever, their works were lim ited on a xed perturbation wave num ber (i.e., $q=$ ). In addition, they did not com pare their results w ith that of the hom ogenous tw o-com ponent BEC s case [14\{16].

In this paper, we study the M Ioftw o-com ponent B EC s in an optical lattice. The explicit expression of the excitation spectrum is presented analytically. In order to outline the e ects of the discreteness, we com pare the M I condition of the $m$ odulated plane $w$ aves $w$ th that of the hom ogenous tw o-com ponent BEC s case, in which the M I can occur only for ${ }_{12}^{2}>12$, i.e., the BECs in phase separation region [14\{16]. O ur results show that, the M I of the tw o com ponent BEC s in an optical lattice depends not only on the sign of ${ }_{12} \quad 1 \quad 2$, but also on the wave
num ber $k$ of the carrier waves. For ${ }_{12}^{2}<12$, the M I of the $m$ iscible condensates can also take place when the condensates have relatively large wave num ber k > $=2$. $T$ he ect of the interspecies coupling is investigated by num erical calculations. O ur results show that the coupling betw een the two condensates can transfer the instability from one com ponent to another.

## II. THEORETICALMODEL

W e consider a cloud of BEC atom s which have two intemal states labeled by jli and Ri in an optical lattice. W hen the heights of the interw ell barriers are much higher than the chem ical potentials, the condensate $w$ ave functions can be expressed as a sum of wave functions lopalized in each well of the periodic potential
$(r ; t)=N \quad j \quad j ;(t) \quad\left(r \quad r_{j}\right)$, where $N$ is the total num ber of condensate atom $s$, and ( $\left.\begin{array}{rl}r & r_{j}\end{array}\right)$ is the spatialw ave function localized in the jth site. W ith the help of the tight-binding approxim ation [4], the probability am plitudes j; obey a set ofcoupled D NLS equations ( $\mathrm{h}=1$ ):

where $K$ and 0 with $=1 ; 2$ describe the nearestneighbor hopping term and the on-site atom ic collisions, respectively. The stationary solutions of the D N LS equations (1) are plane waves $\left.j ;={ }^{(0)} e^{i(k j} \quad t\right)$ with the chem icalpotentials of the two-com ponent condensed atom s

Here, the chem ical potentials $P$ are to be determ ined by the norm alization condition $j ; j j ; f=1$. The term $s \quad 2 \mathrm{~K} \cos (\mathrm{k})$ in Eq. (2) are the kinetic energies aroused from tunnelling. It should be noted that, we
study the BECs system in the super uid regim e with $(\mathbb{N}=\mathrm{M}) \mathrm{K} \quad ; \quad$ ( M is the lattioe num ber), and thus the dynam ics can be well described by the D N LS equations.

The excitation spectrum can be obtained by the stability analysis of the plane waves. W e introduce $\mathrm{hm}^{\mathrm{m}}$ all perturotations to the carrier wave as: $\mathrm{j}_{\mathrm{i}}=$

phonon $m$ odes are taken in the traditional form $j_{i}=$ $\left.u e^{i(q j}!t\right)+v e{ }^{i(q j!t)}$, with the constants $u$ and $v$ to be determ ined. Then we obtain the excitation spectra as

In the above derivations, we have assum ed ${ }^{(0)}$ to be real, and taken $K_{1}=K_{2}=K$, then $q_{; 1}=q_{q}{ }_{2}=$ q $4 K \cos (k) \sin ^{2}(q=2)$ [18]. In the absence of the interspecies interactions $(12=0), \quad=2_{1}\binom{(0)}{1}^{2}$ or $2_{2}\left({ }_{2}^{(0)}\right)^{2}$. The two-com ponent BECs are fully decoupled, and the spectra are the sam ew th single-com ponent case $[9,18]$. A ccording to Refs. [6,8], the plane waves of the condensates are modulationally unstable when the eigen frequencies becom es im aginary, i.e., $q\left(q^{+}\right)<0$. In this case, the system undergoes exponential grow th $w$ ith the grow th rate determ ined by the im aginary part of ! ( ${ }_{\mathrm{q}}$ '). From Eq. (4), we know that: (i) if ${ }_{12}^{2}<12$, i.e., the case of the tw o com ponents being $m$ iscible, both

1 and 2 are positive; (ii) if ${ }_{12}^{2}>12$, then $1<0$ and $2>0$. W thin the second scenario, the condensates tend to separate spatially, nam ely the phenom ena of phase separation $[19,20]$. The sign of $\left(\begin{array}{lll}2 & 12 & 1\end{array}\right)$ is of crucial im portant in discussing the stability of the eigenm odes.

## III. M ODULATIONALINSTABILITY

In this section, we study the $m$ odulational instability by using Eq. (3). To understand the e ect ofthe discreteness clearly, we rst study Eq. (3) in the long-w avelength $\lim$ it [6]. Eq. (3) in the long-w avelength lim it, i.e., k! 0 and $q!0$, is reduced to:

which agrees with the usual expression obtained from continuous NLS equations [14\{16] by replacing $K q^{2} w$ th $q^{2}=2 \mathrm{~m}$. It was show $n$ that only im $m$ iscible BECs ( $w$ th $\left.{ }_{12}^{2}>112\right)$ exhibit the M I [21].

## A. The M I condition for the miscible BECs

The M I condition for the two-com ponent BECs are determ ined by the condition: $\mathrm{q}_{\mathrm{q}}\left(\mathrm{q}^{( }\right)<0$. For the $m$ iscible BECswith ${ }_{12}^{2}<12$, the M I occurs for
$\cos (k)<0$ and $q^{+} \quad>0$. For sim plicity, we take

T herefore, the m iscible BEC sm ay exhibits the M I w hen $=2<k<3=2$ and ${ }_{0}^{2}>q^{2}=$. M ore specially, both of the tw o-com ponent $w$ ith relative large w ave num ber ( $k>=2$ ) will be unstable for arbitrary $q$ provided that ${ }_{0}^{2}>{ }_{0}^{2}$;cr $=4 \mathrm{~K}=1$. Below the critical am plitude, the M I region depends on the perturbation's wave num ber q. In Fig. 1 (a), we consider the case ${ }_{0}^{2}<{ }_{0}^{2}$;cr , where the atom ic collisions are taken as $a_{1}: a_{12}: a_{2}:: 1: 007: 1: 1: 01$ [22]. W e take ${ }_{1}=$, then $12=0: 993$ and $2=1: 00298$, which satisfy the m iscible criterion. O ur results show that there exist three di erent regions in the ( $q, k$ ) plane. T he dotted line in Fig. 1 (a) separates the unstable regim e into a fully unstable and a partially unstable, in which one com ponent is stable and the second one is unstable.

> B. The M I condition for the BECS in phase separation region

To study the M I of the im miscible BEC s, we take the atom ic collisions are taken as $a_{1}: a_{12}: a_{2}:: 1: 03: 1: 0: 97$ [23]. Thus we have $12=0: 9709$ and $2=0: 9417$, which $m$ eet the condition ${ }_{12}^{2}>12$. Unlike the previous miscible case, the M I condition considered here depends on the wave numberk. We nd that for cosk $>0$ (i.e., $\mathrm{k}<=2$ or $\mathrm{k}>3=2$ ), the MI condition is ${ }_{0}^{2}>q=j 1$ j. H ow ever, for $=2<k<3=2$, it becom es ${ }_{0}^{2}>\quad q=2$. Since $j_{1 j} \quad 2$, the immiscible BEC $s$ w ill be unstable in the whole ( $q, k$ ) plane provided that ${ }_{0}^{2}>{ }_{0}^{2}$;cr $=4 \mathrm{~K}=j$ 1j. Below the critical am plitude, the $M$ I region in the ( $q, k$ ) plane is show $n$ in $F$ ig. 1 (b). The M I can take place for any wave num ber $k$.

## IV. NUMERICALANALYSIS

The linear-stability analysis can determ ine the onset of M I, how ever it does not yield any dynam ical inform ation beyond the instability point. Therefore, we perform nu$m$ erical sim ulations of the D N LS equations. The initial conditions are tw o m odulated plane waves

in accordance w ith our previous discussions. The m odulation am plitudes are assum ed sm allcom pared w th the background am plitudes $=0: 05 \mathrm{~A}$. W e consider the optical lattice w the total num ber of the sites $M=400$. From the periodic boundary condition, the wave num bers take the form of $k=2 \mathrm{~lm}$ and $\mathrm{q}=2 \mathrm{~s}=\mathrm{M}$, where we choose the unit lattice constant.
$W$ e rst consider the $m$ iscible BEC case. $W$ e take the am plitude as $\mathrm{A}=1=\overline{2 \mathrm{M}+1}$ to insure the norm alization condition. The wave num bers are chosen as ( $1=50$, $s=100),(1=150, s=100)$, and $(1=150, s=50)$, which correspond to the points labeled by 1, 2, 3 in F ig. 1 (a). The rst two points are stable, and the last one is in an unstable regim ew ith the grow th rate being $0: 1863$. Density of the rst com ponent $\left.j_{j ; 1}(t)\right\}$ is plotted in Fig . 2. A s expected from the analytical prediction, for the rst point ( $k==4, q==2$ ), them odulated $w$ ave is stable. H ow ever, for the second point ( $k=3=4, q=2$ ) as show $n$ in $F$ ig. 2 (b), the density increase sharply at
the nal stage. It is not predicted by the linear stability analysis. The reason for this phenom enon is the com plex interactions betw een three fundam ental eigenm odes of wave num bers $k, k \quad q$, and $k+q$ contained in the initial state, and additional com ponents of other w ave num bers [6]. $F$ ig. 2 (c) show s the case that ! ${ }_{q ; 1}$ is real and ! $q ; 2$ is im aginary, which $m$ eans that the com ponent 1 is stable and the com ponent 2 is unstable. H ow ever, the instability is transferred from one com ponent to another due to the e ects interspecies coupling, which in tum leads to the M I of total system. T he appearance of spatially localized $m$ odes $w$ ith large am plitude indicates the $m$ odulational instability of the $m$ iscible BEC s.

In Ref. [17], R aptiet al. calculated the spatiotem poral dynam ics of the two-com ponent BECs w th purely nonlinear coupling, where the w ave num ber $k$ is taken as
=2. A ccording to the linear-stability analysis, how ever, w thin this case both $!_{\mathrm{q} ; 1}$ and ! ${ }_{\mathrm{q} ; 2}$ are real and equal to $2 \mathrm{~K} \sin (q)$, which $m$ eans that there is no the $M$ I. T he appearance of the large-am plitude excitations in their nu$m$ ericalsim ulation $m$ ay originate from the com plex interactions betw een the eigenm odes involved.
$W$ e further study the M I of the tw o-com ponent BECs for the $\mathrm{im} m$ iscible case. A $s$ an exam ple we calculate tw o points: $(l=150, s=5)$ and $(l=150, s=10)$ in the unstable regim e. B oth points have real ! $q_{; 1}$ and im aginary ! q;2. The M I grow th rates are 0:0458 and 0:0902, respectively. The instability grow th tim e for the second point is tw ige to that of the rst point $w$ th the second one. O ur num erical results show $n$ in $F$ ig. 3 con $m$ the
analytical prediction. O ther sim ulations in the unstable regim e show that the increase of $q$ in the $m$ onotonic regim e ( $0<q<$ ) can enhance the grow th rate, i.e., the instability grow th tim e becom es $m$ ore and $m$ ore shorter $w$ th the increase of $q$.

## V.CONCLUSIONS

W e have studied the m odulational instability of twocom ponent BEC in the super uid regim e. T he explicit expression of the excitation spectrum is presented analytically. In the long-w avelength lim it, our results can recover previous results of tw o-species B EC s in hom ogeneous case. From the B ogoliubov dispersion relation we studied the M I condition of the m odulated plane waves. $T$ he discreteness e ect leads to the appearance of the $M I$ for the two-com ponent BECs not only in the $m$ iscible region but also in the phase separation region.

For the m iscible condensates, the M I can occur for relatively large wave num ber of the condensates $k>=2$. For the sm aller ${ }_{0}^{2}$ com pared with the critical density
${ }_{0}^{2}$;cr, the M I condition depends also on the perturbation wave num berq. TheM I conditions in the tw o-com ponent BECsw th the phase separation can take place for any k . H ow ever, unlike to the m iscible case, only one of the species can be modulationally unstable for any given $q$ and k . To con m the analytical results, we also perform ed num erical calculations. W e nd that the interspecies coupling can transfer the instabilities from one com ponent to the other, which lead to the M I of the whole system.

In sum $m$ ary, with the help of linear-stability analysis, we have studied the stability of the $m$ odulated plane waves, which is essential to predict the existence of nonlinear localized m odes, such as dark solitons, in the discrete nonlinear Schrodinger equation $[24,25]$.
