M otivated by the idea of entanglement loss along R enormalization G roup ows, analytical majorization relations are proven for the ground state of (1 + 1)-dimensional conformal eld theories. For any of these theories, majorization is proven to hold in the spectrum of the reduced density matrices in a bipartite system when changing the size L of one of the subsystems. Continuous majorization along uniparametric ows is also proven as long as part of the conformal structure is preserved under the deformation and some monotonicity conditions hold as well. As particular examples of our derivations, we study the cases of the XX, H eisenberg and XY quantum spin chains. O ur results provide in a rigorous way explicit proves for all the majorization conjectures raised by Latorre, Lutken, R ico, V idal and K itaev in previous papers on quantum spin chains.

I. IN TRODUCTION

In the last few years, the emerging eld of quantum information science [1] has developed tools and techniques for the analysis of quantum systems which have been proved to be useful in other elds of physics. The study of many-body H am iltonians, quantum phase transitions, and the quantum correlations -or entanglem entthat these systems develop, are examples of this interdisciplinary research. In fact, understanding entanglem enthas been realized as one of the most challenging and interesting problems in physics [2].

Another interesting application of the tools of quantum information science has been the use of majorization theory [4] in order to analyze the structure present in the ground state -also called vacuum - of som e m odels along Renormalization Group (RG) ows (for a recent review on RG, see [3]). Following this idea, Latorre et al. [5] proposed that irreversibility along RG owsmay be rooted in properties of the vacuum only, without necessity of accessing the whole H am iltonian of the system and its excited states. The vacuum of a theory may already have enough inform ation in order to envisage irreversibility along RG trajectories. Such an irreversibility was casted into the idea of an entanglem ent loss along ows, which proceeded in three constructive steps RG for (1+1)-dimensional quantum systems: rst, due to the fact that the central charge of a (1+1)-dim ensional conform al eld theory is in fact a genuine measure of the bipartite entanglem ent present in the ground state of the system [6, 7], there is a global loss of entanglem ent due to the c-theorem of Zam olodchikov [8], which assures that the value of the central charge at the ultraviolet xed point is bigger or equal than its value at the infrared xed point (c_{u v} c_{IR}); second, given a splitting of the system into two contiguous pieces, there is a monotonic loss of entanglem ent due to the monotonicity num erically observed for the entanglem ent entropy between the two subsystem s along the ow, decreasing when going away from the critical xed (ultraviolet) point; third, this loss

of entanglement is seen to be ne-grained, since it follows from a very strict set of majorization ordering relations, which the eigenvalues of the reduced density matrix of the subsystems are numerically seen to perfectly obey. This last step motivated the authors of [5] to a rm that there was a ne-grained entanglement boss along RG ows rooted in properties of the vacuum, at least for (1+1)-dimensional quantum systems. In fact, a similar ne-grained entanglement boss had already been numerically observed by V idalet al. in [6], for changes in the size of the bipartition described by the corresponding groundstate density operators, at conform ally-invariant critical points.

In this work, we analytically prove the links between conform al eld theory (CFT), RG and entanglem ent that were conjectured in the recent papers [5, 6] for quantum spin chains. We develop, in the bipartite scenario, a detailed and analytical study of the majorization properties of the eigenvalue spectrum obtained from the reduced density matrices of the ground state for a variety of (1+1)-dimensional quantum models in the bulk. Our approach is based on in nitesim al variations of the param eters de ning the model -magnetic elds, anisotropiesor deform ations in the size of the block L for one of the subsystem s. W e prove in these situations that there are strict majorization relations underlying the structure of the eigenvalues of the considered reduced density matrices or, as de ned in [5], there is a ne-grained entanglement loss. The result of our study is presented in terms of two theorem s. On the one hand, we prove exact continuous majorization relations in terms of deformations of the size of the block L that is considered. On the other hand, we are also able to prove continuous maprization relations as a function of the param eters de ning the model. On top we also provide explicit analytical examples for models with a boundary based on previous work of Peschel, Kaulke and Legeza [9].

This paper is structured as follows: in sec.II we rem em ber the concepts of global, monotonous and ne-grained entanglem ent loss, as de ned in [5]. In sec.III we analytically prove continuous m a prization relations for any (1+1)-dimensionalCFT when the size of the subsystem L is changed, and give an example of a similar situation for the case of the XX -m odelw ith a boundary. In sec.IV we prove continuous majorization relations with respect to the ows in parameter space for (1+1)-dimensional quantum systems under perturbations which preserve part of the conform al structure of the partition function. A gain, we support our result with the analysis of a similar situation for the H eisenberg and XY quantum spin chains with a boundary. Finally, sec.V collects the conclusions of our study. We also review in appendix A the de nition of m a jorization and provide a lemma which will be used in our calculations.

II. GLOBAL, MONOTONOUS AND FINE-GRAINED ENTANGLEMENT LOSS

Consider the pure ground state (or vacuum) jiofa given physical system which depends on a particular set of parameters, and let us perform a bipartition of the system into two pieces A and B. The density matrix for A, describing all the physical observables accessible to A, is given by $A = tr_B$ (j ih j) - and analogously for B -. In this section we will focus our discussion on the density matrix for the subsystem A, so we will drop the subindex A from our notation. Let us consider a change in one for sim plicity-of the parameters on which the resultant density matrix depends, say, parameter t, which can be either an original parameter of the system or the size of the region A. In other words, we make the change (t₁) ! (t_2) , where $t_1 \in t_2$. In order to simplify even more our discussion let us assume that $t_2 > t_1$. We wish to understand how this variation of the parameter alters the inner structure of the ground state and, in particular, how does it modify the entanglem ent between the two parties A and B. Because we are considering entanglem ent at two di erent points t_2 and t_1 , we assume for simplicity that the entanglem ent between A and B is bigger at the point t_1 than at the point t_2 , so we have an entanglem ent loss when going from t_1 to t_2 .

Our characterization of this entanglement loss will progress through three stages, as in [5], rening at every step the underlying ordering of quantum correlations. These three stages will be respectively called gbbal, monotonous and ne-grained entanglement loss.

a. G lobal entanglem ent bss. The simplest way to quantify the loss of entanglem ent between A and B when going from t_1 to t_2 is by means of the entanglem ent entropy S ((t)) = tr((t) ln (t)). Since at t_2 the two parties are less entangled than at t_1 , we have that

which is a global assessment between points t_2 and t_1 . This is what we shall call global entanglement loss.

b. Monotonous entanglement bss.- A more rened quantication of entanglement loss can be obtained by imposing the monotonicity of the derivative of the entanglement entropy when varying parameter t". That is, the condition

im plies a stronger condition in the structure of the ground state under deform ations of the param eter. This m onotonic behavior of the entanglem ent entropy is what we shall call m onotonous entanglem ent loss.

c. Fine-grained entanglem ent loss.- W hen monotonous entanglement loss holds, we can wonder whether, in fact, it is the spectra of the underlying reduced density matrix the one that becomes more and m ore ordered as we change the value of the parameter. It is then natural to ask if it is possible to characterize the reordering of the density matrix eigenvalues along the ow beyond the simple entropic inequality discussed before and thereby unveil some richer structure. The nest notion of reordering when changing the param eter is then given by the monotonic majorization (see appendix A) of the eigenvalue distribution along the ow. If we call \sim (t) the vector corresponding to the probability distribution of the spectra arising from the density operator (t), then the condition

whenever $t_2 > t_1$ will re ect the strongest possible ordering of the ground state along the ow. This is what we call ne-grained entanglement loss, and it is ne-grained since this condition involves a whole tower of inequalities to be simultaneously satistical (see appendix A). In what follows we will see that this precise majorization condition will appear in dimensional quantum systems.

III. FINE-GRAINED ENTANGLEMENT LOSS W ITH THE SIZE OF THE BLOCK IN (1+1)-D IM ENSIONAL CFT

A complete analytical study of majorization relations for any (1 + 1)-dimensional conformal eld theory (without boundaries¹) is presented in the bipartite scenario when the size of the considered subsystem s changes, i.e., under deform ations in the interval of the accessible region

for one of the two parties. This size will be represented by the length L of the space interval for which we consider the reduced density matrix $_L$ after tracing out all the degrees of freedom corresponding to the rest of the universe. Our main result in this section can be casted into the following theorem :

Theorem : $_{L}$ $_{L^{0}}$ if L L^{0} for all possible (1 + 1) – dimensional CFT.

Proof:

The unnormalized density matrix _L can then be written as _L = q^b q^(L₀+L₀), since _L can be understood as a propagator and (L₀ + L₀) is the generator of translations in time (dilatations in the conform al plane) [10]. Furtherm ore, we have that

Because $_1$ is always the biggest eigenvalue 8L, the rst cum ulant autom atically satis escontinuous majorization when decreasing the size of the interval L. The variation

of the rest of the eigenvalues $_1$, l > 1, with respect to L reads as follow s:

Let us focus on the second eigenvalue $\ _2$. Clearly two di erent situations can happen:

thus ful lling majorization. The same conclusion extends easily in this case to all the remaining cumulants, and therefore majorization is satised by the whole probability distribution.

if $\frac{\mathcal{I}(q)}{|\mathcal{I}(q)|} < 0$, then $\frac{d_{-2}}{dL} < 0$, and therefore $\frac{d(1+2)}{dL} < 0$, so the second cum ulant satis es majorization, but nothing can be said from this about the rest of the remaining cum ulants.

P roceeding with this analysis for each one of the eigenvalues we see that, if these are monotonically decreasing functions of L then majorization is fulled for the particular cumulant under study, but since $_{i+1} > _i 8i$ we notice that once the rst monotonically increasing eigenvalue is found, majorization is directly satis ed by the whole distribution of eigenvalues, therefore $_L _ L^o$ if L $_L^0$. This proof is valid for all possible (1 + 1)-dimensional conform all eld theories since it is based only on completely general assumptions.

A. A nalytical nite-L m a prization for the critical quantum XX -m odel with a boundary

Let us give an example of a similar situation to the one presented in the previous theorem for the case of the quantum X X -m odel with a boundary, for which the exact spectrum of $_L$ can be explicitly computed. The H am iltonian of the model without magnetic eld, is given by the expression

The system described by the X X -m odel is critical since it has no m ass gap. Taking the ground state and tracing

out all but a block of L contiguous spins, the density matrix $_{\rm L}$ describing this block can be written, in the large L lim it, as a therm alstate of free ferm ions (see [9]):

Once the density matrix of the subsystem is well characterized with respect to its size L, it is not dicult to prove that $_{\rm L}$ $_{\rm L^0}$ if L $_{\rm L}$ ⁰. In order to see this, we will x the attention in the majorization within each mode and then we will apply the direct product lemma from appendix A for the whole subsystem. We initially have to observe the behavior in L of the biggest probability de ned by each individual distribution for each one of the modes, that is, $P_{\rm L} = 1=Z_{\rm L} = (1 + e_{\rm L})^{-1}$, for = 0;1;:::;L 1. It is straightforward to see that

which implies that P_L decreases if L increases 8. This involves majorization within each mode = 0;1;:::;L 2 when decreasing L by one unit. In addition, we need to see what happens with the last mode = L 1 when the size of the system is reduced from L to L 1. Because this mode disappears for the system of size L 1, its probability distribution turns out to be represented by the probability vector (1;0), which majorizes any probability distribution of two components. C om bining these results with the direct product lem ma from appendix A, we conclude that this example for the quantum XX -m odel provides a similar situation for a model with a boundary to the one presented in our previous theorem .

W e study in this section strict continuous m a prization relations along uniparam etric ow s, under the conditions of integrable deform ations and m onotonicity of the eigenvalues in param eter space. The m ain result of this section can be casted into the next theorem :

Theorem : consider a (1 + 1)-dimensional physical theory which depends on a set of real parameters $g = (g_1; g_2; :::)$, such that

there is a non-trivial conform alpoint g , for which the m odel is conform ally invariant

the deform ations from g in parameter space in the positive direction of a given unitary vector \hat{e} preserve part of the conform all structure of the model, i.e., the eigenvalues of the reduced density m atrices of the vacuum (g₂) are still of the form given in eq.(3.2) for values of the parameters g₁ = g + a \hat{e}

ê $\tilde{r}_{q}q(g)$ 0, where q(g) are the corresponding parameter-dependent conform alq-factors.

Then, away from the conform alpoint there is continuous majorization of the eigenvalues of the reduced density matrices of the ground state along the ow in the parameters g in the positive direction of ê, i.e.,

If the eigenvalues are assumed to be of the form given by eq.(3.2), then it is straightforward to see that $\hat{e} \quad \hat{r}_{g-1}(g) \qquad 0$, which assures that the rst cu-

m ulant ful lls m a prization. The rest of the analysis is completely equivalent to the one presented in the previous proof of the theorem in sec.III, which also proves this theorem.

The applicability of this theorem is based on the conditions we had to assume as hypothesis. Indeed, these conditions are naturally fullled by m any interesting m odels. We now wish to illustrate this point with the analytical examples of similar situations for the H eisenberg and X Y quantum spin chains with a boundary.

A. A nalytical m a prization along the anisotropy ow for the H eisenberg quantum spin chain with a boundary

Consider the Ham iltonian of the Heisenberg quantum spin chain with a boundary

where is the anisotropy parameter. This model is noncritical for > 1 and critical at = 1. From the pure ground state of the system, it is traced out half of it, getting an in nite-dimensional density matrix which describes half of the system (N = 2 contiguous spins in the lim it N ! 1). The resulting reduced density matrix

can be written as a therm al density matrix of free ferm ions [9], in such a way that its eigenvalues are given by

and $n_k = 0;1$, for k = 0;1;:::;1. The physical branch of the function arcosh() is de ned for 1 and is a monotonic increasing function as increases. On top, the whole partition function Z can be decomposed as an in nite direct product of the di erent free ferm ionic modes.

From the last equations, it is not di cult to see that ${}_{\circ}$ if 0 . Fixing the attention in a particular mode , we evaluate the derivative of the biggest probability for this mode, P = (1 + e)¹. This derivative is seen to be

It follows from this fact that all the m odes independently m a prize their respective probability distributions as increases, with the peculiarity that the 0th m ode remains unchanged along the ow, being its probability distribution always $(\frac{1}{2};\frac{1}{2})$. The particular behavior of this m ode is the responsible for the appearance of the \cat" state that is the ground state for large values of (in that lim it, the m odel corresponds to the quantum Ising m odel without m agnetic eld). These results, together with the direct product lem m a from appendix A, m ake this example obey m apprization along the ow in the parameter.

B. A nalytical m a prization along uniparam etric ows for the quantum XY-m odel with a boundary

Sim ilar results to the one obtained for the H eisenberg m odelcan be obtained as well for a m ore generic quantum spin chain. Let us consider the quantum X Y \neg m odelw ith a boundary, as described by the H am iltonian

where can be regarded as the anisotropy parameter and as the magnetic eld. The phase diagram of this model is shown in g.(1), where it is seen that there exist di erent critical regions depending on the values of the parameters. Consider the ground state of this H am iltonian of in nite num ber of spins, and trace out half of the system (if the size of the system is N, we trace out N =2 contiguous spins, and take the lim it N ! 1), for given values of and . The resulting density matrix (;) can be written as a therm al state of free ferm ions, and its eigenvalues are given by (see [9]):

We note that the probability distribution de ned by the eigenvalues of (;) is the direct product of distributions for each one of the separate modes. Therefore, in order to study majorization we can focus separately on each one of these modes, in the same way as we already did in the previous examples. We wish now to consider our analysis in terms of the ows with respect to the magnetic eld and with respect to the anisotropy in a separate way.

1. Flow along the magnetic eld

We consider in this subsection a xed value of while the value of changes, always ful lling the condition




Figure 1: phase diagram of the quantum X Y -m odel.

Sim ilar to the latter case, the biggest probability form ode is P = $(1 + e)^{1}$, with

and $x = \begin{pmatrix} p \\ 2 + 2 \end{pmatrix} = .$ Its derivative with respect to is

$$\frac{dP}{d} = \frac{2 e^2}{(1 + e^2)^2} \frac{d}{d} : \qquad (4.16)$$

It is easy to see that this time $\frac{d}{d} < 0$, and therefore $\frac{dP}{d} < 0$ for = 1;2;:::;1, which brings majorization individually for each one of these modes when decreases. The mode = 0 needs of special attention, from eq.(4.16) it is seen that $\frac{dP}{d} = 0$, therefore the probability distribution for this mode remains constant and equal to $(\frac{1}{2};\frac{1}{2})$ all along the ow. This is a marginal mode that brings the system to a \cat" state that appears as ground state of the system for low values of . Notice that this peculiarity is rooted on the particular form of the dispersion relation given in equation (4.8), which is proportional to 2k instead of 2k + 1 for this region in parameter space. These results, together with the direct product lemma from appendix A, prove that this example fulls also majorization.

2. Flow along the anisotropy

In this subsection, the magnetic eld is xed and the anisotropy is the only free parameter of the model, always fulling 2 + 2 > 1. Thus, at this point we can drop from our notation. We will see that $p = \frac{0}{1 - 2}$ if 0, in the two regions $1 < 1 p and + \frac{1}{1 - 2} < 1$. In particular, in the region $+ \frac{p}{1 - 2} < 1$, the probability distribution for the 0th ferm ionic mode remains constant and equal to $(\frac{1}{2}, \frac{1}{2})$. Let us consider the biggest probability for the mode , $P = (1 + e^{-1})^{-1}$, with = 1, where

and as de ned in the preceding sections. It is easy to verify that

for = 0;1;:::;1 if > 1 and for = 1;2;:::;1 if < 1. The mode = 0 for < 1 needs of special attention: it is seen that $\frac{dP^{-2}}{d} = 0$, therefore the probability

distribution for this mode remains constant and equal to $(\frac{1}{2};\frac{1}{2})$ all along the ow. These results, together with the direct product lemma from appendix A, show that this case also obeys majorization along the ow in the parameter.

V. CONCLUSIONS

In this paper we have provided in a rigorous way explicit proves for all the majorization conjectures raised by Latorre, Lutken, R ico, V idal and K itaev in previous papers on quantum spin chains [5, 6]. In particular, we have developed a completely general proof of majorization relations underlying the structure of the vacuum with respect to the size of the block L for all possible (1+1)-dimensional conformal eld theories. An example of a similar situation has been given with the particular case of the XX -m odelw ith a boundary, for which the explicit calculation of the eigenvalues of the reduced density matrix can be perform ed. We have proven as well the existence of a ne-grained entanglem ent loss for (1 + 1)dim ensional quantum system salong uniparam etric ows, regarded that perturbations in param eter space preserve part of the conform al structure of the partition function, and som em onotonicity conditions hold as well. A gain examples of similar situations have been provided by means of the Heisenberg and XY models with a boundary. Our results provide solid m athem atical grounds for the existence of majorization relations along RG - ow s underlying the structure of the vacuum of (1+1)-dimensional quantum spin chains.

Understanding the entanglem ent structure of the vacuum of (1 + 1)-dimensional models is a major task in quantum information science. For instance, spin chains like the ones described in the particular examples of this paper can be used as possible approximations to the com plicated interactions that take place in the register of a quantum com puter [12]. Entanglem ent across a quantum phase transition has also an important role in quantum algorithm design, and in particular in quantum algorithms by adiabatic evolution [13]. On top, the properties of quantum state transmission through spin chains are also intim ately related to the entanglem ent properties present in the chain [14]. Consequently, our precise characterization of entanglem ent in term sofm a prization relations should be helpful for the design of m ore powerful quantum algorithm s and quantum state transm ission protocols.

It would also be of interest trying to relate the results presented in this paper to possible extensions of the ctheorem [8] to system swith more than (1+1)-dimensions. W hile other approaches are also possible [15], majorization may be a unique tool in order to envisage irreversibility of RG - ows in terms of properties of the vacuum only, and some numerical results in this direction have already been observed in system s of di erent dimensionality along uniparam etric ows [16]. New strict mathematical results could probably be achieved in these situations following the ideas that we have presented all along this work.

Appendix A:LEM M A S O N M A JO R IZAT IO N

This appendix includes the form alde nitions of majorization [4] as well as a lemma that is used along the examples presented in this work.

1. De nitions

Let x, y 2 R^N be two vectors such that $P_{i=1}^{P} x_i = P_{i=1}^{N} y_i = 1$, which represent two di erent probability distributions. We say that distribution y majorizes distribution x, written x y, if and only if there exist a set of permutation matrices fP_jg and probabilities $p_j = 0$, $p_j = 1$, such that

Since, from the previous de nition, x can be obtained by m eans of a probabilistic combination of permutations of y, we get the intuitive notion that distribution x is m ore disordered than y.

Notice that in (A1), $_{j}p_{j}P_{j} = D$ de ness a doubly stochastic matrix, i.e. D has nonnegative entries and each row and column sums to unity. Then, x y if and only if x = Dy, D being a doubly stochastic matrix.

A nother equivalent de nition of majorization can be stated in terms of a set of inequalities between the two distributions. Consider the components of the two vectors sorted in decreasing order, written as $(z_1; ::: z_N) z^{\sharp}$. Then, $x^{\sharp} y^{\sharp}$ if and only if

All along this work, these probability sum s are called cum ulants.

A powerful relation between majorization and any convex function f over the set of probability vectors states that $\mathbf{x} = \mathbf{y}$) f(\mathbf{x}) f(\mathbf{y}). From this relation it follows that the common Shannon entropy H(\mathbf{x}) $\prod_{i=1}^{N} \mathbf{x}_i \log \mathbf{x}_i$ of a probability distribution satisfies H(\mathbf{x}) H(\mathbf{y}) whenever $\mathbf{x} = \mathbf{y}$. In what follows we present a kern ma that is used all along our work in the di erent examples that we analyze.

If $p_1 \quad p_2, q_1 \quad q_2$ then $(p_1 \quad q_1) \quad (p_2 \quad q_2)$. This means that majorization is preserved under the direct product operation.

Proof.-

If $p_1 p_2$ and $q_1 q_2$ then $p_1 = D_p p_2$ and $q_1 = D_q q_2$ where $D_p; D_q$ are both doubly stochastic matrices. Therefore $(p_1 q_1) = (D_p D_q)(p_2 q_2)$, where $(D_p D_q)$ is a doubly stochastic matrix in the direct product space, and so $(p_1 q_1)$ $(p_2 q_2)$.
