# M otion of vortices im plies chaos in Bohm ian $m$ echan ics

#### Abstract

#### Abstract

B ohm ian $m$ echanics is a causal intenpretation of quantum $m$ echanics in which particles describe trajectories guided by the wave function. The dynam ics in the vicinity of nodes of the wave function, usually called vortices, is regular if they are at rest. H owever, vortioes generically $m$ ove during tim e evolution of the system. W e show that this m ovem ent is the origin of chaotic behavior of quantum trajectories. A $s$ an exam ple, our general result is illustrated num erically in the two-dim ensional isotropic harm on ic oscillator.


De B roglie-B ohm 's (BB) approach to quantum mechanics has experienced an increased popularity in recent years. This is due to the fact that it combines the accuracy of the standard quantum description w the the intuitive insight derived from the causal tra jectory form alism, thus providing a pow erfiultheoretical tool to understand the physicalm echanism s underlying $m$ icroscopic phenom ena [in', AT]. A though the behavior of quantum trajectories is very di erent from classical solutions it can be used to gain intuition in $m$ any physical phenom ena. N um erous exam ples can be found in di erent areas of research. In particular, we can $m$ ention studies of barrier tunneling in sm ooth potentials [3]


A ccording to the BB theory of quantum $m$ otion, a particle $m$ oves in a determ in istic onbit under the in uence of the extemal potential and a quantum potential generated by the wave function. This quantum potential can be very intricate because it encodes inform ation on wave interferences. B ased on it, B ohm already predicted com plex behavior of the quantum tra jectories in his sem inalw ork $\left[\frac{-6}{1} 1 \mathrm{l}\right.$. This was recently con m ed in several studies when presence of chaos in various system shas been shown num erically [il [q]. H ow ever, the m echanism s that cause such a com plex behavior is still lacking. In this letter we show that m ovem ent of the zeros of the wave function, com $m$ only known as vortices, im plies chaos in the dynam ics of quantum trajectories. Such a m ovem ent perturbs the velocity eld producing transverse hom oclinic orbits that generate the well known Sm ale horseshoes which is the origin of com plex behavior. O ur assertion is based on an analytical proof in a sim pli ed m odel which resem bled the velocity eld near the vortices. In addition, we present a num erical study in a $2-D$
isotropic harm onic oscillator that displays a route to chaos dom inated by this $m$ echanism. It is im portant to $m$ ention that there is no agreem ent in previous works about the in uence of


The findam entalequations in the BB theory are derived from the introduction of the wave function in polar form, $(r ; t)=R(r ; t) e^{i s}(r ; t)$ (throughout the paper $h$ is set equal to 1$)$, into the tim e\{dependent Schrodinger equation, thus obtaining tw o realequations:

which are the continuity and quantum H am ilton \{Jacobi equations, respectively. The last term in the left \{hand \{side of Eq. ( $\bar{i}$ ) is the so \{called quantum potential, a non $\{$ local function determ ined by the quantum state, which, together $w$ ith $V$, determ ines the total force acting on the system. Sim ilarly to what happens in the usual classical H am ilton \{Jacobi theory, quantum trajectories of a particle of $m$ ass $m$ can then be de ned by $m$ eans of the follow ing velocity eld equation:

Vortices appear naturally in the $B B$ fram ew ork. They result from $w$ ave function interferences so they have no classical explanation. In system swithout magnetic eld, the bulk vorticity $r \quad v$ in the probability $u$ id is determ ined by the points where the phase $S$ is singular. Thism ay occur only at points w here the w ave function vanishes. This condition is fiul lled by isolated points in a $2-D$ system and lines in a $3-D$ system. D ue to the single-valuedness of the wave function, the circulation along any closed contour encircling a vortex must be quantized, that is,

 the tim e dependent velocity eld in the vicinity of a vortex located at timetin $r_{v}(t)$ is given by
where $w \quad r \quad\left(r_{v}(t)\right)[10,14]$. W e consider here $2-D$ system $s$ but we belive that our results are valid for system $s$ of higher dim ensions.

B efore presenting our analyticalresults we show a num ericalsim ulation ofquantum trajectories in a system consisting of a particle of unit $m$ ass in a 2-D isotropic harm onic oscillator. $W$ e have set the angular frequency $!=1$, so the $H$ am iltonian of the system results

W e have chosen the follow ing general combination of the rst three eigenstates of the H am iltonian of Eq. ( $\overline{\text { (G) }}$ ) as in itial state

w th $\mathrm{a} ; \mathrm{b} ; \mathrm{c} ; 1$ and 2 real num bers and $\mathrm{a}^{2}+\mathrm{b}^{2}+\mathrm{c}^{2}=1$ (the norm alization condition). A rem arkable point is that th is state generates a periodic tim e dependent velocity eld w ith only one vortex. M oreover, the trajectory of the vortex can be obtained analytically resulting

This fact allow s us to see the in uence of the m ovem ent of a vortex in the dynam ics of the quantum tra jectories, w ithout taking into account the possibility of instantaneous creation or
 w illbe studied elsew here [16].

The non-autonom ous velocity eld generated by the wave function of Eq. (7, is periodic so the best surface of section is given by xing $t=2 \mathrm{n}$ with $\mathrm{n}=0 ; 1 ;::::$ (also called a stroboscop ic view ) . F ig. ${ }_{1}^{11}$, show $s$ surfaces of section $w$ ith $b=c$ and $a=b=0 ; 0: 0553 ; 0: 1138$ and $0: 17651 \mathrm{w}$ th xed value of $1=3: 876968$ and $2=2: 684916$. The tra jectories of the vortex for the cases studied in Fig. 1 the param eter $\mathrm{a}=\mathrm{b}$ is increased. If the position of vortex is xed the tra jectories are regular and no chaos is present [see Fig. ${ }_{1}^{111}(a)$ ]. H ow ever, irregular dynam ics is observed for sm all $a=b$ Fig. $\left.{ }_{1}^{11}(\mathrm{~b})\right]$. The transition to irregular dynam ics is shown in $F$ ig. vortex produces a saddle point near ( $0: 6 ; 0: 75$ ) and their stable and unstable $m$ anifolds have a topological transverse intersection generating the well know nom oclinic tangle [1] $\left.\overline{1}_{1}\right]$.

N ow we will show analytical results that explain the num erical experim ents presented before. O ur starting point is the follow ing $m$ odel: a particle of unit $m$ ass on the plane in the velocity eld ofEq. ( $F_{1}^{1}$ ) w ith the constraints that the trajectory of the vortex is a tim e periodic curve and $\mathrm{w}_{\mathrm{x}}=\mathrm{iw} \mathrm{w}_{\mathrm{y}}$ [18]. Thus, the non-autonom ous vector eld is equal to

This non-autonom ousvelocity eld can be seen as a perturbation of the autonom ous velocity eld $v_{0} \quad\left(0 ; \frac{1}{r}\right)$, w ith $G(r ; ~ ; ~ t) \quad\left(r\left[\sin () y_{v}(t)+x_{v}(t) \cos ()\right] ; \cos () y_{c}(t) \quad x_{v}(t) \sin ()\right)$ the tim e-periodic perturbation. N ote that the eld is induced by the tim e dependent $H$ am irtonian

W e consider periodic curves $r_{v}$ ( $t$ ) such that

U nder these hypothesis the follow ing property can be proved:
There exists a saddle periodic orbit of the ow associated to the vector eld of Eq. ( $\overline{\underline{9}})$, exhibiting a hom oclinic transversal intersection.
$T$ his result, which im plies that quantum trajectories show topological chaos, is the $m$ ain nding of our work. W e illustrate here the geom etrical argum ents of the proof and we leave the full details for a future publication [1][]. W e notice that a periodic onbit of saddle type

exhibits a hom oclinic transversal intersection if their stable and unstable manifolds intersect each other and the tangents of the $m$ anifolds are not colinear at the intersection. T ransversal hom oclinic intersections (or hom oclinic tangles) beat at the heart of chaos. T his is because in the region of a hom oclinic tangle, initial conditions are sub ject to a violent stretching and folding process, the tw o essential ingredients for chaotic behavior.

Let us start to show the $m$ ain result of the letter considering som e im portant charateristics and properties of the ow generated by the velocity elds $v_{0}$ and $v$. The ow 0 associated $w$ ith the autonom ous velocity eld $v_{0}$ is de ned for every ( $x ; y$ ) $(0 ; 0)$. Thus, given a positive time $T_{0}$, the map $R^{0}=T_{T_{0}}:<^{2} \mathrm{nf}(0 ; 0) \mathrm{g}!<^{2} \mathrm{nf}(0 ; 0) \mathrm{g}$ is well de ned. It is straightforw ard to show that the $m$ ap $R^{0} w$ ritten in polar coordinates results $R^{0}=\left(R_{r}^{0}(r\right.$; $) ; R^{0}(r$; )) = ( $\mathrm{r} ; \quad+\frac{1}{r} \mathrm{~T}_{0}$ ). M ap $\mathrm{R}^{0}$ keeps invariant the set ofpoints w ith sam e radius; ie., it keeps invariant the circles. M oreover, the circles are rotated $w$ ith a rate of rotation inversely proportional
 di erence that in the present case, the rate of rotation grows to in nity when the radius is reduced. In this respect, it is im portant to $m$ ention that for generic conservative perturbations of the tw ist $m$ ap the existence of hom oclinic points associated to a saddle periodic point $w$ as proved [2G]. This result was also extended to tim e periodic perturbations of a ow which exhibit an elliptic singularity [21].
$W$ e have assum ed that the vortex $m$ oves periodically along a curve, that is, $r_{v}(t)=r_{v}(t+$ $\mathrm{T}_{0}$ ). Then, the tim e dependent velocity eld $v$ induces a ow $t$ which is de ned for every $(x ; y) \in f(0 ; 0) g$. So, the $m$ ap $R=T_{0}:<^{2} n f(0 ; 0) g!<^{2} n f(0 ; 0) g$ is well de ned. N ote that ow $t$ is generated by a tim e periodic $H$ am iltonian $\mathbb{E q}$. (120)], so $R$ is a conservative $m$ ap. A lso, $R$ can be extended continuously to $(0,0)$ de ning $R(0 ; 0)(0 ; 0)$ note that $R$ ! 0 when $(x ; y)!(0 ; 0)]$. Then, it follow $s$ that $m$ ap $R$ veri es:
$P$ roperty $A: L i k e R^{0}, m$ ap $R$ also has the property that circles are rotated $w$ ith a rate of rotation inversely proportional to the radius [see Fig. '1 '1 (a) and (b)]. In other words, ifm ap R is w ritten in polar coordinates $R(r ;)=\left(R_{r}(r ;) ; R(r ;)\right)$, then $@_{r} R$ is of the order of $1=r^{2}$.
$P$ roperty $B: T$ he im age of a sm all circle of radio $r$ intersects transversally this circle; i.e, $R\left(C_{r}\right) \backslash C_{r}$; and if $q 2 R\left(C_{r}\right) \backslash C_{r}$ then the tangent to $R\left(C_{r}\right)$ and to $C_{r}$ in $q$ are not collinear [see Fig.

From properties A and B of the perturbed map R it follows that for arbitrarily sm all r the $m$ ap $R$ has a xed point $p_{0} w$ ith radius sm aller than $r$ exhibiting hom oclinic transversal

point. O f course, this result im plies that the vector eld of Eq . $(\underset{\underline{1}}{\bar{q}})$ has a saddle periodic orb it w ith an hom oclinic transversal intersection.

W e show the previous result in two steps. First, let us display that the perturbed m ap $R$ has a xed point. P roperty B guarantees the existence of the curve ( r ; 0 ( r )) plotted in $F$ ig. ${ }_{1}^{1} 1(a)$. N ote that $O(r)$ is the angular coordinate of a point on the intersection of a circle $C_{r} w$ ith its im age $R\left(C_{r}\right)$. A point on such a curve is $m$ apped to other point $w$ ith the sam $e$ radius rbut $w$ th a di erent angle 1 ( $r$ ),

It is clear that $m$ ap $R$ has a xed point ifthere exist an $r_{0}$ such that $0\left(r_{0}\right)={ }_{1}\left(r_{0}\right)$. In other words, curves ( $r$; $0(r)$ ) and ( $r ; 1(r))$ off ig. the variation of ${ }_{1}(r)$ is larger than the variation of $0(r)$; in fact, the derivative of ${ }_{1}(r)$ is of the order of $1=r^{2}$. This fact guarantees the existence of $r_{0}$ in the vicinity of $r$ ! 0 [1] $]$.

N ow we will see that the mentioned xed point has a transversal hom oclinic intersection of their stable and unstable $m$ anifolds. $W$ e recall that the stable $m$ anifold is the set of points that converges to the xed point by forw ard iteration of the dynam ic. C onversely, the points
 consider a circle $C_{0}$ of radius $r_{0}$ containing the xed point $p_{0}$. D ue to property $B, C_{0}$ and its im age $R\left(C_{0}\right)$ has al least an additional point of intersection denoted by $q_{0}$. Points $p_{0}$ and $q_{0}$ are connected by the segm ents $s$ and $u$ of $C_{0}$ and $R\left(C_{0}\right)$ respectively. Let us consider the shaded rectangle B of $F$ ig. ' $\underline{1}_{1}^{1}(\mathrm{~b})$ that contains the xed point $p_{0}$. U sing property $A$, we have deduced that segm ents of constant angle $l_{1}$ and $l_{2}$ are stretched by $R$, and this show $s$ that rectangle $B$ is contracted by $R$ along directions close to the tangent of the circles $C_{r}$ and expanded along vectors close to the tangent of $R\left(C_{r}\right)$. This is displayed in $F$ ig. the $m$ apping of the rectangle $B$ is plotted w ith thick dashed line. M oreover, we have proved
in $R$ ef. [ [1] that $R(B)$ is close to $u$ and intersects $C_{0}$ in a point near $q_{0}$, and that, $R^{1}(B)$ is close to $s$ and intersects $C_{0}$ near $q_{0}$. This im plies that the unstable $m$ anifold of $p_{0}$ is close to $u$ and the stable $m$ anifold is close to $s . W$ e recall that $u$ cross $u$ at $q_{0}$, then the stable and unstable $m$ anifolds of $p_{0}$ have a transversalintersection near $q_{0}$.

In sum $m$ ary, we have found an universalm echanism leading to quantum tra jectories having chaotic behavior. W e have show $n$ that the $m$ ovem ent of vortices is a generic tim e dependent perturbation of an autonom ous velocity eld which creates a saddle periodic orbit $w$ ith a transversal hom oclinic intersection of their stable and unstable $m$ anifolds. This transversal intersection generates the well known Sm ale horseshoe which is the origin of com plexity . O ur results should be useful due to the fact that such determ inistic quantum orbits are an im portant theoretical tool for understanding and interpreting several processes in di erent elds. On the other hand, our geom etrical analysis of a singular velocity eld could be im portant for both theoretical and applied problem s of dynam ical system s , as for exam ple advection in non-stationary uids [2].
