# Q uantum -inform ation theoretic properties of nuclei and trapped B ose gases

A bstract
Ferm ionic (atom ic nuclei) and bosonic (correlated atom s in a trap) system sare studied from an inform ation-theoretic point ofview. Shannon and O nicescu inform ation $m$ easures are calculated for the above system s com paring correlated and uncorrelated cases as functions of the strength of short range correlations. O ne-body and tw o-body density and $m$ om entum distributions are em ployed. T hus the e ect of short-range correlations on the inform ation content is evaluated. T he m agnitude ofdistinguishability ofthe correlated and uncorrelated densities is also discussed em ploying suitablem easures ofdistance of states i.e. the well know N K ulback-Leibler relative entropy and the recently proposed Jensen-Shannon divergence entropy. It is seen that the sam e inform ation-theoretic properties hold for quantum $m$ any-body system $s$ obeying di erent statistics (ferm ions and bosons).

## 1 Introduction

Inform ation-theoretic $m$ ethods are used in recent years for the study of quantum $m$ echanical system $s$. [1] [1] [1] $\left[\begin{array}{l}-1\end{array}\right]$ he quantity of interest is Shannon's

An im portant step is the discovery of an entropic uncertainty relation (EUR), [2̄] ] which for a three-dim ensional system has the form

where $S_{r}$ is the inform ation entropy in position-space of the density distribution (r) of a quantum system

and $S_{k}$ is the inform ation entropy in $m$ om entum -space of the corresponding $m$ om entum distribution $n(k)$

The density distributions (r) and $n(k)$ are norm alized to one. Inequality $(\underline{2})$, for the inform ation entropy sum in con jugate spaces, is a joint $m$ easure of unœrtainty of a quantum $m$ echanicaldistribution, since a highly localized
( $r$ ) is associated with a di usen (k), leading to low $S_{s}$ and high $S_{k}$ and vioeversa. Expression ( $\overline{\overline{4}})$ is an inform ation-theoretical relation stronger than H eisenberg's. $S$ is $m$ easured in bits if the base of the logarithm is 2 and nats (natural units of inform ation) if the logarithm is natural.

In previous work we proposed a universal property of $S$ for the density distributions of nuclei, electrons in atom $s$ and valence electrons in atom ic clusters.|-1] T his property has the form

$w h e r e n$ is the number of particles of the system and the param eters a;b depend on the system under consideration. It is noted that recently we have obtained the same form for system s of correlated bosons in a trap. .t̄] $T$ his concept was also found to be useful in a di erent context. U sing the form alism in phase-space of $G$ hosh, Berkow itz and P arr, $[$ g $]$ we found that the
larger the inform ation entropy the better the quality of the nuclear density distribution. $1 \overline{1} 0 \overline{0} 1]$

In previous work we em ployed one-body density distributions in the de nition of . In the present paper we introduce tw o-body density distributions
( $r_{1} ; r_{2}$ ) and the corresponding tw o-body $m$ om entum distributions $n\left(k_{1} ; k_{2}\right)$. O ur aim is to investigate the properties of $S$ at the two-body level for correlated densities. The correlated nucleon system s or the trapped B ose gas, in a good approxim ation, are studied using the low est order approxim ation . $1 \overline{1} \overline{-1}$, [19] Short-range correlations (SRC) are taken into account em ploying the Jastrow correlation function. [20] 1 Thus it is of interest to exam ine how $\mathrm{S}_{2}$ is a ected qualitatively and quantitatively by the sam e form of correlations in com parison w ith $S_{1}$, in view of the fact that the quantities $\left(r_{1} ; r_{2}\right)$ and $n\left(k_{1} ; k_{2}\right)$ carry $m$ ore direct inform ation for correlations than the quantities
(r) and $n(k)$ which are only indirectly a ected by correlations. The above procedure is repeated for an altemative $m$ easure of inform ation ie. Onioescu's inform ation energy E. .[E]ī1] So far, only the $m$ athem atical aspects of this concept have been developed, while the physical aspects have been neglected.

A well know $n m$ easure ofdistance oftw o discrete probability distributions $p_{i}^{(1)} ; p_{i}^{(2)}$ is the K ullback-Leibler relative entropy

which can be easily extended for 3-dim ensional system s .
O ur aim is to calculate the relative entropy (distance) betw een $\mathrm{p}^{(1)}$ (correlated) and $p^{(2)}$ (uncorrelated) densities both at the one-and the two-body levels in order to assess the in uence of SRC (through the correlation param eter y ) on the distance K . It is noted that this is done for both system s under consideration: nuclei and trapped Bose gases. An altemative de nition of distance of tw o probability distributions was introduced by $R$ ao and Lin, thē3, $12 \overline{2} \overline{4}]$ ie. a sym $m$ etrized version of $K$, the Jensen-Shannon divergence Ј [2.

where $H(p)=\quad{ }_{i} p_{i} \ln p_{i}$ stands for Shannon's entropy. W e expect for strong SRC the am ount of distinguishability of the correlated from the uncorrelated distributions is larger than the corresponding onew ith sm allSRC. W em ay also see the e ect of SRC on the number of trials $L$ needed to distinguish $\mathrm{p}^{(1)}$ and $\mathrm{p}^{(2)}$ (in the sense described in $\left[\underline{2}^{-1} \bar{p}_{1}\right]$ ).

In addition to the above considerations, we connect $S_{r}$ and $S_{k} w$ ith fundam ental quantities i.e. the root $m$ ean square radius and kinetic energy respectively. W e also argue on the e ect of SRC on EUR and we propose a universal relation for $S$, by extending our form alism from the one- and twobody level to the N boody level, which holds exactly for uncorrelated densities in trapped B ose gas, alm ost exactly for uncorrelated densities in nuclei (due to the additional exchange term com pared to B ose gas) and it is con jectured to hold approxim ately for correlated densities both in nuclei and B ose gases.

The plan of the present paper is the follow ing. In Sec. 'i, we review the form ulas ofK ullbadk-Leibler relative entropy entropy $K$ and Jensen-Shannon divergence $J$, while in Sec. ī̦i-1 O nioescu's inform ation energy $E$ is described. In Sec. ', i-1 we present the form alism of density distributions used in present work and their applications to Shannon's and O nicescu's entropies. In Sec. ${ }_{-15}^{15}$ we introduce SRC in nuclei. In Sec. 'i-1 we apply the form ulas of $K$ and $J$ in correlated distributions. In Sec. ${ }_{1}^{\prime}$, we present our num erical results and discussion. F inally, Sec. ${ }_{-1}^{1}$ in contains our $m$ ain conclusions.

## 2 K ullback-Leibler relative entropy and Jen senShannon divergence

The K ullback-Leibler relative inform ation entropy $K$ for continuous distributions ${ }_{i}^{(1)}$ and ${ }_{i}^{(2)}$ is de ned by relation ${ }^{(1)}(\overline{1})$. It $m$ easures the di erence of ${ }_{i}^{(1)}$ form the reference (or apriori) distribution ${ }_{i}^{(2)}$. It satis es: $K \quad 0$ for any distributions ${ }_{i}^{(1)}$ and ${ }_{i}^{(2)}$. It is a measure which quanti es the distinguishability (or distance) of ${ }_{i}^{(1)}$ from ${ }_{i}^{(2)}$, employing a well-known concept in standard inform ation theory. In other words it describes how close ${ }_{i}^{(1)}$ is to ${ }_{i}^{(2)}$ by carrying out observations or coin tossing, nam ely $L$ trials (in the sense described in [2-5;1]). We expect for strong SRC the am ount of distinguishability of the correlated ${ }_{i}^{(1)}$ and the uncorrelated distributions ${ }_{i}^{(2)}$ is larger than the corresponding one w ith sm all SRC .

H ow ever, the distance $K$ does not satisfy the triangle inequality and in
addition is i) not sym $m$ etric ii) unbounded and iii) not alw ayswellde ned ['[ $\overline{[ } \overline{5}]$ To avoid these di culties R ao and Lin [2] $\overline{-1}$, ' $2 \overline{4} \overline{-1}]$ introduced a sym m etrized version of $K$ (recently discused in [2] $\overline{2} 1]$ ), the Jensen-Shannon divergence $J$ de ned by relation ! ( $(8)$. $J$ is $m$ inim um for ${ }^{(1)}={ }^{(2)}$ and $m$ axim um when
${ }^{(1)}$ and (2) are two distinct distributions, when $J=\ln 2$. In our case $J$ can be easily generalized for continuous density distributions. For J m inim um the two states represented by ${ }^{(1)}$ and ${ }^{(2)}$ are com pletely indistinguishable, while for $J \mathrm{~m}$ axim um they are com pletely distinguishable. It is expected that for strong SRC the am ount of distinguishability can be further exam ined by using W ooter's criterion . $\mathbf{L D}_{12}$ distinguishable after $L$ trials ( $L$ ! 1 ) if and only if $J\left(^{(1)} ;^{(2)}\right)^{\frac{1}{2}}>p \frac{1}{\overline{2 L}}$.

The present work is a rst step to exam ine the problem of com parison of probability distributions (for nuclei and bosonic system s) which is an area well developed in statistics, know n as inform ation geom etry.tej

## 3 O nicescu's in form ation energy

O nioescu tried to de ne a ner m easure of dispersion distributions than that of Shannon's inform ation entropy. $[\underline{2} \overline{1} 1]$ T hus, he introduced the concept of inform ation energy $E$. For a discrete probability distribution ( $p_{1} ; p_{2} ;::: ; p_{k}$ ) the inform ation energy $E$ is de ned by

$E$ is $m$ axim um if one of the $p_{i}$ 's equals 1 and all the others are equal to zero i.e. $E_{m a x}=1$, while $E$ is minimum when $p_{1}=p_{2}=:::=p_{k}=\frac{1}{k}$, hence $\mathrm{E}_{\mathrm{m} \text { in }}=\frac{1}{\mathrm{k}}$ (total disorder). The fact that E becom es m inim um for equal probabilities (totaldisorder), by analogy w ith them odynam ics, it has been called inform ation energy, although it does not have the dim ension of energy. $\mathbf{2 0}_{-1}^{1}$ ]

It is seen from ( $1 \overline{1} \overline{-1}$ ) that the greater the inform ation energy, the $m$ ore concentrated is the probability distribution, while the inform ation content decreases. E and inform ation content are reciprocal, hence one can de ne the quantity

as a $m$ easure of the inform ation content of a quantum system corresponding to $O$ nicescu's inform ation energy.

Relation (1̄O-1) is extended for a 3-dim ensional spherically sym m etric density distribution (r)

in position and $m$ om entum space respectively, where $n(k)$ is the corresponding density distribution in $m$ om entum space.
$\mathrm{E}_{\mathrm{r}}$ has dim ension of inverse volum e , while $\mathrm{E}_{\mathrm{k}}$ of volum e. Thus the product $E_{r} E_{k}$ is dim ensionless and can serve as a $m$ easure of concentration (or inform ation content) of a quantum system. It is also seen from (1]-̄), ( (1] $\overline{3})$ that $E$ increases as decreases (or concentration increases) and the inform ation (or uncertainty) decreases. Thus O and E are reciprocal. In order to be able to com pare $O$ w ith Shannon's entropy $S$, we redi ne $O$ as

as a m easure of the in form ation content of quantum system in both position and $m$ om entum spaces, inspired by $O$ nicescu's de nition.

W e consider that the atom s of the Bose gases are con ned in an isotropic HO well, where $0(r)=\left(1=\left(b^{2}\right)\right)^{3=4} \exp \left[r^{2}=\left(2 b^{2}\right)\right]$.

A s the $m$ ean eld approach fails to inconporate the intenparticle correlation which is necessary for the description of the correlated nuclei or trapped B ose gases, we introduce the repulsive interactions through the Jastrow correlation function $f\left(\begin{array}{ll}r_{1} & r_{2}\end{array}\right)$ [20]. $]$. The correlated nucleon system $s$ or the B ose gases, in a good approxim ation, can be studied using the lowest order approxim ation, in nuclei and B ose gases have the follow ing form s respectively

The uncorrelated case corresponds to y ! 1 , while SRC increase as y decreases. The above ansatz has the advantage that it leads to analytical form $s$ for the $\left(r_{1} ; r_{2}\right), n\left(k_{1} ; k_{2}\right)$, ( $r$ ) and $n(k)$.

T he onebody Shannon inform ation entropy both in position-and $m$ om entum space are de ned in ${ }_{( }^{\prime}\left(\frac{1}{1}\right)$ and ${ }_{1}^{\prime}(\overline{4}(4)$, where the total sum is

It is worth noting that the above relations hold only approxim ately in nite nuclei (see Tablé ī), due to the additional exchange term, originating from the antisym $m$ etry of the nuclear wave function. There is an exception in the case of ${ }^{4} \mathrm{He}$, where it holds exactly due to the absence of the exchange term.

## 5 Introduction of SR C in nuclei

W e consider that the single particle wave functions, which describe the nucleons is harm onic oscillator type. In order to incorporate the nucleonnucleon (or atom -atom ) correlations, as we m ention in the previous section, we apply the low est order approxim ation. In this case the two-body density distribution, for ${ }^{4} \mathrm{He}$, takes the follow ing form

In the present work, we extend our calculations in nuclei heavier than ${ }^{4} \mathrm{He}\left({ }^{12} \mathrm{C},{ }^{16} \mathrm{O}\right.$ and ${ }^{40} \mathrm{C}$ a) based on the fact that the high-m om entum tails of $n(k)$ are alm ost the sam e for all nuclei w th A 4 . $1 \overline{1} \overline{1}$, , previous w onk two-body density and $m$ om entum distributions for nuclei heavier than ${ }^{4} \mathrm{He}$. $T$ he theoretical schem e of the $m$ ethod com bines the $m$ ean- eld predictions of the tw 0 -body density distributions and tw o-body $m$ om entum distributions of various nucleiw ith their correlated part of ${ }^{4} \mathrm{He}$. Speci cally, in our treatm ent we consider the follow ing form s

From the above expressions it is obvious that the uncorrelated part of the $\left(r_{1} ; r_{2}\right)$ and $n\left(k_{1} ; k_{2}\right)$ originate from the independent particle $m$ odel for every nucleus separately, where the correlated part in each nucleus is that com ing from the nucleus ${ }^{4} \mathrm{He}$. The ( $r$ ) and $\mathrm{n}(\mathrm{k})$ have a sim ilar form.

It should be em phasized that in the uncorrelated case the additional inform ation which is contained in ( $r_{1} ; r_{2}$ ) and $n\left(k_{1} ; k_{2}\right)$ in nuclei, com pared to the trapped B ose gas is the statistical correlations which com e from the antisym $m$ etry character of the $m$ any-body wave function of nuclei. M oreover, in the correlated case the $\left(r_{1} ; r_{2}\right)$ and $n\left(k_{1} ; k_{2}\right)$ contain additional in form ation which originate from the character of the nuleon-nucleon interaction, m aking our m odelm ore realistic and the description m ore com plete. It is of interest to study how the correlations (both statistical and dynam ical) a ect quantitatively and qualitatively the various kinds of inform ation entropy.

## 6 A pplication of the Form alism of $R$ elative Entropy and Jensen-Shannon divergen ce for C orrelated D ensities

The relative entropy is a m easure of distinguishability or distance of two states. It is de ned, generalizing '! (T/i), by

For the Jensen-Shannon divergence $J$ we $m$ ay $w$ rite form ulas for $J_{1}$ (onebody) and $J_{2}$ (two-body), em ploying de nition ${ }_{( }^{\prime}(\overline{1}(\overline{1})$ and putting the corresponding correlated ${ }^{(1)}$ and uncorrelated ${ }^{(2)}$ distributions in position-and m om entum - spaces. We calculate $K$ and $J$ in position- and $m$ om entum spaces, for nuclei and bosons.

## 7 N um erical results and discussion

For the sake of sym m etry and sim plicity we put the width of the HO potential $b=1$. A ctually for $b=1$ in the case of uncorrelated case it is easy to see that $S_{1 r}=S_{1 k}$ and also $S_{2 r}=S_{2 k}$ (the sam e holds for $O$ nicescu entropy), while when b 1 there is a shift of the values of $S_{1 r}$ and $S_{1 k}$ by an additive factor $\ln b^{3}$. H ow ever, the value ofb does not a ect directly the total inform ation entropy $S$ (and also O).S and $O$ are just functions of the correlation param eter y.

In Fig. in we present the Shannon inform ation entropy $S_{1}$ using relation $(\overline{3} \overline{2} \overline{2})$ and $S_{2}$ using relation ( $\left.\overline{3} \overline{5}\right)$ in nuclei $\left({ }^{12} \mathrm{C}\right)$ and trapped Bose gas as functions of the correlation param eter $\ln \left(\frac{1}{y}\right)$. It is seen that $S_{1}$ and $S_{2}$ increase alm ost linearly w ith the strength of SRC i.e. $\ln \left(\frac{1}{\mathrm{y}}\right)$ in both system s . The relations $\mathrm{S}_{2}=2 \mathrm{~S}_{1}$ and $\mathrm{O}_{2}=\mathrm{O}_{1}^{2}$ hold exactly for the uncorrelated densities in trapped B ose gas, while the above relations are alm ost exact for the uncorrelated densities in nuclei and in the case of correlated densities both in nuclei

and trapped B ose gas. A sim ilar behavior is seen for all nuclei considered in the present work ( ${ }^{4} \mathrm{He},{ }^{16} \mathrm{O},{ }^{40} \mathrm{Ca}$ ).

Values of $\mathrm{S}_{1}, \mathrm{~S}_{2}, \mathrm{O}_{1}, \mathrm{O}_{2}$ for various nuclei in the uncorrelated case, are shown in Table 1. The relations ( $\overline{3} \overline{\underline{Z}}$ ) and ( $(\overline{3} \overline{9})$ are satis ed exactly only in the case of ${ }^{4} \mathrm{He}$. However, for the other nuclei, due to the additional exchange term in the nuclear w ave function, the relations ( $\overline{3} \overline{0} \bar{\square})$ and ( $(3 \overline{3} \overline{9})$ hold only approxim ately (the di erences are of order 0:03\% 0:09\% for $S$ and $0: 14 \% \quad 0: 96 \%$ for 0 ).

In $F$ ig. $\underline{1}_{1 / 2}$ we present the decom position of $S$ in coordinate and $m$ om entum spaces, for the sake of com parison i.e. $\mathrm{S}_{1 \mathrm{r}}, \mathrm{S}_{1 \mathrm{k}}, \mathrm{S}_{2 \mathrm{r}}, \mathrm{S}_{2 \mathrm{k}}$ for ${ }^{16} \mathrm{O}$ and trapped
 from the above $F$ igures is the sim ilar behavior betw een $S_{1 r}$ and $S_{2 r}$ and also $S_{1 k}$ and $S_{2 k}$ respectively.

In F ig. iñ we plot the O nicescu inform ation entropy both one-body $\left(\mathrm{O}_{1}\right)$

and two-body $\left(\mathrm{O}_{2}\right)$ for nuclei ( ${ }^{12} \mathrm{C} ; ;^{40} \mathrm{Ca}$ ) and trapped Bose gas (relations (1] $\overline{1}=1),(\overline{3} \overline{\mathrm{G}}))$. W e conclude by noting once again the strong sim ilarities of the behavior betw een one-and two-body O nicescu entropy.

It is interesting to observe the correlation of the ms radii $\mathrm{p} \overline{\mathrm{hr}^{2} i}$ w ith $S_{r}$ as well as the corresponding behavior of the $m$ ean kinetic energy hT iw ith $S_{k}$,
 B ose gas. $T$ his is done in $F$ ig. ${ }_{-1}^{1 / 1}$ for $\mathrm{P} \frac{\mathrm{Y}}{\mathrm{hr}^{2} i}$ and F ig. ${ }_{-1}^{15}$, for $\mathrm{hT} i$ after aplying the suitable rescaling. The corresponding curves are sim ilar for nuclei and trapped Bose gas.

A well-known concept in inform ation theory is the distance between the probability distributions ${ }_{i}^{(1)}$ and ${ }^{(2)}$, in our case the correlated and the uncorrelated distributions respectively. A $m$ easure of distance is the $\mathrm{K} u \mathrm{llb}$ backLeibler relative entropy $K$ de ned previously. The correlated and uncorrelated cases are com pared for the oneboody case ( $\mathrm{K}_{1}$ ) in F ig. ${ }_{-1} \overline{-1}$ and the the two-body case ( $\mathrm{K}_{2}$ ) in F ig. ${ }_{-1}{ }_{1}$, for nuclei ( ${ }^{4} \mathrm{He} i^{16} \mathrm{O} ;^{40} \mathrm{C}$ a) and trapped B ose
 It is seen that $\mathrm{K}_{1 \mathrm{r}}, \mathrm{K}_{2 \mathrm{r}}$ increase as the strength of SR C increases, while $\mathrm{K}_{1 \mathrm{k}}$, $K_{2 k}$ have a $m$ axim um at a certain value of $\ln \left(\frac{1}{y}\right)$ depending on the system under consideration.

C alculations are also carried out for the Jensen-Shannon divergence for one-body density distribution ( $J_{1}$ entropy) as function of $\ln \left(\frac{1}{y}\right)$ for nucleiand
 W e observe again that $J_{1}$ increases with the strength of SRC in positionspace, while in m ost cases in m om entum -space there is a m axim um for a certain value of $\ln \left(\frac{1}{y}\right)$. It is veri ed that $0<J<\ln 2$ as expected theoretically.

It is noted that the dependence of the variouskinds of inform ation entropy on the correlation param eter $\ln \left(\frac{1}{y}\right)$ is studied up to the value $\ln \left(\frac{1}{y}\right)=0(y=$
1), which is already unrealistic corresponding to strong SRC. In addition, lowest order approxim ation does not work well beyond that value. In this case three-body term s should be inchuded but this prospect is out of the scope of the present work.

For very strong SRC the $m$ om entum distribution $n(k)$ exhibits a sim ilar behavior w th the $m$ ean eld ( $\mathrm{y}!1$ ). This is illustrated in Fig.' 9 , where we present $n(k)$ for various values of $\ln \left(\frac{1}{y}\right)$. It is seen that for $s m$ all and large SRC the tail of $n(k)$ disappears. That is why for $s m$ all and large SRC the relative entropy ( $\mathrm{K}_{1 \mathrm{k}}$ and $\mathrm{J}_{1 \mathrm{k}}$ ) is sm all, while in betw een show s a m axim um
 $m$ axim um of the relative entropy $\mathrm{K}_{2 \mathrm{k}}$ in F ig. $\mathrm{I}_{1}$.

## 8 C onclusions and nal com ment

O urm ain conclusions are the follow ing
(i) Increasing the SRC (i.e. the param eter $\ln \left(\frac{1}{y}\right)$ ) the inform ation entropies $S, O, K$ and $J$ increase. A com parison leads to the conclusion that the correlated system s have larger values ofentropies than the uncorrelated ones.
(ii) $T$ here is a sim ilar behavior of the entropies as functions of correlations
for both system $s$ (nuclei and trapped Bose gas) although they obey di erent statistics (ferm ions and bosons).
(iii) There is a correlation of ${ }^{\mathrm{P}} \overline{\mathrm{hr}^{2}}$ i $w$ ith $S_{r}$ and hT iw ith $S_{k}$ in the sense that they have the sam e behavior as a function of the correlation param eter $\ln \left(\frac{1}{y}\right)$. These results can lead us to relate the theoretical quantities $S_{r}$ and $S_{k} w$ ith experim ental ones like charge form factor, charge density distribution, and $m$ om entum distribution, radii, etc. A recent paper addressed in that problem .[ַ]
(iv) The relations $S_{2}=2 S_{1}$ and $O_{2}=O_{1}^{2}$ hold exactly for the uncorrelated densities in trapped B ose gasw hile the above relations are alm ost exact for the uncorrelated densities and in the case of correlated densities both in nucleiand trapped B ose gas. In previous work we proposed the universal relation $S_{1}=S_{r}+S_{k}=a+b \ln N$ where $N$ is the number of particles of the system either ferm ionic (nucleus, atom, atom ic cluster) or bosonic (correlated atom $s$ in a trap). Thus in our case

This is exact for the uncorrelated trapped B ose gas, alm ost exact in correlated nuclei $(\mathbb{N}=1 ; 2)$ and it is con jectured that it holds approxi$m$ ately for correlated system $s$ ( $w$ hich has still to be proved for $N \quad 3$ ).

It is well-known that the low er bound is attained for a G aussian distribution (i.e. the case of ${ }^{4} \mathrm{H}$ e uncorrelated). In all cases studied in the present work EUR is veri ed.

A nal comment seem $s$ appropriate. In general, the calculation of $\left(r_{1} ; r_{2}\right)$ and $n\left(k_{1} ; k_{2}\right)$ is a problem very hard to be solved, especially in
the case of nuclei, in the fram ew ork of short range correlations. Just a few w orks are addressed in that problem. we tried to treat the problem in an approxim ate but self-consistent w ay in the sense that the calculations of $\left(r_{1} ; r_{2}\right)$ and $n\left(k_{1} ; k_{2}\right)$ are based in the same $\left(r_{1} ; r_{2} ; r_{1}^{0} ; r_{2}^{0}\right)$, which is the generating function of the above quantities. A s a consequence the inform ation entropy $S_{2}=S_{2 r}+S_{2 k}$ is derived also in a self-consistent way and there is a direct link between $S_{2 r}$ and $S_{2 k}$, as well as the other kinds of inform ation entropies which are studied in the present work.
