A nother Look at Quantum Teleportation

A dialog with A sher Peres regarding the meaning of quantum teleportation is brie y reviewed. The Braunstein-K in ble method for teleportation of light is analyzed in the language of quantum wave functions. A pictorial example of continuous variable teleportation is presented using computer simulation.

I. IN TRODUCTION

I, Lev Vaidman, knew A sher Peres since the beginning ofmy interest in the Foundations of Q uantum M echanics. Mostly, we were ghting to prove that the interpretations of quantum e ects adopted by each of us were better. A sher was against the usage by A haronov and myself of a quantum state evolving backwards in time [1, 2, 3, 4] and contesting our interpretation of the physical meaning of \weak m easurements" [5, 6, 7]. He objected to the names I gave to my proposals like \cryptography with orthogonal states" [8, 9, 10] or \interaction-free m easurements" [11]. Our disagreements did not make our interactions less fruitful: we agreed about physical facts and discussion of the interpretation only sharpened our (at least mine) understanding of various aspects of these e ects.

Even the most basic disagreement, where A sher says: \Q uantum mechanics needs no interpretation" [12], and I write that the many-worlds interpretation is by far the best way to view quantum mechanics [13], is also essentially a disagreement only about names. A sher explains his view describing K athy, an experimental physicists who, after making a quantum experiment becomes a superposition of a lady who ate a cake and a lady who ate a fruit. A sher says that even at this stage, in principle, it is still possible to reverse the evolution and come back to the state which was before the quantum measurement. Forme, this story is a gedanken test of the many-worlds interpretation. We completely agree on the facts: There is no such thing as the collapse of the quantum wave function. I interpret this story as splitting and reunion (with the help of super-technology) of two worlds, while A sher, to avoid paradoxes, considers this as an argument in favor of the approach according to which quantum mechanics should not be taken as a description of an objective reality.

The main part of this paper is devoted to the renewed analysis, perform ed together with two members of the quantum group of Tel-A viv University, of the topic on which I and A sher, in a way, collaborated: this is the issue of teleportation. I was very pleased to hear from A sher that nally we can e to an agreement. In the last e-mail I received from him two weeks before he left us, he recommended to the Jerusalem Report to interview me instead of him (due to his health condition) about teleportation. In his paper \W hat is actually teleported?" [14], A sher is joking about the suggestion of Charlie Bennett to cite the \weak m easurements" of A haronov and myself, but he mentions that in another work [15] there are seeds of the teleportation paper [16].

Indeed, I had the tools to nd the solution for the teleportation problem . W hen I saw

the abstract of this sem in alpaper I im mediately new how to do it (in my way). But it took the genius of A sher and his collaborators to ask the question. Still, my way of teleportation was useful too. I proposed a method for two-way teleportation which is applicable also for continuous variables [17]. The importance of this work became clear only a few years later, when B raunstein and K im ble found a realistic way to implement the continuous variables teleportation experiment using squeezed light [18]. This experiment was successfully accomplished in 1998 [19] and recently improved [20].

B raunstein and K in ble [18] described their proposal in the language of W igner functions, the common approach of the quantum optics community. Numerous analysis and further experiments since them mostly continued to use the W igner function formalism. I believe that the language of quantum states has advantages in discussions of the Foundations of Q uantum mechanics, so it is of interest to present the B raunstein-K in ble experiment in the language of quantum states. Section 3 is devoted to this purpose. In Section 4 the results of Section 4 are demonstrated on a particular example. But before this, I cannot resist the temptation to continue the interpretation dialogue with A sher.

II. W HAT IS ACTUALLY TELEPORTED?

In the fram ework of classical physics, teleportation, de ned as e.g. \theoretical transportation of m atter through space by converting it into energy and then reconverting it at the term inalpoint," the quotation from A sher's dictionary (W ebster), is obviously a science ction concept. M assive objects, \m atter" cannot \jum p" from one place to another. The de nition in The Oxford D ictionary

sounds equally in possible for in plan entation. However, quantum theory makes it more plausible. According to quantum theory, all elementary particles of the same kind are identical. There is no di erence between the electrons in my body and the electrons in a rock on the moon. Thus, what de ness a particular person is not a collection of the elementary particles he is made of, but the quantum state of these particles. If I want to move to the moon, I need not move my electrons, protons, etc. to the moon. It is enough to reconstruct the quantum state of the same particles there. From my point of view, I am the quantum state, so creation of this quantum state on the moon is my teleportation to the moon. C om pare this view with A sher's reply when he was asked by a new sm an, whether it was possible to teleport not only the body but also the soul: \only the soul."

In this approach, teleportation sounds as trivial as a FAX machine, but it is not. There are two reasons why it seems impossible. First, it is impossible to measure (to scan) the quantum state. Second, the amount of information needed to specify a quantum state even of a small object is so huge that it is not feasible to transmit it in a reasonable time. The dual channel of quantum teleportation does the trick: the quantum state is teleported without being scanned. The quantum channel consists of entangled pairs of elementary particles, as many as we need for the object to be teleported. Originally, at the remote location there is a mixture of di erent states in which probability for any state is the same. Then,

bcal joint measurement performed on the system to be teleported together with the bcal part of the quantum channel speci es the particular decomposition of the mixture in the remote location with relatively small number of states. Finally, the only information to be transmitted is the number of the \actual" state in the mixture. In my view, [21], the local measurement creates numerous worlds with the teleported quantum state which is deformed in various ways. The nal stage of teleportation is the correction of the deformation such that in all worlds the nal state of the remote system is the initial state of the local system.

C learly, A sher would not join me considering myself as an (unknown) quantum state. For him, a quantum state is just the know ledge of the preparer [22]:

A state vector is not a property of a physical system (nor of an ensemble of system s). ... Rather, a state vector represents a procedure for preparing or testing one or more physical system s.

Then, the correction is really not that in portant: the preparer knows that I am teleported in a particular deform ed way. The \deform ed m e" is, probably, not a living creature at all, so I tend not to accept A sher's approach. But, since we are both sure that now and in any foreseeable future, a realistic teleportation experiment with people is a science ction story, this disagreement is irrelevant.

III. WAVE FUNCTION DESCRIPTION OF THE BRAUNSTEIN-KIMBLE

SCHEME

In their sem inal paper on the implementation of continuous teleportation with squeezed light [18], Braunstein and K imble had used the W igner representation. In this section, we explain their method using wave functions.

Figure 1 is a schem atic representation of the experim ental setup envisioned by B raunstein and K im ble. The (single mode) state of the beam incident on the \in port" is to be teleported

to the \out port". To this end, a highly squeezed two-m ode state is used (which leaves the source marked \EPR"). One half of the \EPR-pair" is combined via a 50-50 beam splitter with the \in" beam and the two resulting beams are measured using hom odyne detectors D_x and D_p measuring x and p appropriately. The results of these measurements are then used to implement corrections on the other (remote) half of the EPR pair which leave it in a state which closely approximates the input state.

For simplicity, we will consider the (asymmetric) 50-50 beam splitters (see Fig 2) which act on single photons in the following way:

If the incident beam s in ports 1 and 2 are described by the quadrature-wave function $(x_1;x_2)$, then the beam splitter described by (1) leads to the transform ation [23]:

We start with the initial state (x_1) for the quadrature wave function of the input beam, $(x_2;x_5)$ for that of the (approximate) EPR -pair (the quantum channel) and initial \ready" states of two measuring devices:

U sing Eq. (2), we have for the total state after the action of the beam splitter:

At this stage, x_3 and p_4 are measured and the appropriate correction is applied to the state of the variable x_5 . The wave function in the x representation is shifted by $2x_3$, and the wave function in the p representation is shifted by $2p_4$. At this stage of our analysis we will not introduce the \collapse" of the quantum measurement, but continue to include the measuring device in the description of the total state. The shift in x leads to the following transformation:

To see the e ect of the shift in p, we apply a Fourier transform in x_4 and then multiply the function of x_5 by $e^{i\frac{p}{2}x_5p_4}$:

Thus, we have the desired teleportation of the wave function from mode 1 to mode 5.0 f course, no information about the teleported state remains in the measuring devices.

In the process, we assumed ideal hom odyne detectors and an ideal EPR source. The major di culty is the creation of the EPR source. An approximate EPR state is obtained by shining beams of squeezed light on a beam splitter (Fig.1). The light in input mode a should be highly squeezed in the x quadrature and the light on the input mode b should be highly squeezed in p. The input beam s are well approximated by G aussians:

In order to get a feel for the distortion during the teleportation, we will consider two separate cases: one in which only the squeezed light in port a is not ideal and one in which only the squeezed light in b is not ideal. In the rst case

Now, there is a partial entanglem ent between the system with the teleported state and the measuring devices. Let us look at a particular outcom e of the measurem ent in mode 4, p_4 . This eliminates the entanglem ent. Then, the nalteleported state (up to norm alization) is:

This is just a convolution of the input function with a (real) Gaussian multiplied by an (im aginary) exponent. If the Gaussian is narrow and we can neglect the distortion due to the exponent, the convolution yields approximately the input wave function, i.e., we obtain

The distortion due to the exponent depends on the value of p_4 . In order to estimate it, we can write an operator equation similar to those that appear in the original continuous teleportation paper [17]:

Taking into account the rst of the requirements (10), we see that for probable outcomes of the measurement of p_4 , $\dot{p}_4 j^{<} \frac{1}{a}$. Since we consider a narrow Gaussian such that (x) is nearly constant on an interval of length _a, the exponent does not lead to a signi cant distortion and we obtain:

A gain, there is a partial entanglem ent between the system with the teleported state and the measuring devices. Let us bok at a particular outcom e of the measurem ent in mode 3, x_3 . This eliminates the entanglem ent. Then, the nalteleported state (up to norm alization) is:

For the distortion to be small, we need the G aussian to be approximately constant over the interval where j j is signicant. Let us denote the length of this interval by l which, according to our second choice in (10), is much smaller than b. The condition is then:

which together with (10), ensures that condition for good delity teleportation (21) is satis ed.

We have seen two cases where simple estimation of teleportation distortion was possible: in one case the operation was essentially convolution with a narrow Gaussian, and in the other case the operation was essentially multiplication by a wide Gaussian. Note, that we could consider the process of teleportation in the prepresentation and then we would have the same explanations, but multiplication in the rst case and convolution in the second.

W e have shown that either of the choices

ensures that the distortion shall be small. In a real experiment, both input beams for the EPR source exhibit, of course, nite squeezing (9). Then, we can see from (6) that the nal state of the teleportation procedure (up to norm alization) is:

The analysis of this expression is more complicated, but condition (10) is su cient to ensure that the function will be teleported with little distortion, as will be seen in the computer simulation presented in the following section.

IV. A NUMERICAL SIMULATION

In this section we show numerically the impact of each parameter in the teleportation. We use as our input wave function the silhouette of a wom an Fig.(3). We would like to stress that the choice of a hum an gure is intended to aid in the visual assessment of the distortion and is not, of course, supposed to suggest that teleportation of hum and is feasible.

The characteristics of the spatial wave function are:

where we have chosen units such that h = 1. Then, the computer calculations show that the characteristics of the wave function in momentum space are:

First, we consider the case of in nite squeezing in port b and nite squeezing in port a. In Fig. 4a we show the results of the simulation for strong squeezing, $_a = 1=180 (= 1=10 p_1)$

and a probable outcome of the measurement of the momentum in mode 4, $p_4 = 180 (= 1 = a)$. Fig. 4b shows the results for the same strong squeezing, but a rare large outcome of the measurement of the momentum, $p_4 = 1800 (= 10 = a)$. Fig. 4c shows the results for weak squeezing, $a = 1 = 5.4 (= 1 = 0.3 p_1)$ and probable outcome of the measurement of the momentum $p_4 = 2.7 (= 0.5 = a)$. Finally, Fig. 4d shows the results for weak squeezing, $a = 1 = 5.4 (= 1 = 0.3 p_1)$ and rare large outcome of the measurement of the momentum, $p_4 = 10.8 (= 2 = a)$.

W e see in Fig. 4a that with strong squeezing and not too large a value of p_4 , the wave function is teleported without signi cant distortion. Fig. 4b shows that for strong squeezing, but an improbable large value of p_4 leads to distortion of the regions which require large m om enta. Fig. 4c shows that weak squeezing causes sm oothing out of sm all details of the

wave function and large p_4 and weak squeezing lead to complete distortion of the teleported wave function.

Let us analyze, for example, sm oothing out of sm all details of the wave function which we have seen in Fig. 4c. The teleported wave function is given by the convolution (14) which, with the parameters $1 = a = 5.4 p_4 = 2.7$, reads:

In Fig. 5 we draw the terms of the convolution (29). The graph shows only the real part. The imaginary part is an order of magnitude smaller then the real part. The multiplication of the Gaussian by the exponent has smalle ect, since the width of the Gaussian is smaller than most details of the wave function (v). Thus, the result of the convolution is close to the original wave function, yet some details do disappear, like the mouth.

The second case is in nite squeezing in port a and nite squeezing in port b. In Fig.

6a we show the results of the simulation for strong squeezing, $_{\rm b} = 280 (= 10 \text{ x})$ and a probable outcome of the measurement of position, $x_3 = 280 (= _{\rm b})$. Fig 6b shows the results for the same good squeezing, but rare large outcome of the measurement of position, $x_3 = 2800 (= 10 \text{ b})$. Fig. 6c shows the results for weak squeezing, $_{\rm b} = 8.4 (= 0.3 \text{ x})$ and probable outcome of the measurement of position $x_3 = 4.2 (= 0.5 \text{ b})$. Fig. 6d shows the results for weak squeezing, $_{\rm b} = 8.4 (= 0.3 \text{ x})$ and probable outcome of the measurement of position $x_3 = 4.2 (= 0.5 \text{ b})$. Fig. 6d shows the results for weak squeezing, $_{\rm b} = 8.4 \text{ and}$ rare large outcome of the measurement of the measur

We see in Fig. 6a that with strong squeezing and not too large a value of x_3 , the wave function is teleported without signi cant distortion. It is the product (20) of the original function with a wide G aussian, which for the above parameters reads:

Fig. 7 shows the wave function and the Gaussian of the product (30). We can see that the Gaussian is nearly constant over the support of the wave function, thus causing little distortion.

Fig. 6b shows that strong squeezing, but in probable large value of x_3 lead to distortion of the relative am plitude. Fig. 6c shows that weak squeezing and sm all x_3 yield relatively faithful teleportation of a sm all part of the wave function and distortion (elimination) of



other parts. A gain, weak squeezing together with large x_3 lead to complete distortion of the teleported wave function.

Finally, we compute the teleported wave function when both input states are not ideal. Fig. 8b shows that strong squeezing $_{\rm b} = 280 (= 10 \text{ x});$ $_{\rm a} = 1=180 (= 1=10 \text{ p})$ and probable outcom es $p_4 = 180 (= 1=_{\rm a}); x_3 = 280 (=_{\rm b})$ together lead to a very good delity, while large in probable outcom es $p_4 = 1800 (= 10=_{\rm a}); x_3 = 2800 (= 10_{\rm b})$ lead to signi cant distortion, see Fig. 8c.

The discussion of the physical meaning of teleportation and the analysis of continuous variables teleportation experiment which we performed here provides an intuitive picture of the process and helps to understand the elect of various parameters on the delity of teleportation. We hope it will be useful for designing better teleportation experiments.
