Lazy' quantum ensembles

Abstract

We compare di erent strategies aim ed to prepare an ensem ble with a given density matrix . Preparing the ensem ble of eigenstates of with appropriate probabilities can be treated as 'generous' strategy: it provides maxim al accessible inform ation about the state. A nother extrem ity is the so-called 'Scrooge' ensem ble, which is mostly stingy to share the inform ation. We introduce 'lazy' ensem bles which require minim alle orts to prepare the density matrix by selecting pure states with respect to completely random choice.

We consider two parties, A lice and Bob, playing a kind of game. Bob wishes to guess which pure state is prepared by A lice. H is nullhypothesis, based on the lack of any inform ation about A lice's intention, is that A lice prepares any pure state with equal probability. Then, the average quantum state m easured by Bob turns out to be , and he has to make a new hypothesis about A lice's intention solely based on the inform ation that the observed density matrix is . The arising 'lazy' ensemble is shown to be the alternative hypothesis which m inim izes the Type I error.

Introduction

Consider two parties, A lice and Bob, playing the following game. A lice prepares a pure quantum state according to certain random strategy and then sends it to Bob. Initially Bob possesses no information about A lice's strategy and thus assumes that A lice performs a completely random choice of pure state, we refer to this statement as a null hypothesis. In this case the average density matrix received by Bob would be be proportional to identity.

M easuring the received states, Bob realizes that the average quantum state em itted by A lice is . However, there are in nitely m any ensembles which average to , and Bob still can not recover the strategy of A lice. A lthough B ob now possesses som e inform ation about A lice's intentions: if the received density m atrix di ers from identity, B ob has to m ake an alternative hypothesis. To specify such a hypothesis, som e extra principles m ust be taken into account. These principles should capture the type of A lice's behavior.

W e m ight assume that the strategy of A lice is to prepare eigenstates of with given probabilities, but this is just an assumption that A lice is generous' in providing the accessible information. Or, conversely, A lice m ight be stingy with the information and thus chooses pure states according to Scrooge distribution [1].

In our game, Bob is reluctant to change his opinion and chooses among A lice's strategies (which average to) the closest to his null hypothesis. By closest' we mean minimizing the Kullback-Leibler [2] distance between the distributions. This distance is the average likelihood ratio and is associated with the probability of the Type I error¹.

A nother way for B ob's reasonings is to assume A lice to be lazy in e orts to prepare the ensemble. These e orts are quantiled in terms of dilerential entropy. Remarkably, as we show in Section 1, both approaches yield the same ensemble (3).

1 Dierential entropy and likelihood ratio

First we have to specify a yet vague notion of preparation e orts' for an ensemble. Following [3] we formulate it in therm odynamic terms, namely,

we quantify these e orts by the di erence between the entropy of uniform distribution (that is, our null hypothesis) and the entropy of the ensemble² in question. The only obstacle m ay occur is to de ne this entropy, let us dwell on it in more detail.

The entropy of a nite distribution fpig is given by Shannon form ula

This expression diverges for any continuous distribution: we approxim ate a continuous distribution (x) by a discrete one fp_ig, calculate its Shannon entropy, but it tends to in nity as we re ne the partition. However, we are always interested in the di erence between the entropy of the uniform distribution and the distribution (x) rather than the entropy itself. At each approximation step we calculate this di erence, and the appropriate limit always exists. To show it (see, e.g. [5] for details), make a partition of the probability space by N sets $_i$ having equal uniform measure. Then the di erence E_N between the entropies read:

where $p_i = \prod_{i=1}^{R} p(x) dx$. The lim it expression $\lim_{N \le 1} E_N$ is the dimential entropy

Remarkably, this is equal to Kulback-Leibler distance [2]

$$S(k_{0}) = (x) \ln \frac{(x)}{0} dx$$

between the distribution (x) and the uniform distribution $_0(x)$ with constant density, normalize the counting measure dx on the probability space so that $_0 = 1$. This distance is the average likelihood ratio, on which the choice of statistical hypothesis is based. Then, in order to minimize the Type I error we have to choose a hypothesis with the smallest average likelihood ratio.

2 Lazy'ensembles

The main problem reduces to the following. For given density matrix nd a continuous ensemble having minimal di erential entropy (1):

where d is the unitary invariant measure on pure states norm alized to integrate to unity. W hen there is no constraints in (2), the answer is straightforward | the minimum (equal to zero) is attained on uniform distribution. To solve the problem with constraints, we use the Lagrange multiples method. The appropriate Lagrange function reads:

where the Lagrange multiple is a matrix since the constraints in (2) are of matrix character. Substituting the expression (1) for S () and making the derivative of L over zero, we get

where B is the optim al value of the Lagrange multiple which we derive from the constraint (2) and the norm alizing multiple

is the partition function for (3). Substituting he resulting density (3) to the expression (1) for di erential entropy we get

3 Explicit expressions

First evaluate the partition function (4) in the eigenbasis of B. This integral is a special case of the calculations carried out in [6], according to which

Z (B) reads:

where b_k are the eigenvalues of B. If two orm ore of them are equal, the appropriate expression is obtained as a limit starting with unequal eigenvalues. To write down the expression for the eigenvalues $_s$ of the density matrix via B we could evaluate the integrals

in the eigenbasis of . A lthough, like in therm odynam ics, we have

which gives the explicit expression for the eigenvalues of the density ${\tt m}$ atrix :

from which we see that the resulting density matrix remains unchanged when we add a constant to $allb_k$ -s. That means that the matrix 'tem perature' parameter B for the lazy ensemble is de ned up to an additive constant (in contrast with classical therm odynamics).

Like in [1], the expression (6) for the partition function can be given the following integral form

where the contour encloses all eigenvalues of B.

So, given a lazy ensemble (3) with the parameter B, we have written down the expression (7) for its average density matrix. This expression is well-de ned for any matrix B. The existence problem remains: given a density matrix, is there a lazy ensemble with appropriate parameter B which averages to? Similar question | the existence of tem perature function | arises in therm odynamics. The idea to solve it is the following [5]: we consider the n-dimensional CDF (cum ulative density function) of the measure and study the asymptotics of its Laplace transform. As a result, it can be shown that B exists for any full-range density matrix.

4 Special case: spin-1/2 particle

In this case the state space has dimension 2. Write down the parameter B in the eigenbasis of the density matrix in a suitable form :

$$B = b I + 0 + (10)$$

Then the expression (6) for partition function reads:

Calculating the partial derivatives according to (8), we get the following expressions for the ∞ e cients _{1,2} of the density matrix



Denote by f() the inverse to . Since the is odd and monotone function of , its inverse f exists and bears the same properties. Then the matrix B (10) is the following function of the density matrix

B = b I +

Since the expression (13) for is the independence of the choice of b, in twodimensional case both matrices B and are dened by their mean deviation values and , respectively. So, the essential dependence of the matrix temperature' parameter B from the density matrix is completely captured by the function f. Its graph books as follows.



5 Lazy ensembles are equilibrium

Like G ibbs ensembles in therm odynam ics, the lazy ensembles are equilibrium, namely, the introduced 'temperature' parameters B possess the equalizing property. To show it, rst introduce the notion of conditional ensemble. In term s of game played by A lice and B ob this means that B ob measures a xed observable H upon the particles emitted by A lice. A gain, he has the uniform distribution as null hypothesis, but the constraint in (2) is of scalar rather than of matrix character. Solving the appropriate variational problem

we obtain

this ensemble is conditional with respect to given observable H .

Consider two quantum systems with state spaces H and H 0 , respectively. Let their states initially be and 0 . Then, since we consider a non-interacting

coupling of the system s, the joint density matrix is 0 in the tensor product space H H⁰. Let us measure the sum of values of the observables H and H⁰, that is, introduce the observable H = H I⁰ + I H⁰. The conditional optim alensem ble of separable states with respect to the observable H is the follow ing distribution

Like in classical therm odynamics, the partition function of the joint system is the product of subsystem s' partition functions:

therefore the equalizing property holds

which means that the conditional lazy ensembles are equilibrium and that plays the rôle of tem perature parameter.

Concluding rem arks

C ontinuous ensembles of pure states proved their relevance in various aspects of quantum mechanics. From the theoretical perspective, they provide the lim it cases on which num erical characteristics of density matrices are attained, for instance, the minimal value of accessible information about the state is attained on Scrooge' ensemble which is a continuous distribution [1]. Furthermore, we claim that they are relevant from the operationalistic point of view. Even if we are speaking of preparing discrete ensembles, we must also have in mind that their are unavoidably smeared by various noises and, strictly speaking, we have to deal with continuous distributions.

We use the techniques of continuous ensembles to carry out statistical inference in quantum realm according to the standard scheme: we have an a priori hypothesis (we necessarily need it, otherwise there is no way to make any inference [7]), then we obtain some information about the system and have to shift to a new hypothesis.

In our case the null hypothesis is the assumption that any pure state is em itted with equal probability. Then the information is obtained that the average density matrix of the state is . We show how, starting from the hm inimale ort' assumption, to guess the strategy of the preparation of the pure states. As a result, we obtain so-called 'lazy' ensembles.

These ensembles are also proved to provide the minimal deviation from the null hypothesis. They are described by exponential distributions (3) of pure states averaging to a given density matrix :

where the matrix parameter B plays a rôle in some respect similar to tem perature, in particular, it is shown to possess the equalizing property. A lthough we may not treat it as a fully-edged tem perature, for instance, in contrast with classical therm odynamics, it is ambiguously de ned up to an arbitrary additive constant. A coording to form ula (5), we can so choose the additive gauge for B that ln Z will vanish and the mean value TrB will be equal to the di erential entropy of the ensemble, so we may call this matrix parameter B di erential entropy observable'.
