# Existence C riterion of $G$ enu ine $T$ ripartite Entanglem ent

#### Abstract

In this paper, an intuitive $m$ athem atical form ulation is provided to generalize the residualentanglem ent for tripartite system sof qubits (Phys. Rev. A 61, 052306 (2000)) to the tripartite system s in higher dim ension. The spirit lies in the tensor treatm ent of tripartite pure states ( P hys. R ev. A 72,022333 (2005)). A distinct characteristic of the present generalization is that the form ulation for higher dim ensional system $s$ is invariant under perm utation of the subsystem $s$, hence is em ployed as a criterion to test the existence of genuine tripartite entanglem ent. Furthem ore, the form ulation for pure states can be conveniently extended to the case of $m$ ixed states by utilizing the kronecker product approxim ate technique. As applications, we give the analytic approxim ation of the criterion for weakly m ixed tripartite quantum states and consider the existence of genu ine tripartite entanglem ent of som e weakly $m$ ixed states.

## I. IN TRODUCTION

Entanglem ent is an essential ingredient in the broad eld of quantum inform ation theory. It is the basis of a lot of quantum protocols, such as quantum computation [1], quantum cryptography [2], quantum teleportation [3], quantum dense coding [4] and so on. It has been an im portant physical resource. R ecently, $m$ any efforts have been $m$ ade on the quanti cation of the resource $[5,6,7,8]$, how ever, the good understanding is only lim ited in low-dim ensional system s. The quanti cation of entanglem ent for higher dim ensional system $s$ and $m$ ultipartite quantum system s rem ains to be an open question.

Since the rem arkable concurrence was presented [5], it has been show $n$ to be a useful entanglem ent $m$ easure for the system $s$ of qubit. $M$ ore interestingly, based on the concurrence, Valerie C o m an et al [9] introduced the so called residual entanglem ent for tripartite system s of qubits. The residualentanglem ent is independent on the perm utation of the qubits, hence can be em ployed to $m$ easure genuine three-party entanglem ent, i.e. the tripartite entanglem ent, which opens the path to studying $m$ ultipartite entanglem ent. B ased on the $m$ otivation of generalizing the de nition of the residual entanglem ent to higher dim ensionalsystem $s$ and $m$ ultipartite quantum system S, A lexander $W$ ong et al [10] introduced the de nition of the $n$-tangle for $n$ qubits $w$ ith $n$ even, how ever, the $n$-tangle itself is not a m easure of the $n$-partite entanglem ent. Later, hyperdeterm inant in Ref. [11] has been show $n$ to be an entanglem ent $m$ onotone and represent the genuine $m$ ultipartite entanglem ent. H ow ever, it is easy to nd that the hyperdeterm inant for higher dim ensional system $s$ and $m$ ultipartite system can not be explicitly given conveniently. In particular, so far the

[^0]hyperdeterm inant as an entanglem ent $m$ easure has not been able to be extended to $m$ ixed system $s$. Further$m$ ore, a new $m$ ethod by constructing $N$-qubit entangle$m$ ent $m$ onotones w as introduced by A ndreas O sterloh et al [12] for pure states to $m$ easure the $n$-partite entanglem ent, how ever, it is only con ned to the system s of qubits and seem s to be very di cult to extend to the case ofm ixed states analogously to $R$ ef. [11].

In this paper, we introduce a new approach to generalize the residual entanglem ent for tripartite system $s$ of qubits to the tripartite system $s$ in higher dim ension. O ne knows that the key to obtaining the explicit A B C in Ref. [9] is the analytic expression of the concurrence in $m$ ixed system $s$ of qubits. H ow ever, so far no one has been able to obtain an analytic expression of concurrence (or concurrence vector) for higherdim ensionalm ixed system $s$, which $m$ eans that the expectable results for higher dim ensional system $s$ seem $s$ not to be obtained from the sim ilar $m$ ethod to that in Ref. [9]. Hence, we provide an intuitive $m$ athem atical form ulation to generalize the residual entanglem ent according to the tensor treatm ent oftripartite pure states presented in $R$ ef. [13]. A distinct characteristic of the present generalization is that the form ulation for higher dim ensional system $s$ is invariant under perm utation of the subsystem $s$ (i.e. the qudits), hence can be em ployed as a criterion to test existence of the genuine tripartite entanglem ent (also called tripartite entanglem ent for convenience in the paper). Further$m$ ore, the form ulation for pure states can be conveniently extended to the case ofm ixed states by utilizing the kronecker product approxim ate technique $[14,15]$. H ow ever, it should be noted that the formulation is not an entanglem ent $m$ easure except that for tripartite system $s$ of qubits due to the variance under localunitary operations. As applications, we give the analytic approxim ation of the criterion for weakly $m$ ixed tripartite quantum states (quasipure states) and consider the existence oftripartite entanglem ent ofsom e quasipure states, which show sthat our criterion can be conveniently applied in these cases.

The paper is organized as follow s. Firstly, we give the intuitive generalization of the residual entanglem ent for pure states; secondly, we extend it to $m$ ixed states and discuss the existence of tripartite entanglem ent of som e quasipure states; the conclusions are draw $n$ in the end.

## II. EXISTENCECRITERION OFTRIPARTITE ENTANGLEMENTEOR PURE STATES

The residual entanglem ent for tripartite system $s$ of qubits or A B C (i.e. the tripartite entanglem ent $m$ easure) is given by

W hat's more, the a term $s$ in above equations are the $\mathrm{P}_{1}$ cients in the standard basis de ned by $j_{\mathrm{ABC}} \mathrm{i}=$
${ }_{i ; j ; k=0}^{1} a_{i j k} \ddot{\mu} j k i_{A B C}$. Asmentioned in Ref. [9], the expression of ( $j_{\text {A в с }}$ i) can be m entally pictured by im agining the eight coe cients $a_{i j k}$ attached to the comers of a cube. The picture yields that is invariant under perm utations of the qubits, because a perm utation of qubits corresponds to a re ection or rotation of the cube. It happens that the picture is consistent to the tensor cube introduced in Ref. [13]. In other words, a tensor cube of $j_{\text {A }}$ C $i$ corresponds to a tripartite entanglem entm easure ( $j_{\text {A }}$ C $i$ i). For convenience, weem ploy $f\left(j_{A B C}\right)=j\left(j_{A B C} i\right) j^{2}$ to $m$ easure tripartite entanglem ent, which is equivalent to ( $j_{A B C}$ i) from the view point of entanglem ent $m$ easure. Obviously, $f$ ( $j$ А в с i) has the sam e properties to ( $j_{\text {A B C }}$ i).

A ccording to Ref. [13], a tripartite pure state in any dimension can be regarded as the tensor grid ${ }_{P}^{\text {Which }}{ }_{P}^{\text {includes }}$ tensor cubes. E.g. let $\mathrm{j}_{\mathrm{ABC}} \mathrm{i}=$ ${\underset{i}{i} j=0}_{1}^{P_{k=0}^{2}} a_{i j k} \quad \ddot{i} j k i_{A B C}$, the tensorgrid of $j_{A B C}$ ican be pictured as gure 1, which includes three tensor cubes. In this sense, one can draw a conclusion that tensor cube is the unit of tensor grid. Since every tensor cube in a

tensor grid can be considered as an non-norm alized tripartite pure state of qubits, one can get that every unit corresponds to the tripartite entanglem ent $m$ easure of the non-norm alized pure state. N am ely, the tensor cube corresponds to the $m$ inim al unit of describing the tripartite entanglem ent. T herefore, whether there exist som e genuine tripartite entanglem ent can be determ ined by all the $m$ inim alunits.

Theorem 1:For any a tripartite pure state $j$ iwhich inchudes $M \mathrm{~m}$ inimal units $m$ entioned above, let the the non-norm alized tripartite pure state of qubits corresponding to the ith unit be denoted by $j_{i} i$, then the corresponding tripartite entanglem ent can be given by f ( $\left.{ }^{\prime}{ }_{i} i\right)$. De ne
for the state $j i$, then if there does not exist genuine tripartite entanglem ent in $j$ i, $F(j i)=0$.

Proof. It is obvious that $F(j i)=0 \mathrm{~m}$ eans that $\mathrm{f}\left(\mathcal{J}_{i} i\right)=0$ holds for all ${ }^{\prime}{ }_{i}$, vige versa. Since the tensor cube corresponds to the m inim al unit of describing the tripartite entanglem ent, $F$ ( $j$ i) $=0$ show sthat there does not exist genuine three-party entanglem ent in $j i$. That is to say, $F$ ( $j$ i) can e ectively test the existence of tripartite entanglem ent in $j$ i. Furtherm ore, a perm utation of qudits corresponds to a re ection or rotation of the tensor grid, which is sim ilar to that in Ref. [9], hence all the tensor cubes in the tensor grid are invariant except the relative positions in the grid. N am ely, F (j i) is invariant under perm utations of the qudits.

## III. EXISTENCECRITERION OFTRIPARTITE ENTANGLEMENT FOR M IXED STATES

A. K ronecker product approxim ation technique

W e rst introduce the kronecker product approxim ation technique $[14,15]$. For any a matrix $M=\left[m_{i j}\right], w$ ith

## C. Examples

In above subsection, we have provided three di erent low erbounds for any $m$ ixed state, which can be em ployed as necessary conditions to test the existence of tripartite entanglem ent in principal. H ow ever, by analysis, one can nd that the num erical realization to calculate the bounds for am ixed state requires the eigenvalue decom position ofa $m$ atrix de ned in the sam edim ension to that of $\underset{i=1}{4}$, which reduces the e ciency of calculation. In order to avoid the sim ilar problem, an analytic approxim ation $m$ ethod was introduced for quasi pure states in Ref. [19]. By utilizing the analogous $m$ ethod, one will nd that eq. (17) can be sim pli ed signi cantly, hence our criterion can w ork well for quasi pure states. Before the exam ples, we rstly give the analytic approxim ation of eq. $\mathrm{P}^{(17)}$.

can be considered as a quasi pure state for $\mathrm{x}>1=3$. $F_{a}(\mathrm{x})$ ) is show n in F ig. 2, which indicates the consistent conclusion to that in Ref. [20]. W hat's m ore, for the quasi pure states generated by the $m$ ixture of $m a x-$ im ally $m$ ixed state (identity $m$ atrix) and tripartite G H Z state ( $T$ he cases in $3 \quad 3$ dim ension is included.), the corresponding $\mathrm{F}_{\mathrm{a}}(\mathrm{l}$ s can all be show n to be nonzero. Since $F_{a}()$ is not $m$ onotone in higher dim ension, the corresponding gures are not given here.

## IV. CONCLUSION AND D ISCUSSION

In sum $m$ ary, we have introduced an intuitive $m$ athe$m$ atical form ulation to generalize the original tripartite entanglem ent to higher dim ensional tripartite system $s$ according to the tensor treatm ent of a tripartite pure state. A distinct characteristic of the present generalization is that the form ulation for higher dim ensional system $s$ is invariant under perm utation of the qudits. W hen the form ulation is reduced to tripartite system s ofqubits, there exists an exponent $\frac{1}{2}$ di erent from the original one, but the change of exponent provides convenience for the generalization to $m$ ixed states. The form ulation for pure states can be conveniently extended to the case of

conditions to test the existence of tripartite entangle$m$ ent, but the su ciency of them $m$ ay be di erent. H ow ever, because the dim ension of $A$ is m uch higher than that corresponding to bipartite entanglem ent, it seem s to be a bit di cult to directly apply to test the existence of tripartite entanglem ent of a general quantum $m$ ixed state. Fortunately, for the weakly $m$ ixed states, i.e. quasipure states, one can nd that our criterion can be conveniently applied and is even a su cient condition for the existence of tripartite entanglem ent. In particular, our criterion can provide an analytic approxim ation. Since the 3-tangle is an entanglem ent $m$ easure, $\mathrm{F}_{\mathrm{a}}(\mathrm{l}$ ) is not only an existence criterion, but also an e ective tripartite entanglem ent indicator. Even though there exist som e questions left open, the intuitive $m$ athem atical formulation of tripartite entanglem ent and the convenient extension to $m$ ixed states $w i l l$ play an im portant role in the further understanding of $m$ ultipartite entanglem ent m easure.
