# A complete algorithm to nd ows in the one-way measurement model

#### A bstract

This article is the complement to [7], which proves that ows (as introduced by \$]) can be found e ciently for patterns in the one-way measurement model which have non-empty input and output subsystems of the same size. This article presents a complete algorithm for noting ows, and a proof of its' correctness, without assuming any knowledge of graph-theoretic algorithms on the part of the reader. This article is a revised version of [4], where the results of [7] also rst appeared.

### 1 Introduction

In the one-way measurement model [1, 2, 3], algorithms are essentially described by a sequence of single-qubit measurements (where the choice of measurement may depend on earlier measurement results in a straightforward way) performed on a many-qubit entangled state. This many-qubit state may be described in terms of the state of an input system I, together with a graph G of entangling operations involving I and a collection of auxiliary qubits prepared in the j+i state: each edge of G represents a single controlled-Z operation between two qubits. A fler the sequence of measurements, any qubits left unmeasured still support a quantum state, and are interpreted as an output system 0. A triple (G; I; O) belonging to a given pattern is called the geometry of the pattern.

In [4], it was shown that the ow property de ned by Danos and Kashe 5I can be e ciently tested for a geometry (G;I;O) when JJ = JO. The property is the existence of a causal ow<sup>1</sup>, which describes a partial order 4 describing an order (independent of measurem ent angles) in which the qubits of the geometry may be measured to perform a unitary embedding, once suitable corrections are applied to the output qubits. Causal

owsmay allow quantum algorithms to be devised in the one-waymeasurementmodelwithout using the circuit model: [6] proposes one way in which this might be done.

This article presents a complete algorithm for noting causal ows for a geometry (G; I; O) with Ji = D jin time O (km), where k = Ji = D jand m = E (G) j, suitable for an audience with no experience in graph-theoretic algorithm s. This is a revised version of [4], re-written with the aim of focusing on the algorithm for noting ows for the sake of reference. For the graph-theoretic claracterization of ows, this article refers to [], which is an improved presentation of the graph-theoretic results presented originally in [4].

A lthough no know ledge of graph-theoretic algorithm s is assumed, a basic understanding of graph theory and the one-way measurement model is essential. For basic de nitions in graph theory, readers may refer to Diestel's excellent text [9]; I will use the conventions of [7, 8] for describing patterns in the one-way model.

## 2 Prelim inaries

In this section, we will x our conventions and review the results and term inology of [].

#### 2.1 Basic notation and conventions

For a graph G, we write V (G) for the set of vertices and E (G) for the set of edges of G. Sim ilarly, for a directed graph (or digraph) D, we write V (D) for the set of vertices and A (D) for the set of directed edges (or arcs) of D. If x and y are adjacent, we let xy denote the edge between them in a graph, and x ! y denote an arc from x to y in a digraph. We will use the convention that digraphs m ay contain loops on a single vertex and multiple edges between two vertices, but that graphs cannot have either.

W hen a graph G is clear from context, we will write x = y when x and y are adjacent in G, and write  $S^{c}$  to represent the complement of a set of vertices S = V (G).

If C is a collection of directed paths (or dipaths), we will say that x ! y is an arc of C, and that the edge xy is covered by C, when x ! y is an arc in a path P 2 C.

In this paper, N denotes the non-negative integers. For any n 2 N, [n] denotes the set fj 2 N jj < ng.

#### 2.2 Results for Causal Flows

2.2.1 De nition and motivation

Denition 1. A geometry (G;I;O) is a graph G together with subsets I;O V (G). We call I the input vertices and O the output vertices of the geometry. A causal ow on (G;I;O) is an ordered pair (f;4), with a function  $f:O^{\circ}$ ! I<sup>o</sup> and a partial order 4 on V (G), such that

(Fi) x f(x); (Fii) x 4 f(x); (Fiii) y f(x) = x 4 y; (1)

hold for all vertices x 2 0  $^{\circ}$  and y 2 V (G). We will refer to f as the successor function of the causal ow, and 4 as the causal order of the causal ow.

A geom etry (G; I; O) represents the inform ation of a one-way measurem ent pattern which is independent of the order of operations and measurem ent angles. G is the entanglem ent graph of the pattern, I is the set of qubits which are not prepared in a xed state initially (their joint initial state in the algorithm may be arbitrary), and O represents the set of qubits which are not measured in the pattern (which thus support a nalquantum state).

The conditions (Fi) { (Fiii) are motivated by how byproduct operators and signal dependencies are induced by commuting correction operations to the end of a pattern which performs a unitary embedding. The signing cance of a causal ow on a geometry (G;I;O) is that any pattern de ned on that geometry can be transformed into one which has the same measurement angles and which performs a unitary embedding H<sub>I</sub> ! H<sub>O</sub>. In particular, this means that unitary embeddings can be devised in the measurement model by ignoring signal dependencies and treating each measurement operator as though it post-selects for some one of the states in the basis of the measurement. See Section 2.2 of [7] for details.

#### 2.2.2 G raph-theoretic characterization

The result of [7] was obtained by characterizing causal ows in terms of collections of vertex-disjoint paths.

De nition 2. Let (G;I;O) be a geometry. A collection C of (possibly trivial) directed paths in G is a path cover of (G;I;O) if

(i). each v 2 V (G) is contained in exactly one path (i.e. the paths cover G and are vertex-disjoint);

(ii). each path in C is either disjoint from I, or intersects I only at its initial point;

(iii). each path in C intersects O only at its nalpoint.

The successor function of a path cover C is the unique  $f: 0^{\circ}$  ! I<sup>c</sup> such that y = f(x) if and only if x ! y is an arc of C. If a function  $f: 0^{\circ}$  ! I<sup>c</sup> is a successor function of some path-cover of (G;I;O), we call f a successor function of (G;I;O).

If a geometry (G;I;O) has a causal ow (f;4), the maximal orbits of the successor function f de ne a path cover for (G;I;O), which allow us to consider the causal ow in terms of vertex-disjoint paths in G:

Theorem 3 [7, Lem m a 3]. Let (f;4) be a causal ow on a geometry (G;I;0). Then there is a path cover  $P_f$  of (G;I;0) whose successor function is f.

G iven that the successor function of a causal ow for (G;I;O) induces a path cover, one might think of also trying to obtain a causal ow from the successor function of a path cover. There is an obvious choice of binary relation for a successor function f :

De nition 4. Let f be a successor function for (G;I;O). The natural pre-order 4 for f is the transitive closure on V (G) of the conditions

  $x 4 f(x);$   $y f(x) = x 4 y;$  (2)

for all x; y 2 V (G).




Figure 1: A geometry with a successor function  $f: 0^{\circ}$  !  $I^{\circ}$ , but no causal ow.

If 4 is a partial order, it will be the coarsest partial order such that (f;4) is a causal ow. However, it is easy to construct geom etries where 4 is not a partial order. Figure 1 illustrates one example. For any choice of successor function f on this geom etry, (Fiii) forces either  $a_0 \ 4 \ a_1 \ 4 \ a_2 \ 4 \ a_0 \ or \ a_0 < a_1 < a_2 < a_0$  to hold. Because  $a_0$ ,  $a_1$ , and  $a_2$  are distinct, such a relation 4 is not antisymmetric, so it isn't a partial order.

In the example above, we have a cycle of relationships induced by condition (Fiii). The following de nitions characterize when such cycles of relationships occur.

Denition 5. Let (G;I;O) be a geometry, and F a family of directed paths in G. A walk  $W = u_0 u_1 \cdots u_1$  is an in uencing walk<sup>3</sup> for F if it is a concatenation of zero or more paths (called segments of the in uencing walk) of the following two types:

xy,where x ! y is an arc of F;

xzy,where x ! z is an arc of F and yz 2 E (G).

A vicious circuit for F is a closed in uencing walk for F with at least one segment.

Theorem 6 [7, Lemma 9]. Let C be a path cover for (G; I; O) with successor function f, and let 4 be the natural pre-order of f. Then x 4 y if and only if there is an in uencing walk for C from x to y.

G iven that we want to forbid cycles of relationships for the natural pre-order 4 , we are then interested in the following restriction of path covers:

De nition 7. A path cover C for (G; I; O) is a causal path cover if C does not have any vicious circuits in G.

Theorem 8 [7, Theorem 10]. Let (G; I; O) be a geometry with path cover C, f be the successor function of C, and 4 be the natural pre-order for f. Then C is a causal path cover if and only if 4 is a partial order, which occurs if and only if (f; 4) is a causal ow for (G; I; O).

By characterizing causal ows in terms of causal path covers, we can make use of the following result:

Theorem 9 [7, Theorem 11]. Let (G; I; O) be a geometry such that j j = j 0 j, and let C be a path cover for (G; I; O). If C is a causal path cover, then C is the only maximum collection of vertex-disjoint I { O dipaths.

Then, if  $J_{ij} = 0$  j and (G;I;O) has a causal ow, there is a unique maximum -size collection of vertex-disjoint I { O paths, and that collection is a causal path cover which allows one to reconstruct a causal ow. Taking the contrapositive, if we can nd a maximum -size collection of vertex-disjoint paths from I to O which is not a causal path cover, then (G;I;O) does not have a causal ow.

## 3 An e cient algorithm for nding a causal ow when ji = j0 j

Using Theorem s 8 and 9 when jIj = jDj, we can reduce the problem of nding a causal ow to nding a maximum -size family of vertex-disjoint I{O paths in G.G iven such a family of paths F, we may then verify that the resulting family form s a path cover for G, obtain the successor function f of F, and attempt to build a causal order compatible with f.W e illustrate how this may e ciently be done in this section.

Im plem entation details. For the purpose of run-time analysis, I x here conventions for the data structures used to implement graphs, paths, and sets throughout the following algorithms.

W e will assume an implementation of graphs and digraphs using adjacency lists for each vertex x (in the case of digraphs, using two separate lists for the arcs entering x and those leaving x). Such an implementation can be easily performed in space O (m), where m is the number of arcs/edges, assuming a connected (di-)graph.<sup>4</sup>

Sets of vertices are considered to be in plemented via arrays storing the characteristic function of the set. W e m ay assume without loss of generality that these are also used to perform bounds-checking on arrays which are used to implement partial functions on V (G), such as successor functions f:  $0^{\circ}$ !  $1^{\circ}$ .

Collections of vertex-disjoint dipaths F in a graph G will be implemented as a set V (F) indicating for each x 2 V (G) whether x is covered by F, and a digraph containing all of the arcs of F. A swell, functions prev and next will be dened for all vertices in F (respectively, 0 °) covered by F which returns the predecessor (respectively, successor) of a vertex covered by F.

Throughout some of the algorithm s below, a family of vertex-disjoint paths m ay be transformed into to a graph where a single vertex has out-degree 2, but every other vertex has out-degree at m ost 1, and every vertex has in-degree at m ost 1. So long as these bounds are m aintained, determ ining whether a vertex is covered by F, whether an arc is in F, and adding/deleting arcs from F can be done in constant time. A swell, the function prev will be well-de ned so long as the in-degree of the graph representation of F is bounded by 1.

### 3.1 E ciently nding a path cover for (G;I;O)

Given a geometry (G; I; O), we are interested in obtaining a maximum -size family F of disjoint I { O paths in G in order to test whether it is a causal path cover. This is known to be e ciently solvable.

Problem s involving constructing collections of paths with some extrem all property in graphs are usually solved by reducing the problem to a problem s of network ow s on digraphs: algorithm s for such problem s have been very well studied. (Section 4.1 of [7] outlines an algorithm of this kind to nd a maximum -size fam ily of disjoint I { 0 paths.) However, in order to present a solution which does not assume any background in graph-theoretic algorithm s, and also in order to reduce the number of auxiliary concepts involved in the solution, I will present an algorithm not explicitly based on network ow s<sup>5</sup>. A dividend of such a presentation is that it highlights the relationship between in uencing walks and walks which alternate with respect to a collection of disjoint paths, which was alluded to in D e nition 5.

#### 3.1.1 A lternating and augm enting walks

De nition 10. Let I; O V (G). A collection of vertex-disjoint paths from I to O is proper if its' paths intersect I and O only at their endpoints.

A collection of k vertex-disjoint I { 0 paths of is necessarily proper when jij = j0 j = k. We would like to arrive at such a maximum -size collection by producing successively larger proper collections of vertex-disjoint paths. To so so, we will use results of graph theory pertaining to M enger's Theorem . The basic approach present is outlined in Section 3.3 of [9].

De nition 11. For a fam ily F of vertex-disjoint directed paths from I to O, a walk  $W = u_0 u_1$  in G is said to be pre-alternating with respect to F if the following hold for all 0 < j;k 6 ':

- (i). F does not contain  $u_j ! u_{j+1}$  as an arc;
- (ii). if  $u_j = u_k$  and  $j \in k$ , then  $u_j$  is covered by F;
- (iii). if  $u_j$  is covered by F , then either  $u_j$  !  $u_{j1}$  or  $u_{j+1}$  !  $u_j$  is an arc of F .

W is said to be alternating with respect to F if W is pre-alternating with respect to F, and  $u_0$  is an element of I not covered by F.W is an augmenting walk for F if W alternates with respect to F, and  $u_0 \ge 0$ .

Figure 2 illustrates two pre-alternating walks for a fam ily F of vertex-dispint paths in a geometry (G;I;O).



Figure 2: Two examples of a walk W (hollow arrows) which is pre-alternating with respect to a collection F of vertex-disjoint paths from I to O (solid arrows). In both examples, circled vertices are entry points of W into F (see Denition 13).

The relationship between in uencing walks and pre-alternating walks is most clear for a path cover C of (G;I;O), in which case an in uencing walk for C is the reverse of a walk which is pre-alternating for C. As we will see in the next few pages, pre-alternating walks describe ways in which di erent fam ilies of disjoint paths from I to O are related to each other: this is essentially the reason why a vicious circuit (i.e. a closed in uencing walk) exists for a path cover whenever there is a second fam ily of disjoint I { O paths of the same size.

First, we will show that augmenting walks for F are always present if  $\frac{1}{F} \leq \frac{1}{J} = \frac{1}{J}$ , and if there is a fam ily of vertex-disjoint I { 0 paths of size k :

Theorem 12. Let G be a graph, and I;  $O \setminus (G) \in J = D = k$ . Let F be a collection of vertex-disjoint I { O paths with  $f \in J < k$ , and i 2 I be a vertex not covered by F. If there is a collection C of vertex-disjoint dipaths from I to O with  $f \subset J = k$ , then there is an augmenting walk W for F starting at i which traverses each edge of G at most once, and where i is the only input vertex in W not covered by F.

Proof Suppose G contains a collection C of k vertex-disjoint I { O dipaths, let F be some proper collection of vertex-disjoint I { O dipaths of size less than k, and let  $I^0 \notin ?$  be the set of input vertices not covered by F. Let us say that a vertex v 2 V (G) is an incidence point of C and F if v is covered by both C and F, and there is a vertex w which is adjacent to v in a path of C but which is not adjacent to v in any path of F. Let I be the set of incidence points of C and F, and let G be a di-graph with V (G) =  $I^0$  [ I [ O, and (x ! y) 2 A (G) for x; y 2 V (Q) if one of the follow ing applies:

there exists a vertex z 2 I such that

(i). x and z lie on a common path P in C, where z is the next incidence point in P after x, and (ii). y and z lie on a common path  $P^0$  in F, where z is the next incidence point in  $P^0$  after y;

x and y lie on a common path P in C, there are no incidence points on P after x, and  $y \ge 0$ .




Figure 3: Two fam ilies of vertex-disjoint I { O paths in a graph: one fam ily C with k paths (hollow arrows), and one fam ily F with < k paths (solid arrows). C incled vertices are the incidence points of C and F . D ashed lines are the other edges of the graph.




Figure 4: The digraph G obtained by applying the construction above to Figure 3. D ashed arrows represent the edges from path segments belonging to either C or F in the originalgraph; thick black arrows are the actual arcs of G, which are induced by those path segments.

Because both C and F are vertex-disjoint collections of paths, it is easy to show that the maximum in-degree and out-degree of G are both 1. Thus, G consists of vertex-disjoint di-cycles, walks of length 2, isolated vertices, and directed paths.

Because each v 2  $I^0$  is not covered by a path of F, and is not preceded by any vertices in it's respective path of C, it has in-degree 0 in G. Then, each element of  $I^0$  is at the beginning of a maximal dipath in G. Furthermore, each vertex in v 2  $I^0$  [ I has out-degree 1: if P 2 C is the path covering v, either there are no incidence vertices after v on P, in which case there is an arc v ! y for the vertex y 2 O at the end of P; or if we let z 2 I be the rst incidence vertex following v on P, we will have  $z \ge I$ , in which case there will be an incidence vertex w which precedes z on some path of F, because all input vertices covered by F are incidence points. Thus, any maximal dipath in G must end in O. Then, for each i 2  $I^0$ , there is a dipath from i to some element of O in the graph G.

Consider any vertex i 2  $I^0$ , and let  $u_0 ! u_1 ! ! . . . . be the dipath in G from i to 0 . Let P 2 C and P<sup>0</sup>2 F be the paths containing <math>u_{1} :$  from  $(u_{2} ! u_{1}) 2 A (G)$ , we know that there is an incidence vertex after  $u_{1}$  in the path P<sup>0</sup>. Note that  $u_{2}$  is either not covered by any path of F, or it occurs at the end of a path of F and is not followed by any vertices on that path; then,  $(u_{1} ! u_{2}) 2 A (G)$  in plies that there are no incidence points on P after  $u_{1}$ . Then, the arcs leaving  $u_{1}$  in P and P<sup>0</sup> must be di erent: the fact that no incidence point follows  $u_{1}$  in P then implies that no path of F intersects P after  $u_{1}$ . In particular,  $u_{2}$  is not covered by F.

Because  $u_0 \ge I^0$  and  $u \cdot \ge 0$  are both not covered by F, we may construct an augmenting walk W for F in the original graph G, as follows. If '= 0, we let W be the trivial path on  $u_0$ , which is an augmenting walk for F. 0 there is:

For each j 2 [' 1], let  $v_j$  be the next incidence point after  $u_j$  on the path  $P_j$  2 C containing  $u_j$ . (This  $v_j$  will then also be the next incidence point after  $u_{j+1}$  on the path  $P_j^0$  2 F containing  $u_{j+1}$ .)

Let  $P_j$  be the segment of  $P_j$  from  $u_j$  to  $v_j$ , and  $P_j^0$  be the reverse of the segment of  $P_j^0$  from  $u_{j+1}$  to  $v_j$ .

Finally, let  $\mathbb{P}_{1}$  be the path segment in C from  $u_{1}$  to  $u_{2}$ .

Then, de new =  $u_0 P_0 v_0 P_0 u_1 P_1$   $v_1 P_1 u_2 \cdot W \in M$  and  $v_1 P_2 \cdot W \in M$  is an augmenting walk for F:

- (i). Each path P<sub>j</sub> is internally disjoint from F, because they are sub-paths of elements of C, and do not contain any incidence points in their interiors. Then, none of the arcs of P<sub>j</sub> are arcs of F for any j2 [']. A lso, all of the arcs of the paths P<sub>j</sub><sup>0</sup> are the reverse of arcs of F : they do not contain arcs of F either. Then, none of the arcs of W are arcs of F.
- (ii). Because u<sub>0</sub> ! !. is a directed path in G, we have u<sub>j</sub> € u<sub>k</sub>. Because each path P<sub>j</sub> and P<sub>j</sub><sup>0</sup> is uniquely determ ined by u<sub>j</sub> for j 2 [' 1], those sequences of vertices can also occur only once each. Each interior vertex of P<sub>j</sub> or P<sub>j</sub><sup>0</sup> can only occur in a single path of C or F, between two consecutive elements of I<sup>0</sup> [ I [ 0 on that path : then, because each segment P<sub>j</sub> and P<sub>j</sub><sup>0</sup> only occur once in W, each interior vertex of those segments also occurs only once in W.

Thus, if any vertex x occurs more than once in W , x must be an end point of some path  $F_j$  or  $F_j^0$ . A side from  $P_0$  and  $P_{1,1}$ , both end-points of each such segment has in-degree 1 and out-degree 1, so they cannot be elements of either  $I^0$  or 0. Then, any vertex which occurs more than once in W is an element of I, and is therefore covered by F.

(iii). The only points in W which are covered by F are the vertices of the paths  $P_j$  for j 2 [' 1], which are all at the beginning or the end of arcs in W which are the reverse of arcs of F.

Thus, W is an augmenting walk for F. Furtherm ore, because each edge of G is contained in at most one segment  $P_j$  or  $P_j^0$ , each edge occurs at most once in W. Finally, because elements of  $I^0$  have in-degree 0 in G and do not occur in the segments  $P_j$  or  $P_j^0$ , any input vertices other than  $i = u_0$  which occur on W must be incidence points, which means they are covered by F. Thus, there is a proper augmenting path for F of the desired type starting at i2 I.

The above Theorem illustrates how we can build an augmenting walk for F from a collection of disjoint I { 0 paths which covers I and 0. If we impose restrictions on the type of augmenting walk we consider, we may also e ciently do the reverse. The restriction we are interested in is the following:

De nition 13. Let  $W = u_0 u_1$ , be a walk which which is pre-alternating with respect to F.

An entry point of W into F is a vertex  $u_j$  which is covered by F , where either j = 0 or  $u_j$  !  $u_{j\,1}$  is not an arc of F .

The walk W is monotonic if, for every path P 2 F and for any indices 0 6 h < j < `such that  $u_h$  and  $u_j$  are both entry points for W into F which lie on P,  $u_h$  is closer to the initial point of P than than  $u_j$  is.

W is a proper pre-alternating walk if W traverses each edge at m ost once, each input vertex in W (except possibly  $u_0$ ) is covered by F, and W is monotonic.

W e will be most interested in proper augmenting walks, which are useful in increasing the size of proper collections of I { O paths. The sort of augmenting walk that is guaranteed by Theorem 12 is almost a proper augmenting walk, and merely lacks a guarantee of monotonicity. However, the following Lemma shows that we lose no generality in imposing monotonicity as a condition: Lem m a 14. Let G be a graph, and I; O V (G). Let F be a collection of vertex-disjoint I { O paths, and let W be an augmenting walk for F from i 2 I to ! 2 O. Then there is a monotonic augmenting walk W for F from i to !.

If W has no reversed pairs, then W is already monotonic, in which case we may let W = W.

Suppose that  $(u_h; u_j)$  is a reversed pair of W. Then h < j, but  $u_j$  is closer than  $u_h$  to the initial point of the path  $Q \ge F$  which covers both of them. Note that  $u_v = !$  is not covered by F, and so is not on the path Q: then, let  $j^0 \ge [1]$  be the smallest index such that  $u_{j^0+1}$  is not on Q. Let  $Q = q_0$  a  $qq_{11}$  b  $1qq_b$  m q where  $q_a = u_{j^0}$  and  $q_b = u_h$ . Then, let

$$W^{0} = u_{0} \qquad h \mu q_{b} q_{b 1} q_{b 2} \qquad a + \varrho q_{a} u_{j^{0}+1} \qquad \cdot u$$

From the fact that W is an augmenting walk for F, it is easy to show that W <sup>0</sup> is also an augmenting walk for F. A swell, the entry points of W <sup>0</sup> into F are a subset of the entry points of W into F, in which case the reversed pairs of W <sup>0</sup> are also a subset of the reversed pairs of W ; and W <sup>0</sup> does not have  $(u_h; u_j)$  as a reversed pair. Then, W <sup>0</sup> has strictly fewer reversed pairs than W .

Because W is a nite walk, it can have only nitely many reversed pairs; then, by recursion, we may construct a monotonic augmenting walk W for F from ito !.

C orollary 15. Suppose Jj = D j = k, F a proper collection of vertex-disjoint I { 0 paths in G with F j < k, and let i 2 I be a vertex not covered by F. If there is a collection C of vertex-disjoint dipaths from I to 0 with f j = k, then there is a proper augmenting walk W for F starting at i.

For proper augmenting walks, the reason for requiring that no edge is traversed twice is essentially to help construct e cient algorithms for noting them, which we consider later. The requirements that the only input vertex in the walk which is not covered by F, and that it be monotonic, are essentially chosen to allow us to use augmenting walks to increase the size of a proper collection of vertex-disjoint paths to cover exactly one more input vertex. W e may do this using the following operation:

Denition 16. Let F be a proper collection of vertex-disjoint I { O dipaths in G, and W be a proper augmenting walk for F. Then, F W denotes the collection of directed paths which are formed by those arcs x ! y which belong either to W or a path of F, and for which <math>y ! x is not an arc of either W or F.



Figure 5: On the left: an example of a proper collection F of vertex disjoint I { O paths (solid arrows) with a proper augmenting walk W for F (hollow arrows). On the right: the augmented collection of paths F = W.

The collection F W described above is form ed by the usual procedure for augmenting a network- ow with an augmenting path: one can think of form ing F W by \adding" together the arcs of F and W, and \cancelling" them whenever they point in opposite directions on a single edge.

Lem m a 17. Let F be a proper collection of vertex-disjoint I { O dipaths in G, and W be a proper augmenting walk for F. Then F W is a proper collection of vertex-disjoint I { O dipaths, with F W j= F j+ 1; and the input vertices covered by F W are those covered by F and W together.

Proof | W e induct on the number of times r that the walk W intersects the paths of F. If r = 0, then F W = F [fW g, and the inputs covered by F W are clearly those covered by F or by W. O therw ise, suppose that the proposition holds for all cases where the augmenting walk intersects the paths of its' respective collection fewer than r times.

Let W be given by W =  $u_0u_1$  aug<sub>41</sub>  $b_1u_b$ , where none of the points  $u_j$  are covered by F for j2 [a], and where  $u_{j+1}$ !  $u_j$  is an arc of F for all a 6 j < b. Let Q 2 F be the path containing  $u_a$  through  $u_b$ : in particular, let Q =  $q_0q_1$   $cq_sq_1$   $d_1q_b$  m  $q_w$  here  $q_c = u_b$  and  $q_i = u_a$ . Then, we may de ne

then Q<sup>0</sup>2 F W, and W<sup>0</sup> is an augmenting walk for F<sup>0</sup> = (F r Q) [fQ<sup>0</sup>g which intersects the paths of F<sup>0</sup> fewer than r times. Because F is a proper collection of vertex-disjoint I { 0 paths, Q<sup>0</sup> only intersects I and 0 at its' endpoints, and Q<sup>0</sup> does not intersect any paths of F r Q, F<sup>0</sup> is proper. Similarly, because Q only intersects I at q<sub>0</sub> and because W only intersects I at u<sub>0</sub> and at input vertices covered by F, W<sup>0</sup> does not cover any inputs except those covered by F. Because W doesn't traverse any edges twice, and all of the other entry points q<sub>h</sub> of W into F on the path Q have h > c by the monotonicity of W, W<sup>0</sup> itself does not traverse any edge twice. Finally, all of the entry points of W into F are also entry points of W<sup>0</sup> into F<sup>0</sup>, except for u<sub>a</sub> : all the other are left una ected, including the order in which they occur. Then W<sup>0</sup> is monotonic, so that W<sup>0</sup> is a proper augmenting walk for F<sup>0</sup>.

By the induction hypothesis,  $F^0 W^0$  is a proper collection of vertex-disjoint paths from I to 0, with  $f^0 W^0 j = f^0 j + 1 = f j + 1$ . Also by induction, the input vertices covered by  $F^0 W^0$  are those covered by  $F^0 r b W^0$ . Because  $W^0$  covers the input  $q_0$ , and  $F^0$  covers all inputs covered by W or by F except for  $q_0$ ,  $F^0 W^0$  then covers all vertices covered by F or by W. Finally, note that the set of arcs from  $F^0$  and  $W^0$  together only di ers from the set of arcs from F and W together by the absence of the arcs  $u_j ! u_{j+1}$  from W and the arcs  $u_{j+1} ! u_j$ , for a 6 j < b, which oppose each other. We then have  $F^0 W^0 = F W$ : thus, f W j = f j + 1, and F W covers the input vertices covered either by F or by W.

3.1.2 An e cient algorithm for nding a proper augmenting walk

A lgorithm 1 determ ines if a vertex supports a suitable proper pre-alternating walk W with respect to F, and compute F W if one is found. Using it, we may not proper augmenting walks for F by performing a depth-rst search along proper alternating walks W for F in an attempt to not one which ends in O.

Theorem 18. Let (G;I;O) be a geometry with Jj = D j = k, F a proper collection of fewer than k vertexdisjoint paths from I to O, iter a positive integer, i2 I a vertex not covered by F, and visited :V (G) ! N with visited(x) < iter for all x 2 V (G). Then AugmentSearch halts on input (G;I;O;F;iter;visited;i). Furtherm ore, let (F; visited; status) = AugmentSearch (G;I;O;F; iter;visited;i).

- (i). If status = fail, then there are no proper augmenting walks for F starting at i;
- (ii). If status = success, then F is a proper family of vertex-disjoint I { 0 paths of size F j+ 1 which covers i and all input vertices covered by F, and visited (x) 6 iter for all x 2 V (G).

Proof Let G, I, O, F, and iter be xed as above. Throughout the proof, we will consider chains of recursive calls to AugmentSearch. One invocation of AugmentSearch is the daughter of a second invocation if

At any stage in a particular invocation of AugmentSearch, we will refer to the ordered pair (visited;v) as the data pair of the invocation, where v is the nalparam eter of the input, and visited the second last param eter, including any changes which have been made to it during the invocation. (Though the input param eters of AugmentSearch include G, I, O, F, and iter, we will occasionally refer to data pairs as the input of an invocation of AugmentSearch has a data pair (visited;v) and m akes a daughter invocation, we may describe that invocation as being \daughter invocation for (visited;v)"; sim ilarly, a daughter invocation for (visited;v) or the descendant of one is a \descendant invocation for (visited;v)".

We de ne a probe walk W for an ordered pair (visited;v) to be a proper pre-alternating walk starting at v such that, for all vertices x in the walk, visited(x) = iter only if x is at the beginning of W and x 2 0 only if x is covered by F or x is at the end of W. Then, we let R (visited;v) be the set of vertices x 2 V (G) which end-points of probe walks for (visited;v). We will reduce the problem of determining whether there is a proper augmenting path for F passing through v to a question of the existence of whether there is an output vertex in

R (visited; v), for visited restricted in a manner described below.

A canonical walk for a data pair (visited; v) is a proper alternating walk W with respect to F, such that the following all hold:

- (i).visited(x) 6 iter for all x 2 V (G).
- (ii). v is the end-point of W  $\,$  .
- (iii). for all vertices x on W , if visited(x) < iter, then either x = v, or x occurs exactly once in W and is an entry point of W into F .
- (iv). for any path P ofF, and x 2 V (P) which is not in W, visited(x) < iter if and only if either (a) there is no entry point of W after x on the path P, or (b) there is exactly one entry point p of W after x on the path P, and v lies on P strictly between x and p.</p>

A data pair (visited;v) is itself canonical if it has a canonical wak. We will be interested in the behaviour of AugmentSearch on canonical inputs. (Note that the input described in the statement of the Theorem is a special case.) We will show that AugmentSearch essentially performs a depth-rst traversal of R (visited;v) along probe walks for (visited;v) in an attempt to nd an output vertex. If it succeeds, it has traversed a proper augmenting walk  $\overline{W}$  for F, and can construct F  $\overline{W}$ .

Suppose W is a canonicalwalk for a data pair (visited;v). It is easy to show that if we extend W to a longer walk W  $^{0} = W vw_{1}w_{2}$  N wfor some N > 1, and W  $^{0}$  is a canonicalwalk for some data pair (visited; wN), then W is a canonicalwalk for (visited; v). We will use this fact frequently in the two Lemmas below.

Lem m a 18-1. Suppose that (visited;v) has a canonical walk W . If R (visited;v) does not contain any output vertices, AugmentSearch halts on input data (visited;v), with output value (F; visited; fail); where visited di ers from visited only in that visited(x) = iter for all x 2 R (visited;v), and where (visited;v) also has the canonical walk W .

Proof We will proceed by induction on the length 'of the longest probe walk for (visited;v). Regardless of the value of ', line 1 transforms the data pair (visited;v) to (visited<sup>(1)</sup>;v), where visited<sup>(1)</sup> di ers from visited in that visited<sup>(1)</sup> (v) = iter; then, any canonical walk for (visited;v) is also a canonical walk for (visited<sup>(1)</sup>;v). As well, it cannot be that v 2 0 : then the condition on line 2 will not be satisfied.

If '= 0, the condition on lines 3 cannot be satis ed, and the condition of line11 is not satis ed by any neighbor
w v. Then, line 28 will ultimately be executed, returning (F; visited<sup>(1)</sup>; fail). Because R (visited; v) =
fvg, the proposition holds in this case.

O therw ise, suppose '> O, and that the proposition holds for canonical data pairs whose probe walks all have length less than '. Consider the vertices which m ay be the subject of a daughter invocation of Augment Search:

1. If  $v \ge 1$  and v is covered by F, and z is the predecessor of v in the paths of F, then (visited;v) has probe walks starting with the arc v ! z if and only if visited<sup>(1)</sup> (z) = visited(z) < iter. If this holds, then a daughter invocation of AugmentSearch with input data (visited<sup>(1)</sup>;z) is perform ed.

In this case, note that (visited<sup>(1)</sup>;z) has probe walks ending in O only if (visited;v) does; then R (visited<sup>(1)</sup>;z) is disjoint from O, and all of the probe walks of (visited<sup>(1)</sup>;z) are strictly shorter than those of (visited;v). Let W <sup>(1)</sup> = W vz: because W is a canonical walk, z 2 V (W) only if z occurs only once in W and is an entry point of W into F, in which case the edge vz is never traversed by W. Then, it is easy to show that W <sup>(1)</sup> is a canonical walk for (visited<sup>(1)</sup>;z). By the inductive hypothesis, Augment Search will halt on input (visited<sup>(1)</sup>;z) and return a value (F; visited<sup>(2)</sup>;fail), where visited<sup>(2)</sup> di ers from visited<sup>(1)</sup> only in that visited<sup>(2)</sup> (x) = iter for all x 2 R (visited<sup>(1)</sup>;z) R (visited;v), and where W <sup>(1)</sup> is a canonical walk for (visited<sup>(2)</sup>;z). Then, W is a canonical walk for (visited<sup>(2)</sup>;v).

O therwise, if visited<sup>(1)</sup> (z) = iter, if v 2 I, or if F does not cover v, let visited<sup>(2)</sup> = visited<sup>(1)</sup>; W is a canonical walk for (visited<sup>(2)</sup>; v) in this case as well.

2. Suppose that at some iteration of the for loop starting at line 10, the data of AugmentSearch is a data pair (visited<sup>(h)</sup>;v) for which W is a canonical walk, visited<sup>(h)</sup> (v) = iter, and w is a neighbor of v

satisfying the conditions of lines 11 and 12. Note that (visited<sup>(h)</sup>;w) has probe walks ending in O only if (visited;v) does; then, R (visited<sup>(h)</sup>;w) is disjoint from O, and all of the probe walks of the form er are strictly shorter than those of the latter. Let  $W^{(h)} = W$  vw; because w is not covered by F, the fact that visited<sup>(h)</sup>(w) = visited(w) < iter implies that w does not occur in W. Because w  $\geqq$  I, we know that  $W^{(h)}$  is a proper alternating walk. In particular,  $W^{(h)}$  is a canonical walk for (visited<sup>(h)</sup>;w).

By the inductive hypothesis, AugmentSearch will then halt on input (visited<sup>(h)</sup>;w) and return a value (F;visited<sup>(h+1)</sup>;fail), where visited<sup>(h+1)</sup> di ers from visited<sup>(h)</sup> only in that visited<sup>(h+1)</sup> (x) = iter for all x 2 R (visited<sup>(h)</sup>;w) R (visited;v), and where W <sup>(h)</sup> is a canonical walk for (visited<sup>(h+1)</sup>;w). Then, W is a canonical walk for (visited<sup>(h+1)</sup>;v).

3. Suppose that at some iteration of the for loop starting at line 10, the data of Augment Search is a data pair (visited<sup>(h)</sup>;v) for which W is a canonical walk, visited<sup>(h)</sup> (v) = iter, and w is a neighbor of v satisfying the conditions of lines 11 and 18. Then, w is covered by a path P 2 F and has a well-de ned predecessor z in P. Let W <sup>(h)</sup> = W vwz: this is an alternating walk with respect to F.

The walk W  $^{(h)}$  is monotonic only if w is further from the initial point of the path P 2 F than any entry point of W on P. If P contains no entry points of W into F, this is satisfied. Otherwise, let y be the nal entry point of W into P.

Suppose that v is not covered by P . Because (visited<sup>h)</sup>;v) is canonical, every vertex x on the path P from the initial point up to (but possibly not including) y has visited<sup>(h)</sup>(x) = iter. Because visited<sup>(h)</sup>(z) < iter, z is at least as far along P as y is; then, w is strictly further. Thus, W <sup>(h)</sup> is m onotonic.

If v is covered by P, then every vertex x on P with visited(x) < iter either is at least as far as y on P, or has the property that y is the only entry point between x and the end of P, and that v lies between x and y. However, if there are more than zero vertices of the second type, then v has a predecessor z in P with visited(z) < iter. Then, from the analysis of part 1 above, all vertices x which precede v in P with visited(x) < iter are in R (visited<sup>(1)</sup>;z), and thus have visited<sup>(h)</sup>(x) = visited<sup>(2)</sup>(x) = iter. Then, W <sup>(h)</sup> is monotonic if and only if w is further along P than y, which reduces to the analysis of the preceding case.

Because visited<sup>(h)</sup> (z) < iter, either z is not in W, or it occurs exactly once as an entry point of W into F. Because visited<sup>(h)</sup> (w) < iter and w is further along P than any entry point of W, w does not occur in W at all. Then, neither vw norwz are traversed by W, in which case W<sup>(h)</sup> is a proper alternating walk. In particular, it is a canonical walk for (visited<sup>(h)</sup>;z).

Again, (visited<sup>(h)</sup>;z) has probe walks ending in O only if (visited;v) does; then, R (visited<sup>(h)</sup>;z) is disjoint from O, and all of the probe walks of the form er are strictly shorter than those of the latter. By the inductive hypothesis, AugmentSearch will then halt on input (visited<sup>(h)</sup>;z) and return a value (F;visited<sup>(h+1)</sup>;fail), where visited<sup>(h+1)</sup> di ers from visited<sup>(h)</sup> only in that visited<sup>(h+1)</sup>(x) = iter for all x 2 R (visited<sup>(h)</sup>;z) R (visited<sup>(h+1)</sup>;v), and where W <sup>(h)</sup> is a canonicalwalk for (visited<sup>(h+1)</sup>;z).

By induction on the number of neighbors w v satisfying the conditions of lines 11, 12, and 18, the data (visited;v) when the for loop term inates and line 28 is executed will be a nearly canonical pair, and visited di ers from visited only on elements of R (visited;v).

It remains to show that  $\overline{\text{visited}}(x) = \text{iter for all } x 2 \text{ R}$  (visited;v). We have shown this already for x = v; then, let r 2 R (visited;v) r fvg. By de nition there is a probe walk W for (visited;v) ending in r. The vertex w immediately following v on W will be either tested on line 3 or line 11 as a neighbor of v; then, there exists indices h<sup>0</sup> such that W is not a probe walk of (visited<sup>(h<sup>0</sup>)</sup>;v). Let h > 0 be the largest integer such that W is a probe walk for (visited<sup>(h)</sup>;v) : then, there are vertices  $x \in v$  in W such that visited<sup>(h+1)</sup> (x) = iter. Let y 2 R be the last such vertex in W , let W <sup>0</sup> be the segment of W from y onwards: then r 2 R (visited<sup>(h+1)</sup>;v) which had input data (visited ;y) for some function visited : it is not di cult to show that visited (y) < iter. By induction on daughter invocations using the analysis above, we may show that (visited ;y) is a canonical data pairwith probe walks strictly shorter than `: then, for all x 2 R (visited ;y), we have visited<sup>(h+1)</sup> (x) = iter. How ever, because visited<sup>(h+1)</sup> (x) < iter implies visited (x) < iter, and because all vertices x 2 V (W) after y have visited<sup>(h+1)</sup> (x) < iter, W<sup>0</sup> is a probe walk for (visited ;y). Then, we have visited<sup>(h+1)</sup> (r) = iter.

Because  $visited(x) = iter if and only if visited^{(h)}(x) = iter for som eh > 1, we then have <math>visited(r) = iter$  for any r 2 R (visited; v). By induction, the Lemma then follows.

Lem m a 18-2. Suppose that (visited;v) is a canonical data pair. If R (visited;v) contains an output vertex, AugmentSearch halts on input data (visited;v), with output value (F  $\overline{W}$ ;visited;success); where  $\overline{W}$  is a probe walk for (visited;v) ending in 0, and visited di ers from visited only in that visited(x) = iter only for x in some subset of R (visited;v).

Proof | We induct on the length '2 N of the longest probe walk for (visited;v) ending in 0. If '= 0, then v 2 0, and the result holds trivially. O therwise, suppose '> 0 and that the result holds for those canonical data pairs (visited ;x) which have probe walks of length less than 'ending in 0.

Let W be a canonical walk for (visited;v). Consider the sequence of vertices  $w_1; w_2; M; which are tested (either on line 4, line 13, or line 19) in the course of the invocation of AugmentSearch. We let visited<sup>(1)</sup> di er from visited in that visited<sup>(1)</sup> (v) = iter, and from this de ne visited<sup>j)</sup> for j > 1 by letting visited<sup>(j+1)</sup> be the second component of the output of the daughter invocation with input data (visited<sup>(j)</sup>; w<sub>j</sub>). (If the daughter invocation with data pair (visited<sup>(M)</sup>; w<sub>M</sub>) halts, this sequence extends to visited<sup>(M+1)</sup>.)$ 

Let W be a probe walk for (visited;v) which ends at a vertex ! 2 0, and let 1 6 N 6 M + 1 be the largest integer such that R (visited<sup>(j)</sup>;w<sub>j</sub>) is disjoint from 0 for all j < N. If N = M + 1, this means that the invocation of AugmentSearch on input data (visited<sup>M</sup>);w<sub>M</sub>) halted with fail in the nalpart of its' output value, and that there are no neighbors of w v which can satisfy the conditions of lines 11, 12, and 18 (due to the choice of M as the length of the sequence of daughter-invocations). However, we may show by induction that for all 1 6 j 6 N, W is a probe walk for (visited<sup>(j)</sup>;v), which is canonical:

This follows im mediately for j = 1, because visited<sup>1)</sup> only di ers from visited at v, and thus has W as a probe walk and W as a canonical walk.

Suppose for some 1 6 j < M that W is a canonical walk for (visited<sup>j</sup>;v), that W is a probe walk for (visited<sup>(j)</sup>;v), and that visited<sup>(j)</sup>(v) = iter. Then we can extend W to a canonical walk W <sup>(j)</sup> for (visited<sup>(j)</sup>;w<sub>j</sub>): either by setting W <sup>(j)</sup> = W vw<sub>j</sub> in the case that (w<sub>j</sub> ! v) 2 A (F) or w<sub>j</sub> is not covered by F, or by setting W <sup>(j)</sup> = W vzw<sub>j</sub> where (z ! w<sub>j</sub>) 2 A (F) otherwise. Because R (visited<sup>(j)</sup>;w<sub>j</sub>) contains no output vertices, by Lemma 18-1 we know that visited<sup>(j+1)</sup> di ers from visited<sup>j)</sup> on Lemma R (visited<sup>(j+1)</sup>;w<sub>j</sub>). Then, W is a canonical walk for (visited<sup>(j+1)</sup>;w<sub>j</sub>). Then, W is a canonical walk for (visited<sup>(j+1)</sup>;v).

For any vertex x in W , the sub-path W  $_x$  from x to ! is a probe walk for (visited<sup>(j)</sup>;x) of length less than `. If W has a non-trivial intersection with R (visited<sup>(j)</sup>;w<sub>j</sub>), then some vertex x 2 V (W) is the rst such vertex which is given as part of an input data pair (visited;x) for a descendant invocation for (visited<sup>(j)</sup>;w<sub>j</sub>). By induction on the recursion depth from v to x, we may show that there is then a probe walk W for (visited<sup>(j)</sup>;v) ending at x, and that W W is a canonical walk for (visited;x); and precisely because x is the rst vertex of W which is visited in a descendant invocation for (visited<sup>j)</sup>;w<sub>j</sub>), we know that visited (y) < iter for all y 2 V (W) r fv;xg. Then, W <sub>x</sub> is a probe walk for (visited;x), and by the induction hypothesis, this invocation of AugmentSearch then term inates with success as the last part of its' output. A gain by induction on the recursion depth, we may also show that the invocation of AugmentSearch with data (visited<sup>(j)</sup>;w<sub>j</sub>) would also term inate with success as the last part of its' output. But because j < N, this cannot happen by Lem ma 18-1 | from which it follows that W is disjoint from R (visited<sup>(j)</sup>;w<sub>j</sub>). Thus W is also a probe walk for (visited<sup>(j)</sup>;v).

By induction, W is a probe walk for (visited  $^{(N)};v)$ , so it must be that N 6 M . By the choice of N, there is then a probe walk W  $^0$  for (visited  $^{(N)};w_N$ ) which ends in O.

Because  $w_N$  is part of the input to a daughter invocation of AugmentSearch, we have visited<sup>(N)</sup> ( $w_N$ ) < iter; thus we can easily extend W<sup>0</sup> (by one or two vertices, depending on whether  $w_N$  is a neighbor of v or the predecessor in F of a neighbor of v) to form a probe walk W<sup>00</sup> for (visited<sup>(N)</sup>;v). Because W<sup>00</sup> will also be a probe walk for (visited;v), it has length at most `; then W<sup>0</sup> is strictly shorter than ` in length. By the induction hypothesis, the invocation of AugmentSearch on input data (visited<sup>(N)</sup>; $w_N$ ) then halts, and returns the output value (F  $\overline{W^0}$ ;visited;success), where  $\overline{W^0}$  is a probe walk for (visited<sup>(N)</sup>; $w_N$ ) ending in O, and where visited di ers from visited<sup>(N)</sup> only on a subset of R (visited<sup>(N)</sup>; $w_N$ ). We proceed by cases:

If v is covered by a path of F, v  $\geq$  I, and  $w_N$  is the predecessor of v in F, then  $\overline{W} = vw_N \overline{W}^0$  is a probe walk for (visited; v) ending in O. Note that A (F  $\overline{W}$ ) = A (F  $\overline{W}^0$ ) r fw<sub>N</sub> ! vg; then, the value which is returned as output on line 7 is (F  $\overline{W}$ ; visited; success).

If  $w_N$  is not covered by a path of F, then  $w_N$  v, and the walk  $\overline{W} = vw_N \overline{W}^0$  is a probe walk for (visited;v) ending in O. Note that A (F  $\overline{W}$ ) = A (F  $\overline{W}^0$ ) [fv!  $w_N$  g; then, the value which is returned as output on line 16 is (F  $\overline{W}$ ; visited; success).

If neither of the previous two cases apply, it must be that  $w_N$  is the predecessor in F of some third vertex  $u = v \cdot Because w_N$  is part of the input to a daughter invocation for (visited<sup>(N)</sup>;v), we know that visited<sup>(N)</sup>(u) < iter: then,  $\overline{W} = vuw_N \overline{W}^0$  is a probe walk for (visited;v) ending in 0. Note that  $A(F = \overline{W}) = A(F = \overline{W}) r fw_N ! ug [fv! ug; then, the value which is returned as output on line 23 is (F = \overline{W}; visited; success).$ 

Finally, because R (visited<sup>(N)</sup>;  $w_N$ ) R (visited; v), and because visited<sup>(N)</sup> di ers from visited only on R (visited; v) for 16 i < N, it follows that visited di ers from visited only on a subset of R (visited; v), with visited(x) = iter on that subset. Thus, if the Lemma holds for pairs (visited; v) having probe walks of length less than '> 0 ending in 0, it also holds for such pairs with probe walks ending in 0 of length '+ 1. By induction, the Lemma then holds.

To prove the Theorem, it then su cesto note that for a function visited :V (G) ! N with visited(x) < iter for all x 2 V (G), probe walks for (visited; i) are just proper alternating walks with respect to F which start at i, in which case such a probe walk  $\overline{W}$  which ends in O is a proper augmenting walk for F. Then all the various parts of the Theorem follow from Lemmas 18-1 and 18-2 collectively.

R un-time analysis. Because AugmentSearch marks each vertex v with visited (v) iter when it visits v, each vertex is only visited once. At each vertex, each of the neighbors w v are tested for if they full lithe condition of line 3, or of lines 11, 12, and 18. Because computing prev, AddArc, and RemoveArc is constant-time for F a collection of vertex-disjoint paths (or di ering only slightly from one as described in the discussion on implementation details), the amount of work in an invocation to AugmentSearch for a vertex v 2 V (G) is 0 (deg v), neglecting the work performed in descendant invocations. Sum ming over all vertices v 2 V (G), the run-time of AugmentSearch is then 0 (m) for an input as described in the statement of Theorem 18.

#### 3.1.3 An e cient algorithm for constructing a path cover for (G;I;O)

U sing AugmentSearch as a subroutine to build successively larger proper families of vertex-disjoint I { 0 paths, A loorithm 2 describes a straightforward subroutine which attempts to build a path cover for (G;I;O).

C orollary 19. Let (G;I;O) be a geometry with jI = jO; then BuildPathCover halts on input (G;I;O). Furthermore, let = BuildPathCover(G;I;O). If = fail, then (G;I;O) does not have a causal ow; otherwise, is a path cover F for (G;I;O).

Proof Suppose (G;I;O) has a causal ow: then it has a collection of k = Ji = J jvertex-disjoint I { O paths by Lemma 3. Then, by Corollary 15, for any proper collection F of vertex-disjoint I { O paths with

f j < k, there is a proper augmenting walk for F starting at any i2 I which is not covered by F. For such a collection F and vertex i, if visited(x) < iter for all x 2 V (G), AugmentSearch(G;I;O;F;iter;visited;i) returns (F W;visited;success), where visited(x) 6 iter for all x 2 V (G), and where W is a proper augmenting walk for F starting at i. Then, F W is a proper collection of vertex-dispint paths, covering i and the input vertices covered by F, and with f W j = f j + 1. By induction, we may then show that at the end of the for loop starting at line 4, F will be a fam ily of vertex-dispint I { O paths which covers all of I, in which case f j = k. If all of the vertices of V (G) are covered by F, F is then a path cover for (G;I;O), and BuildPathCover returns F. Taking the contrapositive, if BuildPathCover (G;I;O) returns fail, then (G;I;O) has no path cover.

Conversely, if BuildPathCover(G;I;O) returns fail, then either the condition of line 7 failed, or the condition of line 12 failed. If the form er is true, then by Theorem 18 there were no proper augmenting walks for some proper collection F of fewer than k disjoint I{O paths, in which case by Corollary 15 there is no such collection of size k, and thus no causal path cover for (G;I;O). O therwise, F is a maximum -size collection of disjoint paths from I to O, but is not a path cover for (G;I;O); then by Theorem 9, there again is no causal path cover for (G;I;O) by Theorem 8. The result then holds.

R un-time analysis. BuildPathCover iterates through k = jj input vertices as it increases the size of the collection of vertex-disjoint paths, invoking Augment Search for each one. The running time for this portion of the algorithm is then 0 (km). As this is larger than the time required to initialize visited or to determ ine if there is an element v 2 V (G) such that  $v \ge V$  (F), this dom inates the asymptotic running time of BuildPathCover.

#### 3.2 E ciently nding a causal order for a given successor function

G iven a path cover C for a geom etry (G;I;O), and in particular the successor function f of C, we are interested in determining if the natural pre-order 4 for f is a partial order, and constructing it if so. In this section, I present an e cient algorithm to determ ine whether or not 4 is a partial order, by reduction to the transitive closure problem on digraphs.

#### 3.2.1 The Transitive C losure P roblem

Any binary relation R can be regarded as de ning a digraph D with (x ! y) 2 A (D) () (xRy). Chains of related elements can then be described by directed walks in the digraph D. This motivates the following de nition:

De nition 20. Let f be a successor function for a geometry (G;I;O): the in uencing digraph  $\downarrow$  is then the directed graph with vertices V (I<sub>f</sub>) = V (G), where (x ! y) 2 A (I<sub>f</sub>) if one of y = x, y = f(x), or y f(x) hold.

The three types of arcs in D e nition 20 correspond to the relations in Equation 2, whose transitive closure is the natural pre-order. Note that aside from self-loops x ! x, the arcs in  $I_f$  correspond directly to the two varieties of segments of in uencing walks. (This is an alternative way of proving Lemma 6.)

It is natural to also speak of transitive closures of binary relations in graph-theoretic term s, as follows:

De nition 21. For a digraph D, the transitive closure of D is the digraph T with V (T) = V (D), and such that  $(x \mid y) \ge A$  (T) if and only if there is a non-trivial<sup>6</sup> directed walk from x to y in the digraph D.

Thus, x ! y is an arc in the transitive closure of  $I_f$  and only if x 4 y, or equivalently i there is an in uencing walk for C from x to y in G.

Transitive C losure P roblem. Given a digraph D, determine it's transitive closure T.

The Transitive C losure problem is known to be e ciently solvable. A lgorithm 3 presents on solution, which is (a paraphrasing of) the pseudocode of Figure 3.8 from [13]. This algorithm is a simple modi cation of Tarjan's algorithm for noting strongly connected components of digraphs (equivalence classes of mutually reachable vertices using directed walks), which nds the transitive closure by determining the \descendants" of each x 2 V (D):

Desc(x) =

 contains a non-trivial directed walk from x to y : (3)

The following is an overview of Algorithm 3: interested readers may refer to [13] for a more complete analysis.

A di-connected component of D is an equivalence class of vertices which can be reached from each other by non-trivial directed walks in D. Tarjan's algorithm detects these components by performing a depth-rst search which traverses arcs of D, and detecting when it has traversed a directed cycle in D.

A stack is used to keep track of vertices of the digraph have been visited, but whose di-connected com ponent has not yet been completely determ ined. W hen the vertices belonging to a a given component are determ ined, we pop them o of the stack (line14) and insert them into a set representing that component.

We say that v precedes w in the ordering of the stack if v is on the stack and w is not, or if v is lower on the stack than w is. Then, we may keep track of the \root" Root (v) of v, which is an upper bound on the stack-m inim alvertex of the component containing v. At rst, we set the root of v to itself, and we always ensure that Root (v) 6 v.

Suppose we discover a descendant w of v such that Root (w) 6 Root (v) 6 v. Then v is a descendant of Root (w), which is in a common component with w by de nition. Because w is also a descendent of v, v

must be in a comm on component with w. Then Root (w) is the smallest known vertex in that component: we update Root (v) Root (w) to improve the known minimum for v.

Because vertices are only allocated to a di-connected component after they are popped of the stack, we may test each of the descendants w of v to see if they have been allocated to a component, rather than testing if Root (w) 6 Root (v). If not, then v is in a common component with w, and we update Root (v) to be the minimum of Root (v) and Root (w) on line 8, as in the previous case.

If Root (v) = v on line11, then v is the stack-m in in alelem ent of its' component: then any vertices higher than v on the stack will be in the same component as v. Conversely, because all descendants of v have been visited by that point, all of the vertices in the same component as v are still on the stack. Thus, we may pop them o the stack and allocate them to a component, until we have removed v o of the stack (lines 11 through 19).

As we determ ine the connected components of the digraph, we may maintain the sets of descendants of each vertex: if (v ! w) 2 A (D), then the descendants of w are all also descendants of v, so we ensure that Desc(w) Desc(v) (as on line 9).

The above is performed for all vertices v 2 V (G) to obtain the transitive closure.

A loorithm 3 is su cient to build the natural pre-order 4 for a successor function f. How ever, the output does not indicate whether 4 is a partial order, and it performs work that is unnecessary if 4 is not actually a partial order. We may also take advantage of the availability of the path cover C which is given as input, which is not available in the more general Transitive C losure problem. Therefore, we are interested in adapting A loorithm 3 to the application of nding a causal order.

3.2.2 Chain decompositions with respect to the path cover C

Let C be a path cover for (G;I;O) with successor function f. The transitive closure of the in uencing digraph I will often have high maximum degree: because the longest path in C has at least n=k vertices, and the end-point of this path will be at the term inus of arcs coming from every vertex on the path, the maximum in-degree of the transitive closure is at least n=k; and similarly for the maximum out-degree. In A loorithm 3, this im plies that the set Desc (v) may become comparable to V (G) in size. In order to construct the arc-lists of the transitive closure reasonably else the to reduce the else ort required in determining the sets Desc (v).

A standard approach to this problem would be to  $nd a chain decomposition [3] for I_f, which is a collection of vertex-disjoint dipaths of I_f which cover all of I_f. By the de nition of the in uencing digraph, C itself is such decomposition of I_f. Then, using a chain decomposition with respect to C, we can e ciently represent Desc(x) in terms of the rst vertex y in each path of C such that y 2 Desc(x).$ 

D e nition 22. Let  $C = fP_jg_{j2K}$  be a parameterization of the paths of a path cover C for a geometry (G;I;O), let f be the successor function of C, and let 4 be the natural pre-order for f. Then, for x 2 V (G) and j 2 K, the supremum  $sup_j(x)$  of x in  $P_j$  is the minimum integer m 2 N, such that x 4 y for all vertices y 2 V ( $P_j$ ) which are further than distance m from the initial vertex of  $P_j$ .

We may use the suprem a of x in the paths of C to characterize the natural pre-order for f:

Lem m a 23. Let  $C = fP_{j}g_{j2K}$  be a parameterization of the paths of a path cover C for a geometry (G;I;O), let f be the successor function of C, let 4 be the natural pre-order for f, and let L :V (G) ! N m ap vertices x 2 V (G) to the distance of x from the initial point of the path of C which contains x. Then

holds for all x 2 V (G) and y 2 V (P<sub>j</sub>), for any j 2 K .

Proof | Let  $x \ge V$  (G), and  $x \ge 2 \le C$ . Let  $v \ge V$  ( $((P_j))$ ) be such that  $L(v) = \sup_j (x)$ . By de nition, if  $y \ge V$  ( $((P_j))$ ) and  $x \le y$ , then L(v) > L(v). Conversely, if  $y \ge V$  ( $((P_j))$ ) and L(v) = L(v) + h for h > 0, then  $y = f^h(v)$ ; then  $x \le v \le y$ , and the result holds by transitivity.

To determ ine the supremum function for all vertices, it will be helpful to be able to e ciently determ ine which path of C a given vertex belongs to and how far it is from the initial vertex for it's path. A loorithm 4 describes a simple procedure to do this, which also produces the successor function for the path cover C. (In the case where ji = j0 j, every path of C has an initial point in I; we then take K = I to be the index set of the paths of C.)

#### 3.2.3 Detecting vicious circuits with respect to C

If the in uencing digraph I contains non-trivial di-connected components, we know that there are closed inuencing walks | i.e. vicious circuits | for C in (G;I;O). In that case, Theorem 8 together with Theorem 9 im ply that (G;I;O) has no causal ow, in which case we may as well abort. Recall that SimpleTC keeps track of di-connected components by allocating vertices to a component C after the elements of C have been completely determ ined. However, the state of being allocated into a component can be replaced in this analysis by any status of the vertex which is changed after the descendants of a vertex have been determ ined; and this status may be used to determ ine if a vicious circuit has been found.

A kgorithm 5 is a simple procedure to initialize an array status over V (G). A status of none will indicate that no descendants of the vertex have been determ ined (except itself), fixed will indicate that all descendants of the vertex have been determ ined, and pending will indicate that the descendants are in the course of being determ ined. Because output vertices have only them selves for descendants, their status is initialized to fixed; all other vertices are initialized with status (v) = none. At the same time, A kgorithm 5 initializes a supremum function which represents only the relationships of each vertex to the ones following it on the same path. 3.2.4 An e cient algorithm for computing the natural pre-order of f

A lgorithm s6 and 7 below represent a modil ed version of A lgorithm 3, specialized to the application of computing the natural pre-order for the successor function f of a path cover C. Rather than explicitly constructing the in uencing digraph  $I_{\rm I}$  and traversing directed walks in  $I_{\rm f}$  (as is done in A lgorithm 3), we instead traverse in uencing walks for C (characterized by its' successor function) in the graph G.

Theorem 24. Let f be a successor function of a path cover C for a geometry (G;I;O). Let P : V(G) ! Im ap vertices v to the initial point of the path of C that covers v, and let L : V(G) ! digraph provided as the the input of the main procedure. Throughout, 4 denotes the natural pre-order of f.

For distinct vertices v; w 2 V (G), because (v ! w) 2 A ( $I_f$ ) if and only if either w = f (v) or w f (v), we may replace the iterator limits \w such that (v ! w) 2 A (D)" of the for loop starting on line 6 of A lgorithm 3 with a loop iterating over w = f (v) and w f (v): this is what we have on line 2 of TraverseInflWalk.

At line 8 of A lgorithm 3, if Comp(w) = nil, we infer that v and w are in a common di-connected component of the digraph  $I_f$ : this implies that v 4 w and w 4 v. If  $v \in w$ , this implies that 4 is not antisymmetric, and thus not a partial order; by Theorem 8, C is then not a causal path cover. We proceed by cases:

If 4 is antisymmetric, then the in uencing digraph is acyclic, in which case  $\pm$  has only trivial di-connected components. In this case, the following changes preserve the functionality of A lgorithm 3:

- In the case that w = v in the for loop, all the operations perform ed are super uous, in which case we may embed lines 7 through 9 in an if statem ent conditioned on  $w \notin v$ .
- Because each vertex is the only vertex in its' component when I<sub>f</sub> is acyclic, we may replace lines 11 through 19 of SimpleTC with a line setting Comp(v) to an arbitrary non-nil value, which in this case may be interpreted as allocating the vertex v to its' di-connected component (i.e. the singleton fvg).

A lso, the condition of line 8 is never satis ed in a call to SimpleTC(v). Then, we may replace the conditional code with an arbitrary statement, e.g. a command to abort the procedure.

- A fler the above replacement, the value of stack is not used within the procedure call SimpleTC(v), and has the same value after the procedure call to SimpleTC(v) as it does before the call. Then, stack is super uous to the performance of the algorithm. Similarly, the value of Root(v) is not a ected except to initialize it. We may then eliminate all references to either one.
- The value of Comp (w) is only tested to determ ine whether or not it is nil, so we may replace the array Comp with status, and its' possible states of being nil or non-nil with the states of being pending and non-pending. We deen the two values none and fixed to represent being non-pending and also having not yet been visited, and being non-pending and having been visited, respectively.
- Using the array sup to implicitly represent the sets of descendants, we may replace the union performed on line 9 with code which sets sup(i;v) to the minimum of sup(i;v) and sup(i;w) for each i2 I. Note also that, because x is a descendant of v in  $I_f$  i v = x or x is a descendant of w, we may remove the initialization of Desc(v) on line 5 of A lgorithm 3 if we initialize sup for each vertex so that it represents each vertex as a descendant of itself (for instance, in the main procedure, which is replaced by ComputeSuprema).

By perform ing the substitutions described above, we can easily see that TraverseInflWalk together with ComputeSuprema is equivalent to A lgorithm 3 when 4 is anti-symmetric. Then,  $\pounds$  fail because line 4 of ComputeSuprema is never evaluated; we then have = sup as in Equation 5, from the correctness of A lgorithm 3.

If 4 is not antisymmetric, then there are distinct vertices  $x; y \ge V$  (G) such that  $x \le y \le x$ , in which case x and y are in a non-trivial component in  $I_f$ . Then, the for loop of BuildCausalOrder will eventually encounter a vertex v of which x and y are descendants.

In the depth- rst traversalof in uencing walksperform ed in TraverseInflWalk(G;I;O;f;sup;status;v), eventually a directed cycle containing both x and y will be discovered. W ithout loss of generality, assume that the depth- rst traversal starting from v visits x before y: then, the depth- rst traversal will eventually uncover a walk of the form

Then in the procedure call TraverseInflWalk(G;I;O;f;sup;status; $y^0$ ), line 5 will nd status(x) = pending, as line 1 of the procedure call TraverseInflWalk(G;I;O;f;sup;status;x) has been executed while line 14 has not. Then, the procedure aborts by returning R without rst changing the status of status( $y^0$ ) from pending.

It is clear that if  $w^0$  depends on w, and if TraverseInflWalk(G;I;O;f;sup;status; $w^0$ ) aborts with status( $w^0$ ) = pending during a procedure call TraverseInflWalk(G;I;O;f;sup;status;w), then the latter will also abort with status(w) = pending. By induction, we may then show that for v 2 V (G) for which x and y are descendants, TraverseInflWalk(G;I;O;f;sup;status;v) will abort with status(v) = pending in the for loop in ComputeSuprema.

By the analysis of the case where 4 is antisym m etric, the status status (v) = pending w ill only occur at line 4 of Compute Suprema if 4 is not antisym m etric. If this occurs, = fail; as well, no causalpath cover exists for (G; I; 0) by Theorem 9, and thus no ow exists for (G; I; 0) by Theorem 8.

Thus,  $\epsilon$  fail i 4 is a partial order; and when this occurs, by reduction to A logrithm 3, sup corresponds to the natural pre-order 4 in the sense of Equation 5.

R un-time analysis. We may analyze the run-time of Algorithm 7 as follows. Let  $n = \frac{1}{2} (G)_{j,m} = \frac{1}{2} (G)_{j,m}$   $k = \frac{1}{2} = \frac{1}{2} j$ , and d be the maximum degree of G. The time required to execute the for all loop starting on line 8 of TraverseInflWalk is 0 (k); then, aside from the work done in recursive invocations to TraverseInflWalk, the time required to perform an invocation of TraverseInflWalk for a vertex v is 0 (k deg f (v)). Because the rst invocation of TraverseInflWalk for a vertex v will change status (v) to som ething other than none, which prevents any further invocations for v, TraverseInflWalk will only be called once for any given vertex in the course of A lgorithm 7. Then, sum m ing over all vertices v 2 V (G), the amount of time required to perform the for all loop starting on line 2 of ComputeSuprema is 0 (km). The time required by InitStatus to initialize sup and status is 0 (km); then, the overall running time of A lgorithm 7 is 0 (km).

#### 3.2.5 A slightly more e cient algorithm for nding a causal order for f

If C is a causal path cover, it also is possible to nd a causal order  $4 \mod 1$  compatible with f which diers from the natural pre-order for f, or determ ine that none exists, by recursively assigning integer \level" values to vertices rather than building the set of descendants. For example, one may construct a function :V (G) ! N satisfying

Note that the set S (x) of vertices y such that x = f(y) or x = f(y) are the initial points for any in uncering walk for C with one segment which ends at x. By constructing the predecessor function  $g = f^{-1}$  of C rather than the functions P and L in Algorithm 4, we can easily ind all elements of S (x) in G by visiting g(z) for z = x or z = x. Then, such a level function can be constructed by a Tarjan style algorithm similar to Algorithm 6, using the status array in the same way, but traversing the arcs of the in uncing digraph  $\frac{1}{2}$  in the opposite direction as TraverseInflWalk. We may then de nex  $\frac{4}{2}y$  ()  $[x = y]_{-}[(x) < (y)]$ .

It is easy to see that the resulting partial order [4] resulting would have the sam e maximum -chain length as the natural pre-order 4 : any maximal chain in 4 is a list of the end-points of consecutive segments in an in uencing walk for C, which will be a maximum chain in [4]. However, [4] also contains relationships between vertices with no clear relation in the in uencing digraph [4], because it su ces for two vertices to be on di erent \levels" for them to be comparable.

Such a causal order 4 can actually be constructed in 0 (m) time, because the algorithm to construct it consists essentially of just a depth- rst traversal with operations taking only constant time being done at each step. We have instead presented the above algorithm because the extra time required to obtain the coarsest compatible causal order for f will not a ect the asymptotic run time of the complete algorithm for noting a ow, because of the immediate reduction to the well-studied problem of transitive closure, and in the interest of describing an algorithm to construct the natural pre-order for f (being the coarsest compatible causal order for f).

### 3.3 The com plete algorithm

We now describe the complete algorithm to produce a ow for a geometry (G;I;O), using A lgorithm s2 and 7.

C orollary 25. Let (G;I;O) be a geometry with jIj=jOj. Then FindFlow halts on input (G;I;O). Furthermore, if FindFlow(G;I;O) = fail, then (G;I;O) does not have a causal ow; otherwise, FindFlow(G;I;O) = (f;P;L;sup), and (f;4) is a causal ow, where 4 is characterized by

and is the natural pre-order for f.

P roof | By Corollary 19, a causal path cover exists for (G;I;O) only if BuildPathFamily(G;I;O) sets 6 fail on line 1; thus if = fail, (G;I;O) has no causal ow by Theorem 8.0 therw ise, is a path cover. If BuildCausalOrder sets = fail on line 4, (G;I;O) has no causal ow by Theorem 24.0 therw ise, the relation 4 characterized by Equation 7 is the natural pre-order for f and a causal order, in which case (f;4) is a causal ow.

R un-time analysis. Because  $\frac{6}{6}$  fail at line 1 im plies that is a path cover, GetChainDecomp visits each vertex v 2 V (G) once to assign values for P (v), L (v), and possibly f (v) in the case that v 2 0<sup>°</sup>. Then, its' running time is 0 (n). The running time of FindFlow is then dom inated by BuildPathCover and ComputeSuprema, each of which take time 0 (km).

## 4 Potential Improvements

This paper has described e cient algorithms for nding ows, with the aim of not requiring prior know ledge of graph-theoretic algorithms in the presentation. This constraint has led to choices in how to present the algorithms which may make them less e cient (in practical terms) than may be achievable by the state of the art; and no signi cant analysis of the graphs them selves have been performed. Here, I discuss issues which may allow an improvement on the analysis of this article.

### 4.1 Better algorithms for nding path covers

For network- ow problems (the usual tools used for solving questions of maximum -size collections of paths in graphs), there is a rich body of experimental results for elicient algorithms. However, there seems to be very little discussion in the literature of the special case where all edge capacities are equal to 1, which is relevant to the problem of inding maximum collections of vertex-disjoint I { 0 paths. It is direct to determine, in this case, whether there is a signilicant directed in the performance of various algorithms. Although it is less elicient than other algorithms for general network ow problems, the most obvious choice of network ow algorithm for inding a maximum family of vertex-disjoint I { 0 paths is the Ford-Fulkerson algorithm, which has an asymptotic running time 0 (km). This running time is identical to Algorithm 2: this should not be surprising, as Algorithm 1 essentially implements a depth- rst variation of the Ford-Fulkerson algorithm for inding an augmenting ow.

A more thorough investigation of network owsmay yield an improved algorithm for noting a path cover for (G;I;O), which (when coupled with the faster algorithm for noting a minimum -depth causal order) would yield

#### 4.2 Extrem al results

a faster algorithm for nding causal ows.

C onsider all the ways we can add edges between n vertices to get a geom etry with k output vertices and a causal ow. Just to achieve a path cover, we require n k edges; this lower bound is tight, as graph consisting of just k vertex-disjoint paths on n vertices has this many edges, and the paths represent a causal path cover of that graph. The more interesting question is of how many edges are required to force a graph to not have any causal path covers.

Let **n** be the residue of n m odulo k. Consider a collection of k paths  $fP_{j}g_{j2\ [k]}$ , given by  $P_j = p_j^{(0)} \qquad j^{(dn}\bar{p}^{ke-1)}$ for j < n, and  $P_j = p_j^{(0)} \qquad j^{(bn}\bar{p}^{ke-1)}$  for j > n. Then, let G be the graph de ned by adding the edges  $p_1^{(a)}p_j^{(a)}$ for all a and h  $\epsilon$  j where these vertices are well-de ned, and  $p_j^{(a)}p_h^{(a+1)}$  for all a and h < j where these vertices are well-de ned. W e m ay identify the initial point of the paths  $P_j$  as elements of I and end-points as elements of 0: then, let M (n;k) denote the geometry (G; I; 0) constructed in this way.

The geometry M (n;k) has the obvious successor function given by  $f(p_j^{(a)}) = p_j^{(a+1)}$  for all j and a where both vertices are de ned. Then, consider the natural pre-order for f:

- (i). we obviously have  $p_j^{(a)} 4 p_j^{(b)}$  for a 6 b, for every j 2 [k];
- (ii). from the edges  $p_h^{\scriptscriptstyle (a)}\,p_j^{\scriptscriptstyle (a)}$  , we obtain  $p_h^{\scriptscriptstyle (a-1)}$  4  $p_j^{\scriptscriptstyle (a)}$  for allh;j2 [k] and alla > 0; and
- (iii). from the edges  $p_h^{(b+1)} p_j^{(b)}$  for h < j, we obtain  $p_h^{(b)} 4 p_j^{(b)}$  and  $p_j^{(b-1)} 4 p_h^{(b+1)}$ . (Note that the second of these two constraints is redundant, as  $p_j^{(b-1)} 4 p_h^{(b)} 4 p_h^{(b+1)}$  is in plied by the above two cases.)

Then, the natural pre-order 4 on M (n;k) is closely related to the lexicographical order on ordered pairs:  $p_h^{(a)}$  and  $p_j^{(b)}$  are incomparable if they are both endpoints of their respective paths  $P_h$  and  $P_j$ , and otherwise  $p_h^{(a)}$  4  $p_j^{(b)}$  if and only if either a < b, or a = b and h 6 j. This is clearly a partial order, so M (n;k) has a causal ow : and it has kn  $\frac{k+1}{2}$  edges in total.

I conjecture that this is the maximum number of edges that a geometry on n vertices with k output vertices can have. If this can be proven, we can determ ine that certain geometries have no ows just by counting their edges; the upper bounds of this paper can then be improved to  $0 (k^2n)$ .

## 5 Open Problem s

To conclude, I re-iterate the open problem spresented in [7].

- 1. The general case. When Jj> D j, it is easy to see that a causal ow cannot exist, because no successor function f may be de ned. This haves the case where Jj< D j. If = D j Jj, we may test sets @I I<sup>c</sup> with j@Ij = to see if the geometry (G;I [ @I;O) has a causal ow: doing this yields an O (km n) algorithm for noting a causal ow for (G;I;O). Is there an algorithm for noting causal ows in an arbitrary geometry with Jj6 D j, whose nun-time is also polynomial in = D j Jj?
- 2. G raphs w ithout designated inputs/outputs. Quantum computations in the one-way model may be performed by composing three patterns: one pattern to prepare an appropriate quantum state, a pattern to apply a unitary that state (in the vein that we have been considering in this article), and a nalpattern which measures the resulting state in an appropriate basis. The composite pattern has no input or output qubits, and so has only the measurement signals as an output. The result of the computation would then be determined from the parity of a subset of the measurement signals.

G iven a graph without any designated input or output vertices, what constraints are necessary to allow a structure similar to a causal ow to be found, which would guarantee that determ inistic n qubit operations in the sense of [5] can be performed in the one-way measurement model with the entanglement graph G?

- 3. Ruling out the presence of causal ows with only partial inform ation about G. Are there graphs G where it is possible to rule out the presence of a ow for (G;I;O) from a proper sub-graph of G, or given n =  $\frac{1}{2}$  (G)j, m =  $\frac{1}{2}$  (G)j, and k =  $\frac{1}{2}$  =  $\frac{1}{2}$  ); (This question obviously includes the extrem al problem asked earlier.)
- 4. Relaxing the causal ow conditions for Paulim easurements. Suppose that, in addition to I and O, we know which qubits are to be measured in the X axis and which are to be measured in the Y axis (corresponding to measurement angles 0 and =2 respectively). These qubits can always be measured rst in a pattern, by absorbing byproduct operations on those qubits and performing signal shifting. However, the analysis of patterns in terms of causal ows does not take this into account, as it is independent of

m easurem ent angles. Is it possible to develop a natural analogue for causal ow s which represents these qubits as m inim al in the corresponding causal order, which m ay be e ciently found for geometries with jj = j0 jor jj = j0 jor

The results of this article were inspired by the similarity between of the characterization in terms of causal ows, with aspects of graph theory related to M enger's Theorem in general, and the relationship between in uencing walks and alternating walks in particular. Investigation into open questions involving e cient construction of causal ows or relaxations of them may bene t from additional investigation of this link.
