Intensity correlations and entanglem ent by frequency doubling in a dual ported resonator

We show that non-classical intensity correlations and quadrature entanglement can be generated by frequency doubling in a resonator with two output ports. We predict twin-beam intensity correlations 6 dB below the coherent state limit, and that the product of the inference variances of the quadrature uctuations gives an Einstein-Podolsky-Rosen (EPR) correlation coe cient of $V_{EPR} = 0.6 < 1$. Comparison with an entanglement source based on combining two frequency doublers with a beam splitter shows that the dual ported resonator provides stronger entanglement at lower levels of individual beam squeezing. Calculations are performed using a self-consistent propagation method that does not invoke a mean eld approximation. Results are given for physically realistic parameters that account for the Gaussian shape of the intracavity beams, as well as intracavity losses.

I. IN TRODUCTION

The process of parametric down conversion has been used widely to generate non-classical optical elds at the level of single photons, as well as many photon

elds described by continuous variables[]. At the microscopic level non-classical correlations and entanglem ent arise due to the possibility of converting a single high frequency photon into a pair of correlated lower frequency photons. The down conversion process can be used to generate so called twin beam s that have intensity correlations that are stronger than would be obtained with individual coherent states[2, 3, 4, 5, 6, 7, 8]. Twin beam s have been successfully applied to sub-shotnoise spectroscopy [9] and quantum nondem olition measurem ents [10]. The generation of entangled beam s in param etric down conversion was predicted by Reid and D rum m ond in the late 80's[11, 12, 13], and is crucial for studies of quantum teleportation and networking[14, 15, 16, 17, 18].

The process of second harm onic generation (SHG) where a fundamental eld at $!_1$ is frequency doubled to create a harm onic at frequency $!_2 = 2!_1$ is complementary to parametric down conversion, and can also be used for creating nonclassical light. The possibility of using frequency doubling may be convenient for reaching spectral regions that are not readily accessible by down conversion. It is well known that quadrature squeezing of both the fundamental and harm onic elds occurs in second harm onic generation [19, 20, 21]. The generation of multibeam correlations in second harm onic generation share demonstrated the existence of correlations between the fundamental and harm onic elds 22, 23, 24, 25 including entanglement




FIG.1: (color online) A dual ported singly resonant cavity which provides two harm onic outputs.

between the fundam ental and harm onic elds[6, 27] and entanglem ent in type II SHG in the fundam ental eldsalone [28, 29]. The possibility of nonclassical spatial correlations in either the fundam ental or harm onic eldsalone [30, 31, 32] and of entanglem ent in the fundam ental eld[3] has also been shown in models that include di raction.

In this work we investigate the production of two beam s at the harm onic frequency that exhibit nonclassical intensity correlations and quadrature entanglem ent. The device we analyze is the dual ported resonator show n in Fig. 1. The pump beam at $!_1$ is resonant in the cavity, while the generated harm onic exits at both end m irrors. As we show below the harm onic outputs exhibit strong quantum correlations. This can be understood naively as follows. W hile traversing the crystal to the right squeezing is generated in the fundam ental and harm onic elds, as well as correlations between the fundam ental and harmonic. Even though all of the harm onic leaves the cavity at the right hand m irror, the intracavity fundam ental that generates a harm onic eld on the backwards pass through the crystal is correlated with harm onic output 1. The intracavity eld transfers the correlations to output 2, leading to a nonzero correlation between outputs 1 and 2.

In order to describe this process theoretically we need to go beyond the usual mean eld description of SHG squeezing [21], and account for variations in the elds at di erent locations inside the cavity. To do so we com -

bine the linearized solutions for propagation of quanuctuations in traveling wave SHG \$4, 35] with a tum self-consistent application of the cavity boundary conditions as was st done by M aeda and K ikuchi [6]. It was shown in Ref. 36 that the propagation model reproduces the mean eld results at low coupling strength, but predicts larger quantum noise reduction at high coupling strength. Since the propagation model relies on a linearized description of the quantum uctuations its validity m ay break down in the lim it of very large squeezing, where the uctuations in the unsqueezed quadrature are no longer sm all. The accuracy of the linearized m odel was studied by comparison with num erical solutions of a quantum phase space model[25]. It was found that the linearized m odel provides accurate predictions provided the normalized interaction length $\beta 4, 35$] does not exceed 2-3. In the results presented here, using realistic physical parameters and G aussian beam s, we have < 1. We are therefore con dent that the linearized theory provides an accurate description of the nonlinear resonator for the range of param eters considered here.

The structure of the paper is as follows. In Sec. II we de nenotation and present the solutions for the quadrature uctuations and squeezing spectra of the harmonic outputs. These results are used to calculate the intensity correlations in Sec. III. EPR correlations and inseparability [37] of the outputs are dem onstrated in Sec. IV. We compare the EPR correlations created in the dual ported resonator with the alternative approach of com bining two separate SHG resonators at a beam splitter in Sec. V, and give a discussion of the results obtained in Sec. V I.

II. PROPAGATION MODELOF INTRACAVITY SHG




FIG.2: (color online) Propagation model of singly resonant SHG cavity with dual output ports.

The dual ported resonator of Fig. 1 is shown in more detail in Fig. 2 where we have separated the forward and backward passes to create an equivalent ring resonator model. Since the counterpropagating beam s are strongly phase m ismatched in the crystal we can neglect any direct interaction between them. The pump beam at frequency $!_1$ enters through an input coupler described by transmission and rejection matrices T_1 ; R_1 (defined below). The second harm onic outputs are allowed to escape through input and output mirrors. The cavity is assumed to be resonant at the frequency $!_1$ of the external pump beam.

The coupled propagation of the slowly varying wave envelopes of the fundam ental (frequency $!_1$) and second harm onic (frequency $!_2$) in the crystal is described by the classical equations

The intensities of each eld are given by $I = \frac{0}{2}n_i c E_i \hat{f}$, n_i is the refractive index at frequency $!_i$, c is the speed of light in vacuum, and the phase m ism atch is $k = 2k_1$ k where $k_i = !_i n_i = c$: The coupling constants are given by $_i = !_1 d = (cn_i)$; where d is the e ective secondorder susceptibility of the crystal.

These equations are valid for plane waves whereas real experiments are typically performed with G aussian beams. In order to obtain the correct value for the coupling constant when using G aussian beams we avail ourselves of the results of the B oyd-K leinm an theory [38]. We assume that the fundamental eld is a lowest order G aussian beam with waist w (1=e² intensity radius) that is symmetrically located in the center of the crystal and introduce scaled eld amplitudes $A_i = i \frac{1}{0} cn_i = (2 \sim !_i)E_i$. The characteristic eld strength E_i is chosen such that $\frac{3}{4}i^{2}j$ gives the number of photons per second at frequency $!_i$ carried by the G aussian beam. The coupled equations for the scaled amplitudes then take the form

where h = arg(h); L_c is the length of the crystal, and $z_{R1} = n_1!_1 w^2 = (2 \text{ c})$ is the Rayleigh length of the fundam ental beam . The single pass conversion e ciency is determ ined by $E_{N L} = \frac{P_2 (z = L_c)}{P_1^2 (z = 0)}$, where $P_1; P_2$ are the powers of the two elds. The Boyd-K leinm an solution assum es that the harm onic is generated with a waist that gives equal Rayleigh lengths for both frequencies, and that the attenuation of the fundam ental eld due to upconversion is small. As shown in Appendix A the fractional depletion of the intracavity eld due to a single pass through the crystal is always sm all for the param eters considered here. For param eters where this is not the case it would be necessary to use a more cum bersom e multim ode theory that accounts for the coupling of different spatialm odes [39] which is outside the scope of the present work.

To solve for the transformation of quantum uctuations we replace the classical elds in Eqs. (2) by annihilation operators $\hat{A_j}$: The propagation equations for $\hat{A_j}$ are the same as the classical Eqs. (2). These nonlinear operator equations can be solved perturbatively by putting $\hat{A_j}(z;t) = A_j(z) + \hat{a_j}(z;t)$ where $A_j(z)$ are the (classical) mean elds and $\hat{a}_i(z;t)$ time and space depen-

dent uctuation operators which satisfy the commutation relations $[\hat{a}_i(z;t); \hat{a}_j^{Y}(z^0;t^0)] = _{ij}(z \ 2)$ (t $\hat{e}_j^{Y}; [\hat{a}_i(z;t); \hat{a}_j(z^0;t^0)] = 0$: We then linearize in the uctuation operators, and write the resulting operator equations as equations for classical uctuations with the replacements $\hat{a}_j(z;t) \ a_j(z;t), \hat{a}_j^{Y}(z;t) \ a_j(z;t)$. The sem iclassical theory [40] expresses the expectation values of symmetrically ordered quantum operators in terms of the classical c-num bers $a_j;a_j$.

The solutions to the linearized propagation equations are known [34, 35]. We can write the solutions in the form x (;t) = N ()x (0;t) where $x = (x; x_2; y_1; y_2)^T$ and

At this point we note that the transform ation m atrix (4) is only valid when is real. In the m ore general case of complex propagation m ixes the x and y quadratures. W e will limit our study to the case of real for which the analytical solutions can be expressed in terms of simple hyperbolic functions (the more general case involves elliptic functions). We therefore wish to have

real which is the case when k = 0: U nfortunately the maximum value of $E_{\rm N\,L}$ and hence is obtained for [88] $z_{\rm R\,1} = 0.176 L_{\rm c}$ and $k L_{\rm c} = 3.26$ which im plies a complex value of : For the analysis presented below we choose k = 0 in order to make real. For zero phase m ismatch the optimum value of the beam focusing corresponds to $z_{\rm R\,1} = 0.325 L_{\rm c}$, which gives a value of $E_{\rm N\,L}$ that is about 40% smaller than could be obtained with nonzero phase m ismatch. We will assume these focusing conditions in all the subsequent analysis. Numerical results will be given for a KNbO₃ crystal, fundamental wavelength of $_1 = 860$ nm, $L_{\rm c} = 1$ cm; d = 11 pm=V; $n_1 = n_2 = 2.2$; and k = 0 for which the optimum focusing is w = 21.1 m which gives $E_{\rm N\,L} = 0.015$ W⁻¹:

A self-consistent solution for the uctuations in the cavity of Fig. 2 is found by combining the transferm a-trix for the crystal propagation with the e ects of m irror re ections and transm issions as well as intracavity losses. We rst transform to frequency domain variables de ned by

Note that in the frequency domain the quadrature am - plitudes x (z;); y (z;) are complex variables.

We introduce the 4 4 matrices for transmission and re ection with nonzero pdiagonal elements $T_{j} = diag(\frac{1}{1} - \frac{T_{1j}}{T_{1j}}, \frac{T_{2j}}{1}, \frac{T_{2j}}{T_{2j}}, \frac{T_{2j}}{1}, \frac{T_{2j}}{T_{2j}}, \frac{T_{1j}}{1}, \frac{T_{2j}}{1}, \frac{T_{2j}}{$ where T_{ij} denotes the power transm ittance for frequency i at m irror j. Residual intracavity losses due to crystal absorption, re ections at crystal surfaces, and m irror losses are lumped into e ective loss beam splitters indicated by $L_3; L_4$ in Fig. 2. These losses are described by coe cients L_{ij} for frequency $!_i$ at position j and corresponding re ection and transmission matrices $L_2 j = 1$ $T_{L_j} = diag(1)$ L_{1j}; 1 L_{1j}; $R_{L_{j}} = diag(L_{1j}; L_{2j}; L_{1j};)$ L₂₁).

The phase shift acquired in one cavity round trip is represented by the matrix D =diag(e^{{ = c1};e^{{ = c2};e^{{ = c1};e^{{ = c2}}</sup>, where the cavity free spectral range is ci = c=(2n_iL_c + 2L_a), and 2L_a is the round trip length of air in the cavity. We have assumed the cavity is on resonance, so that the phase shift is an odd function of : This ensures that D can be used with the quadrature uctuation vector x(z;) which contains components at : If the cavity were detuned it would mix the x;y quadratures and the round trip phase would have to be calculated separately for a (z;) and a (z;):

Vacuum noise sources enter the cavity at m irrors 1;2 and through the loss ports. We describe these by quadrature noise vectors $v_j = (u_{1j}(); u_{2j}(); v_{1j}(); v_{2j}())^T$; where $u_{ij}(); v_{ij}()$ are frequency dom ain am plitude and phase quadrature uctuations of frequency $!_i$ at position j:

Using Eqs. (4-8) and the above de nitions the selfconsistent solution for the intracavity uctuations to the right of beam splitter 1 is

where I is the identity matrix. The result depends on the propagation lengths $_1$ and $_2$ which in turn are functions of the pump beam power and resonator parameters. Expressions for the propagation lengths in terms of experimentally accessible parameters are given in Appendix A. The vectors of output quadrature uctuations are de ned as $X_j = (X_{1j}; X_{2j}; Y_{1j}; Y_{2j})^T$, where j labels the spatial position. The outputs can be written in terms of the self-consistent intracavity eld as

Equations (10) are quite general and can be used to describe singly or doubly resonant cavities provided the nonlinear propagation is phase matched and the cavity is on resonance at both frequencies. The general expressions for the output quadratures that result from evaluation of these equations are very cum bersom e. W e will restrict ourselves to the case of a resonant fundam ental, and complete transmission of the harmonic at mirrors 1;2, i.e. $T_{21} = T_{22} = 1$: W e will assume that the intracavity losses L_3 ; L_4 only a ect the fundamental elds so $L_{23} = L_{24} = 0$: This last assumption is not a loss of generality since harm onic losses can be accounted for at the detectors external to the cavity. Finally, since we will take $L_{13} \in 0$ which accounts for fundam ental loss between the two passes through the crystal, we can put $T_{12} = 0$ without loss of generality. With these assum ptions the results for the harm on ic output quadrature uctuations can be written as

Explicit expressions for the coe cients f;g;h;j are given in Appendix B. Except when needed for clarity we will in what follows suppress the dependence on z and for brevity.

The spectra $S_{X j}$; $S_{Y j}$ are normalized by the input noise so that S < 1 corresponds to a squeezed quadrature. To evaluate the spectra we make the usual assumption that the input noise elds at di erent locations and frequencies are uncorrelated so that




FIG. 3: (color online) Amplitude squeezing (left) and phase antisqueezing (center) at = 0 for the parameters given in the text. The right hand plot shows the uncertainty product which is almost identical for the two output ports.

It can be readily veried using the expressions given in Appendix B that when $_1 = _2 = 0$ which corresponds to a purely linear resonator all the squeezing spectra are identically unity.

Representative results for the squeezing spectra are given in Fig. 3. The results are shown as a function of the pump beam power external to the cavity for parameters $E_{\rm N \ L1} = E_{\rm N \ L2} = .015$ W 1 ; $T_{11} = .01$; and $L_{13} = L_{14} = 0.005$: The dependence of $_1$; $_2$ on pump power is shown in Appendix A. The smaller squeezing effect on the second output beam can be attributed to the fact that the mean eld value of the intracavity power is reduced due to the SHG process after the forward pass through the crystal. Since, as is shown in Appendix A, the norm alized propagation lengths are less than 0.25 at the highest pump power used, we can expect the linearized sem iclassical results to be accurate [25].

III. NONCLASSICAL INTENSITY CORRELATIONS

G iven the squeezing spectra we can evaluate the quantum correlation of the intensity di erence or sum of the two output beam s. U sing two detectors we measure the intensity di erence of the harm on ic outputs as

where g is an electronic gain factor. As the intensities of the two harm onic outputs are not equal due to di erent propagation lengths $_1$; $_2$ as well as the possibility of unequal detector sensitivities we introduce an electronic gain parameter g that can be adjusted to m inim ize the noise of the intensity di erence or sum. We can express the variance of the detected intensity di erence uctuations in terms of the squeezing spectra calculated above as follows. The uctuations of a beam with intensity I are I() = 2IX (): The variance of the uctuations is given by

where $C_X = C_X = (0)$: W hen the second term is negative the variance can be less than unity which represents a nonclassical twin beam correlation.

As shown in Appendix A the intensity ratio is given by $I_1=I_2 = _1 = _2$ which can be determined from Eqs. (A 1-A2). For input powers up to a few W atts I_1 ' I_2 and S_{x1} ' S_{x2} : Thus the optimum g values are g_{opt} ' 1:

The case of g' 1 corresponds to an intensity di erence which has noise greater than the shot noise limit, while g' 1 which corresponds to the sum of intensities gives a strong nonclassical correlation. There is a simple physical explanation of this e ect. A positive am plitude




FIG. 4: (color online) N orm alized uctuations of the dierence and sum intensities at = 0 using g = 1: The inset shows g_{opt} for the intensity sum. The parameters used were the same as in Fig. 3.

uctuation in the harm onic output at port 1 corresponds to an increased depletion of the fundam ental beam . The weakened fundam ental then results in a smaller amplitude output of the harm onic at the second port. Thus the correlation function C_X is negative and the sum of the output intensities has a reduced expectation value.

U sing the optim um values g_{opt} the norm alized variance given by Eq. (16) can be written as

where the m inus sign corresponds to the case g' 1: The normalized intensity noise is shown in Fig. 4 as a function of pump power. The uctuations of the intensity sum for $g = g_{opt}$ are indistinguishable from the case g =

1 for the range of pump powers shown. We see that the nonclassical intensity correlation is stronger than the squeezing of each output beam shown in Fig. 3.

IV. EPR CORRELATIONS AND ENTANGLEMENT

The presence of nonclassical twin beam correlations motivates evaluating the presence of EPR correlations and entanglement between the two output beams. Optical beams with quadrature uctuations that embody EPR correlations were rst demonstrated in 199241]. The essence of the EPR paradox is the ability to infer an observable of one system from a measurement performed on a second system spatially separated from the

rst. Hence a conditional variance is used to quantify the degree of EPR correlation. As shown by Reid [12] a linear estimate of the inference variance can be used as a su cient condition for the presence of the EPR paradox.




FIG. 5: (color online) Normalized inferred variance of the harm onic outputs at = 0: The parameters used were the same as in Fig. 3.

We plot the inferred variance product in Fig. 5 as a function of the fundam ental pump power. The variance product is less than 1, im plying the outputs are EPR correlated, for pump power above about 30 mW.

The presence of EPR correlations are a su cient but not a necessary condition for entanglement of the two output beams. A necessary and su cient condition for entanglement of G aussian states is the inseparability of the density matrix describing the two output modes. This can be veried using the criterion of D uan et al.[7]. In our notation this criterion can be written as

In order to facilitate comparison with $V_{\rm EPR}$ de ned in Eq. (20) we have included a factor of 1=4 in the de nition of $V_{\rm D\,G\,C\,Z}$: Thus entanglem ent is indicated for both criteria by V < 1: Figure 5 shows that $V_{\rm D\,G\,C\,Z}$ < 1 for all

nite values of the pump power, and that $V_{B\,G\,C\,Z} < V_{E\,P\,R}$: These results verify that the harmonic elds at the two ouput ports are always entangled, but strong EPR correlations are only present when the pump power exceeds a threshold value.

V. EPR CORRELATIONS ON A BEAM SPLITTER




FIG. 6: (color online) M ethod for generating EPR correlations by mixing individually squeezed beams on a 50/50 beam splitter.

An alternative approach to creating EPR correlations is to combine two individually squeezed beam son a beam splitter[14], as shown in Fig. 6. The two input beam s are labeled with subscripts 1;2 and the two output beam s are labeled a;b: For notational convenience we drop the

rst subscript labeling the harm onic frequency. We can choose the phase of the incident beams such that the harm onic eld uctuations transform as

where the condition for an EPR paradox is $V_{EPR} < 1$: As seen in Fig. 3 second harmonic generation results in nonideal squeezed states with $S_{X \ 1}S_{Y \ 1} = p > 1$: We can then write $V_{EPR} = 4S_{X \ 1}^2 p^2 = (S_{X \ 1}^2 + p)^2$:




FIG. 7: (color online) EPR (solid lines) and inseparability (dashed line) correlation coe cients for nonideal squeezed beam s com bined on a beam splitter.

The EPR correlation is shown in Fig. 7 for several values of p:W e see that for strong am plitude squeezing the EPR correlation is quite insensitive to the degree of excess noise in the phase quadrature. On the other hand for m oderate levels of squeezing, less than about 4 dB, $V_{\rm EPR}$ increases signi cantly with p:R eferring to Fig.3 we see that P_{in} = 0.5 W gives S_X = 2 dB and p = 22. For




FIG.8: (color online) Correlation coe cient V $_{\rm EPR}$ produced by mixing outputs from dual and single port resonators. The correlation is calculated as a function of the total input power, so that in the case of two linear or ring resonators, each one is pumped by P_{in}=2 as shown in Fig. 6.

these values the EPR correlation obtained by m ixing two individually squeezed beam s on a beam splitter is $V_{EPR} = 1:1$, so there is no EPR paradox. On the other hand for $P_{in} = 0.5 \text{ W}$ the dualported resonator gives $V_{EPR} = 0:7$: Thus the dualported resonator is able to generate m uch stronger EPR correlations even though the output beam s have a lower level of squeezing than is required using a beam splitter to m ix two squeezed sources.

W hen combining two equivalent squeezed sources on a beam splitter the DGCZ criterion as given by Eq. (21) takes on the simple form $V_{DGCZ} = S_X$; which is independent of the parameter p: Thus, as seen in Fig. 7, non-separable beam s can always be created by beam splitter mixing, even using nonideal squeezed sources.

W e can also compare the EPR correlation generated in the dual ported resonator directly with beam splitter mixing as a function of total pump power. As seen in Fig. 8 the value of $V_{\rm EPR}$ generated using two sources and a beam splitter depends strongly on the characteristics of the source. The upper curve labeled linear resonator shows the results obtained by using one of the outputs from a dual ported resonators with the parameters used in Figs. 3 to 5. This is clearly suboptim al as only half of the generated harm onic light is being used, and no EPR paradox is seen for moderate pump powers in this case. The lower curve labeled ring resonator corresponds to an optim ized ring resonator which has the same param – eters as for the dual ported resonator except $E_{\rm N \ L2}$ = 0: This resonator generates m uch stronger squeezing, and also a sm aller $V_{\rm EPR}$ than the dual ported resonator. We defer until the next section a discussion of the optim al approach to generating EPR correlations using SHG .

VI. DISCUSSION

We have shown that SHG in a resonator with two output ports can be used to generate output beams that exhibit nonclassical intensity correlations, as well as entanglem ent. The analysis uses a propagation model for the quantum uctuations that goes beyond the usual m ean eld approximation. We have shown results for the zero frequency noise uctuations. The nonclassical correlations and entanglem ent will degrade as the frequency considered is increased, with the frequency dependence following the usual Lorentizan form for a nonlinear cavity [21]. The use of SHG to create entangled beam s, as opposed to the more com monly employed m ethod of param etric oscillation or am pli cation, m ay be advantageous in that it provides additional exibility in the choice of spectral region for the entangled beam s. It is also possible to com bine two individually squeezed beam s with a 50-50 beam splitter to create entanglem ent[14]. The question therefore arises as to which method, the dual ported resonator or two separate resonators, is most e cient at creating usable entanglem ent. This question has been considered for the case of degenerate vs. nondegenerate param etric oscillation in R ef. [42] where it was shown that a single nondegenerate oscillator was generally preferred.

Referring to Fig. 8 we see that the EPR correlations strength for a given available pump power obtainable with the dual ported resonator lies in between the results obtained by combining the outputs of two separate dual ported, or single port ring resonators. The results presented were obtained for resonator parameters given in the text. A lthough di erences occur for di erent parameter choices we believe the results presented are representative. Given available nonlinear crystals which x the value of $E_{\rm N \ L}$ the most important parameters that can be varied are the internal losses and input coupler transmissions. Results have been given for round trip passive losses of $L_{13} + L_{14} = 1$ %. Reducing this further gives larger nonclassical elects but seem s unrealistic for current experiments. We have also chosen a low input

coupler transm ission of $T_{11} = 1$ % : W hile this does not give the maximum possible harm onic conversion we have found that it is close to optimum for generating squeezing.

A lthough Fig. 8 appears to show that, as far as EPR correlations are concerned, it is more e cient to com bine two separate resonators, this conclusion m ay not be warranted. The single output resonator which generates the strongest EPR correlation in Fig. 8 does so by producing large amounts of squeezing. For the parameters used in the text and $P_{in}=2 = 0.5 \text{ W}$ the ring resonator is predicted to give about 6 dB of am plitude squeezing into a single harm onic output. On the other hand the largest am ount of am plitude squeezing ever reported in a SHG experiment was, to the best of our know edge, measured to be 2.4 dB, with an inferred squeezing of 5.2 dB [43]. It may therefore not be possible to achieve the level of squeezing predicted in the theoreticalmodel. The di culties include parasitic e ects such as blue light induced infrared absorption that become prom inent when large am ounts of the harm onic eld are generated [44]. There are also more fundam ental lim itations present in high conversion e ciency SHG due to the excitation of competing parametric processes which have been shown to lim it the level of harm onic squeezing that is attainable [45].

G iven these considerations the use of a dual ported

resonator which generates a strong EPR correlation even though the squeezing level and the power of each beam are not large m ay be advantageous com pared to com bining separate SHG resonators on a beam splitter. Finally, we note that the dual ported con guration of Fig. 1 is also attractive in terms of experim ental sim plicity, com – pared to a two resonator plus beam splitter arrangem ent.

APPENDIX A: EFFECTIVE INTERACTION STRENGTH

In order to use Eqs. (10) to calculate output spectra we must rst evaluate the interaction strength in each crystal. Because the fundam ental is partially converted to the second harm onic in the rst pass through the crystal the interaction in the second pass will be slightly weaker.

The cavity geometry is shown in Fig. 2. After some simple algebra we nd for the conversion e ciency of crystal1

We have introduced the conversion e ciencies $_1 = P_{21}=P_{in}$; $_2 = P_{22}=P_{in}$; P_{21} ; P_{22} are the harmonic output powers after the stand second crystal passes, P_{in} is the fundamental pump power external to the cavity, and the other parameters are de ned in Sec. II. When $E_{NL2} = L_{14} = T_{12} = 0$ Eq. (A1) reduces to the known result [46] for a single crystal ring cavity.




FIG.9: (color online) Power conversion e ciency, second harm onic power and norm alized propagation length, in the dual output cavity.

Num erical examples using the same parameters as in Sec. II ($E_{NL1} = E_{NL2} = :015 \text{ W}^{-1}$; $n_1 = n_2 = 2:2$; $T_{11} = :01; T_{12} = 0; L_{13} = L_{14} = :005$) are shown in Fig. 9. The conversion e ciencies, second harm onic power, and propagation lengths are shown in Fig. 9 as a function of the input pum p power. The parameters were chosen to give strong nonclassical correlations, but are not optim al for power conversion since $_1$; $_2$ peak at quite low power, and the cavity is undercoupled at higher input powers. We see that the norm alized propagation lengths 1; 2 1 so the linearized analysis used in the paper is reliable. In addition the fractional pump depletion due to a single pass of the intracavity eld with power P_c through the crystal is given by $P_c=P_c =$ $_{1}E_{N L 1}P_{in}$: For the parameters used the fractional depletion is always less than 5%, so the Boyd-K leinm an analysis which is based on the assumption of an unaltered spatial form for the fundam ental eld is a good approxim ation.
