G eneral pure multipartite entangled states and the Segre variety

A bstract

In this paper, we construct a measure of entanglement by generalizing the quadric polynomial of the Segre variety for general multipartite states. We give explicit expressions for general pure three-partite and four-partite states. Moreover, we will discuss and compare this measure of entanglement with the generalized concurrence.

1 Introduction

Quantum entanglement has received a lot of attention during the recent years because of its usefulness in m any quantum information and communication tasks such as quantum teleportation and quantum cryptography. However, there is still many open questions concerning the quanti cation and classi cation of multipartite states and also its true nature. Thus a deep understanding of this interesting quantum mechanical phenomena could result in construction of new algorithms and protocols for quantum information processing. One widely used measure of entanglement is the so-called concurrence [1]. The connection between concurrence and geometry is found in a map called the Segre em bedding [2, 3]. In this paper we will expand our result on the Segre variety [4], which is a quadric space in algebraic geometry, by constructing a m easure of entanglem ent for general pure multipartite states, which also coincides with concurrence of a general pure bipartite and three-partite states [5]. Now, let us start by denoting a general, pure, composite quantum system m Q consisting of the pure state j i = $\begin{pmatrix} P_{N_1} & P_{N_2} & P_{N_m} \\ k_1 = 1 & k_2 = 1 & k_m = 1 & k_1; k_2; \dots; i_m \end{pmatrix} k_1; k_2; \dots; k_m i$ and corresponding to the Hilbert space H_Q = H_{Q1} H_{Q2} Q_M, where the dimension of the jth Hilbert space is N $_{\rm j}$ = dim (H $_{\rm Q}$ $_{\rm i}$). W e are going to use this notation throughout this paper. In particular, we denote a pure twoqubit state by $Q_2^p(2;2)$. Next, let Q denote a density operator acting on H Q. The density operator o is said to be fully separable, which we will denote by sep , w ith respect to the H ilbert space decomposition, if it can be written as $P_N = P_N = P$ p_k are positive real numbers and $\frac{k}{0}$, denotes a density operator on Hilbert space H_{Q_j} . If p = p represents a pure state, then the quantum system is fully separable if p = p can be written as p = p then the quantum system is fully operator on H_{Q_j} . If a state is not separable, then it is said to be an entangled

state. For those readers who are unfamiliar with algebraic geometry, we give a short introduction to the basic denition of complex algebraic and projective variety. However, the standard references for the complex projective variety are [6,7]. Let $fg_1;g_2;\dots;g_qg$ be continuous functions C^n ! C. Then we dene a complex space as the set of simultaneous zeroes of the functions

The com plex space becomes a topological space by giving them the induced topology from C $^{\rm n}$. Now, if all g_i are polynomial functions in coordinate functions, then the real (com plex) space is called a real (com plex) a nevariety. A complex projective space C P $^{\rm n}$ is dened to be the set of lines through the origin in C $^{\rm n+1}$, that is,

The com plex manifold C P 1 of dimension one is a very in portant one, since as a real manifold it is homeomorphic to the 2-sphere S^2 , e.g., the B loch sphere. Moreover, every complex compact manifold can be embedded in some C P n . In particular, we can embed a product of two projective spaces into a third one. Let $fg_1;g_2;\dots;g_qg$ be a set of homogeneous polynomials in the coordinates $f_1;g_2;\dots;g_qg$. Then the projective variety is defined to be the subset

We can view the complex a nevariety $V_C(g_1;g_2;...;g_q)$ C^{n+1} as a complex cone over the projective variety $V(g_1;g_2;...;g_q)$.

2 Multi-projective variety and a multipartite entanglement measure

In this section, we will review the construction of the Segre variety. Then, we will construct a measure of entanglement for general multipartite states based on a modication of the denition of the Segre variety. This is an extension of our pervious result on construction of a measure of entanglement for general pure multipartite states [4]. Then the ideal I_A^m of S_A is generated by $P_{k_1;l_2;k_2;l_2;...;k_m}$; l_m and describes the separable states in $C P^{N_1N_2}$ m^{N_1} [8]. The image of the Segre embedding Im $(S_{N_1;N_2;...;N_m})$, which again is an intersection of families of quadric hypersurfaces in $C P^{N_1N_2}$ m^{N_1} , is given by

where N is an arbitrary normalization constant and j=1;2;:::;m. This measure coincides with the generalized concurrence for a general bipartite and three-partite state, but for reasons that we have explained in [4], it fails to quantify the entanglement form 4, whereas it still provides the condition of full separability. However, it is still possible to dene an entanglement measure for general multipartite states if we modify the equation (8) in such away that it contains all possible permutations of indices. To do so, we propose a measure of entanglement for general pure multipartite states as

where Perm () denotes all possible perm utations of indices $k_1;k_2;\dots;k_m$ by $l_1;l_2;\dots;l_m$, e.g., the rst set of perm utations is give by equation (6) de ning the Segre variety. By construction this measure of entanglement vanishes on product states and it is also invariant under all possible perm utations of

indices. Note that the $\,$ rst set of permutations de nes the Segre variety, but there are also additional products of the complex projective spaces as subspaces of C P $^{\rm N}$ $_{\rm 1}$ N $_{\rm 2}$ $^{\rm m}$ N $^{\rm 1}$ which are de ned by other sets of permutations of indices in equation (9).

3 Som e exam ples: three-partite and four-partite states

In this section we will apply this measure of entanglement to three-partite and four-partite states and give explicit expression for the measure of entanglement for these states. We start by the simplest multipartite states, namely three-partite states. Following the recipe in the general expression for multipartite states, we can write the measure of entanglement for such states as

This measure of entanglement for three-partite states (10) coincides with generalized concurrence [5]. Moreover, this measure of entanglement measure is equivalent but not equal to our entanglement tensor based on joint POVMs on phase space [9]. Next, we will discuss the measure of entanglement for four-partite states. In this case, we have more then one set of permutations and as we have explained before this is the reason why the measure of entanglement that is directly based on the polynomial that dene the Segre variety fails to quantify the entanglement of four-partite states. Now, a measure of entanglement based on the modied Segre variety for four partite states is given by

The rst sum in equation (11) de nes the Segre variety, and the second sum gives another product of the complex projective spaces which is still a quadratic subspace of CP N_1N_2N_3N_4 . For example, for four-qubit states the rst set

of perm utations represented by the rst sum gives 112 quadric terms and the second set of perm utations, which is represented by the second sum, gives 36 quadric terms. Thus a measure of entanglement for four-qubit states contains 148 terms.

4 Conclusion

In this paper, we have constructed a geometric well-motivated measure of entanglement for general pure multipartite states, based on an extension of the Segre variety. This measure of entanglement works for any pure state and vanishes on multipartite product states. We have also given explicit expressions for our entanglement measure for general pure three-partite and four-partite states. Moreover, we have compared this measure of entanglement with the generalized concurrence.
