

# Yangian and Applications

## Abstract

In this paper, the Yangian relations are tremendously simplified for Yangians associated to  $SU(2)$ ,  $SU(3)$ ,  $SO(5)$  and  $SO(6)$  based on RTT relations that much benefit the realization of Yangian in physics. The physical meaning and some applications of Yangian have been shown.

## 1 Introduction

Yangian was presented by Drinfel'd ([1-3]) twenty years ago. It receives more attention for the following reasons. It is related to the rational solution of Yang-Baxter equation and the RTT relation. It is a simple extension of Lie algebras and the representation theory of  $Y(SU(2))$  has been given. Some physical models, say, two component nonlinear Schrödinger equation, Haldane-Shastry model and 1-dimensional Hubbard chain do have Yangian symmetry. Yangian may be viewed as the consequence of a "bi-spin" system. How to understand the physical meaning of Yangian is an interesting topic. In this paper, there is nothing with mathematics. Rather, we try to use the language of quantum mechanics and Lie algebraic knowledge to show the effects of Yangian.

## 2 Yangian and RTT Relations

Let  $G$  be a complex simple Lie algebra. The Yangian algebra  $Y(G)$  associated to  $G$  was given as follows ([1-3]). For a given set of Lie algebraic generators  $I$  of  $G$  the new generators  $J$  were introduced to satisfy

$$[I_i; I_j] = C_{ij} I_k \quad C_{ij} \text{ are structural constants;} \quad (2.0.1)$$

$$[I_i; J_k] = C_{ik} J_k; \quad (2.0.2)$$

and, for  $G \in \mathrm{sl}(2)$ :

$$[J_i; [J_i; I_k]] - [I_k; [J_i; J_k]] = a_{ijk} f_{I_k; I_i; I_j} g; \quad (2.0.3)$$

where

$$a_{ijk} = \frac{1}{4!} C_{ii} C_{jj} C_{kk}; \quad (2.0.4)$$

$$f_{I_k; I_i; I_j} g = \sum_{\substack{i+j+k \\ i \neq j \neq k}} x_i x_j x_k; \quad (\text{symmetric summation}); \quad (2.0.5)$$

or for  $G = \mathrm{sl}(2)$ :

$$\begin{aligned} & [J_i; [J_i; I_k]] + [[J_i; J_k]; [I_k; J_i]] \\ &= (a_{ijk} C_{ii} + a_{jki} C_{jj}) f_{I_k; I_i; I_j} g; \end{aligned} \quad (2.0.6)$$

When  $C_{ij} = i^{(j-i)}$  ( $i, j = 1, 2, 3$ ), equation (2.0.3) is identically satisfied from the Jacobian identities. Besides the commutation relations there are coproducts as follows.

$$(I_i) = I_i \otimes 1 + 1 \otimes I_i; \quad (2.0.7)$$

$$(J_k) = J_k \otimes 1 + 1 \otimes J_k + \frac{1}{2} C_{kk} I_i \otimes I_i; \quad (2.0.8)$$

Further, the Yangian can be derived through RTT relations where  $R$  is a rational solution of Yang-Baxter equation (YBE) ([1-12]).

After lengthy calculations, we found the independent relations for  $Y(\mathrm{SU}(2))$ ,  $Y(\mathrm{SU}(3))$ ,  $Y(\mathrm{SO}(5))$  and  $Y(\mathrm{SO}(6))$  by expanding the RTT relations and also checked through equations (2.0.1)-(2.0.3) and (2.0.6) by substituting the structural constants ([13-17]), where RTT relation (Faddeev, Reshetikhin, Takhtajan | RFT [18]) satisfies

$$R(u-v)(T(u)-1)(1-T(v)) = (1-T(v))(T(u)-1)R(u-v); \quad (2.0.9)$$

## 2.1 Y (SU(2))

Let  $P_{12}$  be the permutation. Setting

$$R_{12}(u) = P R_{12}(u) = uP_{12} + I; \quad (2.1.1)$$

$$\begin{aligned} T(u) &= I + \sum_{n=1}^{\infty} u^n \begin{pmatrix} T_{11}^{(n)} & T_{12}^{(n)} \\ T_{21}^{(n)} & T_{22}^{(n)} \end{pmatrix}^{\#} \\ &= I + \sum_{n=1}^{\infty} u^n \frac{1}{2} (T_0^{(n)} + T_3^{(n)}); \quad \begin{pmatrix} T_+^{(n)} \\ \frac{1}{2} (T_0^{(n)} - T_3^{(n)}) \end{pmatrix}; \end{aligned} \quad (2.1.2)$$

and substituting the  $T(u)$  into RTT relation it turns out that only

$$I = T^{(1)}; I_3 = \frac{1}{2} T_3^{(1)}; \quad (2.1.3)$$

$$J = T^{(2)}; J_3 = \frac{1}{2} T_3^{(2)} \quad (2.1.4)$$

are independent ones. The quantum determinant

$$\det T(u) = T_{11}(u)T_{22}(u-1) - T_{12}(u)T_{21}(u-1) = C_0 + \sum_{n=1}^{\infty} u^n C_n \quad (2.1.5)$$

gives

$$C_0 = 1; C_1 = T_0^{(1)} = \text{tr} T^{(1)}; \quad (2.1.6)$$

$$C_2 = T_0^{(2)} - I^2 + T_0^{(1)} (1 + \frac{1}{2} T_0^{(1)}); \quad ; : \quad (2.1.7)$$

The independent commutation relations of Y (SU(2)) are:

$$[I; I] = i \quad I \quad ( ; ; = 1; 2; 3); \quad (2.1.8)$$

$$[I; J] = i \quad J; \quad (2.1.9)$$

and  $(A = A_1 - iA_2)$

$$[J_3; [J_+; J_-]] = (J_- J_+ - I_- J_+) I_3 \quad (2.1.10)$$

that can be checked to generate all of relations of equations (2.0.1), (2.0.2) and (2.0.6) with the help of Jacobi identities.

The coproduct is given through (RTT) as

$$T_{ab} = \sum_c T_{ac} \quad T_{cb}; \quad (2.1.11)$$

The simplest realization of  $Y(SU(2))$  is

$$I = \sum_{i=1}^N I_i \quad (i : \text{lattice indices}); \quad (2.1.12)$$

$$J = \sum_{i=1}^N i I_i + \sum_{i < j} W_{ij} I_i - I_j; \quad (2.1.13)$$

where

$$W_{ij} = \begin{cases} 1 & i < j \\ 0 & i = j \\ -1 & i > j \end{cases} \quad (\text{for any representation of } SU(2)) \quad (2.1.14)$$

or

$$W_{jk} = i \cot \frac{(j-k)\pi}{N} \quad (\text{only for spin } \frac{1}{2}; \text{ Haldane-Shastry model [19-21]}); \quad (2.1.15)$$

and  $i$  arbitrary constants. Noting that  $i$  plays important role for the representation theory of  $Y(SU(2))$  given by Chari and Pressley ([22-24]).

The big difference between representations of Lie algebra and Yangian is in that in Yangian there appear free parameters  $i$  depending on models.

Another example for single particle is finite  $W$ -algebra ([25-26]). Denoting by  $L$  and  $B$  angular momentum and Lorentz boost, respectively, as well as  $D$  the dilatation operator, the set of  $L$  and  $J$  satisfies  $Y(SU(2))$  where ([13], [25])

$$I = L \quad (2.1.16)$$

$$J = I - B - i(D - 1)B \quad (2.1.17)$$

and

$$[J, J] = i(2I^2 - c_2^0 - 4)I; \quad c_2^0 \text{ casimir of } SO(4;2); \quad (2.1.18)$$

There are the following models whose Hamiltonians do commute with  $Y(SU(2))$ .

Two component nonlinear Schrodinger equation (Mukarakam and Wadati [27])

$$i_t = -\phi_{xx} + 2c_1 \phi_x^2; \quad (2.1.19)$$

$$I = \int dx^+ (x) \left( \frac{\phi_x}{2} \right)^2 (x); \quad (2.1.20)$$

$$J = i \int dx^+ (x) \left( \frac{\phi_x}{2} \right)^2 (x) - \frac{ic}{2} \int dx dy^+ (y) \phi_x^+(y) \phi_x^-(y); \quad (2.1.21)$$

One-dimensional Hubbard model (for  $N = 1$ , [28])

$$\begin{aligned}
 H &= \sum_{i=1}^N (a_i^\dagger a_{i+1} + a_{i+1}^\dagger a_i + b_i^\dagger b_{i+1} + b_{i+1}^\dagger b_i) - U \sum_{i=1}^N (a_i^\dagger a_i - \frac{1}{2})(a_i^\dagger a_i - \frac{1}{2}); \quad (2.1.22) \\
 J &= J_1 - iJ_2; \\
 J_+ &= \sum_{\substack{i,j \\ i>j}} a_i^\dagger b_j - U \sum_{\substack{i,j \\ i>j}} "a_i^\dagger I_i^+ I_j^3; \\
 J &= \sum_{\substack{i,j \\ i>j}} b_i^\dagger a_j + U \sum_{\substack{i,j \\ i>j}} "a_i^\dagger I_i^- I_j^3; \\
 J_3 &= \frac{1}{2} \sum_{i,j} (a_i^\dagger a_j - b_i^\dagger b_j) + U \sum_{i<j} "a_i^\dagger I_i^+ I_j^-; \quad (2.1.23)
 \end{aligned}$$

where

$$\begin{aligned}
 "a_i^\dagger &= \begin{cases} 1 & i < j; \\ 0 & i = j; \\ -1 & i > j; \end{cases} \\
 "a_i^\dagger &= \begin{cases} 1 & i < j; \\ 0 & i = j; \\ -1 & i > j; \end{cases} \quad (2.1.24)
 \end{aligned}$$

Essler, Korepin and Schoutens found the complete solutions ([29–30]) and excitation spectrum ([31]) of 1-D Hubbard model chain.

Haldane-Shastry model ([9–21]) whose Hamiltonian is given by a family. The first member is

$$H_2 = \sum_{i,j}^X 0 \left( \frac{Z_i Z_j}{Z_{ij} Z_{ji}} \right) (P_{ij} - 1); \quad (2.1.25)$$

where and henceforth the ' stands for  $i \neq j$  in the summation and  $P_{ij} = 2(S_i - \frac{1}{4})$ ,  $Z_k = \exp^{i \frac{k}{N}}$ ,  $Z_{ij} = Z_i - Z_j$ . The next reads

$$H_3 = \sum_{i,j,k}^X 0 \left( \frac{Z_i Z_j Z_k}{Z_{ij} Z_{jk} Z_{ki}} \right) (P_{ijk} - 1); \quad (2.1.26)$$

and

$$H_4 = \sum_{i,j,k,l}^X 0 \left( \frac{Z_i Z_j Z_k Z_l}{Z_{ij} Z_{jk} Z_{kl} Z_{li}} \right) (P_{ijkl} - 1) + H_4^0; \quad (2.1.27)$$

$$H_4^0 = \frac{1}{3} H_2 - 2 \sum_{i,j}^X 0 \left( \frac{Z_i Z_j}{Z_{ij} Z_{ji}} \right)^2 (P_{ij} - 1); \quad (2.1.28)$$

where

$$\begin{aligned}
 P_{ijk} &= P_{ij} P_{jk} + P_{jk} P_{ki} + P_{ki} P_{ij}; \\
 P_{ijkl} &= P_{ij} P_{jk} P_{kl} + (\text{cyclic for } i,j,k \text{ and } l); \quad (2.1.29)
 \end{aligned}$$

The eigenvalues of  $H_2$  and  $H_3$  have been solved in Ref. [21] and numerical calculations were made for  $H_4$ . The  $H_2$  and  $H_3$  were shown to be obtained in terms of quantum determinant ([32]).

Hydrogen atom (with and without monopole, [33])

$$H = \frac{p^2}{2} + \frac{1}{2} \frac{q^2}{r^2} - \frac{e^2}{r}; \quad p = zeA \quad (2.1.30)$$

where  $p$  is mass,  $q = ze^2$ ,  $e^2$  and  $g$  being monopole charge.

Super Yang-Mills Theory ( $N = 4$ ):  $Y(SO(6))$  ([34])

$$H = 2 \sum_j^X h(j) P_{j+1}^j; \quad h(j) = \sum_{k=1}^{X-j} \frac{1}{k}; \quad h(0) = 1; \quad (2.1.31)$$

where  $P^j$  is projector for the weight  $j$  of  $SU(2)$  and  $X$  stands for "lattice" index.

## 2.2 $Y(SU(3))$

For the Yangian associated to  $SU(3)$ , there are the following independent relations

$$[I_i; I_j] = \text{if } i=j; \quad [I_i; J] = \text{if } J(i, j) = 1; \quad ; \quad (2.2.1)$$

Denote

$$I^{(1)} = I_1 - iI_2; \quad U^{(1)} = I_6 - iI_7; \quad V^{(1)} = I_4 - iI_5; \quad \frac{P}{2} I_8^{(1)} = I_8; \quad (2.2.2)$$

and  $J$  represents the corresponding operator for  $I^{(2)}$ ;  $U^{(2)}$ ;  $V^{(2)}$  and  $I_8^{(2)}$ ;  $I_3^{(2)}$ . After lengthy calculation one finds that based on RTT relation there is only one independent relation for  $Y(SU(3))$  additional to equation (2.2.1):

$$[I_8^{(2)}; I_3^{(2)}] = \frac{1}{3!} (f I_+^{(1)}; U_+^{(1)}; V_+^{(1)} g - f I_-^{(1)}; U_-^{(1)}; V_-^{(1)} g) \quad (2.2.3)$$

where  $f$  stands for the symmetric summation. The conclusion can be verified through both the Drinfeld formula ( $C_{ij} = \text{if } i=j$ ) and RTT relations with replacing  $P_{12}$  in  $SU(2)$  by

$$P_{12} = \frac{1}{3} I + \frac{1}{2} X; \quad (2.2.4)$$

where  $X$  are the Gell-Mann matrices. Setting

$$T(u) = \sum_{n=0}^{\infty} u^n T^{(n)}; \quad (2.2.5)$$

$$T^{(n)} = \begin{matrix} \frac{2}{6} \frac{1}{3} T_0^{(n)} + T_3^{(n)} + \frac{1}{\sqrt{3}} T_8^{(n)} & T_1^{(n)} - iT_2^{(n)} & T_4^{(n)} - iT_5^{(n)} & 3 \\ \frac{6}{4} T_1^{(n)} + iT_2^{(n)} & \frac{1}{3} T_0^{(n)} - T_3^{(n)} + \frac{1}{\sqrt{3}} T_8^{(n)} & T_6^{(n)} - iT_7^{(n)} & \frac{7}{5} \\ T_4^{(n)} + iT_5^{(n)} & T_6^{(n)} + iT_7^{(n)} & \frac{1}{3} T_0^{(n)} - \frac{2}{\sqrt{3}} T_8^{(n)} & \end{matrix} \quad (2.2.6)$$

and substituting them into RTT relation we find equations (2.2.1)–(2.2.3) are independent relations together with the co-product, for example,

$$\begin{aligned} I^{(2)} &= I^{(2)} \quad 1 + 1 \quad I^{(2)} \quad 2(I_3^{(1)} \quad I^{(1)} \quad I^{(1)} \quad I_3^{(1)}) \\ &+ \frac{1}{2}(V^{(1)} \quad U^{(1)} \quad U^{(1)} \quad V^{(1)}) \end{aligned} \quad (2.2.7)$$

and others.

The quantum determinant of  $T(u)$  which is 3 by 3 matrix for the fundamental representation of  $gl(3)$  takes the form

$$\begin{aligned} \det_3 T(u) &= T_{11}(u)fT_{22}(u-1)T_{33}(u-2) \quad T_{23}(u)T_{32}(u-2)g \\ &\quad T_{12}(u)fT_{21}(u-1)T_{33}(u-2) \quad T_{23}(u-1)T_{31}(u-2)g \\ &\quad + T_{13}(u)fT_{21}(u-1)T_{32}(u-2) \quad T_{22}(u-1)T_{31}(u-2)g \\ &= \sum_p (-1)^p T_{1p_1}(u)T_{2p_2}(u-1)T_{3p_3}(u-2) \end{aligned} \quad (2.2.8)$$

where  $p$  stands for all the possible arrangements of  $(p_1; p_2; p_3)$ . In comparison with the quantum determinant

$$\det_2 T(u) = \sum_{k+l=m=0}^{\lambda} \frac{(l+m-1)!}{(m-1)l!} u^{-(m+l+k)} (T_{11}^{(k)} T_{22}^{(m)}) - T_{12}^{(k)} T_{21}^{(m)}; \quad (2.2.9)$$

now we have

$$\begin{aligned} \det_3 T(u) &= \sum_{k+l+m=p+q=0}^{\lambda} \frac{(l+m-1)! 2^q (p+q-1)!}{(m-1)l! (p-1)q!} u^{-(m+l+k+p+q)} \\ &\quad fT_{11}^{(k)} (T_{22}^{(m)} T_{33}^{(p)}) - T_{23}^{(m)} T_{32}^{(p)} - T_{12}^{(k)} (T_{21}^{(m)} T_{33}^{(p)}) + T_{23}^{(m)} T_{31}^{(p)} \\ &\quad + T_{13}^{(k)} (T_{21}^{(m)} T_{32}^{(p)}) - T_{22}^{(m)} T_{31}^{(p)} g \\ &= \sum_{n=0}^{\lambda} u^{-n} C_n; \end{aligned} \quad (2.2.10)$$

i.e.,

$$C_0 = 1; C_1 = T_0^{(1)}; C_2 = T_0^{(2)} + T_0^{(1)} + 2(T_0^{(1)})^2 - I^2; \quad (2.2.11)$$

$$\begin{aligned} I^2 &= \sum_{n=0}^{\lambda} I^n : \\ &= 1 \end{aligned} \quad (2.2.12)$$

When we constrain  $\det T(u) = 1$  it leads to  $Y(SU(2))$  and  $Y(SU(3))$  that are formed by the set  $fI; J_g, = 1; 2; 3$  and  $= 1; 2; \dots; 8$  for  $SU(2)$  and  $SU(3)$ , respectively.

An example of realization of  $Y(SU(3))$  is the generalization of Haldane-Shastry model ([9–21]) for the fundamental representation of generators of  $SU(3)$ :

$$I = \sum_i^X F_i; \quad (2.2.13)$$

$$J = \sum_i^X iF_i + f \sum_{i \neq j}^X W_{ij} F_i F_j; \quad (2.2.14)$$

where  $W_{ij}$  satisfies the same relation as in Haldane-Shastry model given in section 2.1 and  $F_i$  are the Gell-Mann matrices.

### 2.3 $Y(SO(5))$ and $Y(SO(6))$

For  $SO(N)$  it holds

$$[L_{ij}; L_{kl}] = iC_{ijkl}^{st} L_{st}; \quad (2.3.1)$$

where

$$C_{ijkl}^{st} = ik js lt - il js kt - jk is lt + jl is kt; \quad (2.3.2)$$

The rational solutions of YBE for  $SO(N)$  were firstly given by Zamolodchikov's ([35]). They are also re-derived by taking the rational limit of the trigonometric R-matrix:

$$R(u) = f(u)[u^2 P + u(A - I - \frac{3}{2}P) + \frac{3}{2}I^2]; \quad (2.3.3)$$

where  $u$  stands for spectral parameter and the other free parameter ([36–37]). The elements of  $R(u)$  are ( $a; b; c; d = 2; 1; 0; 1; 2$ )

$$R(u)_{cd}^{ab} = u^2 \delta_{ab} \delta_{cd} + u(a_{ab} c_{cd} - a_{ac} b_{cd} - \frac{3}{2} a_{ad} b_{cd}) + \frac{3}{2} a_{ac} b_{cd}^2; \quad (2.3.4)$$

For  $SO(5)$ , we introduce

$$T^{(1)} = \begin{matrix} & 2 & E_3 & \frac{3}{2} & U_+ & E_+ & V_+ & 0 & 3 \\ & 6 & U & F_3 & \frac{3}{2} & F_+ & 0 & V_+ & \frac{7}{4} \\ & 6 & E & F & \frac{3}{2} & F_+ & E_+ & \frac{7}{4} & \\ 4 & V & 0 & F & F_3 & \frac{3}{2} & U_+ & \frac{5}{4} & \\ 0 & V & E & U & U & E_3 & \frac{3}{2} & & \end{matrix}; \quad (2.3.5)$$

where

$$\begin{aligned} E_3 &= E_{22} - E_{21}; \quad F_3 = E_{11} - E_{12}; \quad U_+ = E_{21} - E_{12}; \\ V_+ &= E_{21} - E_{12}; \quad E_+ = E_{20} - E_{02}; \quad F_+ = E_{10} - E_{01}; \\ U &= E_{12} - E_{21}; \quad V = E_{12} - E_{21}; \quad E = E_{02} - E_{20}; \\ F &= E_{01} - E_{10}; \end{aligned} \quad (2.3.6)$$

$$T_{ab}^{(2)} = \frac{3}{2} I_{ab}^{(2)} \quad (a,b=2;1;0;1;2); \quad (2.3.7)$$

Substituting  $T^{(n)}$  (only  $n = 1, 2$  are needed to be considered) into R TT relation, there appears 35 relations for  $J$  besides the Jacobi identities. However, a lengthy computation shows that besides

$$\begin{aligned} [I_i; I_j] &= C_{ij} I \\ [I_i; J_k] &= C_{ik} J \end{aligned} \quad (i,j) \quad (2.3.8)$$

there is only one independent relation

$$[E_3^{(2)}; F_3^{(2)}] = \frac{1}{4!} (fU_+; E_+; F_+ g - fU_+; E_-; F_+ g + fV_+; E_+; F_+ g + fV_-; E_+; F_+ g); \quad (2.3.9)$$

where again  $f^\pm g$  stands for the symmetric summation.

A realization of  $Y(SO(5))$  is given as follows. Set

$$I_{ab}(x) = \frac{1}{2} f^+(x) (I^{ab}) \quad (x) \quad (a,b=2;1;0;1;2); \quad (2.3.10)$$

$$f^+(x); \quad (y)g_+ = (x-y) : \quad (2.3.11)$$

Then

$$I_{ab} = \begin{matrix} X \\ x \end{matrix} I_{ab}(x); \quad (2.3.12)$$

$$J_{ab} = \begin{matrix} X \\ x \\ xy; x \neq a, b \end{matrix} (x-y) I_{ac}(x) I_{cb}(y) \quad (2.3.13)$$

satisfies the commuting relations for  $Y(SO(5))$ . The following Hamiltonian of ladder model not only commutes with  $I_{ab}$ , i.e., it possesses  $SO(5)$  symmetry, but also commutes with  $J_{ab}$ .

$$H = H_1 + \begin{matrix} X \\ x \end{matrix} H_2(x) + \begin{matrix} X \\ x \end{matrix} H_3(x); \quad (2.3.14)$$

$$H_1 = 2t_1 \left[ c^+(x)c^-(y) + d^+(x)d^-(y) + H.C. : \right]; \quad (2.3.15)$$

$$\begin{aligned} H_2(x) &= U(n_c - \frac{1}{2})(n_{c\#} - \frac{1}{2}) + (c^\dagger d) + V(n_c - 1)(n_d - 1) + JS_c \quad \text{S} \\ &= \frac{J}{4} \sum_{a < b} I_{ab}^2 + (\frac{1}{8}J + \frac{1}{2}U) (+ - 2); \end{aligned} \quad (2.3.16)$$

$$H_3(x) = 2t_3 (c^\dagger(x)d^\dagger(x) + H.C. :); \quad (2.3.17)$$

Because locally  $SO(6)$ ,  $SU(4)$  we introduce 15 generators

$$T_{ab}^{(1)} = I_{ab}; \quad T_{ab}^{(2)} = I_{ab}^{(2)} (a,b=1;2;\dots;6): \quad (2.3.18)$$

and the  $R(u)$ -matrix reads

$$R(u) = f(u)[u^2 P + u(A - 2P - I) + 2^2 I]; \quad (2.3.19)$$

The RTT relation gives  $4 + 4 + 441 + 315 + 225$  more relations. After careful calculations one finds ([15-16]) that there are the following independent relations for  $J_{ab}$  themselves:

$$\begin{aligned} [I_{12}^{(2)}; I_{34}^{(2)}] &= \frac{i}{24} (fI_{23}; I_{16}; I_{46}g + fI_{23}; I_{15}; I_{45}g + fI_{14}; I_{25}; I_{35}g \\ &\quad + fI_{14}; I_{26}; I_{36}g - fI_{13}; I_{26}; I_{46}g - fI_{13}; I_{25}; I_{45}g \\ &\quad - fI_{24}; I_{15}; I_{35}g - fI_{24}; I_{16}; I_{36}g); \end{aligned} \quad (2.3.20)$$

$$\begin{aligned} [I_{12}^{(2)}; I_{56}^{(2)}] &= \frac{i}{24} (fI_{15}; I_{23}; I_{36}g + fI_{15}; I_{24}; I_{46}g + fI_{26}; I_{13}; I_{35}g \\ &\quad + fI_{26}; I_{14}; I_{45}g - fI_{25}; I_{13}; I_{36}g - fI_{25}; I_{14}; I_{46}g \\ &\quad - fI_{16}; I_{23}; I_{35}g - fI_{16}; I_{24}; I_{45}g); \end{aligned} \quad (2.3.21)$$

$$\begin{aligned} [I_{34}^{(2)}; I_{56}^{(2)}] &= \frac{i}{24} (fI_{45}^{(1)}; I_{13}^{(1)}; I_{16}^{(1)}g + fI_{45}^{(1)}; I_{23}^{(1)}; I_{26}^{(1)}g + fI_{36}^{(1)}; I_{14}^{(1)}; I_{16}^{(1)}g \\ &\quad + fI_{36}^{(1)}; I_{24}^{(1)}; I_{26}^{(1)}g - fI_{35}^{(1)}; I_{14}^{(1)}; I_{16}^{(1)}g - fI_{35}^{(1)}; I_{24}^{(1)}; I_{26}^{(1)}g \\ &\quad - fI_{46}^{(1)}; I_{13}^{(1)}; I_{16}^{(1)}g - fI_{46}^{(1)}; I_{23}^{(1)}; I_{26}^{(1)}g); \end{aligned} \quad (2.3.22)$$

### 3 Applications of Yangian

The first example was given by Belavin ([38]) in deriving the spectrum of nonlinear model. Here we only show briefly some interpretations of Yangian through the particular realizations of Yangian.

#### 3.1 Reduction of $Y(SU(2))$

The simplest realization of  $Y(SU(2))$  is made of two-spin system with  $S_1$  and  $S_2$  (any dimensional representations of  $SU(2)$ ):

$$J^0 = \frac{1}{+} J = \frac{1}{+} (S_1 - 1 + S_2 - 1 + 2 S_1 - S_2); \quad (3.1.1)$$

that contains the (antisymmetric) tensor interaction between  $S_1$  and  $S_2$ . For example, for Hydrogen atom  $S_1 = L$  and  $S_2 = K$  (Lung-Lenz vector).

For  $S_1 = S_2 = 1/2$ , when

$$= \frac{1}{2}; \quad (3.1.2)$$

we prove that after the following similar transformation

$$Y = A J^0 A^{-1}; \quad A = \begin{pmatrix} 2 & 1 & 0 & 0 & 0 \\ 6 & 0 & i & 0 & 7 \\ 8 & 0 & i & 0 & 5 \\ 4 & 0 & i & 0 & 1 \\ 0 & 0 & 0 & 0 & 1 \end{pmatrix}; \quad (3.1.3)$$

the Yangian reduces to SO(4): ( $= + i = \frac{p}{2 + e^i}$ )

$$\begin{aligned} Y_1 &= \begin{pmatrix} M_1 & 0 & & & \\ 0 & L_1 & & & \\ & & \# & & \\ & & & M_2 & 0 \\ & & & 0 & L_2 \end{pmatrix}; \quad M_1 = \begin{pmatrix} 1 & 0 & & \\ 2 & 1 & 0 & \\ & & \# & \\ & & & M_2 \end{pmatrix}; \quad L_1 = \begin{pmatrix} 1 & 0 & 1 & \\ 2 & 0 & 0 & \\ & & \# & \\ & & & L_2 \end{pmatrix}; \\ Y_2 &= \begin{pmatrix} M_2 & 0 & & & \\ 0 & L_2 & & & \\ & & \# & & \\ & & & M_3 & 0 \\ & & & 0 & L_3 \end{pmatrix}; \quad M_2 = \begin{pmatrix} 1 & 0 & i & \\ 2 & i & 1 & 0 \\ & & \# & \\ & & & M_3 \end{pmatrix}; \quad L_2 = \begin{pmatrix} 1 & 0 & i & 1 \\ 2 & i & 0 & \\ & & \# & \\ & & & L_3 \end{pmatrix}; \\ Y_3 &= \begin{pmatrix} \frac{1}{2} & 0 & & & \\ 0 & \frac{1}{2} & 0 & & \\ & & \# & & \\ & & & \frac{1}{2} & 0 \\ & & & 0 & \frac{1}{2} \end{pmatrix}; \quad M_3 = \begin{pmatrix} 1 & 0 & & \\ 2 & 0 & & \\ & & \# & \\ & & & 3 \end{pmatrix}; \end{aligned} \quad (3.1.4)$$

and

$$Y^2 = \frac{1}{2} \left( \frac{1}{2} + 1 \right) = \frac{3}{4}; \quad (3.1.5)$$

Namely, under  $= 2$ , the  $Y$  reduces to SO(4) by  $M_- = M_1 - iM_2$ ,  $M_+ = M_+ + iM_3$ ,  $M_0 = M_0$ . The scaled  $M_-$  and  $M_3$  still satisfy the SU(2) relations:

$$[M_3; M_-] = M_-; \quad [M_+; M_-] = 2M_3; \quad (3.1.6)$$

and there are the similar relations for  $L$ .

It should be emphasized that here the new "spin"  $M$  (and  $L$ ) is the consequence of two spin ( $\frac{1}{2}$ ) interaction. As usual for two 2-dimensional representations of SU(2) (Lie algebra)

$$\underline{2} \otimes \underline{2} = \underline{3} \text{ (spin triplet)} \oplus \underline{1} \text{ (singlet)}; \quad (3.1.7)$$

However, here we meet a different decomposition:

$$\underline{2} \otimes \underline{2} = \underline{2}(M) \oplus \underline{2}(L); \quad (3.1.8)$$

The idea can be generalized to SU(3)'s fundamental representation

$$J = uI_1 + vI_2 + f \sum_{i < j}^{X} F_{1i}F_{2j}; \quad (3.1.9)$$

$$[F_i; F_j] = \text{if } F_{ij} \neq 0; \quad (i, j = 1, 2, 3); \quad (3.1.10)$$

Under the condition

$$uv = -2; \quad v + i = 0; \quad (3.1.11)$$

and the similar transformation

$$Y = AJA^{-1} = (u + v); A = \begin{matrix} 2 & & & & & & & & & & 3 \\ & 1 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & \\ & 0 & 0 & i & 0 & 0 & 0 & 0 & 0 & 0 & \frac{1}{2} \\ & 0 & 0 & 0 & 0 & 0 & i & 0 & 0 & 0 & \frac{1}{2} \\ & 0 & i & 0 & 0 & 0 & 0 & 0 & 0 & 0 & \frac{1}{2} \\ & 0 & 0 & 0 & 0 & 1 & 0 & 0 & 0 & 0 & \frac{1}{2} \\ & 0 & 0 & 0 & 0 & 0 & 0 & i & 0 & 0 & \frac{1}{2} \\ & 0 & 0 & i & 0 & 0 & 0 & 0 & 0 & 0 & \frac{1}{2} \\ & 4 & 0 & 0 & 0 & 0 & 0 & i & 0 & 0 & \frac{1}{2} \\ & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 0 & 1 \end{matrix}; \quad (3.1.12)$$

the Yangian then reduces to

$$\begin{aligned} Y(I) &= \frac{1}{4} I_1 & 0 & 0 & 3 & 2 & I_+ & 0 & 0 & 3 \\ & 0 & 0 & I & 0 & \frac{1}{2} & 0 & 0 & 0 & \frac{1}{2} ; & Y(I_+) &= \frac{1}{4} I_+ & 0 & 1 & I & 0 & \frac{1}{2} ; \\ Y(I_8) &= \frac{p}{3} \frac{6}{4} & 0 & 0 & 3 & 2 & 0 & 0 & 0 & I_3 \\ & 0 & 0 & 0 & 0 & \frac{1}{2} & 0 & 0 & 0 & \frac{1}{2} ; & Y(I_3) &= \frac{1}{2} \frac{6}{4} & 0 & 0 & 0 & 0 & \frac{1}{2} ; \\ Y(U_+) &= \frac{6}{4} U_+ & 0 & 0 & 3 & 2 & U & 0 & 0 & 3 \\ & 0 & 0 & U_+ & 0 & \frac{1}{2} & 0 & 0 & 0 & \frac{1}{2} ; & Y(U) &= \frac{6}{4} U & 0 & 1 & U & 0 & \frac{1}{2} ; \\ Y(V_+) &= \frac{6}{4} V & 0 & 0 & 3 & 2 & V & 0 & 0 & 3 \\ & 0 & 0 & V & 0 & \frac{1}{2} & 0 & 0 & 0 & \frac{1}{2} ; & Y(V) &= \frac{6}{4} V & 0 & 0 & V & 0 & \frac{1}{2} ; & (3.1.13) \end{aligned}$$

The usual decomposition through the Clebsch-Gordan coefficients for the representations of Lie algebra  $SU(3)$  is  $\underline{3} \otimes \underline{3} = \underline{6} \otimes \underline{3}$ . However, here we have

$$\underline{3} \otimes \underline{3} = \underline{3} \otimes \underline{3} \otimes \underline{3}; \quad (3.1.14)$$

and

$$\underset{=1}{\overset{x^8}{Y}} \underset{=1}{\overset{2}{Y}} = \frac{1}{u+v} \underset{=1}{\overset{x}{J}} \underset{=1}{\overset{2}{J}} = \frac{1}{3}; \quad (3.1.15)$$

It is easy to check that the rescaling factor does not change the commutation relations for  $SU(3)$  formed by  $I$ ,  $U$ ,  $V$ ,  $I_3$  and  $I_8$ . In general, we guess for the fundamental representation of  $SU(n)$  we shall meet

$$\underline{n} \otimes \underline{n} = \underline{n} \otimes \underline{n} \otimes \underline{n} + \dots + \underline{n} \quad (n \text{ times}); \quad (3.1.16)$$

Next we consider Yang-Mills gauge field for reduced  $Y(SU(2))$ . For a tensor wave function  $(x \mapsto f(x_1, x_2, x_3, x_0 g))$ ,

$$(x) = k_{ij}(x)k_i (i; j = 1, 2, 3, 4); \quad (3.1.17)$$

An isospin transformation yields

$$^0(x) = U(x) \cdot (x); \quad U(x) = 1 - i^a J_a; \quad (3.1.18)$$

where

$$J^a = u S_a - 1 + v 1 - S_a + 2 \sum_{abc} S^b S^c; \quad (3.1.19)$$

or

$$[J_a] = u(S^a) + v(S^a) + i \epsilon_{abc} (S^b)(S^c); \quad (3.1.20)$$

Define

$$D = @ + g A^a [J_a]; \quad (3.1.21)$$

i.e.,

$$[D] = @ + g A^a [J_a](x); \quad A = A^a J_a; \quad (3.1.22)$$

The gauge-covariant derivative should preserve

$$(D) = 0; \quad (3.1.23)$$

i.e.,

$$(@^a(x) + g A^a) [J_a] - ig^a(x) A^b [J_b; J_a] = 0; \quad (3.1.24)$$

When  $uv = -2$  and by rescaling

$$Y_a = (u + v) J_a; \quad (3.1.25)$$

we have

$$A^a = \sum_{abc} b(x) A^c(x) + \frac{i}{g} @^a(x); \quad (3.1.26)$$

and

$$F = \frac{1}{g} [D]; \quad D = F^a Y_a; \quad (3.1.27)$$

$$F^a = @ A^a - @ A^a + ig \sum_{abc} A^b A^c; \quad (3.1.28)$$

Here the tensor isospace has been separated to two irrelevant spaces, i.e.,  $= \begin{pmatrix} 1 & 0 \\ 0 & 2 \end{pmatrix}$

where  ${}_1$  and  ${}_2$  are 2 2 wavefunction.

### 3.2 Illustrative examples: NM R of Breit-Rabi Hamiltonian and Yangian

The Breit-Rabi Hamiltonian is given by

$$H = K - S + B \cdot S; \quad (3.2.1)$$

where  $S = \frac{1}{2}$  and  $B = B(t)$  is magnetic field.

The Hamiltonian can easily be diagonalized for any background angular momentum (or spin)  $K$ . The  $S$  stands for spin of electron and for simplicity  $K = S_1$  ( $S_1 = 1=2$ ) is an average background spin contributed by other source, say, control spin. Denoting by

$$H = H_0 + H_1(t); \quad H_0 = S_1 \cdot S; \quad H_1(t) = B(t) \cdot S; \quad (3.2.2)$$

Let us work in the interaction picture:

$$H_I = B(t) (\epsilon^{S_1 \cdot S} S_2 e^{-i S_1 \cdot S}) = B(t) J; \quad (3.2.3)$$

$$J = S_1 + S_2 + 2(S_1 \cdot S_2); \quad (3.2.4)$$

where  $\epsilon_1 = \frac{1}{2}(1 - \cos \theta)$ ,  $\epsilon_2 = \frac{1}{2}(1 + \cos \theta)$ ,  $\theta = \frac{1}{2}\sin \theta$ . Obviously, here we have  $\epsilon_1 \epsilon_2 = \theta^2$ . It is not surprising that the Y (SU(2)) reduces to SO(4) here because the transformation is fully Lie-algebraic operation. This is an exercise in quantum mechanics.

For generalization we regard  $\epsilon_1$  and  $\epsilon_2$  as independent parameters, i.e., drop the relation  $\epsilon_1 \epsilon_2 = \theta^2$ . Looking at

$$J = S_1 + S_2 - \frac{1}{2}(\epsilon_1 + \epsilon_2)(S_1 + S_2) + (S_1 + S_2) + 2(S_1 \cdot S_2); \quad (3.2.5)$$

When  $\theta = \frac{1}{2}$ ,  $\epsilon_1 = \cos \theta$  and  $\epsilon_2 = \frac{1}{2}\sin \theta$ , it reduces to the form in the interacting picture. Putting

$$S_1 + S_2 = S; \quad \theta = \frac{\hbar}{2} (\hbar \text{ is not Planck constant}); \quad (3.2.6)$$

In accordance with the convention we have

$$J = S + \sum_{i=1}^{x^2} i S_i + \frac{\hbar}{2} S_1 \cdot S_2 - \frac{1}{2}(\epsilon_1 + \epsilon_2)S = S + Y; \quad (3.2.7)$$

Since  $J \neq S + J$  still satisfies Yangian relations, it is natural to appear the term  $S$ . The interacting Hamiltonian then reads

$$H_I(t) = B(t) \cdot S - B(t) \cdot Y; \quad (3.2.8)$$

When  $i = 0, h = 0$ , it is the usual NM R for spin 1/2. To solve the equation, we use

$$i \frac{\partial j(t)}{\partial t} = H_I(t) j(t); \quad j(t)i = \begin{matrix} X \\ = \end{matrix} \begin{matrix} a(t)j \\ i; \end{matrix} \quad (32.9)$$

where  $f$ ;  ${}_3g$  is the spin triplet and  ${}_0s$  singlet. Setting

$$B_-(t) = B_1(t) - iB_2(t) = B_1 e^{-i\omega_0 t}; \text{ and } B_3 = \text{const:} \quad (32.10)$$

and rescaling by

$$a(t) = e^{i\omega_0 t} b(t); \quad (32.11)$$

we get

$$\begin{aligned} i \frac{db(t)}{dt} &= f \frac{1}{2} B_1 a_3(t) - (\omega_0 - \frac{1}{2} B_3) b(t) g - \frac{1}{2} B_1 a_0(t); \\ i \frac{da_3(t)}{dt} &= -\frac{B_1}{2} f b_+(t) + b_-(t) g - \frac{1}{2} B_3 a_0(t); \\ i \frac{da_0(t)}{dt} &= \frac{1}{2} + f \frac{1}{2} B_1 [b_-(t) b_+(t)] g + B_3 a_3(t); \end{aligned} \quad (32.12)$$

where  $i = (1 \ 2 \ i\frac{\hbar}{2})$ , i.e.,

$$j(t)i = \begin{pmatrix} 2 & b_1(t) & 3 \\ 6 & a_3(t) & 7 \\ 4 & b_-(t) & 5 \end{pmatrix}; H_I = \begin{pmatrix} 2 & \omega_0 & B_3 & B_1 \frac{1}{2} & 0 & \frac{1}{2} & B_1 & 3 \\ 6 & B_1 \frac{1}{2} & 0 & B_1 \frac{1}{2} & \frac{1}{2} & B_3 & 7 \\ 4 & 0 & B_1 \frac{1}{2} & (\omega_0 - B_3) & \frac{1}{2} & B_1 & 7 \\ \frac{1}{2} & + B_1 & \frac{1}{2} + B_3 & \frac{1}{2} & + B_1 & 0 \end{pmatrix}; \quad (32.13)$$

$$i \frac{dj(t)i}{dt} = H_I j(t)i: \quad (32.14)$$

Noting that  $H_I$  is independent of time, we get

$$j(t)i = e^{iE t} j(0)i: \quad (32.15)$$

Then

$$\det H_I - E j = 0 \quad (32.16)$$

leads to

$$\begin{aligned} E^4 - [(\omega_0 - B_3)^2 + B_1^2 + \frac{1}{4}] + (B_1^2 + B_3^2) E^2 + \\ \frac{1}{4} + B_3^2 (\omega_0 - B_3)^2 - 2 B_3 B_1^2 (\omega_0 - B_3) + B_1^4 = 0; \end{aligned} \quad (32.17)$$

There is a transition between the spin singlet and triplet in the NMR process, i.e., the Yangian transfers the quantum information through the evolution. The simplest case is  $B_1 = 0$ , then the eigenvalues are

$$E = \begin{pmatrix} 0 & B_3 \end{pmatrix}; E = \begin{pmatrix} 1 & \frac{B_3}{2} \\ 0 & (1 - \frac{B_3}{2})^2 + \frac{\hbar^2}{4} \end{pmatrix}; \quad (3.2.18)$$

It turns out that there is a vibration between  $s = 0$  and  $s = 1$ .

$$\langle s^2 \rangle = 0 \text{ at } t = \frac{1}{2\pi} \text{ (total spin } = 0); \quad (3.2.19)$$

$$\langle s^2 \rangle = 2 \text{ at } t = \frac{1}{2\pi} \text{ (total spin } = 1); \quad (3.2.20)$$

Under adiabatic approximation it can be proved that it appears Berry's phase. Obviously, only spin vector can make the stereo angle. The role of spin singlet here is a witness that shares energy of spin=1 state.

Actually, if

$$B(t) = B_0 \sin e^{i\omega_0 t}; \quad B_3 = B_0 \cos; \quad (3.2.21)$$

and

$$\begin{aligned} j_{11i} &= j'''i; \quad j_{1-1i} = j##i; \quad j_{10i} = \frac{1}{2}(j''#i + j#''i); \\ j_{00i} &= \frac{1}{2}(j''#i - j#''i); \end{aligned} \quad (3.2.22)$$

then let us consider the eigenvalues of

$$H = S_1 \otimes B_0 S_3 \otimes B_0 J_3; \quad (3.2.23)$$

under adiabatic approximation which are

$$E = \frac{1}{2} \left( \frac{q}{2} \sqrt{\omega^2 + g^2 B_0^2} + \right); \quad (3.2.24)$$

and

$$f_1^{(\pm)} = [2(\omega^2 + g^2 B_0^2) +]^{1/2} [(\omega^2 + g^2 B_0^2 +) \pm]^{1/2}; \quad (3.2.25)$$

$$f_2^{(\pm)} = [2(\omega^2 + g^2 B_0^2 +) \mp (\omega^2 + g^2 B_0^2 +)]^{1/2} [(\omega^2 + g^2 B_0^2 +) \pm]^{1/2}; \quad (3.2.26)$$

We obtain the eigenstates of  $H$  besides  $j_{1ii}$  ( $i = 1, 2$ )

$$j_{-i} = f_1^{(\pm)} j_{10i} + f_2^{(\pm)} j_{00i}; \quad (3.2.27)$$

where

$$\begin{aligned}
 j_{11}(t)i &= \cos^2 \frac{1}{2} j_{11}i + \frac{1}{2} \sin e^{i!_0 t} j_{10}i + \sin^2 \frac{1}{2} e^{2i!_0 t} j_{1-1}i; \\
 j_{1-1}(t)i &= \sin^2 \frac{1}{2} e^{2i!_0 t} j_{11}i - \frac{1}{2} \sin e^{i!_0 t} j_{10}i + \cos^2 \frac{1}{2} j_{1-1}i; \\
 j_{00}(t)i &= \frac{1}{2} f_1^{(1)} f \sin e^{i!_0 t} j_{11}i + \frac{p}{2} \cos j_{10}i + \sin e^{i!_0 t} j_{1-1}i \\
 &\quad + f_2^{(1)} j_{00}i;
 \end{aligned} \tag{3.2.28}$$

We then obtain

$$\begin{aligned}
 h_{11}(t) j_{11}(t)i &= i!_0 (1 - \cos); \\
 h_{1-1}(t) j_{11}(t)i &= i!_0 (1 - \cos); \\
 h_{00}(t) j_{00}(t)i &= 0;
 \end{aligned} \tag{3.2.29}$$

The Berry's phase is then

$$j_{1-1} = ; = 2 (1 - \cos); \tag{3.2.30}$$

whereas  $j_{10} = j_{00} = 0$ . The Yangian changes the eigenstates of  $H$ , but preserves the Berry's phase.

### 3.3 Transition between S-wave and P-wave superconductivity

We set for a pair of electrons:

$$S : \text{spin singlet}; L = 0; \tag{3.3.1}$$

$$P : \text{spin triplet}; L = 1; \tag{3.3.2}$$

Due to Balian-Werthamer ([39]), we have

$$4(k) = \frac{1}{2} \sum_{k^0}^X V(k; k^0) \frac{4(k^0)}{E(k^0)} \tanh \frac{E(k^0)}{2}; \tag{3.3.3}$$

$$E(k) = (\omega^2(k) + \Delta(k)^2)^{\frac{1}{2}}; \tag{3.3.4}$$

Therefore, still by Balian-Werthamer ([39]), we know

$$4(k) = 4\left(\frac{4}{3}\right)^{\frac{1}{2}} \frac{P \overline{2Y}_{1,1}(\hat{k})}{Y_{1,0}(\hat{k})} \frac{P \overline{Y}_{1,0}(\hat{k})}{P \overline{2Y}_{1,-1}(\hat{k})} = \left(-\frac{P}{6}\right) 4(k) \left(\frac{4}{3}\right)^{\frac{1}{2}} \delta_{0,0}(\hat{k}); \tag{3.3.5}$$

$$_{0;0}(\hat{k}) = \frac{1}{3} \hat{P} Y_{1,1}(\hat{k})_{11} - Y_{1,0}(\hat{k})_{10} + Y_{1,1}(\hat{k})_{1-1} g = \frac{1}{8} \begin{matrix} " \\ \hat{k} \\ \hat{k}_z \\ \hat{k}_+ \end{matrix}^{\#}; \quad (3.3.6)$$

where  $_{11}$ ,  $_{10}$  and  $_{1-1}$  stand for spin triplet:

$$_{0;0} \quad J=0, m=0 : \quad (3.3.7)$$

The wave function of SC is

$$_{0;0} = \frac{1}{2} \begin{matrix} " \\ 0 \\ Y_{0;0} \\ 0 \end{matrix}^{\#} : \quad (3.3.8)$$

Introducing

$$I = \sum_{i=1}^{x^2} S(i); \quad (i = 1, 2, 3); \quad (3.3.9)$$

$$J = \sum_{i=1}^{x^2} i S(i) \frac{i h v}{4} (S(1)S(2) - S(2)S(1)); \quad (3.3.10)$$

and noting that  $J \neq J + fI$  does not change the Yangian relations, we choose for simplicity  $f = \frac{1}{2}(1 + 2)$ . Then we obtain for  $G = \hat{k} (J + fI)$

$$G_{0;0} = \hat{k} (J + fI)_{0;0} = \frac{\hat{P}}{2} \left( 2 - 1 + \frac{h v}{2} \right)_{0;0}; \quad (3.3.11)$$

The transition directionally depends on the parameters in  $Y(SU(2))$ . For instance,

We call the type of the transition "directional transition" ([40]). The controlled parameters are in the Yangian operation. They represent the interaction coming from other controlled spin.

We have got used to apply electromagnetic field  $A$  to make transitions between  $1$  and  $1-1$  states. Now there is Yangian formed by two spins that plays the role changing angular momentum states.

### 3.4 Y (SU (3))-directional transitions

Setting

(Here, no summation over repeated indices,  $i \neq j \neq k$ ). The reason that such a condition works only for 3-dimensional representation of SU (3) is similar to Haldane's (long-ranged) realization of Y (SU (2)) ([19]). In SU (2) long-ranged form, the property of Pauli matrices leads to  $(\sigma)^2 = 0$ . Instead, for SU (3) the conditions of  $J$  satisfying Y (SU (3)) read

that are satisfied for Gell-Mann matrices.

The simplest realization of Y (SU (3)) is then

Recalling  $(I_8 = \frac{P}{2} Y)$

where  $i$  and  $h$  (not Planck constant) are arbitrary parameters. Notice again that the simplest choice of  $W_{ij}$  is given by equation (3.4.8).

When  $i = 1, 2, Y$  ( $SU(2)$ ) makes transition between spin singlet and triplet. Now  $Y$  ( $SU(3)$ ) transits  $SU(3)$  singlet and Octet. For instance, setting

Obviously, in this case the Yangian operators make the transition from the octet to a "combined" singlet state of  $SU(3)$ .

### 3.5 $J^2$ as a new quantum number

Because  $[I^2; J^2] = 0$ ;  $[I^2; I_z] = 0$ ;  $[J^2; I_z] = 0$ , but  $[J^2; J_z] \neq 0$ , we can take  $fI^2; I_z; J^2$  as a conserved set.

First we consider the case  $S_1^N S_2^N S_3^N$ , where  $S_1 = S_2 = S_3 = \frac{1}{2}$ . We shall show that instead of 6-j coefficients and Young diagrams,  $J^2$  can be viewed as a "collective" quantum number that describes the "history" besides  $S^2$  ( $S = S_1 + S_2 + S_3$ ) and  $S_z$ .

As representations of Lie algebra  $SU(2)$ , we have

$$(\frac{1}{2}^0 \quad \frac{1}{2}^0 \quad \frac{1}{2}^0) = (1^M \quad 0^0 \quad \frac{1}{2}^M) = \frac{3}{2}^M \quad \frac{1}{2}^M \quad \frac{1}{2}^0; \tag{3.5.1}$$

Noting that  $\frac{1}{2}^0 i$  and  $\frac{1}{2}^0 i$  are degenerate regarding the total spin  $\frac{1}{2}$ . The usual Lie algebraic base can be easily written as

It is worth noting that the conclusion is independent of the order, say,  $(\frac{1}{2}, \frac{1}{2})^N, (\frac{1}{2}, \frac{1}{2}), (\frac{1}{2}, \frac{1}{2})^N, (\frac{1}{2}, \frac{1}{2})$  and the other way. The difference is only in the value of  $\theta$ .

The above example can be generalized to  $S_1^N S_2^N L$  where  $S_1 = S_2 = \frac{1}{2}$  and  $L^2 = l(l+1)$ . As representations of Lie algebra  $SU(2)$ , we have

There are no degeneracy for  $l=1$ , but two  $l=1$  states can be distinguished in terms of  $J^2$

$$[H; J^2] = 0 \quad (3.5.22)$$

which is satisfied if the matrix  $J^2$  is symmetric, i.e.,

$$= \frac{f2u_1^2 - 2h^2 [l(l+1) + \frac{1}{4}]g}{(u_3^2 - h^2)} = 2(l+1); \quad (3.5.23)$$

Therefore, the parameter in  $Y(SU(2))$  determines the rotation angle  $\theta$ . It is reasonable to think that the appearance of "rotation" of degenerate states is closely related to the "quantum number" of  $J^2$ . Transition between  ${}^+_m$  and  ${}^-_m$  ( $l=1$ ) can be made by  $J_3$ . Because there are two independent parameters  $u_1$  and  $u_3$  in  $J$ , one can choose a suitable relation between  $u_3$  and  $= \frac{b}{a}$  such that

$$J_3 = \frac{b}{a}; \quad (3.5.24)$$

i.e., the transition between two degenerate states in Lie-algebra is made through  $J_3$  operator, because of

$$[J^2; J_3] \neq 0; \quad (3.5.25)$$

### 3.6 Higher degeneracy

In the experiment for  $^{87}\text{Rb}$  molecular there appears new degeneracy ([41]) at the special  $B_0$  (magnetic field), i.e., the Zeeman effect disappears at  $B_0$ . The model Hamiltonian reads ([42]) ( $x$  is scaled magnetic field)

$$H = K - S + x(k + \frac{1}{2})S_z; \quad (3.6.1)$$

where  $K$  is angular momentum and  $K^2 = K(K+1)$ . It only occurs for spin  $S = 1$ . It turns out that when  $x = 1$  there appears the curious degeneracy, that is, there is a set of eigenstates corresponding to

$$E = \frac{1}{2}; \quad (3.6.2)$$

The conserved set is  $fK^2; G_z = K_z + S_z g$ . For  $G = K + S$  we have  $G = k - 1; k$ . The eigenstates are specified in terms of three families: T; B and D. Only D-set possesses the degeneracy.

Higher gives, for example, the eigenstates for  $x = 1$  ([42]):

$$\begin{aligned} x = +1 & \quad H_{Dm} = (\frac{1}{2})_{Dm}; \\ x = -1 & \quad H_{Dm} = (-\frac{1}{2})_{Dm}; \end{aligned} \quad (3.6.3)$$

and shows that

$$\begin{aligned} Dm &= [2(K + \frac{1}{2})(K + m + \frac{1}{2})]^{\frac{1}{2}} f [\frac{(K - m + 1)(K + m + 1)}{2}]^{\frac{1}{2}} e_1 \\ &\quad + [(K + m)(K + m + 1)]^{\frac{1}{2}} e_2 + [\frac{(K - m)(K + m)}{2}]^{\frac{1}{2}} e_3 g; \end{aligned} \quad (3.6.4)$$

$$\begin{aligned} Dm &= [2(K + \frac{1}{2})(K - m + \frac{1}{2})]^{\frac{1}{2}} f [\frac{(K - m)(K + m)}{2}]^{\frac{1}{2}} e_1 \\ &\quad + [(K - m)(K - m + 1)]^{\frac{1}{2}} e_2 - [\frac{(K - m + 1)(K + m + 1)}{2}]^{\frac{1}{2}} e_3 g; \end{aligned} \quad (3.6.5)$$

where  $e_1 = e_1 - e_m$ ,  $e_2 = e_0 - e_m$  and  $e_3 = e_1 - e_{m+1}$ .

It is natural to ask what is the transition operator between  $Dm$  and  $Dm'$ ? The answer is Yangian operator. In fact, introducing

$$J = aS_+ + bK \quad (S_K_z - S_z K); \quad (3.6.6)$$

we find that by choosing  $a = \frac{k+1}{2}; b = 0$ , we have

$$Dm \stackrel{J_+}{\longrightarrow} e_1(m)_{Dm+1} \text{ and } Dm \stackrel{J_-}{\longrightarrow} e_2(m)_{Dm-1}; \quad (3.6.7)$$

and by choosing  $a = \frac{k}{2}; b = 0$ , we have

$$D_m \stackrel{J_1}{=} \begin{pmatrix} 0 \\ 1 \end{pmatrix} (m) D_m - 1 \quad \text{and} \quad D_m \stackrel{J_2}{=} \begin{pmatrix} 0 \\ 2 \end{pmatrix} (m) D_m + 1; \quad (3.6.8)$$

The Yangian makes the transition between the states with  $B_1$  and  $B_2$ , which here is only for  $S = 1$ . The reason is that for  $S = 1$  there are two independent coefficients in the combination of  $J_1$  and  $J_2$  and there are two free parameters in  $J$ . Hence the number of equations are equal to those of free parameters ( $a$  and  $b$ ), so we can find a solution. The numerical computation shows that only  $S = 1$  gives rise to the new degeneracy ([42]) that prefers the Yangian operation ([43]).

### 3.7 New degeneracy of extended Borel-Rabi Hamiltonian

As was shown in the Hupper's model ( $H = K - S + x(k + \frac{1}{2})S_3$ ) there appeared new degeneracy for  $S = 1$ . It has been pointed out that the above degeneracy with respect to Zeeman effect cannot appear for spin =  $\frac{1}{2}$ . Actually, in this case it yields for  $S = \frac{1}{2}$  ([42]),

$$E = \frac{1}{4} !_m S_3; \quad (3.7.1)$$

where

$$!_m^2 = [(1 + x^2)(k + \frac{1}{2}) + 2xm](k + \frac{1}{2}); \quad (3.7.2)$$

Therefore if the Hupper's type of degeneracy can occurs, there should be  $_m = 0$  that means

$$x_0 = \frac{m}{k} \stackrel{s}{\longrightarrow} i - 1 - \frac{m^2}{k^2} \quad (k = K + \frac{1}{2}); \quad (3.7.3)$$

i.e., the magnetic field should be complex.

However, the situation will be completely different, if a third spin is involved. For simplicity we assume  $S_1 = S_2 = S_3 = \frac{1}{2}$  in the Hamiltonian:

$$H = (aS_2 + bS_3) \stackrel{p}{\perp} + x \stackrel{p}{\perp} \overline{abs}_1^z; \quad b=a; \quad (3.7.4)$$

then besides two non-degenerate states, there appears the degenerate family:

$$H \stackrel{D}{=} \left( \frac{a+b}{4} \right) \stackrel{D}{=} \frac{1}{2}; \quad \text{for } x = 1; \quad (3.7.5)$$

where

$$D_{\frac{1}{2}} = \frac{p}{2} j'''' \# > \stackrel{p}{\perp} j''' \# + (1 - \frac{p}{2}) j'''' \# >; \quad (3.7.6)$$

$$D; \frac{1}{2} = \frac{p_-}{2} j^{\# \# \# \#} - j^{\# \# \#} + (1 - \frac{p_-}{2}) j^{\# \# \# \#} : \quad (3.7.7)$$

The expecting value of  $S_1^z$  are

$$\langle D; \frac{1}{2} | S_1^z | D; \frac{1}{2} \rangle = p_- (x = 1); \quad (3.7.8)$$

$$\langle D; \frac{1}{2} | S_1^z | D; \frac{1}{2} \rangle = p_- (x = -1); \quad (3.7.9)$$

namely, at the special magnetic field ( $x = 1$ ) the observed  $\langle S_1^z \rangle$  still opposite to each other for  $x = 1$ , but without the usual Zeeman split.

The reason of the appearance of the new degeneracy is obvious. The two spins  $S_2$  and  $S_3$  here play the role of  $S = 1$  in comparison with Hepp model.

### 3.8 Super Yang-Mills ( $N = 4$ )-Lipatov model and Y (SO (6))

Beisert et al ([44-45]), Dolan-Nappi-Witten (DNW, [34]) and other authors ([46-47]) proposed to take the quantum correction of the dilatation operator  $D$ .  $D$   $\in$  SO (4;2) is a subalgebra of PSU (2;2|4) as Hamiltonian for super Yang-Mills ( $N = 4$ ):

$$H = \sum_{j=1}^X H_j; \quad (3.8.1)$$

$$H_j = 2 \sum_{j=1}^X h(j) P_j; \quad h(j) = \sum_{k=1}^{X-j} \frac{1}{k}; \quad h(0) = 1; \quad (3.8.2)$$

where  $P_j$  is projector for the weight  $j$  of SU (2) and  $X$  stands for "lattice" index. DNW showed that ([34])

$$[H; Y(SO(6))] = 0; \quad (3.8.3)$$

It turns out that the Hamiltonian  $H$  is nothing but Lipatov model ([48]) which was related to the Yang-Baxter form by Lipatov ([49]), Faddeev and Korchemsky ([50]).

Based on Tarasov, Takhtajan and Faddeev ([51]) the R-matrix associated with any spin  $S$  reads

$$R(u) = \frac{(u-s)(u+2s+1)}{(u-\hat{J})(u+\hat{J}+1)}; \quad (3.8.4)$$

where  $u$  is spectrum parameter and  $s$  the spin (arbitrary). The trigonometric Yang-Baxterization ([52]) gives

$$R(u) = \sum_{j=0}^X j(x) P_j(q) \quad (x = e^{iu}); \quad (3.8.5)$$

where  $P_j(q)$  is the q-deformed product with weight  $j$ . Taking the rational limit ([9], [36]) we have

$$j) \frac{(u)(u+1)}{(u-j)(u+j+1)}; P_j(q) = P_j: \quad (3.8.6)$$

The Hamiltonian for the lattices and + 1

$$H_{+1} = I_1 - I_2 \quad I = \frac{d}{du} R(u)_{j=0} [R(0)]^{-1} - I_{+2} \quad (3.8.7)$$

is then

$$H = \sum_j H_{+1} \quad (3.8.8)$$

where

$$\begin{aligned} H_{+1} &= f(\hat{J}_{+1}) - (\hat{J}_{+1} + 1) + (1 + 2s) + (1 - 2s) - \frac{1}{2s} g_{j=0} \\ &= \sum_j f(j) - (j + 1) + 2(1) - \lim_{x! 0} \frac{1}{x} g P^j_{+1}: \end{aligned} \quad (3.8.9)$$

It describes the QCD correction to the parton model shown by Lipatov ([48-49]). The diagonalization of Lipatov model has probably been achieved by de Vega and Lipatov ([53-54]). Noting that the  $j$  indicates the block in the reducible block-diagonal form.

Using

$$\begin{aligned} (x+1) &= (x) + \frac{1}{x}; \\ (x+n) &= (x) + \sum_{k=0}^{x-1} \frac{1}{x+k}; \\ (1) &= c; \end{aligned} \quad (3.8.10)$$

and hence

$$\begin{aligned} (j+1) &= (1) + \sum_{k=1}^{x^j} \frac{1}{k} = (1) + h(j) \\ (j) &= (1) + h(j) - \lim_{x! 0} \frac{1}{x}: \end{aligned} \quad (3.8.11)$$

We obtain

$$H_{+1} = (-2) \sum_j^X h(j) P^j_{+1}: \quad (3.8.12)$$

Separating the finite part from the infinity the  $H$  is nothing but the  $D$  derived in super Yang-Mills ( $N = 4$ ) with the approximation. Of course, the derivation of  $D$  based on super Yang-Mills ( $N = 4$ ) explores much larger symmetry than Lipatov model. Therefore, DNW's result shows that the Lipatov's model possesses  $SO(6)$  symmetry.

To obtain  $Y(SO(6))$  in terms of RTT relation we start from the rational solution of R-matrix whose general form for  $SO(N)$  was first by Zamolodchikov and Zamolodchikov ([35]) and extended through rational limit of trigonometric Yang-Baxterization ([36]):

$$R = u[u - \frac{1}{2}(N-2)a]P + uA_N + [u + \frac{2}{2}(N-2)]I; \quad (3.8.13)$$

where  $u$  is spectrum parameter and  $a$  a free parameter allowed by YBE. Here we adopt the convention of Jimbo:

$$P_{cd}^{ab} = \begin{matrix} a & b \\ d & c \end{matrix}; \quad (A_N)_{cd}^{ab} = \begin{matrix} a & b \\ c & d \end{matrix} \quad (3.8.14)$$

where

$$a;b;c;d = [\frac{N-1}{2}; \quad \frac{N-1}{2}+1; \quad \frac{N+1}{2}] \quad (3.8.15)$$

and  $N = 2n+1$  for  $B_n$  and  $N = 2n$  for  $C_n, D_n$ .

The R-matrix is given by

$$R = RP = u(u-2)I + u(2u-1)P + 2uA_N; \quad (3.8.16)$$

that coincides with Zamolodchikov's S-matrix (up to an overall factor considering the CDD poles) with  $\beta = 1$  and  $u = \frac{1}{i}$ . Actually, Zamolodchikov's S-matrix is universal, i.e., model independent.

$$\begin{aligned} S(\beta) = R(u) &= Q(u)u(u-2)[I + \frac{-3}{2}P + \frac{1}{2}A_N] \\ &= Q(u)u(u-2)[I - \frac{1}{u}P + \frac{2}{u-2}A_N]; \\ Q(u) &= \frac{(\frac{1}{2}-\frac{i}{2})(\frac{1}{2}+\frac{i}{2})}{(\frac{1}{2}-\frac{i}{2})(\frac{1}{2}+\frac{i}{2})} \end{aligned} \quad (3.8.17)$$

where  $\beta = \frac{2}{N-2}$ ,  $\alpha = iu$ . The spectrum parameter  $u$  is one-dimensional, but  $u$  can be taken to be the cut-off in 4-dimensional quantum field theory, for example

$$u \in \mathbb{R}^2; \quad (3.8.18)$$

where  $\mathbb{R}^2$  is Lorentz invariant, i.e., scalar. This is the reason why asymptotic behavior of quantum field theory model may be related to Yang-Baxter system. The Bethe Ansatz for  $S(\beta)$  with  $SO(6)$  was discussed by Minahan and Zarembo ([46]).

For given  $R(u)$  one can easily obtain Hamiltonian by

$$H = [\frac{\partial R(u)}{\partial u}R(u)]_{u=0}; \quad (3.8.19)$$

for  $O(N)$ .

However, the essential connection between Lipatov model and SO(6)-RTT formulation is still missing.

## 4 Remarks

Although there has been certain progress of Yangian's application in physics, there are still open questions:

- (1) How can the Yangian representations help to solve physical models, in particular, in strong correlation models?
- (2) Direct evidences of Yangian in the real physics.
- (3) What is the geometric meaning of Yangian?
