A Scheme of Cartan Decomposition for su(N)

A bstract

A scheme to perform the Cartan decomposition for the Lie algebra su (N) of arbitrary nite dimensions is introduced. The scheme is based on two algebraic structures, the conjugate partition and the quotient algebra, that are easily generated by a Cartan subalgebra and generally exist in su (N). In particular, the Lie algebras su (2^P) and every su (2^P $^1 < N < 2^P)$ share the isom orphic structure of the quotient algebra. This structure enables an elcient algorithm for the recursive and exhaustive construction of Cartan decompositions. Further with the scheme, a unitary transformation in SU (N) can be recursively decomposed into a product of certain designated operators, e.g., local and nonlocal gates. Such a recursive decomposition of a transformation in plies an evolution path on the manifold of the group.

1 Introduction

The evolution of a closed quantum system of nite dimensions is governed by a unitary transformation in the Lie group SU (N). Portraying the evolution path on the manifold of the group, normally with very high dimensions, will be of great help to the investigation of the system. Geometrically, the set of generators for the Lie algebra su (N) serves as an intrinsic moving frame on the manifold of the group SU (N) [1]. Besides o ering a geometric basis, algebraically su (N) admits the Cartan decomposition that has fundamental importance in the treatment of Lie algebras and Lie groups [2, 3]. The geometric concepts and algebraic skills of the Cartan decomposition have recently been brought into the areas of quantum control and quantum information [5]. Much attention and e ortare thus dedicated to a wider scope of applications [4, 6, 7]. Furthermore, a large programme for quantum computation has very recently been proposed that is mainly depicted in terms of the geometric language [8, 9]. An elective device, in a geometric or an algebraic framework, for the exploration on the immense manifold of unitary transformations has become desirable.

In this article, a general and simple scheme of the Cartan decomposition is introduced. This scheme is applicable to the Lie algebra su (N) of arbitrary dim ensions without being restricted to a power of 2. In the scheme, an arbitrary Cartan subalgebra in su (N) can create a particular form of partition of the algebra, the conjugate partition, that is composed of a certain number of abelian subalgebras. These abelian subalgebras further form an algebraic structure, the quotient algebra, due to the closure under the operation of the Lie bracket. Importantly, every Lie algebra su $(2^{p-1} < N < 2^p)$ shares with su (2p) the isom orphic structure of the quotient algebra. This structure makes straightforward and system atic the exhaustive construction of Cartan decom positions in su (N). When the decomposition is recursively applied to the nal stage, only an abelian subalgebra remains. It immediately leads to a recursive decomposition of the Lie group SU (N), such that a unitary transformation is factorized into a product of actions respectively contributed only by a generator of su (N). A recursive decomposition of a transform ation implies a path on the manifold of the Lie group SU (N), which is adjustable by the choice of the abelian subalgebra designated at each level of the decom position. The scheme m ay have provided a tool for the 'purney on the manifold of SU (N).

2 Conjugate Partition

To have a better access to the scheme, the exposition will begin with the examples of decompositions for su (6) and su (8). Here, su (8) is the Lie algebra of the transformation group SU (8) acting on a 3-qubit system, and su (6) is the algebra of the group SU (6) acting on a system composed of a 2-state and a 3-state quantum particles. Although the scheme is representation independent, simply for convenience the exposition will be given in the spinor representation. The generators of these algebras are hence written in tensor products of the Pauli and Gell-M ann matrices.

The rst step is to take a center subalgebra, denoted as A, which is a m axim alabelian subalgebra, a Cartan subalgebra, arbitrarily chosen from the algebra to be decomposed. With this choice of the center subalgebra, more abelian subalgebras will be generated. An abelian subalgebra of 7 elements, listed in the central column of Fig.1, is an example of the center subalgebra for 3 I; 3 I $su(8), A = f_3 I I; I_3 I; I$ 3**;** 3 $_3$ $_3$ g. It is easy to construct an abelian subalgebra for a Lie algebra, actually a maximal one, by collecting all its diagonal generators. The second step is to, outside the center subalgebra, take an arbitrary generator as a seed, for example I I $_1$ at the left hand side of the center subalgebra in Fig.1a. Four other generators are produced, listed at the right hand side, by calculating the commutator of the seed with each element in the center subalgebra, i.e., m apping the seed to another vector space by the adjoint representation ad_A , $\begin{bmatrix} \mathbf{I} & \mathbf{I} & \mathbf{1}; & \mathbf{3} & \mathbf{I} \end{bmatrix} = \begin{bmatrix} 2\mathbf{i}\mathbf{I} & \mathbf{I} & \mathbf{2}, \begin{bmatrix} \mathbf{I} & \mathbf{I} & \mathbf{1}; & \mathbf{3} & \mathbf{3} \end{bmatrix} \end{bmatrix} = \begin{bmatrix} 2\mathbf{i} & \mathbf{3} & \mathbf{I} & \mathbf{2}, \end{bmatrix}$ etc. Then, in the reversing step, 3 m ore generators are added to the LHS column as shown in Fig.1b after taking any one of the 4 generators in the RHS

column and calculating the comm utators of this generator with those in the center subalgebra.

The rst good property is that the elements in these two new columns respectively form an abelian subalgebra. The 4 generators of such an abelian subalgebra also build a vector space. Let W $_1$ and W $_1$ denote the vector spaces respectively spanned by the subalgebras in the LHS and RHS columns; each of this pair is considered the conjugate by the other, noting that W $_1$; W $_1$] A. Following the same procedure, more conjugate pairs of abelian subalgebras fW $_i$; W $_i$ g are produced by taking a seed outside the center subalgebra and the existing conjugate pairs, from fW $_1$; W $_1$ g to fW $_i$ $_1$; W $_i$ g, and calculating the required commutators. The continued exposition will temporarily be based on the current version of the algorithm primitive.

This procedure leads to a partition of the original algebra as given in Fig.2. Stated in the following Lemma, such a conjugate partition always exists for the Lie algebra su (N), which will be proved with the Main Theorem.

Lem m a. W ith an arbitrary maximal abelian subalgebra A taken as the center subalgebra, the Lie algebra su (N) has a conjugate partition consisting of A and a nite number, q, of conjugate pairs of abelian subalgebras $fW_i; \hat{W}_i; \hat{y}_i$ i q, i.e.,

3 Quotient Algebra

In addition to the partition composed of conjugate pairs of abelian subalgebras, of great interest is an algebraic structure embedded in these subalgebras. An easy check is that, for the partition listed in Fig 2, the commutator of any elements from two dierent subalgebras must be either f0g or in a third subalgebra. It reveals the existence of an algebraic structure, the quotient algebra, based on which constructing Cartan decompositions becomes straightforward.

Denition. For a conjugate partition given by the center subalgebra A and with q conjugate pairs of abelian subalgebras fW $_{i}$; \hat{W}_{i} g; 1 i q, the subalgebras construct a quotient algebra, denoted as a multiplet of partition fQ (A;q)g fA; \hat{W}_{i} ; \hat{W}_{i} ; 1 i qg, if the condition of closure under the operation of the commutator is satisfied: 81 i;j q; 91 k q, s.t.

In the following the notation will be abbreviated as fQ (A)g; the form er form is resumed only when the number of conjugate pairs should be noted. This structure exists not only in su (N = 2^p) but also in su (N \in 2^p). Similarly, the center subalgebra consisting of 5 diagonal generators of su (6), fI $_3$; $_3$ I; $_8$ I; $_3$ $_3$; $_8$ $_3$ g, creates a partition as shown in Fig.3, where a quotient algebra resides. The generators $_j; j=1;2;\dots;8$, for su (3) denote the Gell-M ann m atrices, ref. Appendix A . Here the vector spaces W $_i$ or W $_i$ are spanned by 2 or 3 generators, rather than equally 4 as those for su (8). To construct a conjugate partition and the corresponding quotient algebra, the center subalgebra is not restricted to only diagonal generators. Figs.4 and 5 dem onstrate the conjugate partitions and quotient algebras for su (8) and su (6) that are m ade by taking other choices of center subalgebras. This observation foretells the M ain Theorem .

M ain Theorem. Every Lie algebra su (N) has the structure of the quotient algebra, and every maximal abelian subalgebra A su (N) can generate a quotient algebra fQ (A)g.

Proof. The Main Theorem and the Lemmawillbe proved rst for the Lie algebra su (N = 2^p) and then extended to the algebra su (N $\in 2^p$) as the Corollary.

For every maximal abelian subalgebra A 2 su(N), there exists a transformation in SU(N) that maps A to the intrinsic coordinate or the eigenspace of A, where all elements of the subalgebra A are simultaneously diagonalized. While every maximal abelian subalgebra has its own intrinsic coordinate which can be connected to that of any other maximal abelian subalgebra by a unitary transformation. Equivalently, once a coordinate is decided, the center subalgebra consisting of only diagonal operators is regarded as the intrinsic center subalgebra and has a reserved notation C. Although coordinate independent, the structure and properties of the quotient algebra are better discerned in the eigenspace of the chosen center subalgebra. The exposition thus starts in this coordinate.

-R epresentation. The vector space of the intrinsic center subalgebra C of su (4) for example is spanned by the 3 diagonal operators, I $_3$ = diagf1; 1; 1; 1g, or equivalently by another set of 3 independent operators diagf1; 1;0;0g, diagf1;0; 1; 0g and diagf1;0;0; 1g. In general, the intrinsic center subalgebra C of the Lie algebra su (N) is spanned by the N 1, N N, diagonal operators: diagf1; 1; 0; ;0g, diagf1;0; 1;0; ;0g, ::: and diagf1;0; ;0; 1g. A ccording to the algorithm primitive, calculating the commutators of a seed generator with C, or mapping the seed by the adjoint representation ad_C , produces the generators in the conjugate vector space. To exam ine this operation, the so-called

-representation, an extension of the well-known G ellM ann matrices, is employed, referring to Appendix A for more details. In this representation, a -generator $_{ij}$, an o-diagonal N N matrix, plays the role of $_1$, whose the only two nonzero entries, the (i;j)-th and (j;i)-th, are both assigned 1. Another -generator $_{ij}$, the conjugate of $_{ij}$ and an o-diagonal N N matrix too, takes the role of $_2$ and has nonzero values only at the (i;j)-th and the (j;i)-th entries, respectively assigned i and i. A coording to eqs A 1-A 3, the adjoint representation ad_C leaves a $_{ij}$ or a $_{ij}$ invariant within the pair. The -generators may well be acting as building blocks to form the conjugate pairs of abelian subalgebras. In terms of these generators, some combinatorial traits of the scheme will be read in the following construction of conjugate partitions and quotient algebras.

B in ary Partitioning. A set of the -generators by an appropriate grouping su ces to serve as a basis for the vector space of an abelian subalgebra. Such a grouping implies a corresponding partition on the subscripts of the -generators. Since two of these generators com mute as long as no repetition in the subscripts, a m axim alabelian subalgebra in su (N) C is made by taking any one set of N=2 elements f_{ij} or \hat{k}_{kl} : the subscripts of the generators are given by a partition of the integers from 1 to N , i; j;k;l = 1;2;:::;N g. For instance, two sets of 4 generators in su (8), f $_{15}$; $^{^{\circ}}_{26}$; $_{37}$; $^{^{\circ}}_{48}$ g and f $_{16}$; $^{^{\circ}}_{28}$; $^{^{\circ}}_{37}$; $^{^{\circ}}_{45}$ g, respectively build an abelian subalgebra. Although both partitions of the subscripts lead to the creation of an abelian subalgebra, only the former kind to the further use, to support quotient algebras. Generators of conventional types bring the clue. Take one spinor generator $_3$ I $_1$ 2 su (8) for example, which reads $_{78}$ in the $\,$ -representation and is a vector in the space W $_1$ as ₁₂ + ₃₄ ₅₆ spanned by the 4 generators $_{12}$; $_{34}$; $_{56}$; and $_{78}$. By the algorithm prim it ive, the 4 independent generators for the conjugate vector space \hat{W}_1 are produced from the commutator $[\ _3\ \ I\ _1;C]$. For owing to eqsA 1 and A 2, the required += parities assigned to its are provided by the mapping adowhen going through all the, N $\,$ 1, independent generators of C. Conversely, the $\,$ com m $\,$ utator $(\hat{g};C)$, $(\hat{g$ independent generators to the vector space W $_1$. It is critical to note that the subscripts of the -generators so produced in the same conjugate pair share a comm on binary pattern of partition, here particularly term ed as the binary partitioning. For the vector space W₁, the subscripts of the -generators have the common pattern of bit-wise addition $i^0 + 001 = j^0$, where $i^0 = i$ 1 and $j^0 = j$ 1 are written in their binary expressions. Since the mapping ad leaves a -generator invariant in its conjugate pair, the identical subscript pattern of binary partitioning shall be retained by all the generators belonging to the sam e pair. In other words, the binary partitioning is an invariant under the adjoint representation ad_{C} . It is legitim at to encode such a subscript pattern by a binary string and attach the string to the conjugate pair. The vector spaces W $_1$ and \hat{W}_1 are therefore redenoted as as W_{001} and \hat{W}_{001} .

C on jugate Partition. The continued step is to pick a spinor generator as a seed outside this conjugate pair and the center subalgebra, for example 3 $_{1} = _{14} + _{23}$ $_{58}$ $_{67}$ where the subscripts of the -generators keep another pattern of binary partitioning $i^0 + 011 = j^0$, with $i^0 = i + 1$ and $j^0 = j + 1$ in their binary expressions. Then the conjugate pair W_{011} and \hat{W}_{011} are formed by operations of the commutators required in the algorithm primitive. A coordingly, by this procedure all the vector spaces of abelian subalgebras, associated to the strings from 001 to 111, appear pair by pair, ref. Fig. 6. These 7 conjugate pairs of vector spaces along with the center subalgebra C build a conjugate partition in su (8). This procedure is generally applicable to the Lie algebra su (2p), whose any one spinor generator in the -representation speciles a subscript pattern of binary partitioning. Let a binary string of p digits encode the subscript pattern. Say associated to the string $\,$, an arbitrary spinor generator $g^2 > g^2 >$ as a seed outside C and the existing conjugate pairs. With the application of eqsA 1 and A 2, a new conjugate pair fW; \hat{W} g is formed by the mappings [g;C] and [g;C], where g is a spinor generator produced from the former commutator. Such a step is recursively applied until no generator is left and hence all the 2^p 1 strings of binary partitioning and the 2^p conjugate pairs have appeared. A conjugate partition therefore completes in the Lie algebra su (2^p), eq 2.1. The property of the invariance within a conjugate pair, eq 22, is derived from eqs A 1-A 3.

Quotient Algebra. Most importantly, the binary partitioning encodes the structure of the quotient algebra. The structure becomes clear as being translated into the language of binary partitioning. For three vector spaces of abelian subalgebras associated to three p-digit strings of binary partitioning; and , the condition eq 3.1 is rewritten as [W ; W] \hat{W} , [W ; \hat{W}] $[\hat{W}]$; $[\hat{W}]$. A coording to eqs. A.4-A.6, the commutator of two -generators in su (2^p) with the subscripts (i; j) and (j;k), or (k; j), yields a -generator with the subscript (i;k); here i; j and k are three distinct integers. Suppose that the subscript (i; j) is associated to the string and (j;k) to , and thus there exist the relations of bit-wise additions, $i^0 + j^0 = and j^0 + k^0 = i + i^0 = i + i^0 = j + 1$ and $k^0 = k$ 1 in their binary expressions. The string attached to the yielded subscript (i;k) is then coerced to be + , for $j^0 + j^0 = 0$. A coordingly, characterizing the closure of the abelian-subalgebra vector spaces under the operation of the commutator, the condition is satis ed whenever the relation of bit-wise addition + = holds. To be short, the binary partitioning encodes the condition of closure, eq 3.1, as

The condition exhibits a property of binary combinatorics in quotient algebras. An example for su (8) is illustrated in Fig.8.

That the center subalgebra C is the zero element within a conjugate pair under the operation of the commutator, eq 3.2 repeats eq 2.2 of the conjugate partition. Therefore, the quotient algebra fQ (C; 2^p 1)g given by, in fact \par-

titioned by," C is constructed. Any other quotient algebra fQ (A)g given by a maximal abelian subalgebra A is connected to the former by a unitary transformation U 2 SU (N), namely the equivalence via a conjugation mapping, $fQ(A)g = U^y fQ(C)gU$ with $UAU^y = C$.

Subscript M ultiplication. Apparently there are many more options of conjugate partitions. To ful lithe properties in the Lem ma, the binary partitioning is not a unique way to arrange the subscripts. As aforem entioned, a conjugate partition is created as long as the pairs of the -generators, if and if, in every conjugate pair of vector spaces have no repetition in their subscripts. However, to further embed the structure of quotient algebras, the consistence in the subscripts, i.e., following the binary partitioning or its equivalence, is necessary. An abelian-subalgebra vector space V su(8) for example is spanned by 4 generators, $V = \text{spanf}_{16}$; $_{25}$; $_{37}$: $_{48}$ g W_{100} [W_{101} . This grouping of subscripts is considered inconsistent owing to bearing two dierent strings of binary partitioning. As a result, the commutator [V;W $_{011}$] yields 8 generators that a half of them are in the space W $_{110}$ and another half in W $_{111}$. This inconsistence causes the partition to violate the condition of closure. It is shown in the following that, to accommodate the structure of the quotient algebra given by C, the subscripts of the -generators are obliged to follow the binary partitioning or its perm utations.

A worthy reexam ination is that how the condition of closure is met under the operation of the commutator for any two abelian subalgebras in the conjugate partition given by an intrinsic center subalgebra. Due to eqs. A-A.6, the operation can be reduced to as simple as a subscript multiplication of two integer pairs: (i;j) (j;k) = (i;k), where i;j and k are the subscripts, without repetition, of the -generators in the commutator and the integer pair has no order, i.e., (i;j) = (j;i); the multiplication otherwise is either f0g, as two generators commuting, or falls in C, as two generators belonging to one conjugate pair. The subscript table of su (4) is displayed as,

which represents the 3 conjugate pairs of a conjugate partition. Simply carrying the conjugate pairs of a conjugate partition, the subscript table is orderless in a sense that there is no order for integer pairs in one row and no order either for these rows in the table. Since the multiplication of two integer pairs from any two rst rows always falls in the rest row, this table carries a quotient algebra too. An easy check is that any permutation of the 4 integers m akes the table unchanged, noting the orderless of the table. It implies that the binary partitioning is invariant w.r.t. subscript permutations as the dimension N=4.

Now proceed to the subscript table of su (8),

Only 4 rows of integer pairs are placed in the table, representing the 4 conjugate pairs. For owing to the condition of closure, the other 3 rows of integer pairs have been decided by these 4 rows. This is the so-called pre-decision rule that, for a quotient algebra of su (2^p) , the 2^p p 1 conjugate pairs are determined by certain the other p pairs. Prior to the row f(1;5) (2;6) (3;7) (4;8)g being concerned, any permutations respectively exercised in the integer sets f(1;2;3;4)g and f(1;3) are allowed. For without the consideration of this row, these two sets are disjoint and have no \interaction." While, some inconsistency may be introduced if only a partial permutation is applied to the table with the interaction row. An example is as the table,

where the integers 6 and 7 are permuted in the rst 3 rows, the beginning rows, but no corresponding permutation is followed in the 4th row, the interaction row. The order of a row here is referring to the display order in the table and has no meaning to the conjugate partition. This table is literally equivalent to

where the original integer pairs are preserved in the rst 3 rows, following the binary partitioning, and instead integers 6 and 7 are permuted in the 4th row. The condition of closure is violated when this interaction row is multiplied by either one of two beginning rows, the 1st and the 2nd rows in the table. This example is no atypical. Any permutation of integers in the beginning rows can be rewritten as a permutation in the interaction row and let the integer pairs in the beginning rows be obedient to the binary partitioning. Then, whether the condition of closure is met is depending on if the integer pairs are consistently arranged in the interaction row.

A recursive argument is developed for a general assertion. The subscript table of the Lie algebra su (2^p) is prepared by, in addition to one interaction row, gluing two such tables of su (2^{p-1}) in a way that each of the 2^{p-1} 1 beginning rows is made by collecting integer pairs of the identical binary partitioning from the two tables. The integer pairs in one table are written in integers from 1 to 2^{p-1} , designated as the 1st set of integers, and the pairs in the other table are in integers from $2^{p-1}+1$ to 2^p , as the 2nd set. The interaction row consists of 2^{p-1} integer pairs where one entry of each pair is contributed by the 1st set of

integers and the other by the 2nd set. Take two integer pairs (a;b) and (c;d) in the interaction row and let a and c belong to the 1st set of integers and b and d to the 2nd set. Suppose that in this row at least the two integer pairs (a;b) and (c;d) are inconsistent in their associated strings of binary partitioning. Two di erent strings of binary partitioning are thus attached to these two integer pairs such that $a + b \in c + d$, a; :::; d respectively denoting a 1; :::; d 1 in their binary expressions. There must be one beginning row that has the two integer pairs (b;d) and (;c), leaving the integer to be decided. The two bit-w is additions equal, b+d=+c, for these two integer pairs are in one beginning row and follow the binary partitioning. Then the multiplication of these two rows of integer pairs produces, among the others, the pairs (a;d) and (;d). A contradiction occurs, = b + c + d = a, that has the condition of closure fail. It im plies that, to keep closed the multiplication of integer pairs, the interaction row is obliged to follow the binary partition if the beginning rows have been so. As known earlier, the binary partitioning is naturally respected by su (4), whose subscript table is invariant under any integer permutation. The recursive argument thus starts with the Lie algebra su (8); p = 3, and has its conjugate pairs constructed according to the binary partitioning. Im mediately it asserts that, for the Lie algebra su (2p), only the conjugate partition of subscript patterns following the binary partitioning allows the structure of the quotient algebra fQ (C;2^p 1)q.

Nevertheless, a global permutation, applying the same permutation of integers to every row of the table, is not denied. For in such a case still the binary partitioning is followed and integers are permuted simply as labelling indices. It hence leads to a conclusion that, up to permutations on the subscripts of the generators, the conjugate partition admitting the structure of the quotient algebra fQ (C)g is unique, i.e., the su cient and necessary condition, the one whose arrangement of the -generators in its conjugate pairs conforms to the binary partitioning. Equivalently, the complete set of conjugate partitions that accomm odate the quotient algebra fQ (C)g is obtained by exhaustive perm utations of the subscripts of -generators initiated by the binary partitioning. However, except those coinciding with the binary partitioning, the other options have generators written in superpositions of noncommuting spinor operators. These variations may have advantages in building certain types of H am iltonians for particular physical motivations, but are of no interest to the purpose of operator decom positions described later. In addition, by an appropriate coordinate transform ation, the superpositions can be removed and the binary partitioning is recovered from these variations.

A lgebra Isom orphism. As the dimension N is not a power of 2, the Lie algebra su (N) as well has the structures of the conjugate partition and the quotient algebra. The reason is illustrated by an example of a conjugate partition for su (6) as given in Fig.7. Similarly, the partition composed of 7 conjugate pairs of abelian-subalgebra vector spaces and the intrinsic center subalgebra is expressed in the -representation. The difference between Figs.6 and 7 is that

all the generators with subscripts larger than the dimension N=6, i.e., with 7 or 8 here, are removed from the latter. A reminder is that the center subalgebra C of su (8) is spanned by the set of 7 independent generators $d_{11}; l=2; \ldots; 8$. The (i;j)-th entry of an operator can be referred to as the transition-probability amplitude from the i-th to the j-th dimensions. For su (6), there are no the 7th and the 8th dimensions and no transition to these two dimensions can be made. Therefore any generators with either one of these two subscripts should be set to 0 or simply removed from the partition. As a result, all the rest of 8 8 m atrices of generators originally for su (8) have only 0s in the 7th and the 8th rows and columns. Undergoing the removal of the 7th and the 8th rows and columns, the retaining 35 independent generators of 6 6 m atrices su ce for the form ation of su (6). Conversely, before the 7th and the 8th rows and columns are removed, these generators support an embedding of su (6) in the space of su (8).

Since only those with subscripts greater than the dimension N = 6 are rem oved, still all the -generators with subscripts less than or equal to the dim ension remain. Staying in the original vector spaces, ${\tt W}$ or ${\tt W}$, of the conjugate pairs or of the center subalgebra C, these retaining generators satisfy the condition of closure and the properties of the conjugate partition all the sam e. An isom orphic structure of the quotient algebra is therefore guaranteed for su (6) and su (8). The sim ilar procedure of the rem oving process is applicable to any Lie algebra su $(2^{p-1} < N < 2^p)$. The -generators, $_{ij}$, $_{ij}$ and in the set of 2^p 1 independent d_{11} ; 1 = 2; 3; ...; 2^p , whose either one subscript is greater than the dim ension N and only they are rem oved from the structure of the quotient algebra fQ (C; 2^p 1)q given by the intrinsic center subalgebra C of su (2^p). The Lie algebra su (N) is spanned by the remaining N² 1 generators, whose from the (N + 1)-th to the 2^p -th rows and columns in their matrices are all 0s and are removed. Still all the generators with subscripts ranging from 1 to N respectively stay in the conjugate pairs and the center subalgebra that are structurally inherited from the quotient algebra fQ (C;2^p 1)q. The relations among these abelian subalgebras, eqs. 3.1-3.3, are accordingly preserved. It im plies the following Corollary.

For the conjugate partition of the Lie algebra su $(2^p \ ^1 < N < 2^p)$ obtained by the rem oving process, there are in total $N \ ^1$ generators in the conjugate pairs and $N \ ^1$ independent generators in the center subalgebra. These two numbers decrease compared with those of su (2^p) . The number, $2^p \ ^1$, of the conjugate pairs and the relations among the pairs and the center subalgebra, however, remain the same. The two Lie algebras share the identical structure of the quotient algebra.

C orollary. The quotient algebra of the Lie algebra su (N), where 2^p 1 < N < 2^p and p 2 Z $^+$, is isom orphic to that of su (2^p).

4 Scheme Implementation

The structure of the quotient algebra m akes the construction of C artan decompositions straightforward. The essential procedure is to build the table of the conjugate partition where the quotient algebra is embedded. With the above veri cation, the algorithm is concluded as follows.

A lgorithm . Q uotient A lgebra C onstruction for su (N); N 2 $\rm Z^+$: The step of preparation:

For a m axim alabelian subalgebra A 2 su (N), calculate the unitary transform ation that has A diagonalized, i.e., 9 U 2 SU (N); UAU $^{\rm y}$ = C, m apping A to the intrinsic center subalgebra C.

The 1st step:

Take a generator g_{11} outside C as a seed and calculate the commutator $[g_{11};C]$ which produces a nite number, r, of abelian generators $g_{11};g_{12};$ $_{1n};g$ and the vector space \hat{W}_1 is spanned by this list of generators; in the reversing step, the commutator $[g_{1i};C]$, g_{1i} being any one generator in the list, adds the other r_1 1 abelian generators, $g_{12};$ $_{1n};g$ which with the seed form the conjugate space W_1 .

.....

The k-th step:

W ith a generator g_{k1} outside C and the preceding conjugate pairs W $_i$ and W $_i$, i=1;2;:::;k 1, taken as the k-th seed, calculate the commutator $[g_{k1};C]$ that yields the list of abelian generators $g_{k1};g_{k2};$ $kn_k g$ and the vector space W $_k$ is spanned by these generators; in the reversing step, the commutator $[g_{k1};C]$, g_{k1} being any one generator in the list, yields another list of r_k 1 abelian generators, $g_{k2};$ $kn_k g$ which with the k-th seed form the conjugate space W $_k$.

•••••

End when no generator remains.

M erge into one single pair, following the condition of closure, any conjugate pairs that ${\it com}\,m$ ute.

The construction of the quotient algebra fQ (C)g com pletes; M ap fQ (C)g to the quotient algebra fQ (A)g by fQ (A) $g = U^y fQ$ (C)gU.

The step of merging commuting conjugate pairs is necessary. For, in some representations, one conjugate pair may be created by parts in the preceding steps. The sim plest exam ple is in constructing quotient algebras for su (4) in the -representation. Due to eqs. A. 1 and A. 2, only a single generator, its conjugate, is produced by the mapping [g;C], where g is a $_{ij}$ or a $_{ij}$ and C is the intrinsic center subalgebra of su (4). The two options to merge, for instance, the two com muting conjugate pairs f_{12} ; f_{12} g and f_{34} ; f_{34} g are f_{12} ; f_{34} ; f_{12} ; f_{34} g and f 12; 34; 12; 34g. Consequently, in addition to the original as in Figs.9 and 10, the 2nd version of the quotient algebra is made as given in Fig.11. This is simply the freedom within conjugate pairs, 2 options of distributing each pair of generators ij and ij to their conjugate pair of vector spaces, and is loyal to the rule of binary partitioning. The generators in the 2nd version are in a superposition of 2 noncommuting spinor generators, such as the part ($_1$ for the 2nd qubit in $_{12}$ $^{\circ}_{34} = \frac{1}{2} (I _{3})$ $(_{1} _{2})$. This form is unt for the later purpose of operator decom positions, although the freedom may be useful in som e physical settings.

In practice, there is no order for the generation of conjugate pairs. It is essential and helpful during the construction to check the com mutation relations among the produced pairs by the condition of closure, eq 3.1. At certain stages,

for instance, the seed generators needed are easily tracked by applying this condition to the existing pairs.

For the Lie algebra su (2^p) , the quotient algebra fQ (A) q can be directly constructed with the algorithm by taking a maximal abelian subalgebra A as the center subalgebra, not necessarily the intrinsic one C, and the number of abelian generators r_k in the vector space W $_k$ or \hat{W}_k always equals to 2^{p-1} . Considering the quotient algebra given by the intrinsic center subalgebra is particularly for the Lie algebra whose dimension is not a power of 2. It is worth a few lines for an equivalence of quotient-algebra construction making use of the rem oving process. This version may have the potential to be more e cient when the dimension is large. Since sharing the isomorphic structure, the quotient algebra fQ (A^0) g given by a maxim alabelian subalgebra A^0 su (N^0) should be derivable from fQ (C)g, where $N = 2 < N^0 < N = 2^p$ and C is the intrinsic center subalgebra of su (N). Although requiring two additional steps, the procedure is as simple as follows. The rst step is to construct $fQ(C^0)q$ from fQ(C)q, where C^0 is the intrinsic maximal abelian subalgebra of su (N^0) . That is to cast fQ (C)g into the -representation, rem ove all the generators $_{ij}$ whose $i > N^0$ or $j > N^0$, and then delete all the (N 0+ 1)-th through the N -th rows and columns of the remaining -generators. The 2nd step is to map the quotient algebra fQ (\mathbb{C}^0)g by a unitary transform ation U 0 2 SU (N 0) to the coordinate of A 0 , i.e., $fQ (A^0)q = U^{0Y}fQ (C^0)qU^0$ with $U^0A^0U^{0Y} = C^0$, and nally rewrite the quotient algebra fQ (A 0)g in the required representation. There is an alternative for the transform ation. Owing to the algebraic isom orphism, fQ (A^0)g and fQ (A)g practically share the same transform ation U 2 SU (N), where UA 0 U y = C C and $UAU^{\gamma} = C.Here A$ is a unique maximal abelian subalgebra in su (N) such that A, which can be built from A^0 in terms of the -representation. Note that at this point still the quotient algebra fQ (A 0)g and the intrinsic center subalgebra C⁰ are written in N N matrices of the -generators. The nal form of the quotient algebra fQ (A^0)g is attained once the mapping fQ (A^0)g = $U^{y}fQ$ (C^{0})qU, followed by the deletion of all the ($N^{0}+1$)-th through the N^{-} -th rows and columns, and the return to the required representation are completed.

C artan D ecom position. Therefore, for any maxim alabelian subalgebra A su $(2^{p-1} < N-2^p)$ it is feasible to construct a quotient algebra fQ (A; 2^p-1)g that has 2^p-1 conjugate pairs of abelian-subalgebra vector spaces. This algebraic structure makes straightforward and system atic the construction of the C artan decomposition. The C artan decomposition of the Lie algebra su (N) is referred to as the decomposition su (N) = t p, where the subalgebra t and the subset p satisfy the conditions, [t;t] t, [t;p] p, [p;p] t, and Trftpg = 0. The decomposition is not unique. For a quotient algebra with 2^p-1 conjugate pairs, there are in total 2^p choices of C artan decompositions.

To decide a choice of Cartan decom position is equivalent to a decision of the subalgebra t. Take a quotient algebra of either su (8) or su (6) for example, which has 7 conjugate pairs of vector spaces as shown in Figs 2-5. The subalgebra t must be formed by taking either one vector space of every conjugate pair.

However, due to the condition of closure, when the st 2 vector spaces are chosen from the rst 2 conjugate pairs, the 3rd one from the 3rd conjugate pair is decided. Renote that the order of the conjugate pairs has no relevance. Any 2 conjugate pairs can be specified as the first 2 pairs, by which the 3rd pair is determined due to the condition of closure. The 4th conjugate pair is arbitrarily specied from the remaining pairs, which determines the following 5th through 7th pairs. The vector spaces chosen from the 5th through the 7th conjugate pairs are decided once the choice from the 4th conjugate pair is taken. For instance, if the set $fW_1;W_2;W_3;W_4g$ is collected, the following set of choice is only fW 5; W 6; W 7g. The subalgebra t is formed by gathering these two sets, $t = fW_1; W_2; \hat{W}_3; \hat{W}_4; W_5; \hat{W}_6; \hat{W}_7g$. The subset p is obtained by taking the union of the center algebra A and the remaining vector space in every conjugate pair; am ong the other 7 ones, A is a maxim alabelian subalgebra in p. Inheriting the properties of spinor generators, the subalgebra t and the subset p ful 11 the condition of orthogonality, Trftpg = 0. There are in total 23 choices of t for this given quotient algebra. In general for a quotient algebra of 2^p 1 conjugate pairs, the subalgebra t is decided by the selections of vector spaces, a W or $a\hat{W}$, in the 2^r -th speci ed conjugate pairs, r = 0;1;2;...;p 1, and thus has in total 2^p choices. The pre-decision rule of this form is a result of the condition of closure, eq. 3.1. A Ithough there are 2^p choices of decom positions for a quotient algebra of su $(2^{p-1} < N)$ 2^p), the Cartan decompositions rendered by di erent designations of center subalgebras may have redundancy. Further studies in this regard are continued in [10].

5 Recursive Decomposition

Form ing the subalgebra t is only for the 1st level of decom position of su (N) and let it be redenoted as t_{11} . By the same token, an arbitrary maximal abelian subalgebra in t_{11} can be designated as the center subalgebra of the 2nd level, denoted as A $_{[2]}$, which has $t_{[1]}$ partitioned into 2^{p-1} 1 conjugate pairs. Here the subalgebra A pl is either an abelian subalgebra in the conjugate pairs of the 1st level or simply a new one created by another group of abelian generators. The quotient algebra of the 2nd level, fQ (A $_{p_1}$; 2^{p-1} 1)g, is thus constructed. W ith 2^{p-1} choices in total, the subalgebra t_{p_1} for the 2nd-level decomposition is form ed in this quotient algebra by applying the condition of closure. Sim ilarly, the quotient algebra fQ (A $_{\mathbb{R}_1}$; 2^{p-k+1} 1)g is constructed at the k-th level of decomposition, where forming the subalgebra t_{k} has 2^{p-k+1} choices. As this process is recursively continued for p times to the nal level and the quotient algebra fQ (A $_{\rm fol}$;1)g is derived, the Lie algebra su (2 $^{\rm p}$ $^{\rm 1}$ < N decom posed. Directing such a recursive decom position, a decom position sequence sequence of designated center subalgebras in the order of the recursive level and at last the subalgebra of the nal level, ;p;p+ 1_{i} A= A and A $_{[p+1]}$ = $t_{[p]}$ g. For the center subalgebra

at the k-th level of decomposition A $_{[k]}$, 1 < k p, is an abelian subalgebra W $_{i}$ or \hat{W}_{j} of the original quotient algebra fQ (A); 2^{p} 1)g or a new one of a similar size. It is easy to verify in terms of the -representation that there always exist an enough number of generators in A commuting with A $_{[k]}$ such that the subalgebra A $_{[k]}$ recovers its N 1 abelian generators, ref. Appendix B and [10].

Operator Factorization. The Lie algebra su (N) is recursively decomposable based on the structure of the quotient algebra residing at each level. A coording to the KAK theorem [2, 3], if an algebra g adm its a Cartan decomposition g = t p, its corresponding group action eig has a particular form of decomposition. That is, $8 ext{ g 2 g, } 9 ext{ s}_1; ext{ s}_2 ext{ 2 t and a 2 A , such that } e^{ig} = e^{is_1} e^{ia} e^{is_2}$, where A is a maximalabelian subalgebra in p. The computation of this decomposition is operationally equivalent to the well-known SVD (Singular Value Decomposition) in matrix analysis. The essential step is to map the group action to the coordinate that has the subalgebra A diagonalized. Namely, 9 U 2 SU (N), s.t. $U e^{ig} U^y = (U e^{is_1} U^y) (U e^{ia} U^y) (U e^{is_2} U^y) = O_1 D O_2$ M, where D is diagonal and O $_1$ and O $_2$ 2 SO (N). The m atrix O $_1$ is obtained by calculating the diagonalization matrix for M $^{t} = O_{1}D^{2}O_{1}^{t}$, and O_{2} obtained by calculating that for M ^tM = O_2 ^tD ²O₂. The entries, the eigenvalues, of D are e^{ij} with ij being the eigenvalues of a. Such a computation of the group action decomposition, or the m atrix factorization, is achievable at each level, where Cartan decompositions exist owing to the corresponding quotient algebra. It implies that the matrix is nally factorized into a product of actions contributed by the subalgebras designated in the decomposition sequence.

A coording to the factorization guided by the K AK theorem, the contributed actions are ordered in the form of a binary bifurcation tree. Let the order of an action in a factorization of a unitary transform ation e^{ig} 2 SU $(2^{p-1} < N - 2^p)$ be written in a (p+1)-digit binary string. The contribution of this order can be told by the rst digit position in the string, traced from the (p+1)-th digit, where the digit 1 appears. If the nal, the (p+1)-th, digit is 1, the action of this order is an $e^{it_{[p],r}}$; $r=1;2;\ldots;2^p$, contributed by the subalgebra of the nal level, $t_{[p],r}$ 2 $t_{[p]}$. The action is an $e^{ia_{[p],p}}$; $j=1;2;\ldots;2^k$ 1 and 1 k p, contributed by the center subalgebra designated at the k-th level, $a_{[k],j}$ 2 $a_{[k],j}$ if 1 starts at the k-th digit.

Following a decomposition sequence, the recursive decomposition of a unitary transform ation in SU (N) implies a path on the manifold of the group. A subalgebra designated in the sequence may be regarded as a post or a node during the course of the transform ation. Interestingly, these posts are visited in a hierarchically recursive order, patterned like a bifurcation tree, rather than in a serial order. It exhibits the nature of recursive decompositions of Lie groups. Similar to the isomorphism of the quotient algebra, the Lie groups SU (2^p 1 < N < 2^p) and SU (2^p) share the common spectrum of recursive decompositions, or the same chart of decomposition sequences on the manifold, ref. Appendix B. The paths on the manifold are adjustable by changing designations of subalgebras in the decomposition sequence or even the group representation

up to physical considerations.

Since every subalgebra in a decomposition sequence is abelian, a unitary transform ation in SU (N) is fully decomposed into a product of actions e^{il g}, where g s are generators in the chosen representation and ! s are parameters acquired during the operation of SVD. The dimension N has the prime factorization, $N = 2^{r_0} P_1^{r_1}$ $_{f}$ rp and P_{j} ; j = 1; ...; f, being primes greater than 2. The generators of su (N) can be set as tensor products of the spinor generators and the generators of su (P_i) ; here the generators of the Lie algebra su (P_i) are expressed in the -representation, ref. Appendix A.E.ach contributed action e^{i! g} plays the role of a quantum gate, whose algebra g is written as a tensor product of generators of su (2) and su (P_i) or identity operators of appropriate dim ensions. For the interest of quantum information, a quantum gate $e^{i!}$ is considered local if it has only one single non-identity operator, i.e., a generator of su (2) or su (P_i), in the tensor-product form of q, and considered nonlocal if otherwise. As an immediate result of the decomposition scheme applied to a unitary transformation, a theorem of primitive decompositions is concluded as follows.

Theorem of Gate Decomposition: Every unitary transformation can be fully decomposed into a product of local and nonlocal gates.

The local-and-nonlocal decomposition of a transform ation is only one application of the scheme. More rened results and other applications will be seen in [10]. This scheme of the Cartan Decomposition enables the construction of feasible paths on the manifold of the Lie group SU (N) with components in a physically required representation. The scheme should be of help to the exploration in a quantum system.

A ppendix

A Representation

A -generator, $_{ij}$ or its conjugate $^{\hat{}}_{ij}$, of the -representation is an o-diagonal N N m atrix and serves the role of $_1$ or $_2$ in the i-th and the j-th dimensions. In terms of the D irac notation, the generators read as $_{ij}$ = jiihjj+ jjihij and $^{\hat{}}_{ij}$ = ijiihjj+ ijjihij. In addition, a diagonal N N m atrix d_{k1} is defined as d_{k1} = jkihkj jlihlj. For the Lie algebra su (N), a complete set of generators can be formed by N (N 1)=2 conjugate pairs of $_{ij}$ and $^{\hat{}}_{ij}$ with any N 1 independent diagonal operators d_{k1} , such as d_{11} ; l=2;3;:::;N. It is easy to confirm that Trf $_{ij}$ $_{k1}$ g = 0 and Trf $_{ij}$ Cg = 0, $_{ij}$ 6 $_{k1}$. Here $_{ij}$ denotes either a $_{ij}$ or a $^{\hat{}}_{ij}$, and C is the intrinsic center subalgebra of su (N). The condition of orthogonality Trftpg = 0 is therefore guaranteed at each level of the decomposition, for C p. A lthough no such an obligation required in the decomposition, the orthogonality can be further established in C by taking a certain set of basis generators, C = spanf $\frac{1}{1(1-1)}$ P $\frac{1}{i=1}$ $\frac{1}{1}$ $\frac{1}$

In particular as the dim ension N is a prime, the \rightarrow representation is a suitable choice. An example are the Gell-M ann m atrices for su (3), here denoted by $_{\rm j}$, 1 $_{\rm j}$ 8,

greater than 2. The table of a conjugate partition for su (2^{r_0}) can be quickly built by taking an arbitrary center subalgebra in the spinor representation. An e cient way to build a similar table for su (N) is then to make the center subalgebra written in tensor products of the spinor generators and the generators of su (P_1) in the —representation.

For the completion of de nition, these generators are either symmetric or antisymmetric with respect to the subscript permutation. Namely, $_{ij}=_{ji}$, $^{\hat{}}_{kl}=^{\hat{}}_{lk}$ and $d_{kl}=_{dlk}$, although only those of the latter subscript greater than the former are in actual use.

B Abelian Subalgebra Extension

As aforem entioned, a path on the group manifold is depending on designations of subalgebras in the decomposition sequence. It is useful to search the maximal abelian subalgebras for a Lie algebra. Toward this purpose, an easy method based on quotient algebras is described. This method considers only the \basis generators" and ignores those in superpositions of noncommuting operators. The intrinsic center subalgebra C is always a convenient candidate to start with. As an example for su (4) shown in Fig.9, the center subalgebra $C = f_3$ I; I $_3$; $_3$ $_3$ g is laid in the central column of the quotient algebra. In this quotient algebra, each abelian subalgebra of the conjugate pairs can not 1 corresponding generator in C such that the abelian subalgebra recovers to be maximal. For instance the maximal abelian subalgebra fI $_1$; $_3$ $_1$; $_3$ Ig is formed by taking those in W $_1$ with the generator $_3$ I 2 C. Immediately, 6 maximal abelian subalgebras of nearest neighbors are extended from C. They are reckoned as the maximal abelian subalgebras of extension in the 1st shell.

Likewise, the maximal abelian subalgebras of the 2nd-shell extension are constructed from the 6 quotient algebras given by the maximal abelian subalgebras obtained in the 1st shell. However, only 8 new subalgebras appear in this shell and no more new member in the following shells. In total there exist 15 choices of center subalgebras for su (4), ignoring those in linear combinations of noncommuting operators. Owing to the structure of quotient algebras, all

the maximal abelian subalgebras for the Lie algebra su $(2^p\ ^1 < N\ ^2^p)$ can be found in the rst p shells [10]. As the dimension of the Lie algebra is a power of 2, it makes no dierence with which maximal abelian subalgebra the extension begins. While to trace those for the Lie algebra su $(2^p\ ^1 < N\ < 2^p)$, alike to the above algorithm, the extension should rst be performed on the maximal abelian subalgebras of su (2^p) for p shells. The version for su (N) emerges after applying the removing process to these subalgebras in the representation and then returning the representation required.

Since each of their maximal abelian subalgebras has $2\,(2^p-1)$ nearest neighbors and any one of these subalgebras is reachable within p shells of extension regardless of the starting member, similar to the isomorphism of the quotient algebra, the Lie algebras su (2^p) and every su $(2^{p-1} < N < 2^p)$ share the identical hypercubic structure of maximal abelian subalgebras. The navigation on the manifolds of all the Lie groups SU $(2^{p-1} < N - 2^p)$ is hence led by only one chart of decomposition sequences. More details regarding designations of subalgebras in the sequence and resulted paths are given in [10]. A visionary analogy for Cartan subalgebras may be appropriate and helpful.




Figure 7: The conjugate partition of Fig.3 in the $\,$ -representation.




Figure 8: Grouping the -generators of su (8) into 7 conjugate pairs according to the binary partitioning, the 4 here being a generator, either a $_{\rm ij}$ or a $^{\rm ij}$; the commutator of any two conjugate pairs, associated to the 3-digit strings and , falling in a 3rd pair, associated to the bitwise-addition string + , by the condition of closure.




Figure 9: A conjugate partition and a quotient algebra given by the intrinsic center subalgebra of su (4).




Figure 10: The partition and algebra of Fig.9 in the -representation.
