Operational Classi cation and Quanti cation of Multipartite Entangled States

W e form alize and extend an operational multipartite entanglem ent m easure introduced in T.R. O liveira, G.R igolin, and M.C. de O liveira, Phys. Rev. A 73, 010305(R) (2006) through the generalization of global entanglem ent (GE) [D.A.M eyer and N.R.W allach, J.M ath. Phys. 43, 4273 (2002)]. Contrarily to GE the main feature of this new m easure lies in the fact that we study the m ean linear entropy of all possible partitions of a multipartite system. This allows the construction of an operational multipartite entanglem ent m easure which is able to distinguish am ong di erent multipartite entangled states that GE failed to discrim inate. Furtherm ore, it is also m axim um at the critical point of the Ising chain in a transverse m agnetic eld being thus able to detect a quantum phase transition.

I. IN TRODUCTION

Since Schrodinger's sem inal paper [1] entanglem ent is recognized to be at the heart of Quantum Mechanics (QM). For a long time the study of entangled states was restricted to the conceptual foundations of QM [2, 3]. Since the last two decades, however, entanglement was also recognized as a physical resource which can be used to e ciently in plem ent inform ational and com putational tasks [4]. The understanding of the qualitative and quantitative aspects of entanglem ent, therefore, naturally became a fertile eld of research. Now adays, entanglem ent of bipartite states (a joint state of a quantum system partitioned in two subsystems A and B) is quite well understood. Good m easures of entanglem ent for these systems are available, specially for qubits [5]. On the other hand entanglem ent of multipartite states (a joint state of a quantum system partitioned in more than two subsystems) cannot be understood through simple extensions of the tools and measures employed for bipartite entangled states. Most of the tools available to study bipartite states (e.g. the Schmidt decomposition [6]) are in general not useful for multipartite states. Even a qualitative characterization of the many possible multipartite entangled states (MES) is very com plex since for a given N-partitioned system there are many \kinds" of entanglement [7, 8]. For example, let $_{\rm p}$ jj j $\rm i_{N}$ $_{\rm p}$ be a N-partite state $ji_N = j_1i$ in which $j_i i_i 1 = i_j i_j f_i$ is the ith subsystem state and j i_{N} _p is the state describing the other N p subsystem s. If j i_{N-p} is an entangled state then j i is called a p-separable state [9]. A fter discovering the value of p for a given multipartite state another com plication show s up when we focus on j $i_N p$ since its subsystem s can be

entangled in several inequivalent ways. For example, in the case of three qubits there are two paradigm atic MES which cannot be converted to each other via local operations and classical communication (LOCC)[7]. For four qubits, nine di erent kinds of entanglem ent are possible, which cannot be converted to each other via LOCC [8]. Thus after considerable work we still lack a deep understanding of MES and new tools must be developed in order to capture the essential features of genuine multipartite entanglem ent (ME).

Our aim in this paper is to shed new light on the way ME is characterized and quantied. We intend to do this by form alizing and extending an operational M E m easure introduced in R ef. [10]. W e em phasize that it is an operational measure in the sense that it is easily com putable, even for a multipartite state composed of many subsystems. This new measure can be seen as an extension of the global entanglem ent and we call it, from now on, the generalized global entanglem ent: $E_{G}^{(n)}$. The generalized global entanglem ent has several interesting features, two of which were already explored in Ref. [10]: (i) in contrast to the global entanglem ent m easure [11] it can identify genuine MES and (ii) it is maximum at the critical point for the Ising chain in a transverse m agnetic eld. A nother in portant aspect of E $_{\rm G}^{\rm (n)}$ is the fact that it has an intuitive physical interpretation. We can relate it to the linear entropy of the pure state being studied as wellaswith the purities of the reduced n-party states obtained by tracing out the other N n subsystem s [12, 13].

This paper is organized as follows. In Sec. II we formally de ne $E_{g}^{(n)}$ and we extensively discuss a few important properties satis ed by the generalized global entanglement. In Sec. III we calculate $E_{g}^{(n)}$ for the most representatives MES. This gives us a good intuition of the meaning of $E_{g}^{(n)}$ and illustrates its usefulness. We also compare $E_{g}^{(n)}$ with other measures available, highlighting the main differences and the advantages and disadvantages of each one. In the same section we use $E_{g}^{(2)}$ to quantify the ground state multipartite entanglement

of the one dimension (1D) Ising model in a transverse magnetic eld. Finally, in Sec. IV we present our nal remarks.

II. GENERALIZED GLOBAL ENTANGLEM ENT

G lobal entanglement (GE) was rstly introduced in Ref. [11] to quantify the ME contained in a chain of N qubits. Latter it was dem onstrated [14] to be equivalent to the mean linear entropy (LE) of all single qubits in the chain. This connection between GE and LE considerably simplied the calculation of GE and also extended it to system s of higher dimensions. An intuitive, though not so rigorous, way of understanding GE is to consider it as quantifying the mean entanglement between one subsystem with the rest of the subsystem s. In this process we are dividing a system of N components into a single subsystem and the remaining N 1 subsystem s. W e could, nevertheless, separate the system into two partition blocks, one containing L subsystems and the other L [16, 17]. There are many dierent ways to one N construct a given \block". In Refs. [16, 17] a block of L subsystem s consisted of the rst L successive subsystem s: $L = fS_1; S_2; S_3; \dots; S_L g$. But any other possible com bination of L subsystems could be employed to construct a block. We may have, for instance, a block form ed by the rst L odd subsystem s: $L = fS_1; S_3; S_5; \ldots; S_{2L-1}g$. It is legitim ate to compute the LE of each one of these possible partitions. Roughly speaking this allows us to detect and quantify all possible 'types' of entanglem ent in a multipartite pure state. The generalized global entanglement ($E_{G}^{(n)}$) is dened to take into account all of those possible partitions of a system com posed of N subsystem s. Before we de ne E $_{\rm G}^{\rm (n)}$ we highlight two of its main important qualities: (a) It is a relatively simple and operationalmeasure. Since it is based on LE it can be easily evaluated and it is valid for any type of multipartite pure state (states belonging either to nite or in nite dimension Hilbert spaces); (b) Each class of $E_c^{(n)}$ is related to the mixedness/purity of all possible n-partite

reduced density m atrices out of a system composed of N subsystem s, and thus it is not restricted to reduced density m atrices of only one subsystem as the original GE [11, 12, 13]. This fact is helpful for the physical understanding of $E_{G}^{(n)}$.

Following the de nition of $E_{g}^{(n)}$ we move to the study of the general properties of this new measure relating it to the mixedness/purity of the various reduced density matrices of the system. A fler that we particularize to qubits focusing on the ability of the generalized global entanglement to classify and quantify MES.We conclude this section by presenting a variety of examples, which clarify the necessity of all the classes of $E_{g}^{(n)}$, i. e. n = 1;2;3;:::, to properly understand the many facets of MES.

A. Form alDe nition of the M easure

Consider a system S which is partitioned into N subsystem s S_i, 1 i N.Let ji2 H be a quantum state describing S and H the Hilbert space of the whole system . Since we have N subsystem s, H = H₁ N H= N $_{i=1}^{N}$ H_i, in which H_i is the Hilbert space associated with S_i. The density m atrix of S is = j ih j and we de ne the generalized global entanglem ent [18] as,

where all the param eters are natural num bers, $n\ <\ N$, and

where $j_{j;j+i_1;j+i_2;...;j+i_n}$ is obtained by tracing out all the subsystem s but $S_A = fS_j; S_{j+i_1}; S_{j+i_2}; \ldots; S_{j+i_n} g$ and d = m infdim $S_A; \dim \overline{S}_A g$. Here dim S_A and dim \overline{S}_A are, respectively, the H ilbert space dimension of the subsystem S_A and of its complement \overline{S}_A . In resume the index n is for the number of subsystems in the A partition and the indexes $i_1; i_2; ::::; i_{n-1}$ are the neighborhood addressing for each of the involved subsystem s.

B. General Properties

Eqs. (1) and (2) are valid for any multipartite pure system, even systems described by continuous variables (G aussian states for example). The key concept behind generalized global entanglement is the fact that it is based on the linear entropy, which is an entanglement monotone easily calculated for the vast majority of pure states. Thus, by its very de nition, $E_{\rm G}^{(n)}$ and G inherit all the properties satis ed by LE, including the crux of all entanglement monotones: non-increase under LOCC.

A nother in portant concept of $E_{G}^{(n)}$ and G is the introduction of classes of multipartite entanglem ent (M E) labeled by the index n. As we will see, they are all related with the many ways a multipartite state can be entangled. M oreover, a genuine n-partite entangled state must have non-zero $E_{G}^{(n)}$ and G's for all classes n. Here a genuine M ES means a multipartite pure entangled system in which no pure state can be de ned to anyone of its subsystem s. There is only one pure state describing the whole joint system. For three qubits, for instance, the states jG H Z i = $(1=\frac{1}{2})(j00i + j11i)$ and jM i = $(1=\frac{1}{3})(j01i + j10i + j10i)$ are genuine M ES but j i = $(1=\frac{1}{2})(j00i + j11i)j0i$ is not.

Let us now explicitly show how the rst classes of $E_{\rm G}^{(n)}$ look like. This will clarify the physical meaning of the measure as well as the intuitive aspects which led us to arrive at the general and form alde nitions given in Eqs. (1) and (2).

1. First C lass: n = 1

W hen n = 1 Eqs. (1) and (2) are the same,

and if we remember the de nition of the linear entropy for the subsystem j [14, 15],

then Eq. (3) can be written as [10]

In other words, $E_{G}^{(1)}$ is simply the mean linear entropy of all the subsystem sS_j. We should mention that for qubits (d = 2), $E_{G}^{(1)}$ was shown [14] to be exactly the M eyer and W allach global entanglement [11].

The physical intuition behind the study of the mean linear entropies lies in the fact that the more a state is a genuine M E S the m ore m ixed their reduced density m atrices should be. However, we should not limit ourselves to evaluating the reduced density m atrices of single subsystem s S_j . We can take either two, or three, ..., or n subsystem s and calculate their reduced density m atrices and also calculate their mean linear entropies. This is the reason of why we introduced the other classes of generalized global entanglem ent.

2. Second C lass: n = 2

For n = 2 Eqs.(1) and (2) are not identical anymore, being, nevertheless, entanglem ent m onotones:

Now we deal with the reduced joint density matrix for subsystems S_j and S_{j+i_1} . The extra parameter i_1 is introduced to take account of the many possible distances' between the two subsystems. For nearest neighbors $i_1 = 1$, next-nearest neighbors $i_2 = 2$, and so forth.

N oticing that the linear entropy of the subsystem s S_j and S_{j+ i_1} by tracing out the rest of the other subsystem s is given by

then Eq. (7) can be written as,

This implies that Eq. (6) is simply given by

where the double brackets represent the averaging over all possible G (2; i_1), 1 i_1 N 1.

Looking at Eqs. (9) and (10) we can easily interpret $E_{G}^{(2)}$ and G (2; i_{1}). First, let us deal with G (2; i_{1}). We assume that all the subsystem s are organized in a linear chain. (This assumption simplifies the discussion in what follows.) If we remember that 1 i_{1} N 1, where N is the number of subsystem s, Eq. (9) tells us that G (2; i_{1}) is nothing but the mean linear entropy of two subsystems with the rest of the other subsystem s conditioned on that these two subsystems are i_{1} lattice sites apart.




Figure 1: All combinations of two elements out of ve.

For concreteness, let us explicitly write all the possible G $(2; i_1)$ for a linear chain of ve subsystem s. Since N = 5 we have 1 i_1 4, which gives four G's pictorially represented in Fig. 1:

- G (2;1), which is the mean linear entropy (LE) of the following pairs of subsystem s with the rest of the chain: f(S₁;S₂); (S₂;S₃); (S₃;S₄); (S₄;S₅)g;
- (2) G (2;2), which is the mean LE of the following pairs of subsystem s: f(S₁;S₃); (S₂;S₄); (S₃;S₅)g;
- (3) G (2;3), which is the mean LE of the following pairs of subsystem s: f(S₁;S₄); (S₂;S₅)g;
- (4) G (2;4), which is them can LE of the following pairs of subsystem s: f(S₁;S₅)g.

Finally, Eq. (10) shows that $E_{G}^{(2)}$ is the mean linear entropy of two subsystems with the rest of the chain irrespective of the distance between the two subsystems, i.e., it is the averaged summation of all the (1)-(4) kinds of G (2; i₁), 1 i₁ 4.

3. Third C lass: n = 3

By setting n = 3 Eqs. (1) and (2) become

Eq. (12) deals with reduced density m atrices of three subsystem s: S_j, S_{j+i₁}, and S_{j+i₂}. Therefore, G (3; i₁; i₂) is the mean linear entropy of all three subsystem s with the rest of the chain conditioned to that S_{j+i₁} and S_{j+i₂} are, respectively, i₁ and i₂ lattice sites apart from S_j. Taking the mean of all possible G (3; i₁; i₂) we obtain Eq. (11). This is equivalent to averaging over all linear entropies of three subsystems irrespective of their distances. A lthough we do not explicitly write them here, sim ilar expressions as those given by Eqs. (9) and (10) can be obtained for this class.




Figure 2: All combinations of three elements out of ve.

A gain, as we did for the second class, it is explanatory to analyze in details the N = 5 case. Now 1 $i_1 < i_2$ 4. This time we have six G's (See Fig. 2):

- G (3;1;2), which is the mean linear entropy (LE) of the following triples of subsystem s with the rest of the chain: f (S₁;S₂;S₃); (S₂;S₃;S₄); (S₃;S₄;S₅)g;
- (2) G (3;1;3), which is the mean LE of the following triples of subsystem s: f (S₁;S₂;S₄); (S₂;S₃;S₅)g;
- (3) G (3;1;4), which is the mean LE of the following triples of subsystem s: f(S₁;S₂;S₅)g;
- (4) G (3;2;3), which is the mean LE of the following triples of subsystem s: f (S₁;S₃;S₄); (S₂;S₄;S₅);
- (5) G (3;2;4), which is the mean LE of the following triples of subsystem s: f(S₁;S₃;S₅)g;
- (6) G (3;3;4), which is the mean LE of the following triples of subsystem s: f(S₁;S₄;S₅)g.

4. Higher Classes: n 4

Remembering that n < N, higher classes n of $E_{G}^{(n)}()$ only make sense for system s such that N n + 1 subsystem s. The higher a class n the greater the number of G's necessary for the computation of $E_{G}^{(n)}()$. This is a satisfactory property we should expect from a useful multipartite entanglement measure since as we increase the number of partitions of a system we increase the way it may be entangled [7, 8].

If we employ the de nition of LE for n subsystem sout of a total of N ,

we can write Eqs. (2) and (1) respectively as

In Eq. (14) the single pair of brackets h i represents the averaging over all possible con gurations of n subsystem s in which subsystem S_{j+i_k} is i_k lattice sites apart from S_j . Here 1 < k < n 1. Finally, the double brackets hh ii is the average of the linear entropy of n subsystem s over all possible combinations (distances) in which they can be arranged.

We should mention at this point that $E_G^{(n)}$ and G are more general than the block entanglem ent ($E_B^{(n)}$) as presented in Refs. [16, 17, 19]. By block entanglem ent it is understood that we divide a set of N subsystems $fS_1;S_2;\ldots;S_N$ g in two blocks, $A_n = fS_1;S_2;\ldots;S_n$ g and B_N $_n = fS_{n+1};S_{n+2};\ldots;S_N$ g, and calculate the linear or von N eum ann entropy between blocks A_n and B_N $_n$. In the language of generalized global entanglem ment, block entanglem ent for a translational symmetric state is simply

which is only one of the many G's we can de ne. The main di erence between these two measures lies in the fact that we allow all possible combinations of n subsystem s out of N to represent a possible block'. Contrarily to block entanglement, here there exists no restriction onto the subsystem s belonging to a given block' to be nearest neighbors. They lie anywhere in the system's domain.

C. Particular Properties for Qubits

A lthough Eqs. (1) and (2) are defined for Hilbert spaces of arbitrary dimensions we now focus on some properties of $E_{\rm G}^{(n)}$ and G for qubits. There are two main reasons for studying qubits in detail. Firstly, they are recognized as a key concept for quantum information theory

and secondly, the simplest multipartite states are constructed employing qubits.

Let = j ih j be the density matrix of a N qubit system and $_{j} = Tr_{\overline{j}}$ () the reduced density matrix of subsystem S_{j} , which is obtained by tracing out all subsystem s but S_{j} . A general one qubit density matrix can be written as

where the coe cients are given by

Here $_{j}$ is the Pauli matrix acting on the site j, = 0;x;y;z, where 0 is the identity matrix of dimension two, and p_{j} is real. Since $_{j}$ is norm alized $p_{0} = 1$. Using Eqs. (16) and (17) we obtain

This last result im plies that Eq. (3) can be written as

O ne interesting situation occurs when we have translational invariant states . (The Ising model ground state for example.) In this scenario $h_i i = h_j i$ for any i and j. Therefore, Eq. (19) becomes

which is related to the total magnetization M of the system, $M = \frac{1}{j} = N (h_j^x \dot{i}^2 + h_j^y \dot{i}^2 + h_j^z \dot{i}^2)$, by $E_G^{(1)} = 1 = \frac{M \dot{j}}{N}$.

By tracing out all subsystem s but S_i and S_j we obtain the two qubit reduced density matrix

Eq. (21) is the most general way to represent a two-qubit state and together with Eq. (22) im ply that

Rem ark that in Eq. (23) the trace of $^2_{ij}$ is the sum of all one and two-point correlation functions. Moreover, since E_{G}^{2} and $G(2;i_{1})$ depend on Eq. (23), we nd in these entanglement measures both diagonal and o -diagonal correlation functions.

A gain it is instructive to study translational sym m etric states in which $p_{ij} = p_{ij}$ for any and . Using this assumption in Eq. (7) we get

Note that the previous form ula is not valid for N 3. For N = 2 only $E_{G}^{(1)}$ is de ned and for N = 3 we have d = m infdim S_A ; dim $\overline{S}_A g = 2$ and not d = 4, the value of d for all N 4. Now if we compare G (2; i₁) with the concurrence (a bipartite entanglem ent monotone), as we do for the Ising model in Sec. IIIB, we will note that while the concurrence does not depend on any one-point and on any o -diagonal two-point correlation function [20, 21] G (2; i₁) does.

D. W hy DoWeNeedHigherClasses?

The simple fact that di erent types of entanglem ent appear as we increase the number of qubits (or equivalently the number of subsystem s) [7, 8] indicates that the various classes here introduced m ay be useful to classify and quantify the m any facets of M E. For example, the rst class $E_{\rm G}^{(1)}$ does not su ce to unequivocally quantify M ES.A lthough it ism axim alfor G reenberger-H orme-Zeilinger (G H Z) states [22] it is also m axim al for a state which is not a M ES, as we now demonstrate. Let us com pute $E_{\rm G}^{(1)}$ for three paradigm atic m ultipartite states. The rst one is the G H Z state:

where $[0i^{N}]$ and $[1i^{N}]$ represent, respectively, N tensor products of the states [0i] and [1i]. The GHZ state is a genuine MES since by measuring only one of the qubits in the standard basis we know exactly the results of the other N 1 qubits. Furthermore, tracing out any one of the qubits we obtain a separable state. A direct calculation gives $E_{G}^{(1)}$ (GHZ_N) = 1.

The second state we shall analyze is given by a tensorproduct of N = 2 E instein-Podolsky-Rosen (EPR) Bell states [12]:

where $j^{+}i = (1 = 2)(j0i + j1i)$. For de niteness, we chose one speci c Bell state. However, the results here derived are quite general and valid for any N =2 tensor products of Bell states. This state is obviously not a genuine MES.Only the pairs of qubits (2j 1;2j), where j = 1;2;...;N, are entangled. Nevertheless, we again obtain $E_{G}^{(1)}$ (EPR_N) = 1. This last result illustrates that

 $E_{\rm G}^{\,(1)}$ being maximalis not a su cient condition to detect genuine MES.Note that $E_{\rm G}^{\,(1)}$ for both the GHZ_N and EPR_N states are independent of the number of qubits N in the chain.

The last state we consider is the $\mathbb W$ state [7]. It is deneed as,

The state $j00_{j} 1_{j} 000i$ represents a N qubit state in which the j-th qubit is jli and all the others are jli. As shown in Ref. [11], $E_{G}^{(1)}(W_{N}) = 4(N_{j} - 1) = N^{2}$. Note that $E_{G}^{(1)}$ depends on N and at the therm odynamic limit (N ! 1) we have $E_{G}^{(1)}(W_{N}) = 0$. For three qubits, the W state was shown [7] to be a genuine MES not convertible via LOCC to a GHZ state.

The computation of E $_{\rm G}^{(2)}$ and G (2;1) give di erent values for each of those states. Remark that for N = 2 the previous functions are not de ned and that for N = 3 E $_{\rm G}^{(2)}$ = G (2;1) = 1. Table I shows E $_{\rm G}^{(2)}$ and G (2;1) for the states G H Z $_{\rm N}$; E P R $_{\rm N}$, and W $_{\rm N}$. We should mention that due to translational symmetry, G (2;1) and E $_{\rm G}^{(2)}$ are identical for the states G H Z $_{\rm N}$ and W $_{\rm N}$. It is interesting

Table I: The third and fourth columns give G (2;1) and E $_{\rm G}^{(2)}$ for the three states listed in the rst column when N > 3. The second column gives E $_{\rm G}^{(1)}$ for all N . Contrary to E $_{\rm G}^{(1)}$, we see that G (2;1) and E $_{\rm G}^{(2)}$ distinguish the three states from each other.




Figure 3: (Color online) Here we show G (2;1) as a function of the number of qubits N for the states GH Z_N , EPR_N and W_N . Note that only when N = 4 we have two states with the same entanglement. Furthermore, for 4 N 8, W_N is more entangled than EPR_N. This ordering is changed for N 9.




Figure 4: (C olor online) Here we show $E_{G}^{(2)}$ as a function of N. Again, only when N = 4 we have two states with the same entanglement. Moreover, for N 4, EPR_N is the most entangled state.

to note that depending on the value of N, the states are di erently classi ed through G (2;1). Fig. 3 illustrates the behavior of G (2;1) for those three paradigm atic state as we vary N. A similar behavior is observed for E $_{\rm G}^{(2)}$ (Fig. 4). In this case, how ever, E P R_N is the most entangled state for long chains. The reason for this lies in the de nition of E $_{\rm G}^{(2)}$. For the E P R_N state, G (2;1) = 1 for any 1 2. Therefore, since E $_{\rm G}^{(2)}$ is obtained averaging over all G (2;1), for long chains G (2;1) does not contribute m uch and E $_{\rm G}^{(2)}$! 1.

W e also calculated the values of $E_{g}^{(1)}$, $E_{g}^{(2)}$, and G (2;1) at the therm odynam ic lim it. See Tab. II. Thus even at the therm odynam ic lim it $E_{g}^{(2)}$ and G (2;1) distinguish the three states. The ordering of the states, nevertheless, is di erent. Again this is related to the de nition of $E_{g}^{(2)}$

and is due to the contribution of G (2;1), 1 $\,$ 2, in the calculation of E $_{\rm G}^{\,(2)}$ (E P R $_{\rm N}$).

Besides a measure of multipartite entanglement being able to distinguish di erent kinds of states it should not di erentiate states that essentially contain the sam e am ount of entanglement. For example, let us consider the follow ing state,

This state describes a pair of EPR states where subsystem S_1 is entangled with S_2 and S_3 is entangled with S_4 . Consider now the state de ned as [23]




Figure 5: Pictorial representations of the states (a) ${\rm EPR}_2$ and (b) g_1 .

which is also a pair of EPR states. This time, however, subsystem S_1 is entangled with S_3 and subsystem S_2 is entangled with S_4 (See Fig. 5). Although di erent

pairs of subsystems are entangled in these two di erent states, their amount of entanglement is the same: there are two EPR states in both cases. This fact is captured by the entanglement measures here introduced, i.e. $E_{G}^{(n)}$ (EPR₂) = $E_{G}^{(n)}$ (g₁). The block entanglement, nevertheless, does not always give the same value for the two states above (see Tab. III). This example illustrates

that the block entanglem ent, as its nam e suggests, quanti es only the entanglem ent of partition A (sites 1 and 2) with partition B (sites 3 and 4). The generalized global entanglem ent $E_{g}^{(n)}$, how ever, quanti es the am ount of entanglem ent of a state independently on the way it is distributed am ong the subsystem s. W e can go further and show the importance of using higher classes $E_G^{(n)}$ to correctly quantify the entanglem ent of a multipartite state no matter how the entanglem ent is distributed among the subsystem s. For example, consider the state

where the integer M 1 represents how m any tensor products of $G H Z_N$ we have. Restricting ourselves to N = 3 and M = 2 we get,

Here, subsystem sS_1 , S_2 , and S_3 form a genuine MES and S_4 , S_5 , and S_6 another one. For this state $E_B^{(3)}$ (GHZ₃²) = 0. If we interchange the second qubit (S_2) with the ffh one (S_5) we obtain the following state:




Figure 6: (Color online) Pictorial representations of the states (a) GH Z_3^2 and (b) ZH G_3^2 .

Now subsystem s S_1 , S_3 , and S_5 form a genuine MES and S_2 , S_4 , and S_6 another one (See Fig. 6). Those

two states have the same am ount of entanglem ent, i. e. two GHZ states. However, the computation of the block entanglem ent gives $E_B^{(3)}$ (ZHG $_3^2$) = 6=7 for $E_B^{(3)}$ (GHZ $_3^2$). Had we employed the generalized global entanglem ent we would have obtained $E_G^{(3)}$ (GHZ $_3^2$) = $E_G^{(3)}$ (ZHG $_3^2$) instead. In general we have $E_B^{(n)}$ (GHZ $_n^2$) for $E_B^{(n)}$ (ZHG $_n^2$) and $E_G^{(n)}$ (GHZ $_n^2$) = $E_G^{(n)}$ (ZHG $_n^2$). Therefore, if we want to study the am ount of entanglem ent of a multipartite state, independently on how it is distributed am ong the subsystem s, we should employ $E_G^{(n)}$ instead of $E_B^{(n)}$, since the later furnishes only the am ount of entanglem ent between a particular two block-partition in which the system can be divided.

III. U SEFULNESS OF THE GENERALIZED GLOBAL ENTANGLEMENT

In this section we present two examples in which we explore the ability of $E_{G}^{(n)}$ and the auxiliary measure $G(n;i_{1};i_{2};:::;i_{n-1})$ to quantify multipartite entanglement. The rst example deals with a nite chain of four qubits. We show that $E_{G}^{(2)}$ together with G (2;1) allow us to correctly identify MES. Moreover, comparing the values of G (2;i_{1}) for all the MES here presented we are led to a practical de nition of what is a genuine MES. In the second example we investigate the entanglement properties of the Ising model ground state. We show that $E_{G}^{(2)}$ and G (2;i_{1}) are maximal at the critical point and we analyze what correlation functions are responsible for this behavior of the generalized global entanglement. The results herein presented suggest that the long range correlations in the critical point for the Ising model are related to genuine MES.

A. Finite Chains

Let us now focus on the sim plest non-trivial spin-1/2 chain, i. e. states with N = 4 qubits, by studying the entanglem ent properties of four genuine MES [24, 25]. The rst one [24] is the fam ous four qubit GHZ state [22],

Q ualitative and quantitative features of this state were already discussed in Sec. IID. A direct calculation gives $E_{G}^{(1)}(_{1}) = 1; E_{G}^{(2)}(_{1}) = G(2; i_{1})(_{1}) = 2=3;$ where $i_{1} = 1; 2; 3$. The second state [24] is written as,

Calculating its rst and second order generalized global entanglement we obtain $E_{G}^{(1)}(_{2}) = 1; E_{G}^{(2)}(_{2}) = G(2; i_{1})(_{2}) = 8=9$: Note that as well as j₁i this state is a translational symmetric state. Moreover, $G(2; i_{1})(_{2}) = G(2; i_{1})(_{1})$. This last result will turn out to be very useful in constructing an operational definition of MES. The third state [24] is given as,

Since this state is not translational sym m etric, G (2; i_1) are not all equal. A fler a straightforward calculation we obtain $E_G^{(1)}(_3) = 1; E_G^{(2)}(_3) = 25=27; G(2; 1)(_3) = 7=9; G(2; 2)(_3) = G(2; 3)(_3) = 1: A gain we should note that G (2; <math>i_1$)(_3) G (2; i_1)(_1).

These three states have in common a few remarkable properties [24]: (a) The local density operator describing each qubit is the maxim ally mixed state $(1=2)I_2$, where I_2 is the 2 2 identity matrix, thus explaining why $E_{g}^{(1)} = 1$ for all of them. (b) The two- and three-qubits reduced operators do not have any k-tangle [26], k = 2;3. This emphasizes that they all are genuine MES, i. e. there is no pairwise or triplewise entanglement. (c) They cannot be transformed into one another by LOCC.

W e shall consider a fourth state,

recently introduced and extensively studied in R ef. [25]. The main feature of this state lies in its usefulness to teleport an arbitrary two-qubit state. Employing this task can be accomplished either from subsystems S_1 and S_2 to S_3 and S_4 or from S_1 and S_3 to S_2 and S_4 . The usual channel (two Bell states) used to teleport an arbitrary two-qubit state [23, 27] can teleport two qubits only from a specic location to another one: from S_1 and S_2 to S_3 and S_4 for example. In addition state j i has a hybrid behavior in the sense that it resem bles both the GHZ and W states [25]. Tracing out any one of the qubits the remaining reduced density matrix has maxim alentropy, a characteristic of the GHZ state. However, has a non-zero negativity [28] between one qubit and the other two [25], a property of the W state. By calculating the generalized global entanglem ent we obtain $E_{G}^{(1)}$ () = 1; $E_{G}^{(2)}$ () = 23=27;G (2;1) () = 8=9;G (2;2) () = 1;G (2;3) () = 2=3:A gain we see that for all i_1 we have G (2; i_1)() G (2; i_1)(1).

W e have grouped in Tab. IV the entanglem ent calculated for the previous four states. It is clear then that

 $E_{G}^{(1)}$ cannot be considered as the last word concerning the quanti cation and classi cation of MES.A glim pse of the rst column in Tab. IV shows that all the ve states listed have $E_{G}^{(1)} = 1$, even the EPR₂ state, an obvious non-genuine MES.Therefore, since $E_{G}^{(1)} = 1$ is not useful to classify di erent genuine MES or to correctly identify them we are compelled to go further and study the higher classes of the generalized global entanglem ent in order to achieve such a goal. Turning our attention to $E_{G}^{(2)}$ we see that it is di erent for all the ve states listed in Tab. IV, in plying that $E_{G}^{(2)}$ can distinguish am ong the ve states. According to $E_{G}^{(2)}$ the most entangled state is ₃, which was shown to be a genuine MES [24].

M oreover, important clues for the understanding of what kind of entanglem ent is present in a given multipartite state are also available in G (2; i_1), $i_1 = 1$;2;3. A ctually, these auxiliary entanglem ent m easures give us a more detailed view of the types of entanglement a state has than $E_{G}^{(2)}$ since the latter is an average over all G (2; i1). For example, if we relied only on $E_{G}^{(2)}$ to decide whether or not a state is a genuine MES we would arrive at a wrong answer. This point is clearly dem onstrated if we compare $E_{G}^{(2)}$ for the states EPR_{2} and 1 (GHZ₄). Looking at Tab. IV we see that $E_{G}^{(2)}$ (EPR₂) > $E_{G}^{(2)}$ (1), where EPR₂ is not a genuine MES. The averaging process, as explained in Sec. IID, is responsible for this relatively high value of $E_{G}^{(2)}$ for the state E P R $_{\rm 2}$. R em ark that for translational sym m etric states $E_{G}^{(2)}$ and G (2; i_{1}) are equivalent to detect a genuine MES. However, if we analyze all the G (2; i1) terms we are able to detect a common characteristic shared only by the genuine MES: for and all i we have $G(2;i_1)(i_1;)$ $G(2;i_1)(GHZ_4) = 2=3$. This suggests the following operational de nition of a genuine MES:

De nition 1 Let ji be a pure state describing four qubits. If G (1) = 1 and G (2; i_1) () G (2; i_1) (G H Z₄) = 2=3, i_1 = 1;2;3, then ji is a genuine M ES.

Besides being practical, D e nition 1 has a sim ple physical interpretation if we remember that $E_{G}^{(2)}$ and G (2; i₁) are constructed in terms of the linear entropy of any two qubits with the rest of the chain. Noticing that the linear entropy is related to the purities of the two-qubit reduced density matrices, the de nition above establishes an upper bound for all the two-qubit purities of a MES. In other words, if all the two-qubit purities are below this upper bound the N qubit state can be considered a genuine MES [29]. Furtherm ore, this upper bound was chosen to be that of the GHZ state, which is undoubtedly a genuine MES.

Remark also that since G $(2; i_1)$ is a monotonically decreasing function of the purities, an upper bound for the purities implies a lower bound for the value of G $(2; i_1)$ (cf. De nition 1). We can easily generalize this de nition to N qubits if we express it in terms of all n-qubit purities (n < N):

De nition 2 A pure state of N qubits j i is a genuine MES if

where

Note that as we increase the size of the chain we need to calculate more and more purities. Take for instance the state $G H Z_3^2$ given by Eq. (31). A direct calculation gives Tr($_{j_1}^2$) = 1=2 for 1 jı 6, Tr($^{2}_{3:4}$) = 1=4, and $Tr(\frac{2}{j_1, j_2}) = 1=2$ for all 1 j1 < j2 6 but $(j_1; j_2) = (3; 4)$. Hence, if we restricted De nition 2 just to the one-and two-qubits reduced density matrices we would erroneously conclude that GH ${\rm Z}_3^2$ is a genuine MES.Extending, however, the de nition to all possible reduced density matrices we can detect that G H Z_3^2 is not a genuine MES since $Tr(\frac{2}{1;2;3}) = 1$, a clear violation of De nition 2.

W e end this section remarking that D e nition 2 is completely de ned only for nite chains. For in nite chains (N ! 1) one would have to calculate all G (n; i₁; i₂) (and G (n; i₁; i₂; :::; i_{n 1})) to completely characterize a genuine n-partite entangled state. Finally, the previous de nition does not imply that all genuine MES must have Tr $_{j}^{2}$ 1=2, Tr $_{j/j+i_{1}}^{2}$ 1=2, :::, Tr $_{j/j+i_{1}}^{2}$ 1=2. It is thus only a su cient condition for a state to be a genuine MES.

B. In nite Chains

Currently there is an increasing interest on the relation between entanglem ent and Quantum Phase Transitions occurring in in nite spin chains [16, 17, 30, 31, 35, 36, 37]). For spin chains presenting a second order quantum phase transition (QPT) the correlation length goes to in nity at the critical point, thus suggesting interesting entanglem ent properties for the ground state of such models. Particularly interesting is the 1D Ising m odel [33], which is translationally invariant and presents a ferrom agnetic-param agnetic QPT.As we have seen in Sec. II, the generalized global entanglem ent is easily evaluated for a system with translational symmetry. In this perspective, for the 1D Ising model ground state, here we compute G (1), which is shown to behave similarly to the von Neumann entropy calculated in Ref. [30], and G $(2; i_1)$ for som e values of i_1 .

The 1D Ising model with a transverse magnetic eld is given by the Hamiltonian

This model has a symmetry under a global rotation of 180 over the z axis (^x ! ^x) which dem ands that $h^{x}i = 0$. However as we decrease the magnetic eld, increasing , this symmetry is spontaneously broken (in the therm odynam ic lim it) and we can have a ferrom agnetic phase with h xi f 0. This phase transition occurs at the critical point = $_{c}$ = 1 where the gap vanishes and the correlation length goes to in nity. This transition is named quantum phase transition since it takes place at zero tem perature and has many of the characteristics of a second order therm odynam ic phase transition: phase transitions where the second derivative of the free energy diverges or is not continuous. It is worth noting that in the therm odynam ic lim it for > 1 the ground state is two-fold degenerated. These two states have opposite magnetization. Here we will use the broken symmetric state for > 1 and not a superposition of the two degenerated states, which is also a ground state but unstable. For a more detailed discussion see R efs. [30, 32].

Now, let us explain how we can evaluate G (1) and G (2; i_1) for the one dimensional Ising model. We need, then, the reduced density matrix of two spins, which is a 4 matrix and can be written as

The coe cients are given by

and, as usual, T r_{ij} is the partial trace over all degrees of freedom except the spins at sites i and j, i is the Pauli m atrix acting on the site i, ; = 0;x;y;z where ⁰ is the identity m atrix, and the coe cients p_{ij} are real.

Eq. (39) shows that all we need are the two-point spin correlation functions which, in principle, are at most 16. This number can be reduced using the symmetries of the H am iltonian (37). The translational symmetry implies that $_{ij}$ depends only on the distance ji $_{jj}$ = n between the spins so that we have p_{ij} = p_n and p_n = p_n . All these symmetries imply that the only non-zero correlation functions are: p_n , p^{0x} = p^{x0} = p^x , p^{0z} = p^{z0} = p^z , and p_n^{xz} = p_n^{zx} .

First, let us show the diagonal correlation functions and the magnetizations, which were already calculated in Ref. [33]. For periodic boundary conditions and an in nite chain we have:

We are now left with the evaluation $ofp_n^{xz} = p_n^{zx}$. This calculation was made in Ref. [34] where the authors obtained the o-diagonal, time and temperature dependent, spin correlation functions. In the paramagnetic phase (1) the ground state has the same symmetries of the Ham iltonian which leads to $p_n^{xz} = 0$. For the ferrom agnetic phase (>1) an explicit evaluation leaves us with an expression in term s of intricate com plex integrals which are not straightforward to com pute. For this reason we will use bounds for this o-diagonal correlation function.




Figure 7: (Coloronline) Bounds for p_n^{xz} obtained by imposing the positivity of the eigenvalues of the reduced density operator $_{ij}$.

We can obtain an upper and low er bound for this correlation function by imposing the positivity of the eigenvalues of the reduced density operator $_{ij}$. For the Ising m odel these bounds result to be very tight as we can see in Fig. 7, and depend on n. In Ref. [10] some of the results here discussed were presented using zero as a low er bound. It is worth m entioning that since both G (1) and G (2; i₁) are decreasing functions of the square of the correlation functions, a low er (upper) bound for the latter im plies an upper (low er) bound for the form er.

Since we have all the correlation functions at hand we proceed with the calculations of G (1) and G (2; i_1). Rem mem bering that for the Ising model $p^y = 0 \text{ Eq.}$ (20) can be written as

G (1) = 1
$$(p^x)^2 (p^z)^2$$

As we have already shown G (1) is the mean linear entropy of one spin which, due to translational symmetry, is equal to the linear entropy of any spin of the chain. A

sim ilar related analysis was done by O shome and N ielsen [30] for the von N eum ann entropy instead of the linear entropy. A s well as G (1), see Fig. 9, the von N eum ann entropy is maximal at the critical point [30]. At that time O shome and N ielsen did not give m uch importance to this result since they suspected that the von N eum ann entropy of one spin with the rest of the chain does not m easure genuine M E S. How ever, for a translational sym - m etric state it is a reasonable good indication of genuine M E as we have shown in previous sections. (W e have explicitly studied the linear entropy but the sam e results apply to the von N eum ann entropy. W e have adopted the form erm ainly due to its sim plicity and relation to the M eyer and W allach global entanglem ent [11]).




Figure 8: (Color online) M agnetizations $p^x = h^x i$ (black/dashed line) and $p^z = h^z i$ (red/solid line) as a function of .

Analyzing Eq. (47) we can understand why G (1) is maximal at the critical point (= 1). As we explain in what follows, it is h ^xi the main responsible for this behavior of G (1). For 1 we have h ^xi = 0. A fler the critical point, however, h ^xi \in 0. Moreover, for > 1 Eq. (44) tells us that h ^xi is a monotonic increasing function of and that h ^xi ! 1 as ! 1 . Therefore, since h ^zi is negligible for large values of and h ^xi 1 (See Fig. 8) we must have G (1) approaching zero after the critical point.

W e now analyze G $(2; i_1)$. U sing the Ising m odel sym - m etries Eq. (24) reads,

$$G (2;n) = 1 \quad \frac{1}{3} \quad 2 (p^{x})^{2} + 2 (p^{z})^{2} + 2 (p_{n}^{xz})^{2} + (p_{n}^{xx})^{2} + (p_{n}^{xx})^{2} + (p_{n}^{yy})^{2} + (p_{n}^{zz})^{2} : \quad (48)$$




Figure 9: (Color online) G (1) (red/dashed line) and the bounds for G (2,1) (black/solid lines). Note that they are maximum at the critical point.




Figure 10: (Color online) Two point correlation functions: p_1^{xx} (red/solid), p_1^{yy} (black/long-dashed), and p_1^{zz} (blue/short-dashed).

W ith Eq. (48) we can evaluate G (2;n) for any value of n. In Fig. 9 we have plotted G (1) and the bonds for G (2;1). We can see that both G (1) and G (2;1) are maximum at the critical point = 1. Notice that the bounds are very tight and can barely be distinguished just in a small region for & 1. Furtherm ore, G (2;1) is always smaller than G (1), contrary to what was obtained using zero as a lower bound [10]. As well as in the case of G (1) we can see that the reason for G (2;1) being maximal at the critical point is due to the behavior of h[×] i since it is the only function in Eq. (48) that does not change sm oothly as we cross the critical point (see Fig. 10 for the other correlation functions).




Figure 11: (Color online) G (2;n) for n = 1;7, and 15. From bottom to top n = 1;7, and 15

We have also plotted G (2;n) for n = 1, 7, and 15 (Fig. 11). We can observe that all of them are maximum at the critical point and increase as a function of

n (In Fig. 11 we have plotted only the upper bounds since the lower bounds produce very similar curves). We also note that G (2;7) is very near G (2;15) showing that G (2;n) rapidly saturates to a xed value. At the critical point we have $\lim_{n! 1} G(2;n) = 0.675$. This behavior for G (2;n) points in the direction of the existence of multipartite entanglement at the critical point since any two spins are entangled with the rest of the chain and this entanglement increases with the distance between them. It is also interesting to confront this result with the fact that two spins that are separated by two or more sites are not entangled since their concurrences are zero [31]. The behavior of the concurrence (C (n)) can also be un-

derstood if we note that it can be expressed in terms of the one and two point correlation functions. While for the non-symmetric (ferrom agnetic) state the analytical expression for the concurrence is cumbersome for the symmetric one it is very simple. Fortunately, for the Ising model it was show that the concurrence does not change upon symmetry break [20, 21] and it turns out to be




Figure 12: Concurrence for nearest neighbors.

From this expression we can see that the concurrence (Fig. 12) does not depend on either the o-diagonal correlation function p_n^{XZ} or on the one point correlation functions (m agnetizations). This is an interesting feature and helps us to understand why the concurrence is not m aximum at the critical point.

IV. CONCLUSION

A N-partite quantum system may be entangled in many distinct ways. To characterize and to de ne a good measure of entanglem ent for those system s is a hard problem. The only simple alternative, valid whenever the joint N-system state is pure, is to split the system into two partitions and compute the entanglem ent in that way. This bipartition could be constructed in many different form s and thus give distinct am ount of entanglem ent. O ne possible approach is to divide the system into

two blocks of L and N L subsystems and to compute the block entanglem ent [16, 17] between the two blocks. However one could think of a situation where all of the subsystems in the block L are entangled with each other, as well as the subsystem sofblock N L, but without any entanglem ent between the two blocks. For this situation the block entanglem ent would quantify a zero amount of entanglem ent, which is clearly not true. A valid bipartition approach, which would be able to quantify the entanglem ent for all kinds of bipartition and then to average these to give the total amount of entanglem ent in the system.

In this article we have form alized an operationalm ultipartite entanglem ent m easure, the generalized global entanglement ($E_{G}^{(n)}$), rstly introduced in Ref. [10]. For $n = 1, E_{c}^{(n)}$ recovers the M eyer and W allach global entanglem ent m easure [11]. However for n > 1 E $_{\rm c}^{\rm (n)}$ together with the auxiliary function G $(n; i_1; i_2; \dots; i_{n-1})$ quantify entanglement in the many distinct forms it is distributed in a multipartite system . We have shown that for som e multipartite systems the original global entanglem ent is not able to properly classify and identify multipartite entanglem ent in a unequivocally way, whereas higher classes (n > 1) of E $_{\rm G}^{\rm (n)}$ are. A genuine k-partite entangled state is the one that cannot be written as a product j i_1 j $i_{(k \ l)}$ of state vectors for any l < k, m eaning that there is no other reduced pure state out of the joint k-system s state. To com pletely quantify and classify the multipartite entanglem ent in this kind of state one would have to compute all the $E_{G}^{(n)}$ classes up to n = k 1. How ever we have observed that low er classes of $E_{c}^{(n)}$, such as E $_{\rm G}^{\,\,(1)}$ and E $_{\rm G}^{\,\,(2)}$, are su cient to detect multipartite entanglem ent. The computation of higher orders of $E_{c}^{(n)}$ and of the auxiliary functions G $(n; i_1; i_2; \dots; i_{n-1})$ is necessarily required only to distinguish and classify the ways the system is entangled. A though the calculation of all those higher orders m ay be operationally laborious it is straightforward to perform for nite N systems. Thus we have demonstrated for a variety of genuine multipartite entangled qubit states [24, 25] that $E_{\rm G}^{(2)}$ and G (2; i₁) are able to properly identify and distinguish them whereas $E_{\rm G}^{(1)}$ fails to do so. Inspired by the common characteristic presented by allG (2; i₁) for those paradigm atic states we then discussed an operational de nition of a genuine multipartite entangled state [24, 25].

Finite multipartite systems are interesting for fundam ental discussions on the de nition of multipartite entanglement. In nite systems on the other hand are interesting sincemultipartite entanglementmay be relevant to improve our knowledge of quantum phase transition processes occurring in the therm odynamical limit. We have demonstrated that for the 1D Ising model in a transverse magnetic eld both $E_{\rm G}^{(2)}$ and $G(2;i_1)$ are maximal at the quantum critical point, suggesting thus a favorable picture for the occurrence of a genuine multipartite entangled state. Moreover, the behavior of $G(2;i_1)$ and thus $E_{\rm G}^{(2)}$ can be easily understood as contributions of the one and two-point correlation functions giving us a physical picture for the behavior of the multipartite entanglement during the phase transition process.

In conclusion the generalized global entanglem ent we presented has the following important features: (1) It is operationally easy to be computed, avoiding any minim ization process over a set of quantum states; (2) It has a clear physical meaning, being for each class $E_{G}^{(n)}$ the averaged n-partition purity; (3) It is able to order distinct kinds ofmultipartite entangled states whereas other common measures fail to do so; (4) It is able to detect second order quantum phase transitions, being maximal at the critical point. (5) Finally, for two-level system s it is given in term s of correlation functions, and thus easily com puted for a variety of available m odels. W e hope that this measure may contribute for both the understanding of entanglem ent in multipartite systems and for the understanding of the relevance of entanglem ent in quantum phase transitions.
