M any-body quantum dynam ics of polarisation squeezing in optical bre

We report new experiments that test quantum dynamical predictions of polarization squeezing for ultrashort photonic pulses in a birefringent bre, including all relevant dissipative e ects. This exponentially complex many-body problem is solved by means of a stochastic phase-space method. The squeezing is calculated and compared to experimental data, resulting in excellent quantitative agreement. From the simulations, we identify the physical limits to quantum noise reduction in optical bres. The research represents a signi cant experimental test of rst-principles time-dom ain quantum dynamics in a one-dimensional interacting Bose gas coupled to dissipative reservoirs.

The nonlinear optical response of standard communications bre provides a straightforward and robust method [1] for squeezing the quantum noise always present in laser light to below the vacuum noise level. This feature allows us to design quantum dynamical experiments [2, 3] operating in a very nonclassical regime where highly entangled states can be readily produced, even in many-body regimes involving 10⁸ interacting particles. The squeezing is sensitive to many-body photonphoton interactions, as well as to additional dissipative and therm ale ects [4]. Such complications have a ected all prior experiments and have so far prevented quantitative agreem ent between theory and experiment.

Here we report on quantitative comparisons of rstprinciples simulations with experimental measurements on the propagation of quantum states in optical ber. The excellent agreement, over a wide range of initial conditions, is unprecedented for direct predictions from abinitio treatments of many-body quantum time-evolution. The approach we use has potential applications in many other areas of science, especially to dynamical experiments with ultra-cold atom s and nanotechnology.

Photons in a nonlinear bre are an implementation of the fam ous one-dim ensional attractive B ose gas m odel[5] in quantum eld theory. Fibre squeezing experiments thus provide a substantial opportunity to carry out an experim ental test of the predictions of many-body quantum mechanics for dynamical time-evolution. Such a test requires the sam e ingredients as did G alileo's fam ous tests of classical dynam ics using an inclined plane [6]: one needs a known initial condition, a well-de ned cause of dynam ical evolution, and accurate m easurem ents. All of these essential features are present in our experiments. The initial condition is a coherent [7] photonic state provided by a well-stabilized pulsed laser. The Kerr nonlinearity in silica bre corresponds to a localized (deltafunction) interaction between the photons[8]. Quantum lim ited phase-sensitive measurements have been developed in optics that are able to detect quantum uctuations at well below the vacuum noise level[9, 10].

Even though the simplest model of a 1D interacting Bose gas has exactly soluble energy eigenvalues, the many-body initial value problem still remains intractably complex. Expanding the coherent initial state directly in terms of more than 10^{100} relevant eigenstates (more than the number of particles in the universe) is simply not practical. For such reasons, Feynm an suggested [11] that the calculation of dynamical quantum time-evolution would be impossible without special quantum computing' hardware, which is not available at present. Even worse, there are additional complications occurring due to coupling to phonons in the silica bre medium.

To deal with the exponential quantum complexity in this dissipative system, using existing computers, we em ploy quantum phase-space methods based on the work of W igner[12] and G lauber[7]. W ith modi cations to treat non-classical elds[13], phase-space methods are able to calculate quantum correlations in a dynamical system without recourse to hydrodynam ic approxim ations or linear response theory. They were successfully used for the original prediction of quantum squeezing in optical bres, [14], which was qualitatively veried in several laboratories [1, 15]. Recently, photon-num ber squeezing was simulated [16] and compared with experin ent [17]. However, the cause of squeezing degradation was unclear [18]. By using an improved experimental con guration [3], and including all relevant dissipative e ects in the simulations, we have been able to quantitatively test and verify the phase-space predictions.

P hysically, the K err e ect that generates the squeezing can be viewed as producing an intensity-dependent refractive index, which distorts an initially symmetric phase-space distribution into an ellipse B ecause of energy conservation, how ever, the variance in the am plitude remains constant. Thus the squeezing cannot be detected directly in am plitude or intensity m easurem ents.




Figure 1: Experimental detail for the e-cient generation of polarization squeezed states. Pairs of coherent, 74 fs FW HM sech-shaped laser pulses at 1.5 m are coupled into a birefringent ber. A pre-ber variable delay ensures that the pulses overlap upon exitting the ber. A relative phase shift of $\frac{1}{2}$ is m aintained by means of a piezo-electric crystal in a feedback loop, resulting in circularly or S₃-polarized light. The squeezing measurement is performed by use of a half-wave plate, polarizing beam splitter and two balanced detectors. A lthough the squeezing is broad-band, it is sam pled at a frequency of 17:5 M H z to avoid technical noise.

A lthough laser hom odyne measurements[10] can be used for these phase-sensitive measurements, they require a local oscillator, which is impractical for the high-intensity laser pulses used here. Instead, we employ an interferometric method known as polarization squeezing[3], wherein two multi-photon femptosecond pulses that are initially identical in amplitude propagate along the mutually orthogonal polarization axes x and y of a polarization-maintaining ber. The two output pulses are then combined on a half-wave plate at an angle . For the appropriate phase-space rotation angles = 4, the squeezing or antisqueezing can be detected in the number di erence. Because both pulses undergo sim ilar evolution, most excess therm al noise is common

similar evolution, most excess therm all noise is common to both modes and is thus cancelled. An exception here is any noise induced by birefringent, or depolarizing, effects, which will be unique to each mode. The experimental set-up is illustrated in Fig. 1.

Because the experiment involves ultrashort pulses, we use photon-density operators for each polarisation mode of the optical eld: $b_x(t;z)$ and $b_y(t;z)$ that include a range of spectral components $\mathbf{b}(t;k)$:

where = x;y labels the polarisation, t is time, z is propagation distance and k is wave-number. The wavenum – ber and frequency of the carrier wave are given by k_0 and h_0 . The commutation relations of the eld operators are b (t;z); b_0^{y} (t;z⁰) = (z z⁰) .

To describe the polarisation squeezing, we de ne gen-

eralized Stokes operators:

where L is the bre length and $\overset{\circ}{\mathbb{N}} \circ (z) = \overset{\circ}{\mathbb{R}} dt^{by}(t;z)^{b} \circ (t;z)$. $\overset{\circ}{\mathbb{S}}_{0}$ corresponds to the combined intensity, $\overset{\circ}{\mathbb{S}}_{1}$ gives the number di erence between the x and y modes, and $\overset{\circ}{\mathbb{S}}_{2}$ and $\overset{\circ}{\mathbb{S}}_{3}$ are operators sensitive to the relative phase di erence. In the Stokes measurement after the ber, we measure a given Stokes parameter orthogonal to the bright excitation in S_3. This, the dark $\overset{\circ}{\mathbb{S}}_{1}$ - $\overset{\circ}{\mathbb{S}}_{2}$ plane, is scanned by rotating a halfwave plate to measure: $\overset{\circ}{\mathbb{S}} = \cos()\overset{\circ}{\mathbb{S}}_{1} + \sin()\overset{\circ}{\mathbb{S}}_{2}$: Following from the Stokes operator commutation relations[19], the number di erence is squeezed if the variance of $\overset{\circ}{\mathbb{S}}$ is below, for S_3-polarized light,

To simulate the evolution of the photon density ^b (t;z), we employ a quantum model of a radiation eld propagating along a fused silica bre, including the

 $^{(3)}$ nonlinear responses of the material and the nonresonant coupling to phonons[4, 20]. The phonons act as a reservoir with nite-time correlations (non-Markovian) that generates additional, delayed nonlinearity, as well as spontaneous and therm al noise. Classical, low-frequency phase noise can be neglected, becase it is common to both polarization modes, unless there is a depolarising component. The phonon spectrum is based on the experimentally determined R am an gain for pure fused silica R (!) [21]. Because of the berbirefringence, the two polarization components do not temporally overlap form ost

larization components do not tem porally overlap form ost of the ber length, so we neglect the cross-polarization component of the Ram an gain.

To simplify the theoretical description, we use a propagative frame with rescaled time (t z=v), rescaled propagation distance z=z₀ and dimensionless photonux eld b b $v_{t_0=\overline{n}}$. Here t₀ is the pulse duration, z_0 $t_0^2 = j k^{00} j$ is the dispersion length and $2\overline{n}$ is the photon number in a fundamental sech () soliton pulse. The bre-dependent parameters are pulse velocity v, and dispersion parameter k⁰.

From the multimode Hamiltonian for the full system [4], we obtain Heisenberg equations of motion for the quantum elds. The equations for the phonon eld are integrated to derive quantum Langevin equations for the photon-ux eld

where the nonlinear response function h () includes both the instantaneous electronic response and the R am an re-

sponse determ ined by the gain function R (!) [4, 20, 21]. The correlations of the reservoir elds are

where $n_{\rm th}$ is the temperature-dependent Bose distribution of phonon occupations. The Stokes (! < 0) and anti-Stokes (! > 0) contributions to the Raman noise are included by means of the step function . These equations can easily be modiled to include coupling to gain and absorption reservoirs, but this is unnecessary for the short distances in these experiments.

The exact quantum dynamics can been simulated using the positive-P (+P) phase-space representation [14]. However, for large photon number \overline{n} and short propagation distance L, it is known that the +P method gives squeezing predictions in agreem ent with a truncated W igner phase-space m ethod [22], which allows faster calculations. We have chosen the latter method to reduce computational overheads. This method maps a eld operator to a stochastic eld: b (;)! (;): Stochastic averages involving this eld then correspond to symmetrically ordered correlations of the quantum system. Because of the symmetric-ordering correspondence, quantum e ects enter via vacuum noise. The Kerr e ectmerely ampli esordiminishes this noise in a phasesensitive m anner, w hich m akes the W igner approach ideally suited for squeezing calculations.

Using the W igner mapping, we obtain a Ramanmodi ed stochastic nonlinear Schrodinger equation for the photon ux that is of exactly the same form as Eq. (4) [4, 20]. The correlations of the Raman noise elds

are also of the same form as their operator equivalent Eq. (5), except that the step function is replaced by a constant 1=2. B ecause of the sym m etrically ordered m apping, the Stokes and anti-Stokes contributions to the W igner R am an noise are identical. The initial condition of the stochastic eld is the m ean coherent level plus uctuations that correspond to vacuum noise:




Figure 2: Propagation of (A) E = 4.8 pJ and (B) E = 53.5 pJ pulses, with initial width $t_0 = 74$ fs.

Simulations of the pulse propagation reveal the importance of including the system's multimode nature, which a ect small-amplitude and intense pulses in dierentways. As Fig. 2 shows, the evolution of the amplitude prole of a weak pulse is dominated by dispersion. In contrast, an intense pulse reshapes into a soliton, whose subsequent evolution reveals the elect of the R am an selffrequency shift. The range of input pulse energies in the experiment includes both these extremes.




Figure 3: Phase-space rotation angle versus total input energy E. Squares and diam onds give the experim ental results for the L_1 = 13:4 m and L_2 = 30 m bres, respectively. Continuous (dashed) lines give the simulation results with (without) excess phase noise. Other parameters are t_0 = 74 fs, z_0 = 0:52 m, \overline{n} = 2 $\,10^8$, and $_0$ = 1:51 m.

Fig. 3 gives the phase-space rotation angle at which squeezing is observed at di erent input energies. The simulations and experiments agree very well for the intense pulses, but there is a divergence for weak pulses.

Now classical phase noise has a relatively strong e ect on the weakerpulses, because the antisqueezing produced by the K err e ect is then sm aller and at a greater angle to the phase quadrature. W e therefore include the e ect of excess phase noise by a nonlinear least-squares procedure. A new relative noise variance is calculated from

where K (E) are the angles for K err squeezing with input energy E, and where $_{s}$ (E), $_{a}$ (E) and $_{p}$ (E) are the relative variances of the K err squeezing, K err antisqueezing and phase noise. The Kerr variances and angles $_{\rm K}$ (E) are taken from the simulation data, and the phase noise is assumed to depend linearly on pulse energy [24]. The coe cient of the phase noise is determ ined by a nonlinear least-squares t of the angles $_{\rm N}$ (E) that m in in ise the new variance to the measured squeezing angles. The result gives an excellent t to the experim ental data, even though there is only one parameter for each bre length. This parameter was larger for the longer ber length, indicating that phase noise is largely a ber-induced effect, such as depolarizing guided acoustic wave Brillouin scattering (GAW BS). However, there also seems to be a smaller birefringent noise source outside the ber.




Figure 4: Raw antisqueezing (A) and squeezing (B) for $L_1 = 13.4 \text{ m}$ (squares) and $L_2 = 30 \text{ m}$ (diamonds) bers. Error bars on the squeezing data indicate the uncertainty in the noise m easurem ent; for the antisqueezing the error bars were to sm all to be plotted distinctly for the antisqueezing. Solid and dashed lines show the simulation results with additional phase noise for L_1 and L_2 , respectively. D otted lines indicate the sam pling error in the simulation results.

Antisqueezing and squeezing results are shown Fig. 4, for 13.4 m and 30 m of ber, with the excess phase noise

included. The theoretical results for both squeezing and antisqueezing closely m atch the experim ental data, after estim ated linear losses of 24% are taken into account. That the theoretical antisqueezing results m atch the experim ent indicates that the t obtained from the rotation angle accounts for all the excess classical noise. A deterioration of the squeezing is seen at higher intensity due to R am an e ects, especially for longer ber lengths.

A s an indication of the accuracy of the simulations, we predicted from comparisons of the rotation angle and the anti-squeezing curves in theory and in experiment that the 30 m ber should have a 5% larger core diameter than the shorter ber. This was veried by bermeasurements. There is a residual discrepancy in the highly sensitive squeezing measurements for the 30 m case at large pulse energies. This could be due to e ects such as cross-polarization R am an scattering, higher-order dispersion, or initial pulse-shape distortion.

In conclusion, the e ciency of the squeezing experim ents described here m eans that a com prehensive theoretical m odel m ust be form ulated and solved to quantitatively account for all observations. Solving the m odel requires a rst-principles simulation of quantum timeevolution in a many-body system coupled to a non-M arkovian reservoir. We have achieved this by m eans of a W igner phase-space representation, thus obtaining excellent agreem ent between simulation and experiment over a wide range of energies and bre lengths. The sim ulations reveal that R am an e ects limit squeezing at high intensity and for longer bers and that depolarizing phase noise (ie. G AW B S) limits squeezing at low intensity.

The phase-space equations were discretised on a regular grid ('0.2,'0.03) and solved by a split-step Fourier method, with an iterative semi-implicit algorithm for the nonlinear and stochastic terms. The non-Markovian reservoirs were included by explicitly integrating a set of phonon variables at each point in the propagation grid. Physical quantities were calculated by stochastic averages over 10,000 runs.
