# Equilibration of a dissipative quantum oscillator.

#### Abstract

An explicit dem onstration is given of a harm onic oscillator in equilibrium approaching the equilibrium of a corresponding interacting system by coupling it to a them al bath consisting of a continuum of ham onic oscillators.

In the theory of interacting $m$ any-particle system $s$, an intial condition of them al equilibrium for the system w ithout interactions is often im posed as a convenient device, w ith the im plicit assum ption that tim e-evolution via the full H am iltonian will lead to the correct correlation functions. Such \sw itching on" of interactions goes back a long tim e [1, 2], and is also a part ofm ore recent discussions [3, 4, [5]. In one form or another, the assum $p-$ tion is to be found in $m$ ost theories of transport under non-equilibrium conditions [6]. H ow ever, and despite its ubiquity, it is rarely [7] addressed, and som etim es questioned [8]. The straightforw ard and com plete dem onstration $w$ thin a sim ple $m$ odelo ered here $m$ ay therefore be of general interest.

To set the calculation in its general context, consider a system consisting of a single particle \sub-system," a $m$ any-particle \bath," and interactions betw een the two. Let the Ham iltonian for the interacting system be $H$, and let $H_{0}$ be the $H$ am iltonian for the com plete system with the particle-bath interactions om itted. N ow consider tw $\circ$ reduced density $m$ atrices, one describing true (tim e-independent) equilibrium, and a second corresponding to the tim e-evolution of the equilibrium of the uncoupled system and bath. T hese $m$ ay be w ritten as

In these equations, the prim ed quantities refer to eigenvalues of the sub-system position operator $Q_{0}$, Tr indicates a trace over all states of $H$, th is expf H g=Trexpf Hgw th the reciprocaltem perature, and ${ }_{\text {th }}^{0}$ is identically de ned except that the $H$ of Eq.(1) is replaced by $\mathrm{H}_{0}$. The question being posed is whether the quantity de ned in (2) becom es (1) for large tim es.

The m odel that will be treated here is widely used to describe a dissipative quantum oscillator:

B ecause the couplings in Eq.(3) are quadratic in the coordinates $Q_{i}$, where $i$ is 0 or any one of the ks, the problem is form ally solved by an orthogonal norm alm ode transform ation [g] to new canonical variables q ; $p$,

By putting Eq.(5) on a com m on denom inator, and noting that the num erator is then the determ inant whose zeros are the nom alm ode frequencies, one sees that, as a function of the com plex variable $z, g$ has the representation 10]

In w ords, it haspoles on the realaxis at the norm alm ode frequencies, and (interleaved) zeros also on the real axis at the bath frequencies. Furtherm ore, [8, 10, 11]

O n the left, the operators are in the $H$ eisenberg picture corresponding to $H$ and the average is $w$ ith respect to ${ }_{\text {th }}$; on the right, the tim e-independent average is in th . $T$ his latter quantity is easily evaluated using the $m$ ethod based on the D ebye-w aller identity introduced in ref. (11] to obtain

Thus, Eq.(9) is true if the tim e-dependent coe cients of $u^{2} ; v^{2}$; and uv in Eq.(14) approach the corresponding tim e-independent ones in Eq.(10).

The sum sover in Eq.(13) are m ost easily done using the $m$ ethod of refs. [8, 10, 11]. In particular,

The contour surrounds the real axis, where the function $F$ has been assum ed to be regular and zero for ! < 0. In the last form the upper lim it $!_{c}$ is the highest norm alm ode frequency, and the integral has been w ritten as the im aginary part of the forward portion of the contour. $N$ ote that there is no contribution from the poles at $z=k$ because of the zeros in $g(z)$ at these points, evident from Eq.(6). For an am using illustration of the im portance of these zeros, see the nalparagraph.]

Further progress requires a speci cation of the spectrum ofbath oscillators. On general grounds, one would expect that to dam $p$ out oscillations a continuous spectrum is needed 12]. W hen this is the case it ism eaningful to write

But this is exactly what Eq．（15）gives for the rst term on the right hand side ofE q．（10），provided that the band w idth of the norm alm odes，！ c ，is the sam e as that of the bath，$!_{c} . O f$ course，if this condition were not satis ed， the system would not be em bedded in the bath and could not be expected to equilibrate w ith it．

In a sim ilar way，one can show that the other term $s$ in Eq．（14）contain tim e－independent pieces w hich reproduce those in Eq．（10）．

A though there is no tim e dependence whatsoever in these pieces extracted from Eq．（14），it is of course not the case that the rem ainder does not contribute signi cantly at $t=0$ ．In this lim it，because of the sinusoidalfunctions， only $X_{i}^{c}$ survives．$T$ he com pleteness condition obeyed by the orthogonaltransform ation then requires

$m$ aking $A_{0}$ look identical to $A, w$ ith the im portant dif－ ference that the average is in the uncoupled system．

A smentioned below Eq．（20），the tim e－decaying parts of $A_{0}(t)$ com e from the singularities of $=g(!\quad i f)$ ，and thus depend on the speci cs of the bath．It m ay therefore be most instructive to treat a sim ple model．C onsider \ohm ic＂or linear dissipation［7］，in which $J(!)=$ ！for $0<!<!_{c}$ ．In this situation Eqs．（17）and（5）give

$T$ his function has simple poles at the four points
i $=2$ ，where ${ }^{2}={ }_{0}^{2} \quad{ }^{2}=4$ ．It is these poles that con－ tribute to the time dependence of the $i=0$ term $s$ in Eq．（13）and to the parts indicated by the $::: s$ in Eqs．（20） and（21）．For an underdam ped oscillator，all of them thus decay like $\exp (\quad t=2)$ ，show ing in this case that the damping constant determ ines the rate at which equi－ librium is reached．

This com pletes the dem onstration prom ised in the ab－ stract to this paper．

A s an illustration of the im portance of the zeros of $g(z)$ in the evaluation of sum s over norm alm ode frequencies， ponsider the follow ing proof of the com pleteness relation $\mathrm{X}_{\mathrm{k}}^{2}=1: \mathrm{U}$ sing the m ethod outlined in Eqs．（15）and （16）one obtains

$T$ he subtracted term is the residue of the sim ple pole at $z=k$ which rem ains after taking into account the zero at the sam e point in $g(z)$ ．The contour integral can be seen to be zero．The second term can be evaluated by using an identity expressing the invariance of the deter－ $m$ inant of the dynam icalm atrix for the coupled oscillator system，referred to below Eq．（5），under the orthogonal
norm alm ode transform ation,
