Sem iclassical Tunneling of W avepackets with Real Trajectories

Abstract

Sem iclassical approximations for tunneling processes usually involve complex trajectories or complex times. In this paper we use a previously derived approximation involving only real trajectories propagating in real time to describe the scattering of a Gaussian wavepacket by a nite square potential barrier. We show that the approximation describes both tunneling and interferences very accurately in the limit of small Planck's constant. We use these results to estimate the tunneling time of the wavepacket and nd that, for high energies, the barrier slows down the wavepacket but that it speeds it up at energies comparable to the barrier height.

I. IN TRODUCTION

The success of sem iclassical approximations in molecular and atom ic physics or theoretical chemistry is largely due to its capacity to reconcile the advantages of classical physics and quantum mechanics. It manages to retain in portant features which escape the classical methods, such as interference and tunneling, while providing an intuitive approach to quantum mechanical problems whose exact solution could be very di cult to nd. Moreover, the study of sem iclassical limit of quantum mechanics has a theoretical interest of its own, shedding light into the fuzzy boundary between the classical and quantum perspectives.

In this paper we will apply the sem iclassical form alism to study the scattering of a one dimensional wavepacket by a nite potential barrier. In the case of plane waves, the tunneling and rejection coe cients can be easily calculated in the sem iclassical limit, giving the well known W KB expressions [1]. For wavepackets, however, the problem is more complicated and few works have addressed the question from a dynam ical point of view [2, 3, 4]. The time evolution of a general wavefunction with initial condition (x;0) = 0 (x) can be written as

where K (T) = e^{iH T=~} is the evolution operator and H is the (time independent) ham iltonian. The extra integration on the second equality reveals the Feynman propagator $\langle x \not K$ (T) $\dot{y}_i \rangle$, whose sem iclassical limit is known as the Van-Vleck formula [5] (see next section). When the Van-Vleck propagator is inserted in Eq.(1) we obtain a general sem iclassical formula which involves the integration over the 'initial points' x_i :

If this integral is perform ed num erically one obtains very good results, specially as ~ goes to zero. However, doing the integral is more complicated than it might look, because for each x_i one has to compute a full classical trajectory that starts at x_i and ends at x after a time T, which may not be simple task. A lternative methods involving integrals over initial conditions (instead of initial and nal coordinates) in phase space have also been developed and shown to be very accurate [6, 7, 8]. All these approaches sum an in nite number of contributions and hide the important inform ation of what classical trajectories really matter for the process. In a previous paper [9] several further approximations for this integral were derived and applied to a number of problem s such as the free particle, the hard wall, the quartic oscillator and the scattering by an attractive potential. Them ost accurate (and also them ost complicated) of these approximations involves complex trajectories and was instructioned by Heller and collaborators [10, 11]. The least accurate (and the simplest to implement) is known as the Frozen G aussian Approximation (FGA), and was also obtained by Heller [12]. It involves a single classical trajectory starting from the center of the wavepacket. However, other approximations involving real trajectories can be obtained [4, 9, 13]. These are usually not as accurate as the complex trajectory formula, but are much better than the FGA and can be very good in several situations. Moreover, it singles out real classical trajectories from the in nite set in Eq.2) that can be directly interpreted as contributing to the propagation.

In this paper we apply these real trajectory approximations to study the tunnel e ect. Since this is a purely quantum phenomena, it is a very interesting case to test the sem iclassical approximation and to understand what are the real trajectories that contribute when the wavepacket is moving 'inside' the barrier. More speci cally, we will consider the propagation of a G aussian wavepacket through a nite square barrier. We shall see that the sem iclassical results are very accurate, although some important features of the wavepacket propagation cannot be completely described.

This paper is organized as follows: in the next section we review the sem iclassical results derived in [9], which are the starting point of this work. Next we describe the evolution of a Gaussian through a square potential barrier in its three separate regions: before, inside and after the barrier. Finally in section IV we discuss the calculation of tunneling times, as proposed in [2]. We not that the barrier slows down the wavepacket at high energies, but that it speeds it up at energies comparable to the barrier height. Finally, in section V we present our conclusions.

II. APPROX IM AT ION W ITH COMPLEX AND REAL TRAJECTORIES

O ne in portant class of initial wavefunctions is that of coherent states, which are m in im um uncertainty G aussian wavepackets. In this paper we shall consider the initial wavepacket

where jDi is the harm onic oscillator ground state, \hat{a}^{y} is the creation operator and z is the complex eigenvalue of the annihilation operator \hat{a} with respect to the eigenfunction jzi. Using the position and momentum operators, \hat{q} and \hat{p} respectively, we can write

where q and p are real numbers. The parameters $b = (\sim = m !)^{\frac{1}{2}}$ and $c = (\sim m !)^{\frac{1}{2}}$ are the position and m on entum scales respectively, and their product is \sim .

In order to write the Van V leck form u la of the Feynm an propagator, we need to introduce the tangent matrix. Let S $S(x_f;T;x_i;0)$ be the action of a classical trajectory in the phase space (X;P), with $x_i = X$ (0) and $x_f = X$ (T). A small initial displacement ($x_i; p_i$) modi es the whole trajectory and leads to another displacement ($x_i; p_i$) at time T. In the linearized approximation, the tangent matrix M connects these two vectors of the phase space

where $S_{ii} = (e^2 S = ex_i^2; S_{if}) = e^2 S = ex_i ex_f$. In terms of the coe cients of the tangent matrix, the Van V leck propagator is [5]

For short times m_{qp} is positive and the square root is well de ned. For longer times m_{qp} m ay become negative by going through zero. At these 'focal points' the Van V leck form ula diverges. However, su ciently away from these points the approximation becomes good again, as long as one replaces m_{qp} by its modulus and subtracts a phase =2 for every focus encountered along the trajectory. We shall not write these so-called M orse phases explicitly.

A ssum ing som e converging conditions, the stationary phase approximation allows us to perform the integral over x_i in Eq. (2) (for more details, see [9]). We obtain

where x_0 is the value of the initial coordinate x_i when the phase of the propagator is stationary. It is given by the relation

The end point of the trajectory is still given by X (T) = x_f . In spite of q and p being real, x_0 and p_0 are usually complex. This implies that the classical trajectories with initial position x_0 and m on entum p_0 are complex as well, even with $x_f 2 R \cdot Eq$. (7) was instructed by H eller [10, 11] and it is not an initial value representation (IVR). There are a priori several complex trajectories satisfying the boundary conditions. Thanks to the stationary phase approximation, we were able to replace an integral over a continuum of real trajectories (2) by a nite number of complex ones (7). The problem is now solvable, but still quite di cult to compute. However, it turns out that, in m any situations, these complex trajectories can be replaced by real ones, which are much easier to calculate [4, 9].

Therefore, we look for real trajectories that are as close as possible to the complex ones. Let (X (t); P (t)) 2 C C be the coordinates of a complex trajectory, and (u (t); v (t)) a new set of variables de ned by

A coording to Eq. (8), the boundary conditions become

The initial condition is then the complex coordinate z and the nal condition is the real position x_f . The real and in aginary parts of z are related to the central position q and the central m on entum p of the initial wavepacket respectively. This gives us three real parameters that we m ay use as boundary conditions to determ ine the real trajectory. But a particle whose initial conditions are q and p will not a priori reach x_f after a time T. A lthough it is possible to satisfy such nal condition, it will not usually happen because X (T) is imposed by q and p. Likewise, xing the initial and nal positions q and x will not generally lead to P (0) = p. Therefore we need to choose only two boundary conditions am ong the three parameters, and use the ham iltonian of the system to calculate analytically or num erically the third one. This means that the relation (8) will not be generally full led and the hope is that it will be full led approximately. For a discussion about the validity of

this approximation, see the beginning of the third section in [9]. If we x (q;p), we obtain the Frozen G aussian Approximation of Heller [12]. This is an initial value representation that involves a single trajectory and is unable to describe interferences or tunneling, which are the aim of this paper. However, we can $x X (0) = q; X (T) = x_f$ and calculate P (0) = p_i . When the complex quantities in Eq.(7) are expanded about this real trajectory we obtain [9]

Eq. (11) is the sem iclassical formula we are going to use in this paper. We shall show that, although still very simple, it can describe tunneling and interferences quite well.

III. THE 1-D SQUARE BARRIER

Consider the specic case of a particle of unit mass scattered by the 1-D square barrier de ned by (see gL)

The initial state of the particle is a coherent state (z;x;0) = hxjziw ith average position q < a and average m om entum p > 0, i.e., the wavepacket is at the left of the barrier and m oves to the right. In all our num erical calculations we have x = 0.5 and de ned the critical m om entum $p = \frac{p}{2V_0} = 1$.

The application of the sem iclassical formula Eq.11 requires the calculation of classical trajectories from q to x_f in the time T. For the case of a potential barrier, the number of such trajectories depends on the nalposition x_f . This dependence, in turn, causes certain discontinuities in the sem iclassical wavefunction.

Since the initial wavepacket starts from q < a, it is clear that for $x_f > a$ (at the right side of the barrier) there is only one trajectory satisfying x(0) = q and $x(T) = x_f$. This 'direct trajectory' has $p_i > \frac{p}{2V_0}$ and x(t) increases monotonically from q to x_f .

For $x_f < a$, on the other hand, in addition to the direct trajectory there m ight also be a relected trajectory, that passes through x_f , bounces o the barrier and returns to x_f in the time T. The initial momentum of such a relected trajectory must be greater than that of the direct one, since it has to travel a larger distance. However, if this distance is too big, i.e., if $x_f << a$, the initial momentum needed to traverse the distance in the xed time T becomes larger than $p_{\overline{2V_0}}$ and the relected trajectory suddenly ceases to exist (see next subsection for explicit details for the case of the square barrier and gure 2 for examples).

This qualitative discussion shows that relected trajectories exist only if x_i is sulf close to the barrier. The points where these trajectories suddenly disappear represent discontinuities of the sem iclassical calculation. Fortunatelly, this drawback of the approximation becomes less critical as ~ goes to zero, since the contribution of the relected trajectory at those points become exponentially small as compared to the direct one (see for instance qure 2 (g)).

In the remaining of this paper we are going to obtain explicit expressions for $(z;x_f;T)_{sc}$ before, inside and after the barrier. For xed qwe will calculate the classical trajectories for each x_f , extracting the initial momentum p_i , the action S S ($x_f;T;q;0$) and its derivatives (in order to obtain m_{qq} and m_{qp}).

A. Before the barrier: $x_f < a$

The speci city of this region is that there may exist two dierent paths connecting q to x during the time T: a direct trajectory and a rejected one (g1) whose initial momenta, action and tangent matrix elements are given by

Notice that we have added an extra phase in $_{r}$. W ithout this extra phase (that includes the m inus sign coming from the tangent matrix elements in Eq.(14)), the wavepacket would

not be continuous as it goes through the barrier. For a hard wall, for instance, we impose

= to guarantee that the wavefunction is zero at the wall. For smooth barriers this phase would come out of the approximation automatically, but for discontinuous potentials we need to add it by hand. To calculate we rewrite the previous expressions in complex polar representation, $_{d} = D(x_{f})e^{i'_{d}(x_{f})}$, $_{r} = R(x_{f})e^{i'_{r}(x_{f})+i}$, and let $W(x_{f})e^{i'_{w}(x_{f})+i}$ be the wavefunction inside the barrier, where is the corresponding phase correction. The continuity of the wavefunction at $x_{f} = a$ imposes

Eqs. (15) show that R (a) = D (a) and $'_{d}(a) = '_{r}(a)$. Denoting $' = '_{w}(a)$ $'_{d}(a)$, Eq. (16) becomes $1 + e^{i} = Ae^{i'(+)}$ where A = [W(a)=D(a)]. This complex relation represents in fact two real equations for the unknown variables and . The solutions consistent with the boundary conditions are $\cos() = A^{2}=2$ 1 and $\cos(+) = A=2$. In the limit where p goes to zero (or the potential height V_{0} goes to in nity) we obtain = as expected. Finally, the full wavefunction before the barrier is $(z; x_{f}; T)_{sc} = d + r$ and the probability density can be written as

This is the same result as obtained in [9] for a completely repulsive barrier (V₀ ! 1), except for the phase, because of the dimensional production at $x_f = a$ (j (a)_{sc}f = 0 for the hard wall). However, as discussed in the beginning of this section, an additional dimensional wall appears when the wall is nite: the remeted trajectory does not always exist. From the classical point of view, there is no remeted part if the energy $E = p_{1r}^2 = 2 > V_0$. The maximum initialmomentum allowed is then $p_{\overline{2V_0}}$ and a particle with such momentum takes the time $T_c = \frac{a+q}{p_{\overline{2V_0}}}$ to reach the barrier. Furthermore, for $T > T_c$ the remeted trajectory only exists if $p_{1r} = \frac{x_f + q + 2a}{T} = 6 p_{\overline{2V_0}}$ i.e. if $jx_f j = x_f + 6 x_c = q + 2a + p_{\overline{2V_0}}T$.

Therefore, if $T > T_c$ and $j_{x_f} j_6 x_c$, the probability density is given by Eq.(17), otherwise we only have the contribution of the direct d and #

As a nal remark we note that the calculation of might involve a technical di culty depending on the values of \sim , p and T. For som e values of these parameters the contribution of the direct and rejectories might become very small at x= -a (see for instance)

g2(f), which shows the relected wavepacket in a case of large transmission). In these cases the probability density becomes very small at x = -a and the value of the phase is irrelevant. In some of these situations, where the value of does not a left the results, we actually found that $\cos(\text{theta}) = A^2 = 2$ 1 > 1, which cannot be solved for real. For the sake of numerical calculations we have set = 0 in these cases.

The sem iclassical wavepacket is now completely described for $x_f < a$. The probability density $j_{sc} f$ is a function of $q_i p_i x_f$; T and depends on several parameters, $a_i b_i \sim and V_0$. In our numerical calculations we ked a = 50. This makes the barrier large enough so that we study in detail what is happening inside (see subsection IIIB). The height of the barrier intervenes only in T_c and x_c to establish the limits of the rejected trajectory. Its numerical value is not in portant, but its comparison with p is fundamental: since we have $x d V_0 = 0.5$ this gives $p_{ir} = b p = \frac{p}{2V_0} = 1$. Finally, to simplify matters we ked b = c, i.e. the same scale for position and momentum. This is poses a = b = c = 1. Quantum phenomena such as interference and tunneling should be more in portant for high values of \sim . Since $\sim a = bc = b^2$, b becomes in fact the only free parameter of the approximation. We have also ked q = 60, which guarantees that the initial wavepacket is completely outside the barrier for all values of b used.

Fig. 2 shows snapshots of the wavepacket as a function of x_f at time T = 50. Consider rst the panels (a)-(c) with ~ = 1. The agreement between the exact and the sem iclassical curves is qualitatively good for p 6 $p_{\overline{2V_0}} = 1$. The interference peaks occurs at about the same positions, but the height of the peaks are not exactly the same. A loo the intervals between peaks are a little bigger for the sem iclassical curve than for the exact one. On the other hand, when p is increased, the comparison gets worst and the approximation is not really accurate for p = 2. However, we see that the value of $j_{sc}f$ at p = 2 is only a tenth of its value at p = 0.5: the most important part of the wavepacket is in fact inside and after the barrier. It is then really important to consider $x_f > a$ for high p and we need to wait until subsections IIIB and IIIC to bok at the whole picture.

When $\sim = 0.25$, Fig. 2(d)-(f) and (h), the approximation improves substantially, especially close to the barrier; this shows that the extra phase works well. When p is increased, the contribution of the direct trajectory becomes irrelevant and the interference oscillations are bost in the sem iclassical calculation, although it still shows good qualitative agreement in the average. The cut-o of the sem iclassical curve at $x_f = x_c$ is also clearly visible, whereas the exact one is decreasing continuously. On the one hand this means that the approximation is not perfect but, on the other hand, the sem iclassical approximation explains that the fast nundown of the exact quantum wavepacket comes from the progressive disappearance of the relevant ation becomes nearly perfect. As expected, the sem iclassical approximation works better and better when \sim is decreasing, i.e. when the quantum rules give way to the classical ones.

To end this subsection, we mention that the quality of the approximation is independent of the time T, except for times slightly smaller than T_c . In this time interval only the direct trajectory contributes but the exact wavepacket already shows interferences that can not be described by $j_{sc} f$ (g.2, T = 10). We now enter the heart of the matter, and consider what's happening inside and after the barrier.

B . Inside the barrier: a 6 $x_{\rm f}$ 6 a

From the classical point of view there is only the direct trajectory in this region (see Fig. 1), since a relection on the other side of the barrier (at x = a) can not be considered without quantum mechanics. Calling $p_1 = p_i > \frac{p}{2V_0}$ and p_2 the momentum of this trajectory before and inside the barrier respectively, energy conservation gives $p_1^2=2 = p_2^2=2 + V_0$. This is the

rst equation connecting p to p_2 , but we need a second one which is imposed by the propagation time $T = t_1 + t_2$ where:

This is a quartic polynom ial, which we solve numerically. We obtain four solutions: one is always negative, which we discard since we ked the initial position q on the left side of the barrier; two are sometimes complex and, when real, have $p_1 < 1$; nally, one of the roots is always real, larger than 1 and tends to $\frac{x_f}{T}$ when V_0 is negligible (the limit of a free particle). We take this last root as the initial momentum p_1 .

The action S is also a function of p_1 given by

We calculate the derivatives of S numerically by computing p_1 and S for the initial conditions $(q; x_f)$, $(q + dq; x_f)$, $(q; x_f + dx_f)$... and approximate $\frac{@S}{@x_f}(z; x_f; T)$ by $[S(z; x_f + dx_f; T) S(z; x_f; T)] = dx_f$, etc. F inally, the propagator inside the barrier is given by Eq.(11) plus the phase correction calculated in the previous subsection. The probability density, which in independent of , becomes

Figure 3 shows $j_{sc} f$ as a function of x_f for the same parameters as in subsection IIIA. A lithough the sem iclassical approximation also improves for small ~, here we shall $x \sim = 1$. This is because the behavior of the propagator becomes trivial for small ~: if p < 1 the wavepacket bounces of the barrier almost completely, and otherwise it simply passes over the barrier barely noticing the presence of the potential.

The rst remark is that the wavepacket is continuous at $x_{f} = a$: the extra phase does play its role correctly. As in the case before the barrier, the comparison between exact

and sem iclassical calculations is always at least qualitatively good, and som etim es even quantitatively so. However, there are two main e ects that the sem iclassical approximation cannot take into account.

- 1. there is a gap between the exact and sem iclassical curves, which decreases progressively as x_f increases, and is bridged near the local maximum of the probability density. The reason may come from the fact it is not possible to impose the continuity of the derivative of $_{sc}$ with respect to x_f at a.
- 2. there are oscillations on the exact curve (especially for p = 2 and T = 50) close to the right side of the barrier, that are not present in the sem iclassical approximation. This is a purely quantum e ect, because classical mechanics can not account for a re ected trajectory which would interfere with the direct one in this case. $j_{sc} \hat{j}$ is in fact the mean-value of the oscillations, and that is why there is a discontinuity of the wavepacket at $x_f = a$, since the exact curve is beginning at the bottom of an oscillation.

If we want to stay strictly in the sem iclassical limit, there is nothing we can do about the lack of interferences in the barrier region: this is the limit of our approximation. But if we want to use the sem iclassical point of view in order to provide a more intuitive picture of the quantum world, we can add a 'ghost' trajectory that relects at $x_{\rm f} =$ a and see if it can account for the interferences. Similar ideas have been applied to the frequency spectrum of m icrowave cavities with sharp dielectric interfaces [14] and, more recently, to the spectrum of step potentials conned by hard walls [5]. The argument will be the same as in subsection IIIA, except of course that the relected trajectory will now bounce on the right side of the barrier. The equation for $p_i = p_1$ is again a quartic polynom ial given by

We know that $p_{1 \text{ direct}}$ is the same as $p_{1 \text{ reflected}}$ at $x_f = a$ and we choose the only solution of (23) which sati es this condition. The expression of the new action is:

The results of such an expression, however, are not good: the oscillations become too big, which means that the rejected trajectory needs to be attenuated by a rejection coelecient . To calculate we use the following reasoning: for each point x_f inside the barrier there corresponds a rejected trajectory from q to x_f with a certain value of $p_1 > 1$ computed with Eq. (23). We take for the same attenuation coelecient a plane wave with momentum p_1 would have. Let (F e^{i x_f} + G e^{i x_f}) and C e^{ikx_f} be such a plane wave inside and after the barrier respectively, where $= \frac{p}{2(E - V_0)} = = \frac{p}{p_1^2} \frac{p^2}{p^2} = and k = \frac{p}{2E} = a = p_1 = a$. The continuity of this function and its derivative at $x_f = a$ give us the relative weight of the rejected trajectory with respect to the direct one:

The expression for the total propagator becomes $_{scd} + _{scr} e^{i^{0}}$. We use the same argument as in subsection IIIA to compute the extra phase 0 , adding another correction 0 to the wavefunction on the right side of the barrier. Because there is always a single trajectory on the right side, 0 does not a left the probability density there. We indicate that $\cos^{0} = A_{+}^{2} = 2$ is there $A_{+} = W$ (a)=D (a).

The new results are displayed in gure 4. The gap is still present, but the agreem ent between exact and sem iclassical on the right side is nearly perfect. The interferences are indeed coming from a real 'ghost' trajectory that bounces o at the end of the barrier like a quantum plane wave. Since the left side of the gure has not changed much, the re ected trajectory has no e ect on this part of the wavepacket and we don't need to consider additional re ections. Furtherm ore, we don't have to take $_{scr}$ into account when we calculate in subsection IIIA. We nish this subsection with two comments: rst, the approximation with the ghost trajectory is accurate even for larger values of ~. Second, the wavepacket becomes continuous at $x_f = a$. That is very interesting because continuity comes only when we include the receted trajectory, whereas the part of the wavepacket which goes through the barrier is calculated independently with a single direct trajectory (see next subsection). This means that the sem iclassical propagator after the barrier som show knows there is a receted part.

In the next subsection, we will brie y present the computation of the wavefunction at the right side of the barrier.

C . A fter the barrier: a < x

Following the same arguments as in subsection IIIB, we use the energy conservation $p_1^2=2 = p_2^2=2 + V_0 = p_3^2=2$ (the index 3 refers to the right of the barrier) and the diment times $t_1 = \frac{a+q}{p_1}$, $t_2 = \frac{2a}{p_2}$ and $t_3 = \frac{x-a}{p_3}$ to calculate the initial momentum of the direct trajectory. We obtain

whereas the action becomes

In this region, no re ection is possible and the probability density $j_{sc} \hat{j}$ is simply given by Eq. (22). The results are presented in gure 5. For any values of p, T or ~, there is still a very small di erence between the exact and sem iclassical curves for the ascending part of the wavepacket, whereas the agreem ent is perfect when the function is decreasing.

The conclusion of this section is that the sem iclassical approximation with realtrajectories gives very good results and is indeed able to describe some important quantum e ects.

Interference on the left side of the barrier appears naturally when the wavepacket hits the barrier and the comparison with the exact solution gets better as ~ gets smaller. However, these interferences cannot be obtained in the barrier region, since there are no receted trajectories in the classical dynam ics. We showed that these interferences can be recovered if a 'ghost' trajectory that recets at x = a is added and assumed to contribute with the same coeccient of a plane wave of initialm on entum p_i . With this addition the sem iclassical approximation becomes again very accurate inside the barrier. In the next section we shall brief y discuss the possibility of using our results to calculate the tunneling time as defined and in [2].

IV. SEM ICLASSICAL TUNNELING TIMES

The question of how much time a particle spends in the classically forbidden region during the tunneling process has been attracting the attention of physicists for a long time [2, 16, 17, 18, 19, 20, 21, 22]. The very concept of a 'tunneling time' is, however, debatable [18]. Nevertheless, in a sem iclassical formulation where real trajectories play crucial roles in the tunneling process, the temptation to estimate such a time is irresistible.

Since we are considering a wavepacket, and not a classical state localized by a point in the phase space, we can only de neam ean value of the tunneling time. Let us x the initial conditions q;p (such that p < 1) and $x_f > a$. The probability of noting the initial G aussian state at x_f after a time T is given by $j < x_f K$ (T) $j_z > j_z^2$. Therefore, the particle can reach x_f from (q;p) in several dimension initial momentum $p_1(T) > p = \frac{p}{2V_0}$ is given by Eq. (28). This trajectory spends a time of $(T) = \frac{2a}{p_2(T)} = \frac{p}{p_1^2(T) p^2}$ in the region a < x < a. Notice that the average energy of the wavepacket is below the barrier but the contributing trajectory always has energy above the barrier. Therefore, for xed q;p; x_f , the probability that the wavepacket crosses the barrier in a time (T) is proportional to $j < x_f K$ (T) $j_z > j_z^2$.

is the norm alization factor. It is not equal to 1 because only the part of the wavepacket which goes through the barrier is considered. This is in portant in our case, since the sem iclassical approximation is better for $x_f > a$.

We calculated these integrals numerically, performing a discrete sum over $T_n = n \ T$, with n = 1;2;:::;N and $T = T_{m ax} = N$. If an observer is placed at a xed position $x_f > a$, as the time T slips by, he/she sees the wavepacket arriving from the barrier, becoming bigger and bigger, reaching a maximum and then decreasing and disappearing. We ended the sum at $T_{m ax}$ such that $j < x_f X$ (T) $j_z > \frac{2}{J} < 10^{-4}$ 8 T > $T_{m ax}$.

An important remark is that h i is independent of the observer's position x_f (except for sm all uctuations due to the num erical computation), since Eq.80) measures only the time inside the barrier. The three di erent times we are going to use for comparison are:

 $h_{barr}i$ is the tunneling time computed according to Eq. (30)

 $h_{free}i$ is obtained from the same way as $h_{barr}i$, but in a system without barrier; $h_{free}i$ is simply the time for a free wavepacket to go from a to a.

 $class = \frac{p}{p^2} \frac{2a}{p^2}$ is the time required by a classical particle to cross the barrier.

Fig. 6 shows the dependence of these functions with respect to p. The curves become very similar as p increases, because the barrier becomes more and more negligible. The wavepacket spreads but stays centered around p, which explains why it behaves like a particle of momentum p. When the in uence of the barrier is more important, the wavepacket gets trapped by the barrier and slows down ($h_{barr}i$ is above $h_{free}i$), but for p < 1.8, $h_{free}i$ and class start to increase very fast (class actually diverges at p = 1), whereas $h_{barr}i$ stays nite until p is very close to 0: thanks to the tunnel e ect the wavepacket is accelerated by the barrier, which acts like a liter for the wavepacket and cuts o the contributions of its slowest components (see Fig. 7.(a)). On the other hand when p increases, the fraction of the trajectories with $p < \frac{p}{2V_0} = 1$ becomes negligible and the barrier simply restrains the propagation of the wavepacket (g.7.(b)).

V. CONCLUSION

In this paper we used the sem iclassical approximation Eq. (11), derived in [9], to study the propagation of a wavepacket through a nite square potential barrier. One of the main purposes of this work was to test the validity and accuracy of the approximation, which involves only real trajectories, in the description of tunneling. Surprisingly, we have shown that the approximation is very good to describe the wavepacket after the barrier, even when the average energy of the wavepacket is below the barrier height. The region before the barrier is also well described by the approximation, although discontinuities are always observed because of the sudden disappearance of the rejected trajectory. The continuity of the wavefunction between this region and the region inside the barrier also depends on the calculation of an extra phase . Finally, inside the barrier the sem iclassical form ula is not able to describe interferences. These, however, can be recovered when a ghost trajectory, that rejects on the right side of the barrier, is included and attenuated with the proper coel cient. In all regions the approximation becomes more accurate as ~ becomes smaller.

The sem iclassical approximation (11) is particularly relevant because the propagated wavepacket is not constrained to remain G aussian at all times, as in the case of Heller's Thawed G aussian Approximation [12], and also because it uses only a small number of real trajectories. These are much easier to calculate than complex ones, especially in multidimensional problems. The demonstration of its ability to describe tunneling and interferences is important to establish its generality and also to provide a more intuitive understanding the processes them selves. In particular, using the underlying classical picture, we have computed a tunneling time which shows that the wavepacket can be accelerated or restrained by the barrier depending on the value of the initial central momentum p.

Some interesting perspectives of this sem iclassical theory are the study of propagations through sm ooth potential barriers (which are more realist and more adapted to sem iclassical calculations), the study of time dependent barriers and the extension of the method to higher dimensions and to chaotic system s.




FIG.1: Direct and rejected trajectories from q to $x_1 < a$. For $a < x_2 < a$ or $x_3 > a$ only the direct trajectory exists.




FIG.2: (Color online) Exact (blue thin lines) and sem iclassical (red thick lines) wavepacket at time T = 50, except for panel (h) where T = 10. We xed \sim = 1 for (a), (b) and (c), whereas \sim = 1=4 for (d), (e), (f), (h) and \sim = 1=10 for (g).




FIG.3: (Coloronline) Exact (blue thin lines) and sem iclassical (red thick lines) wavepacket inside the barrier for various values of p and T and $\sim = 1$.




FIG.4: (Coloronline) Exact (blue thin lines) and sem iclassical with ghost rejected trajectory (red thick lines) wavepacket inside the barrier. The panels on the right are magnications of the left ones, showing the perfect match between the approximation and the exact solution.




FIG.5: (Coloronline) Exact (blue thin lines) and sem iclassical (red thick lines) wavepacket after the barrier for p = 2 and T = 50 and 100.




FIG. 6: (Color online) Tunneling time as a function of p. The red thick line and the green curve show the sem iclassical result according to Eq.(30) for the square barrier and the free particle respectively. The thin black line is the classical time for the square barrier potential.




FIG.7: (Color online) Exact (blue thin lines) and sem iclassical (red thick lines) wavepacket after going through the barrier. The green curve (above the other two in both gures) shows the corresponding free particle wavepacket. For p = 0.5 the barrier acts like a liter and only the fast components of the initial wavepacket go through. For p = 2, on the other hand, the wavepacket interacting with the barrier is slightly behind the free particle wavepacket, showing that the barrier slows the trajectories because the momentum is reduced to $p_2 = \frac{p}{p_1^2} \frac{2V_0}{2V_0} < p_1$ between a and a.
